The ornamental design for a front portion of motor vehicle,
as shown and described.

DESCRIPTION

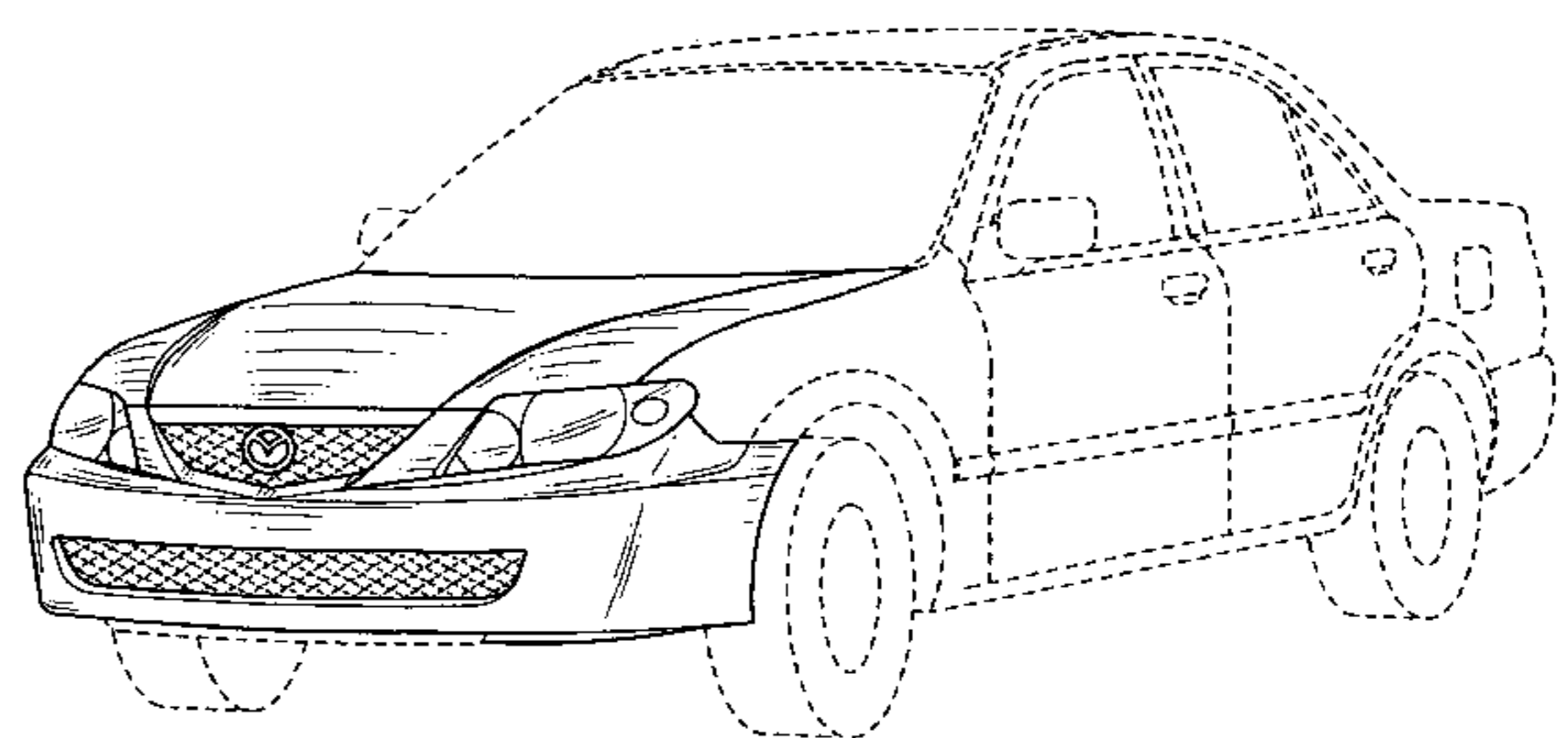
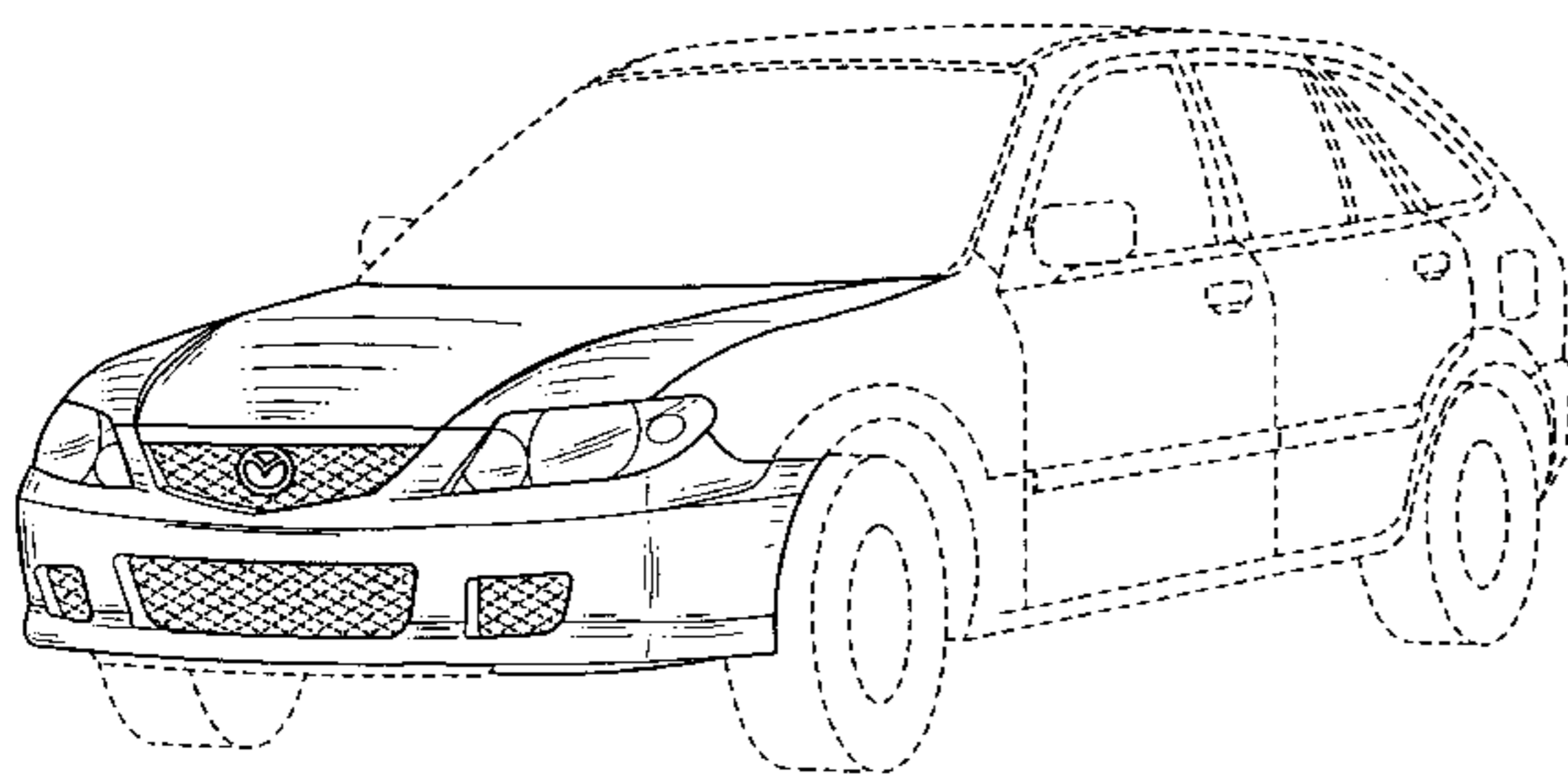

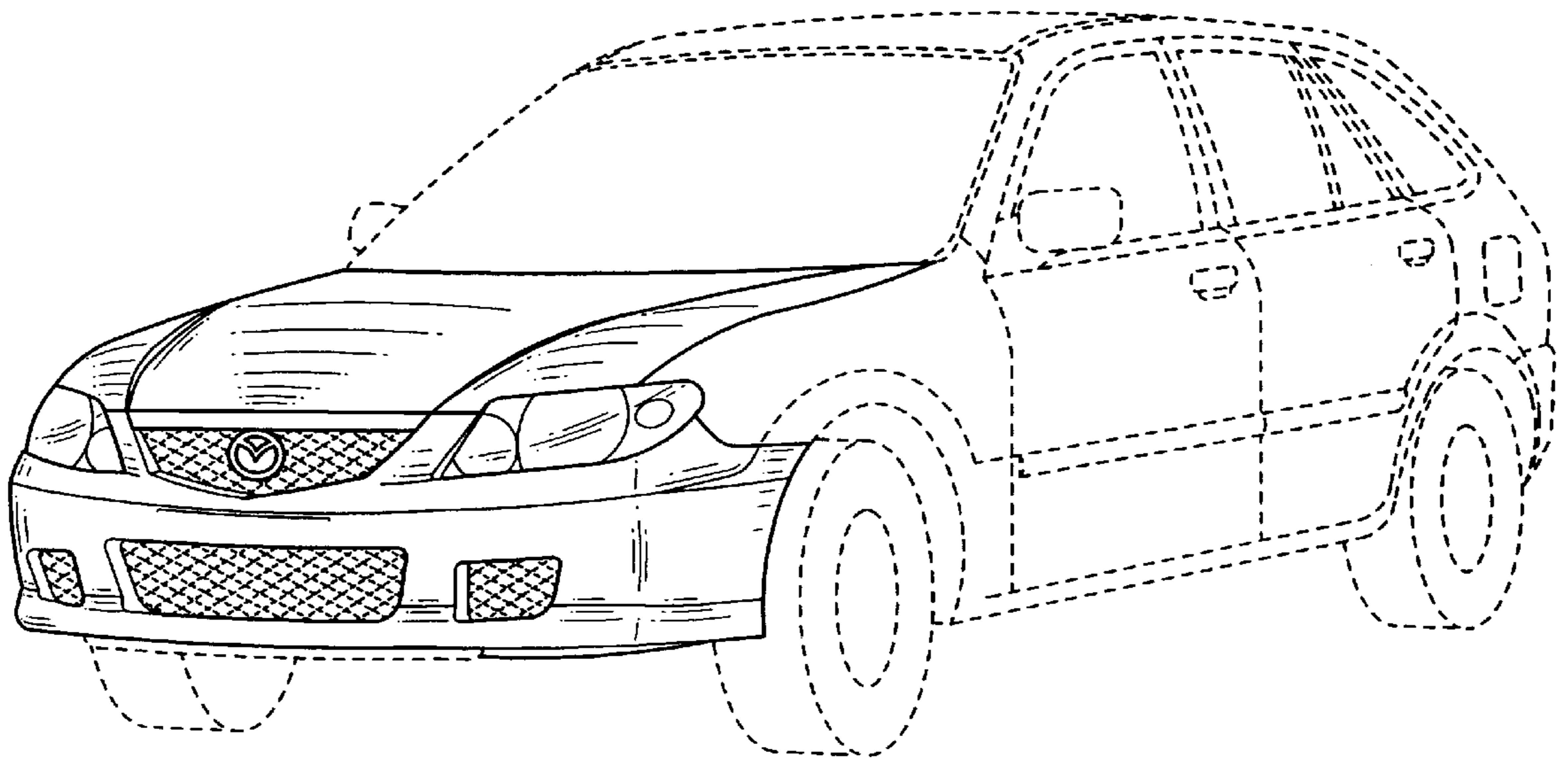

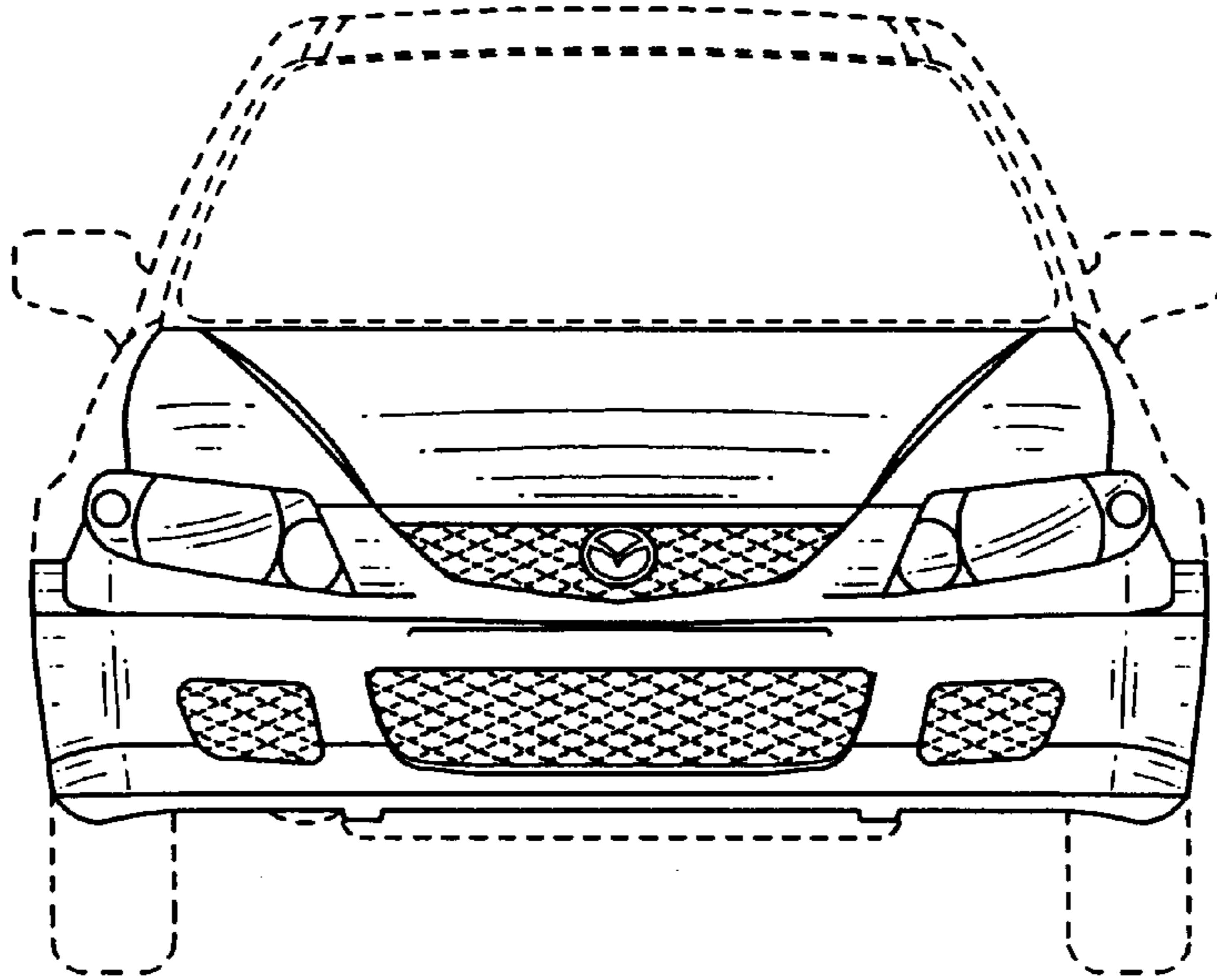

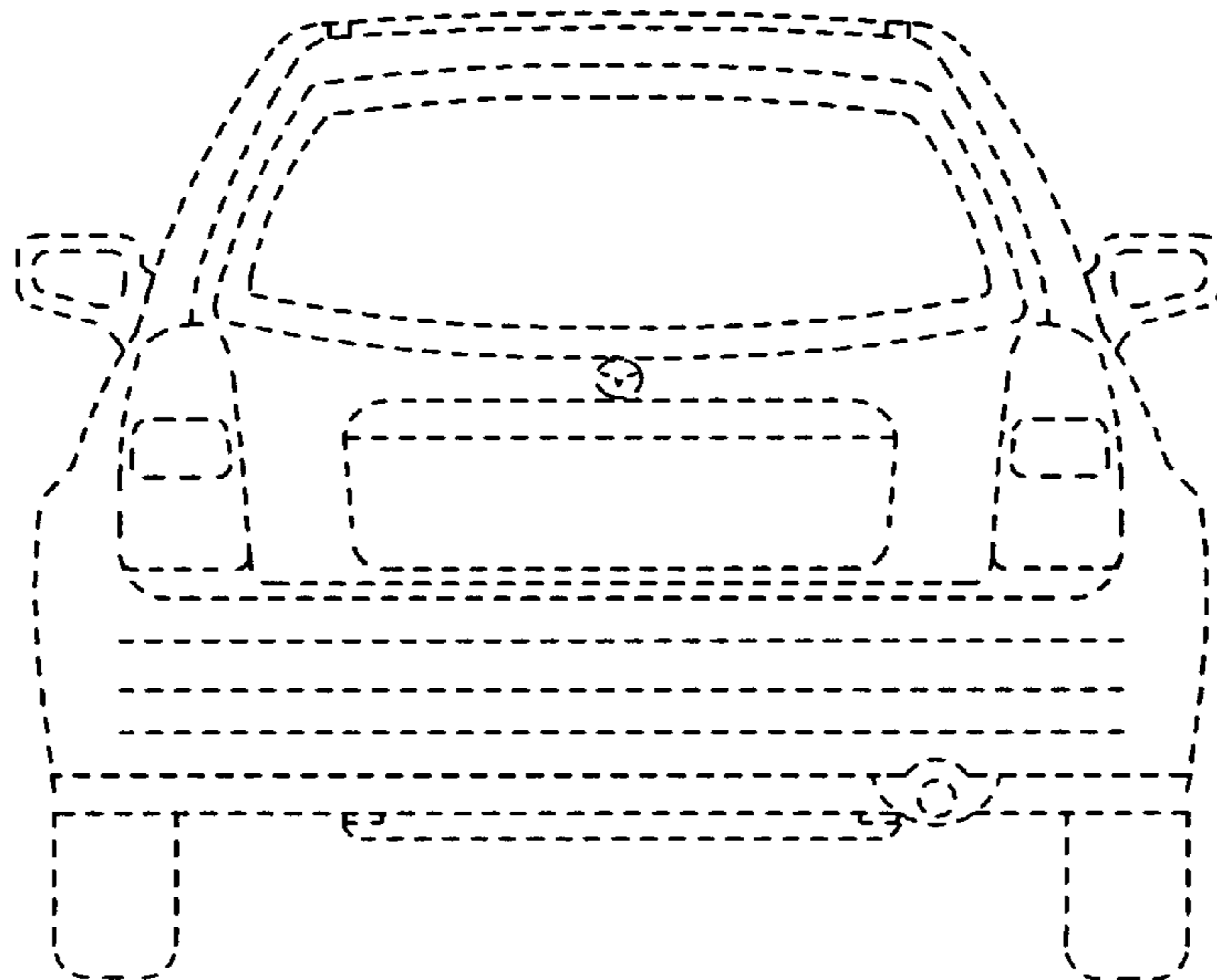

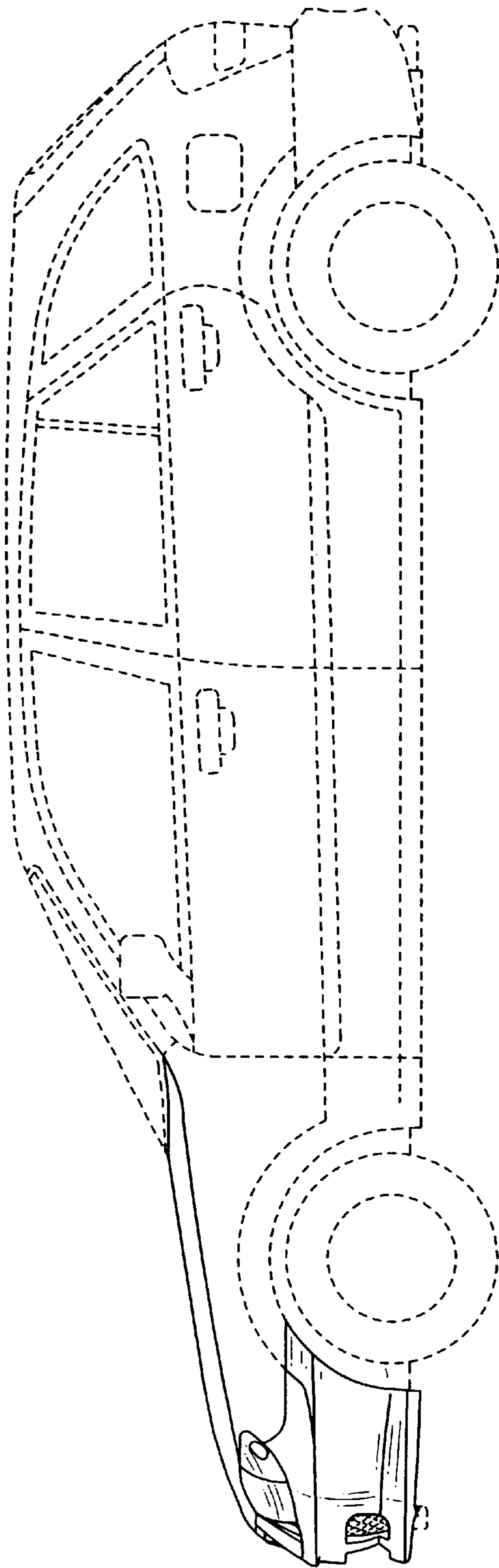

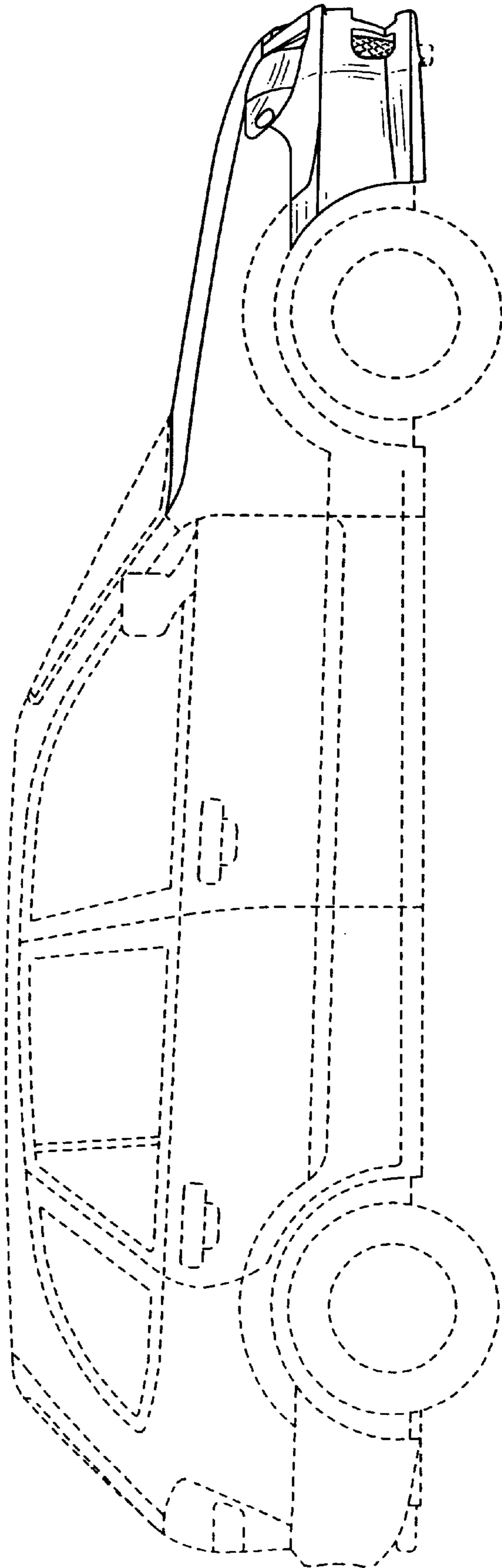

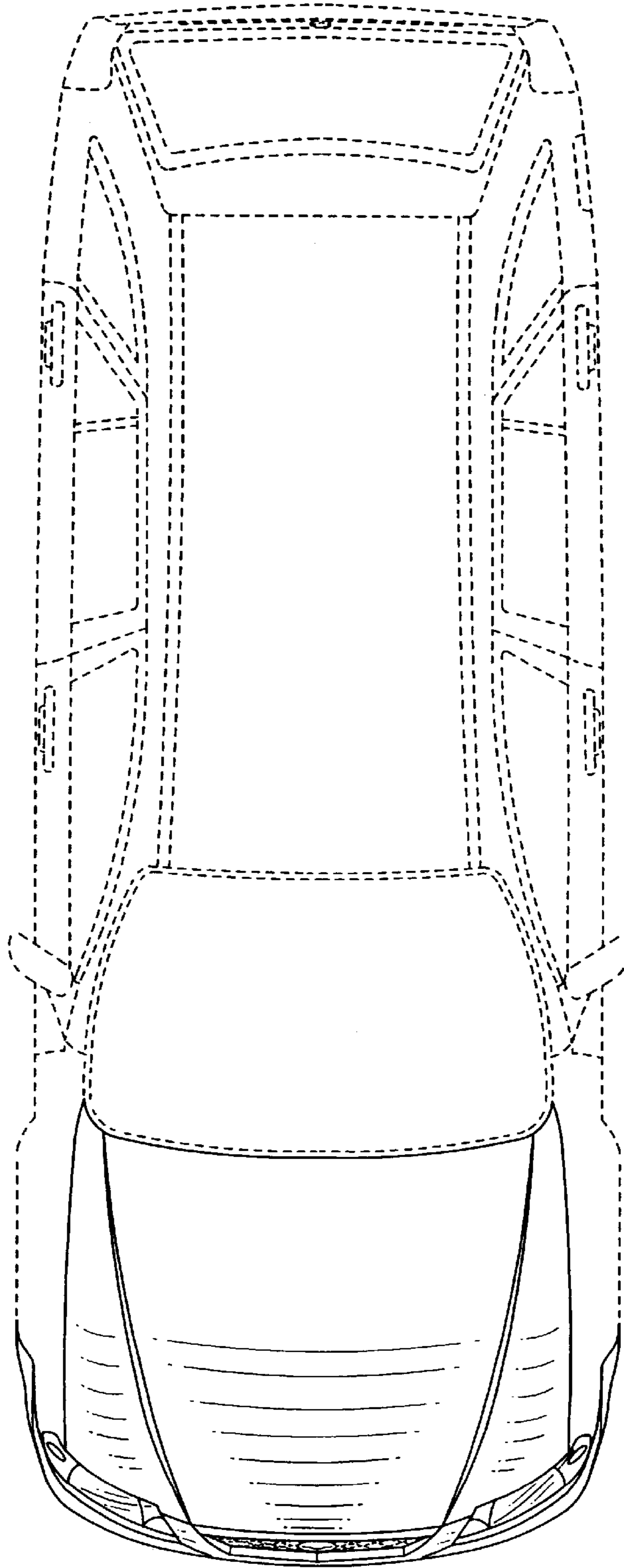

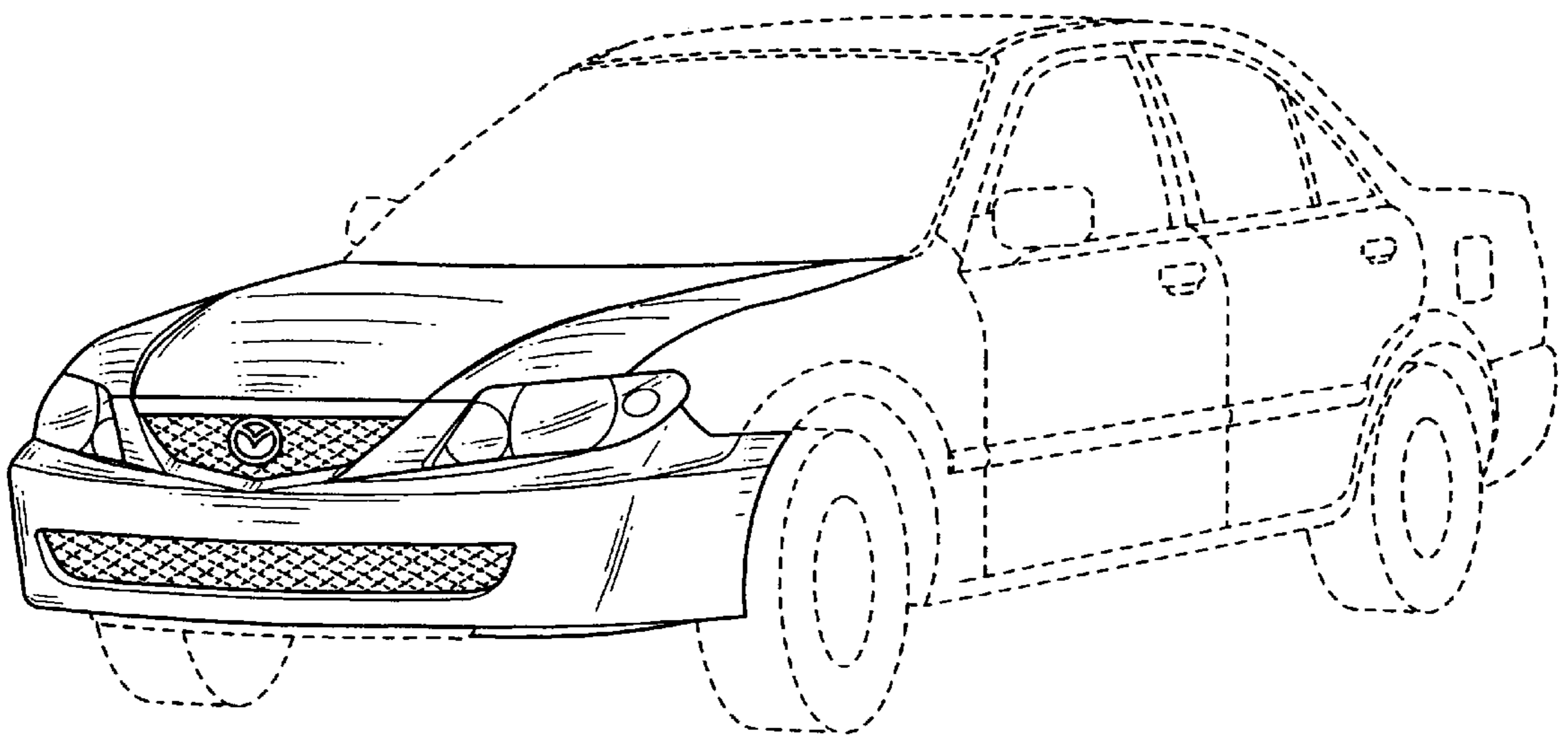

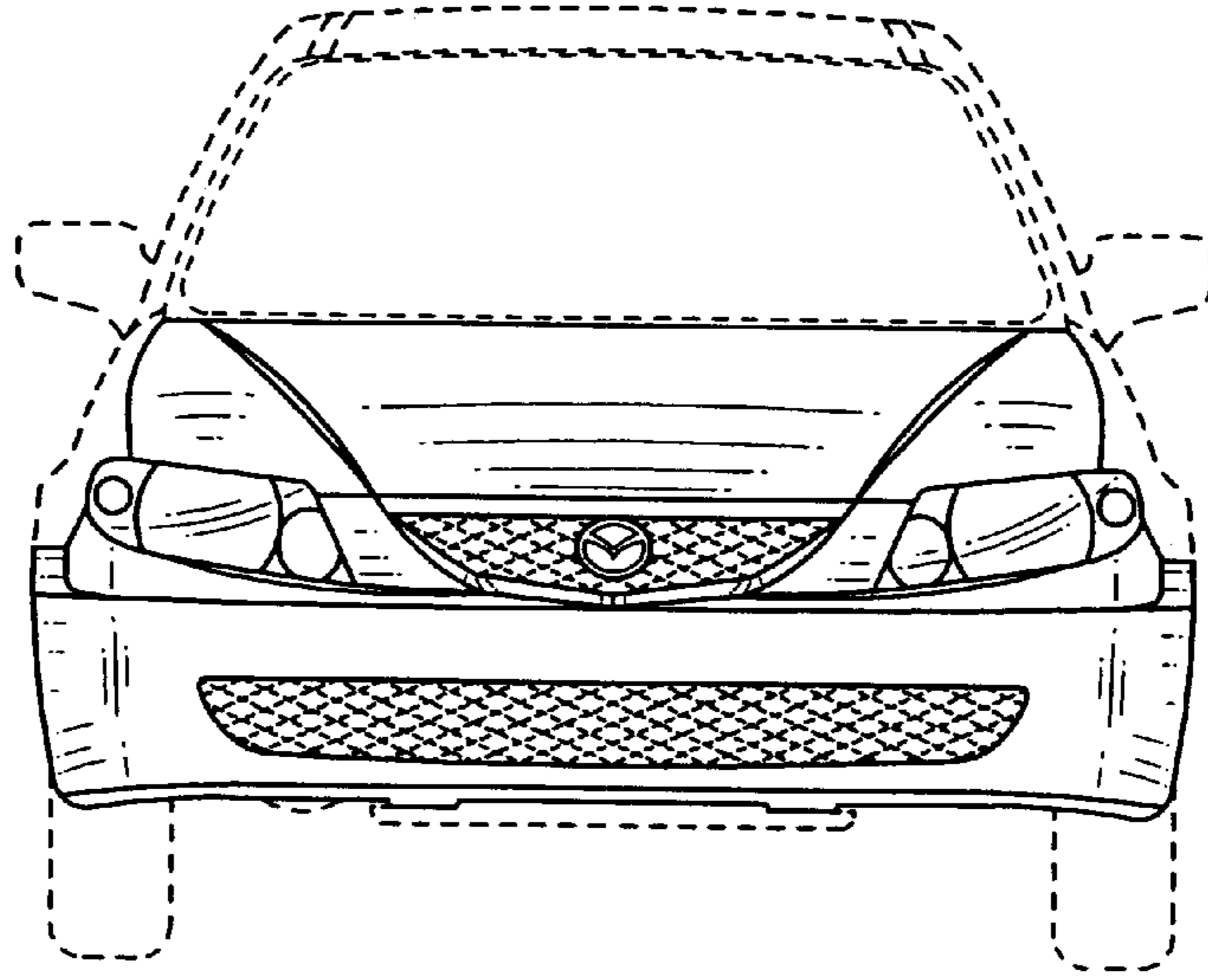

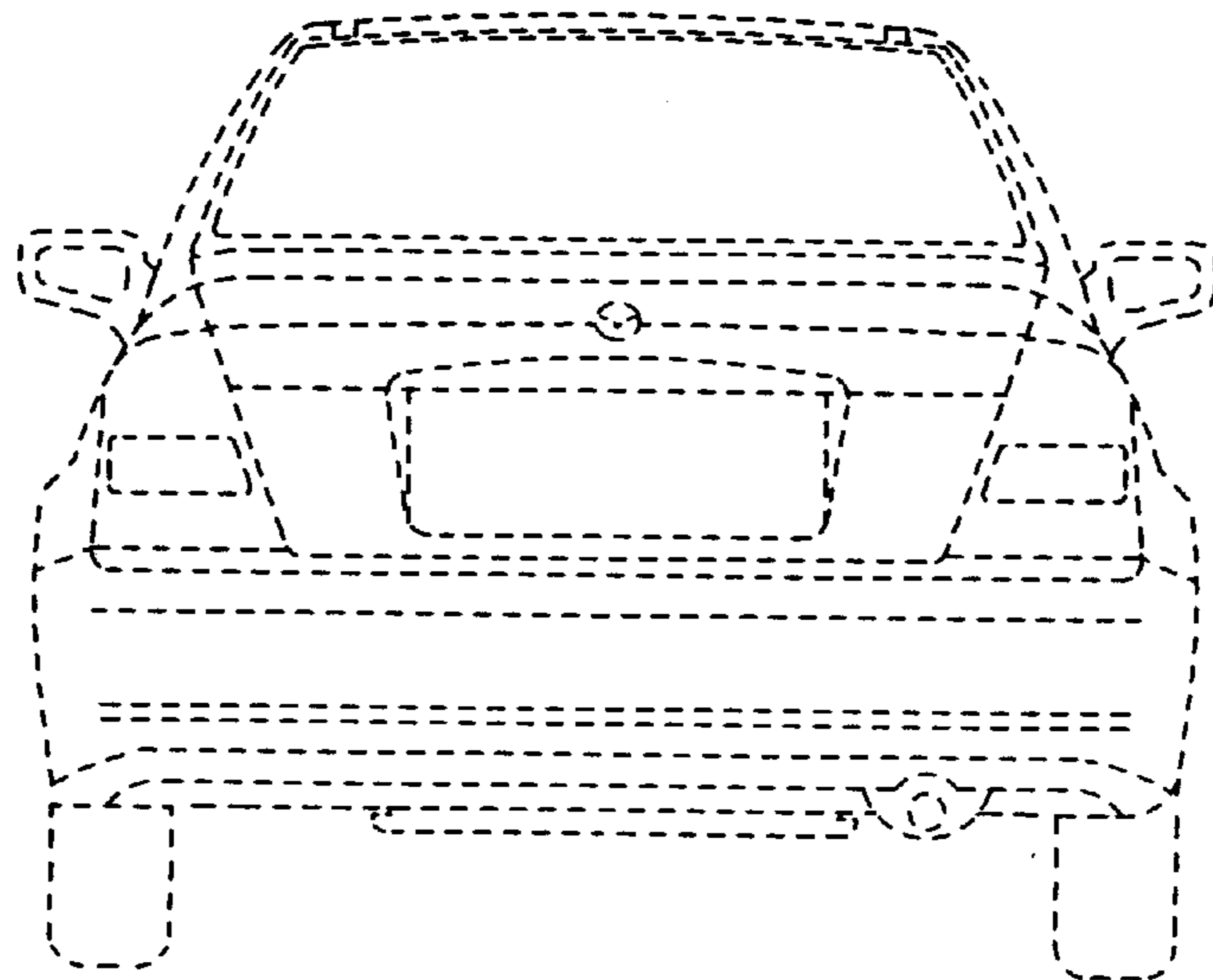

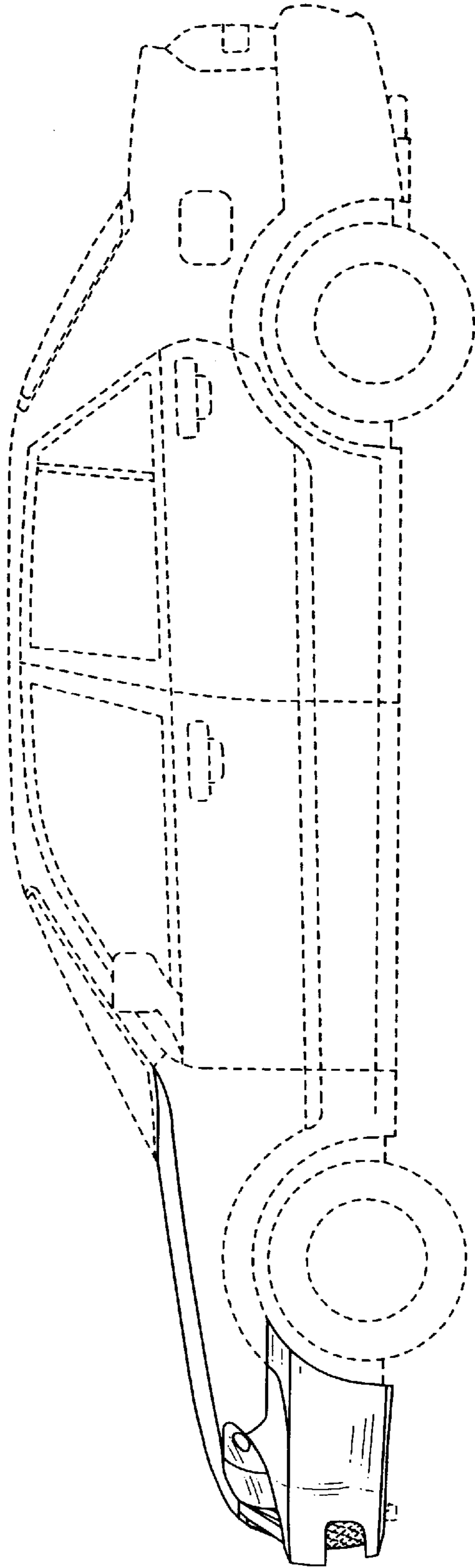

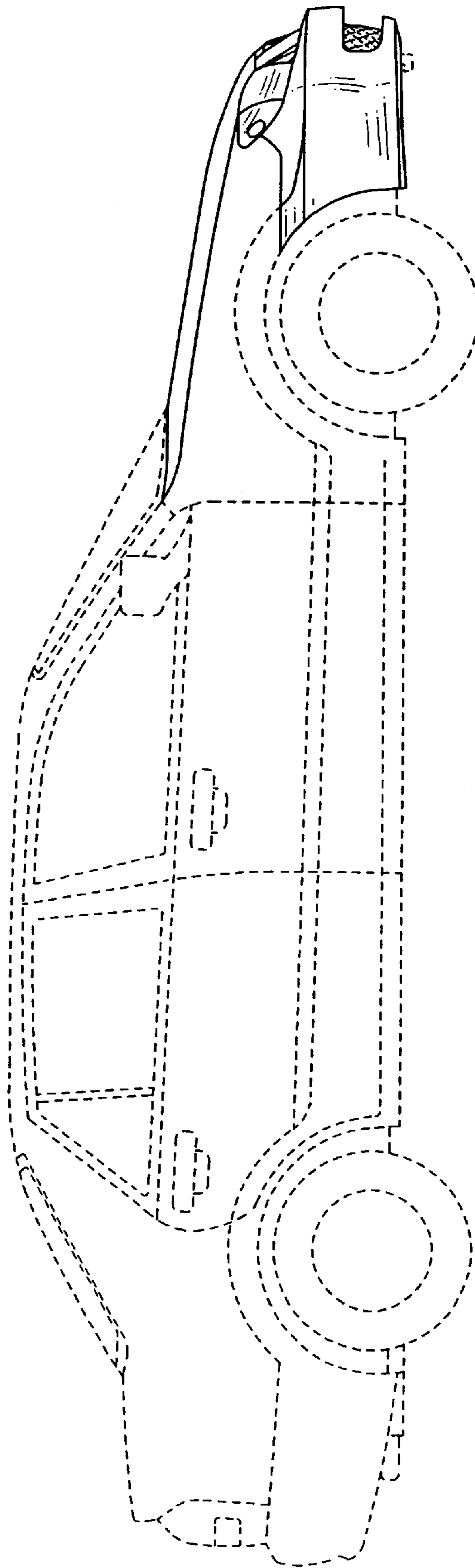
