The ornamental design for a information panel with kicker attachable to vend machine spirals, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the information panel with kicker attachable to vend machine spirals of the present invention;

FIG. 2 is a front elevation view of the information panel with kicker attachable to vend machine spirals of the present invention;

FIG. 3 is a rear elevation view of the information panel with kicker attachable to vend machine spirals of the present invention;

FIG. 4 is a left side elevation view of the information panel with kicker attachable to vend machine spirals of the present invention;

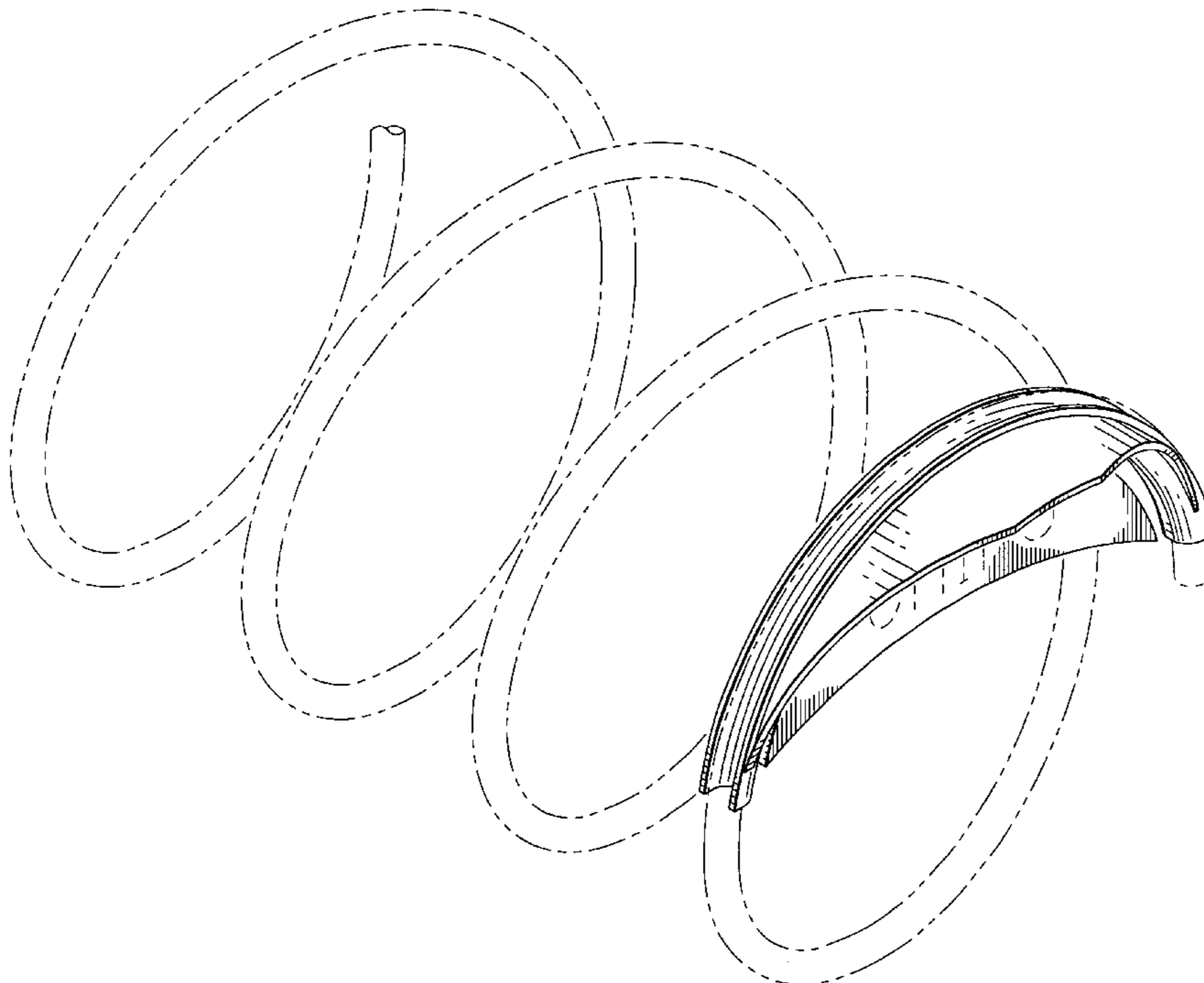
FIG. 5 is a right side elevation view of the information panel with kicker attachable to vend machine spirals of the present invention;

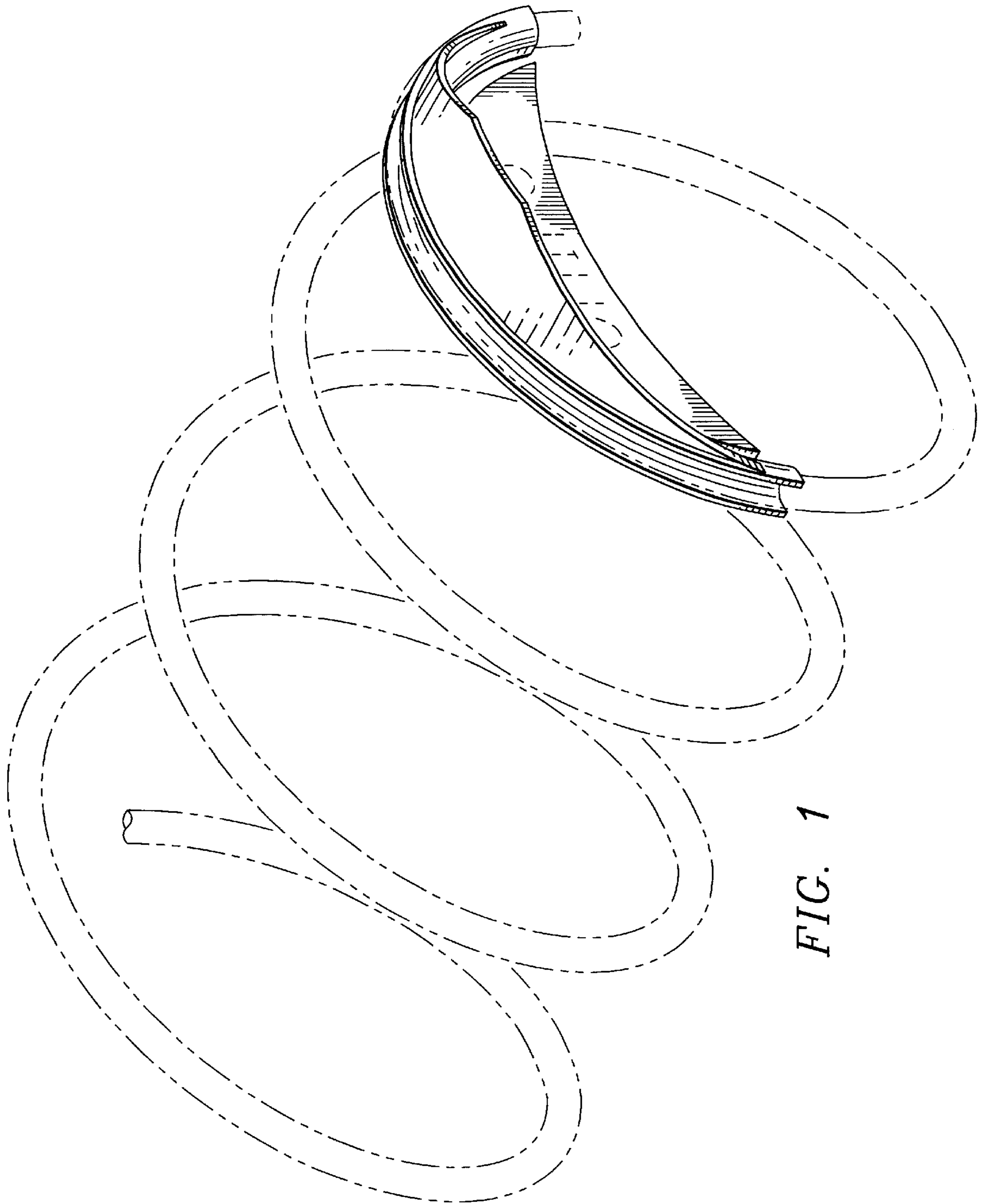

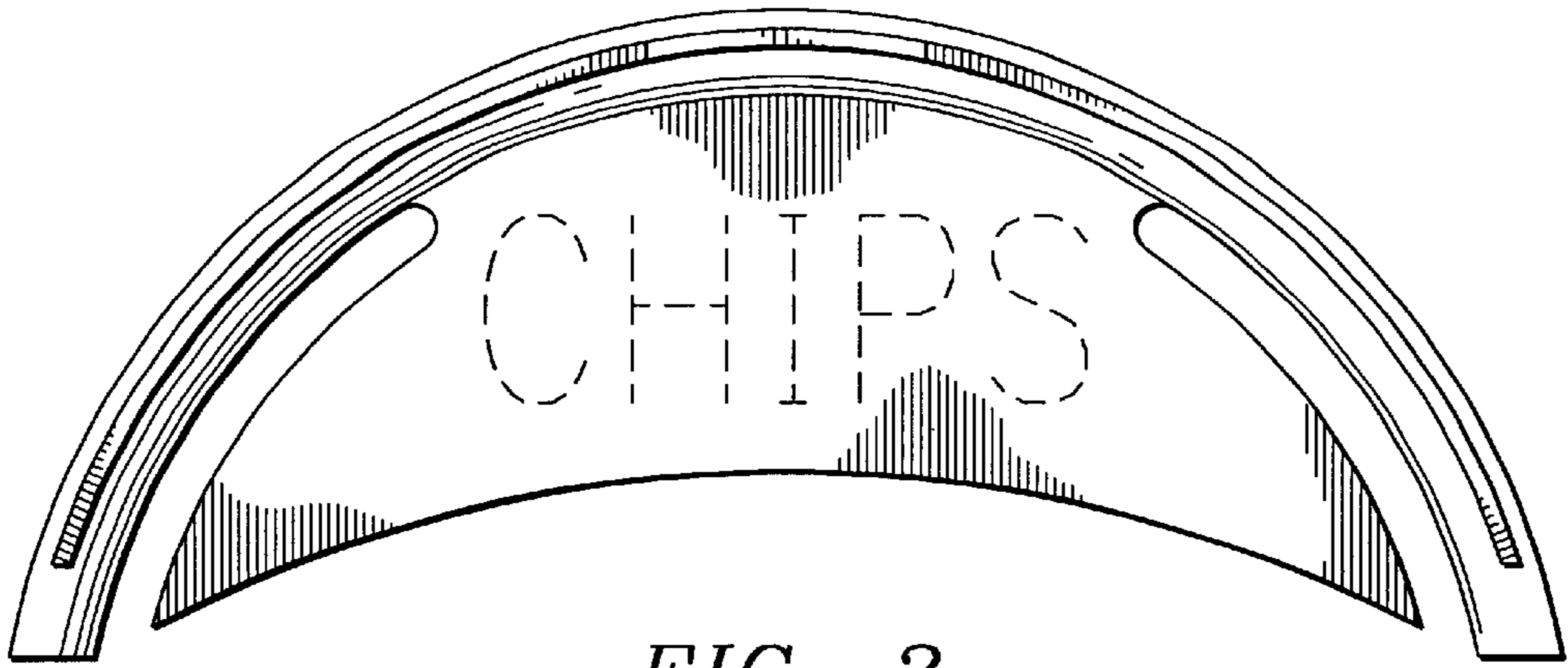

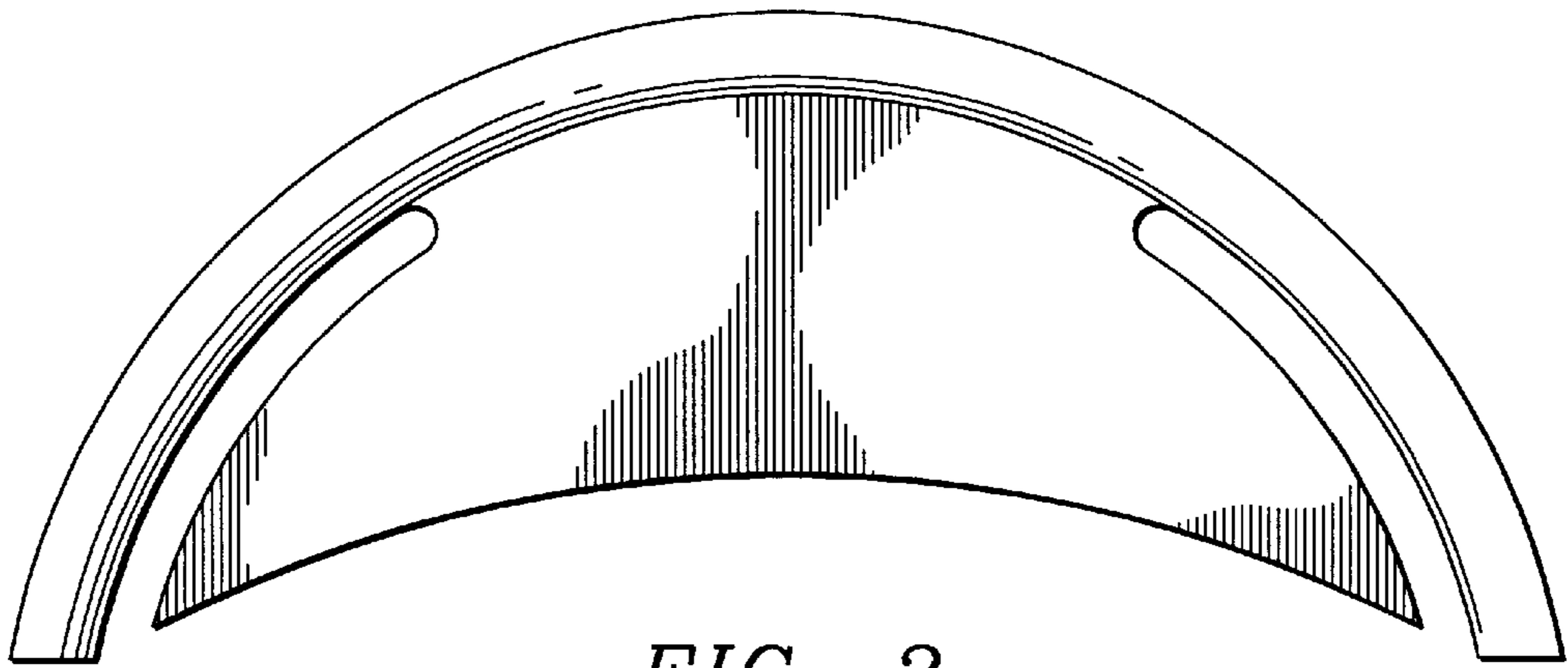

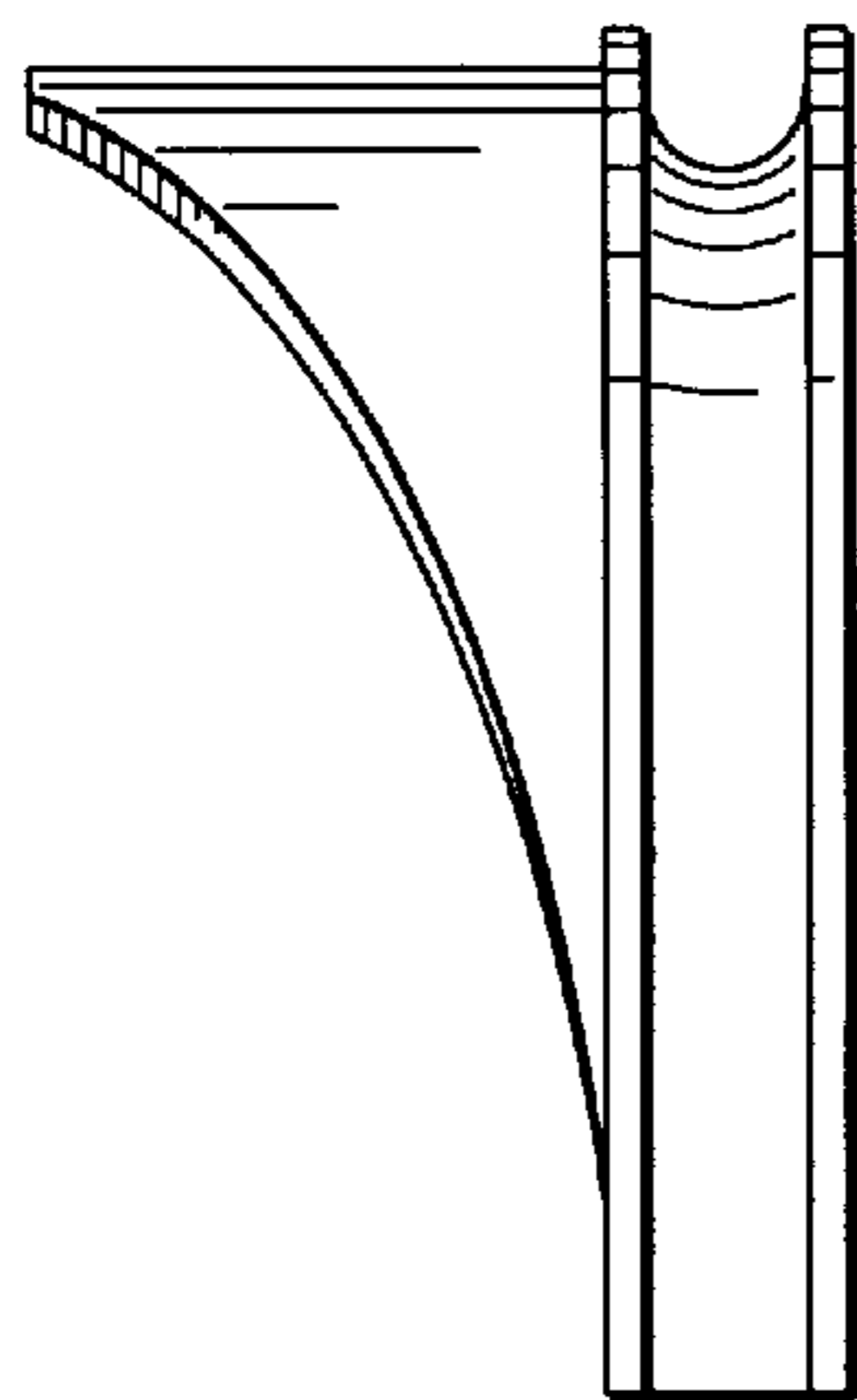

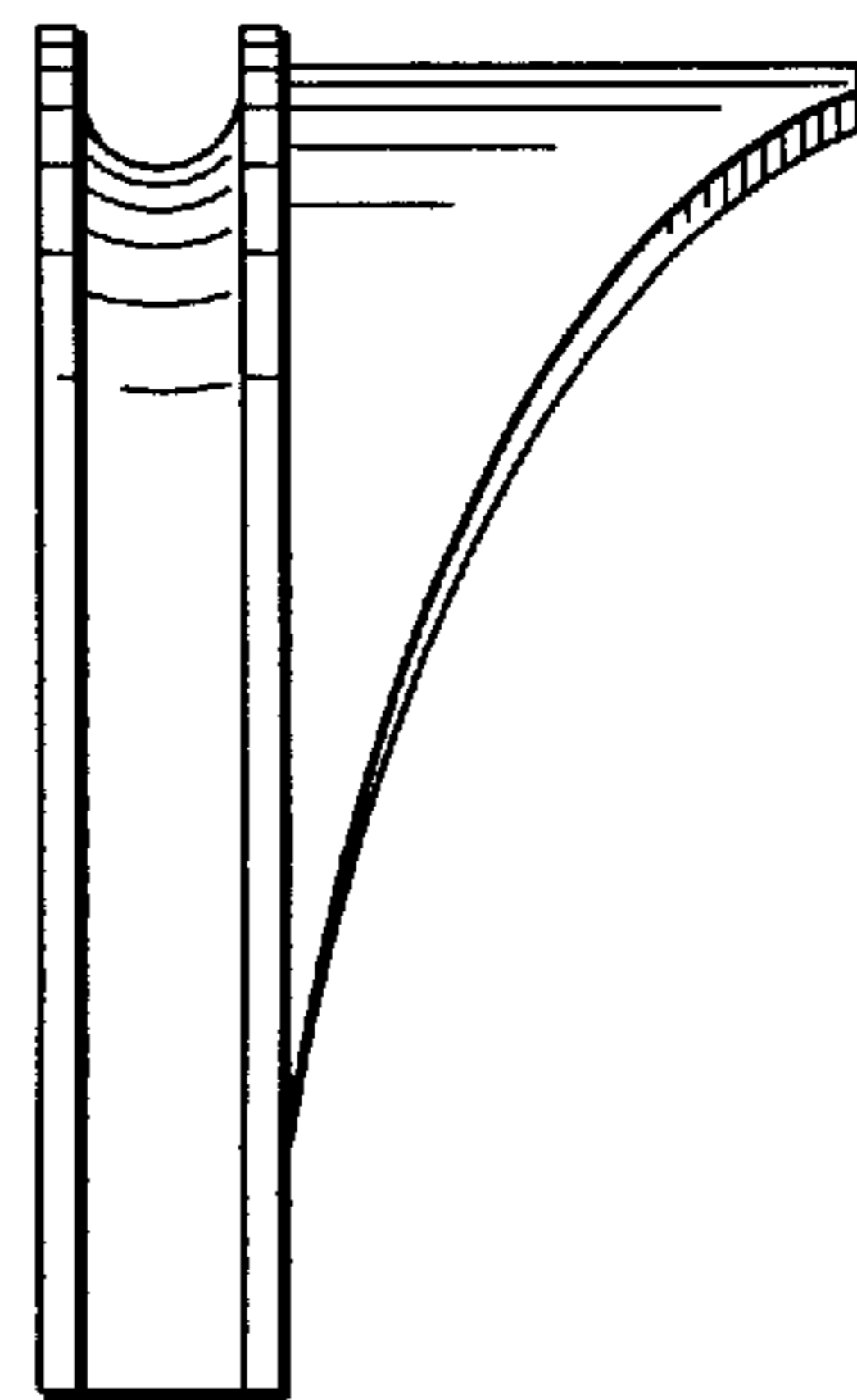

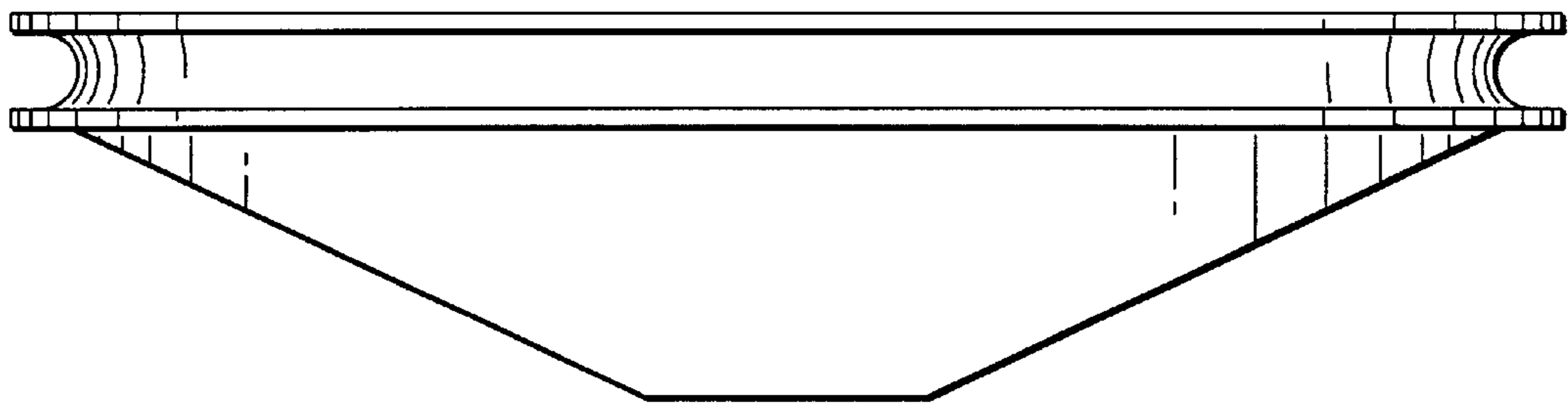

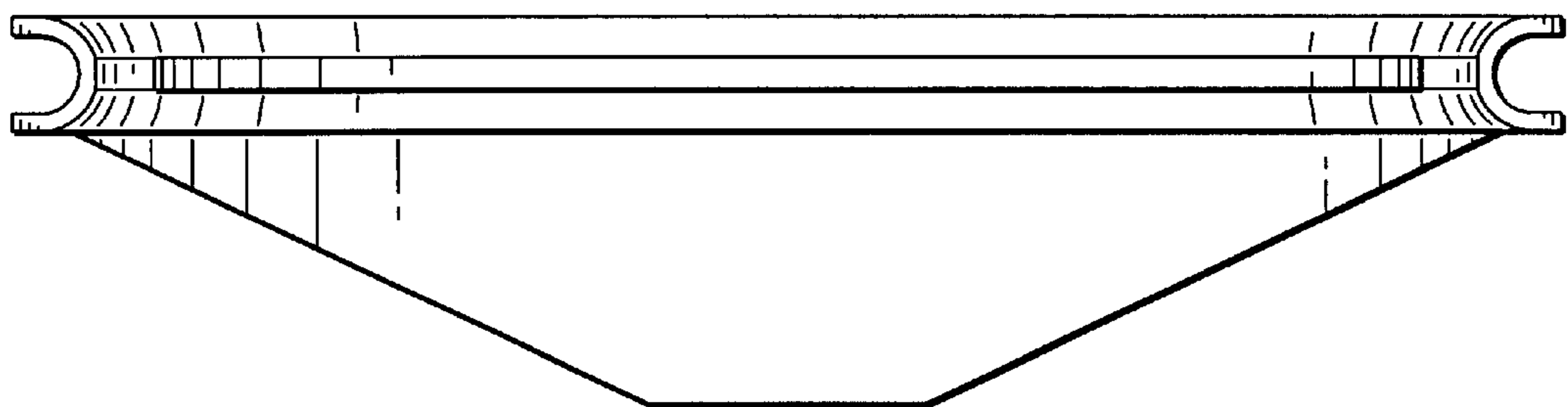
