(57) **CLAIM**

The ornamental design for a traditional large handheld shower head, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side perspective view of a traditional large handheld shower head showing our new design;

FIG. 2 is a front elevation view thereof;

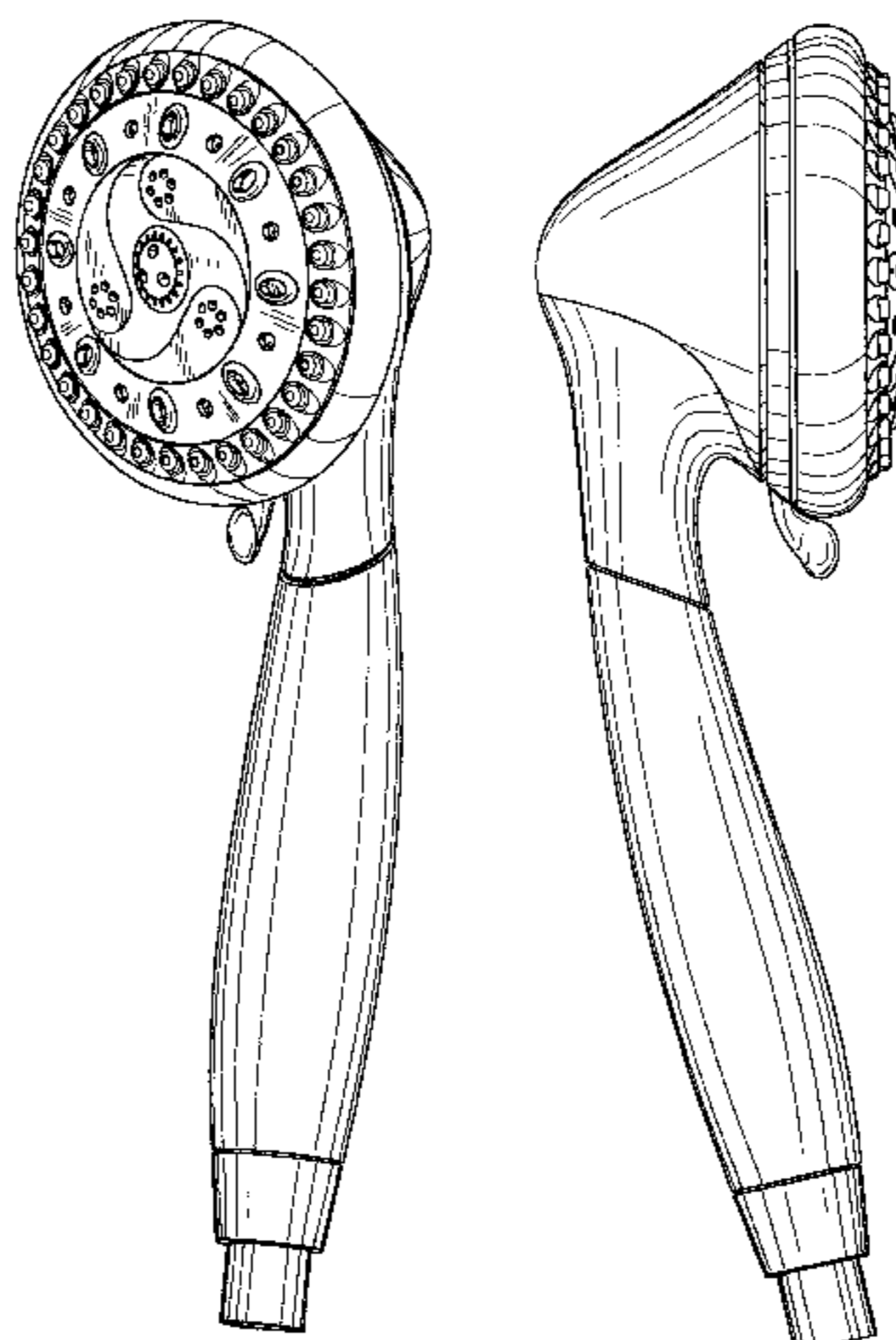
FIG. 3 is a left side elevation view thereof, of which the right side elevation view is a mirror image;

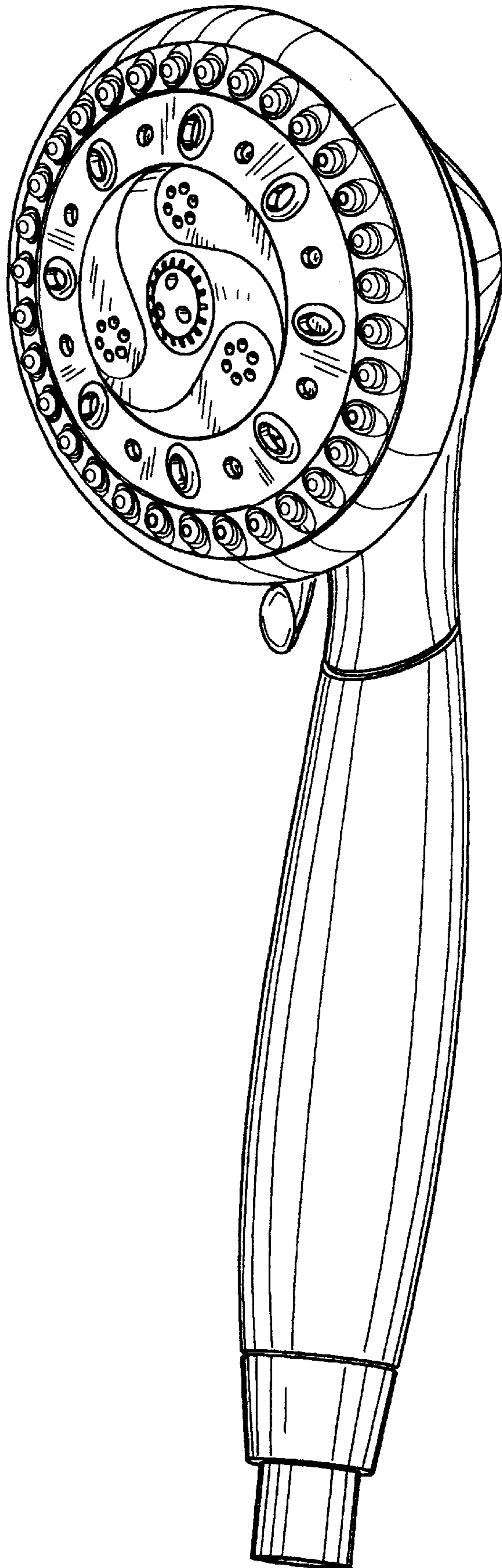

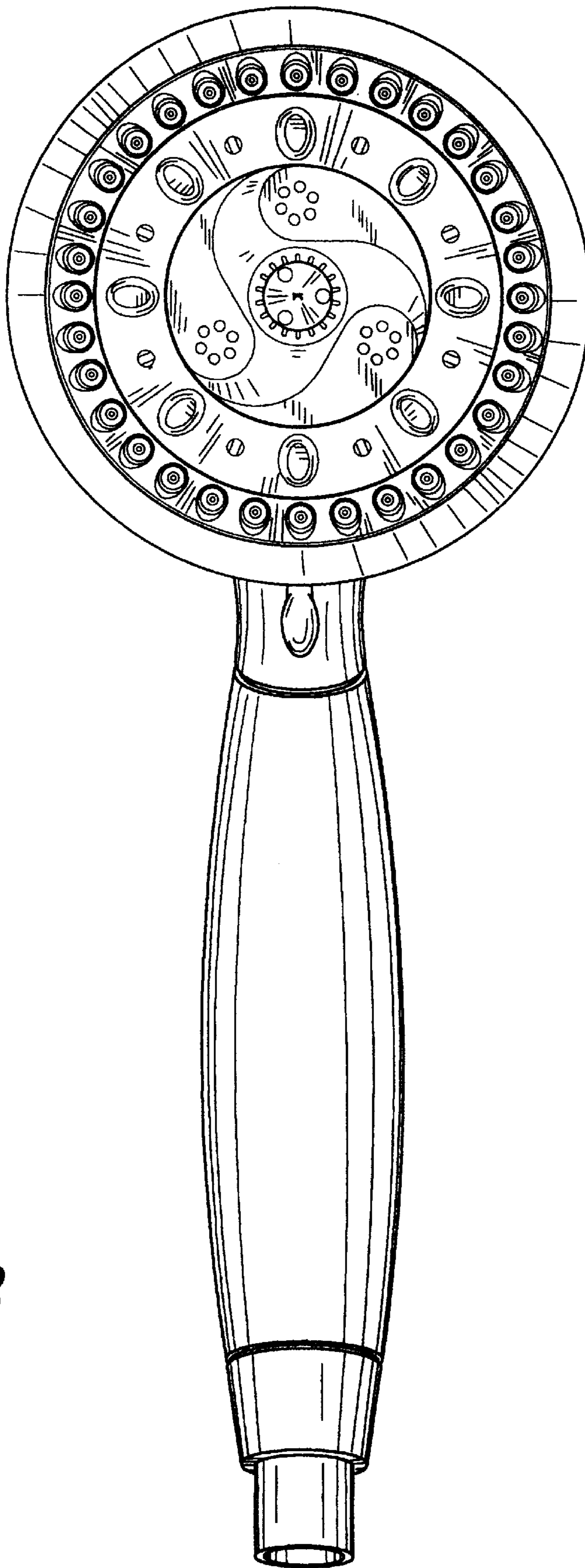

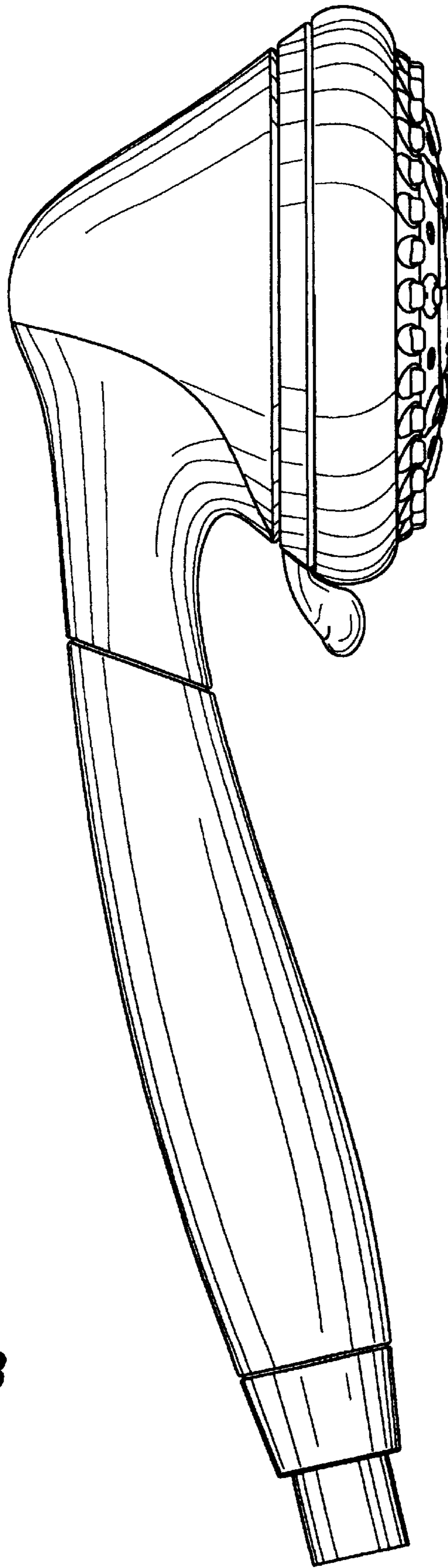

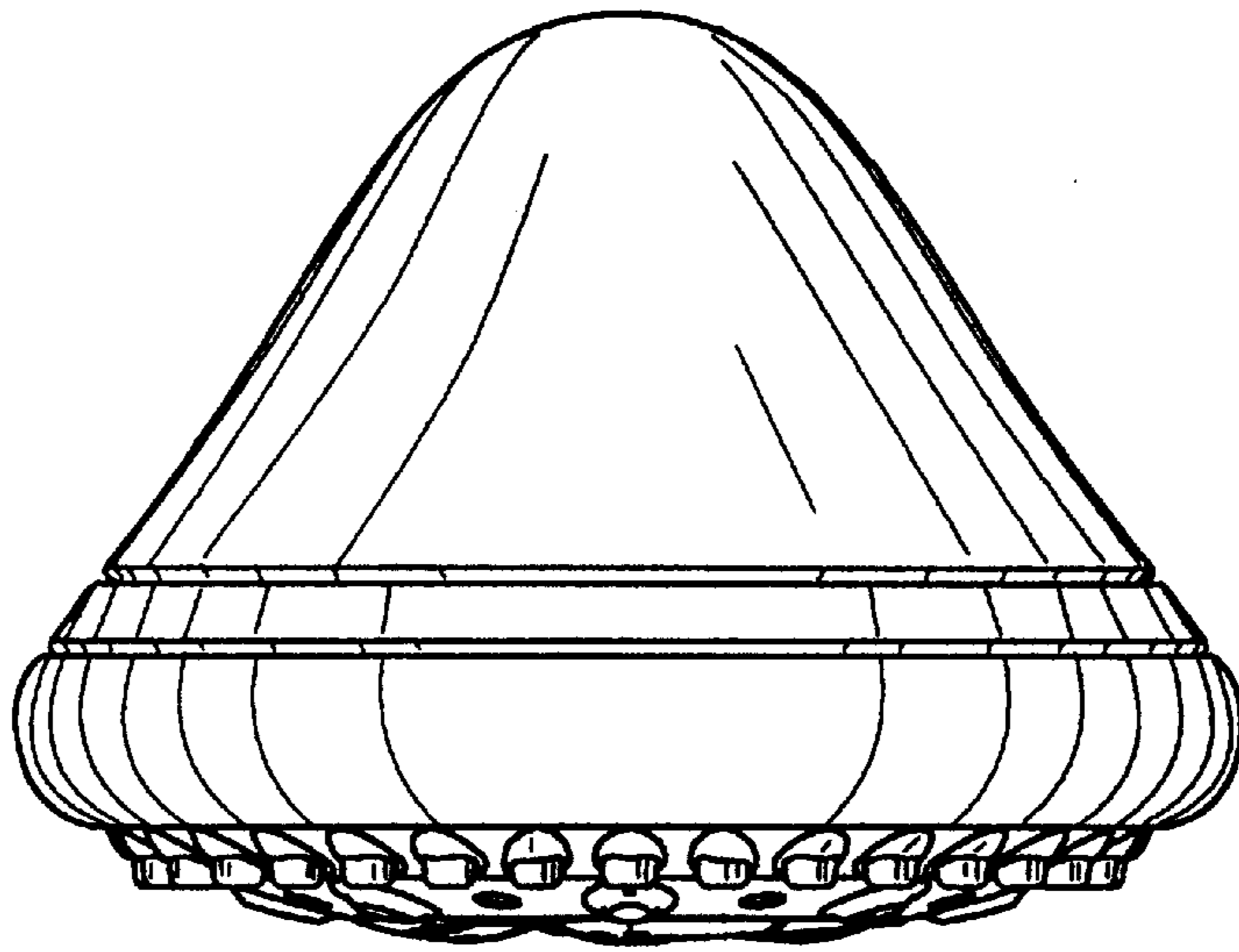

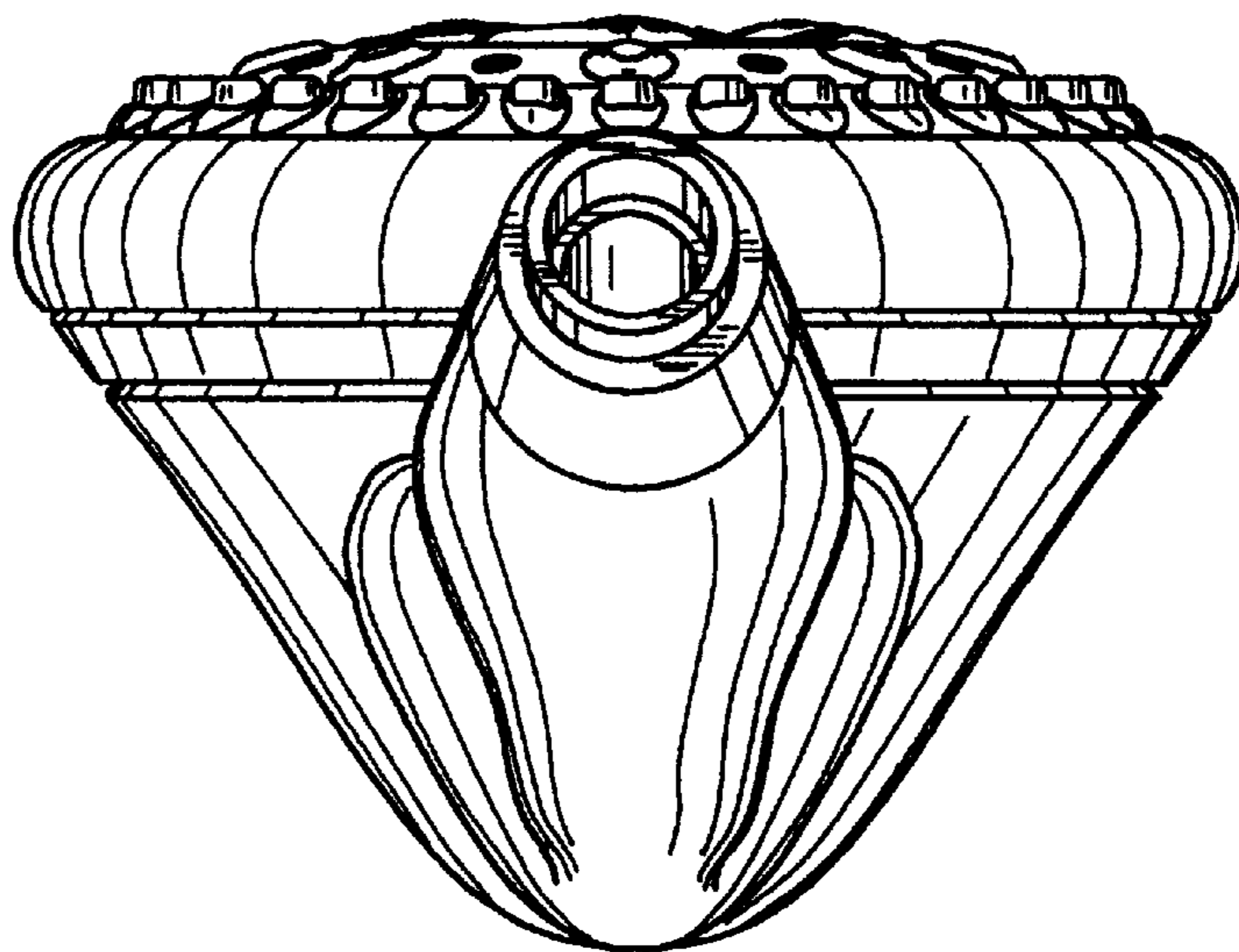

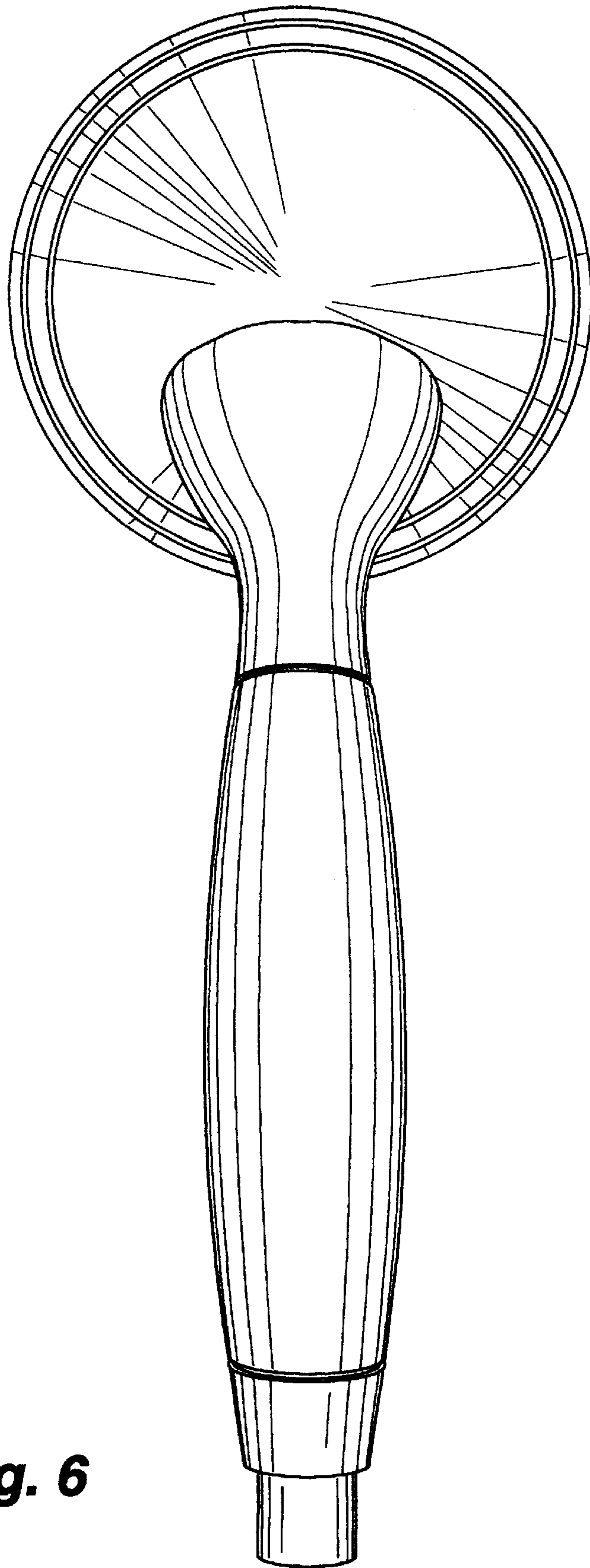
