FIG. 2 is a top plan view thereof;

FIG. 3 is a side elevation view of one side thereof;

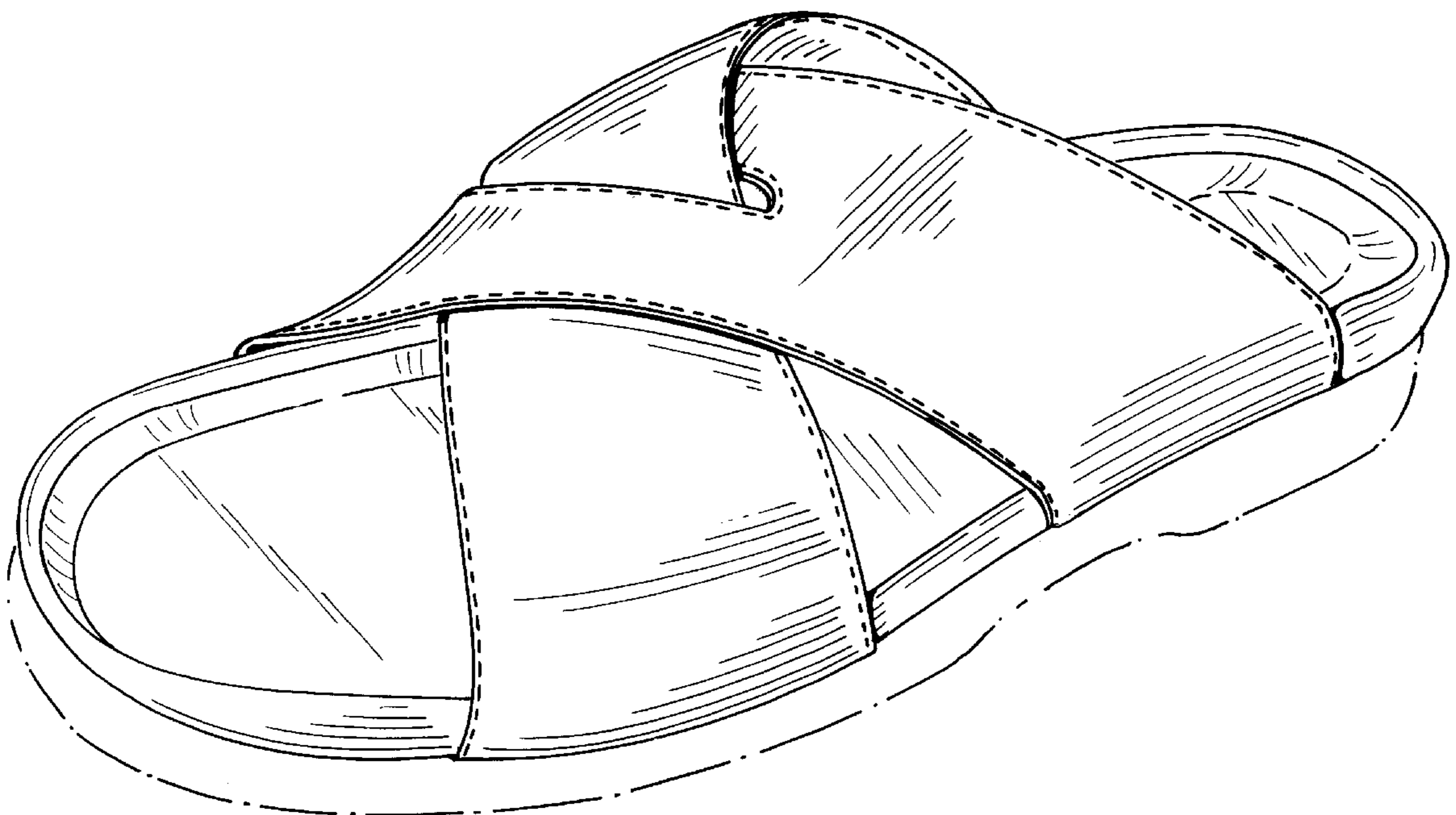
FIG. 4 is a side elevation view of the other side thereof;

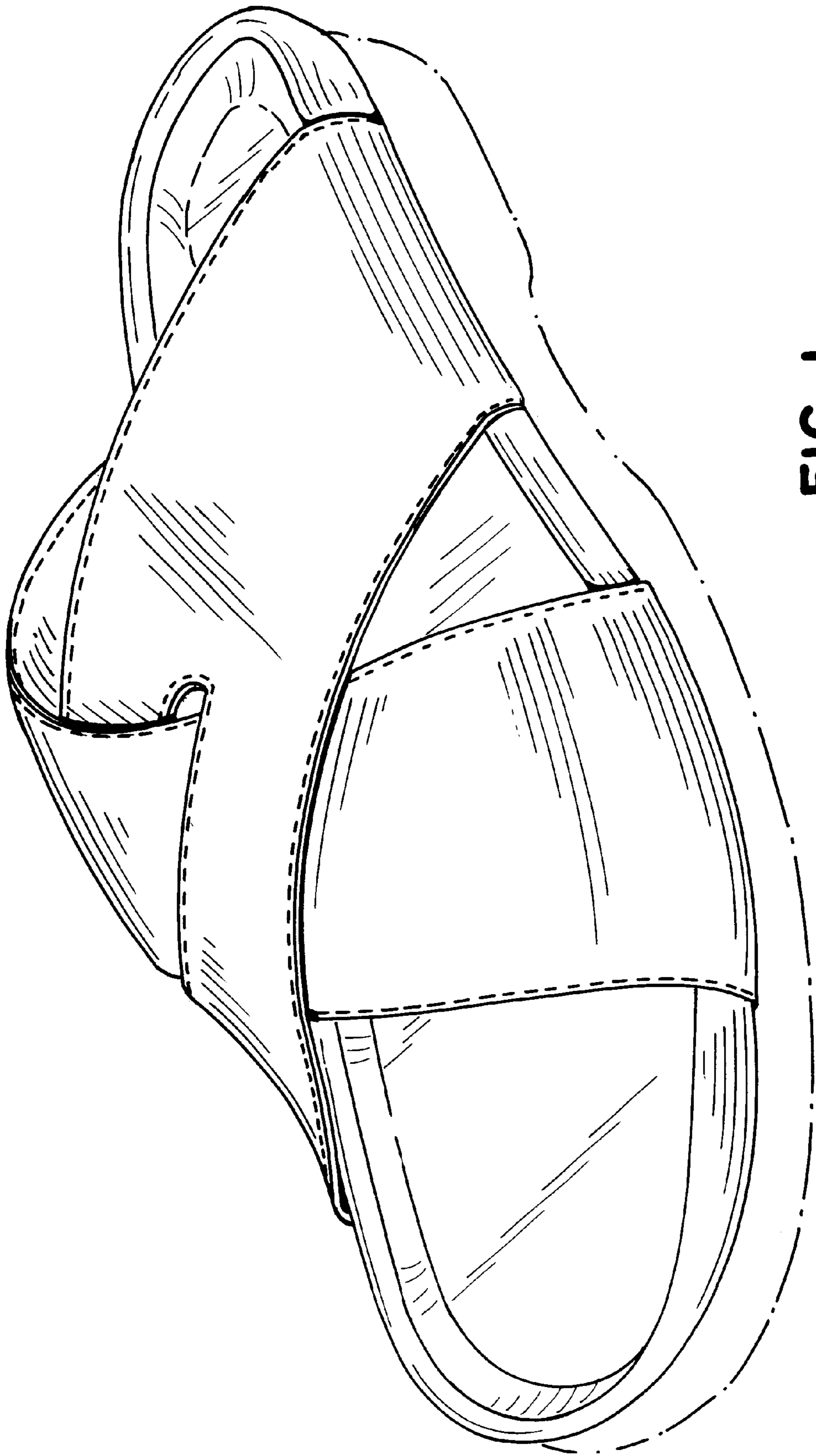

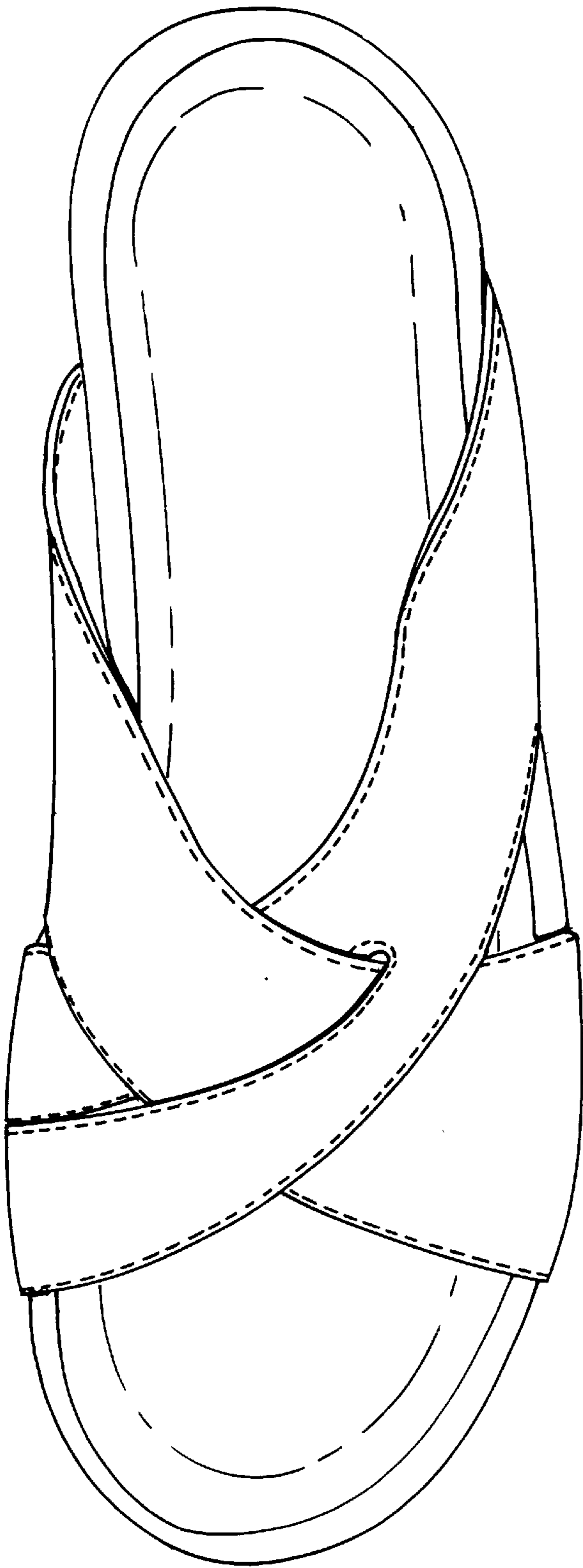

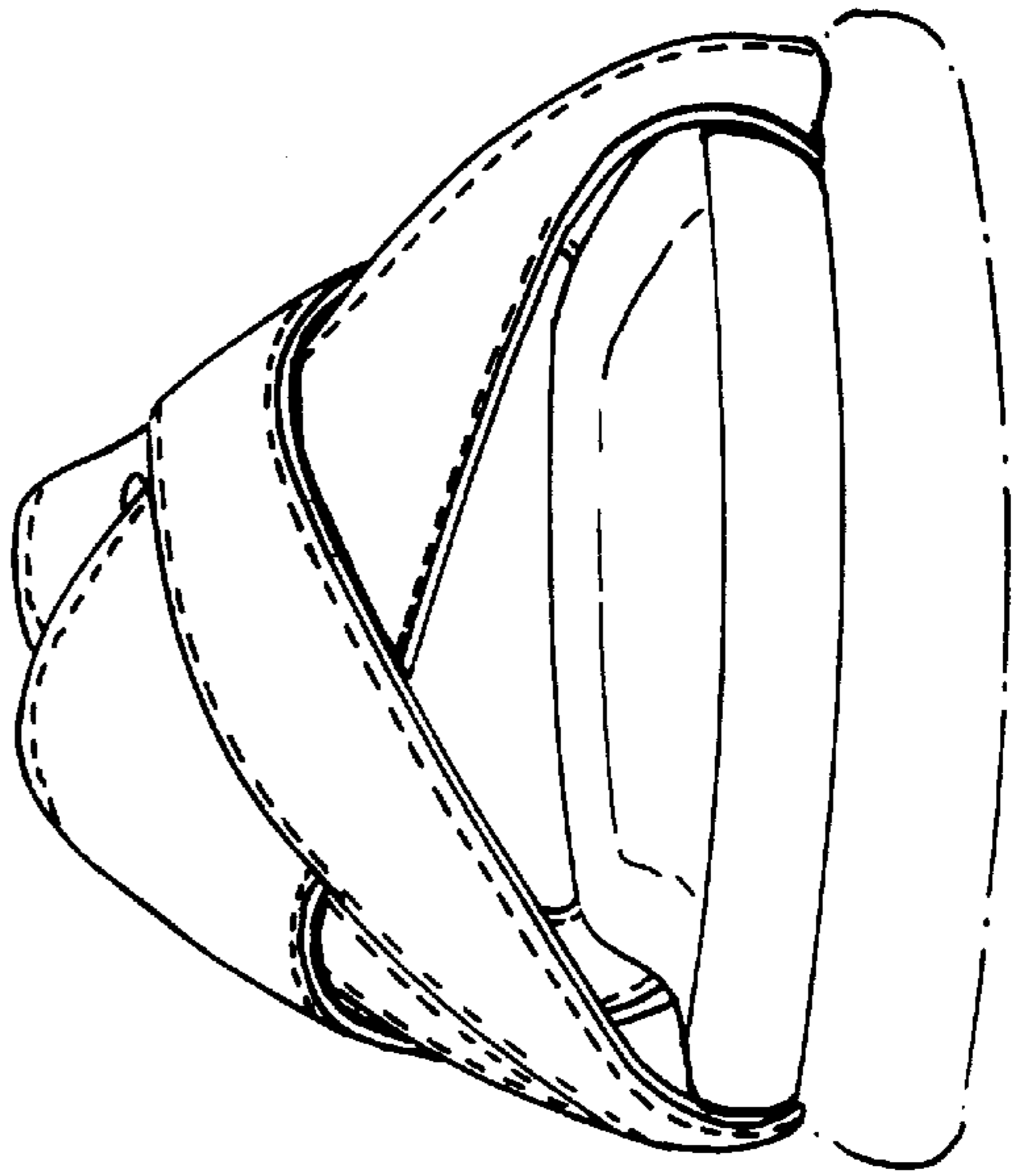

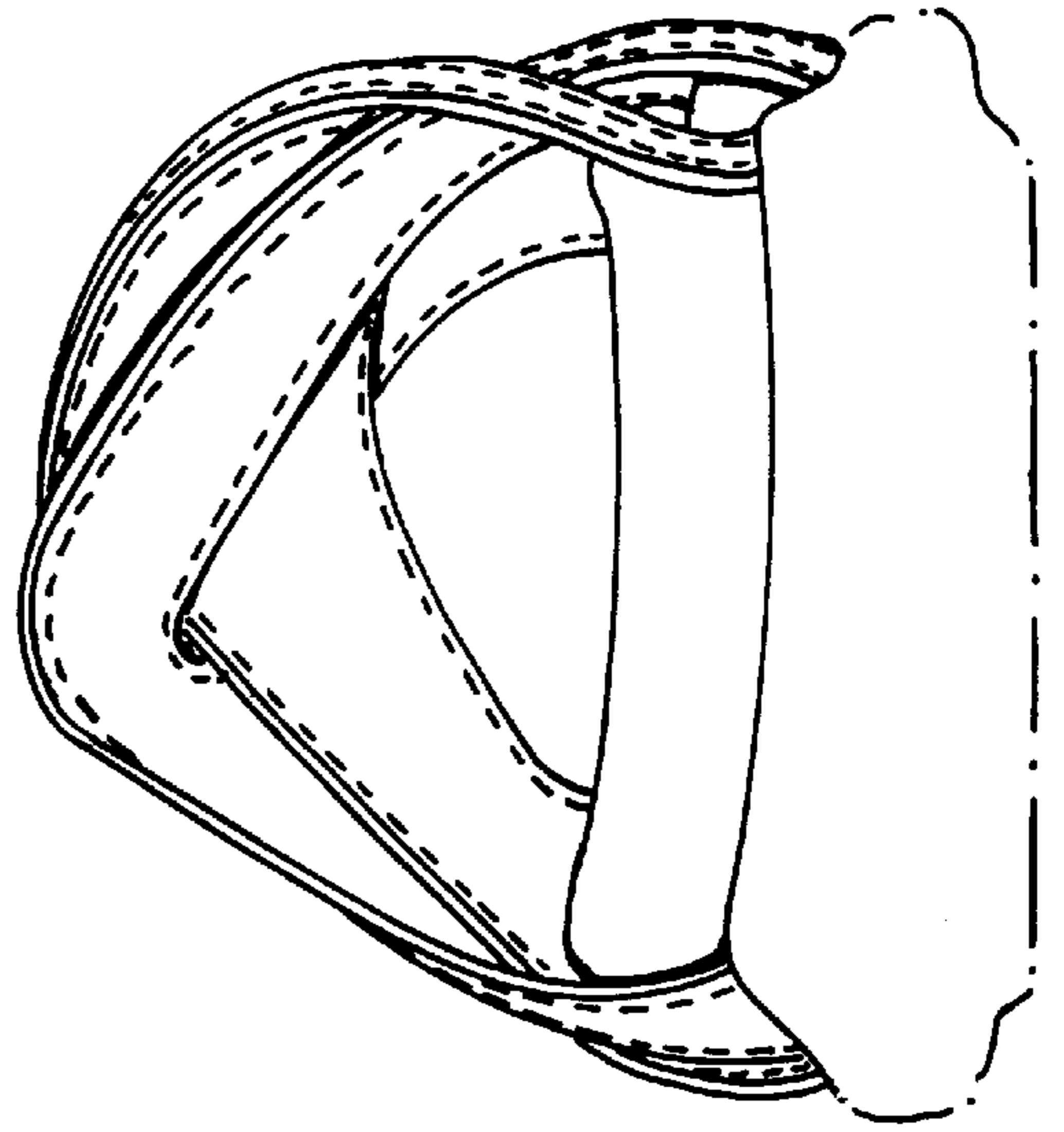

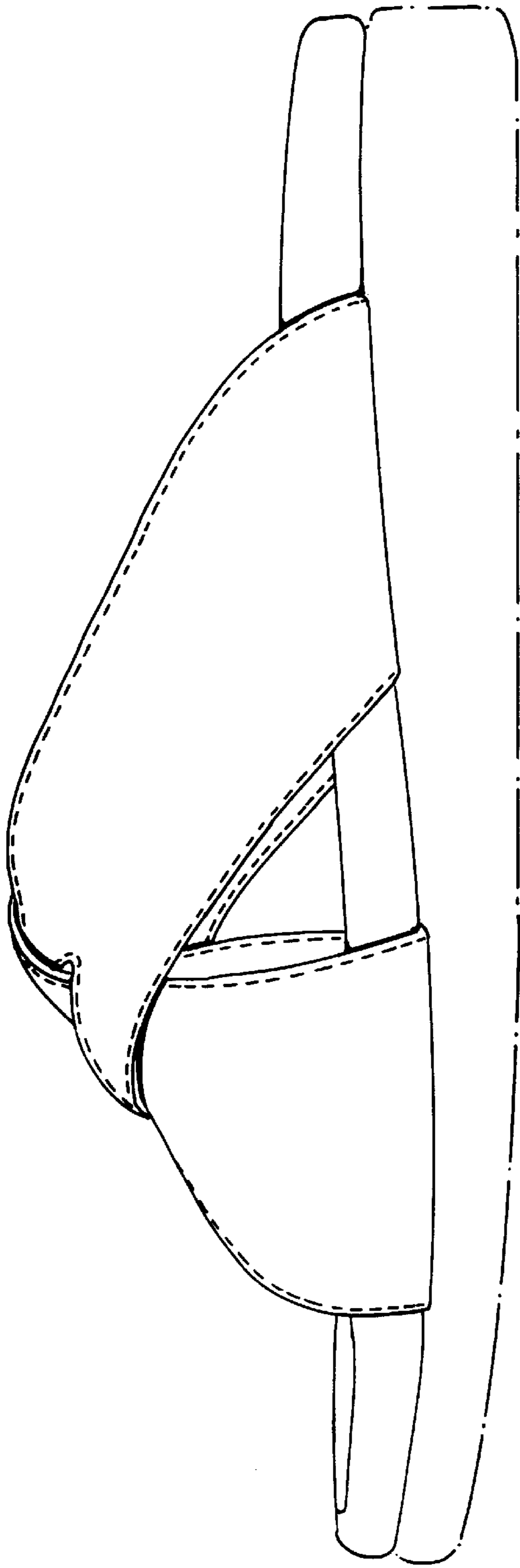
