(57) **CLAIM**

The ornamental design for the furniture trim piece, as shown and described.

DESCRIPTION

FIG. 1 is a left rear perspective view of a furniture trim piece showing my new design;
 FIG. 2 is a left side view thereof;
 FIG. 3 is an end view, the opposite end view being a mirror image thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a rear view thereof; and,
 FIG. 7 is an enlarged fragmented view showing one of the projections on the rear of the piece.

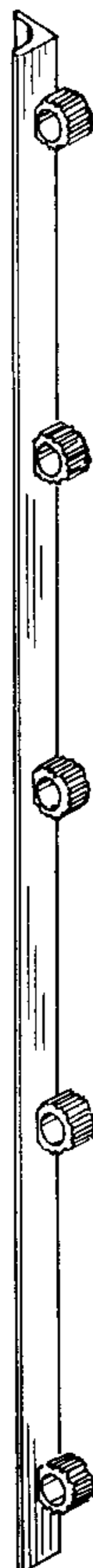

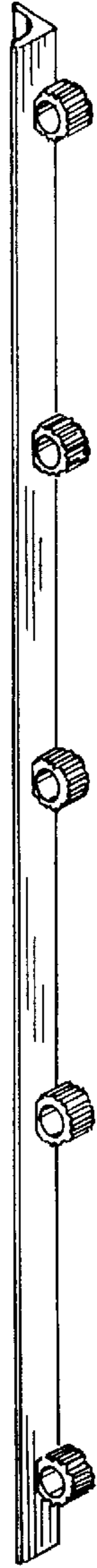

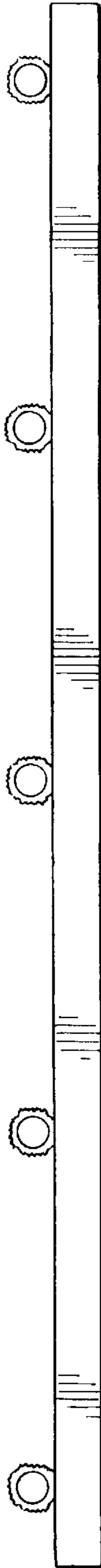

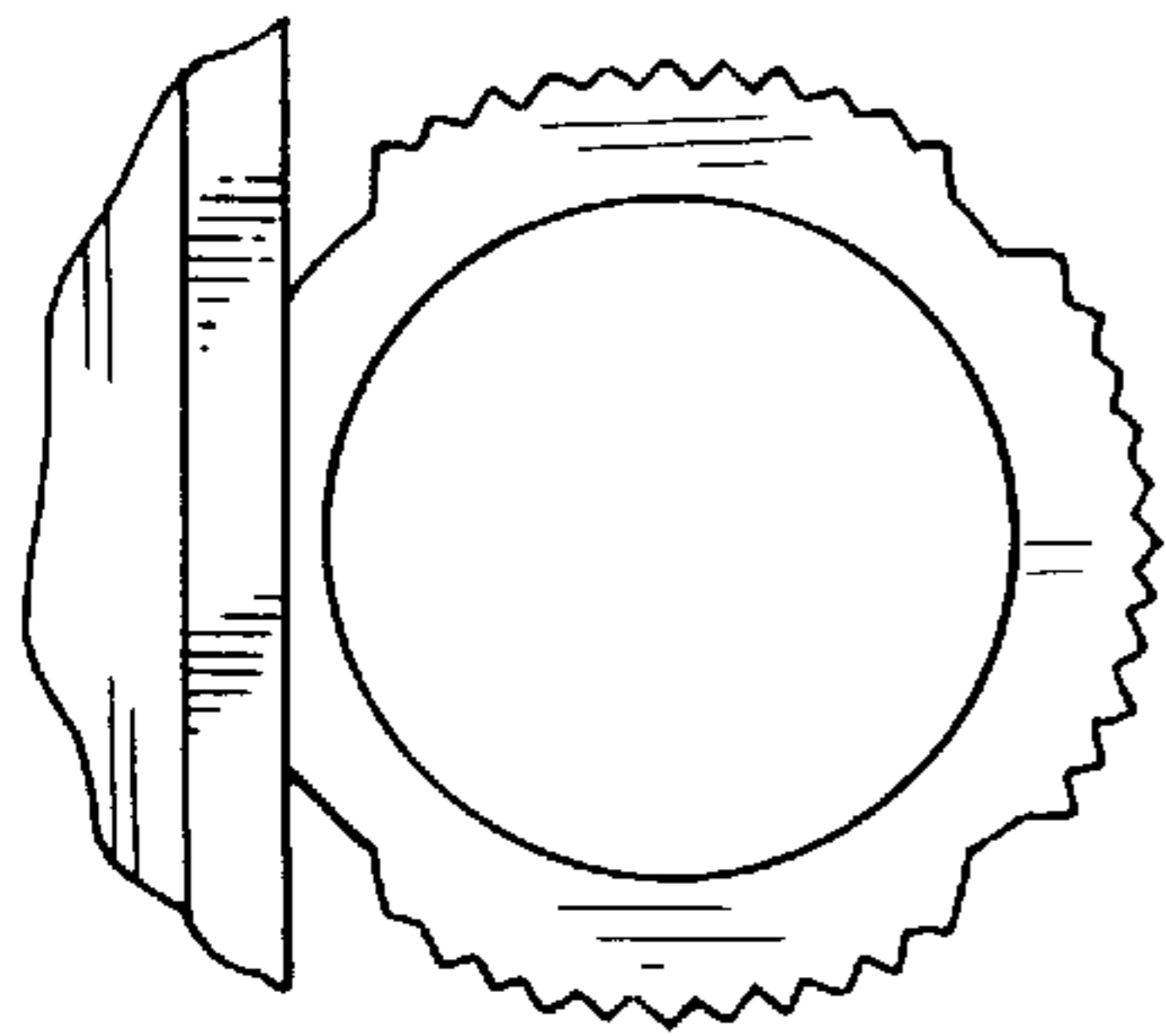
