(57) **CLAIM**

The ornamental design for a toaster, as shown and described.

DESCRIPTION

FIG. 1 is an elevation view of the front of a toaster constructed in accordance with one preferred embodiment of the invention.

FIG. 2 is an elevation view of the left side of the toaster shown in FIG. 1.

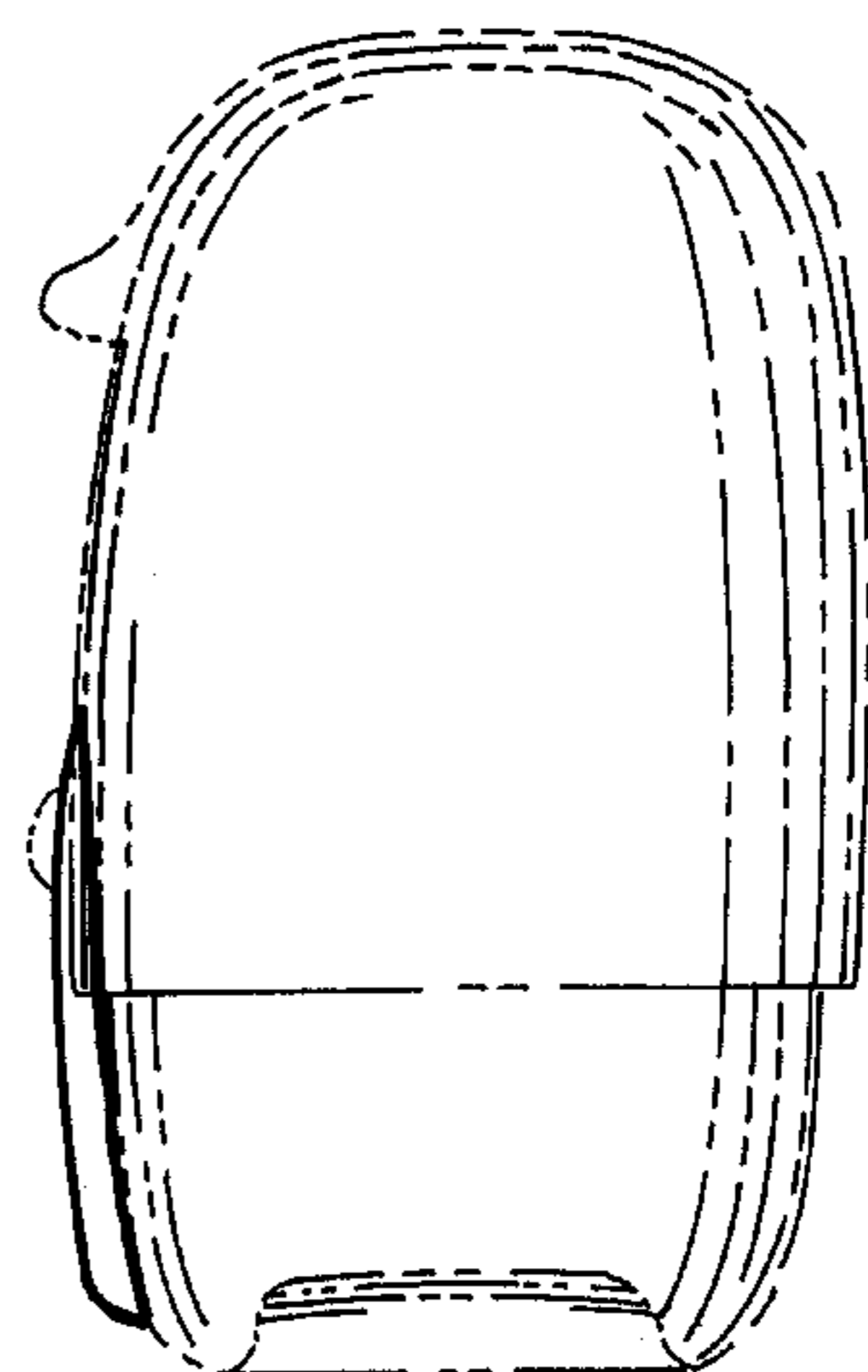
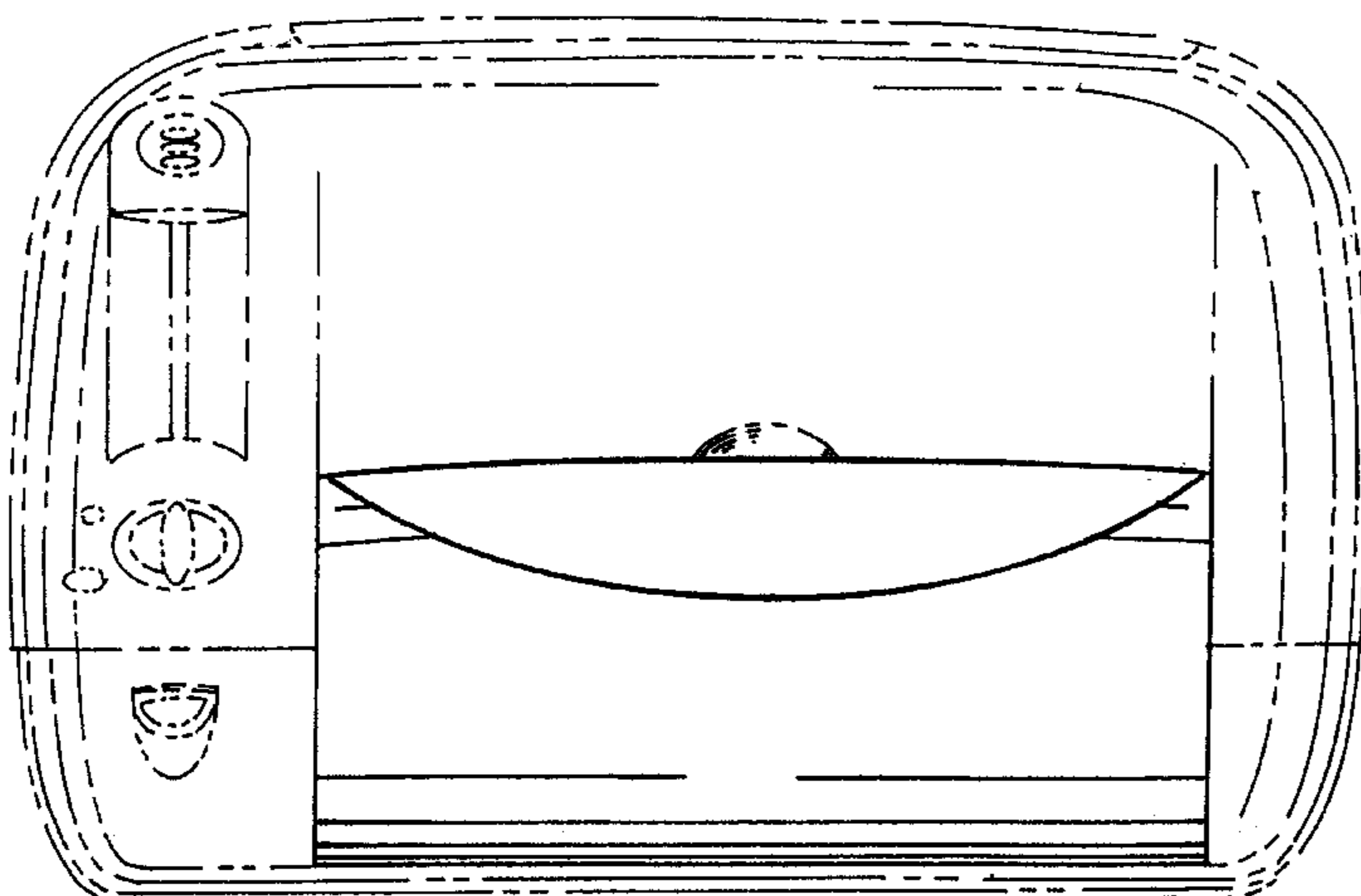
FIG. 3 is an elevation view of the right side of the toaster shown in FIGS. 1 and 2.

FIG. 4 is a top view of the toaster shown in FIGS. 1, 2 and 3; and,

FIG. 5 is a bottom view of the toaster shown in FIGS. 1, 2, 3 and 4.

The broken lines shown in all of the drawings are for illustrative purposes only and form no part of the claimed design. The rear of the toaster forms no part of the claimed design.

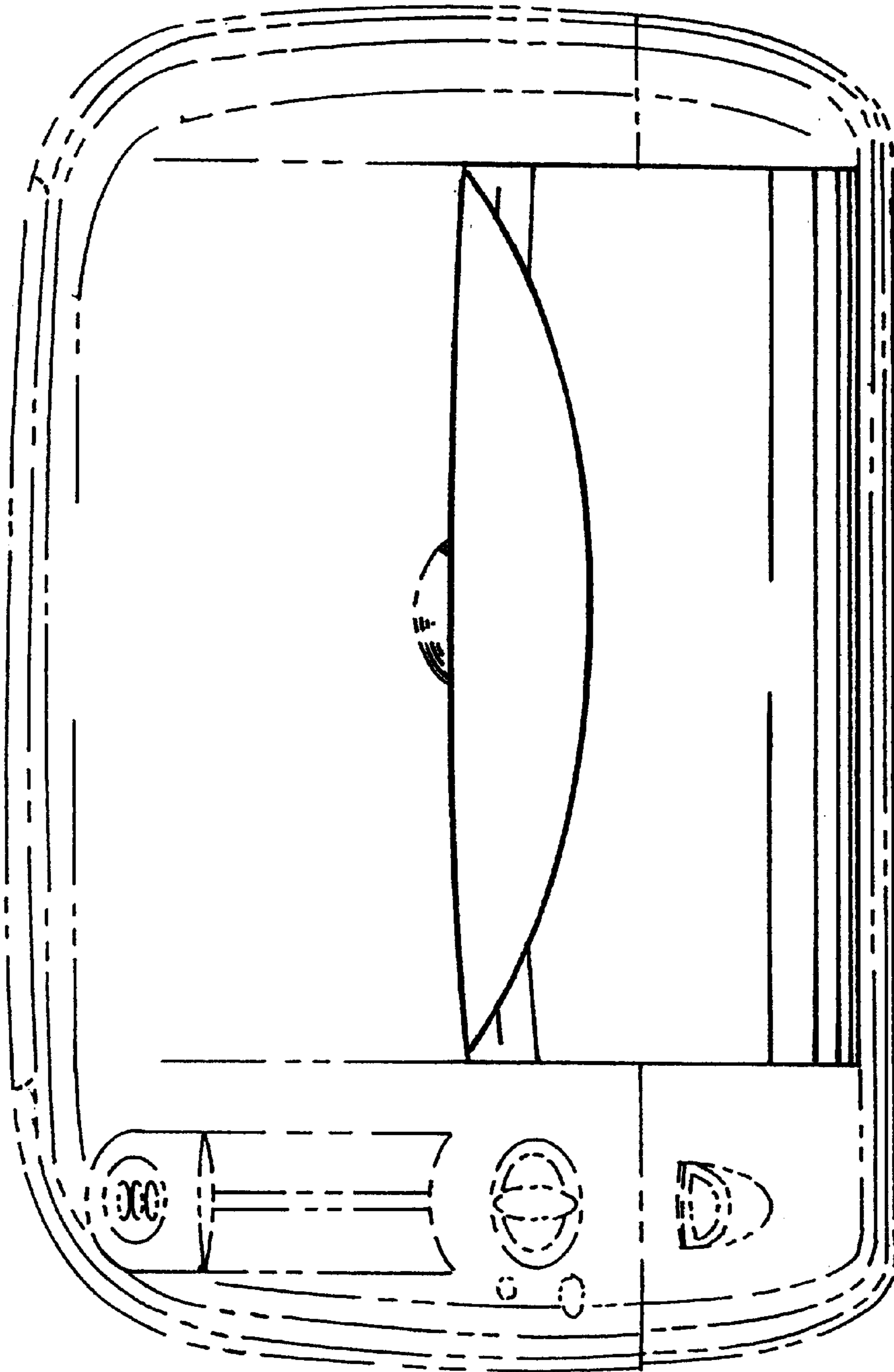

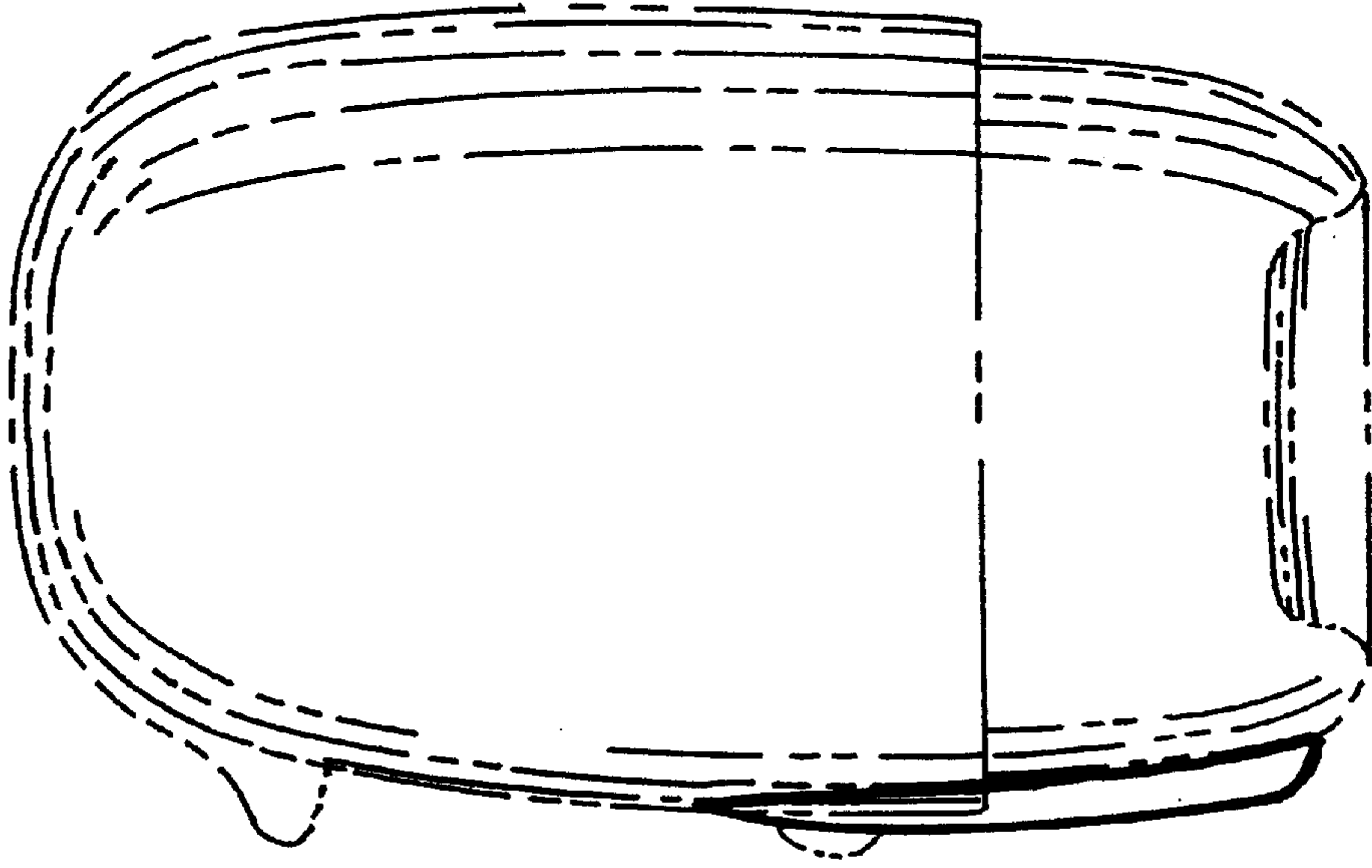

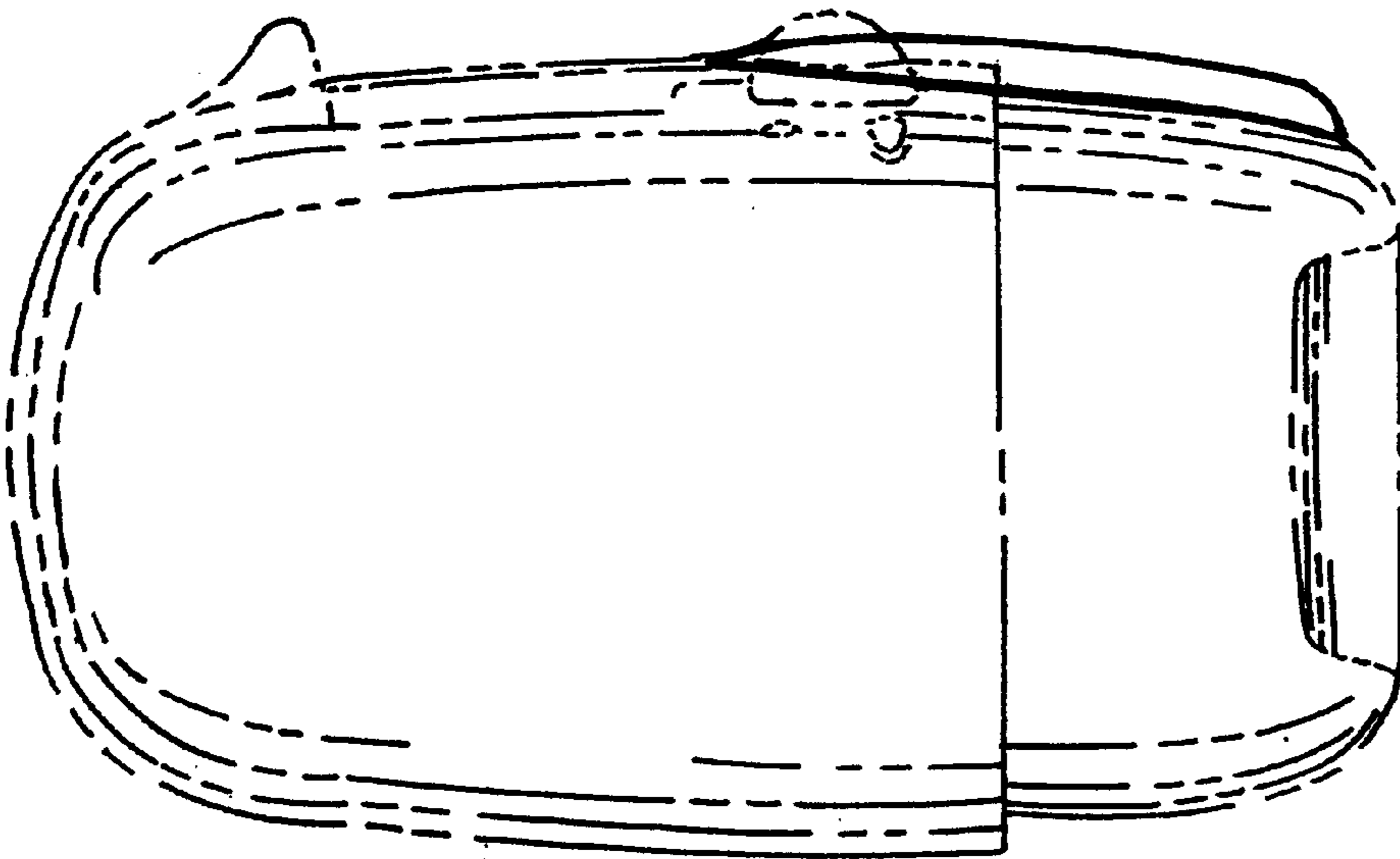

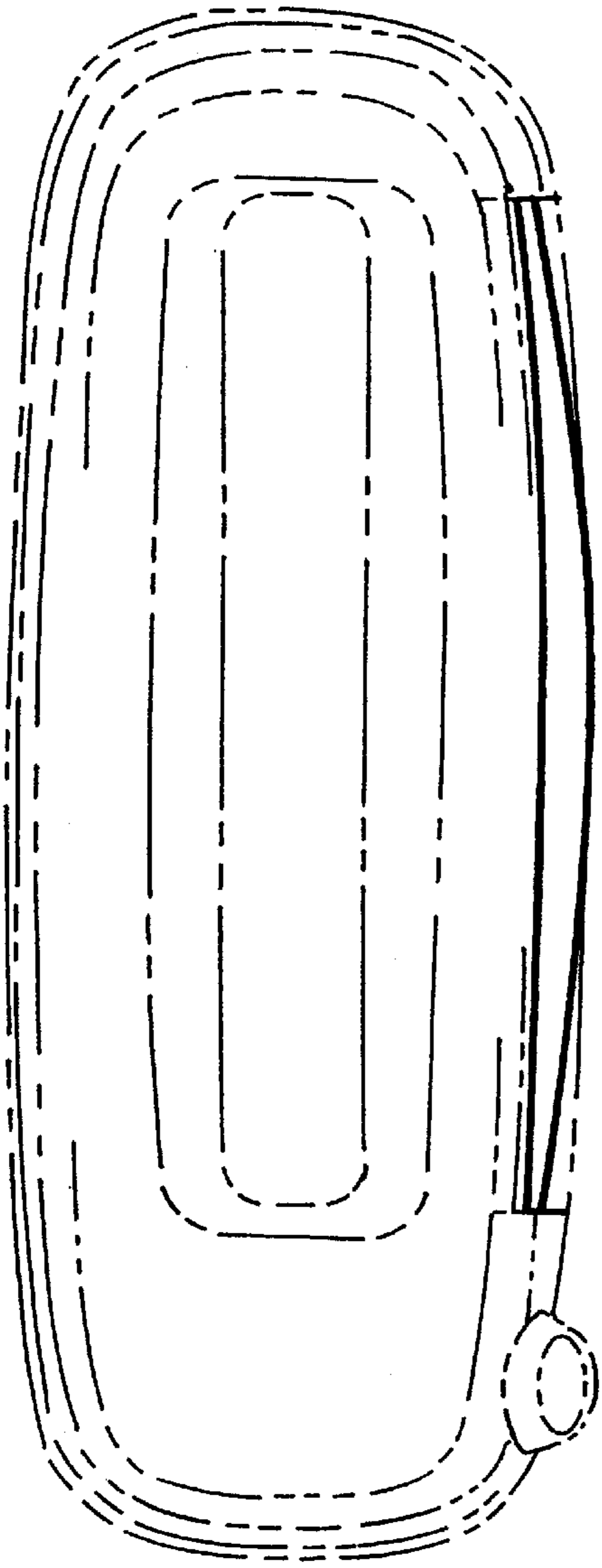

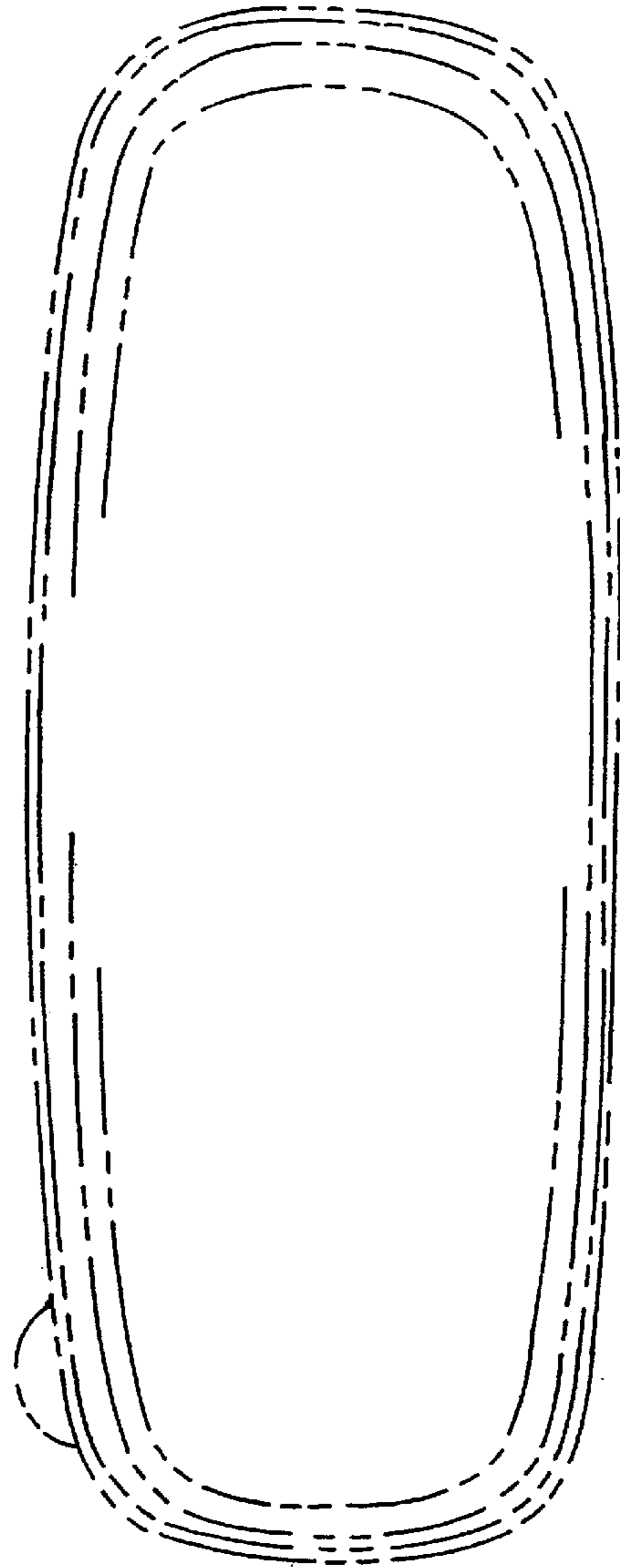
