The ornamental design for a sandpaper package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a sandpaper package design.

FIG. 2 is a front view of the sandpaper package of FIG. 1.

FIG. 3 is a back view of the sandpaper package of FIG. 1.

FIG. 4 is a right side view of the sandpaper package of FIG. 1.

FIG. 7 is a bottom view of the sandpaper package of FIG. 1.

FIG. 8 is a perspective view of a second embodiment of the sandpaper package design.

FIG. 10 is a back view of the sandpaper package of FIG. 8.

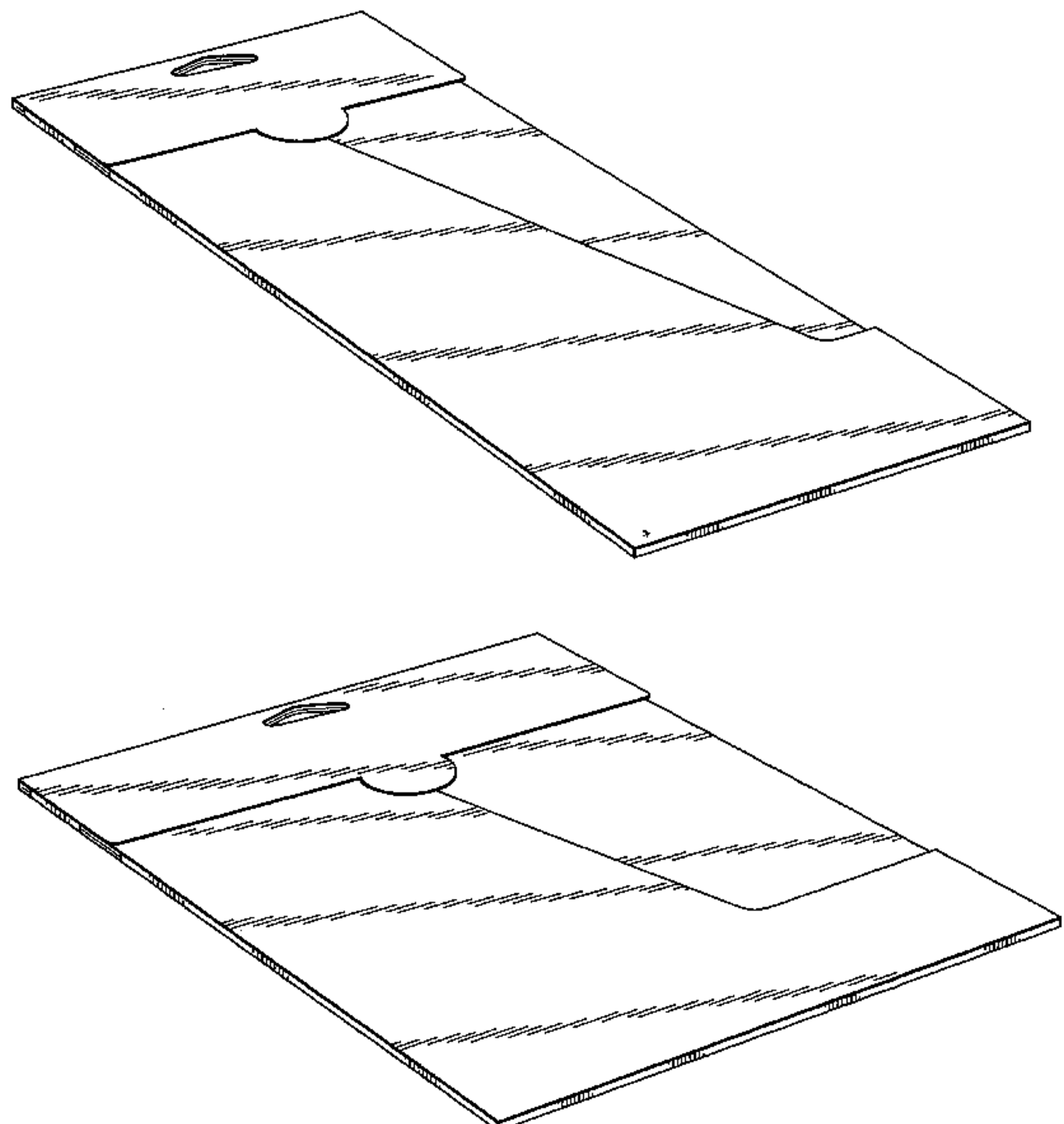
FIG. 11 is a right side view of the sandpaper package of FIG. 8.

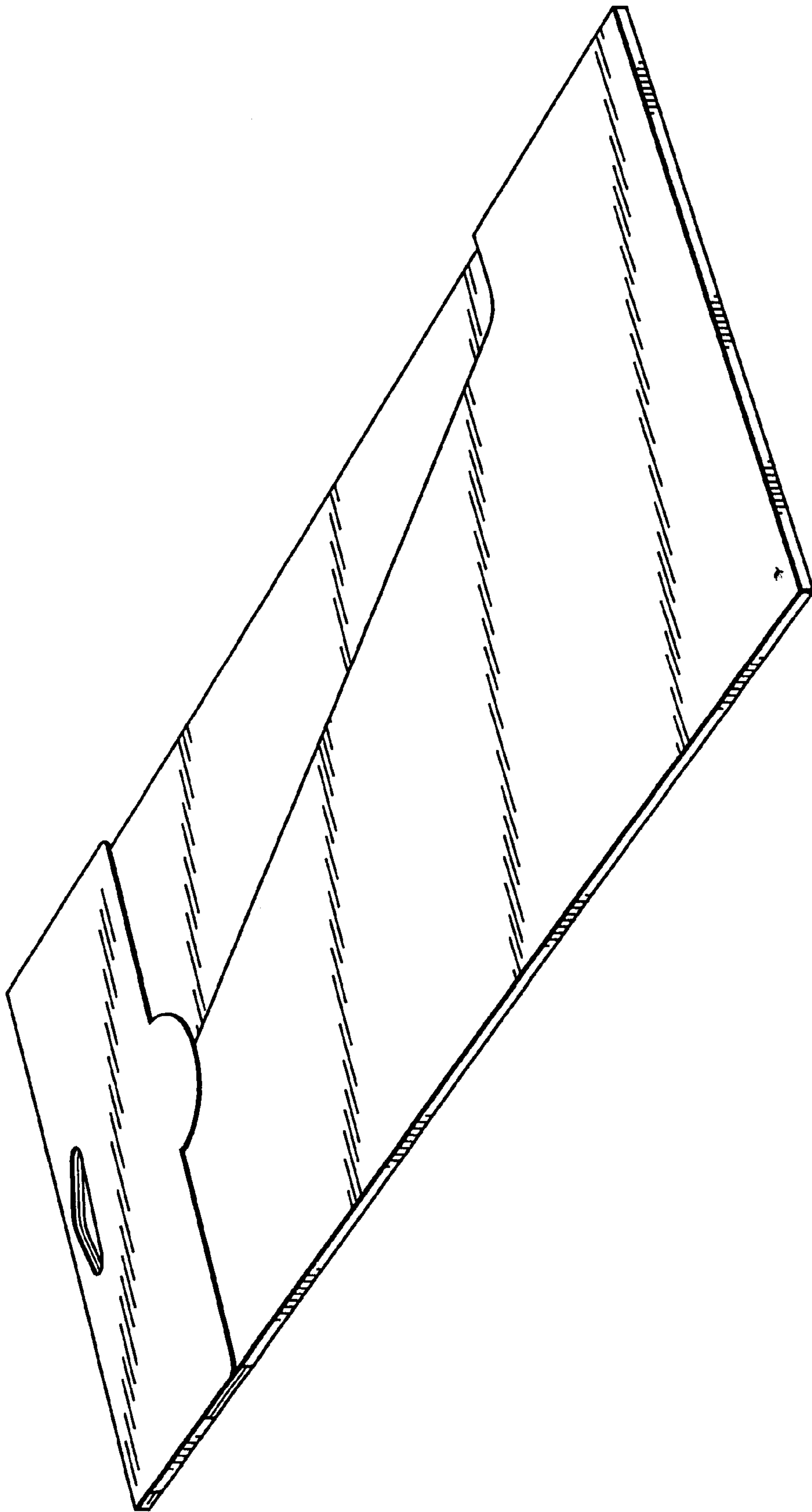
FIG. 12 is a left side view of the sandpaper package of FIG. 8.

FIG. 13 is a top view of the sandpaper package of FIG. 8; and,

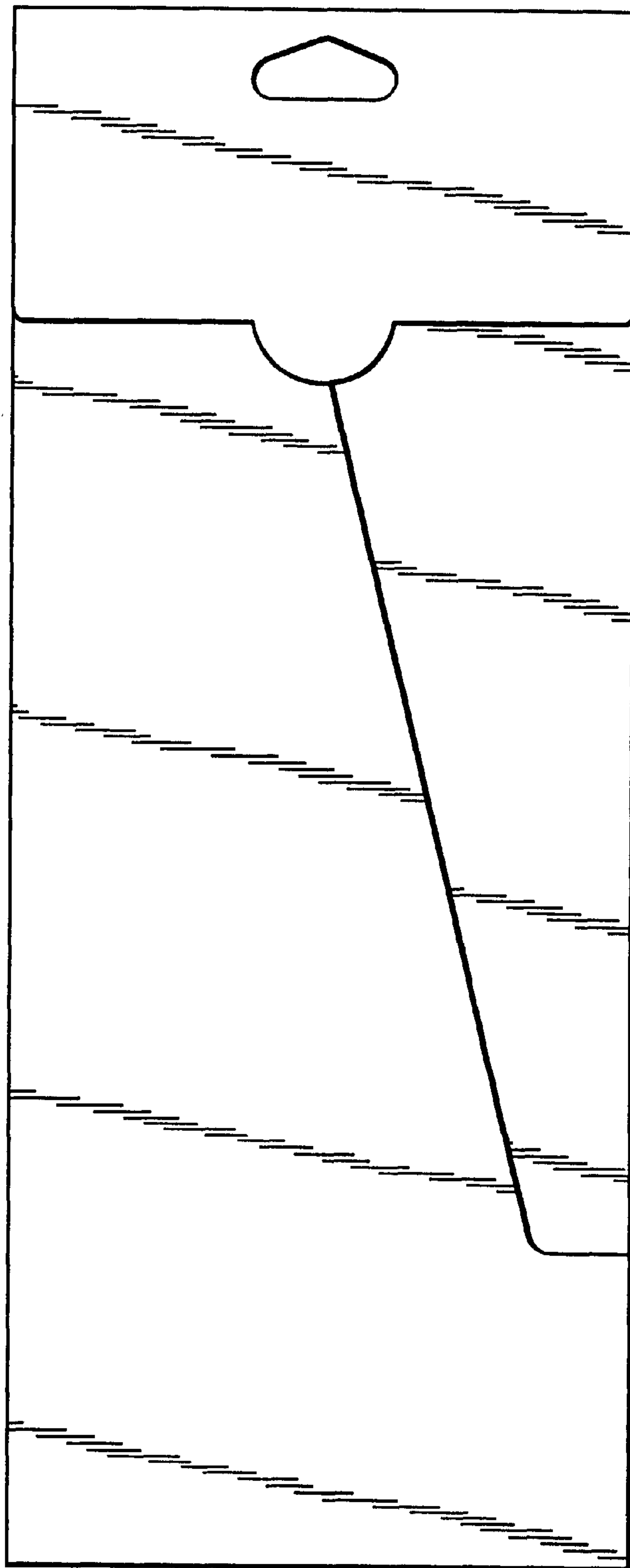
FIG. 14 is a bottom view of the sandpaper package of FIG. 8.

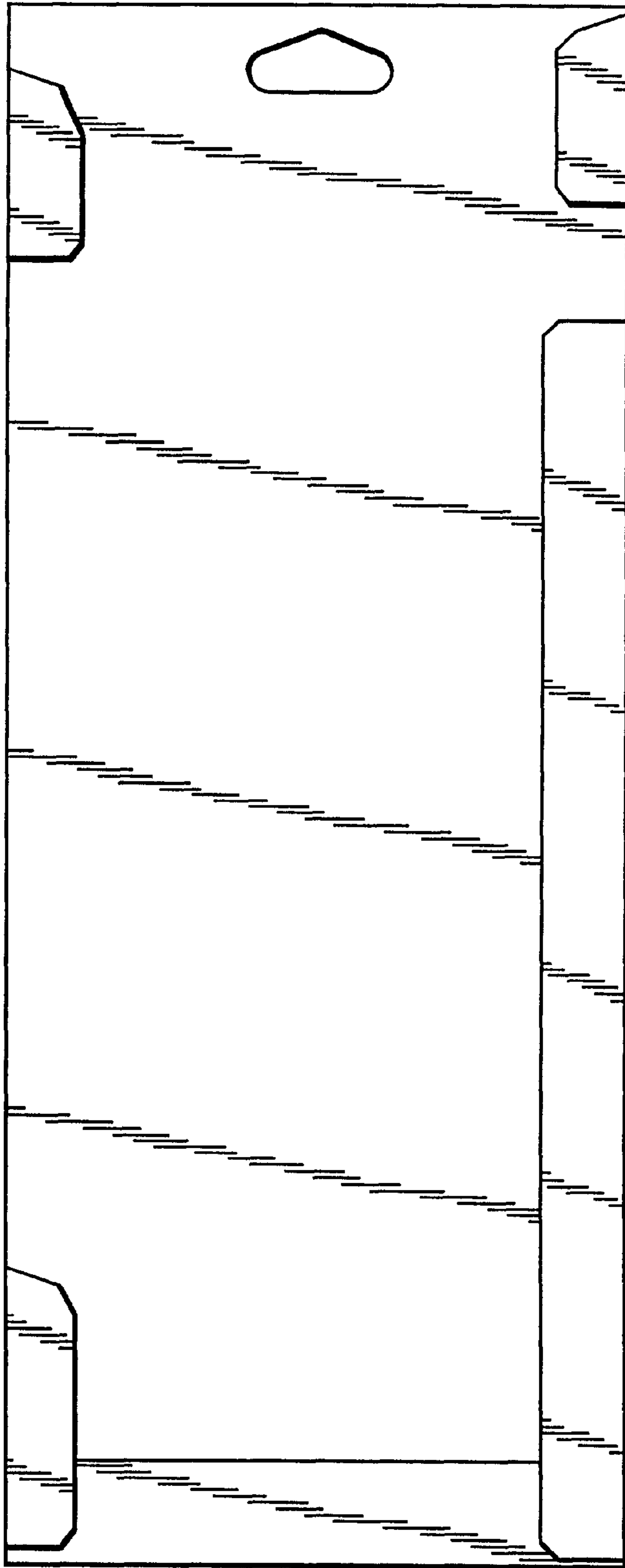

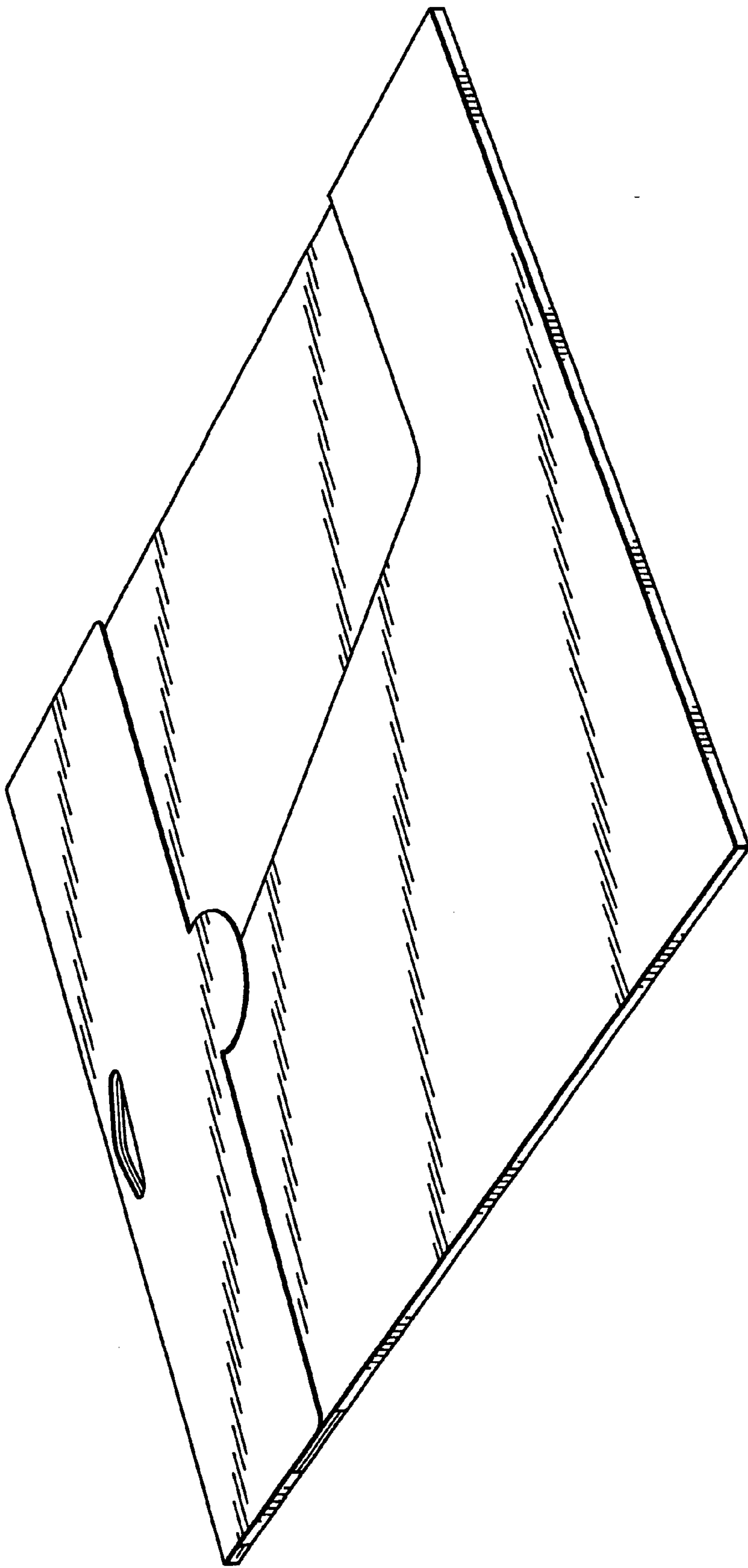

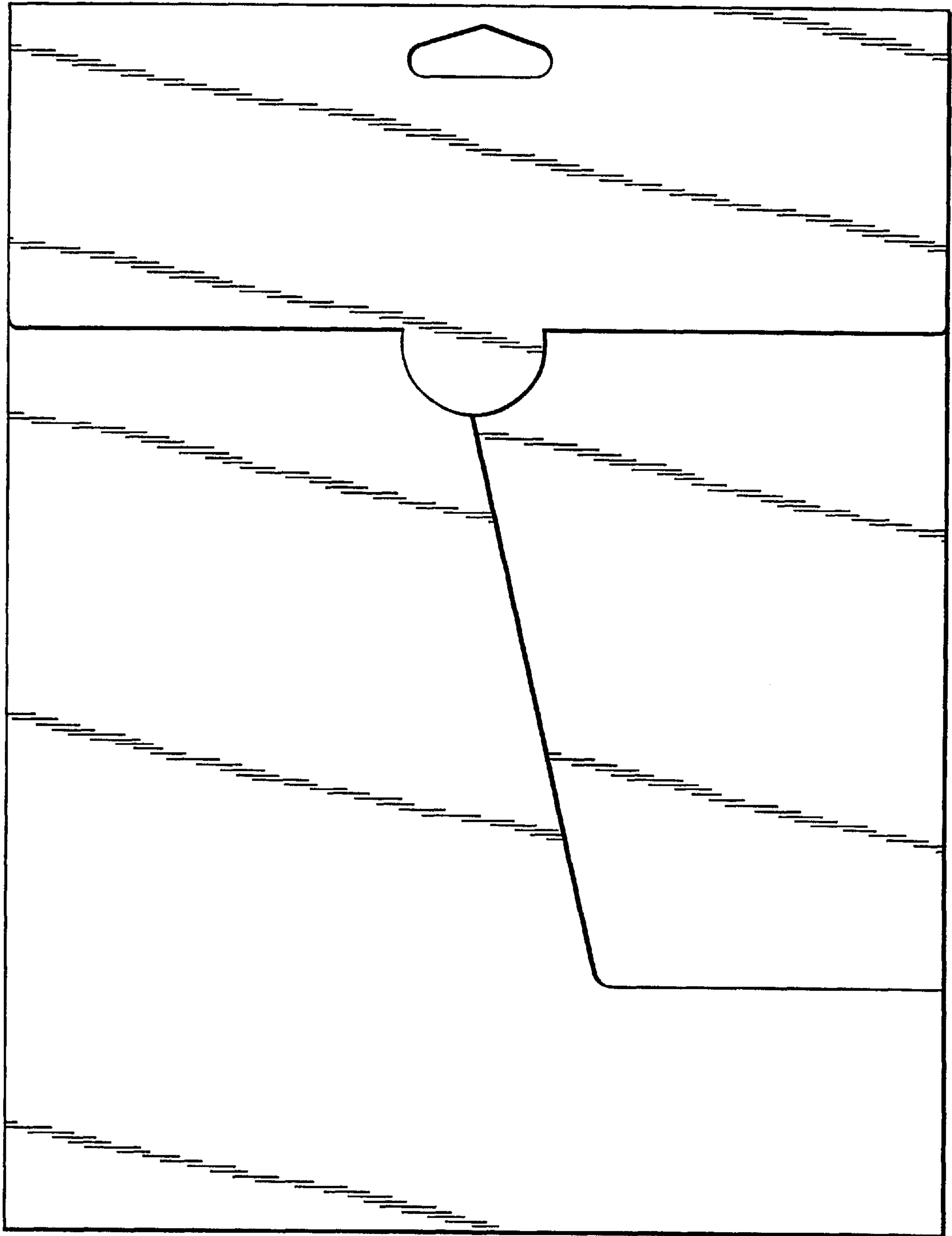

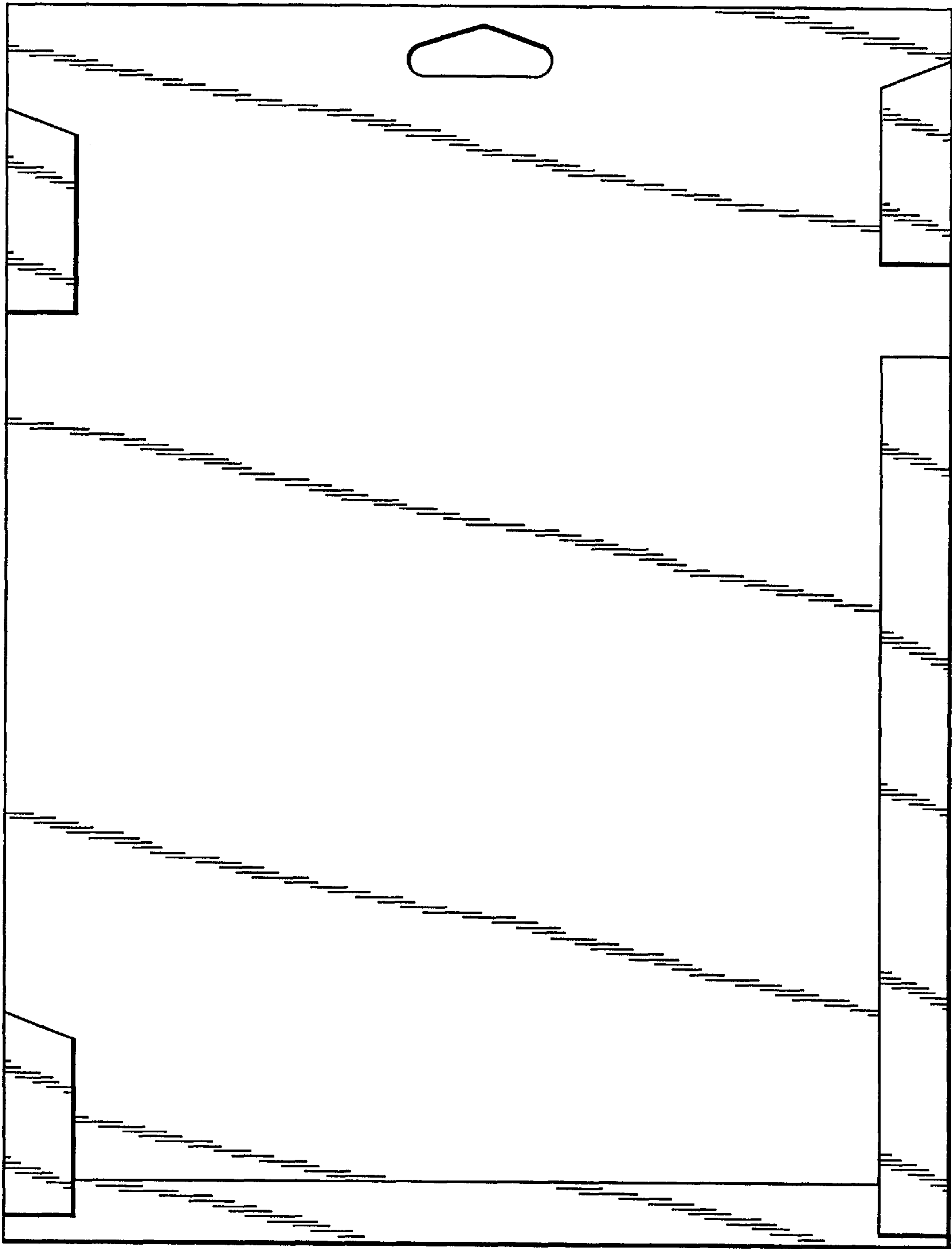
