FIG. 1 is a perspective view of a bottle, embodying our new design;

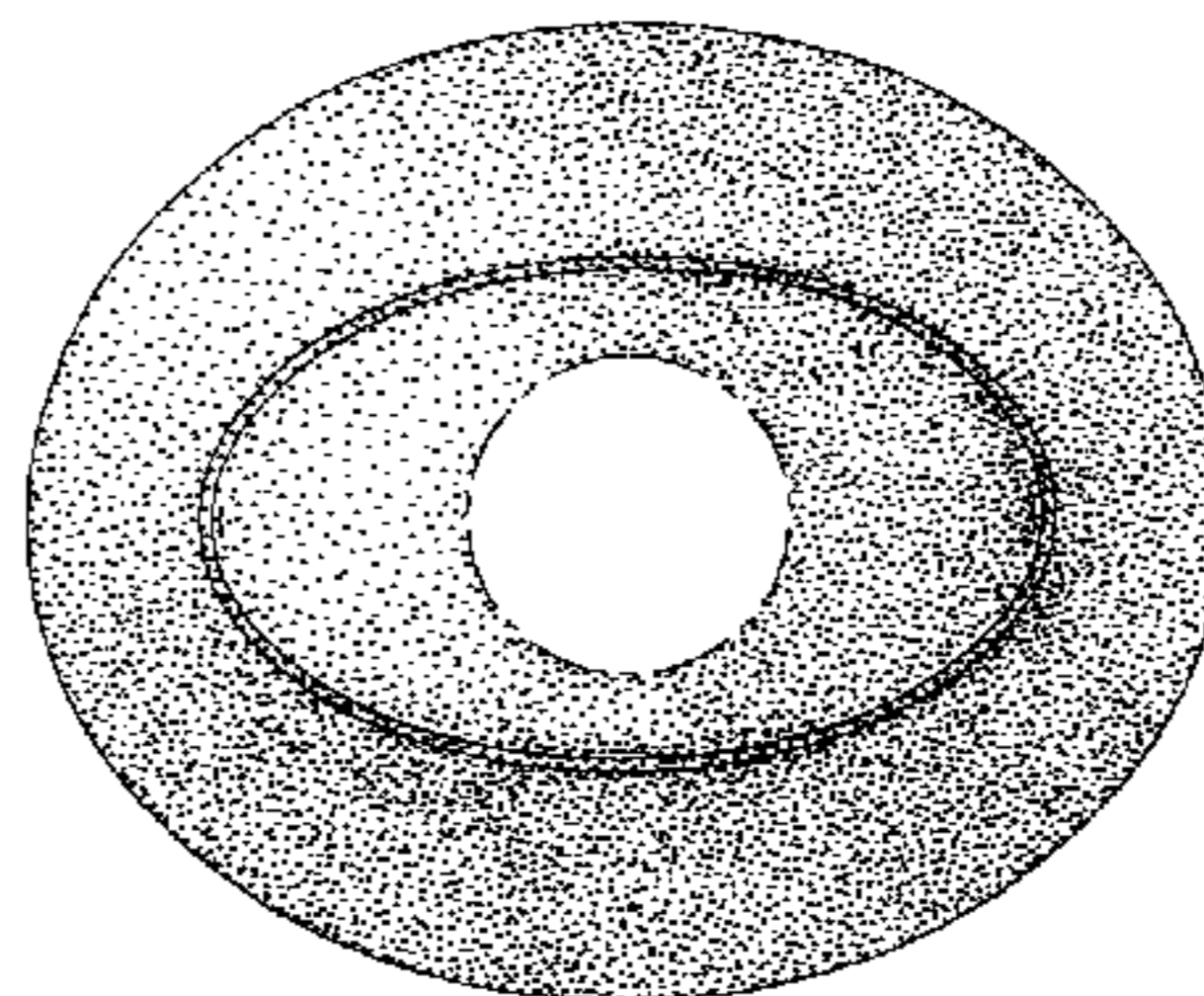
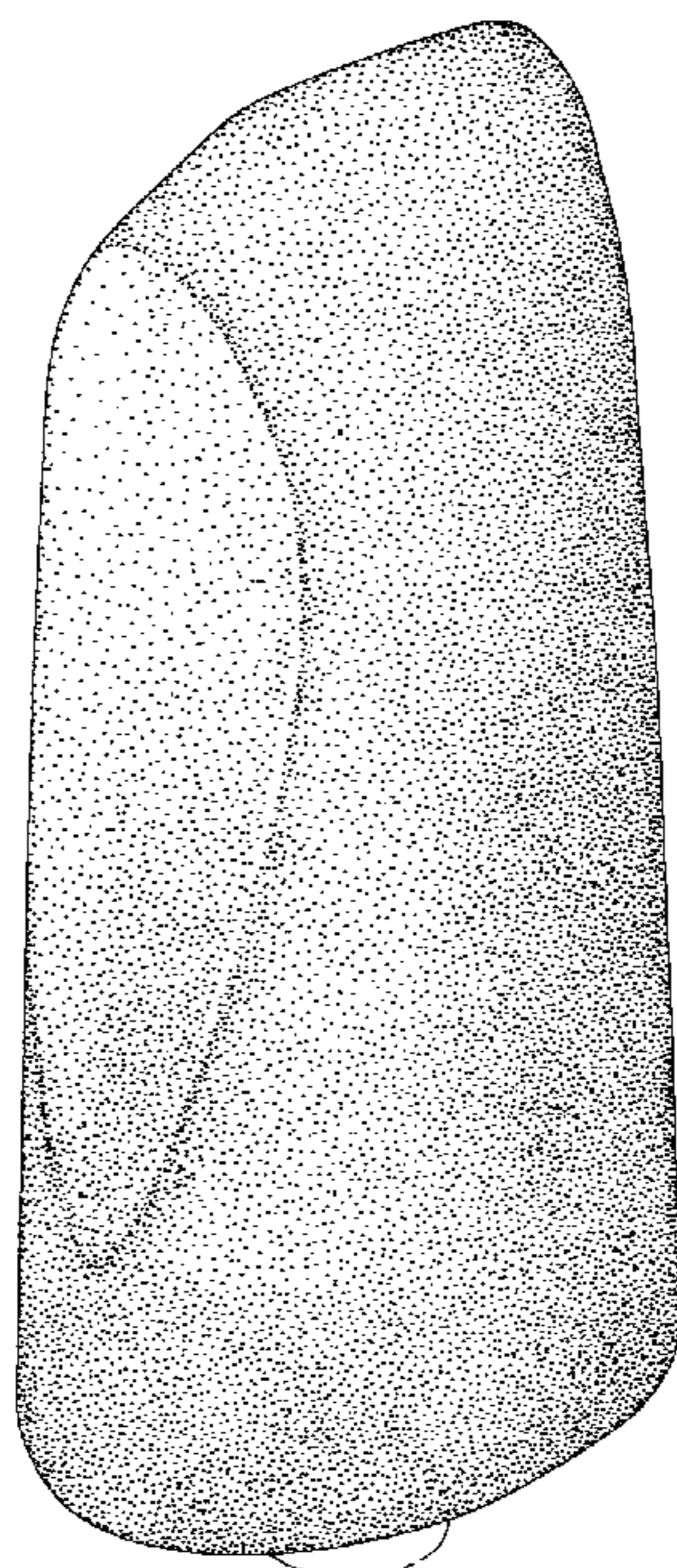
FIG. 2 is a top view thereof;

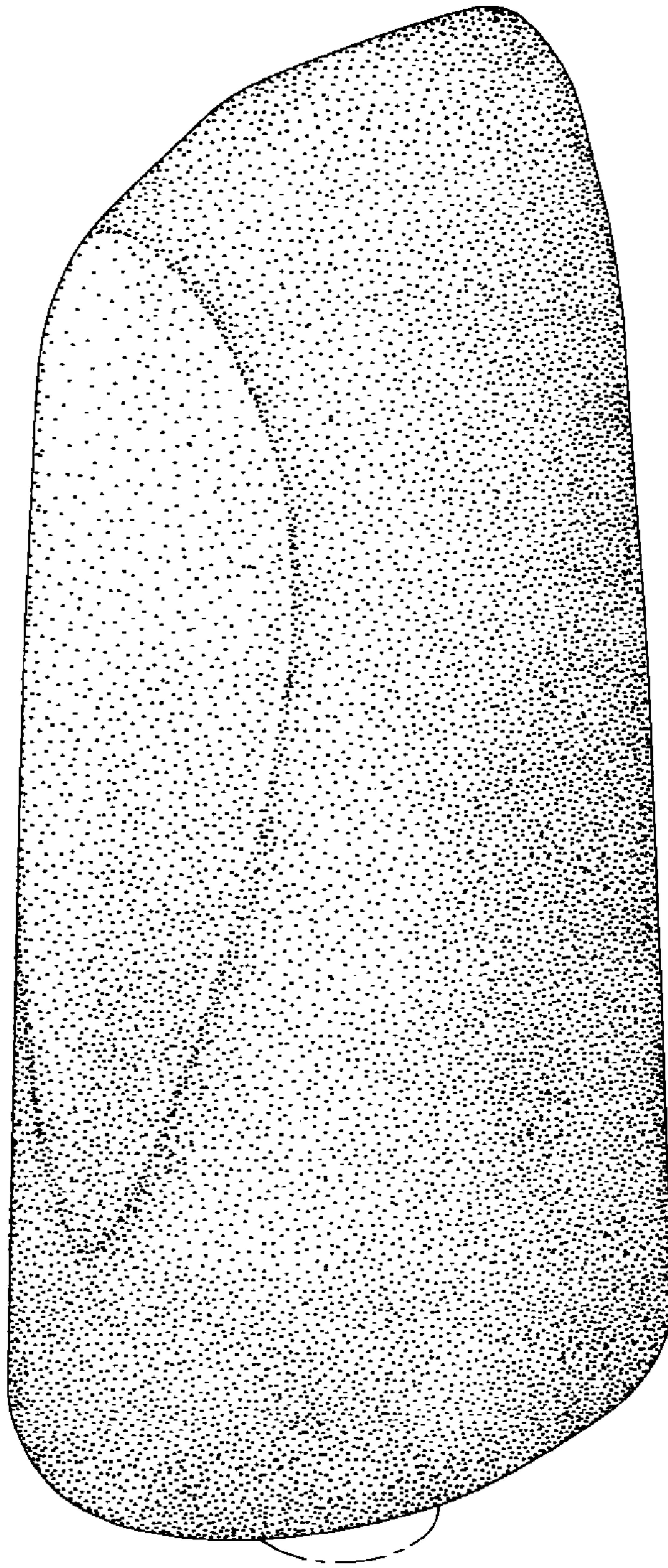

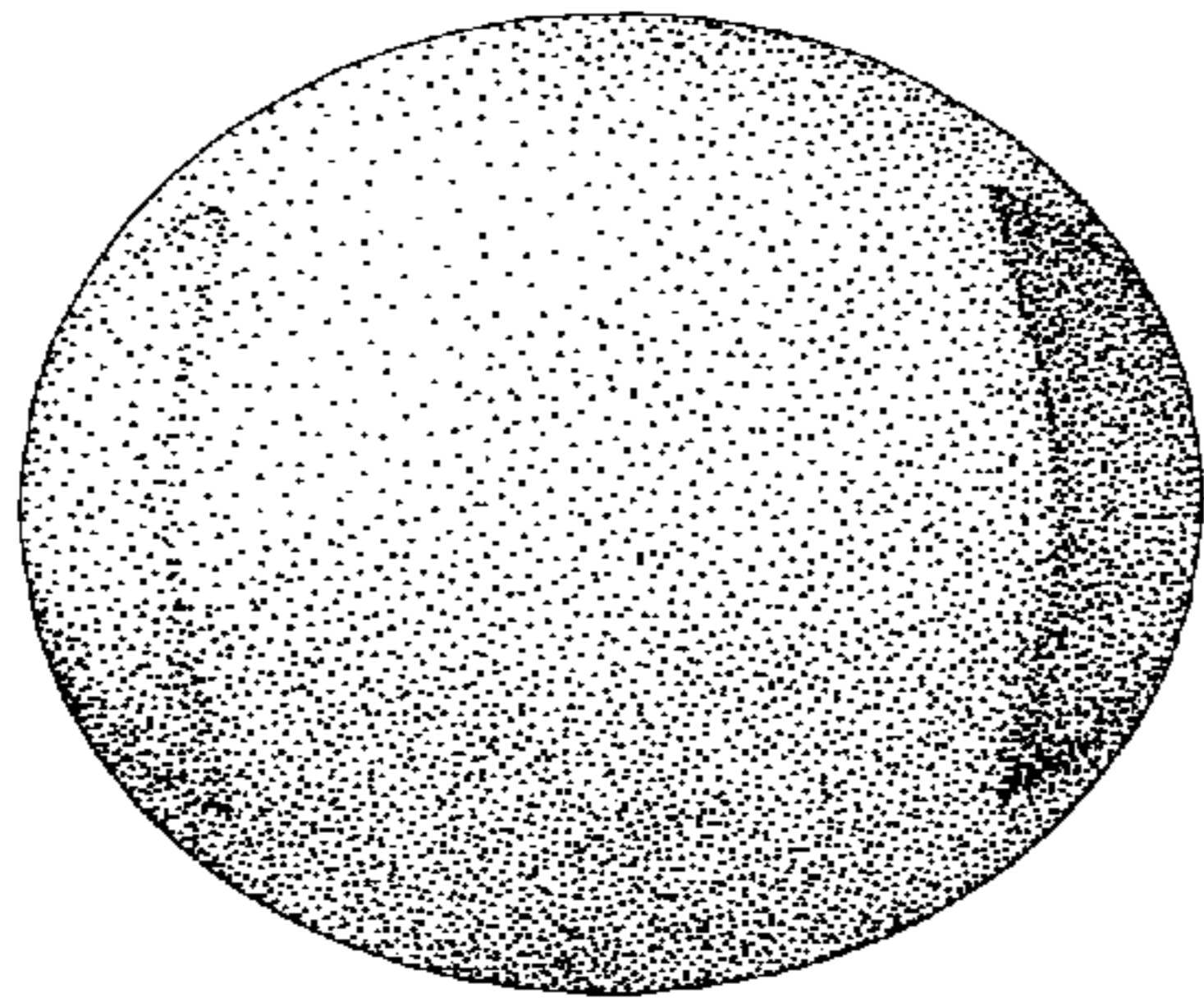

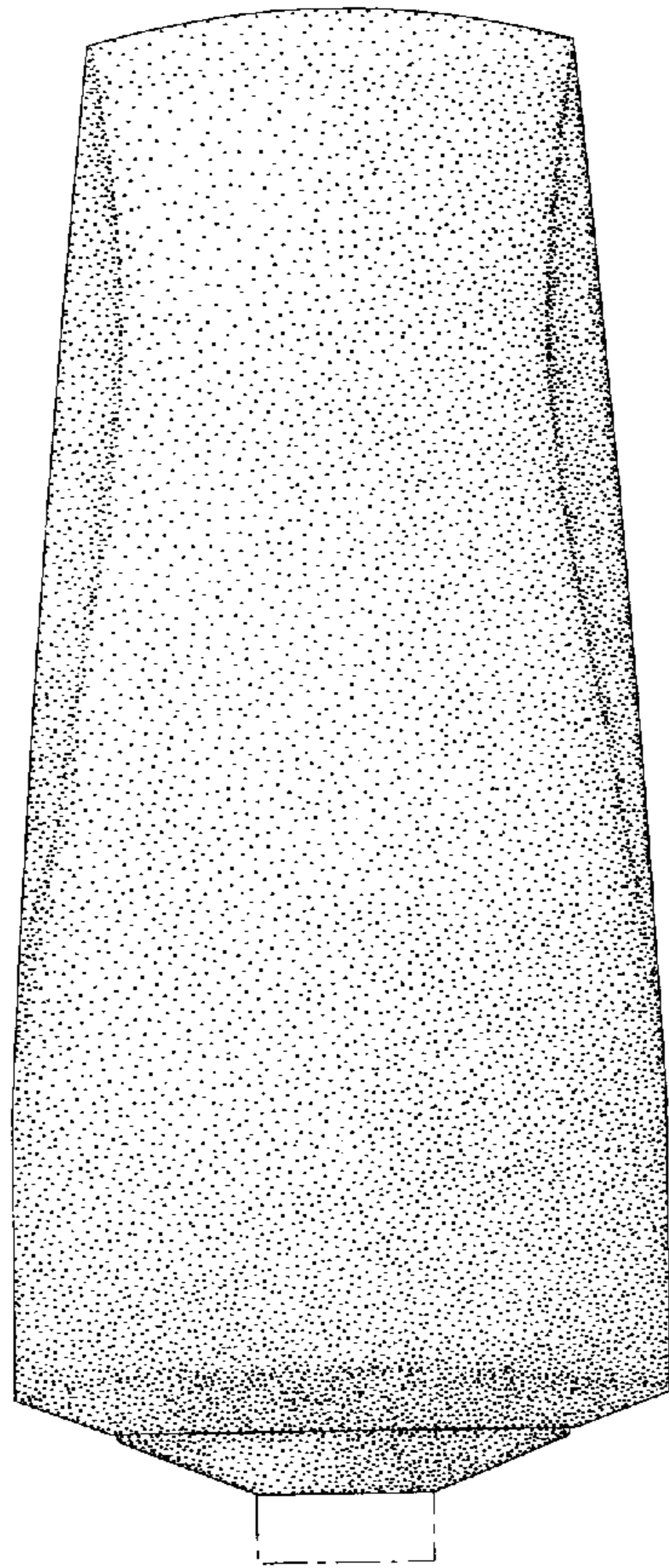

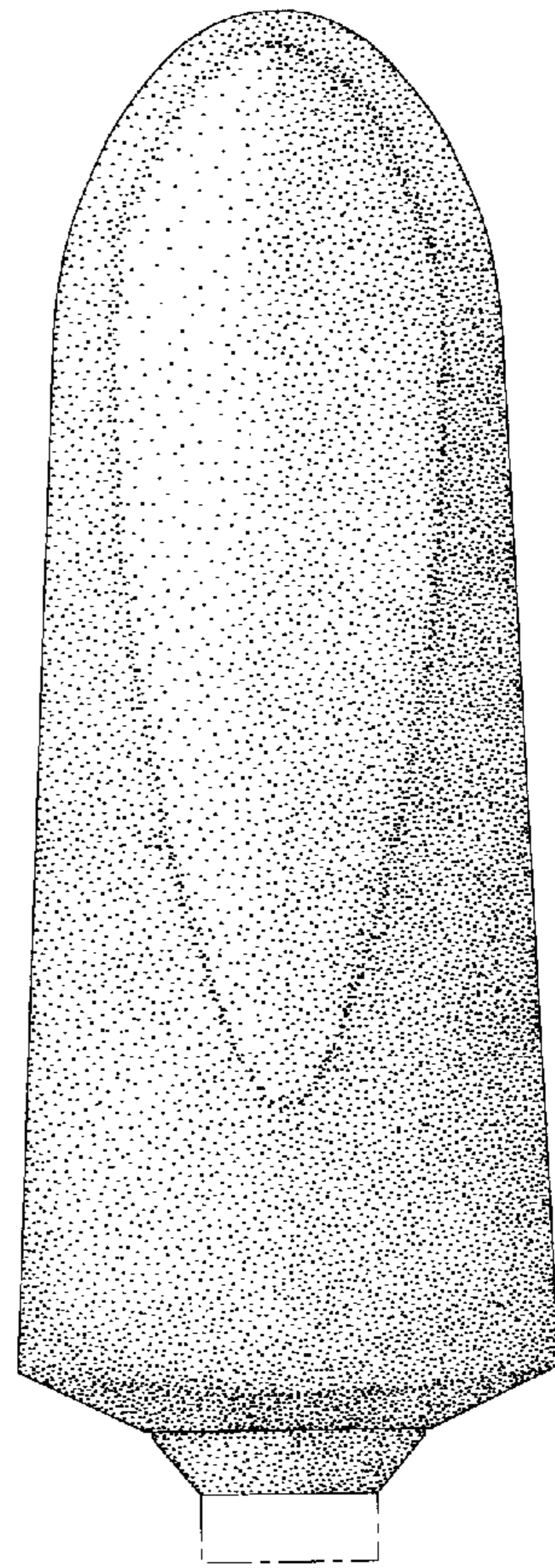

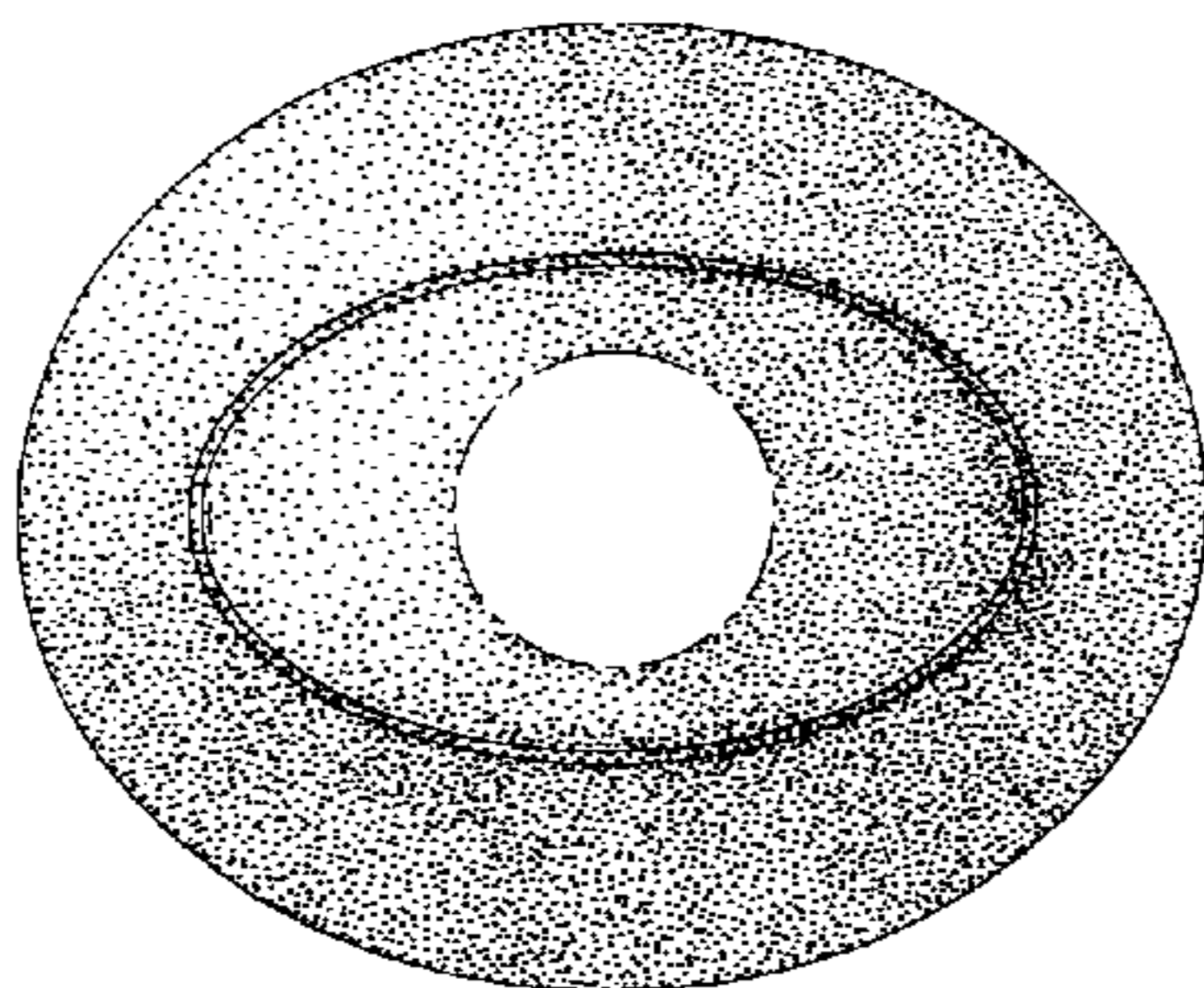
