FIG. 1 is a perspective view of the clock with thermometer and humidity meter.

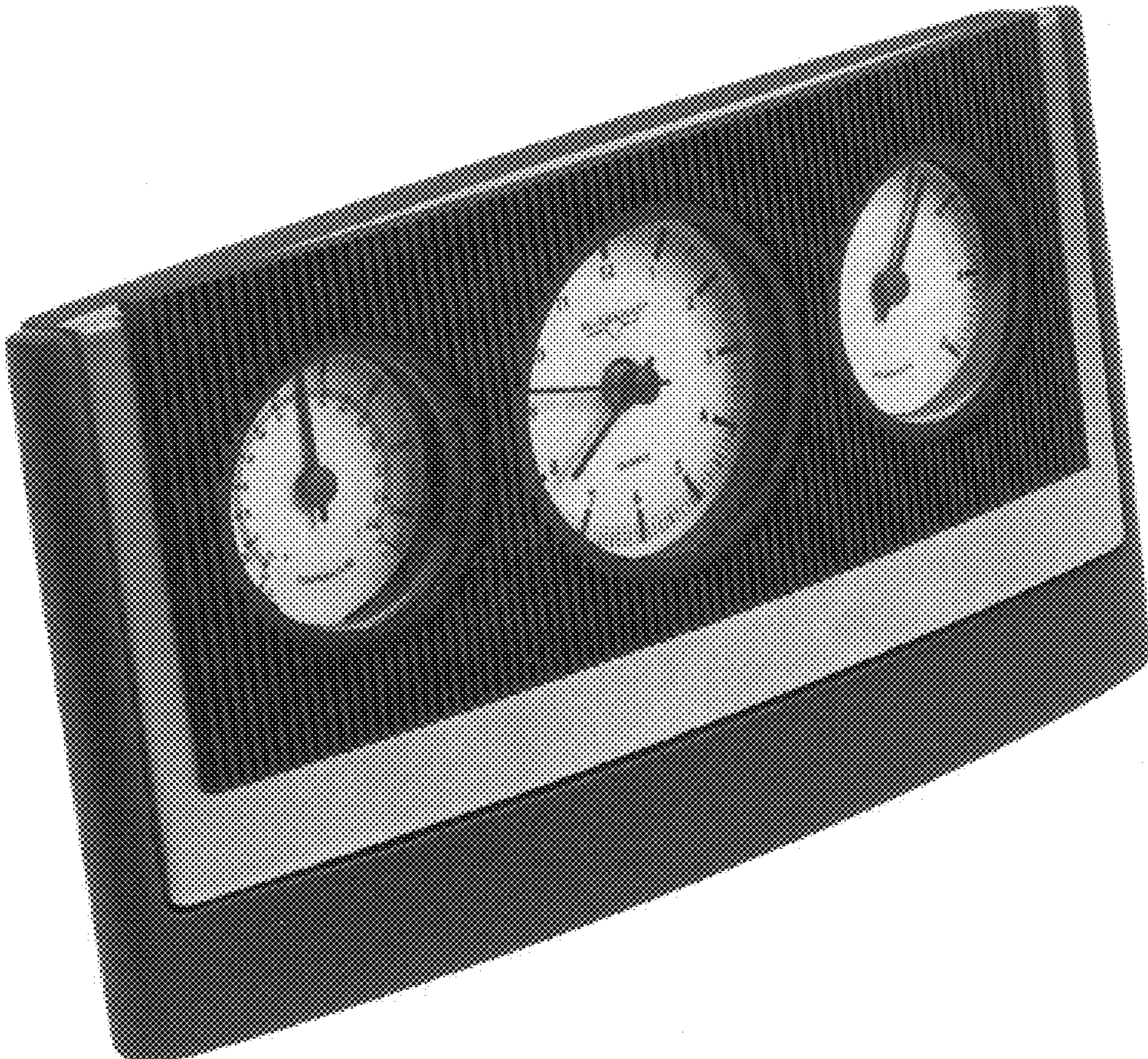
FIG. 2 is a back view thereof.

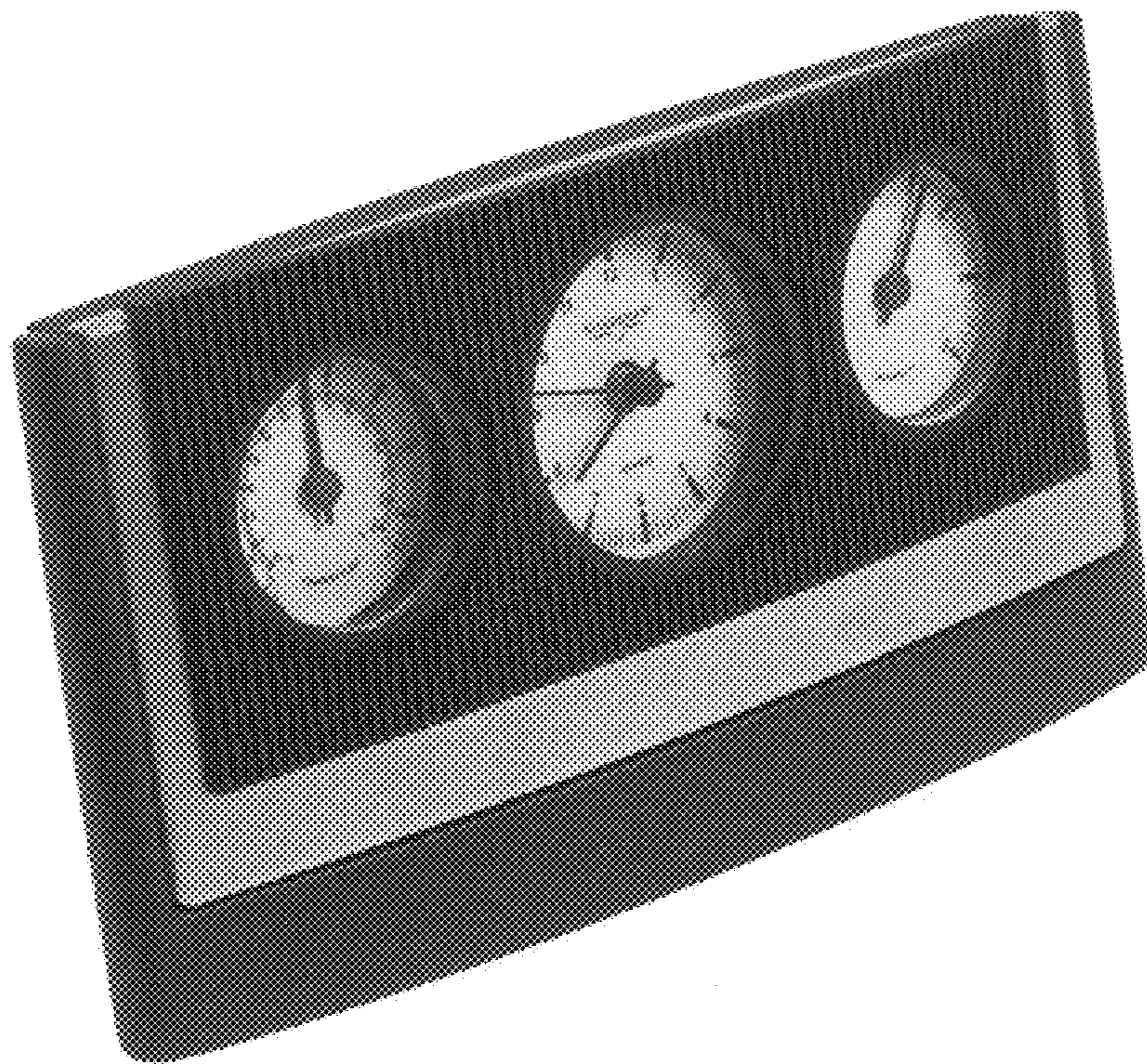

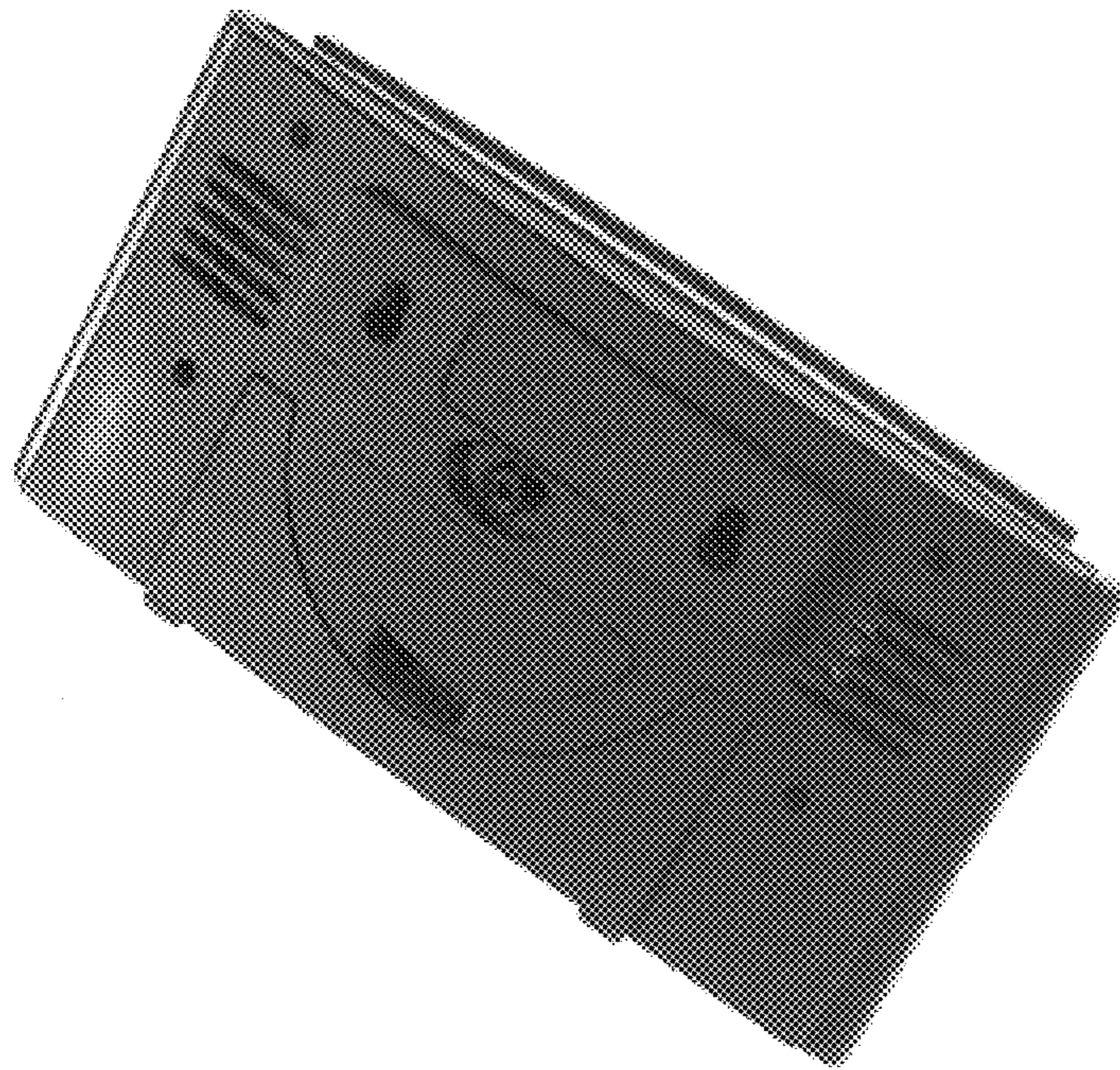
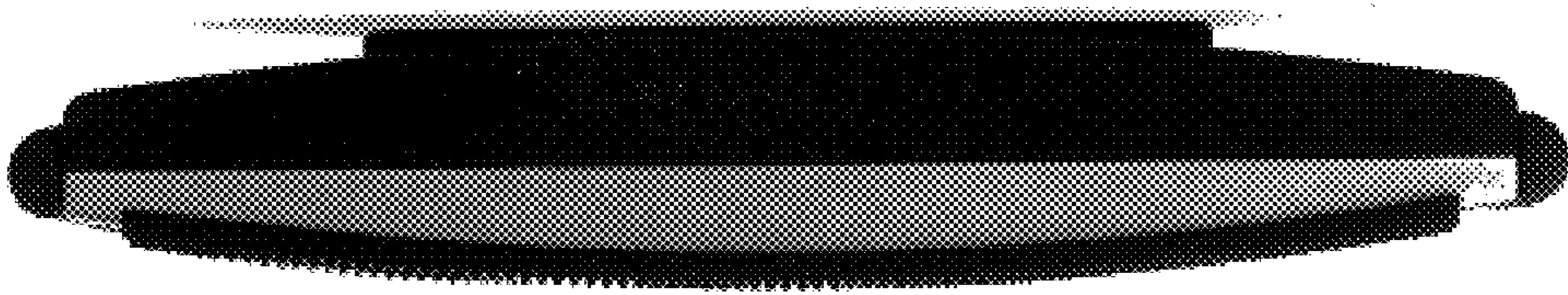

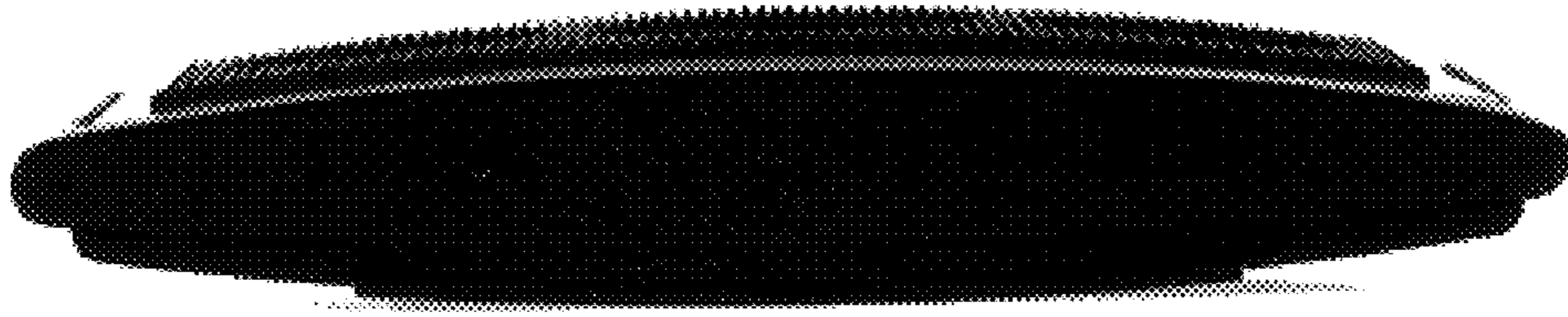

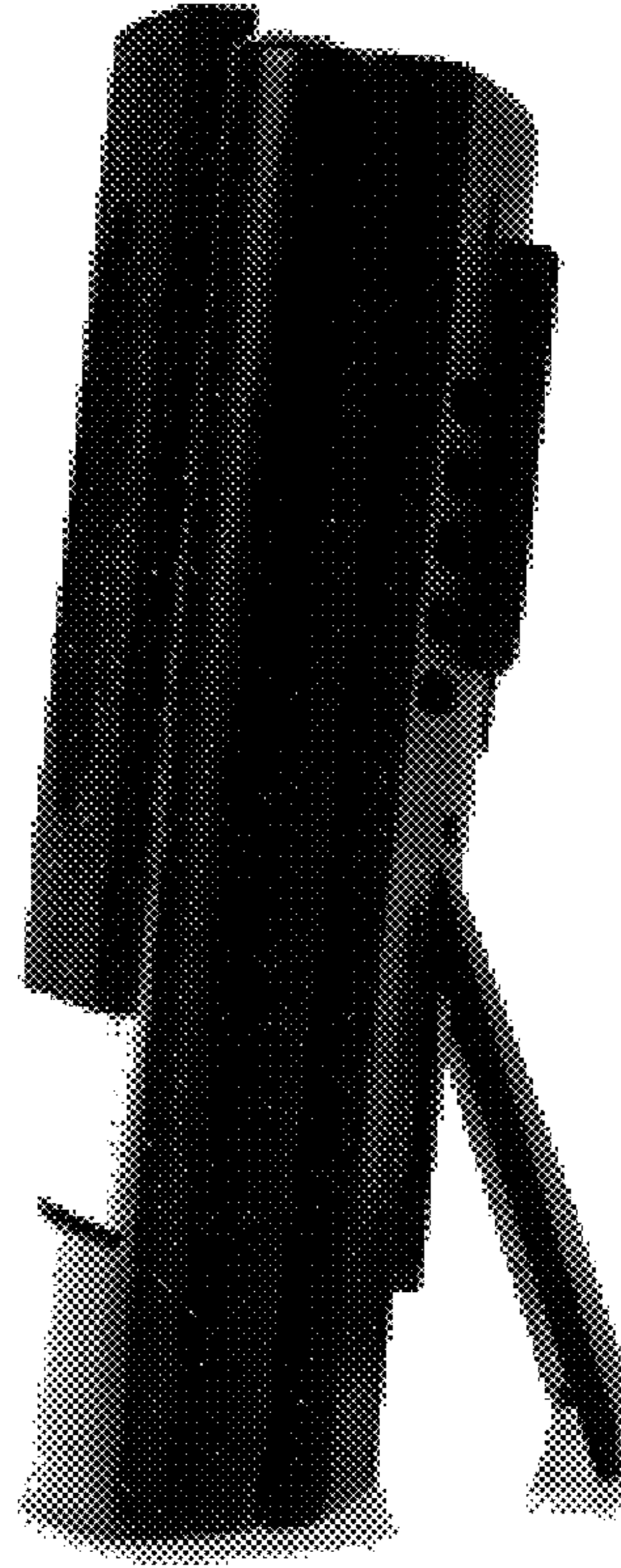
