(57) **CLAIM**

The ornamental design for a tire for motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a tire for motorcycle showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a perspective view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is an enlarged front view thereof;

FIG. 8 is an end face view taken along line 8—8 of FIG. 7 thereof;

FIG. 9 is an end face view taken along line 9—9 of FIG. 7 thereof; and,

FIG. 10 is a referential enlarged front view thereof showing a part of grooves with black color.

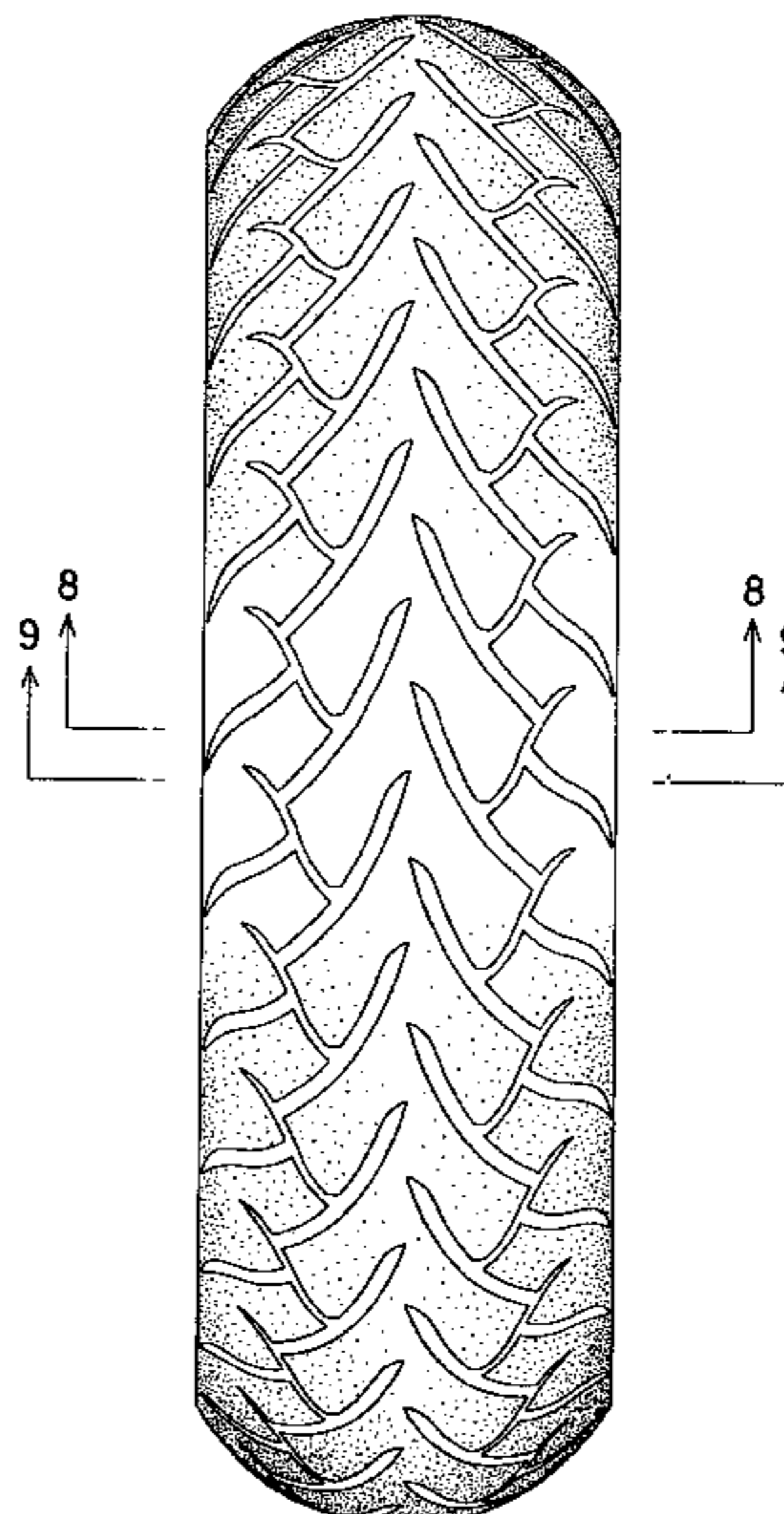

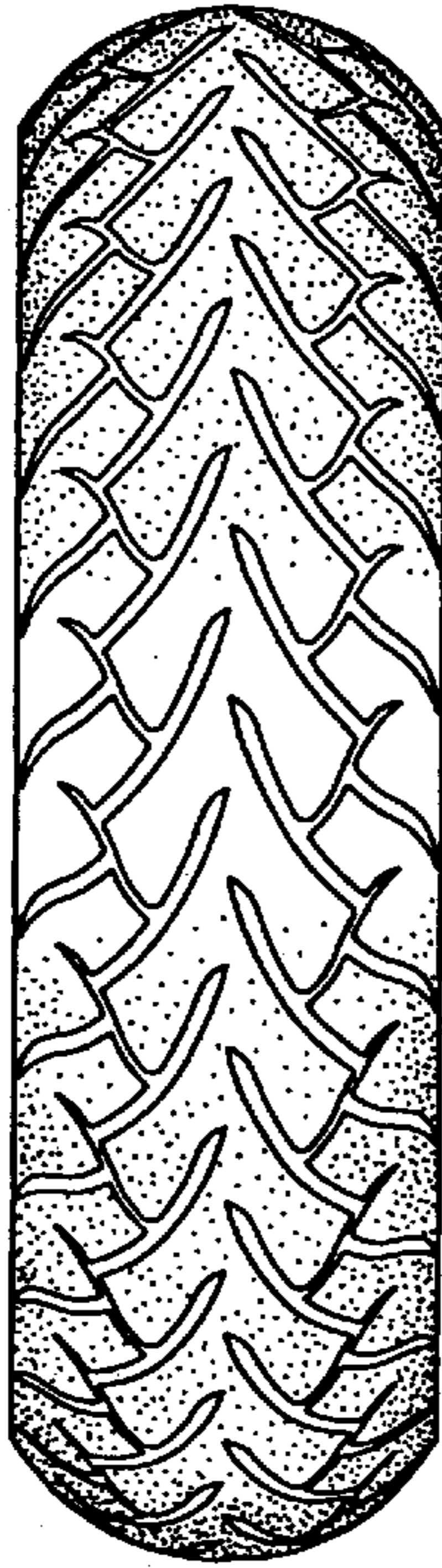

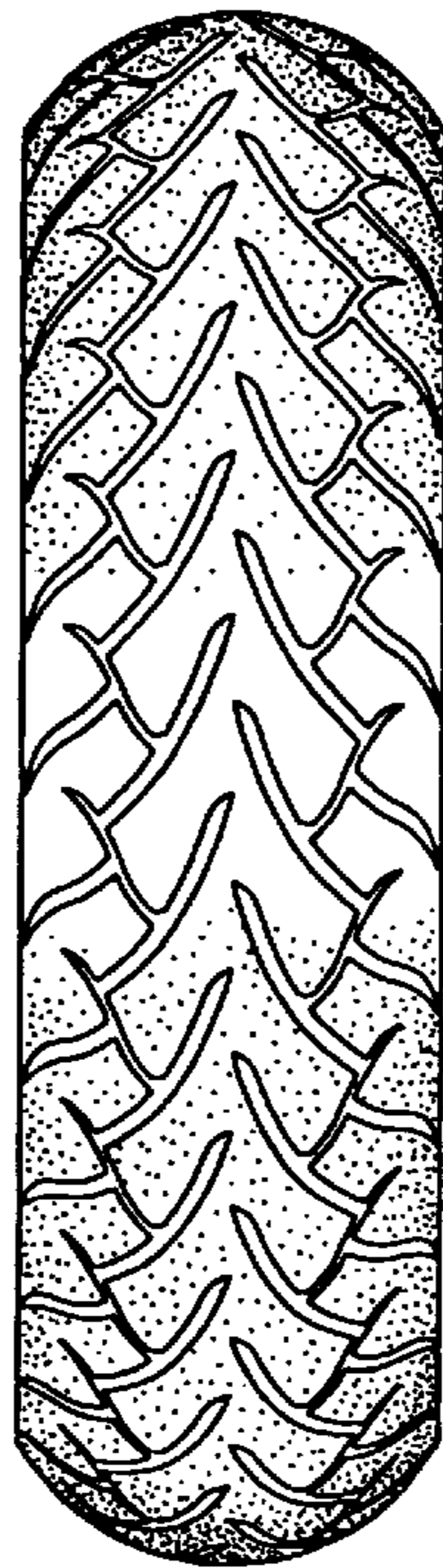

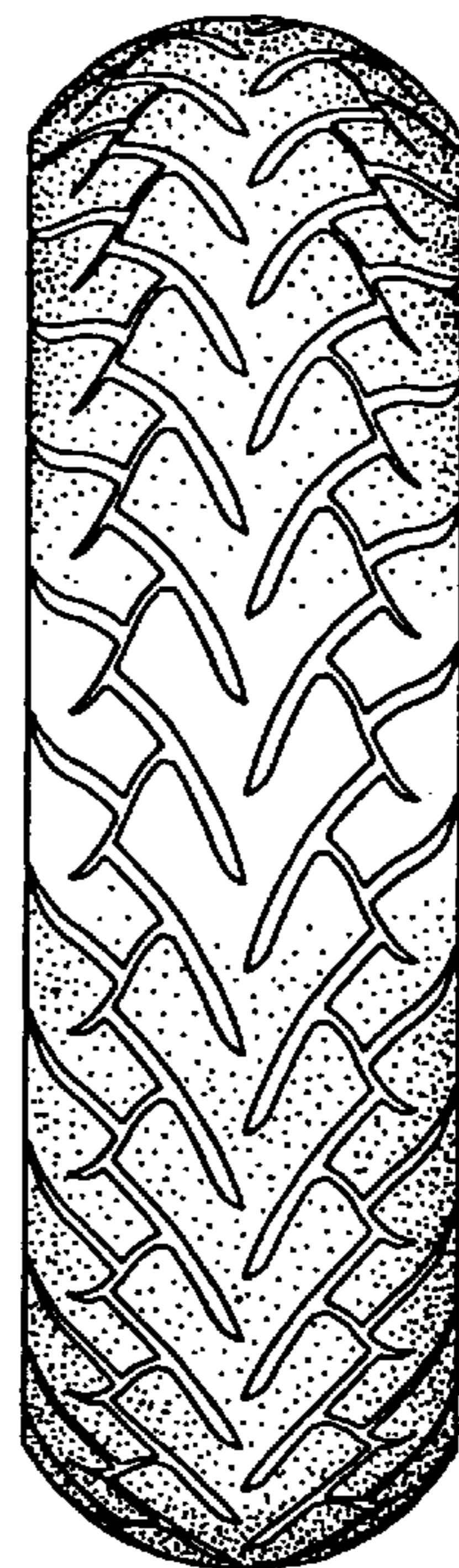

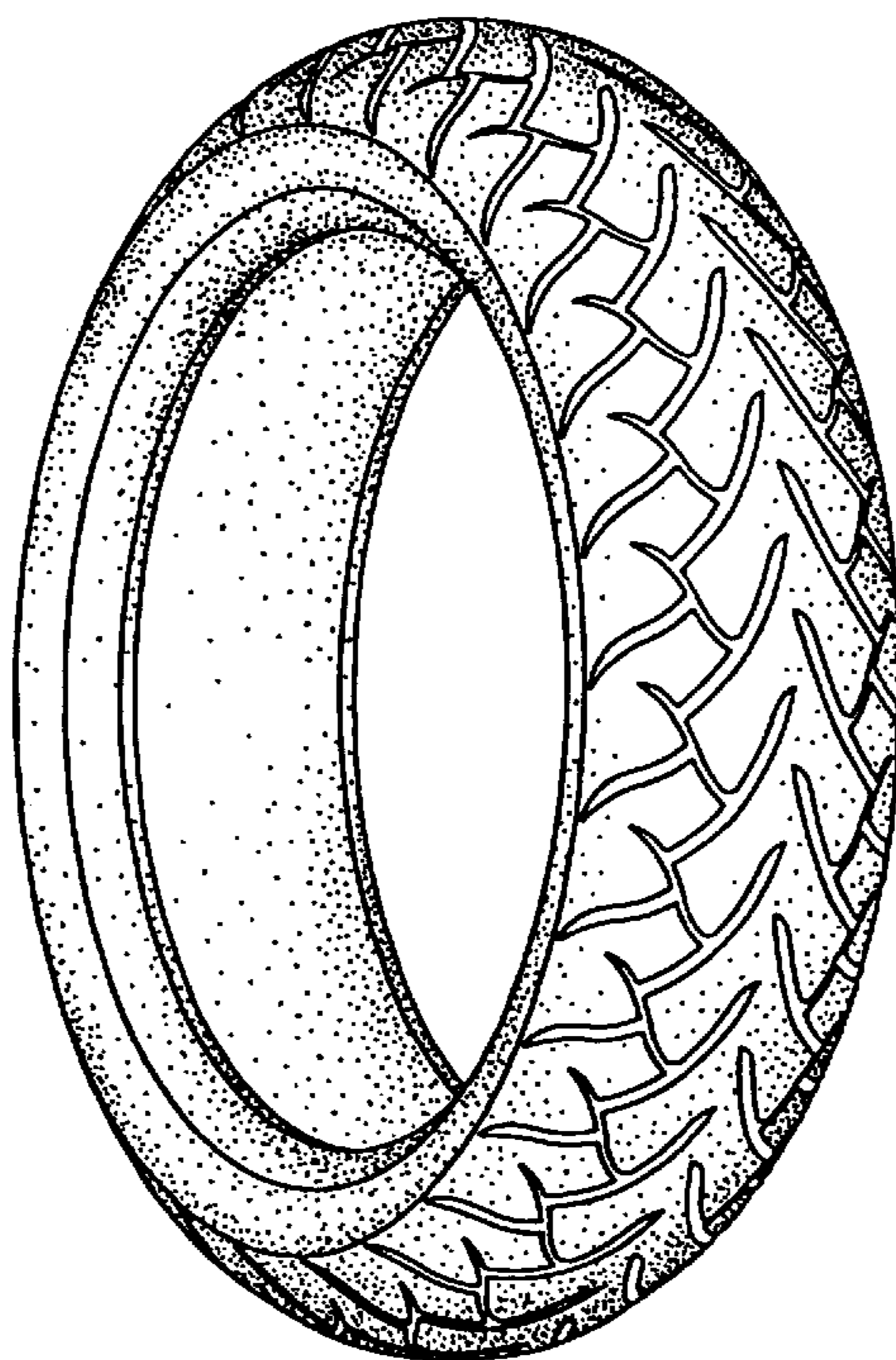

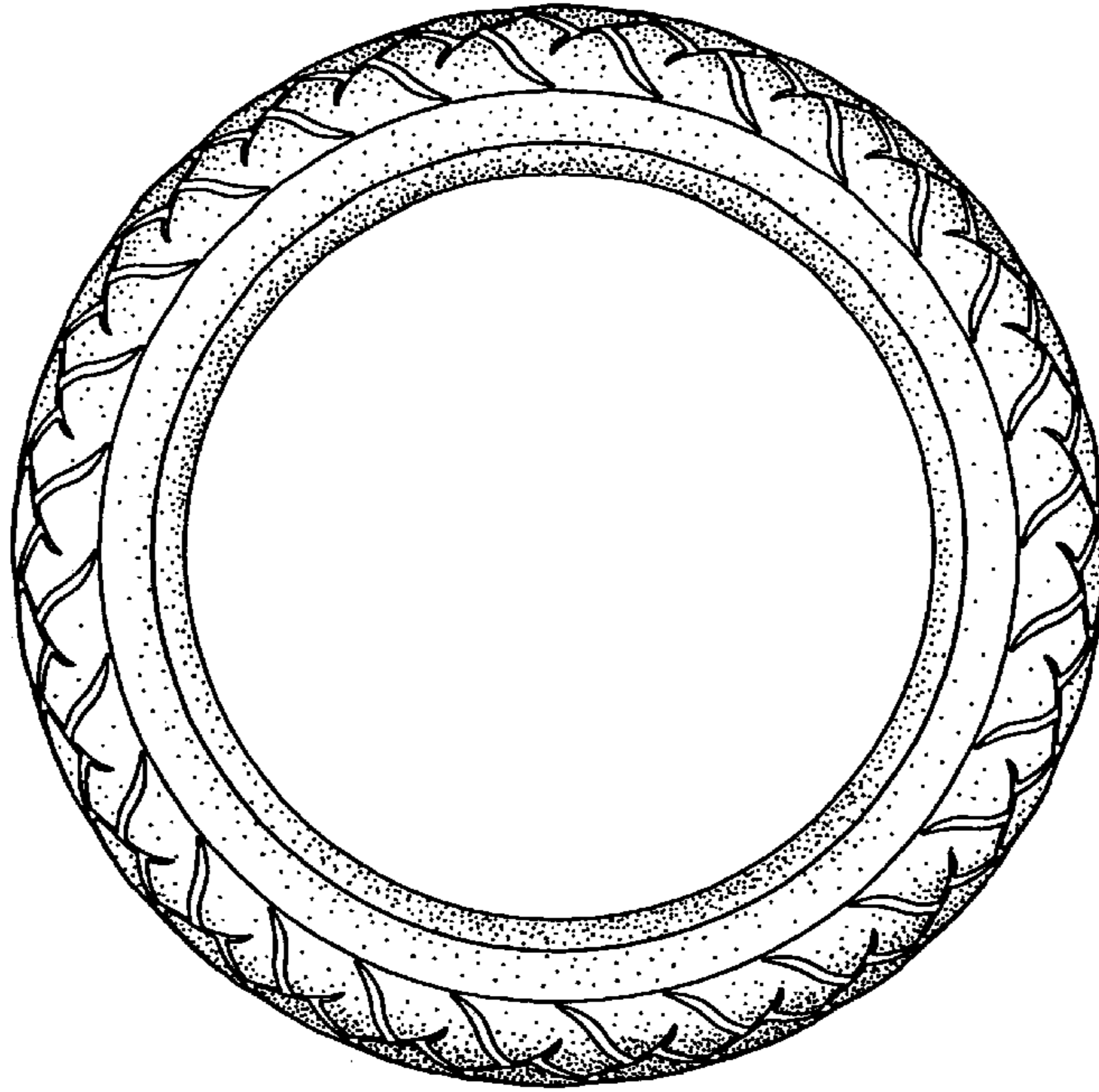

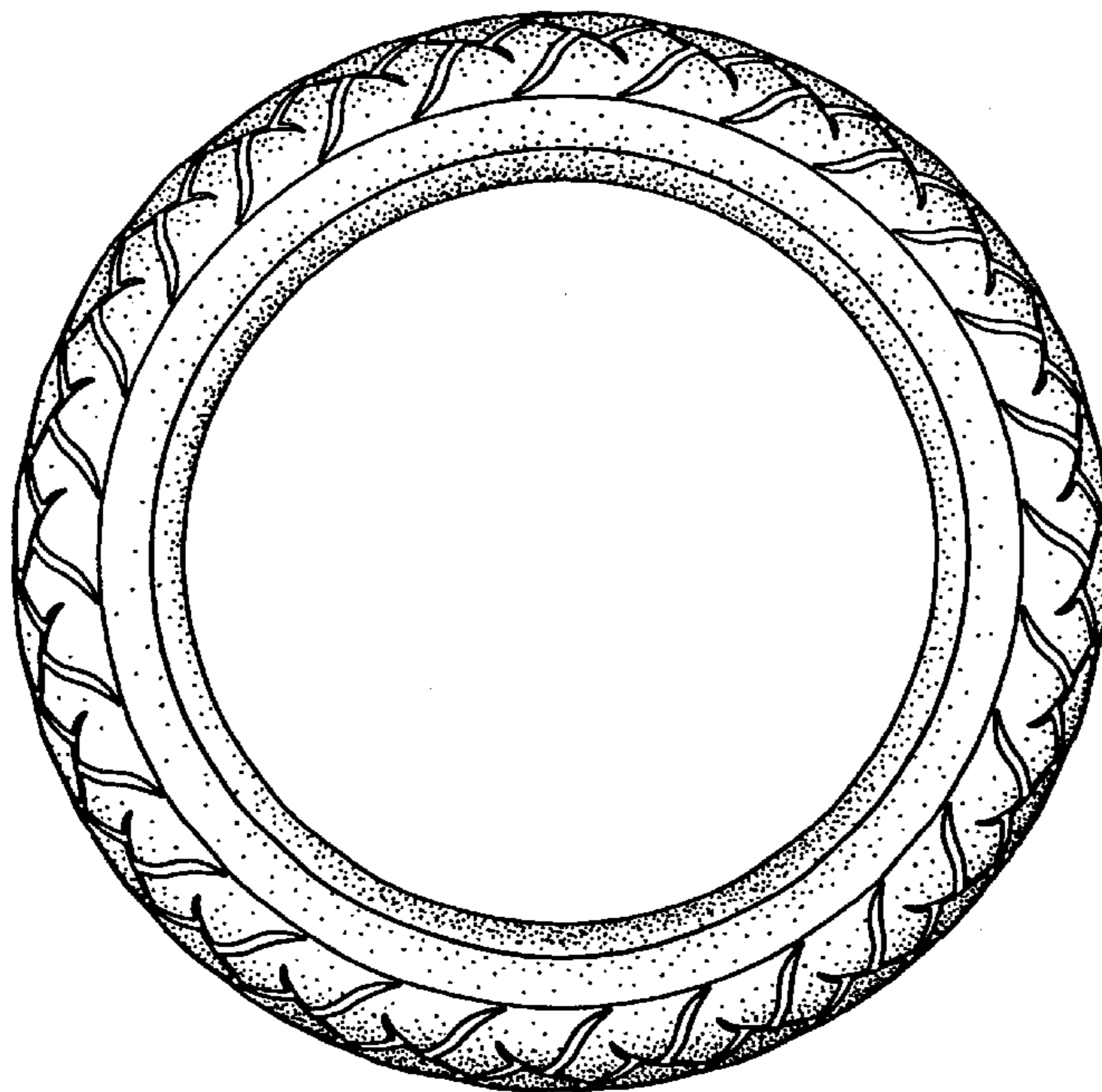

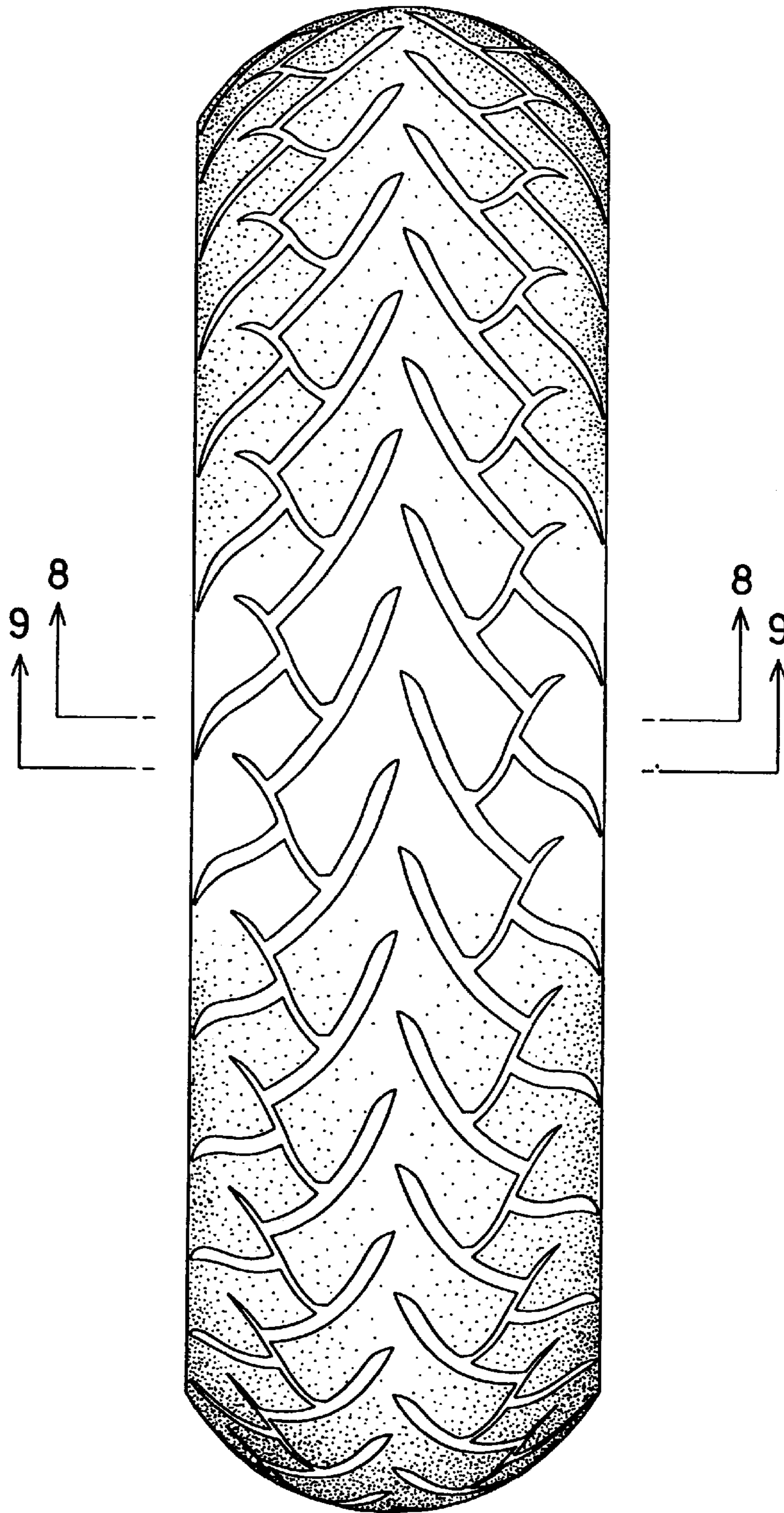

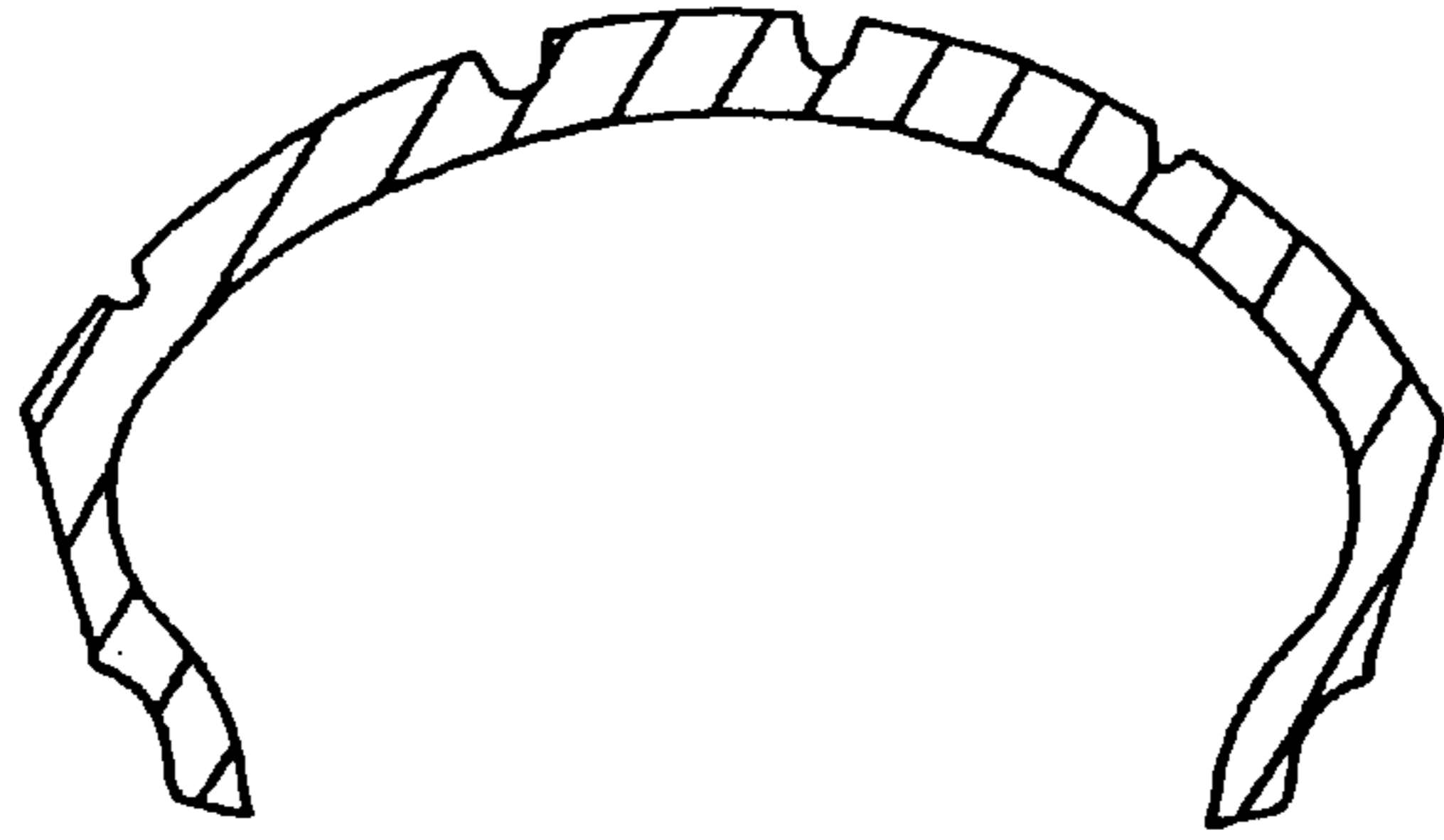

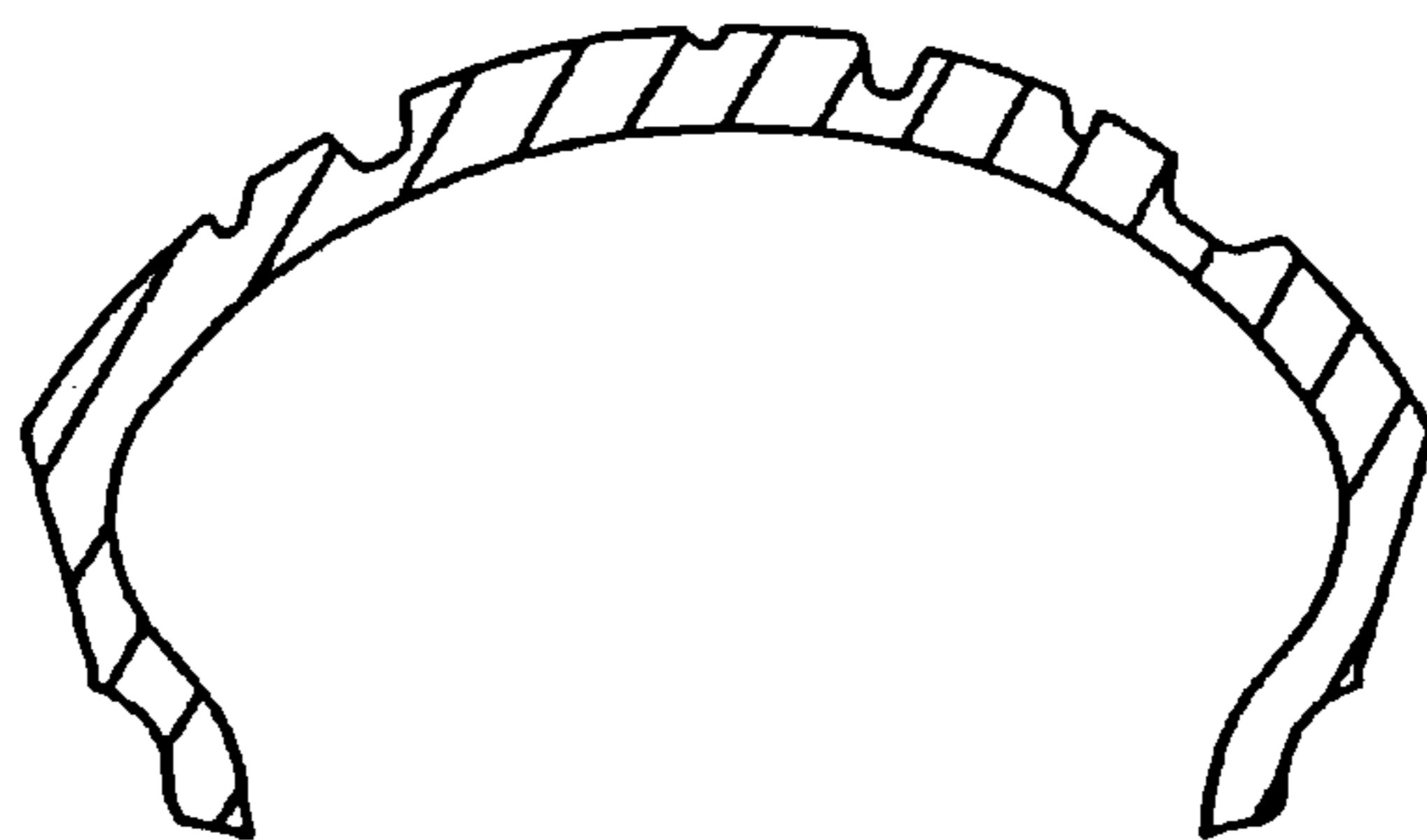
