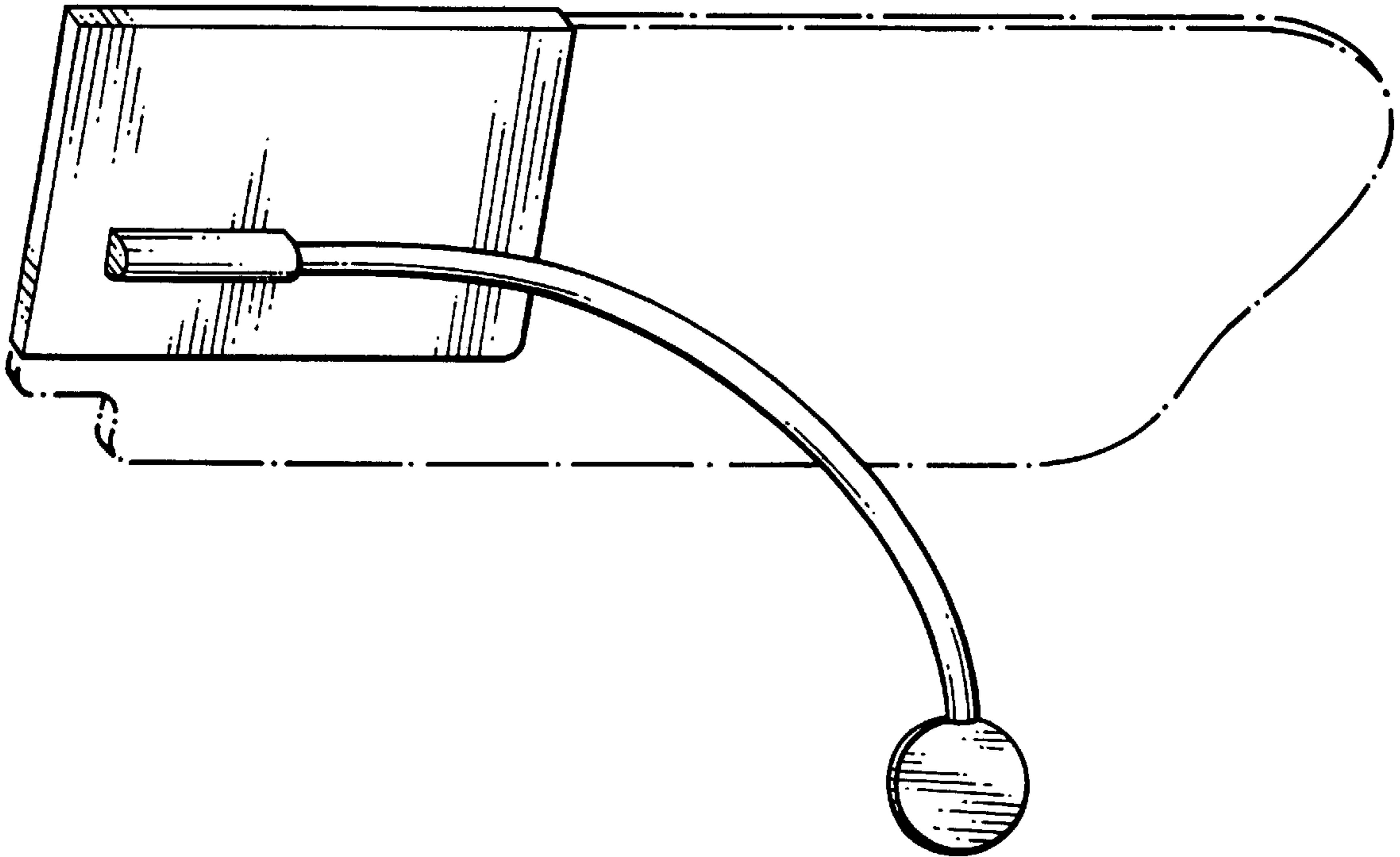
(57) **CLAIM**

The ornamental design for an automobile sun filter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an automobile sun filter showing my new design; the broken line showing of an automobile sun visor is for illustrative purposes only and forms no part of the claimed design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a right-side elevational view thereof  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a left-side elevational view thereof.

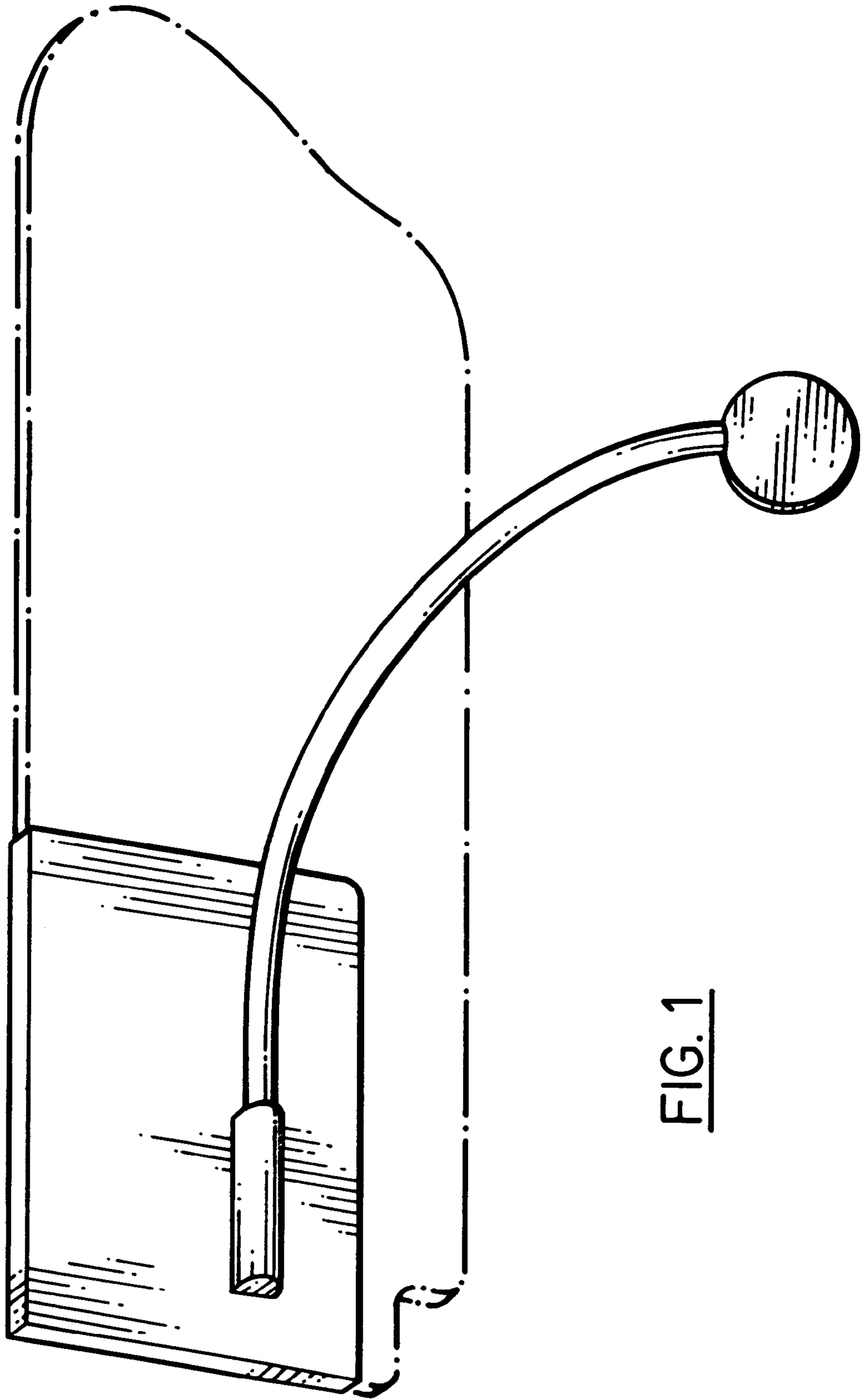

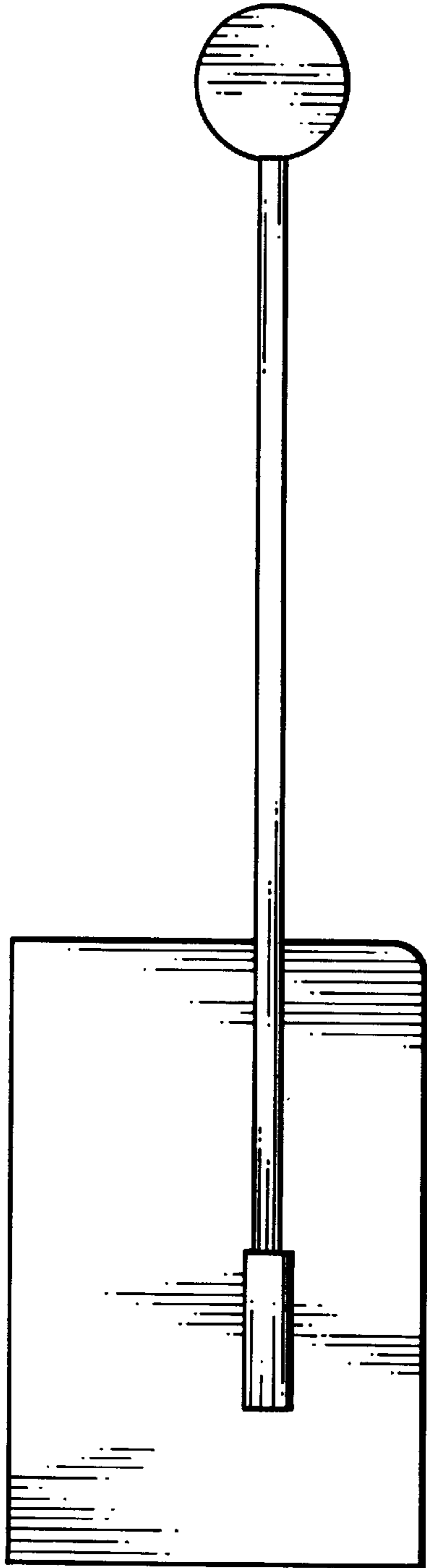

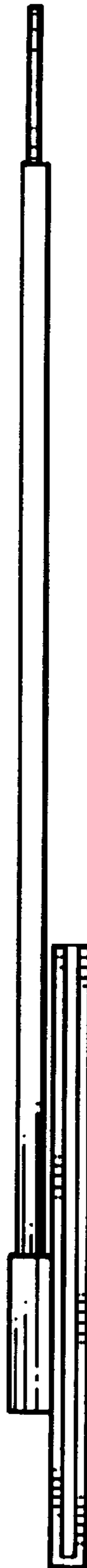

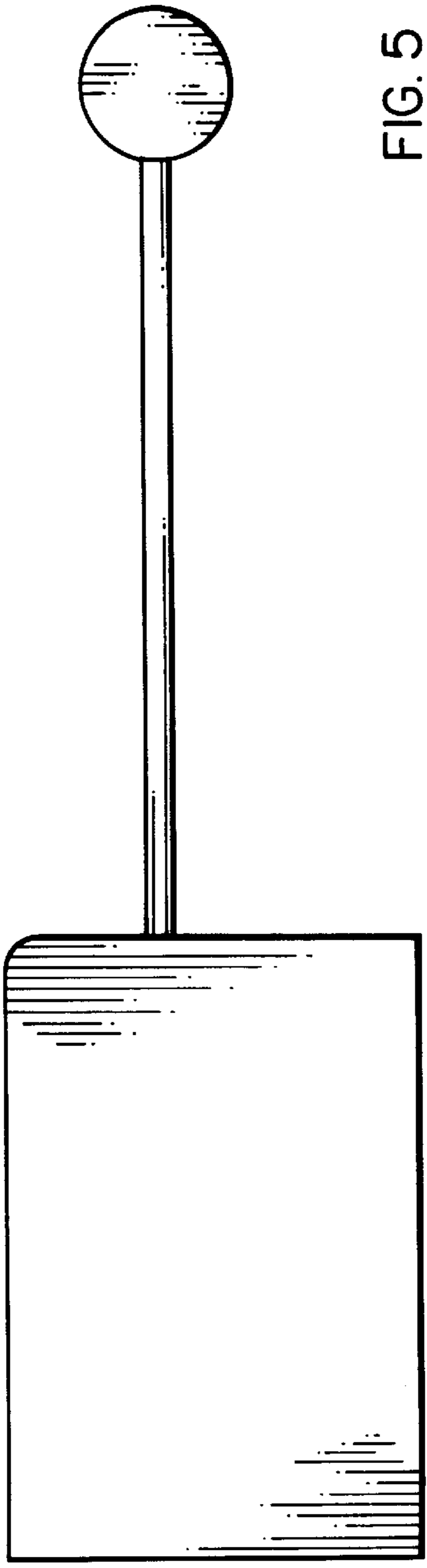
