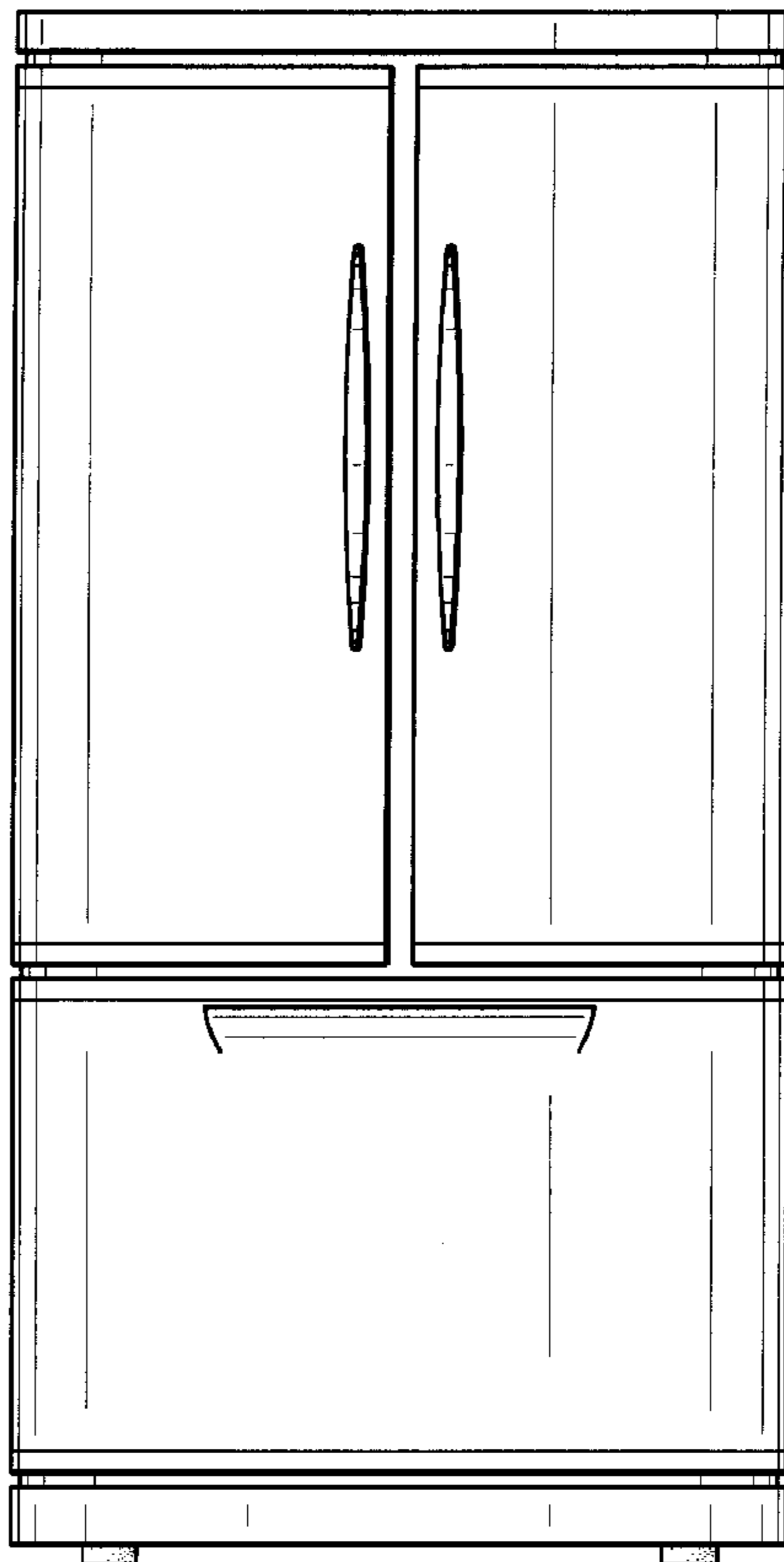
(57) **CLAIM**

The ornamental design for a freezer with drawer below, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the design; FIG. 2 is a rear elevational view of the design; FIG. 3 is a top plan view of the design; FIG. 4 is a bottom plan view of the design; and, FIG. 5 is an elevational view of one side of the design, the other side being the same in appearance as the one side.

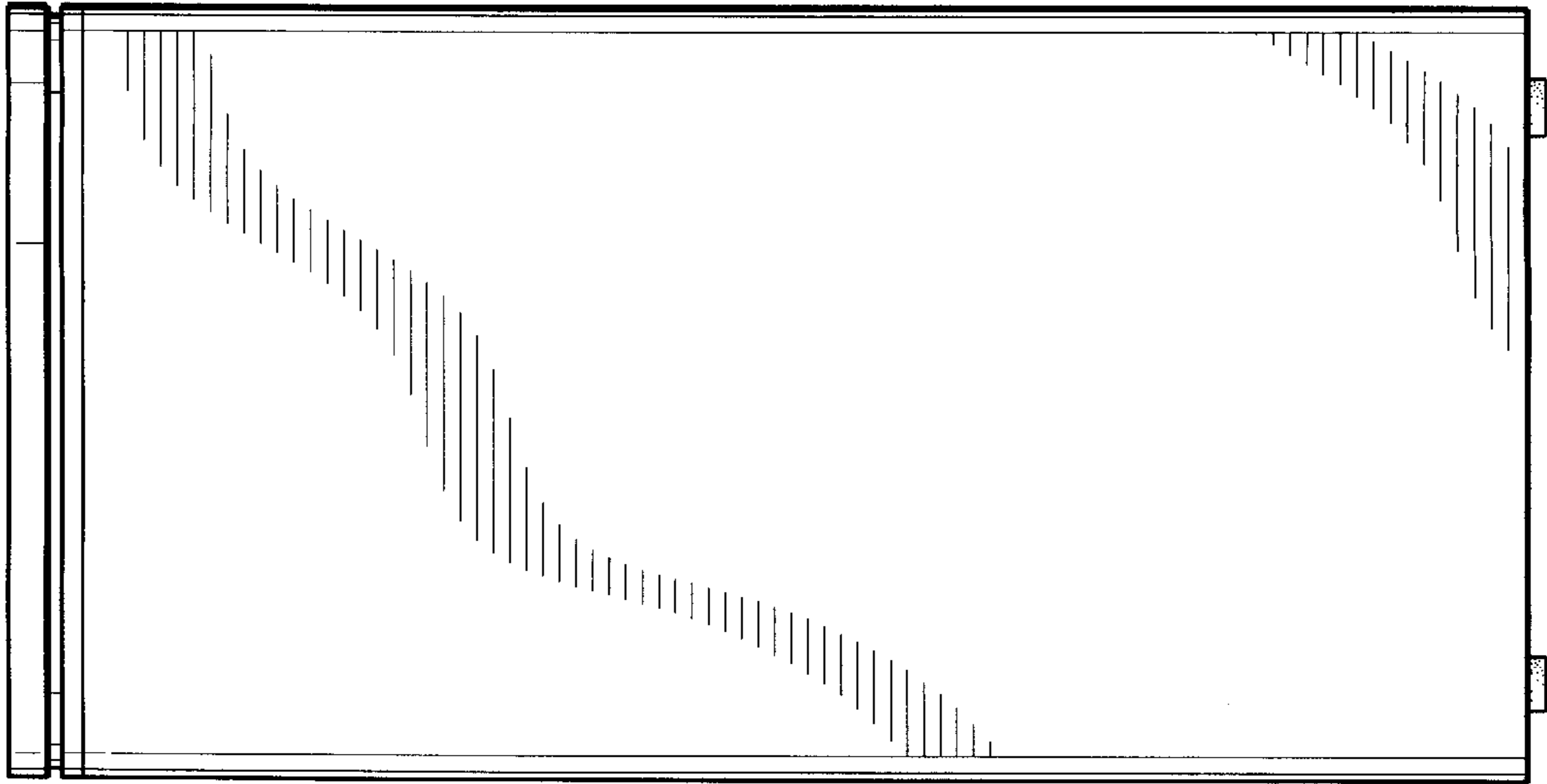

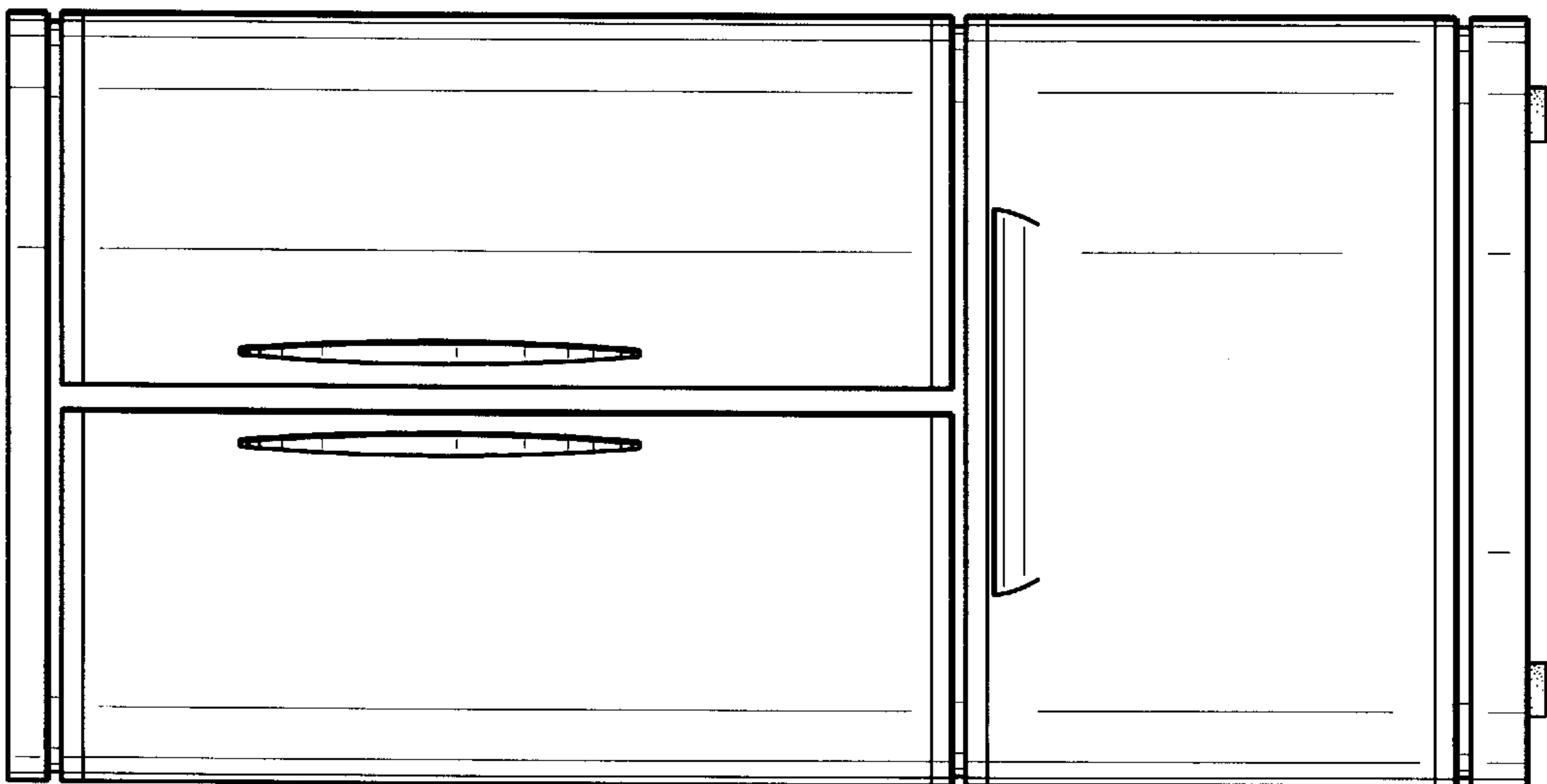

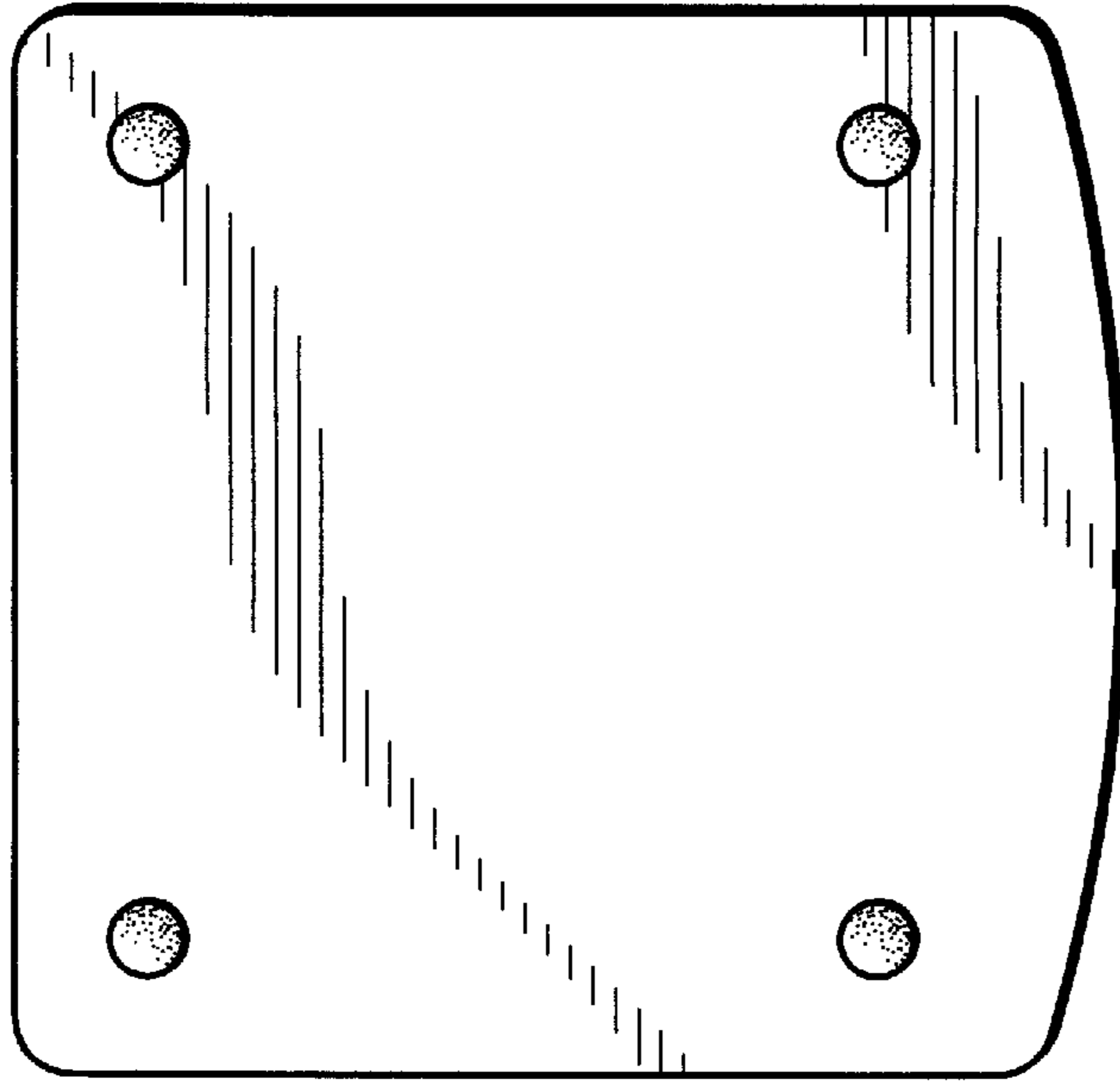

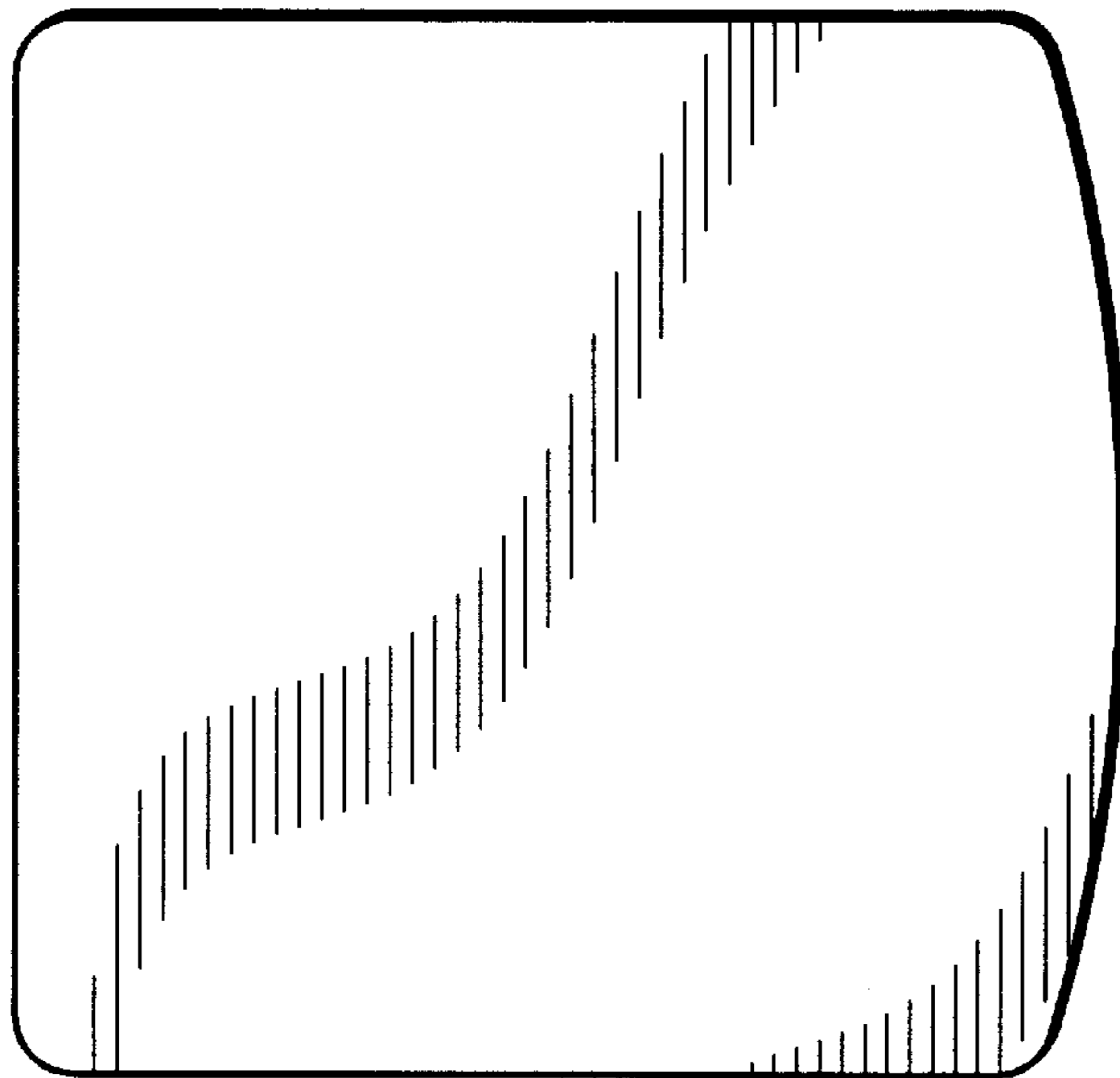

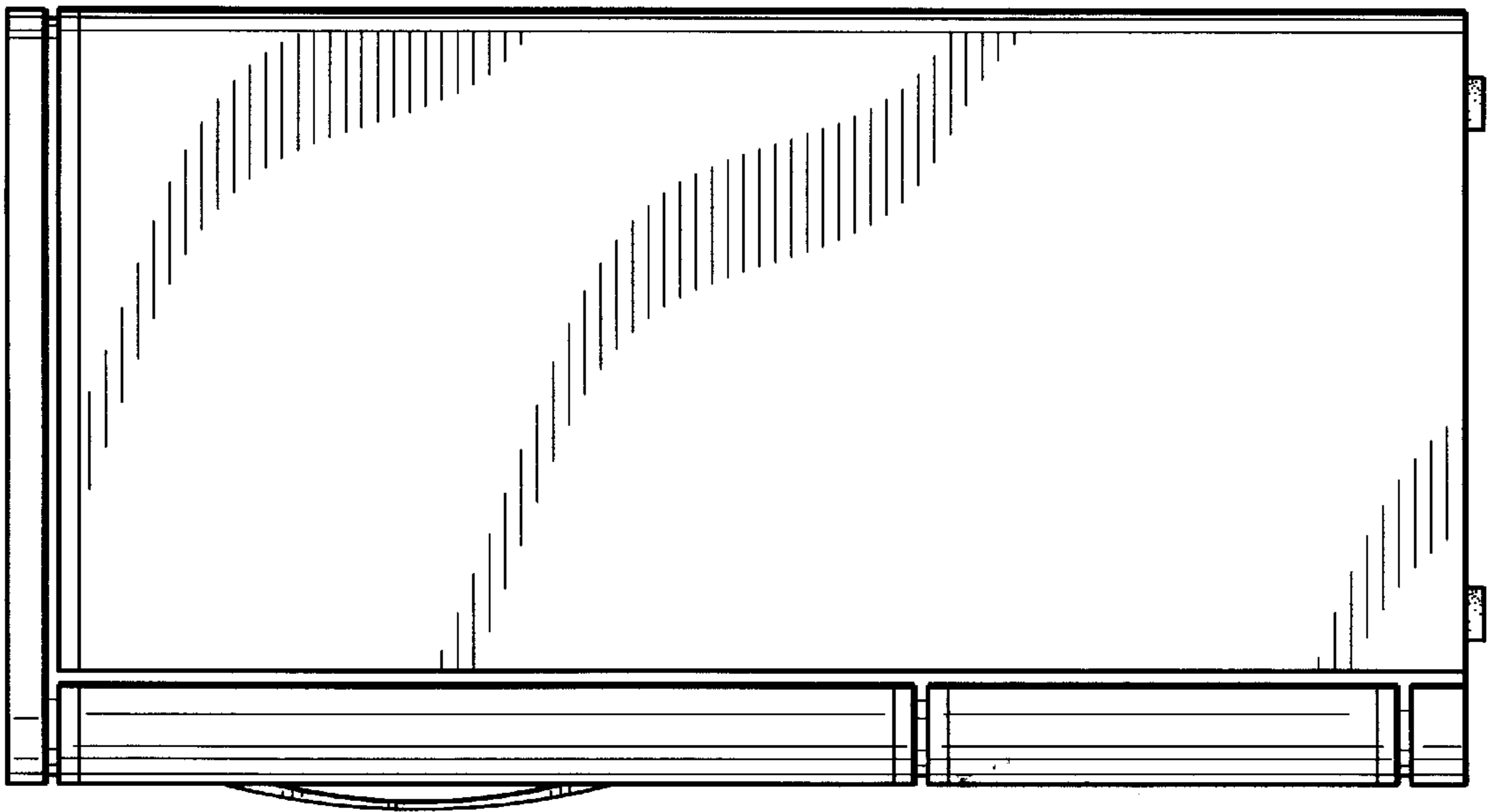
