(57) **CLAIM**

The ornamental design for a quarter collector's book, as shown and described.

FIG. 13 is a rear elevational view of an alternate page as in FIG. 2;

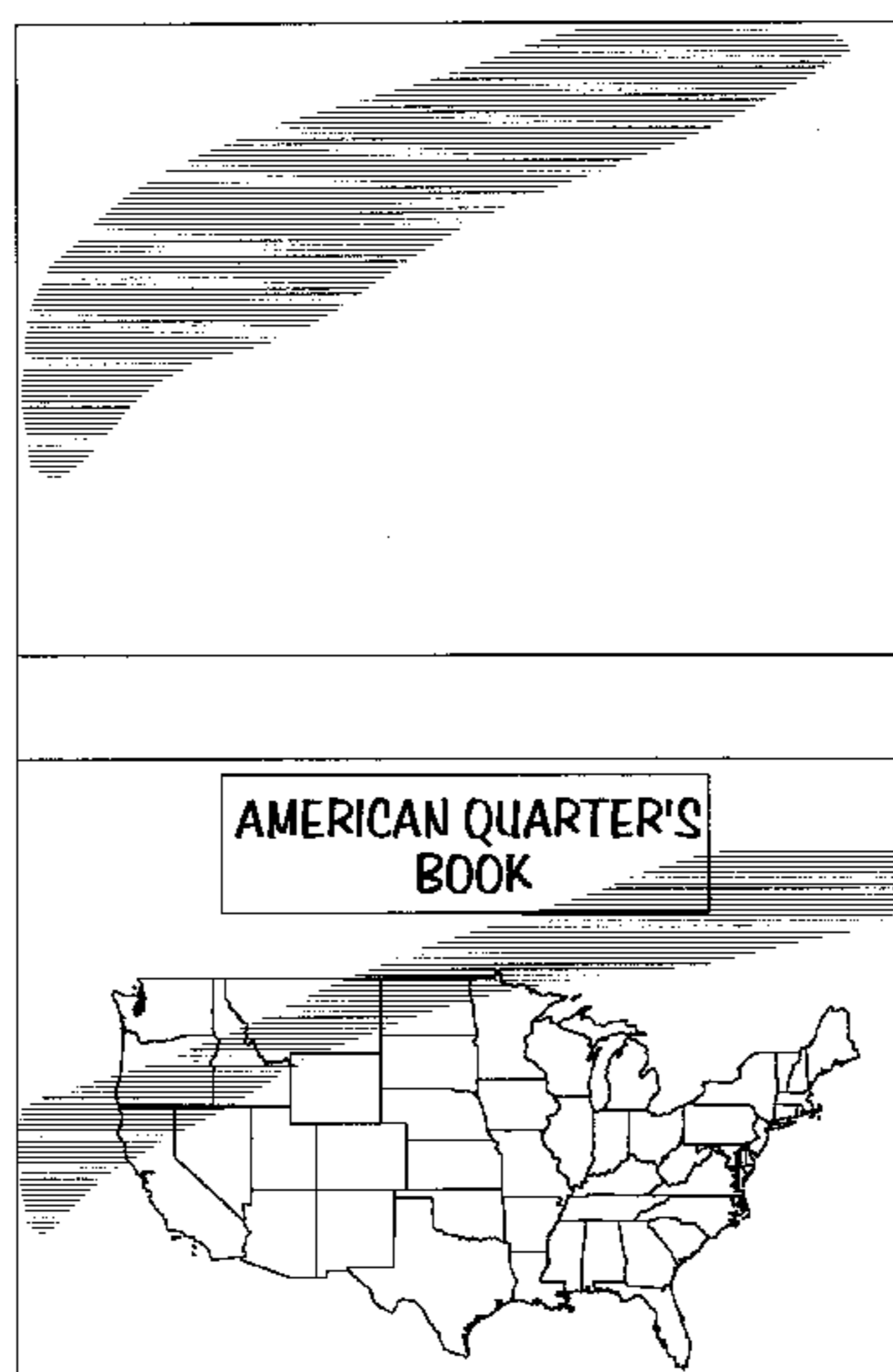
FIG. 14 is a rear elevational view of an alternate page as in FIG. 2;

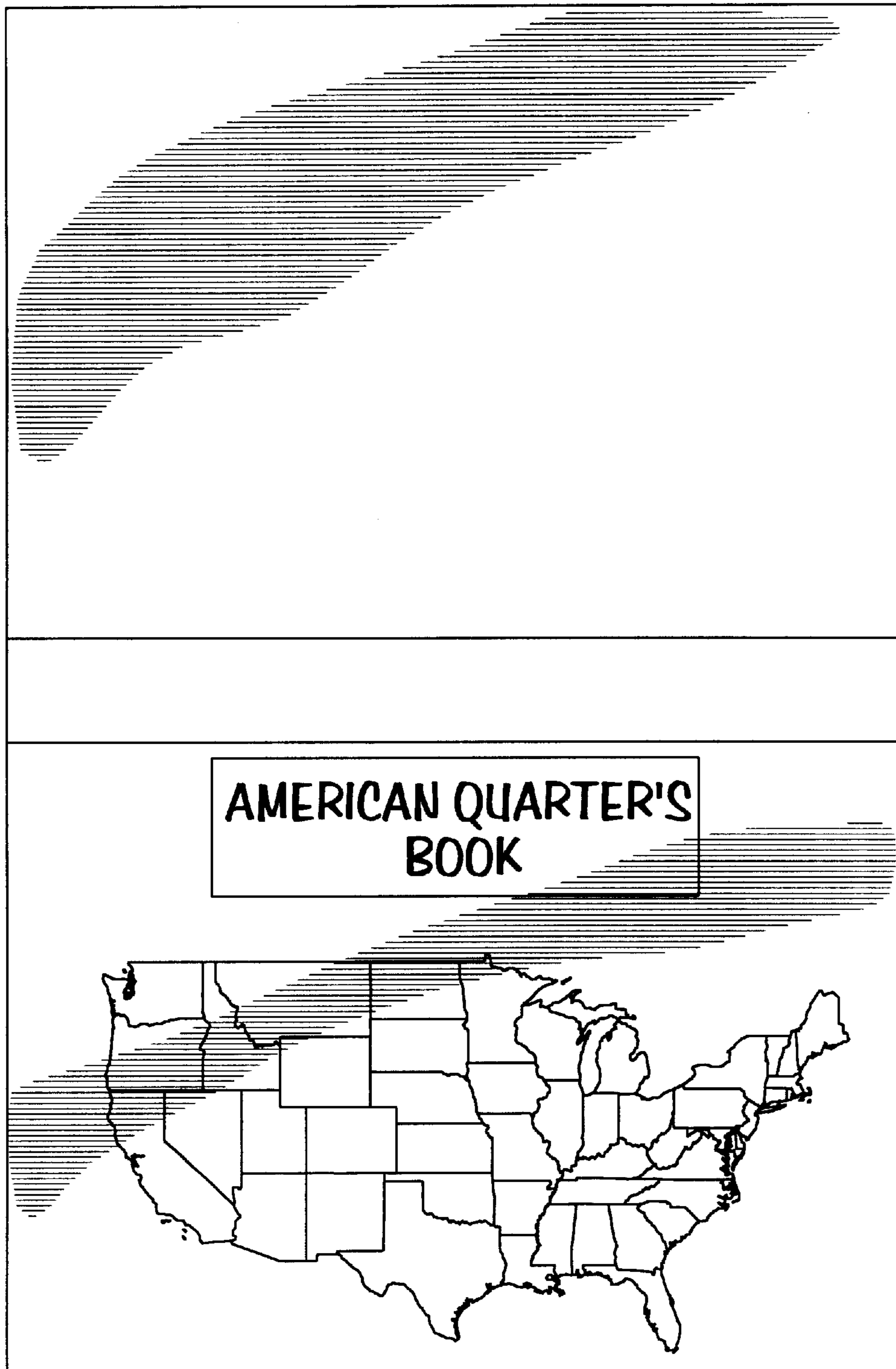

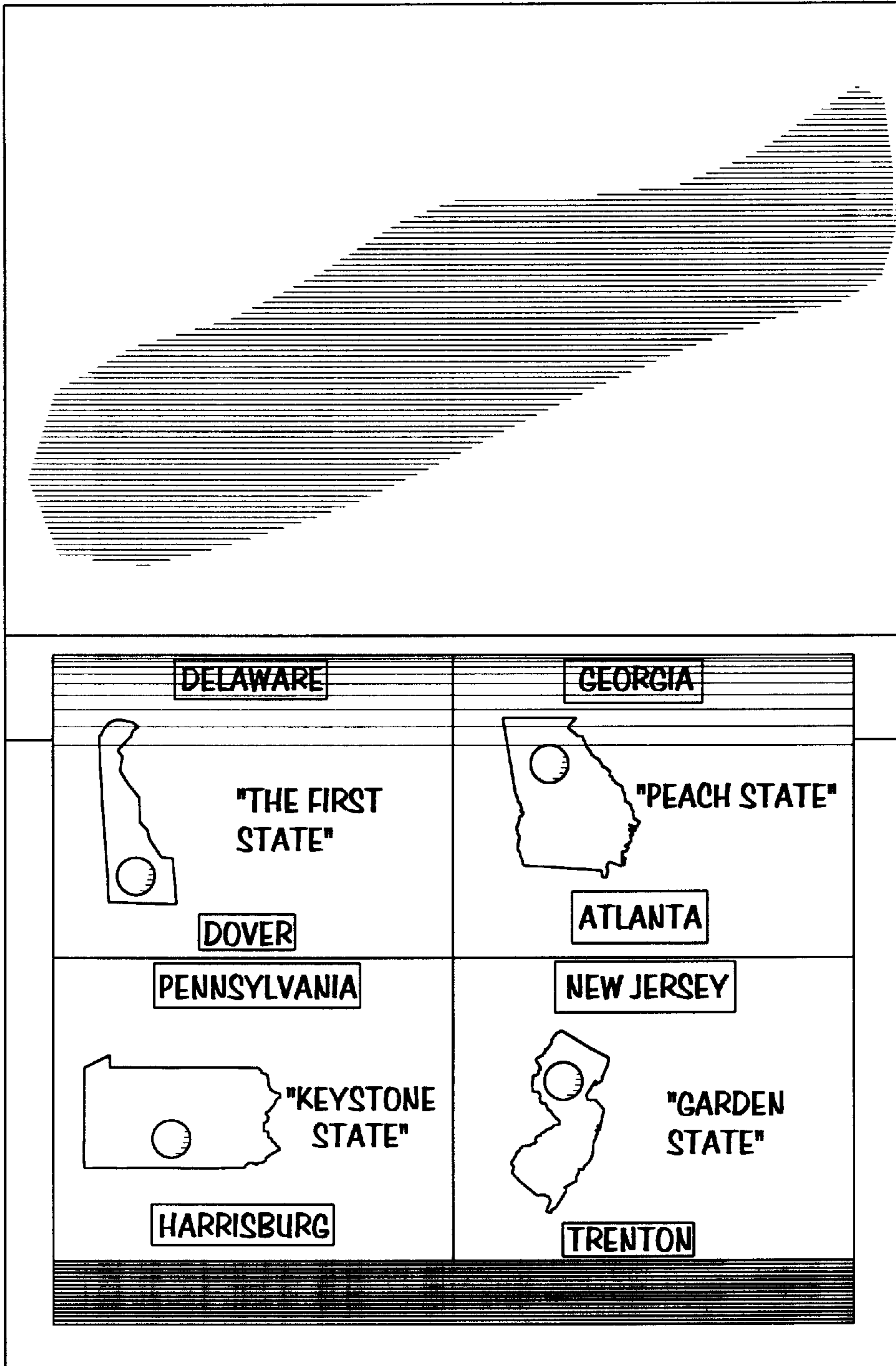

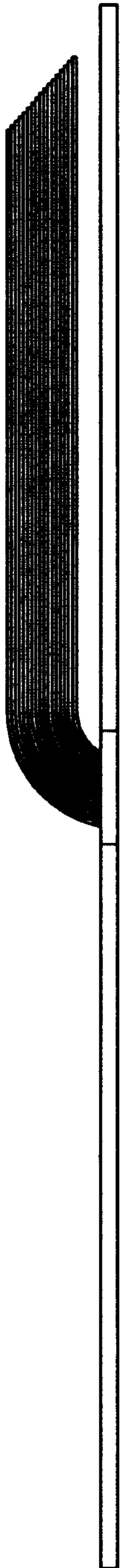

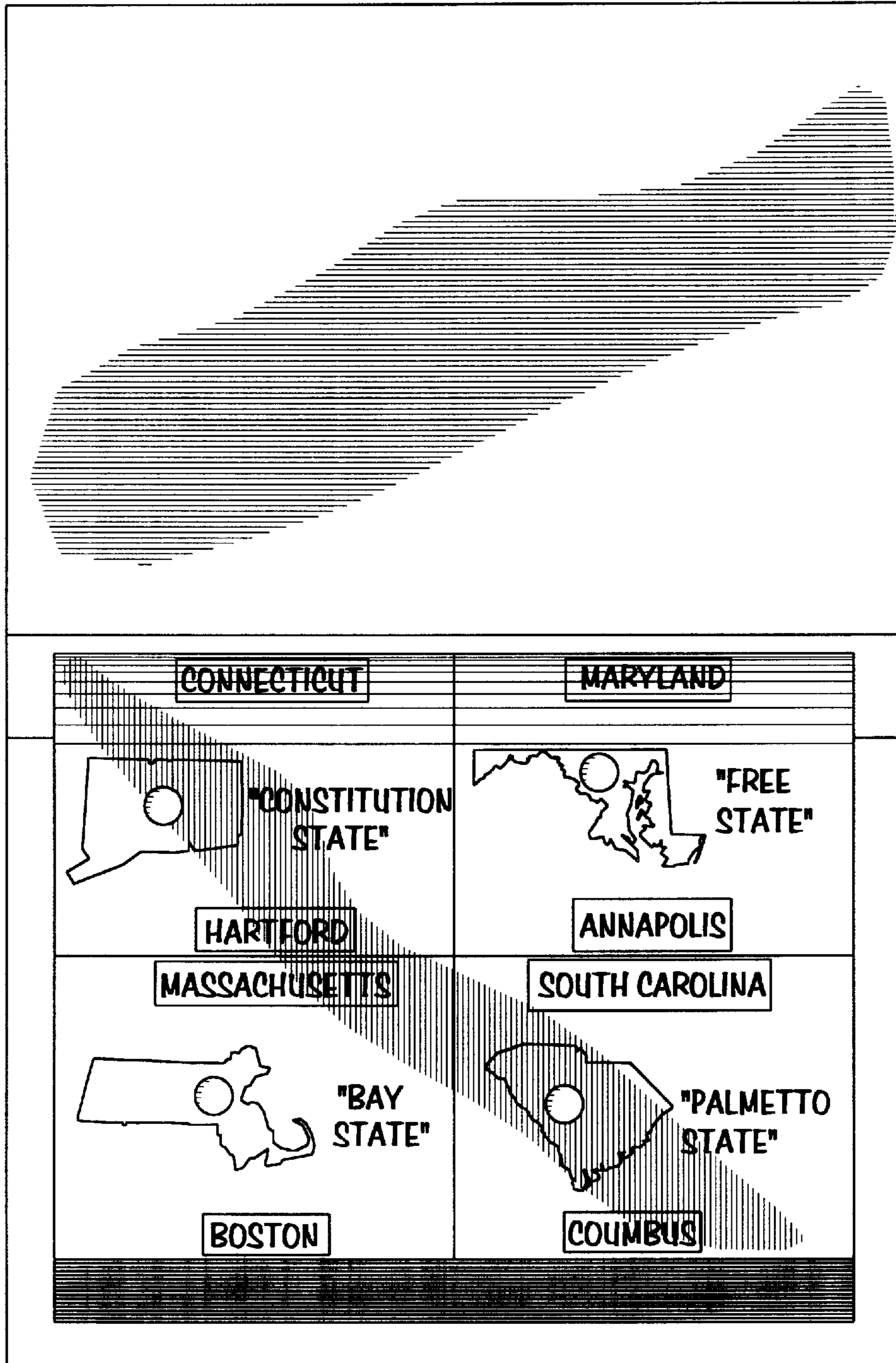

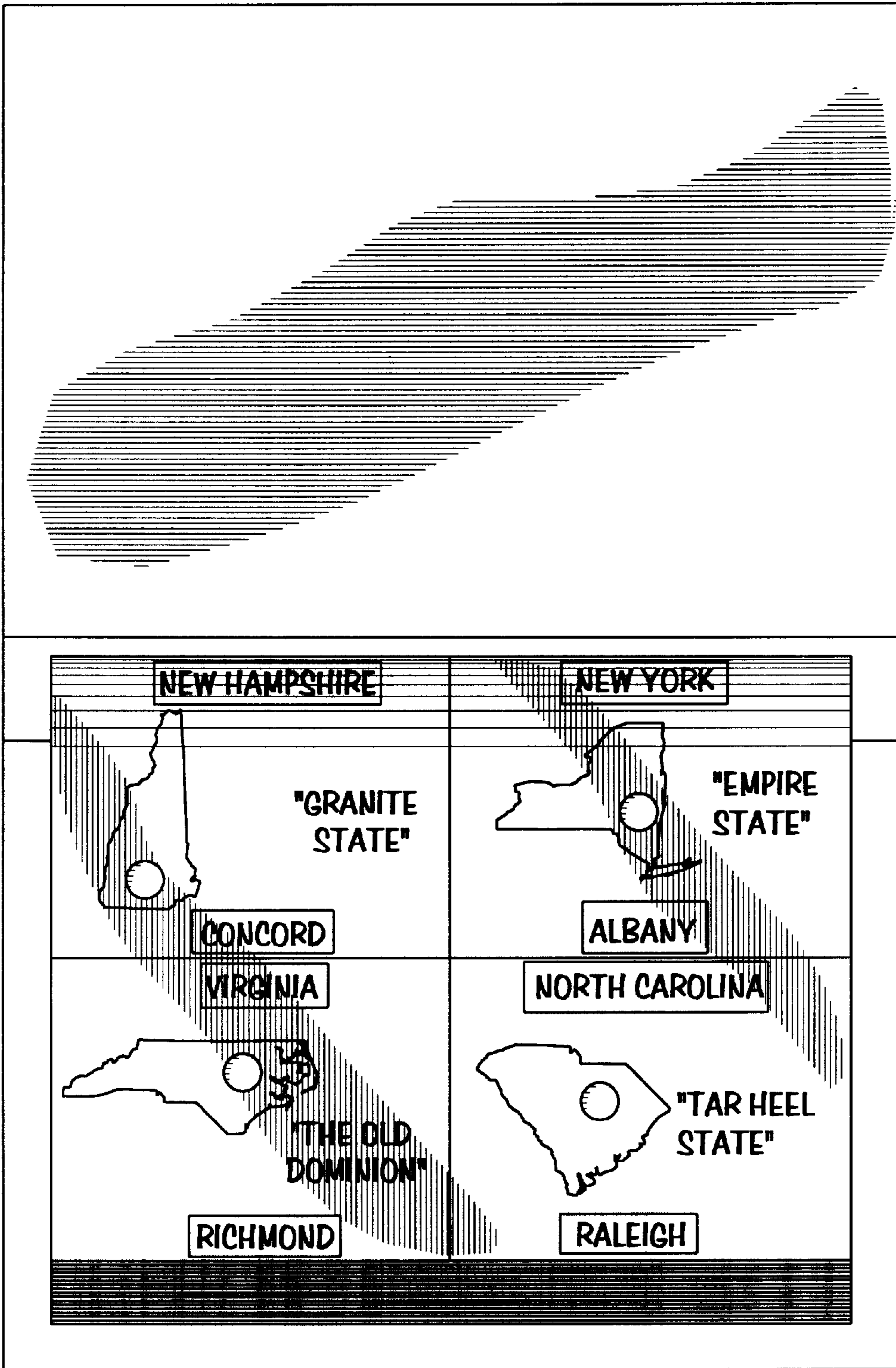

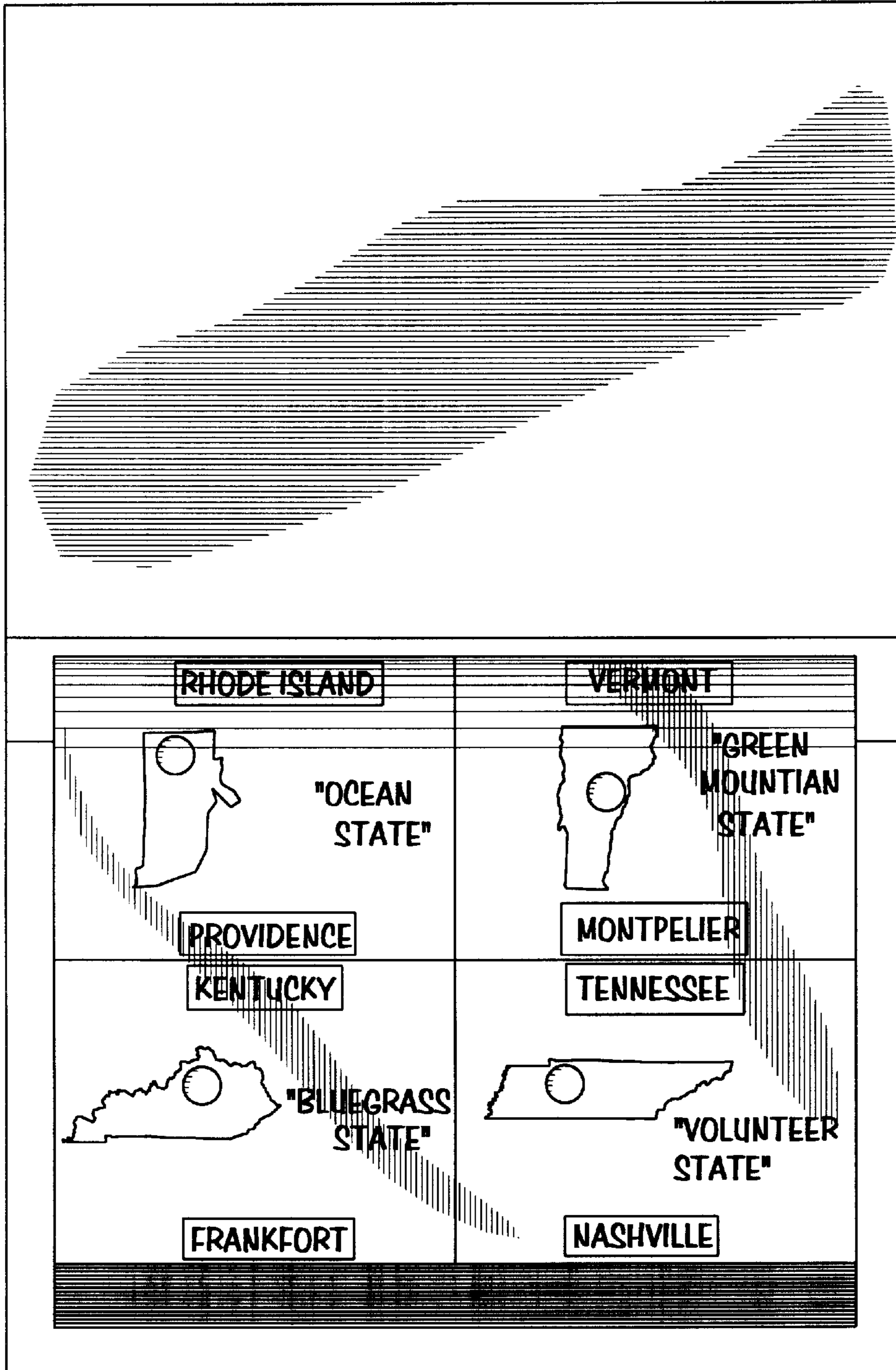

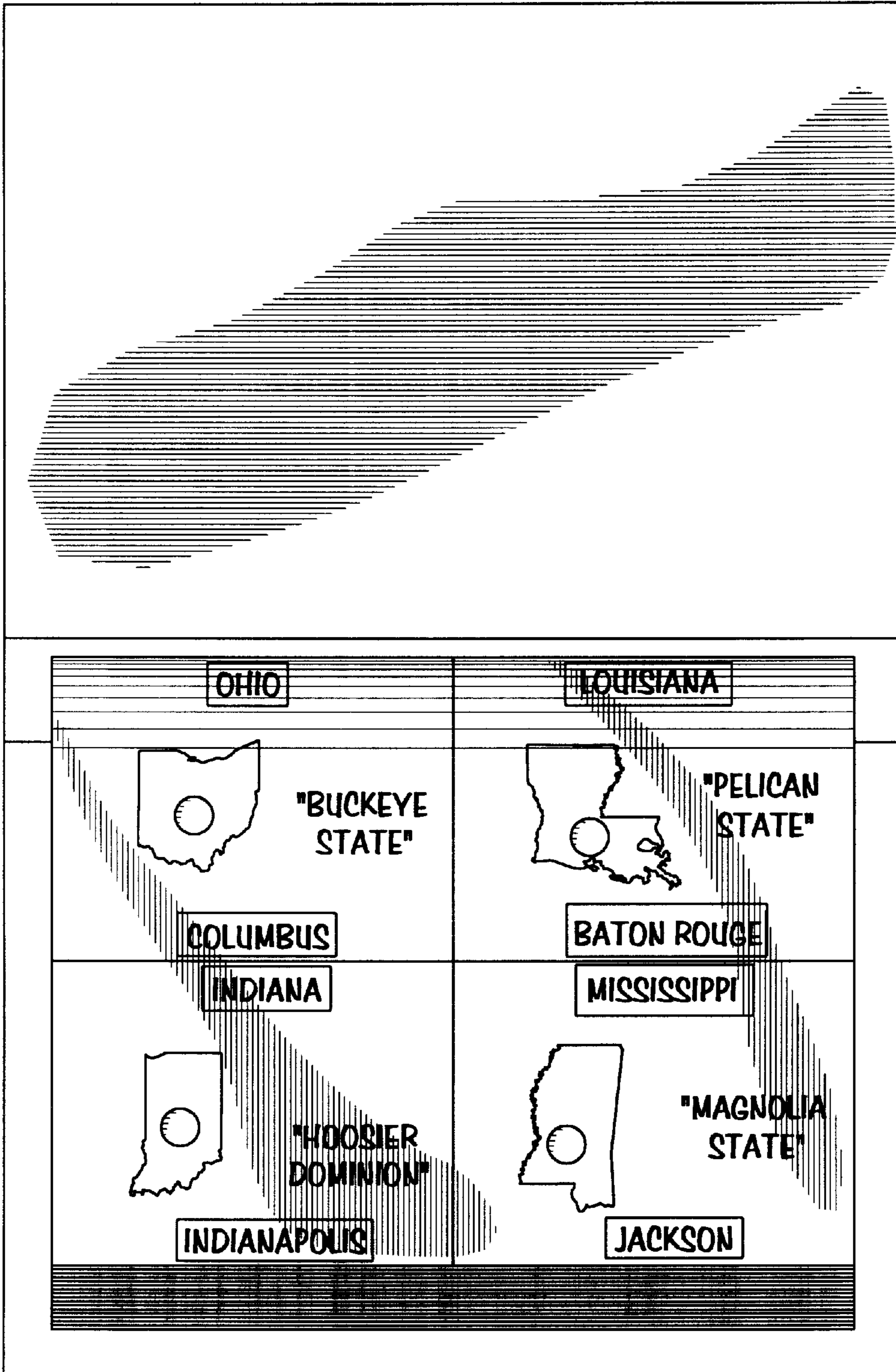

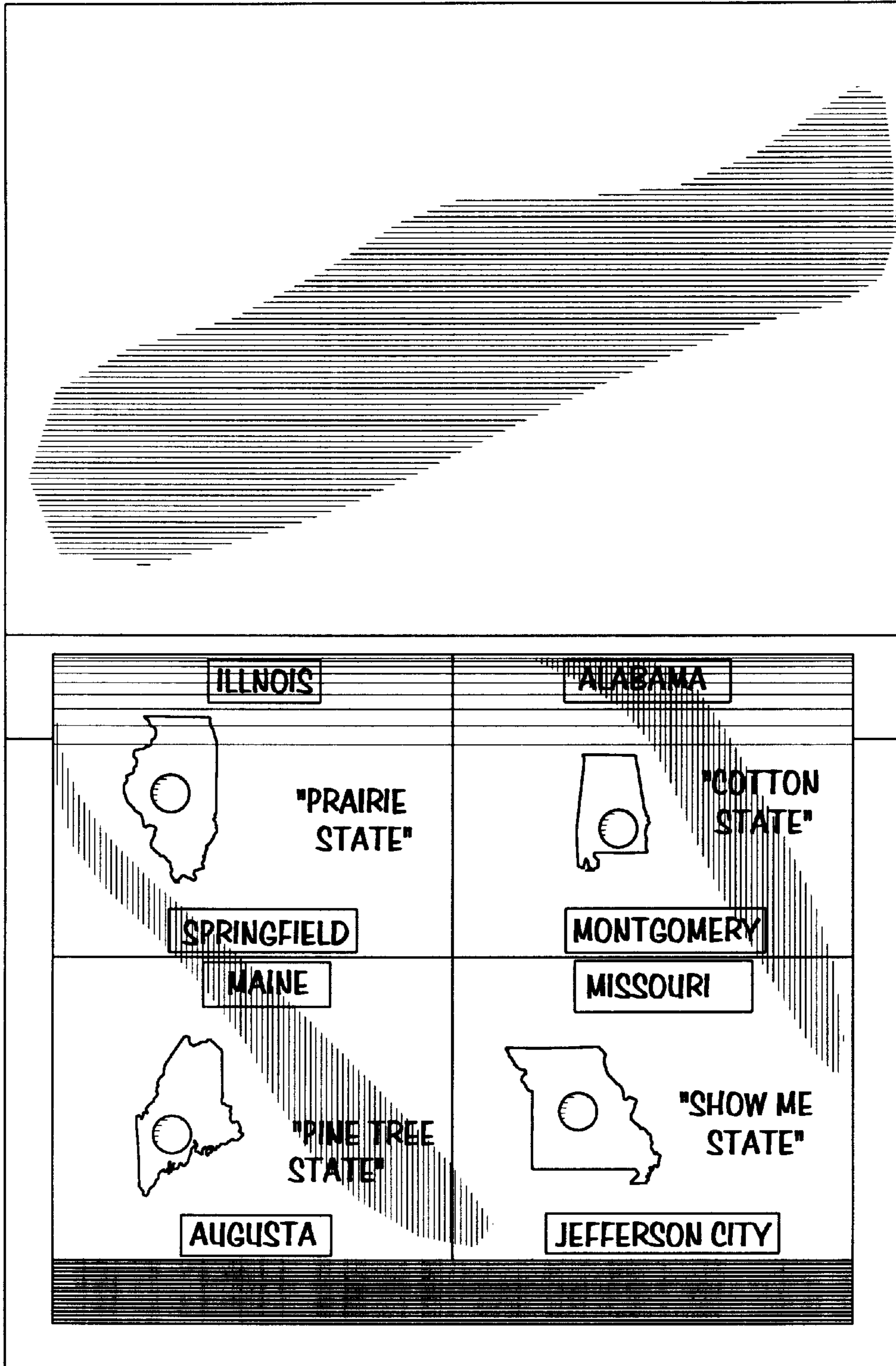

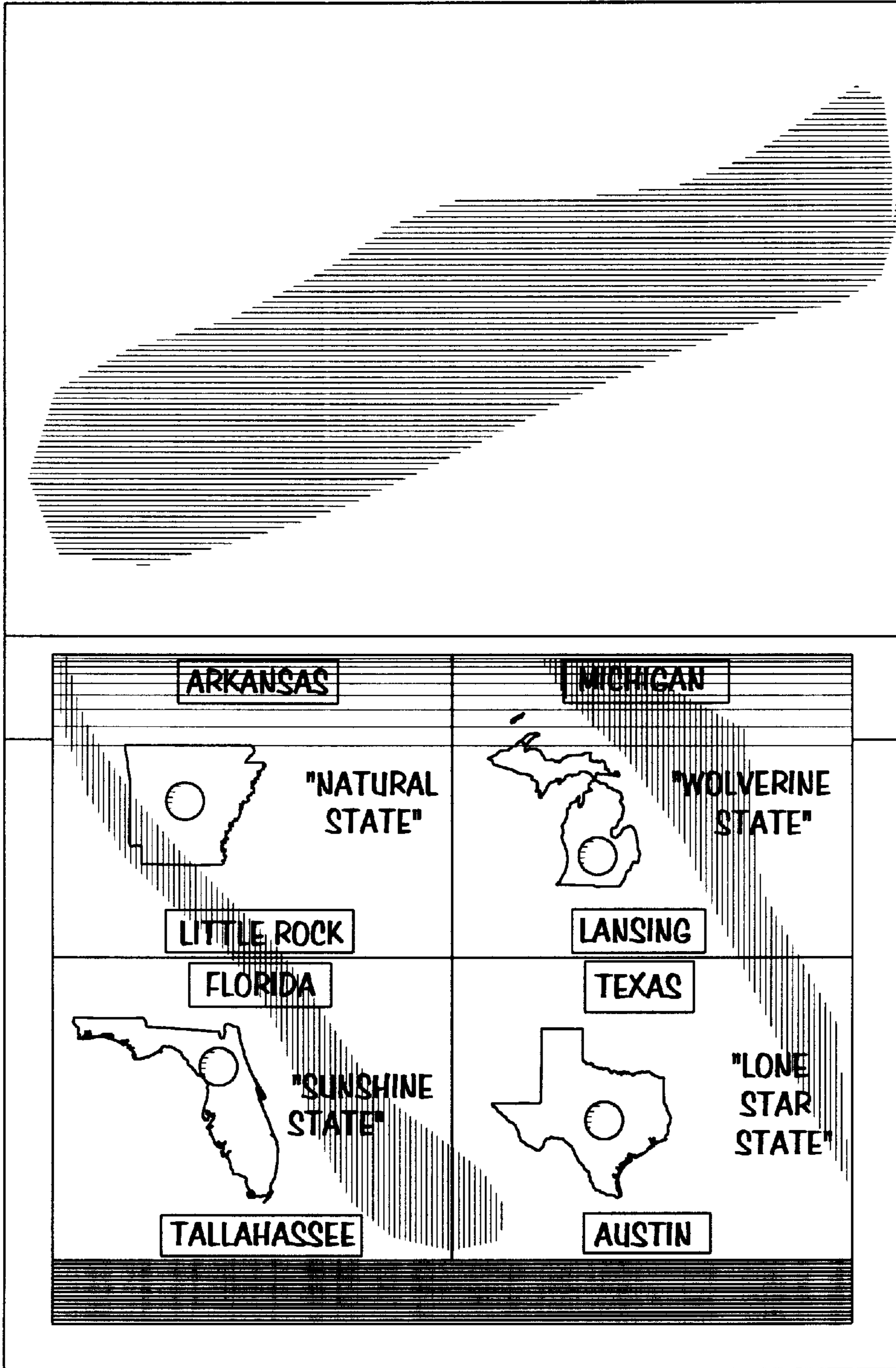

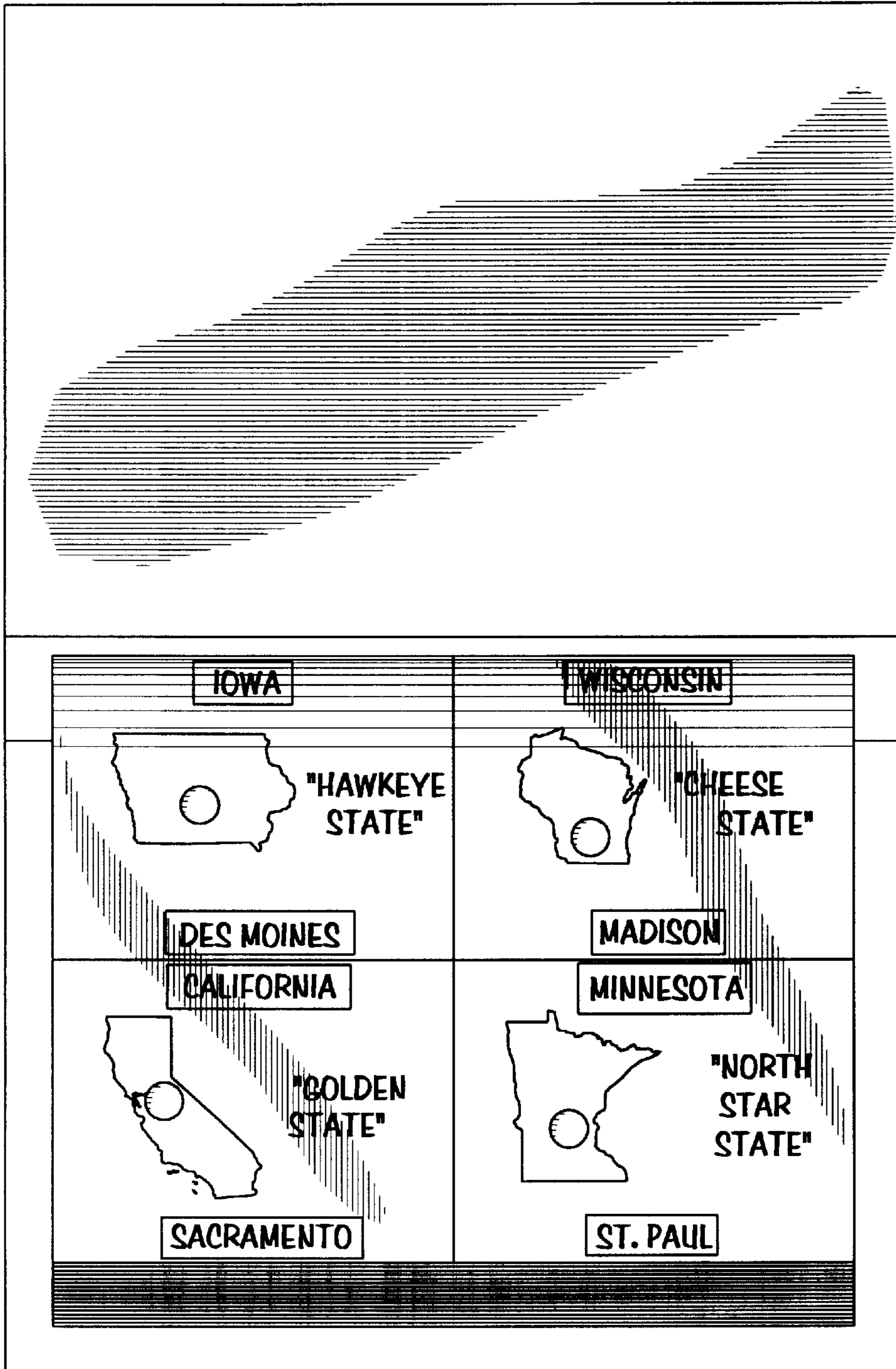

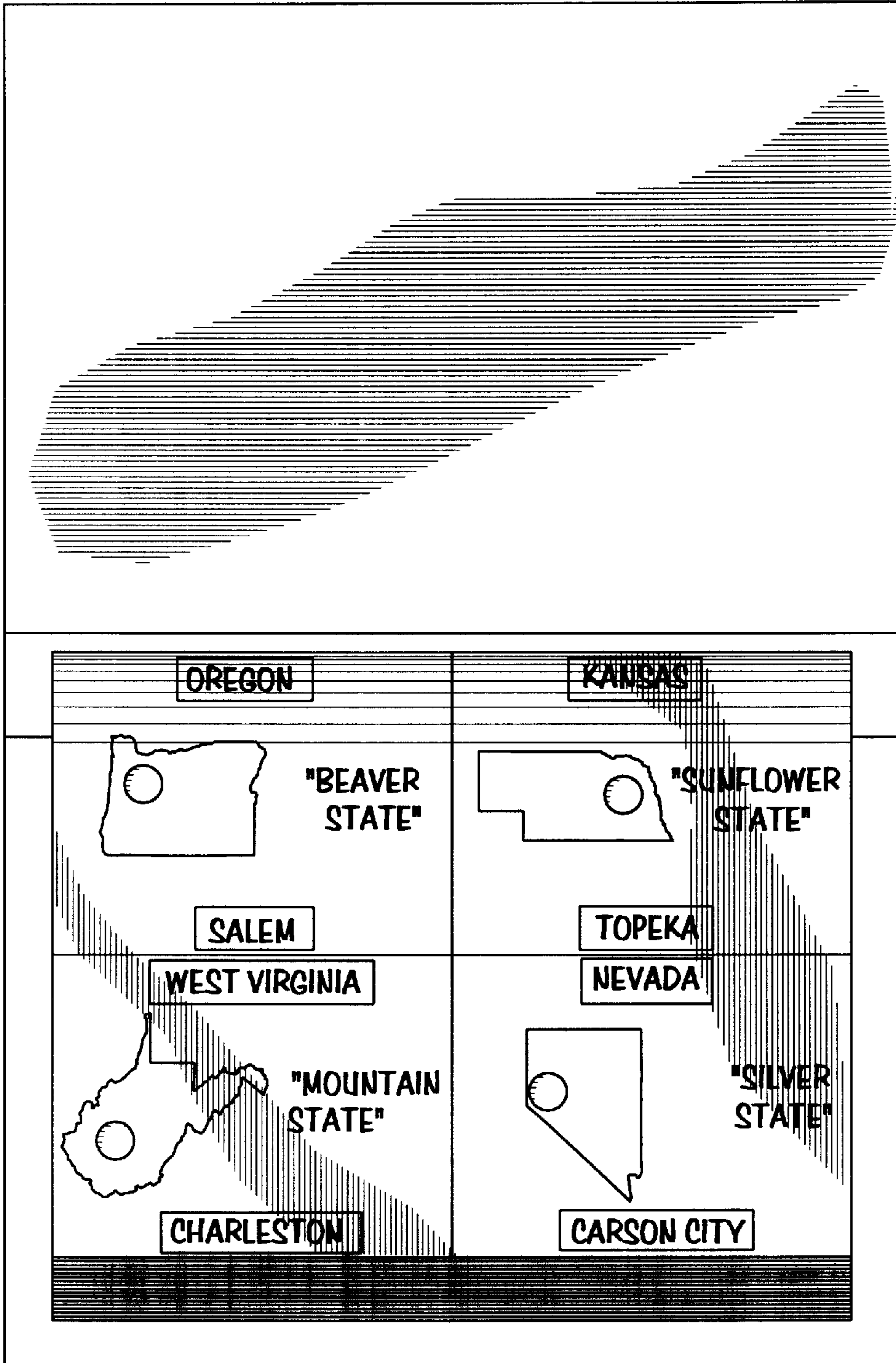

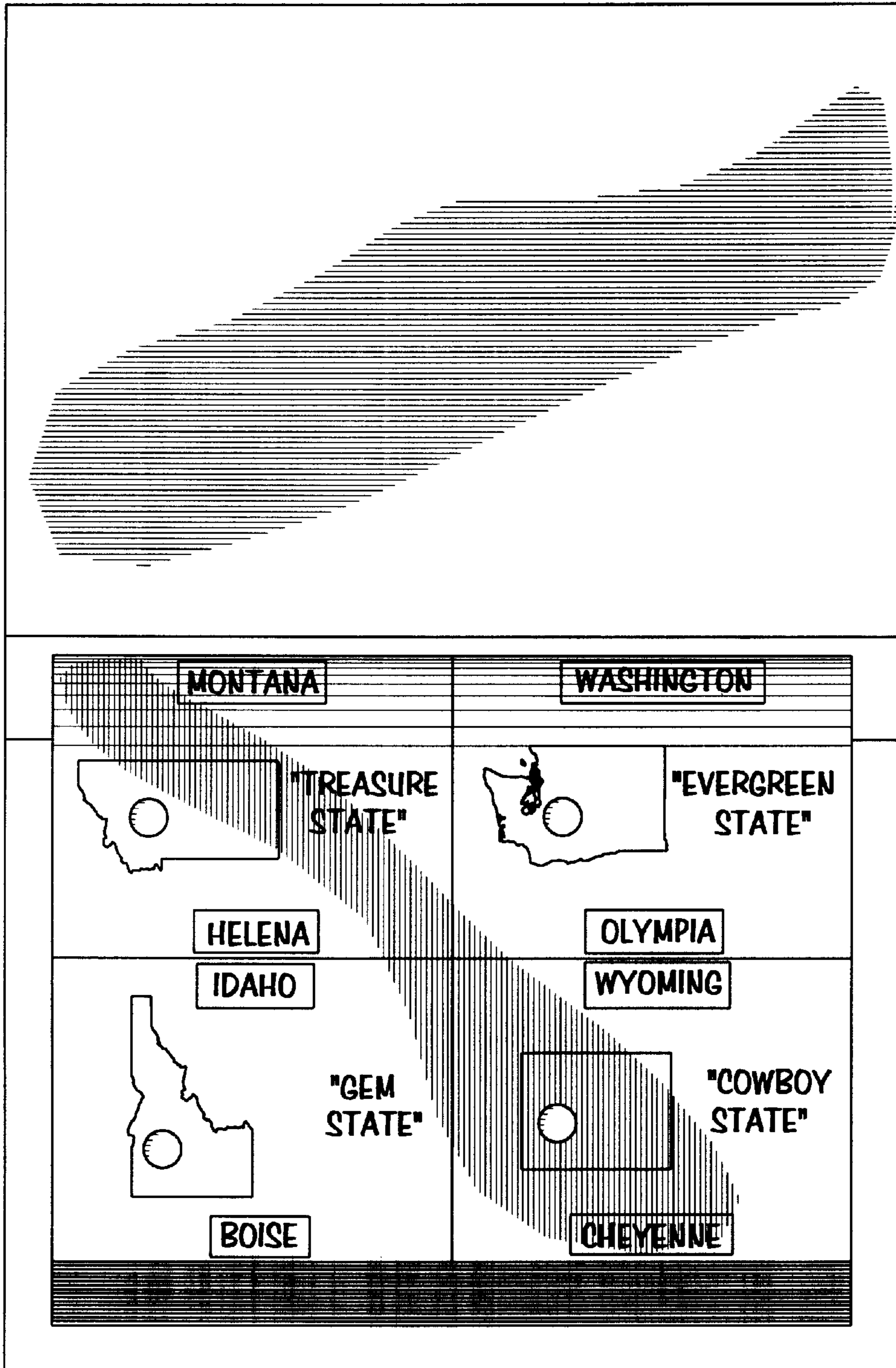

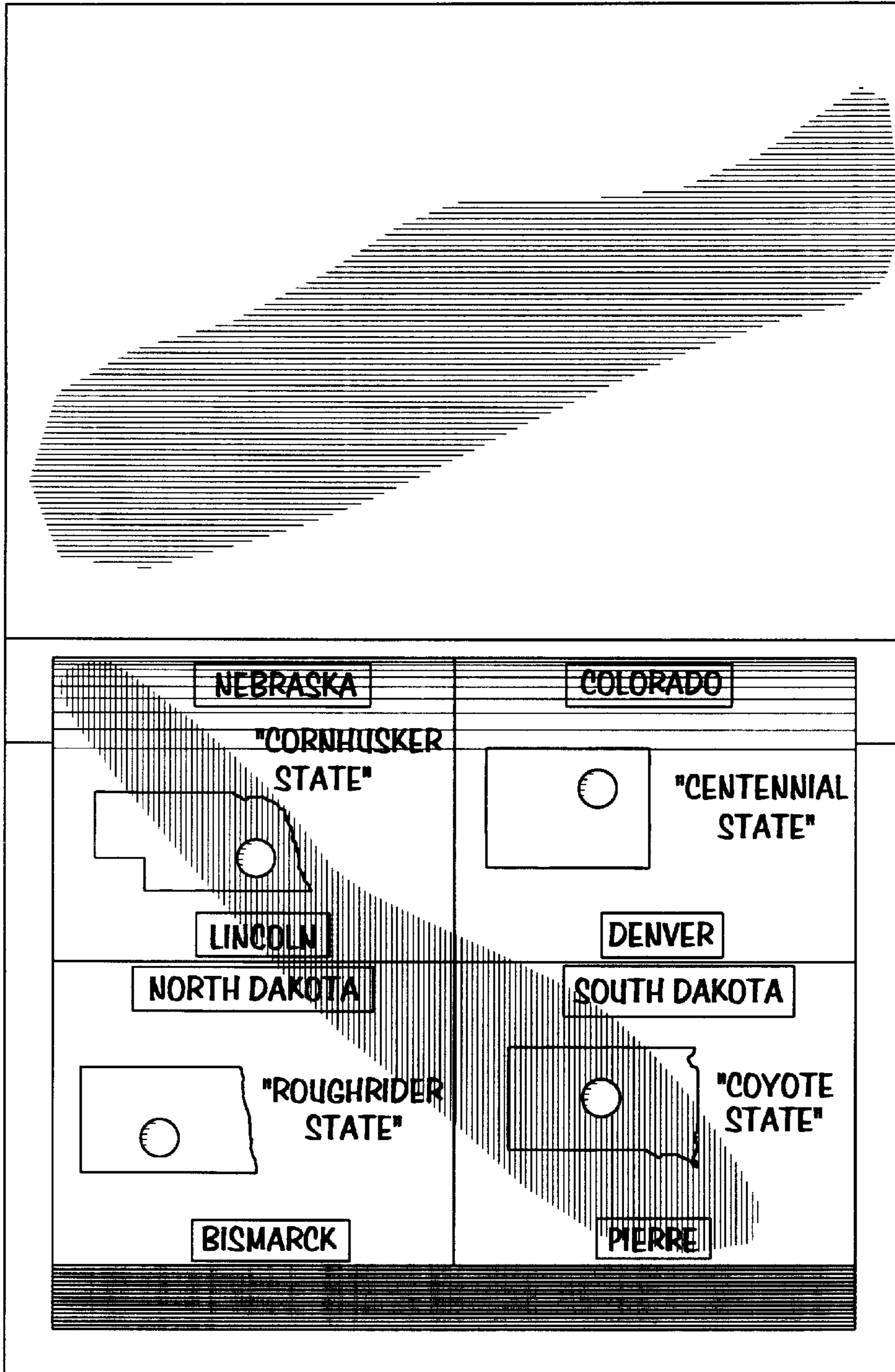

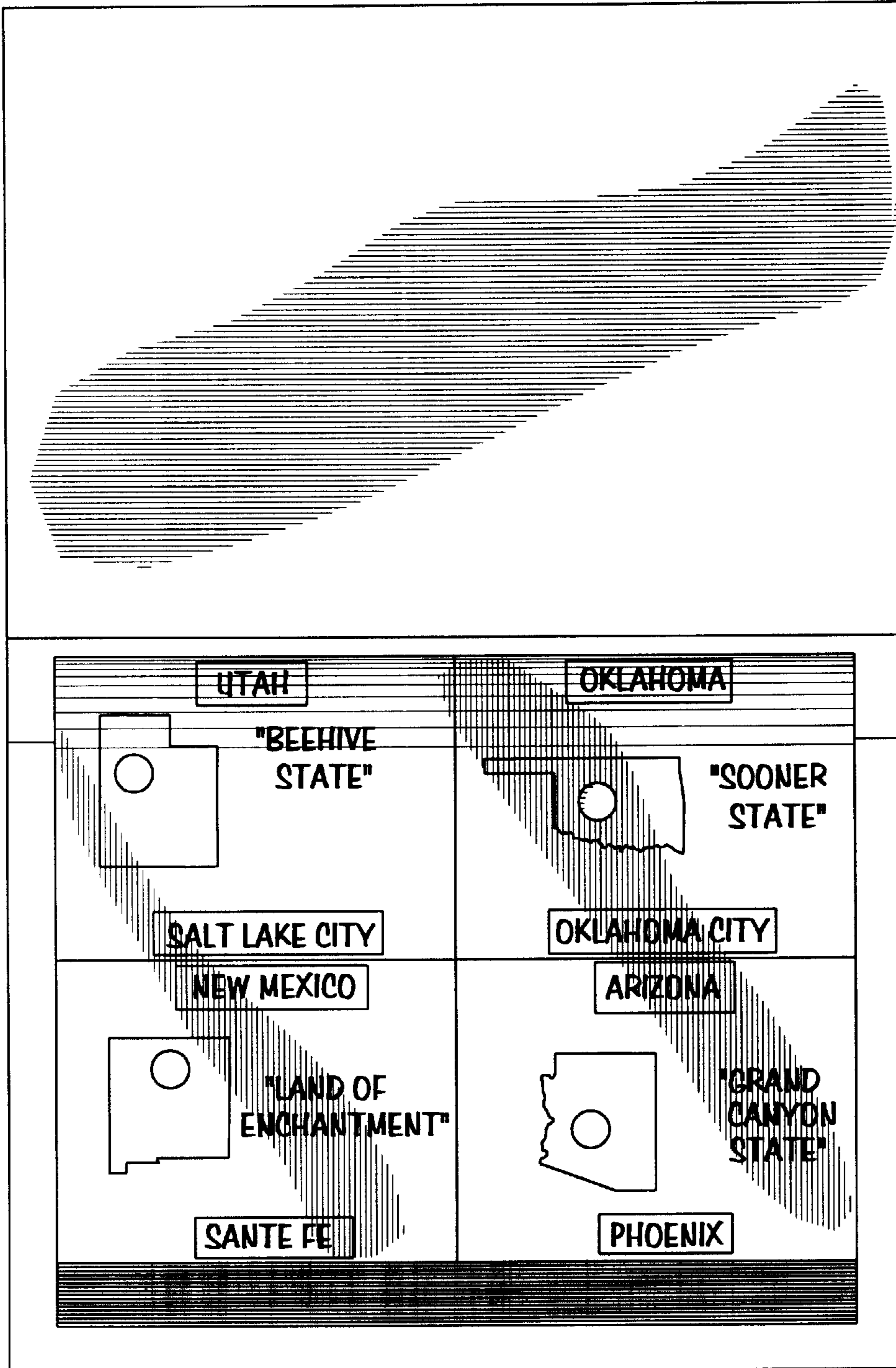

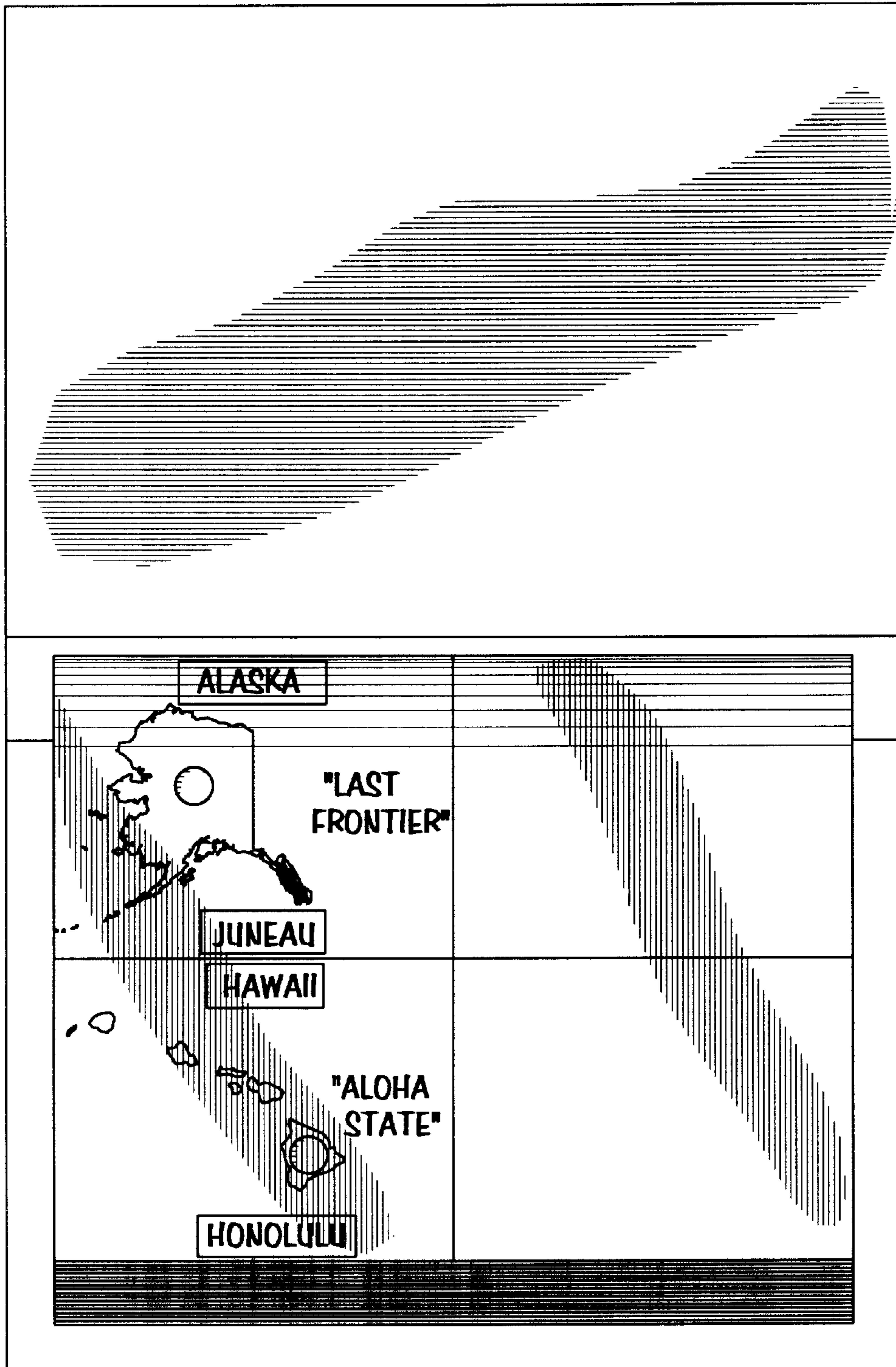
