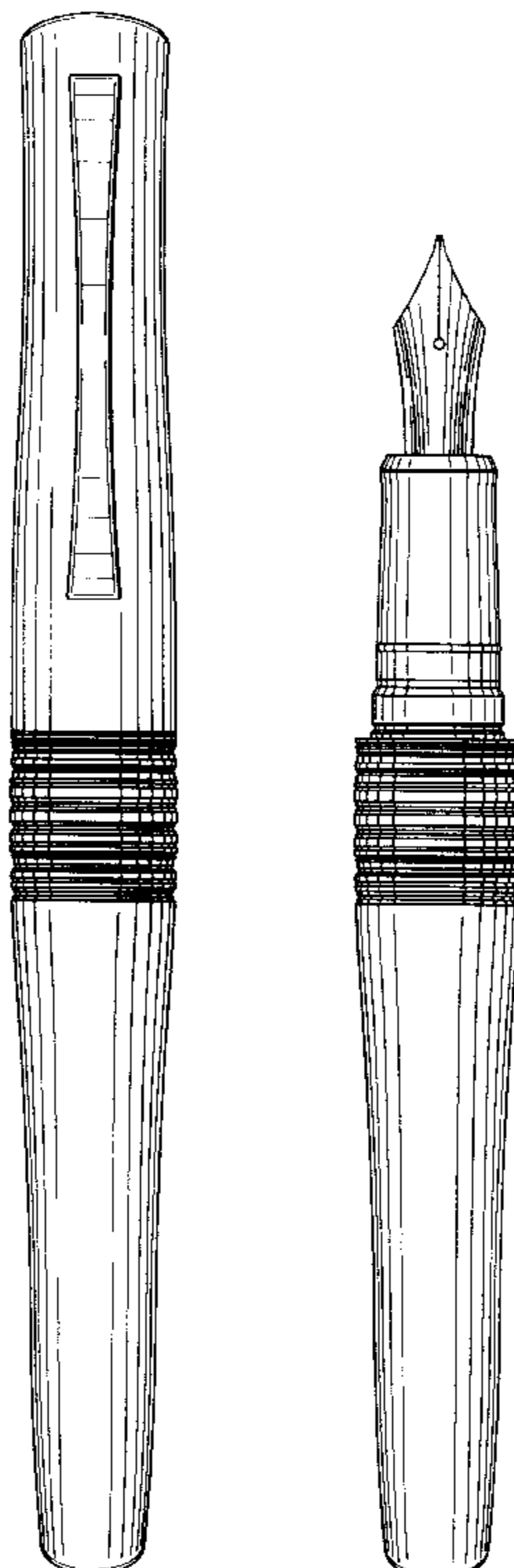
(57) **CLAIM**

The ornamental design for a fountain pen, as shown and described.

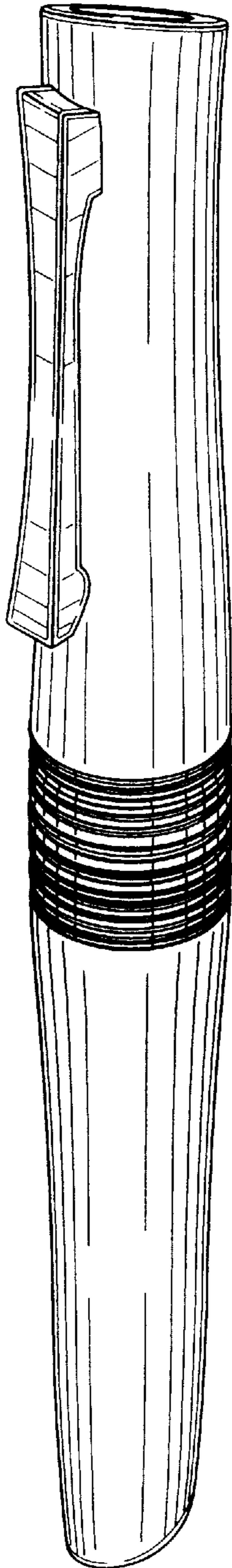
**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a fountain pen showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a front elevational view of the body of the pen with the cover removed for ease of illustration;  
 FIG. 8 is a right side elevational view thereof, the left side being a mirror image thereof;  
 FIG. 9 is a rear elevational view thereof;  
 FIG. 10 is a top plan view thereof;  
 FIG. 11 is a bottom plan view thereof;  
 FIG. 12 is a front elevational view of the cover per se for ease of illustration;  
 FIG. 13 is a right side elevational view thereof, the left side being a mirror image thereof;  
 FIG. 14 is a rear elevational view thereof; and,  
 FIG. 15 is a bottom plan view thereof.

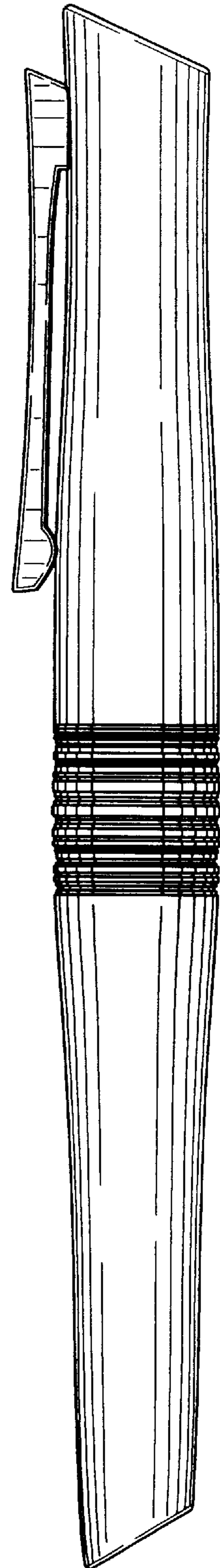

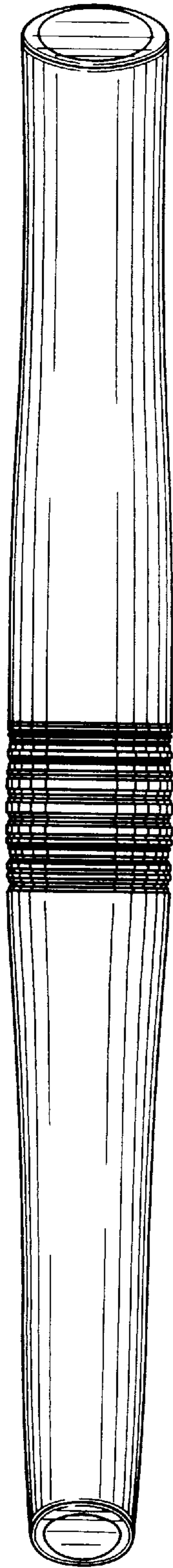

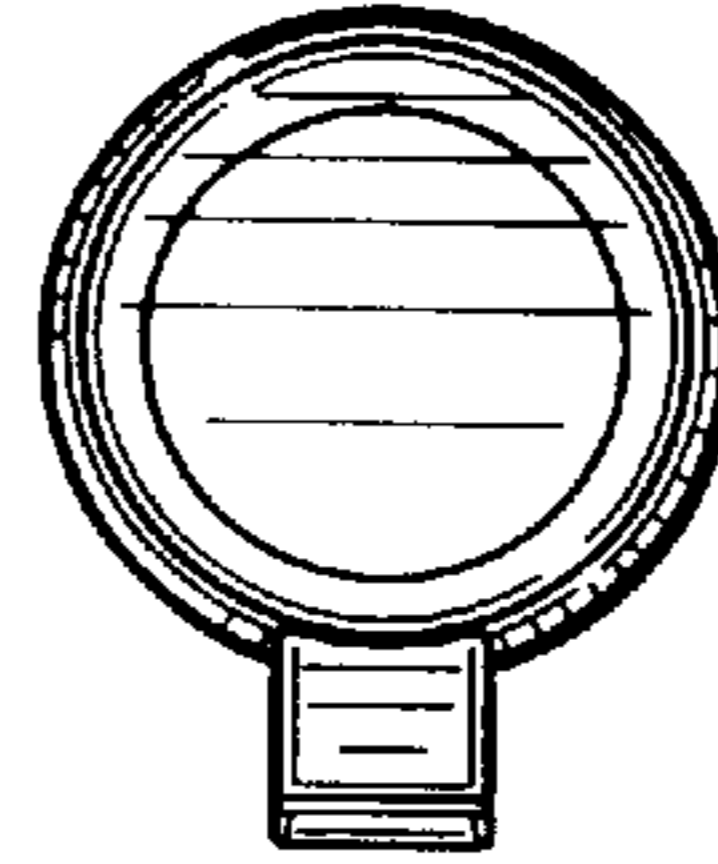

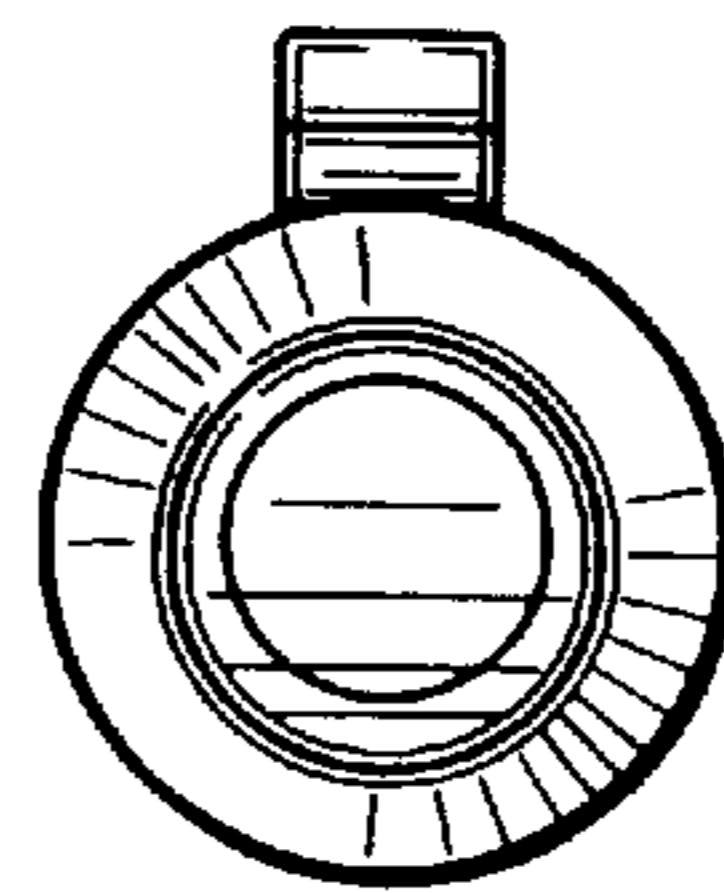

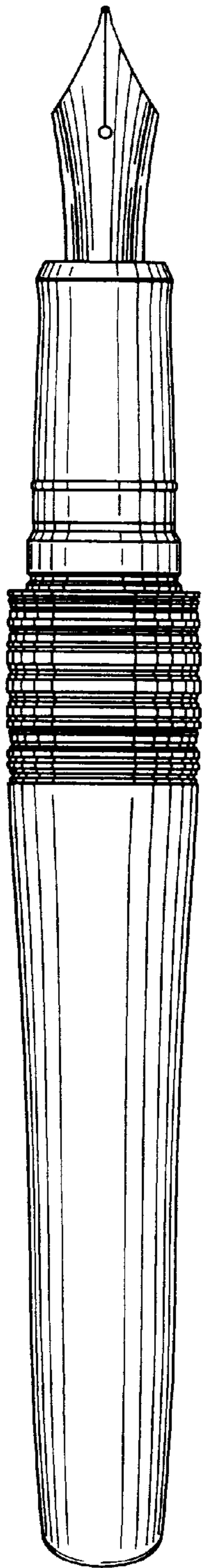

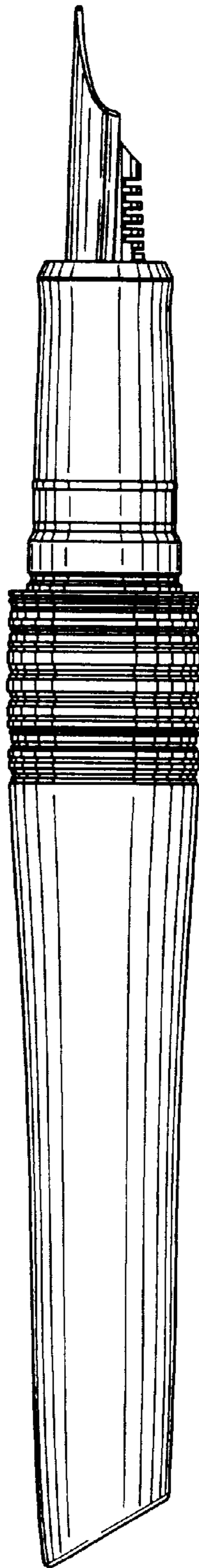

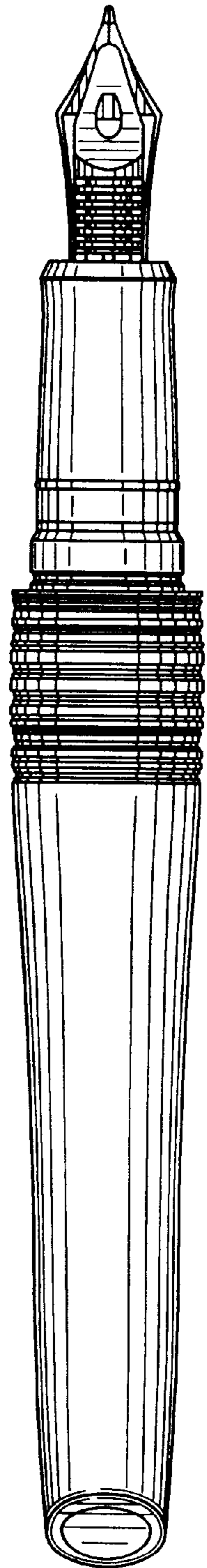

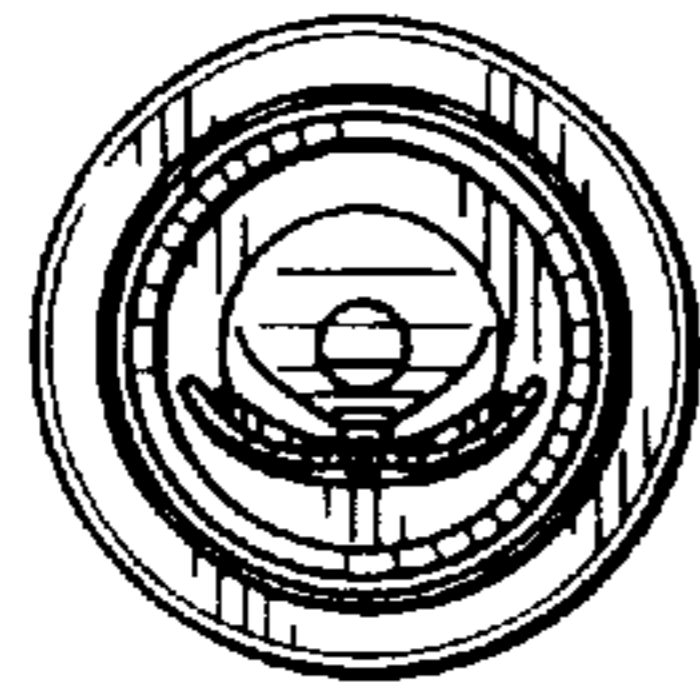

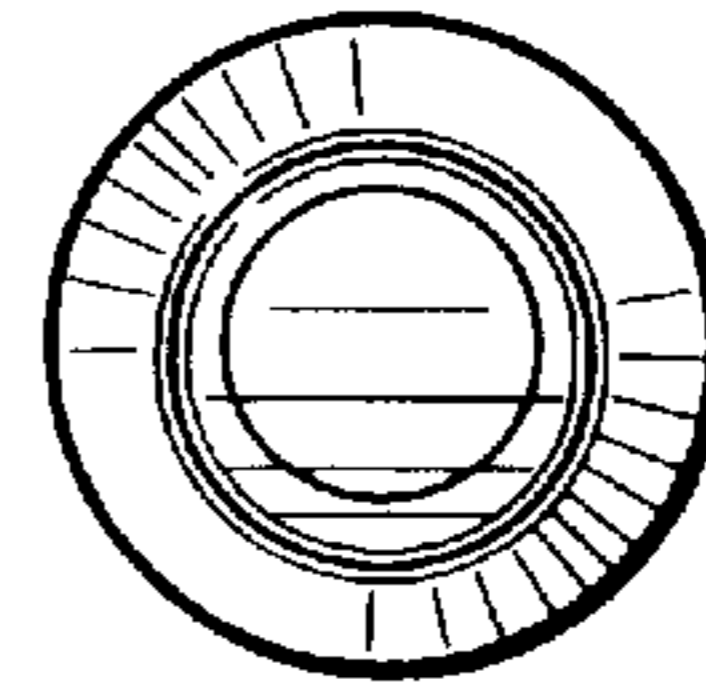

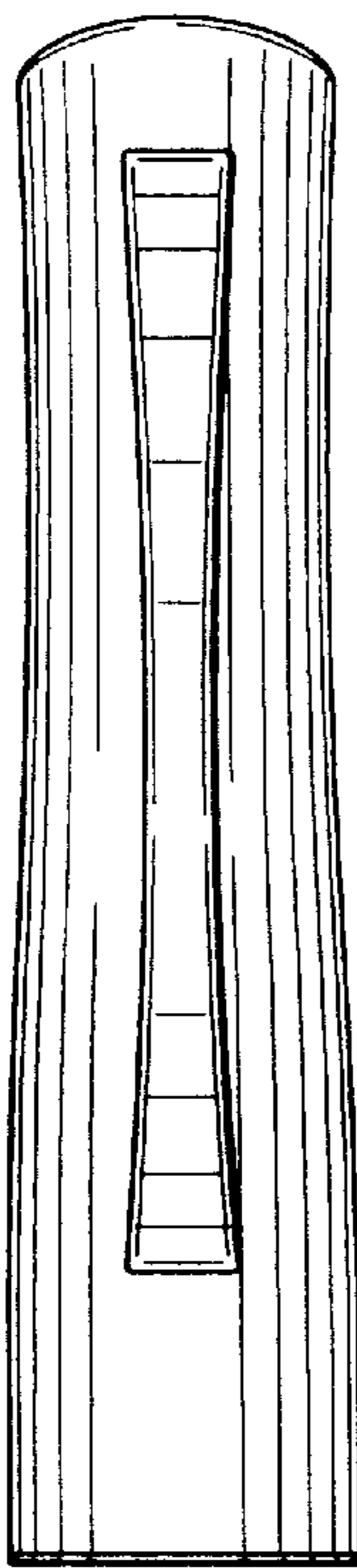

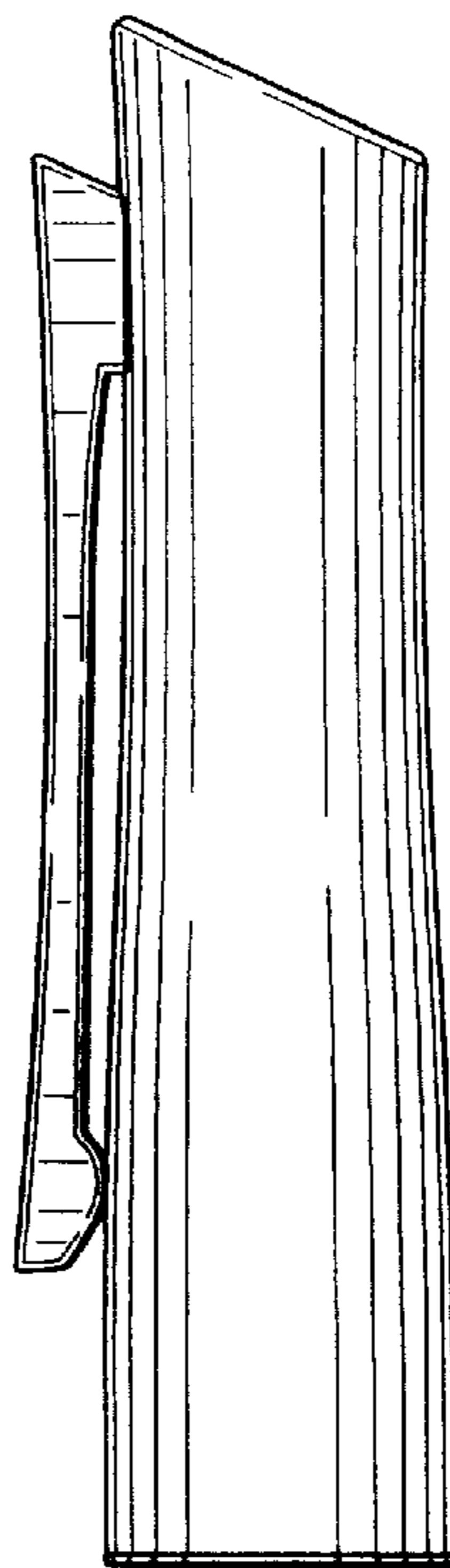

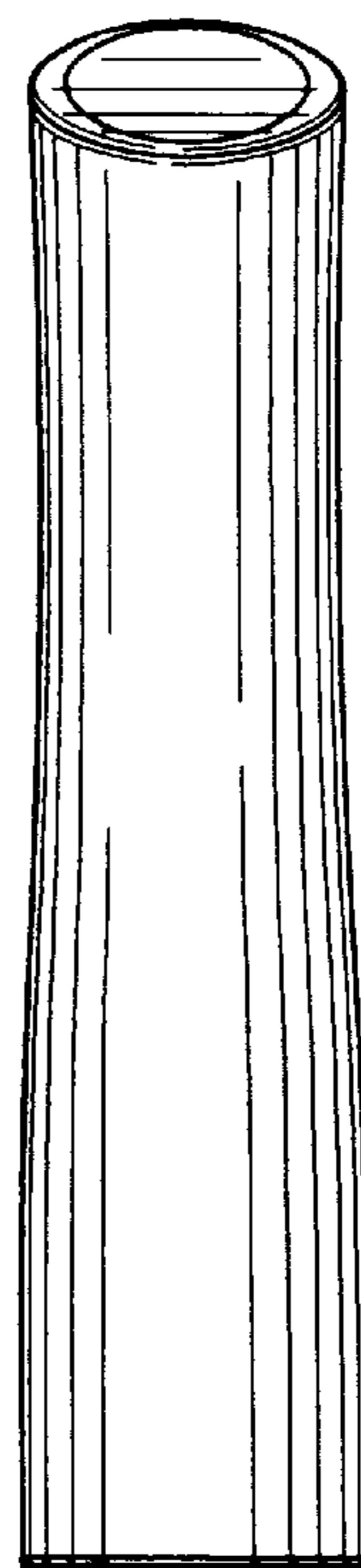
