FIG. 2 is a side view thereof;

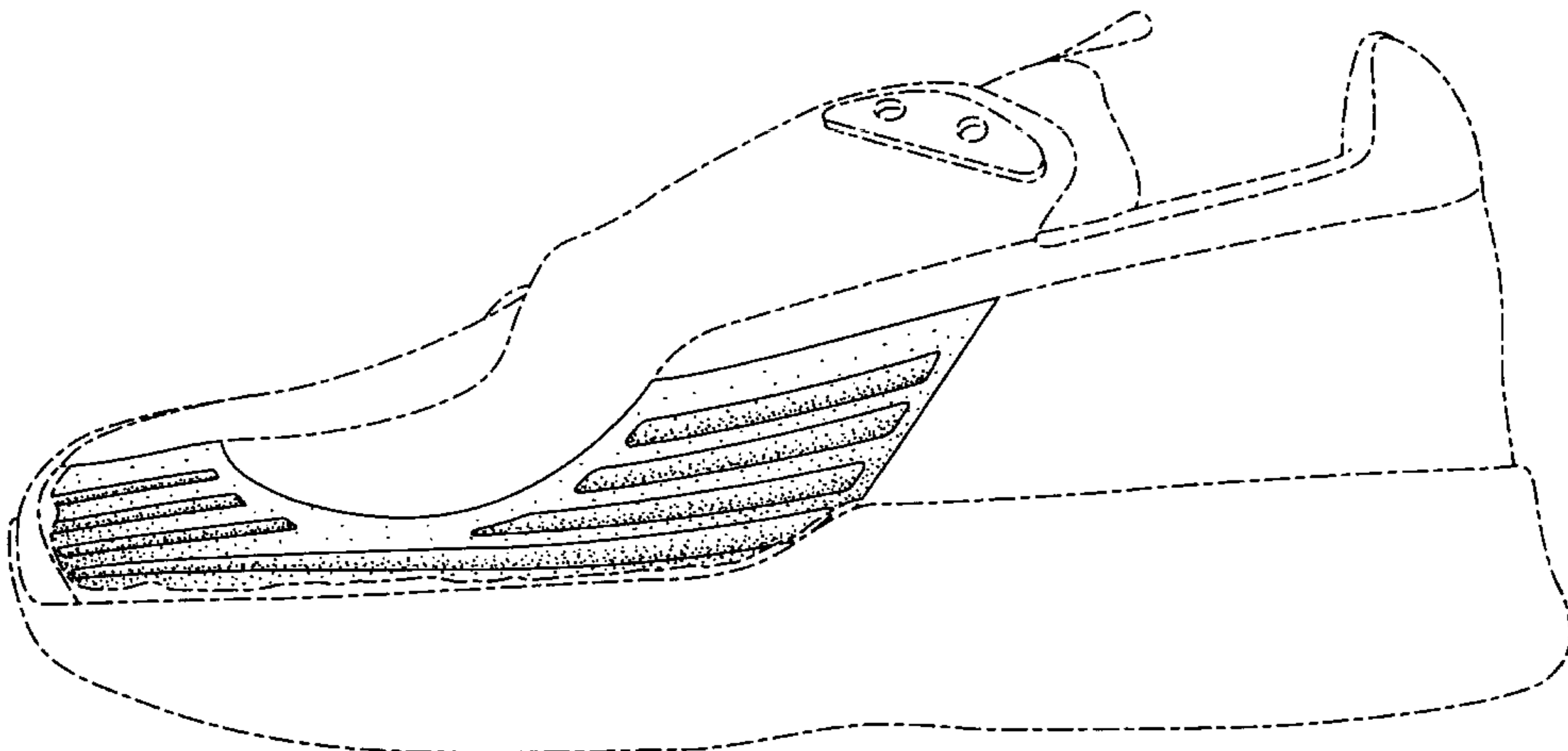
FIG. 3 a top plan view thereof;

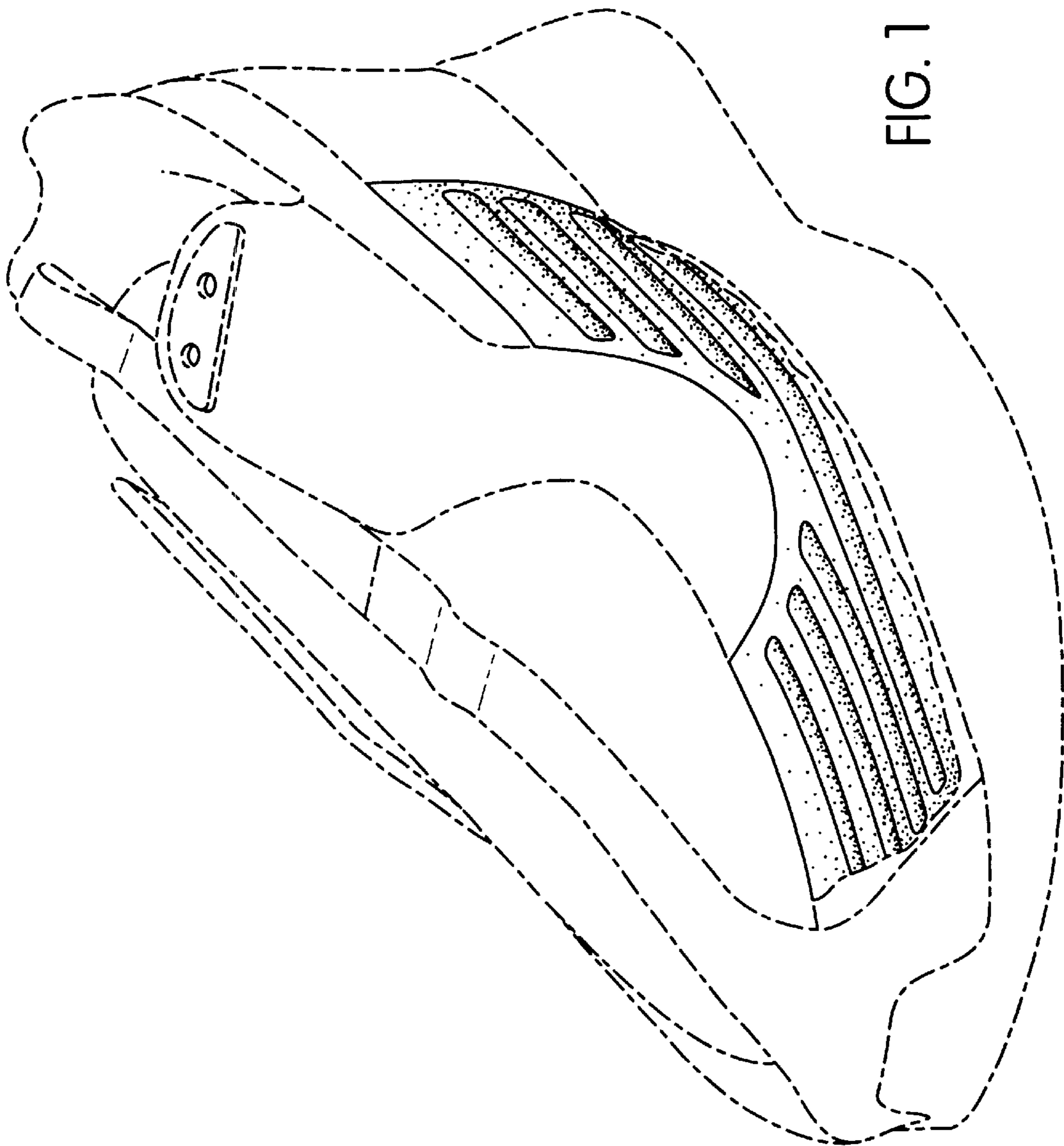

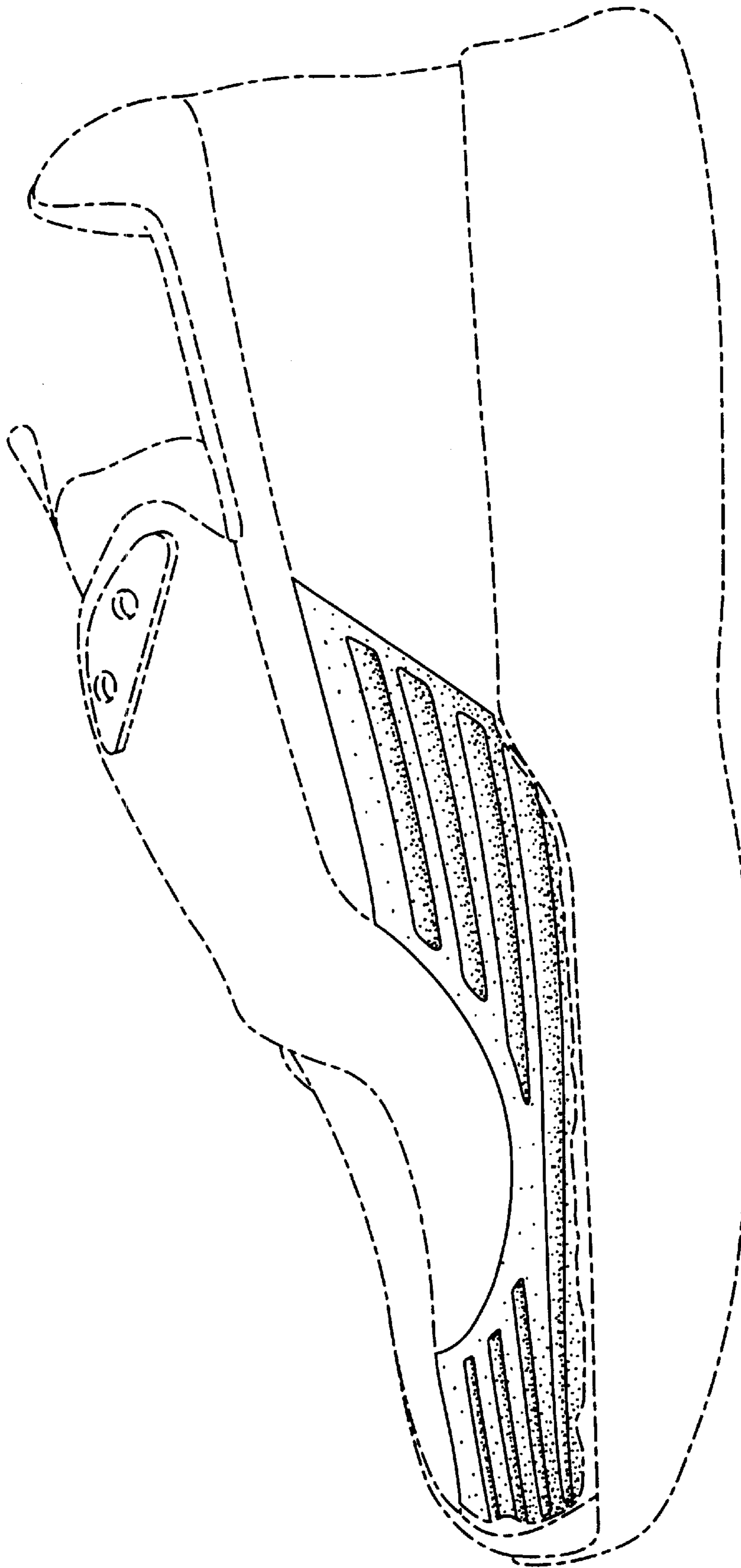

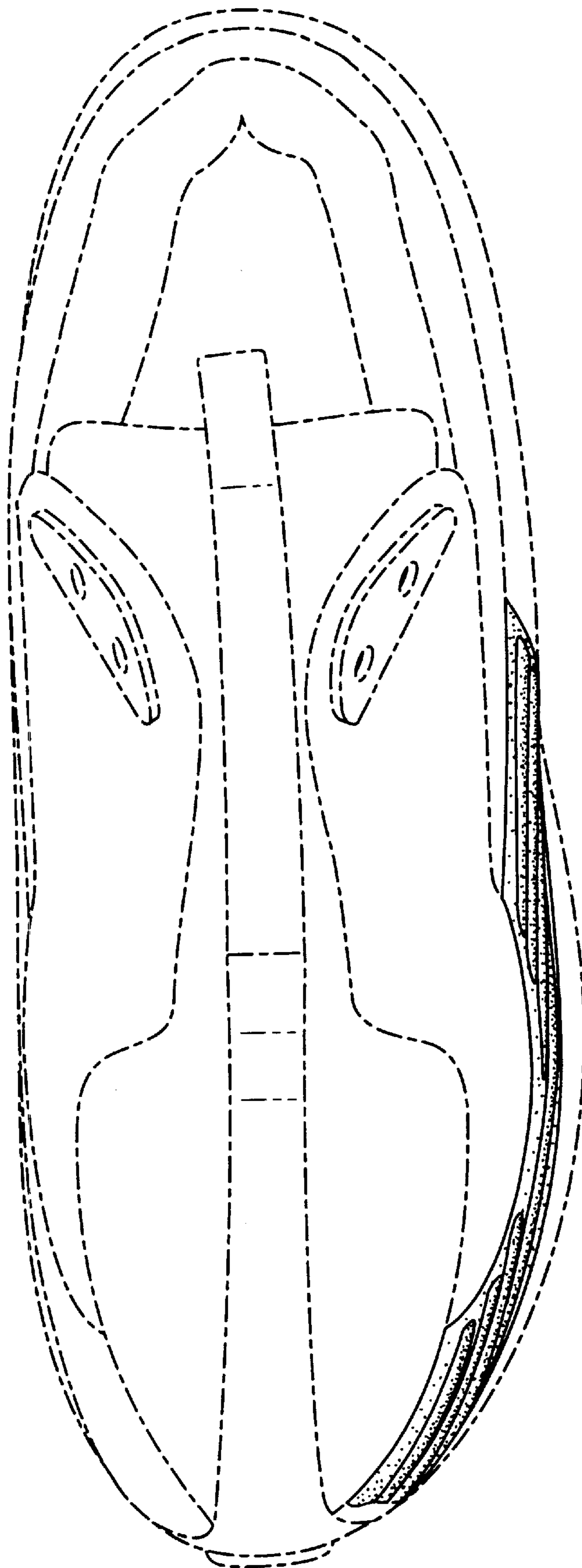

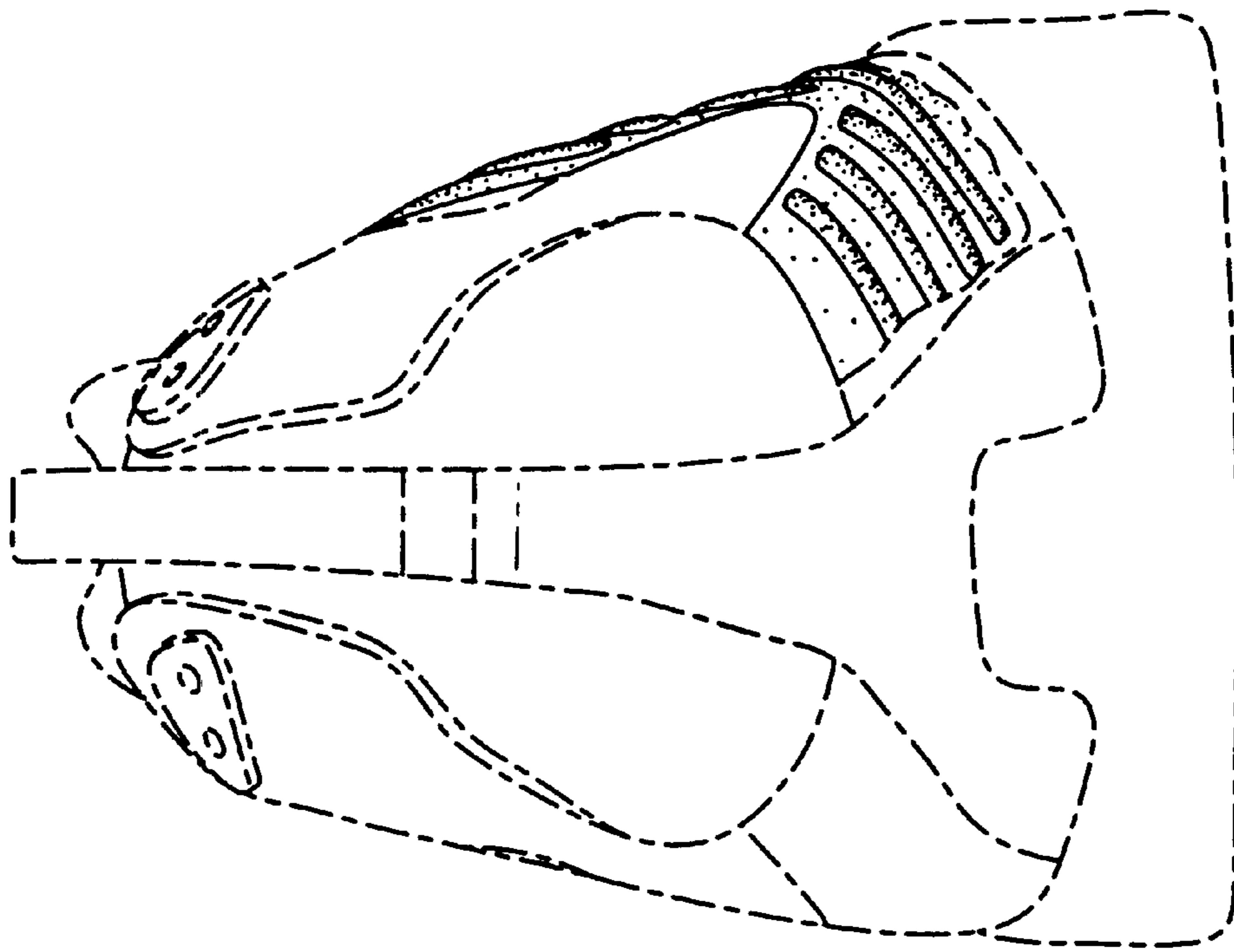

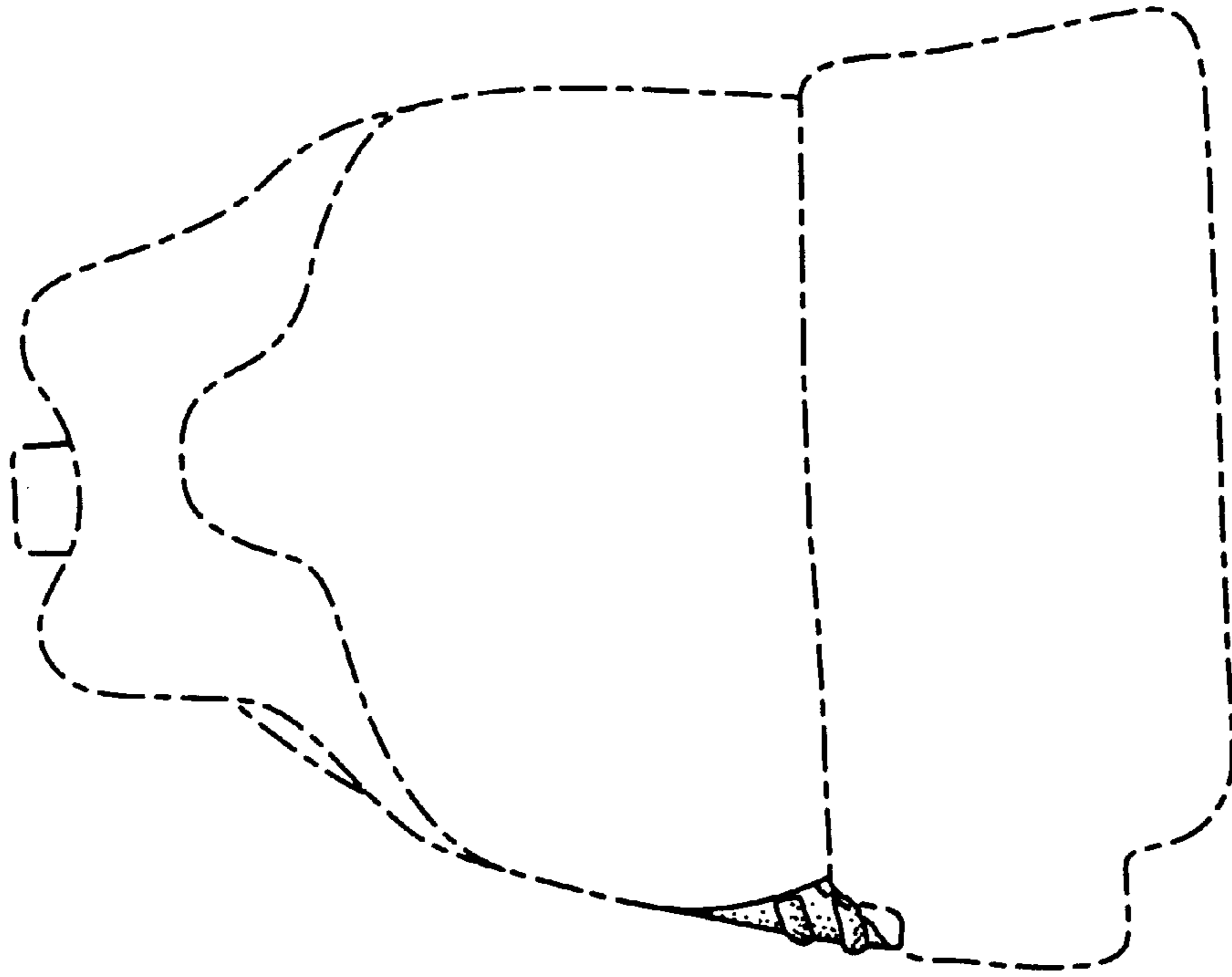
