The ornamental design for a display apparatus, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the display apparatus showing our new design;

FIG. 2 is a front elevation view of the display apparatus shown in FIG. 1;

FIG. 3 is a right side elevation view of the display apparatus shown in FIG. 1, the left side elevation view being a mirror image thereof;

FIG. 4 is a rear elevation of the display apparatus shown in FIG. 1;

FIG. 5 is a top plan view of the display apparatus shown in FIG. 1; and,

FIG. 6 is a bottom plan view of the display apparatus shown in FIG. 1.

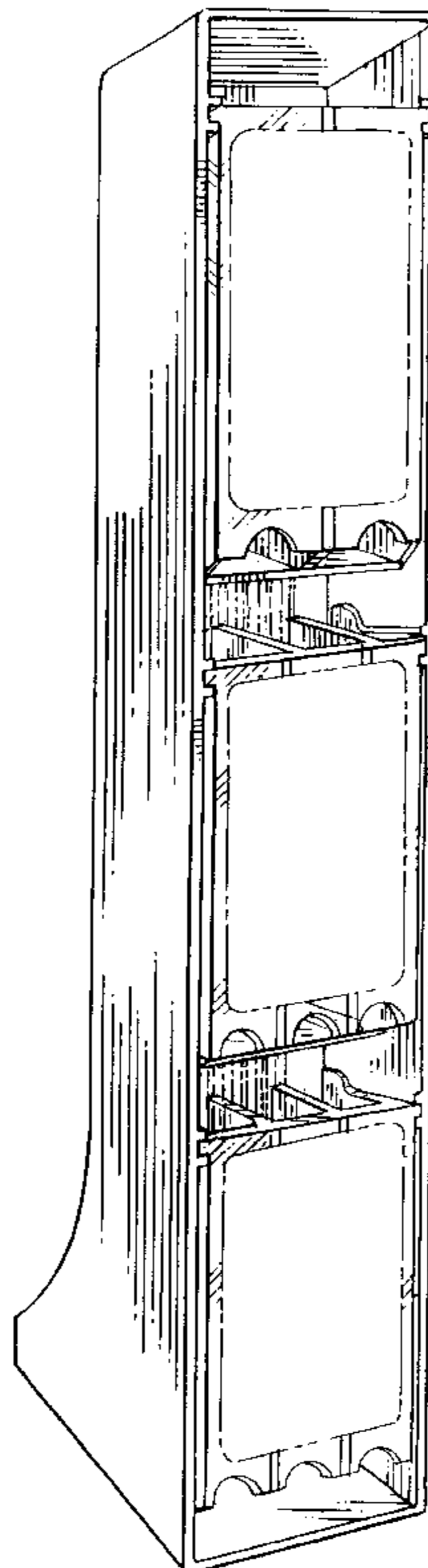

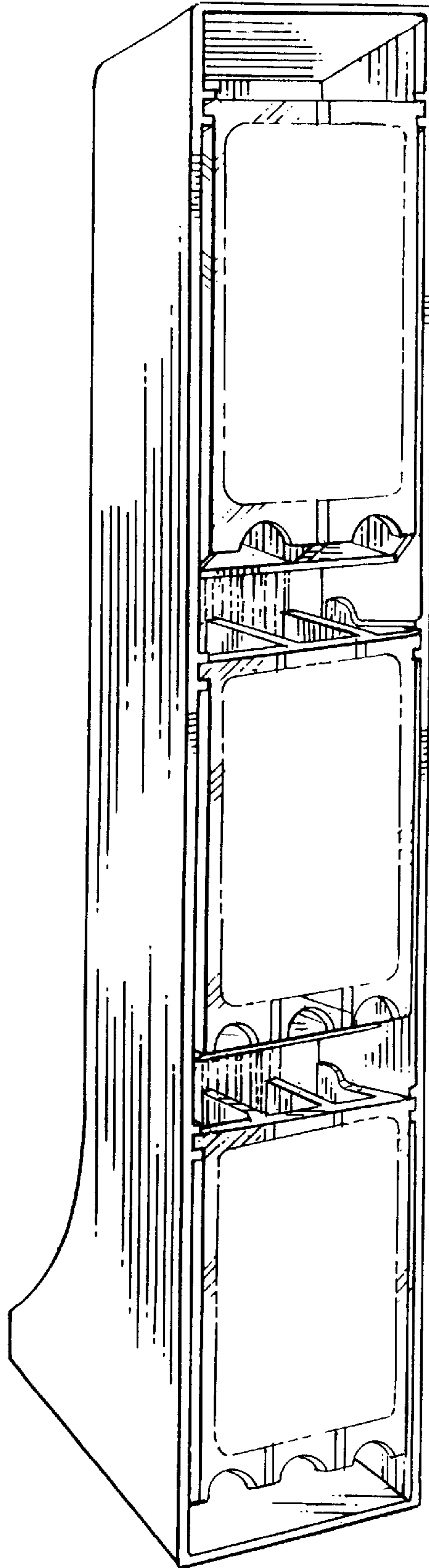

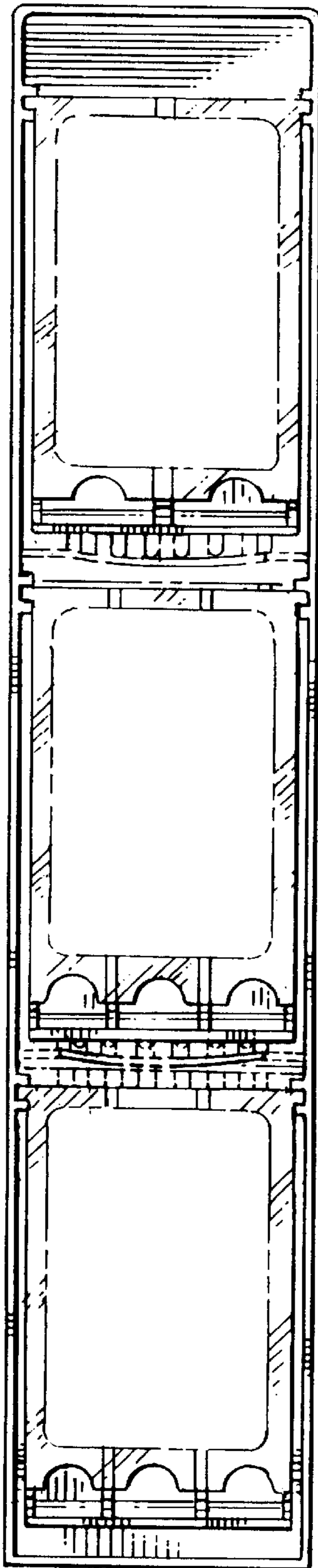

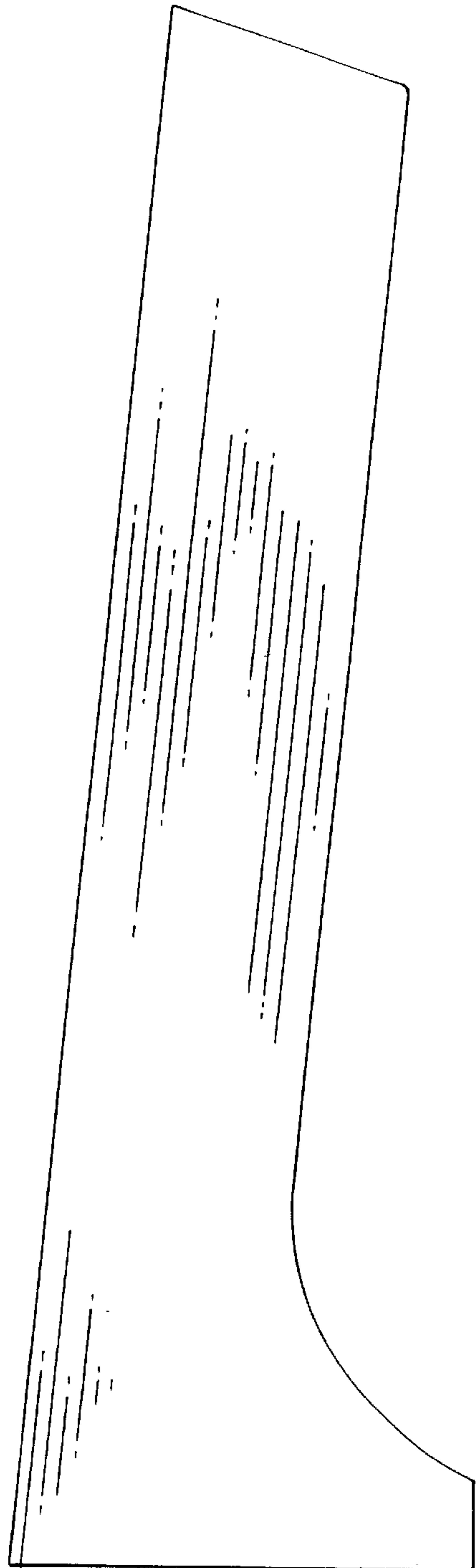

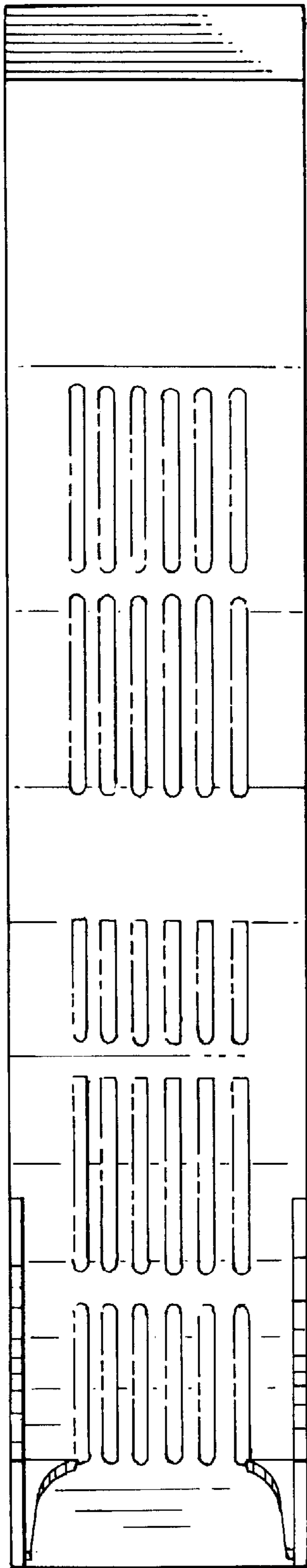

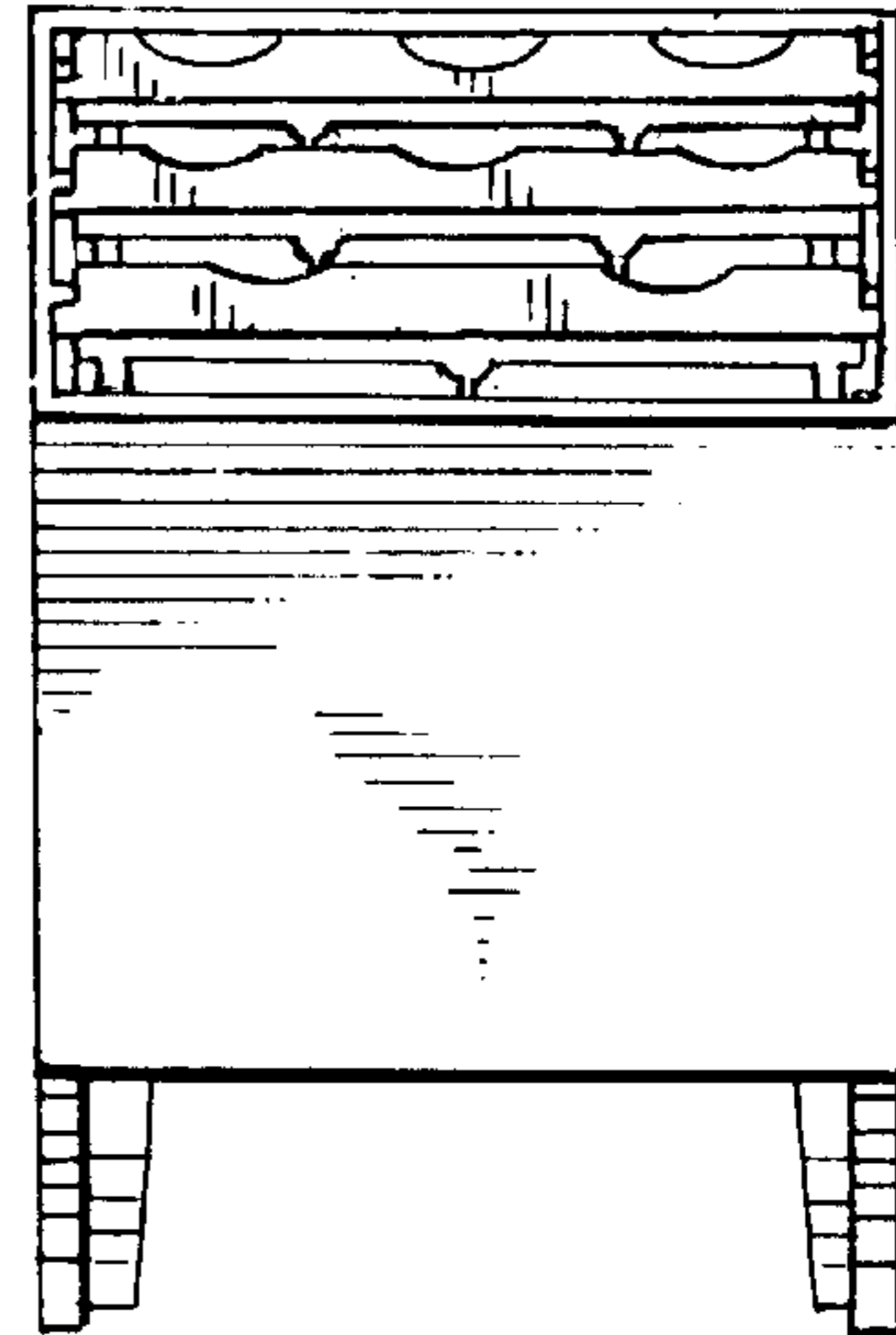
