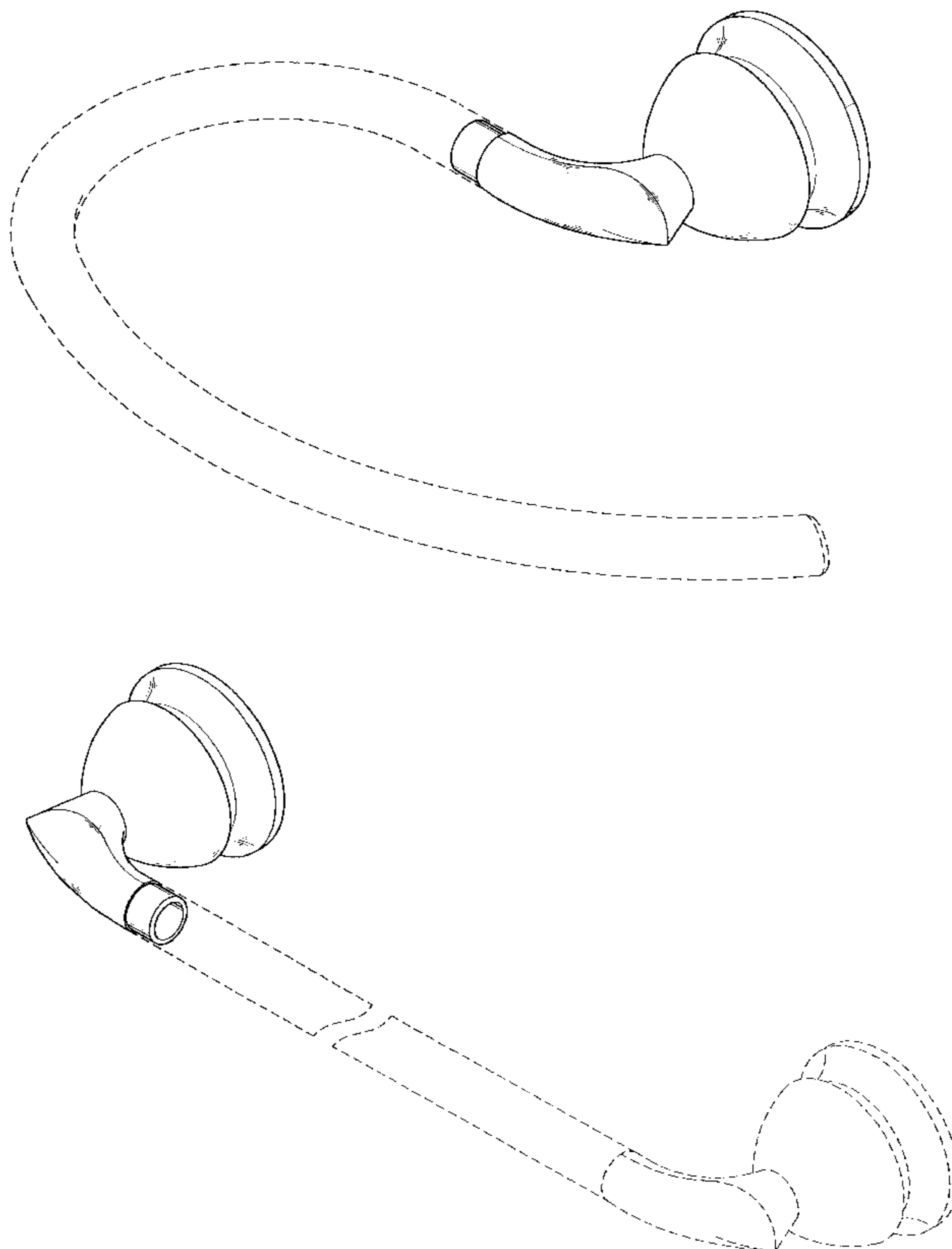
(57) **CLAIM**

The ornamental design for a towel bar post, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a towel bar post showing my new new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof; the right side elevational view being identical to that shown;
 FIG. 5 is a top plan view thereof;

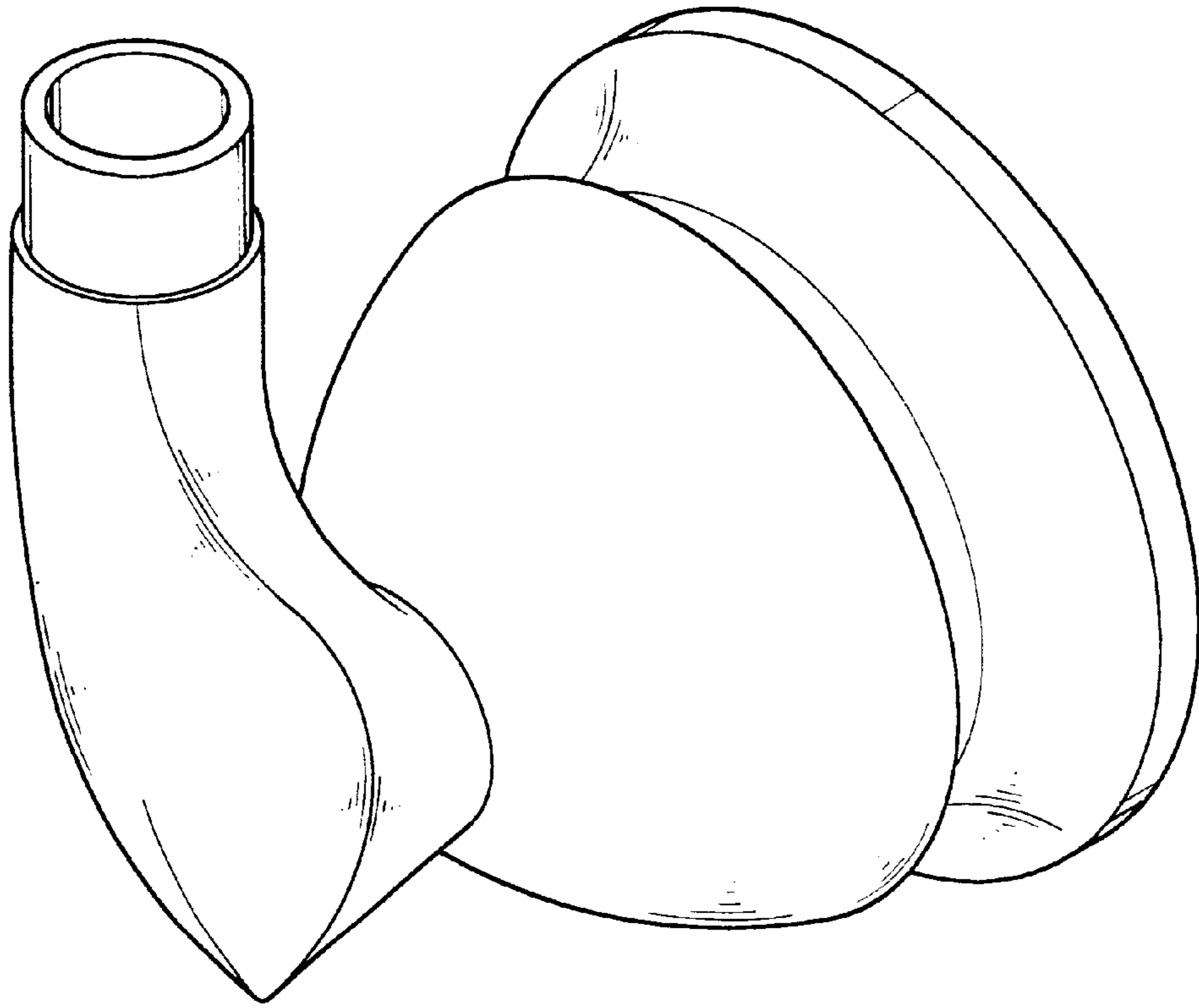

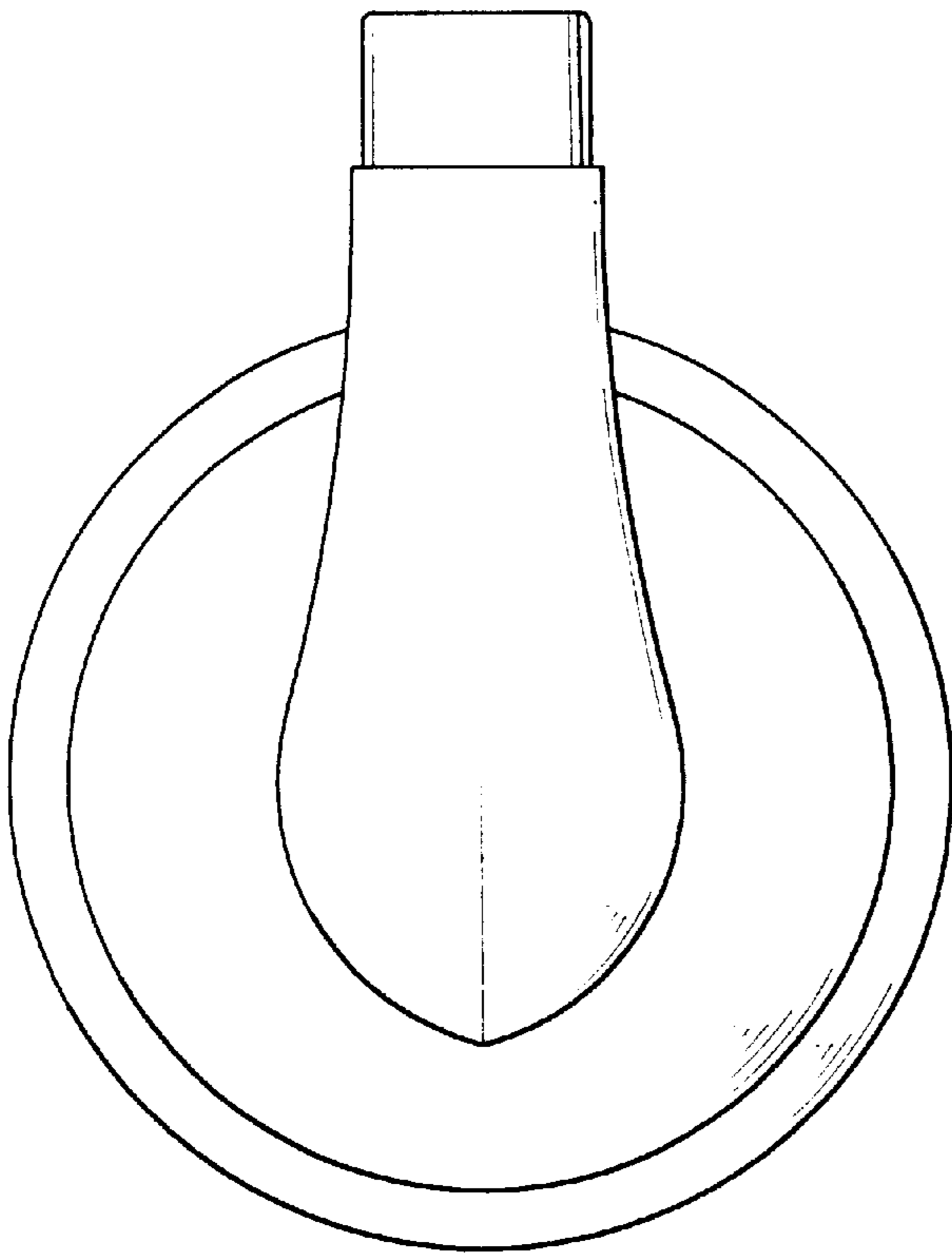

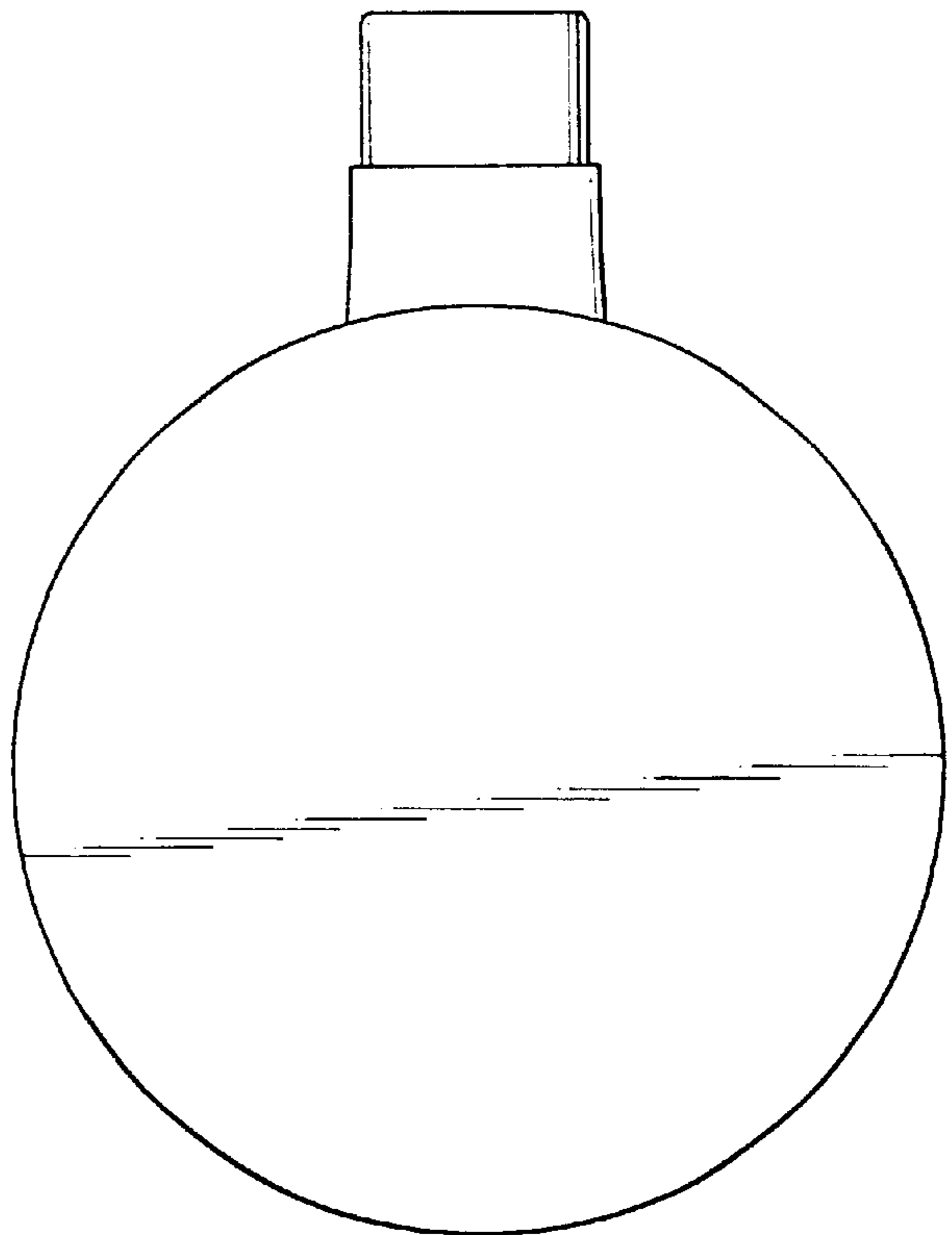

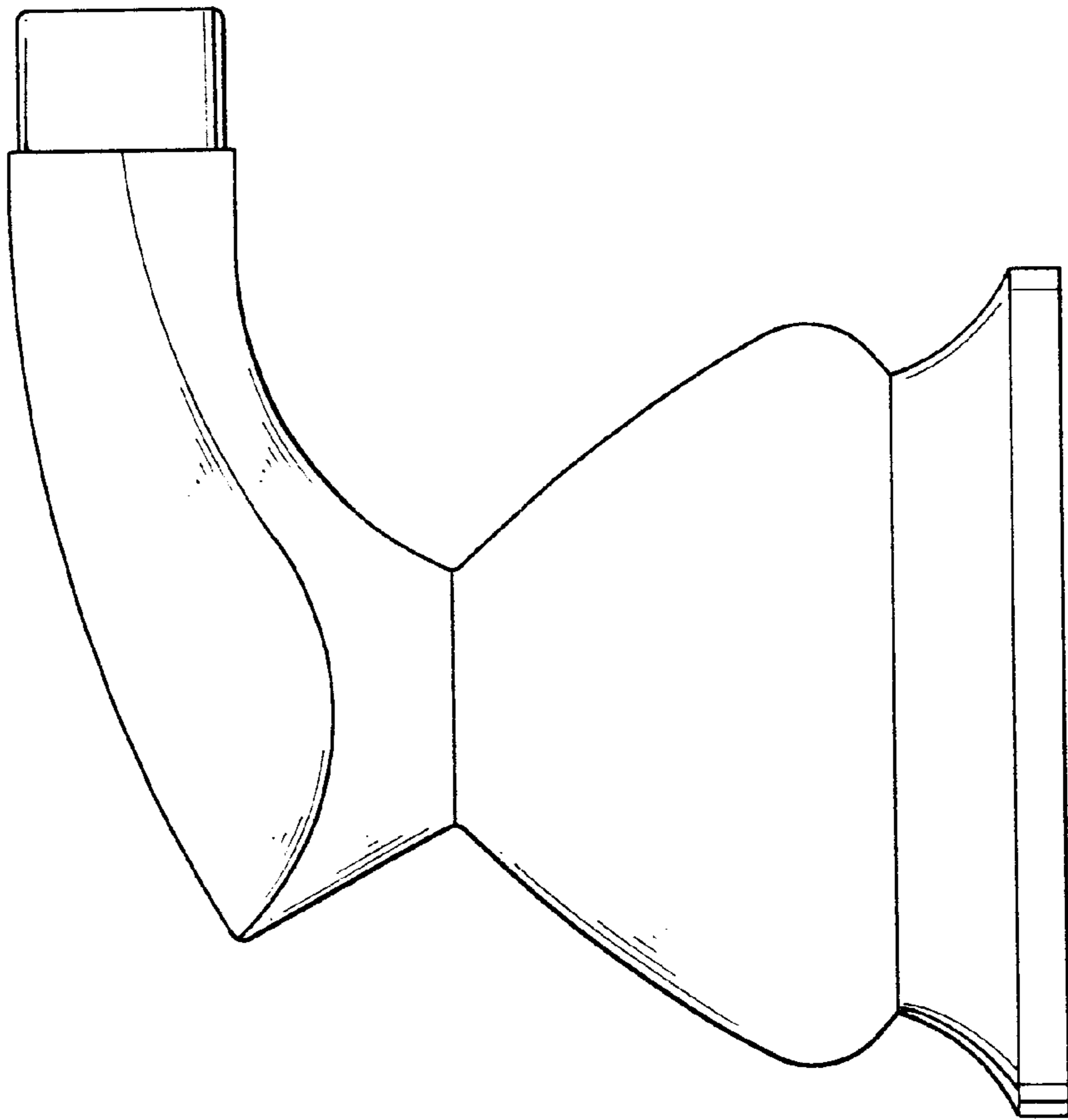

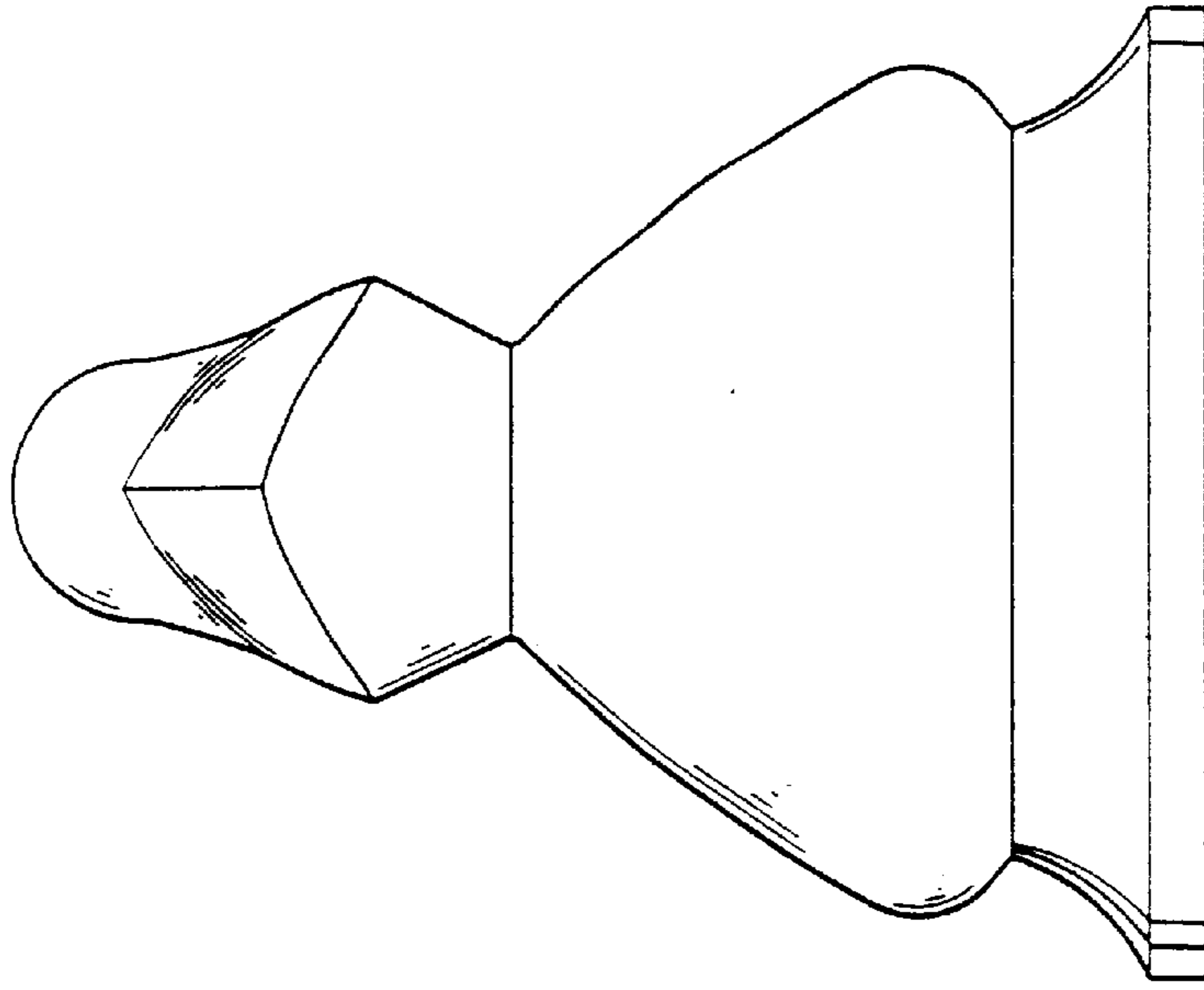

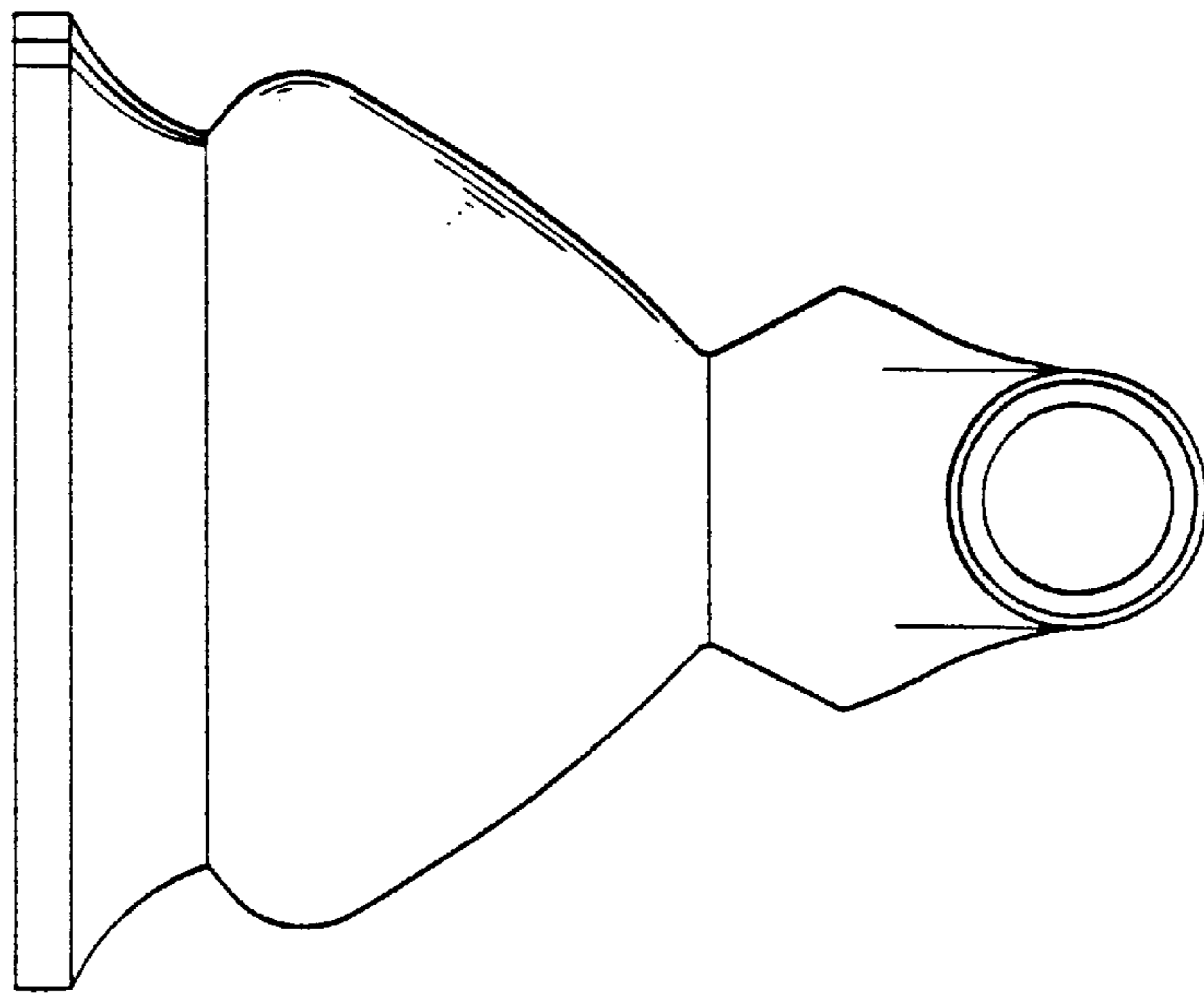

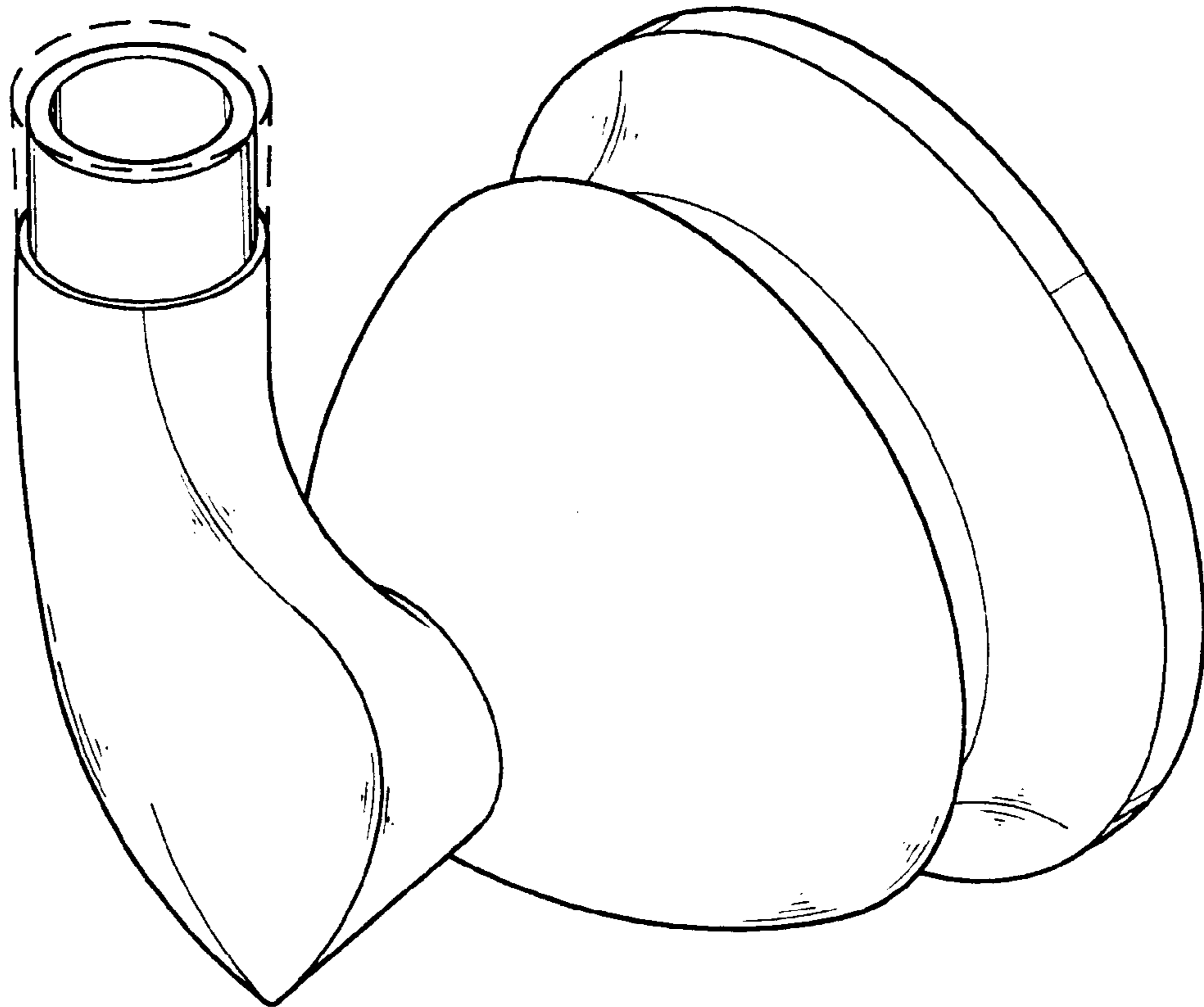

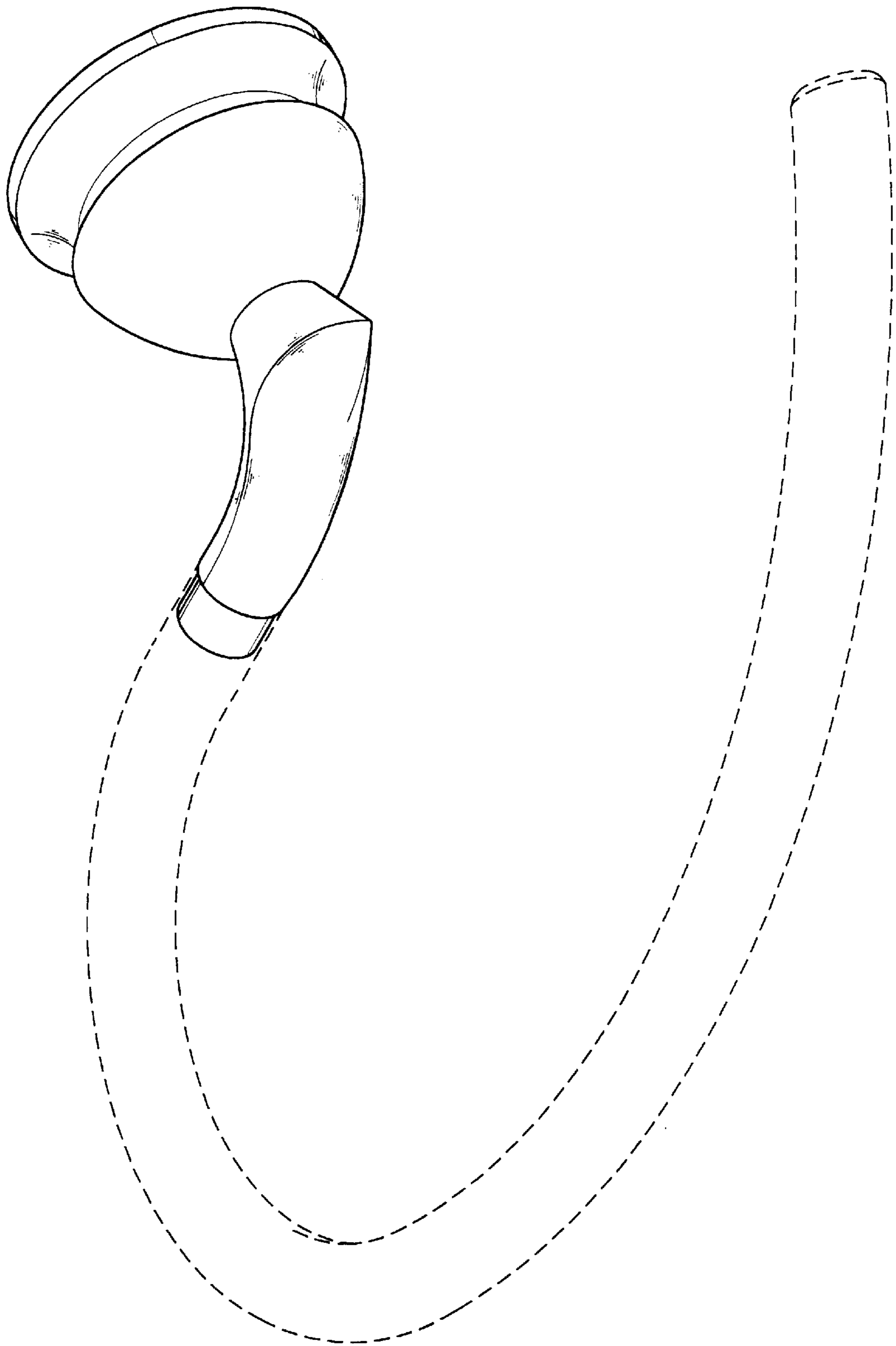

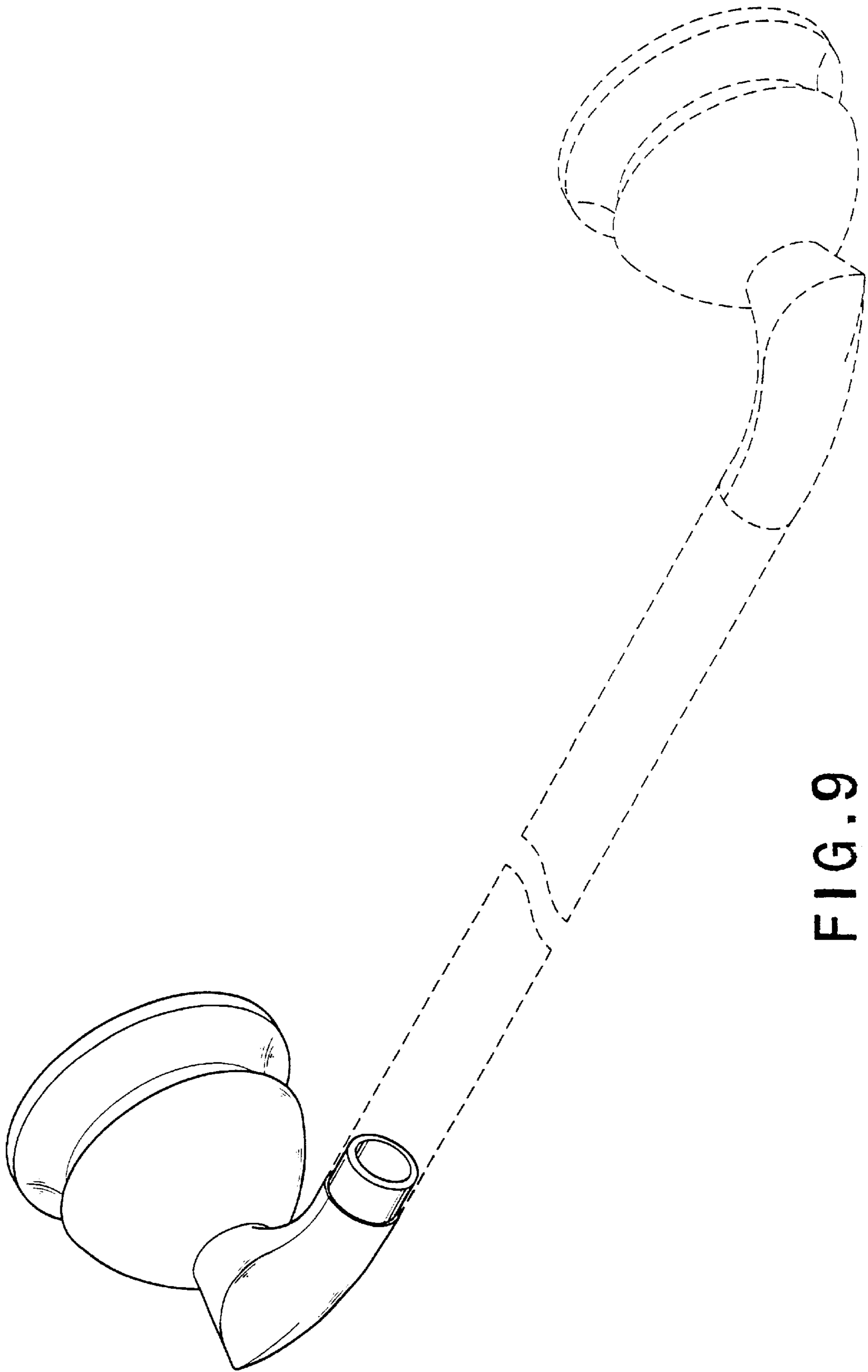
