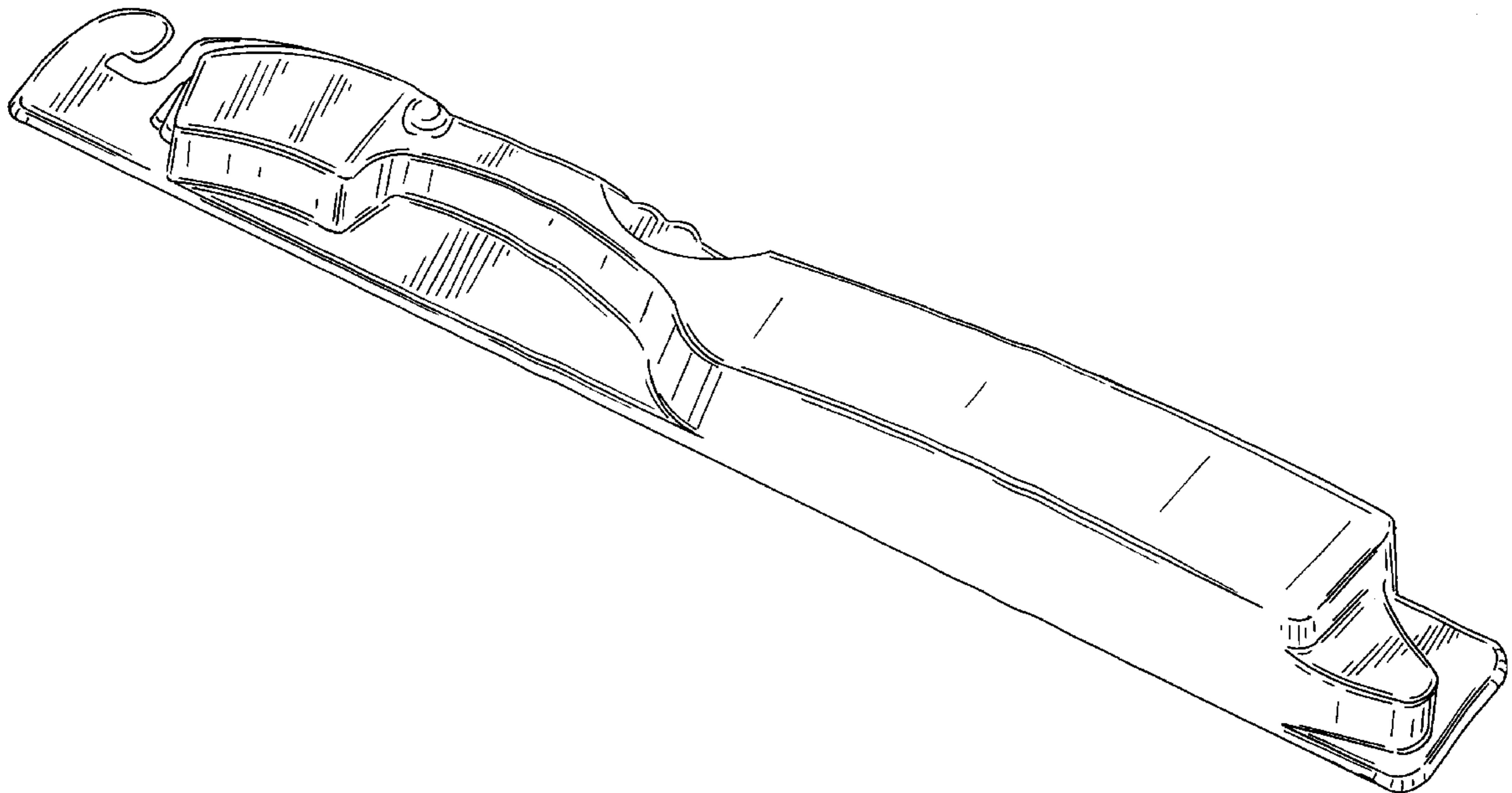
(57) **CLAIM**

The ornamental design for toothbrush packaging, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front and one side of the toothbrush packaging;  
 FIG. 2 is a front view of the toothbrush packaging;  
 FIG. 3 is a left-side view of the toothbrush packaging;  
 FIG. 4 is a right-side view toothbrush packaging;  
 FIG. 5 is a back plan view of the toothbrush packaging;  
 FIG. 6 is a top view of the toothbrush packaging; and,  
 FIG. 7 is a bottom view of the toothbrush packaging.

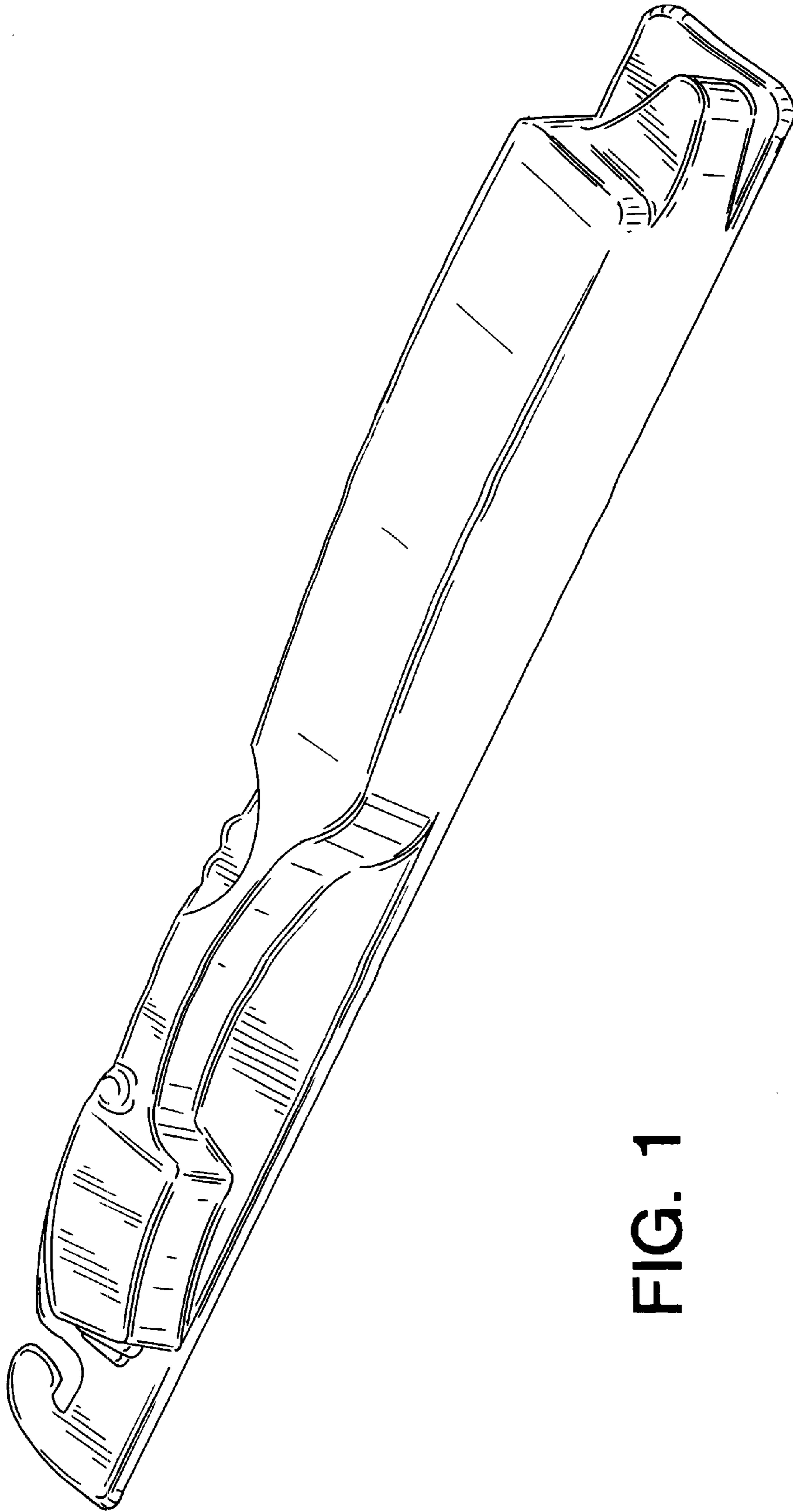

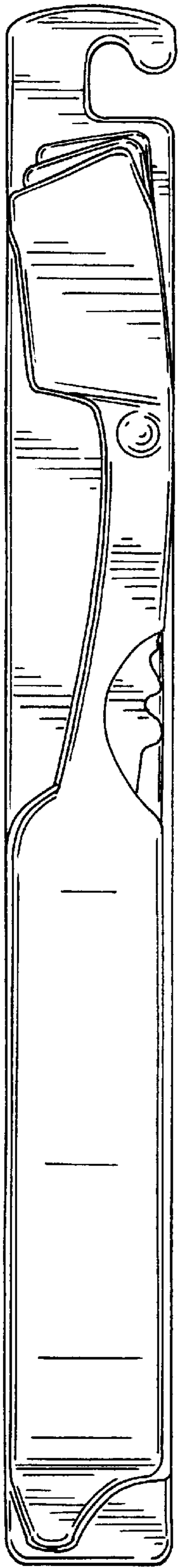

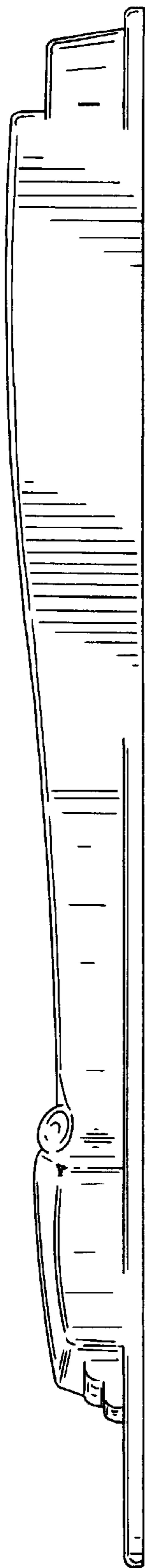

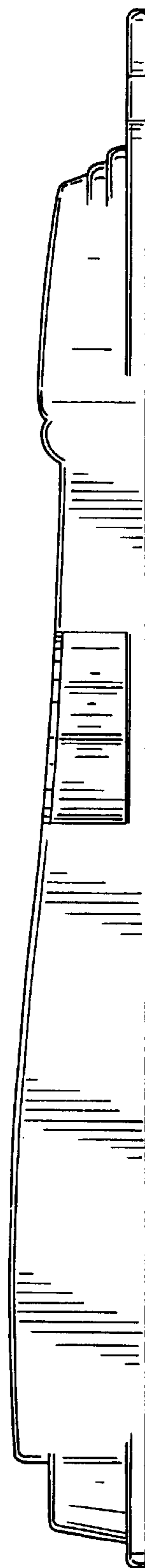

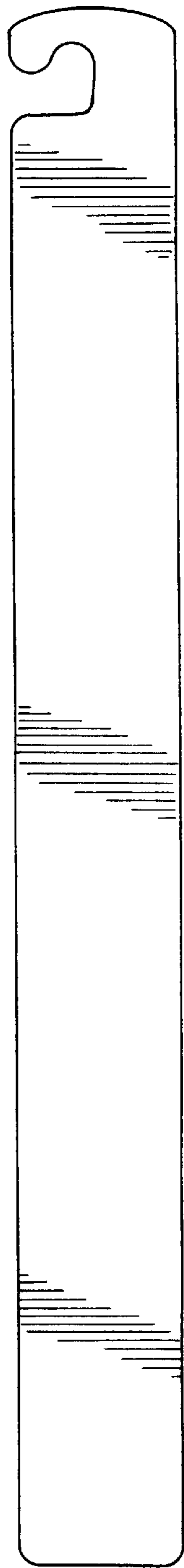

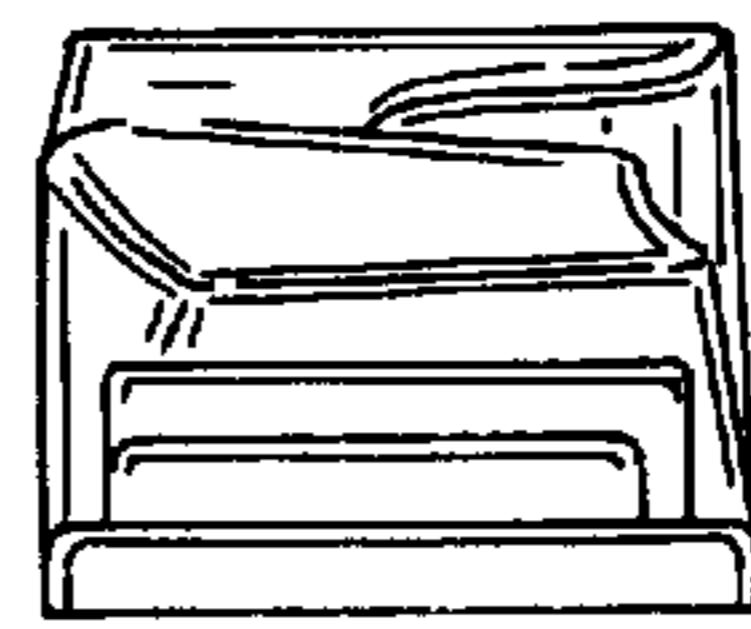

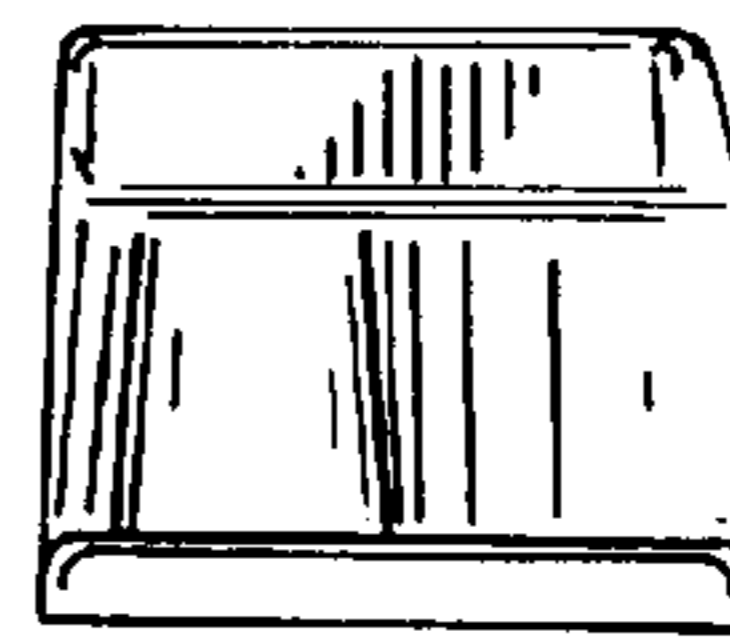
