FIG. 3 is a top view of the snack packaging of the present invention;

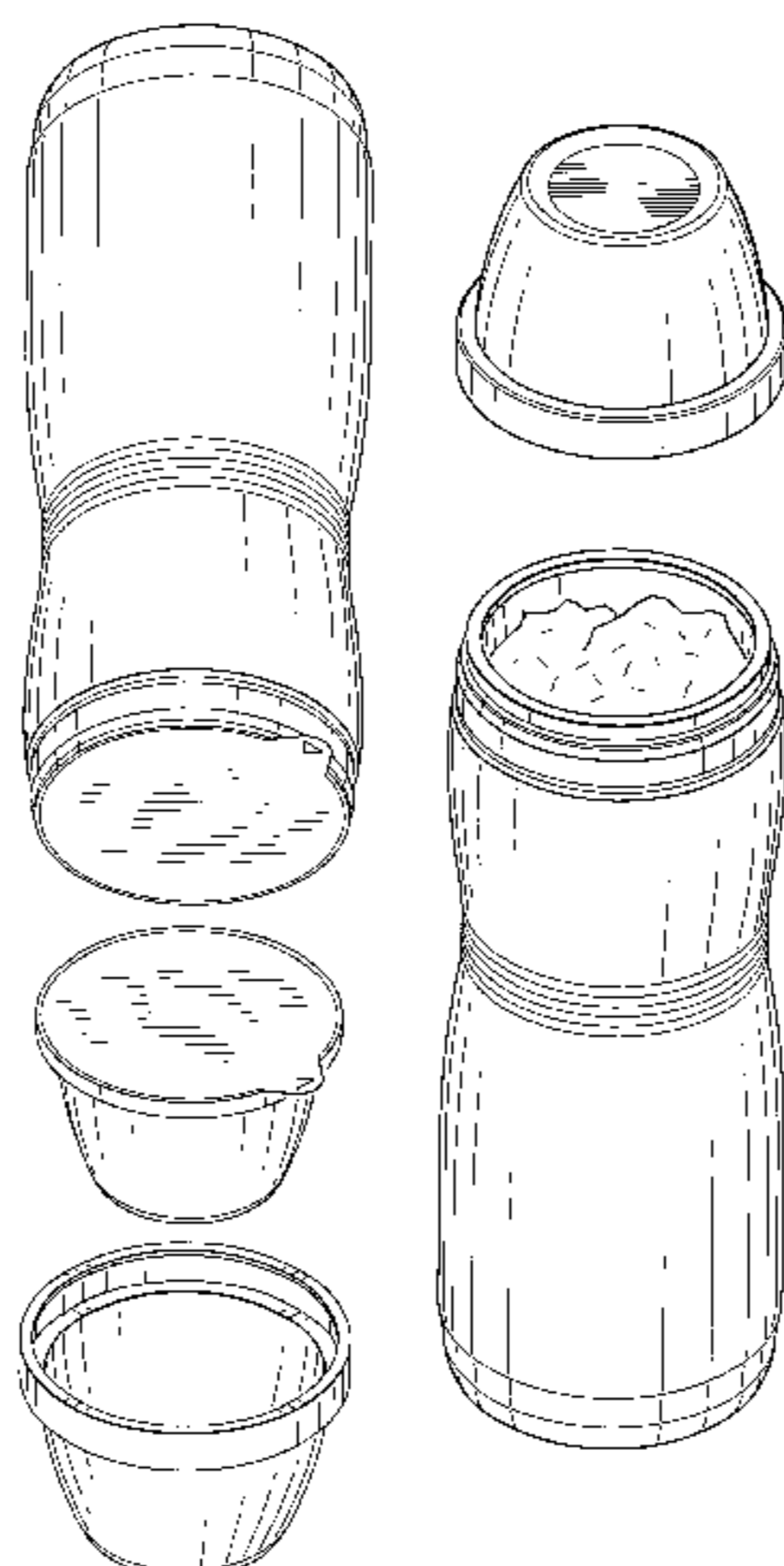
FIG. 4 is a bottom view of the snack packaging of the present invention;

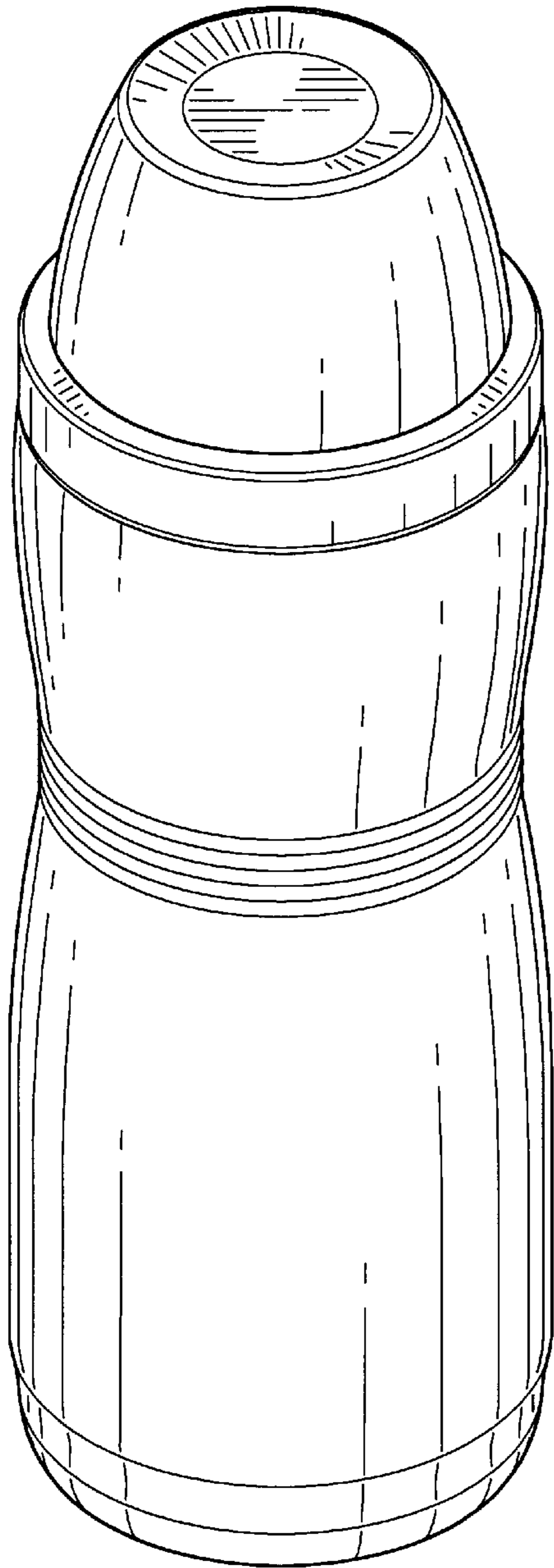

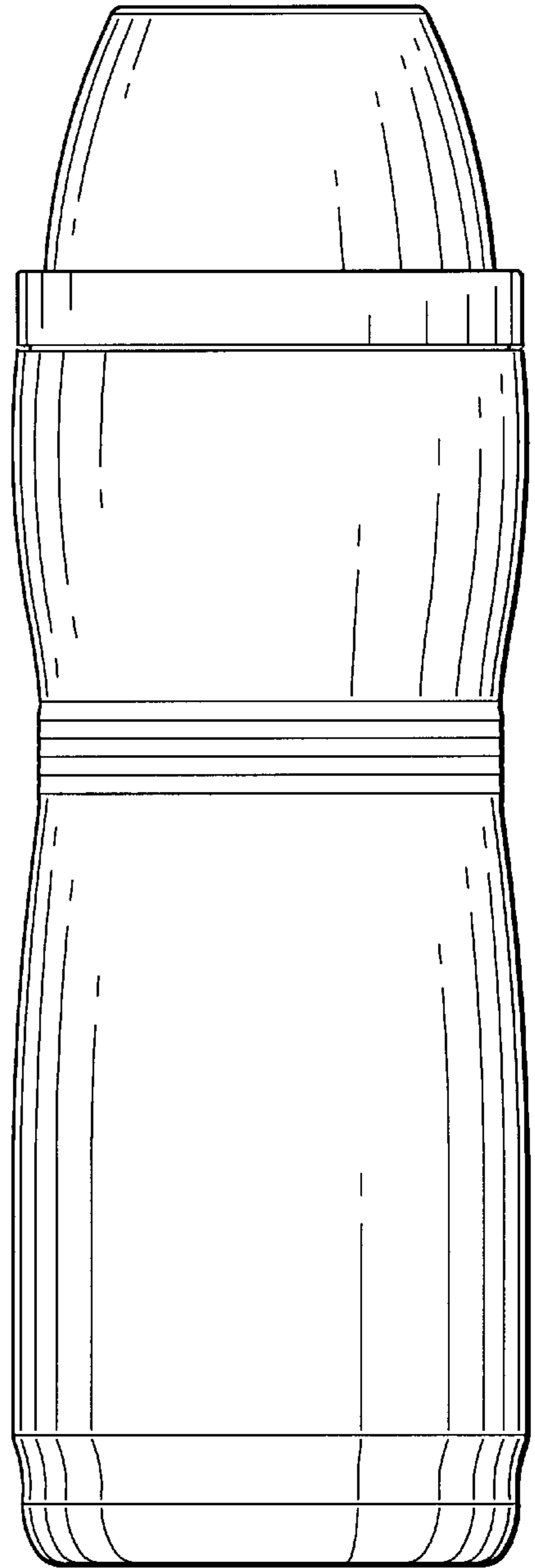

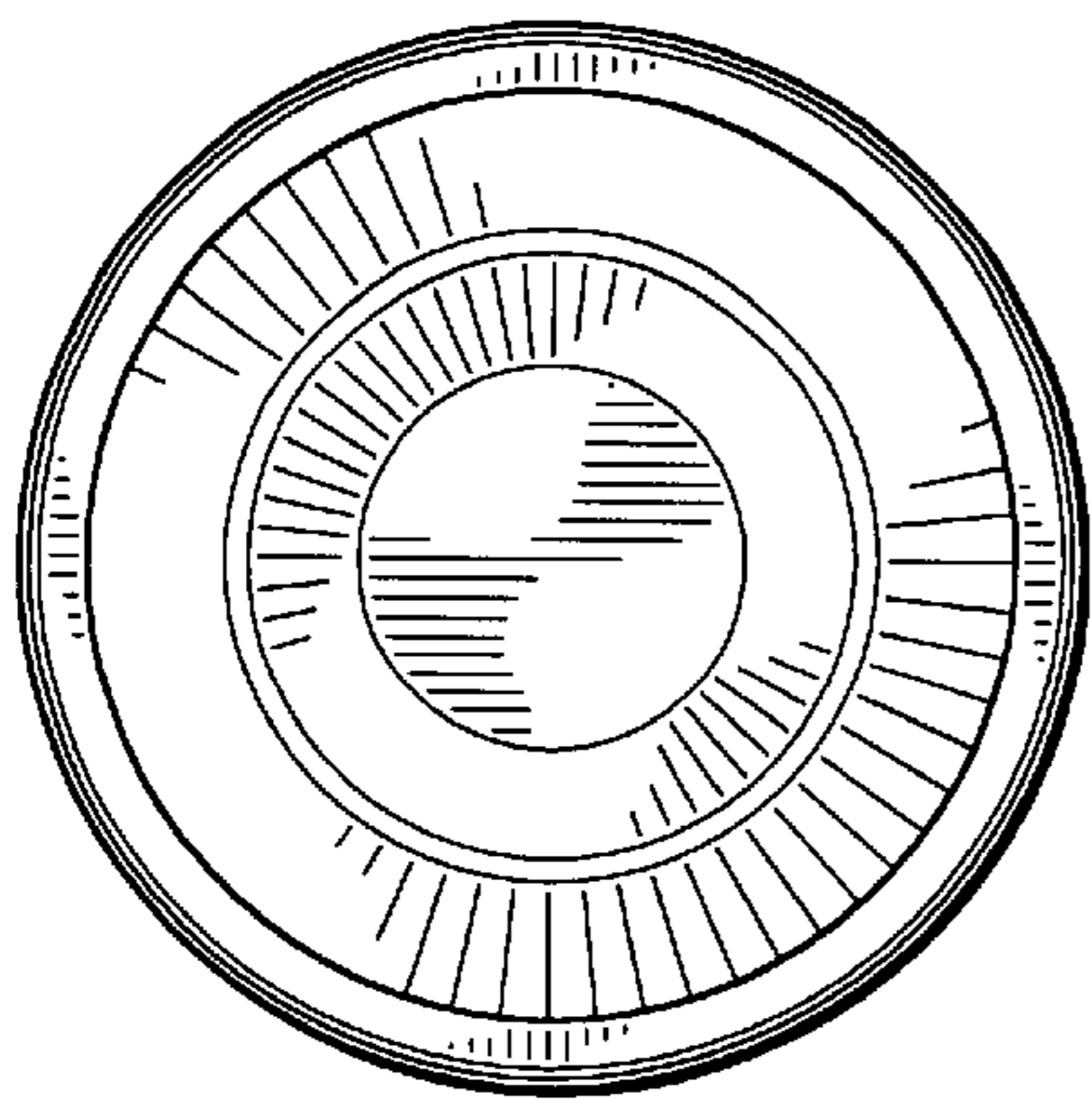

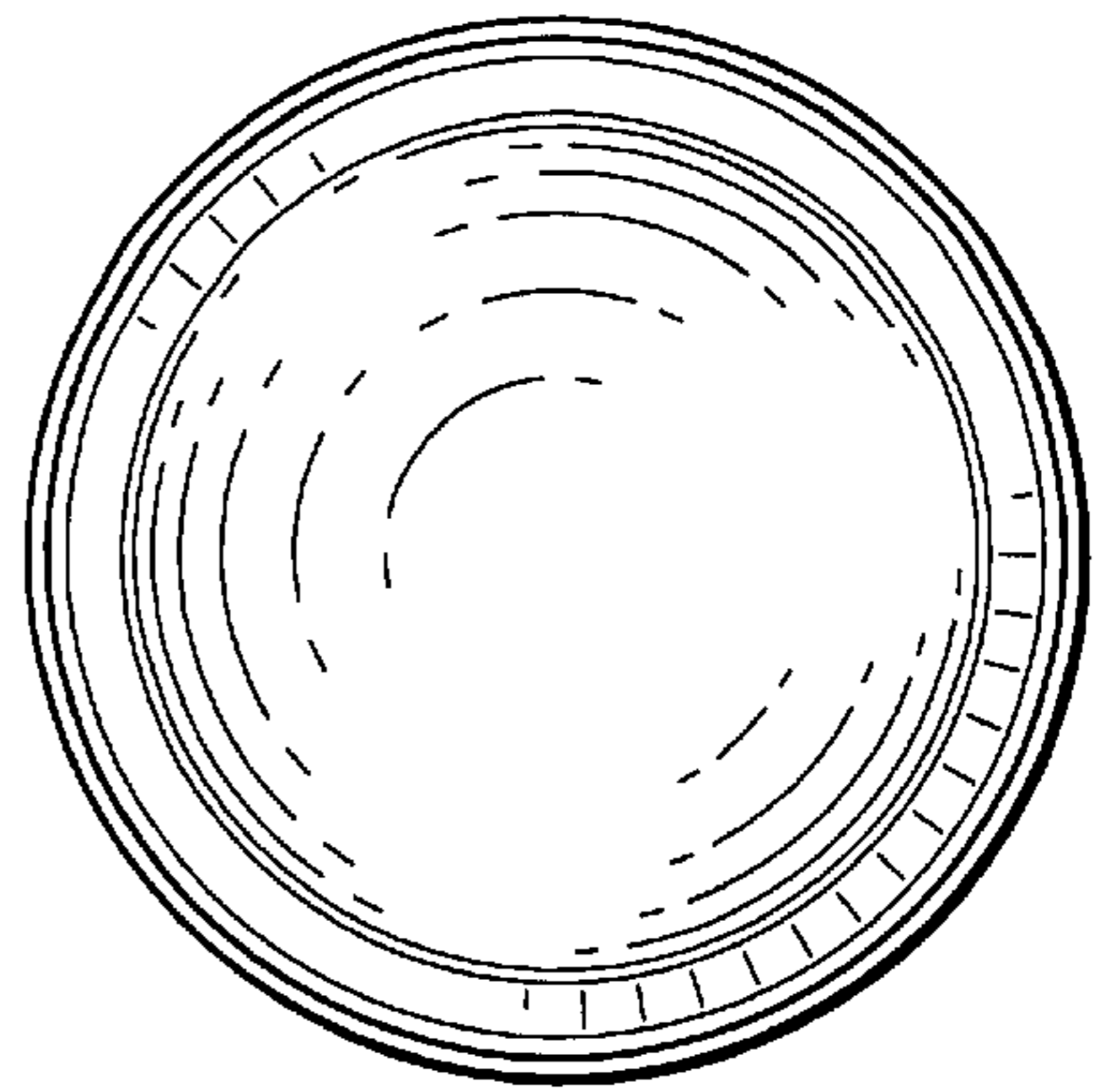

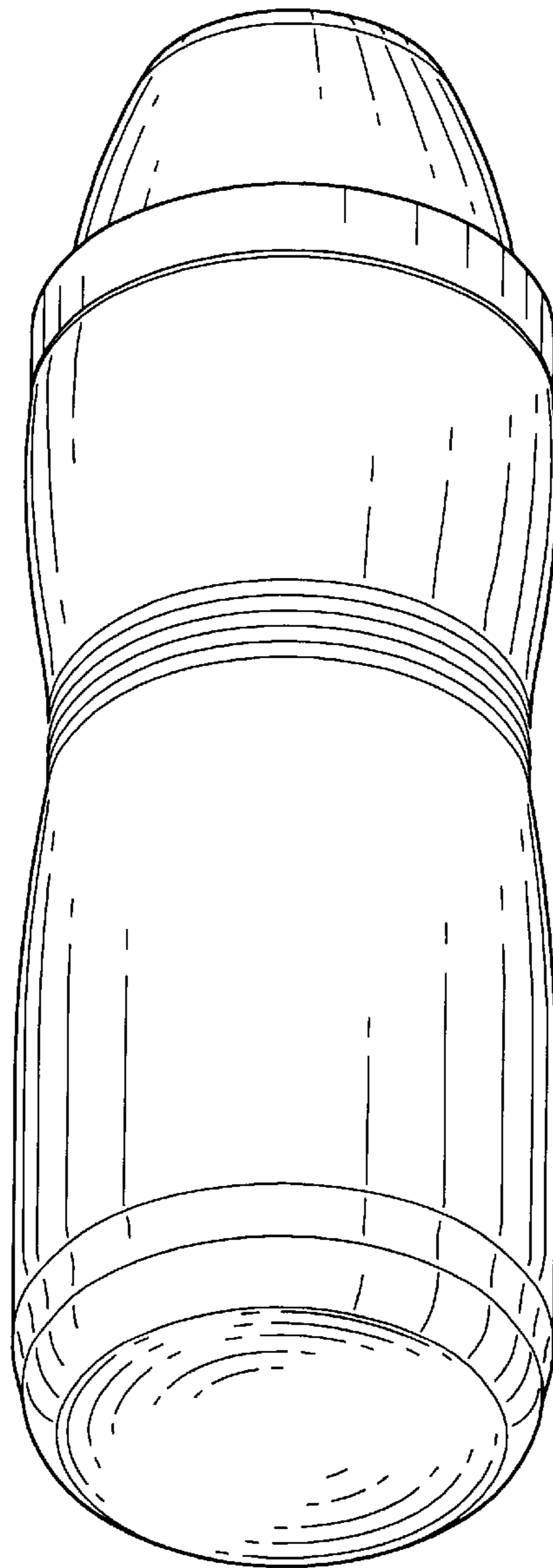

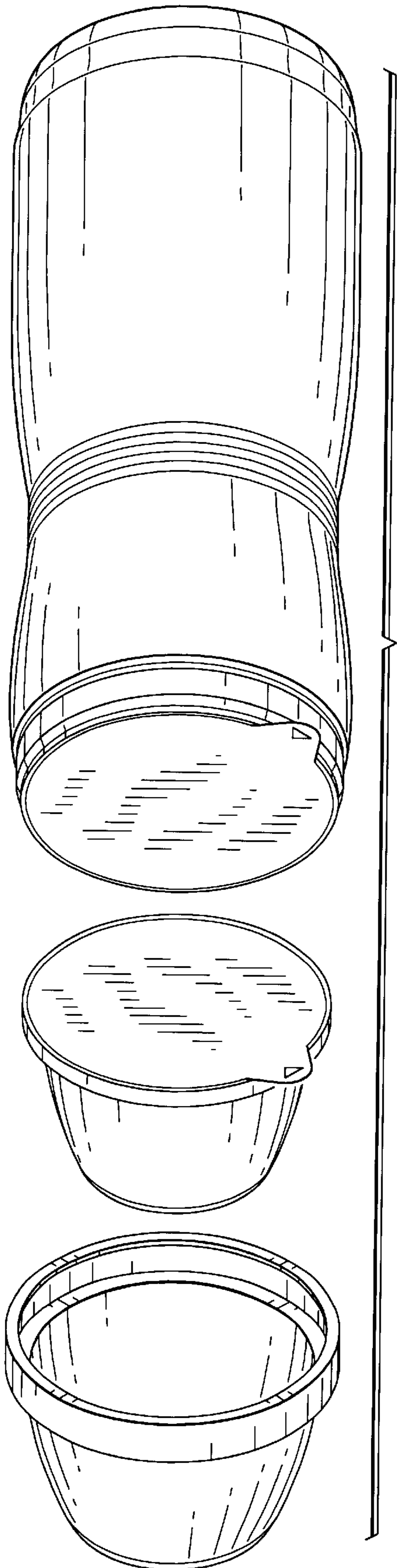
