**DESCRIPTION**

FIG. 15 is a rear elevational view thereof;

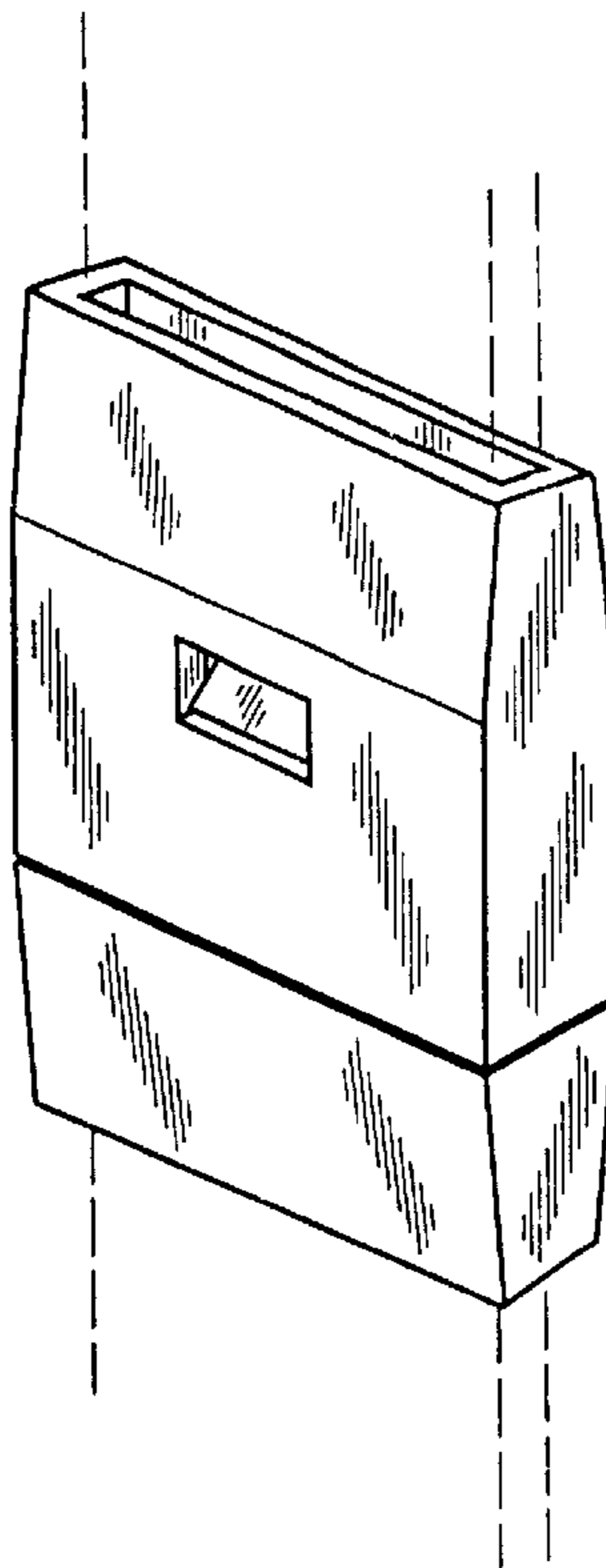
FIG. 16 is a front elevational view thereof;

FIG. 17 is a right side elevational view, the left side elevational view being a mirror image thereof; and,

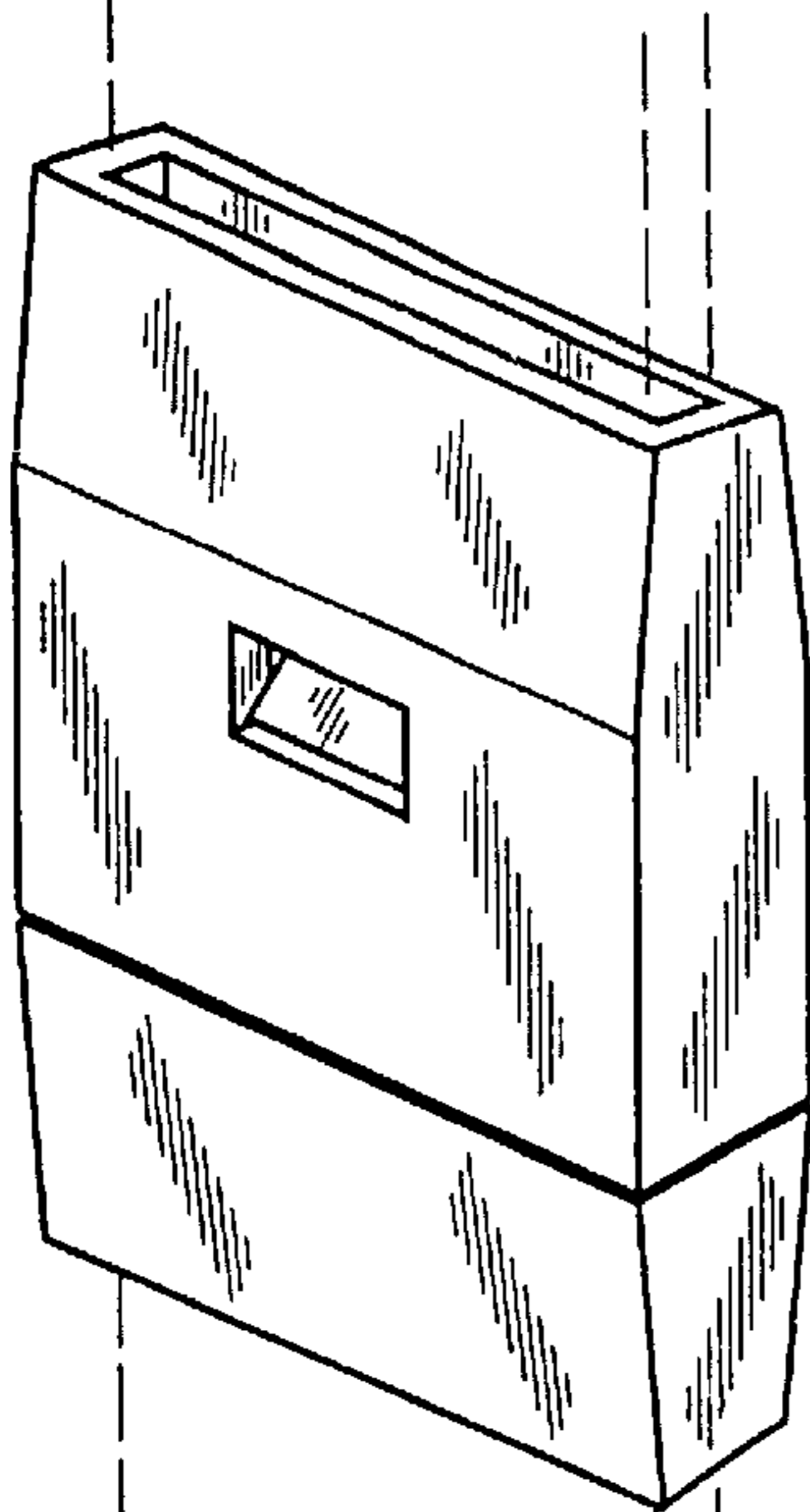
FIG. 18 is a bottom plan view thereof.

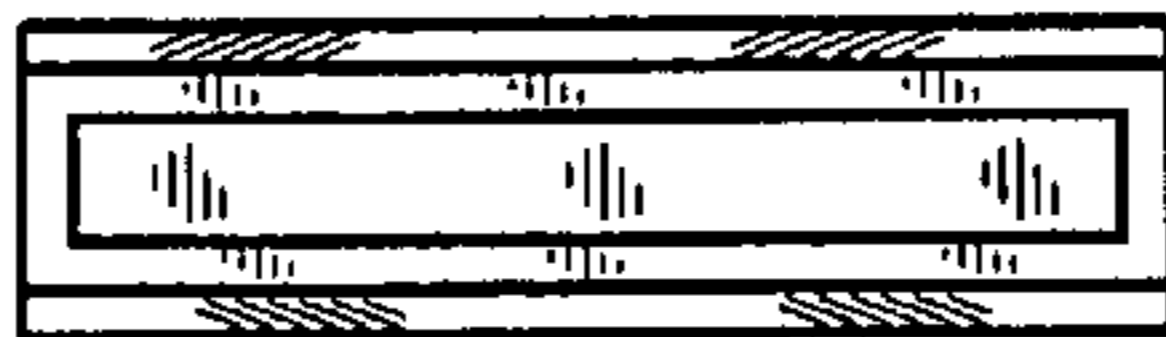

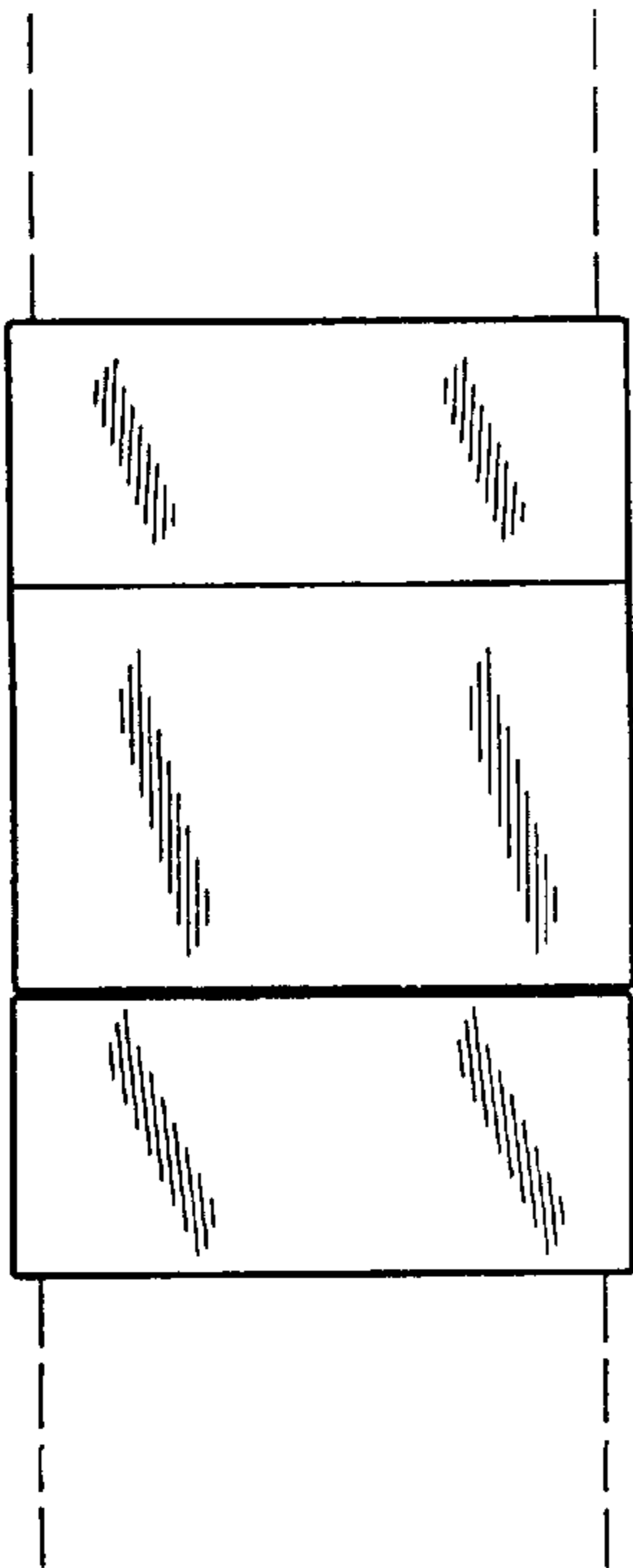

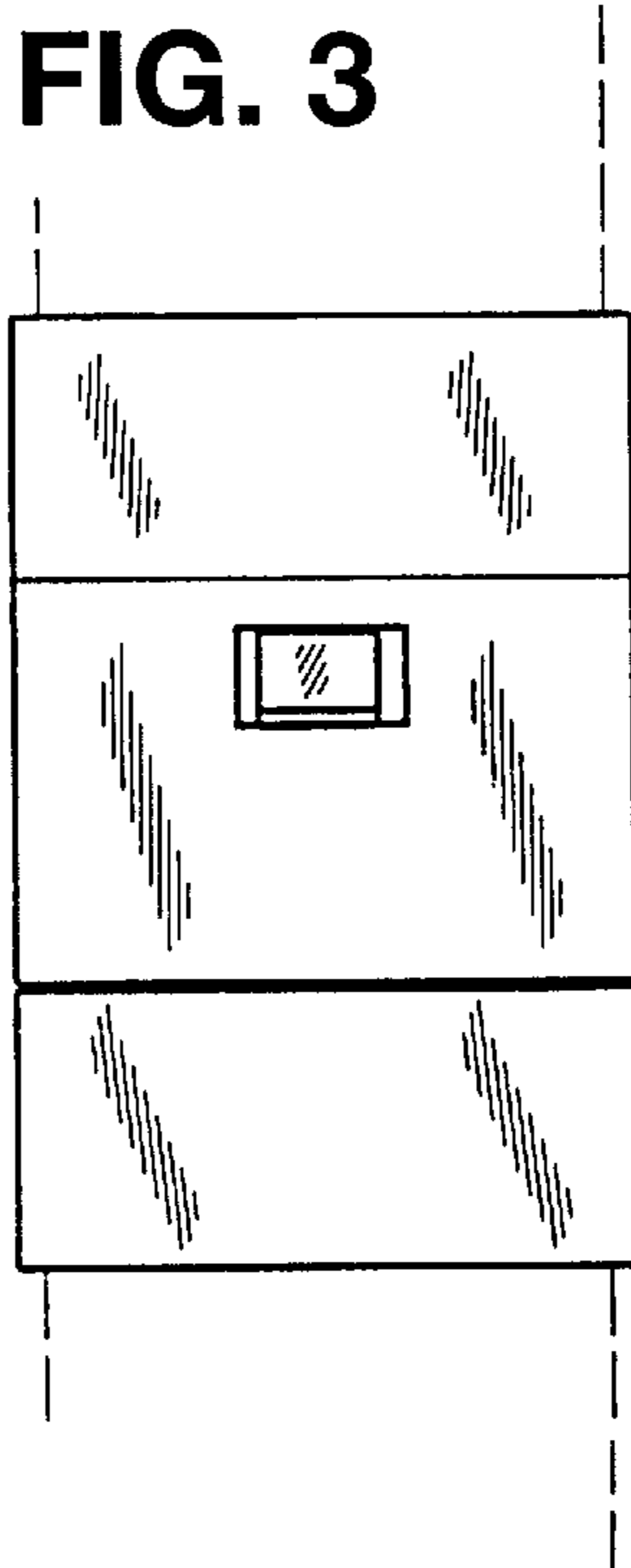

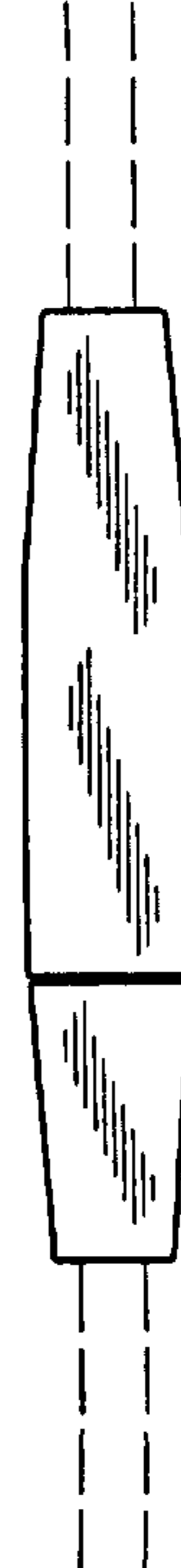

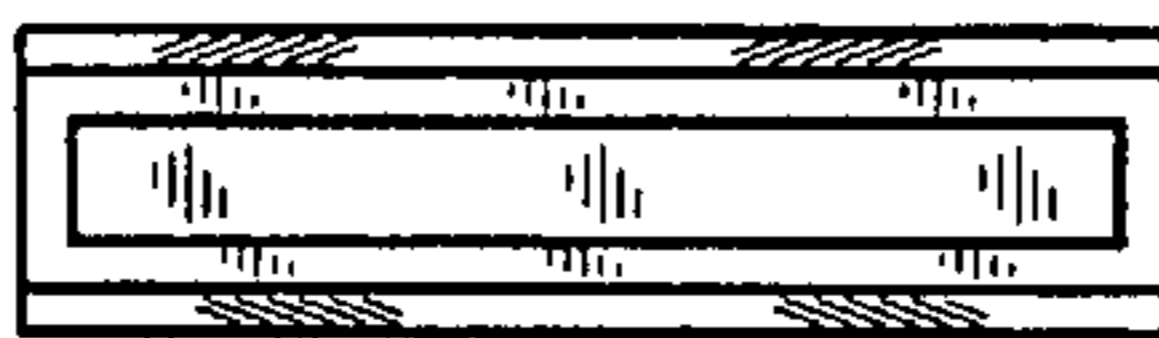

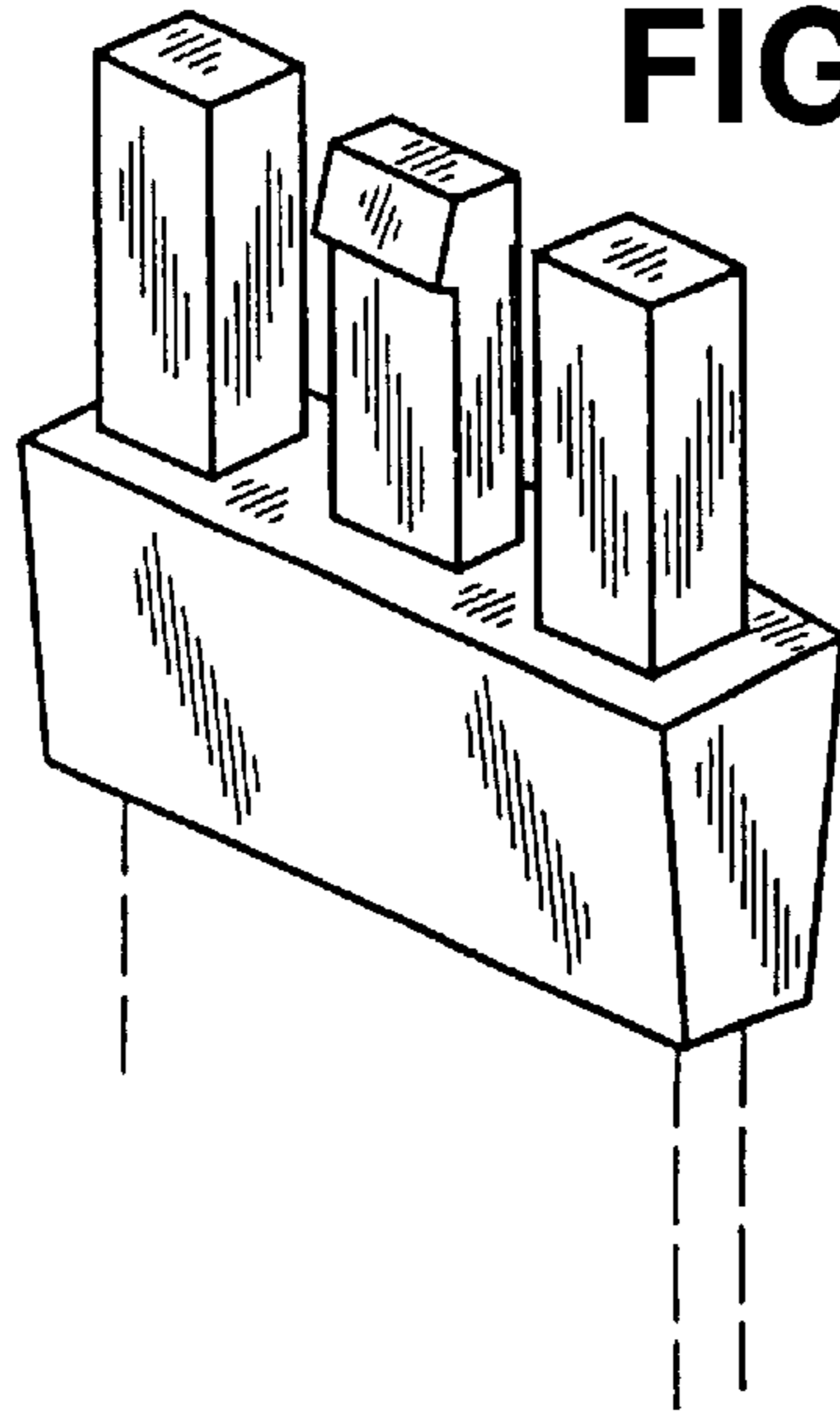

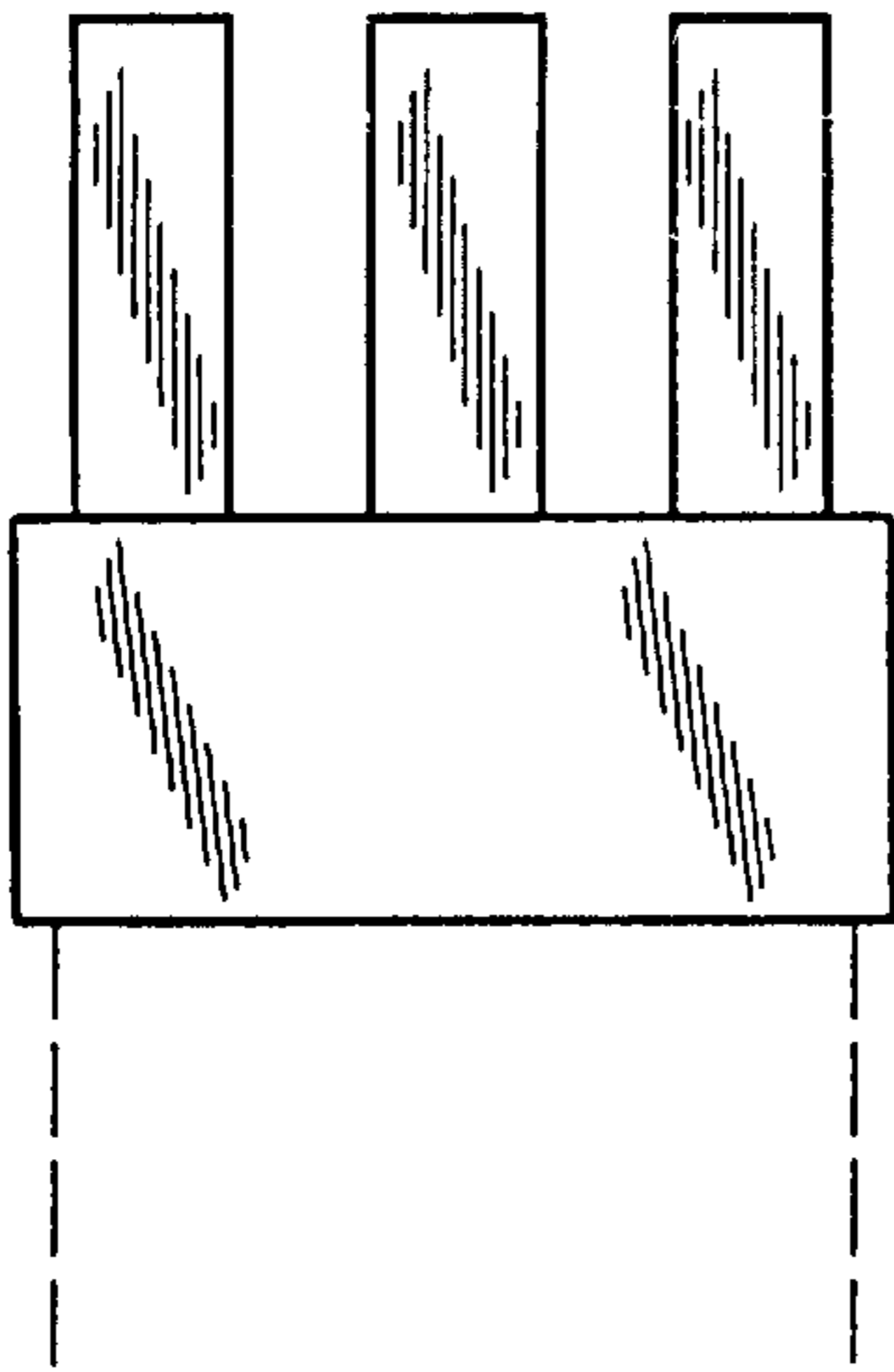

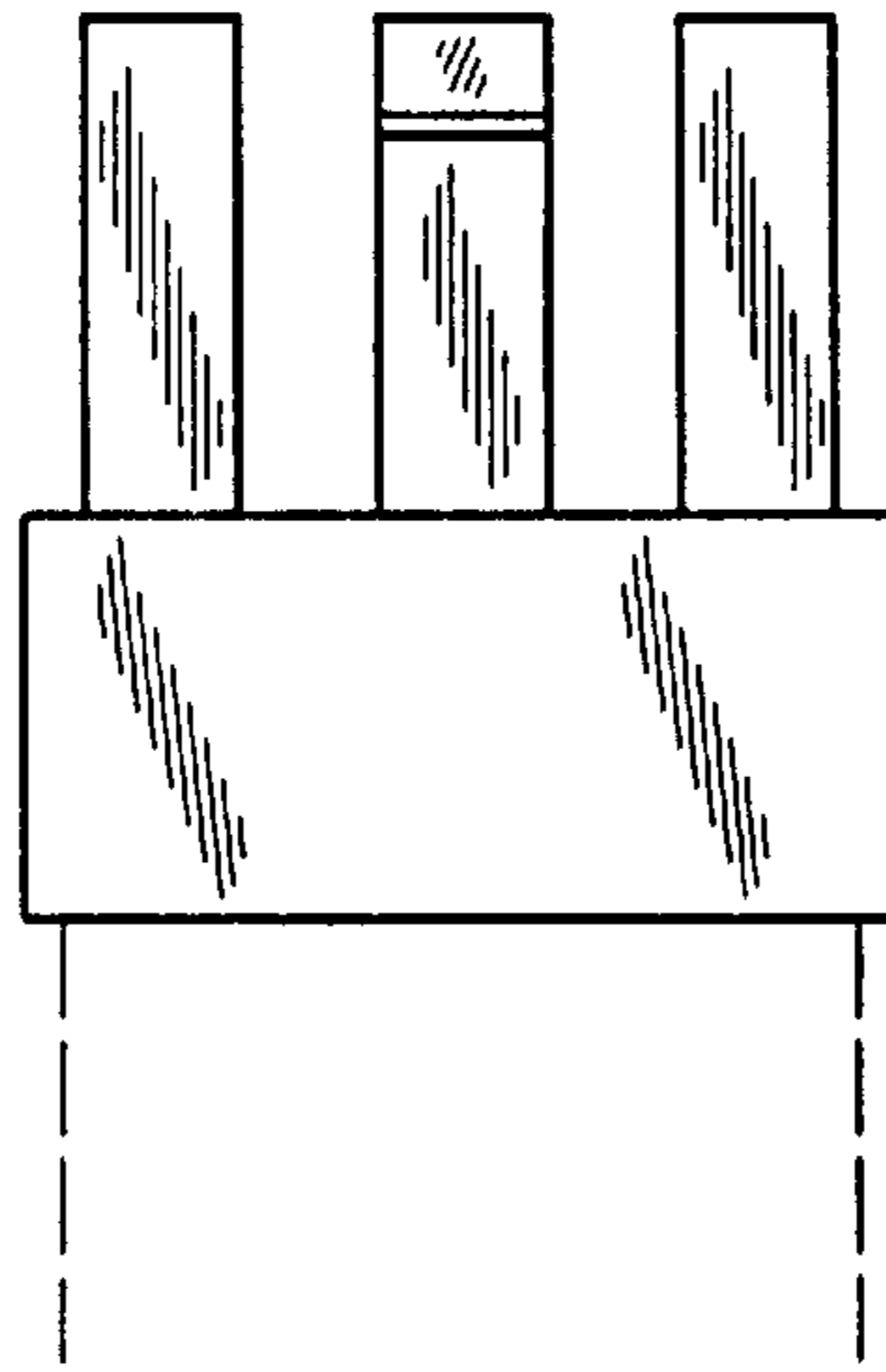

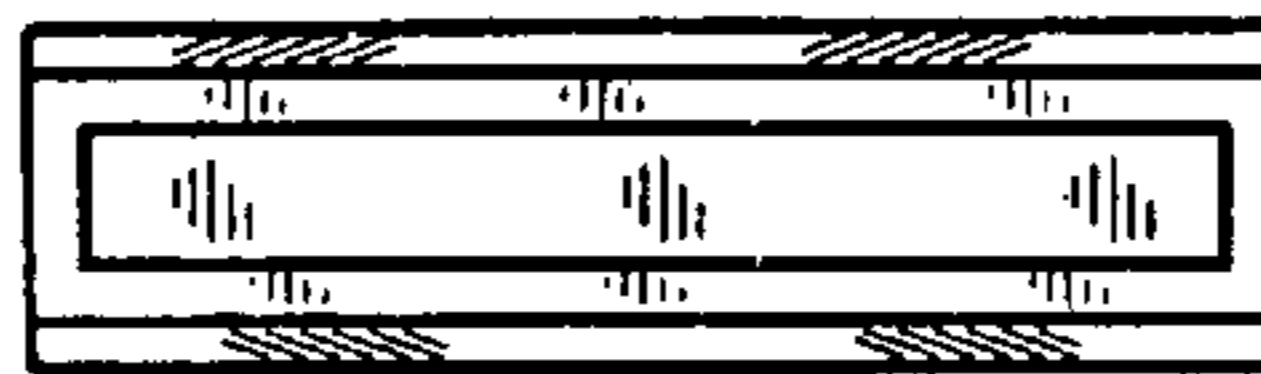

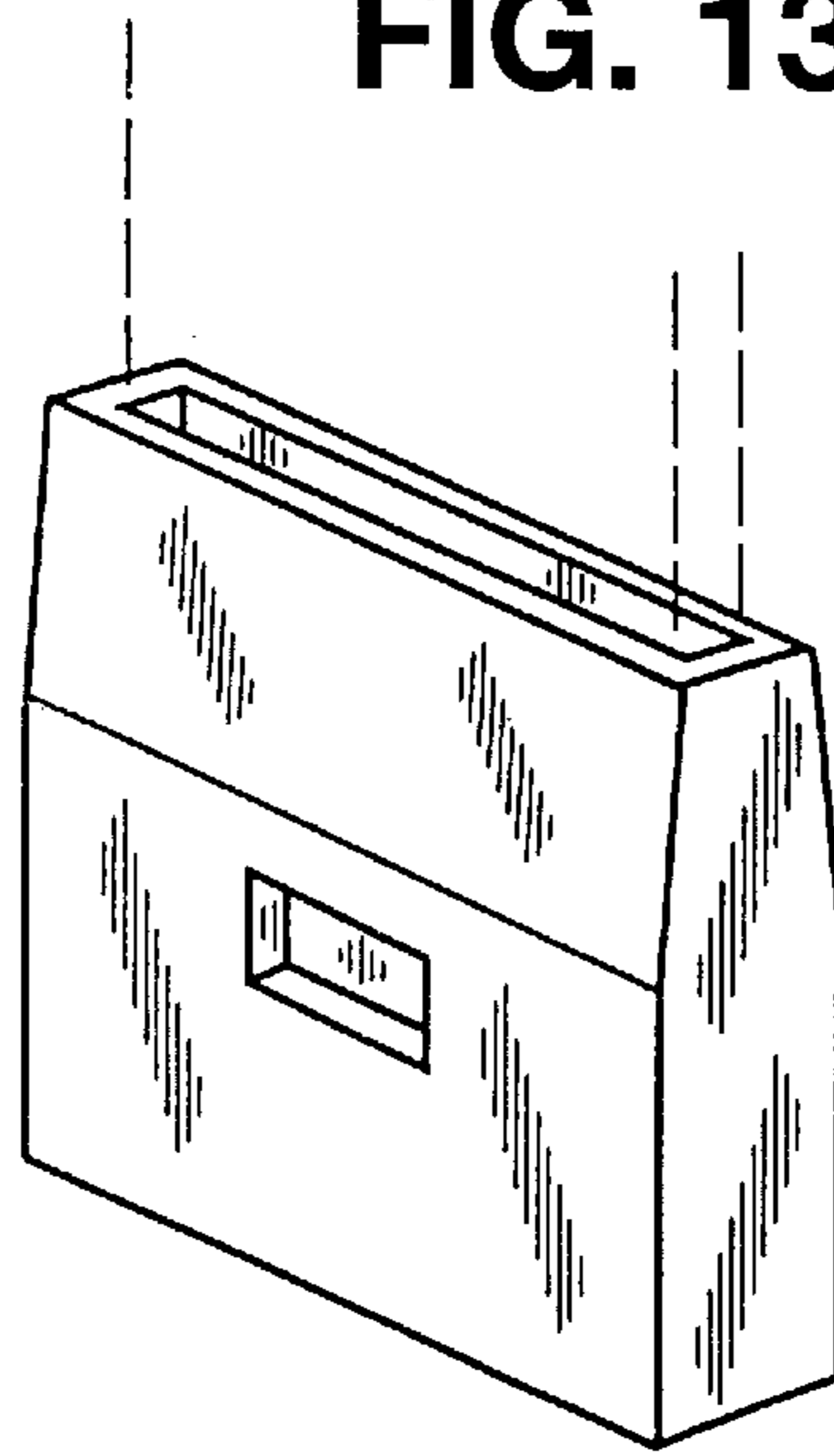

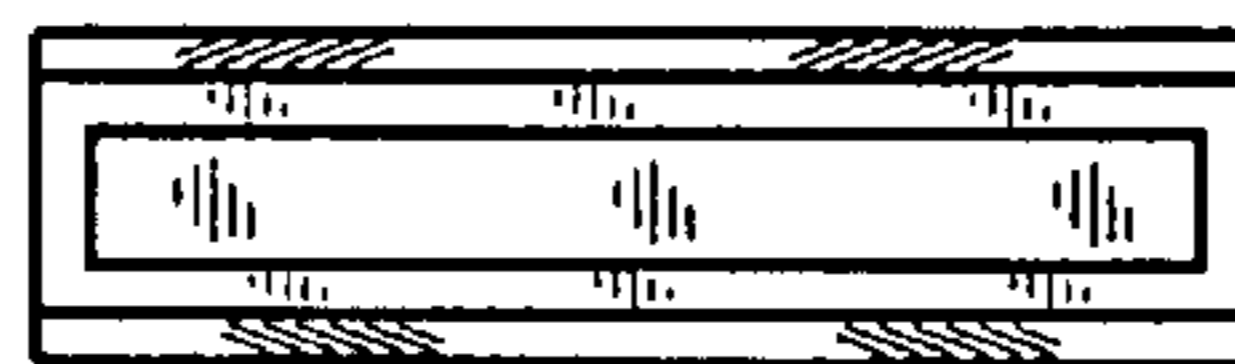

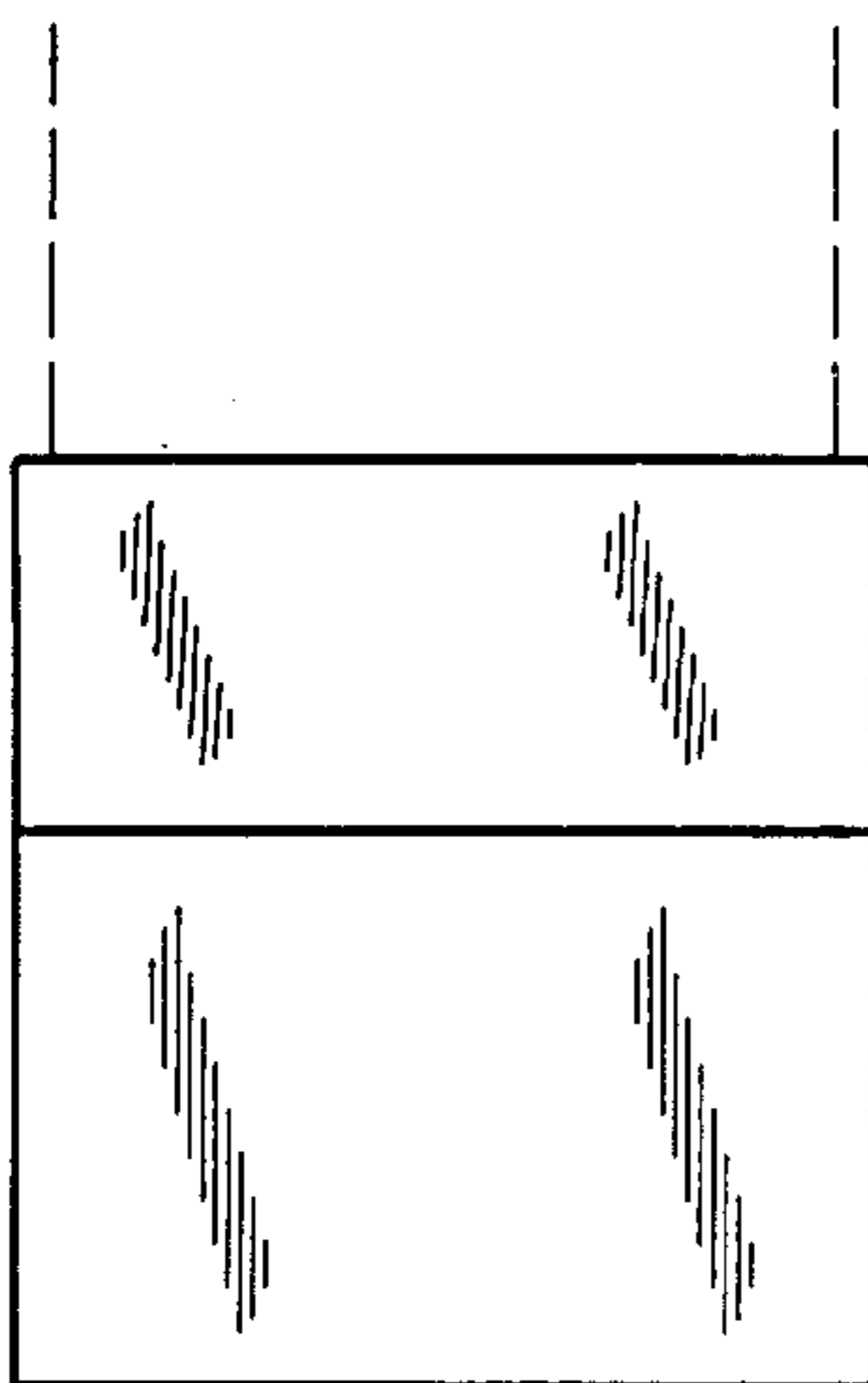

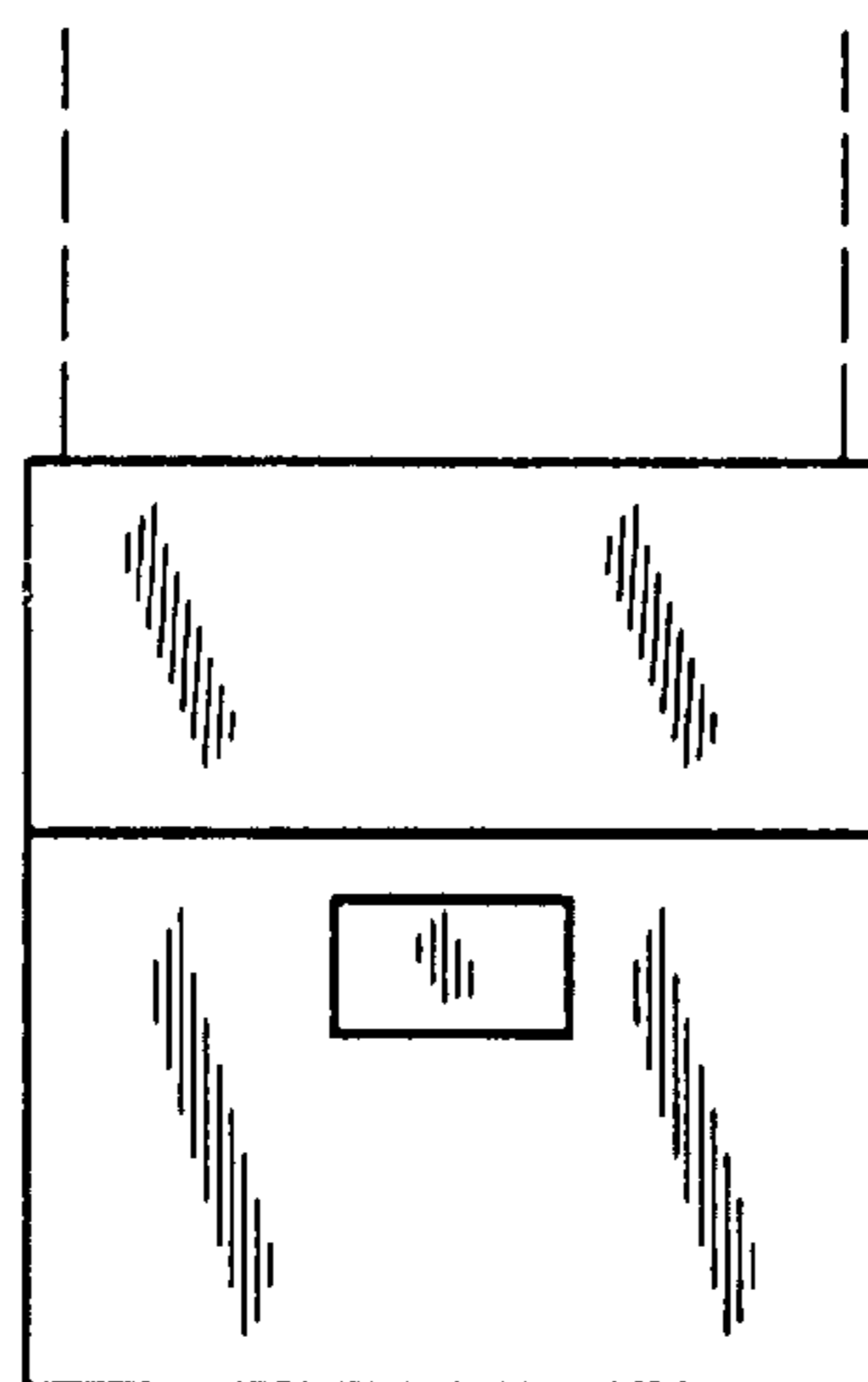
