(57) **CLAIM**

The ornamental design for a fuse assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a fuse assembly showing a first embodiment of my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a front elevational view thereof;

FIG. 7 is a top, front, and left side perspective view of the front portion of the fuse assembly of FIG. 1, with the fuse holder portion omitted;

FIG. 8 is a right side elevational view thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a left side elevational view thereof;

FIG. 11 is a rear elevational view thereof;

FIG. 12 is a front elevational view thereof;

FIG. 13 is a top, front, and left side perspective view of the fuse holder portion of the fuse assembly of FIG. 1, with the front portion omitted;

FIG. 14 is a right side elevational view thereof;

FIG. 15 is a top plan view thereof;

FIG. 16 is a rear elevational view thereof;

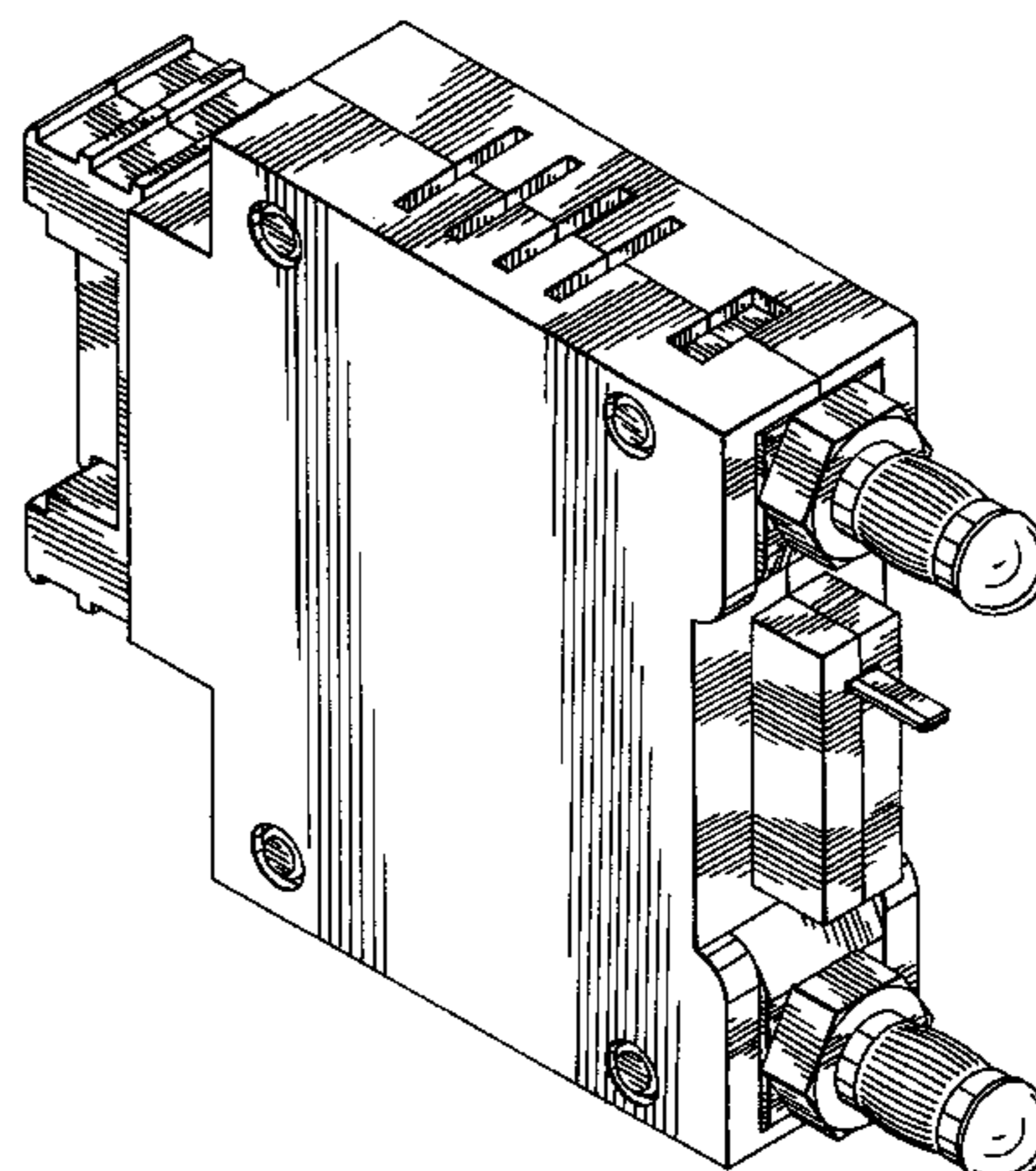
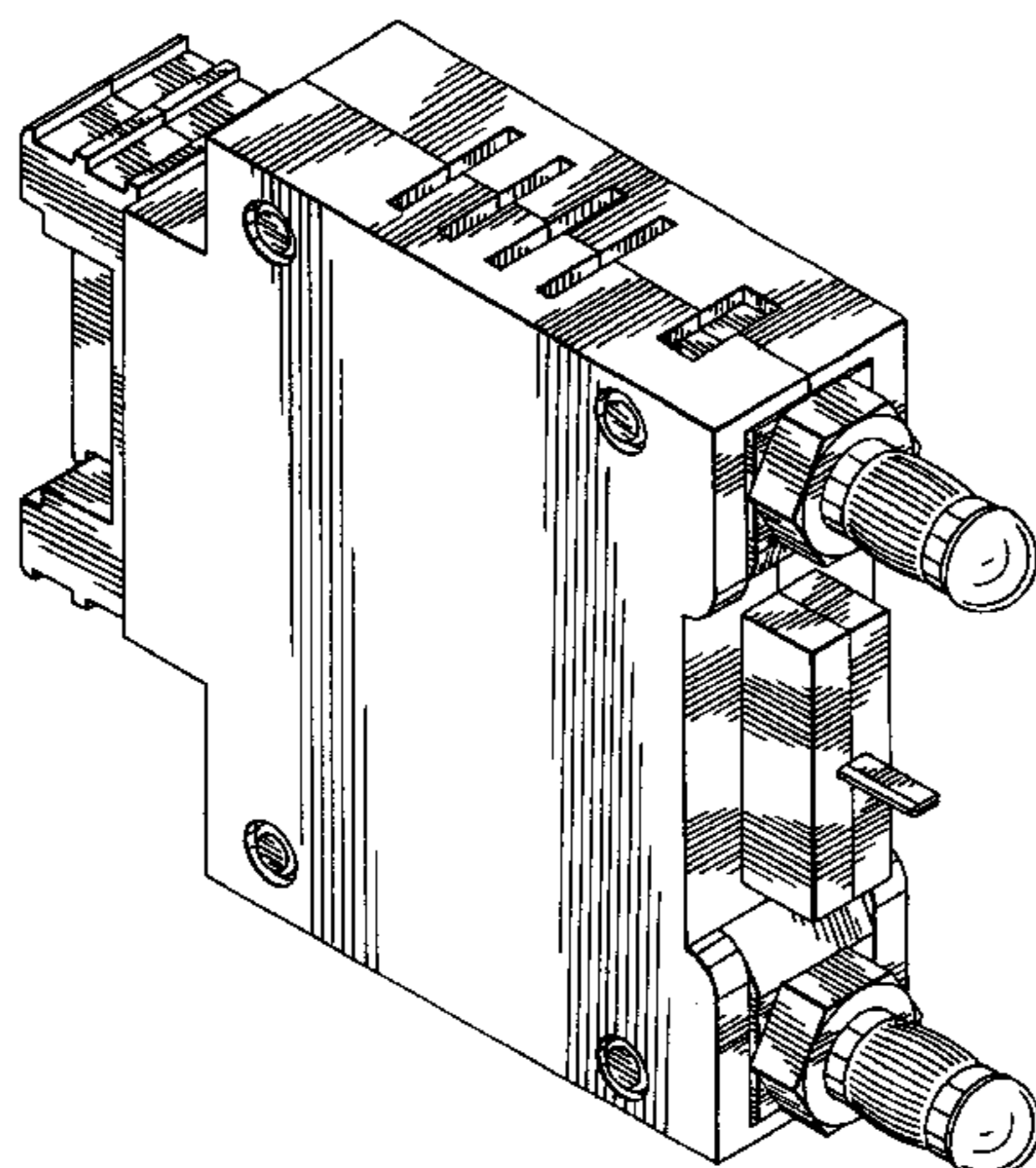
FIG. 17 is a front elevational view thereof;

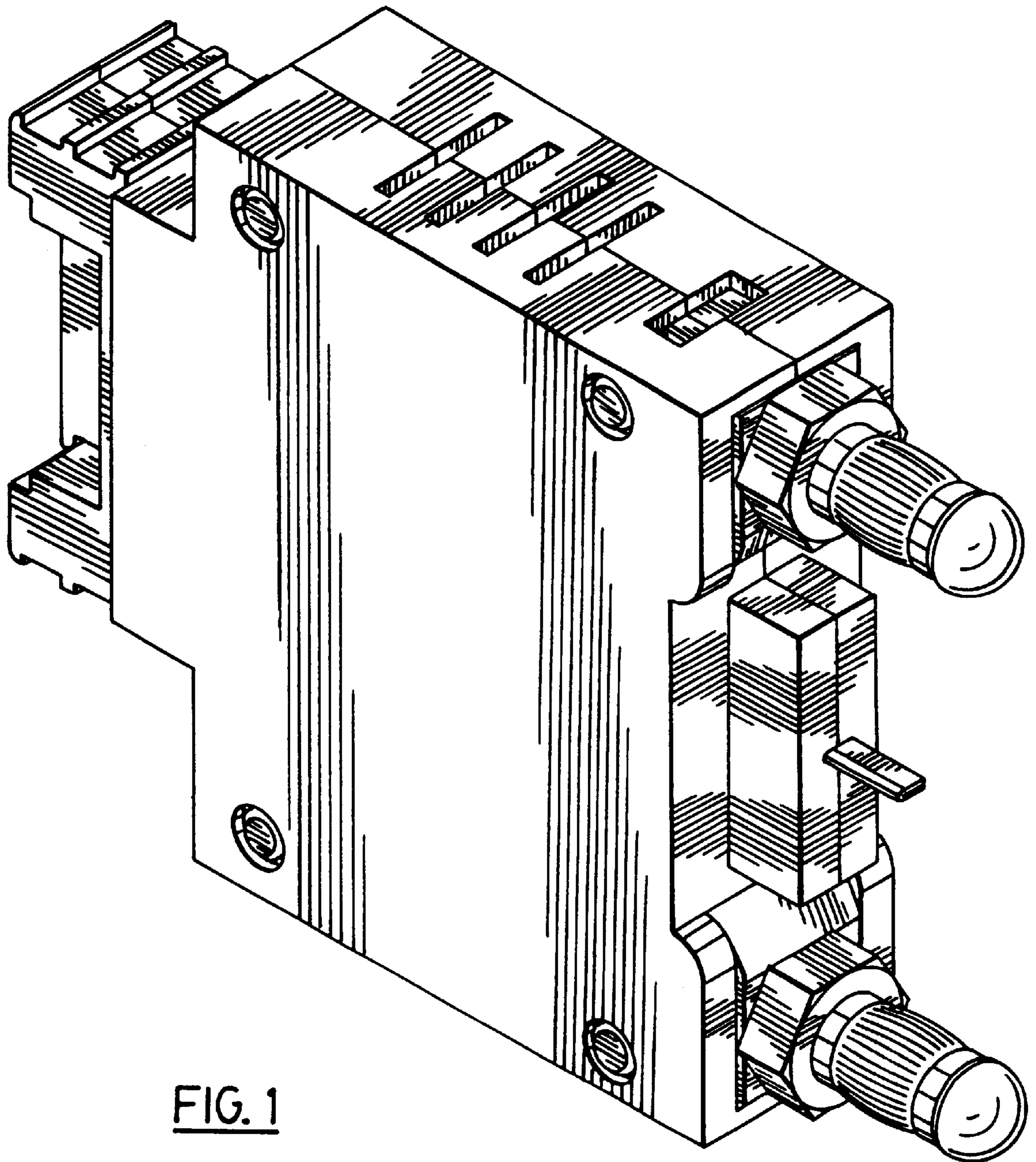
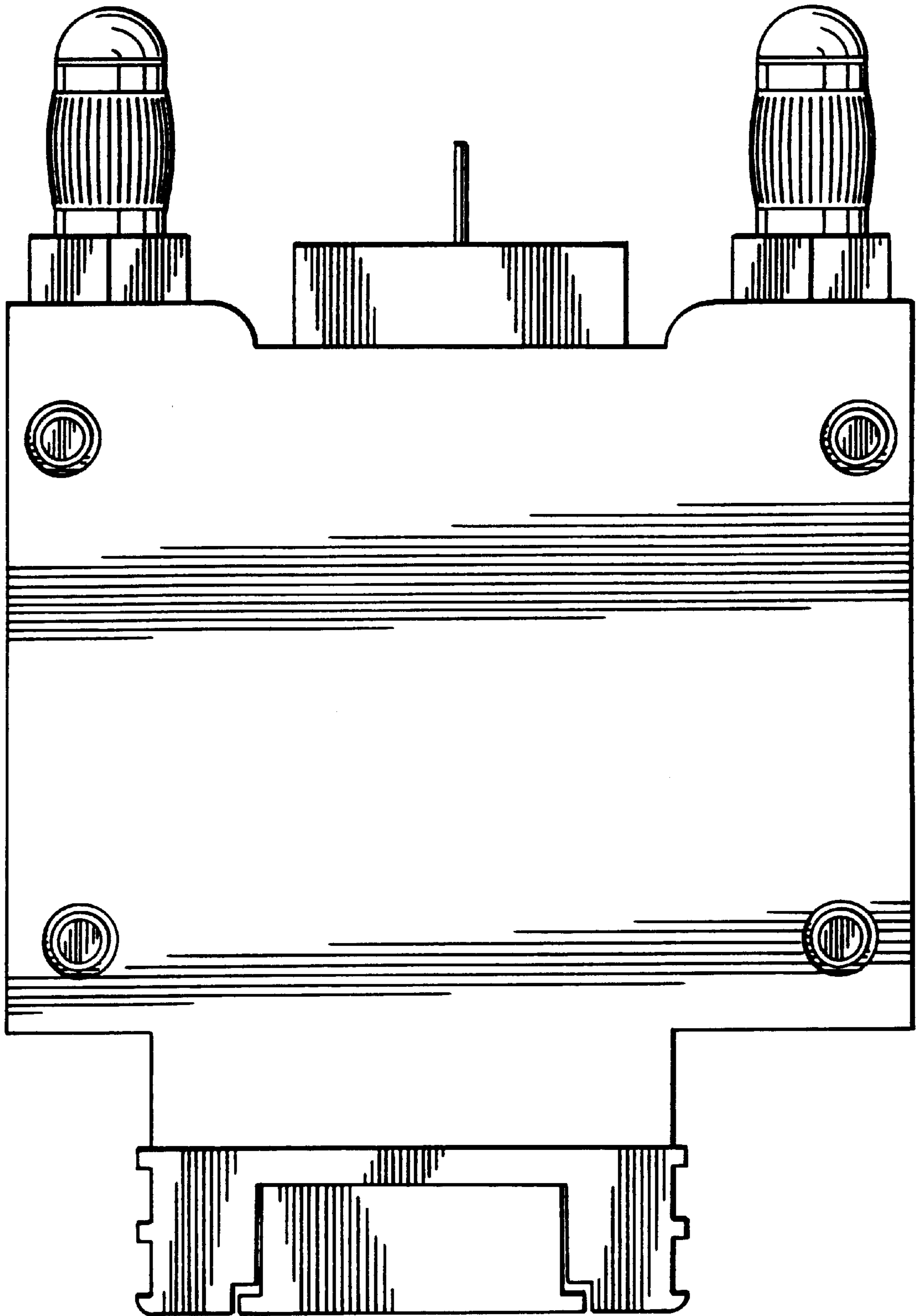

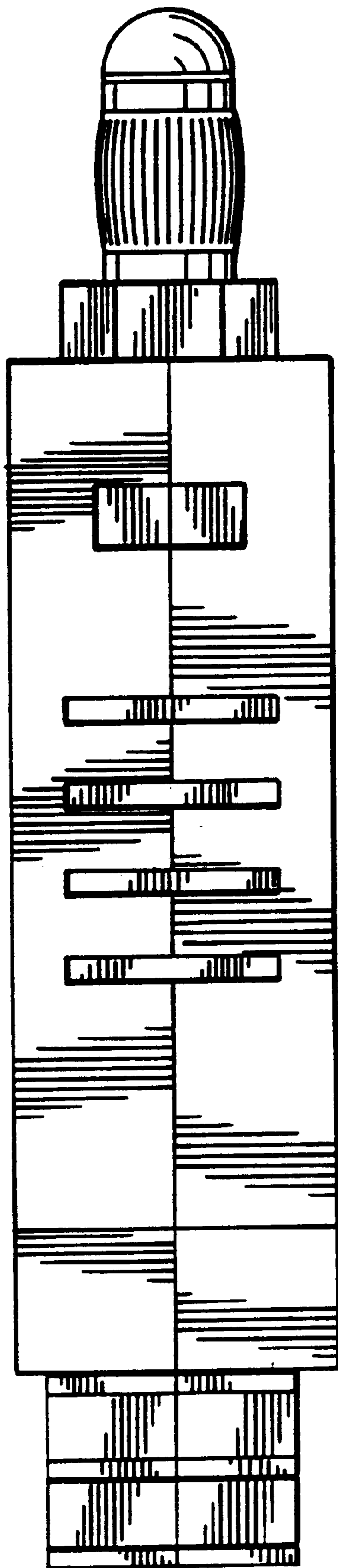

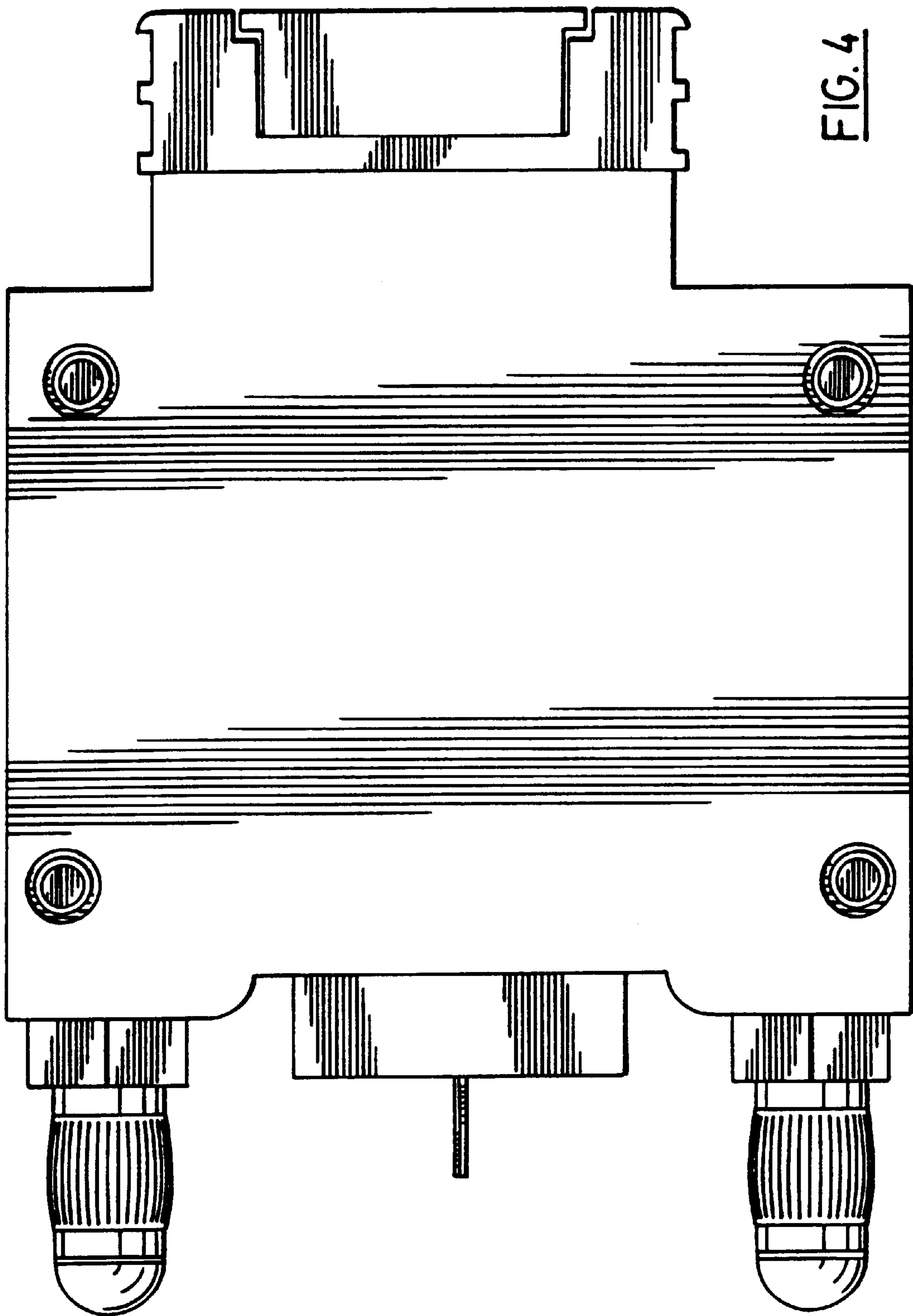

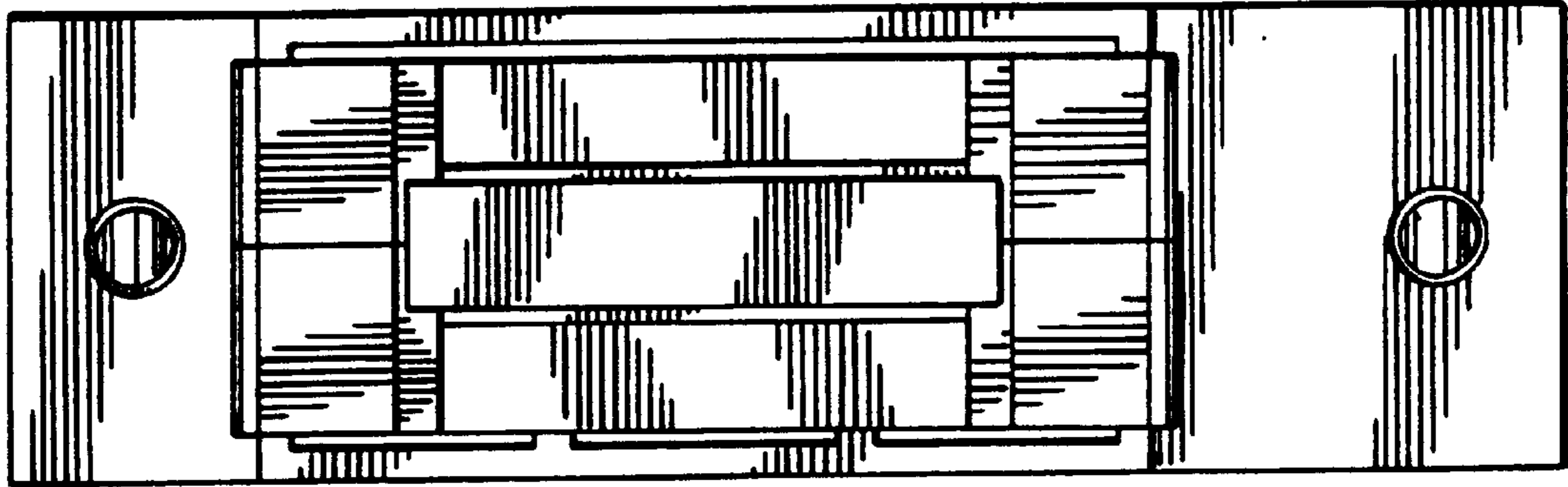
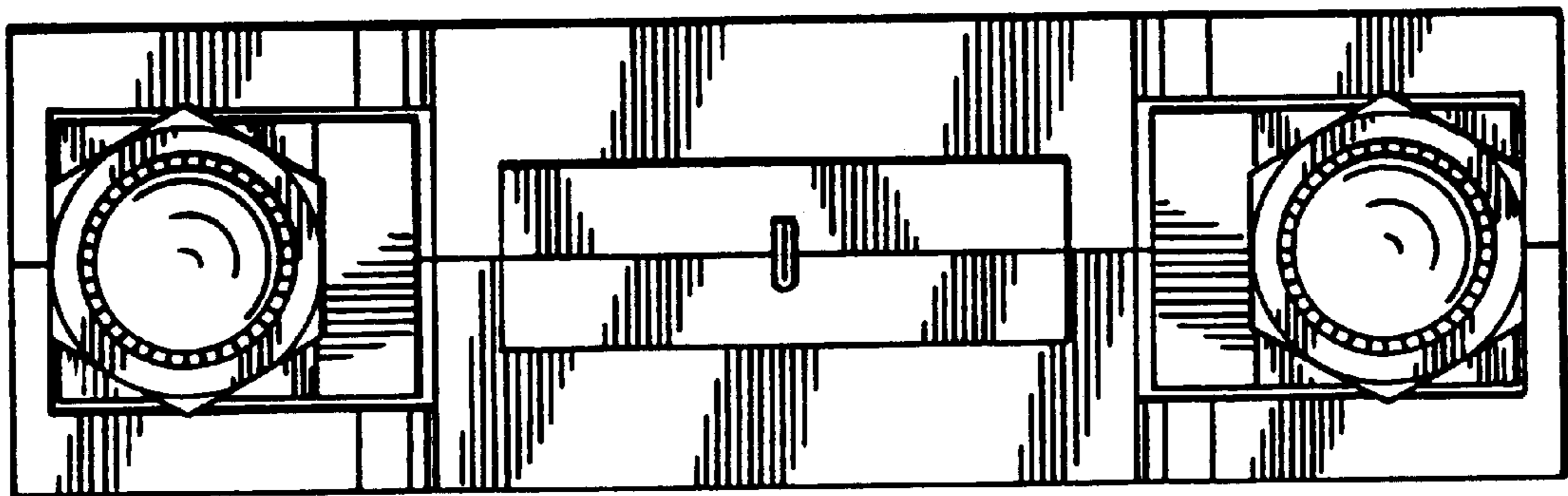

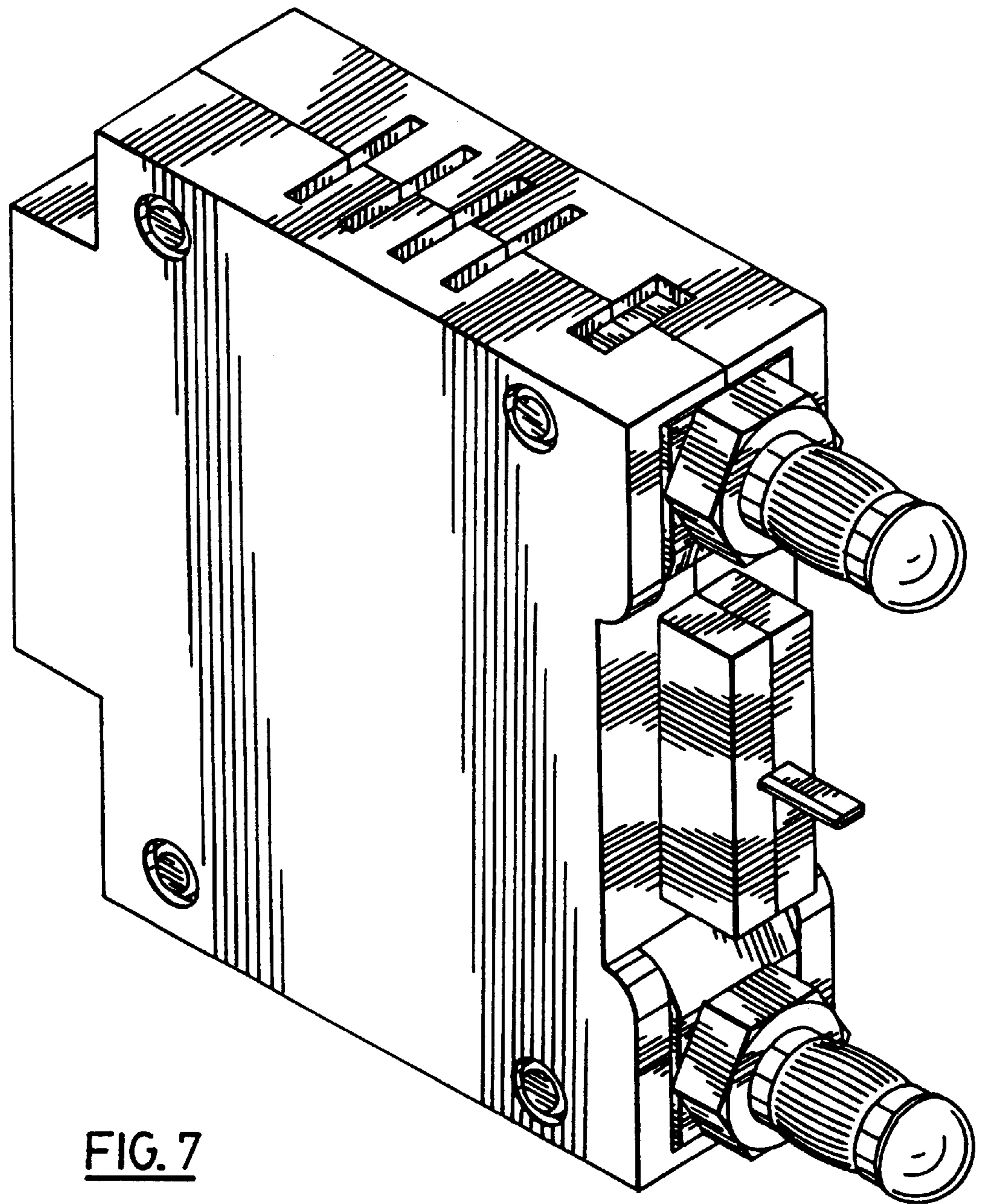
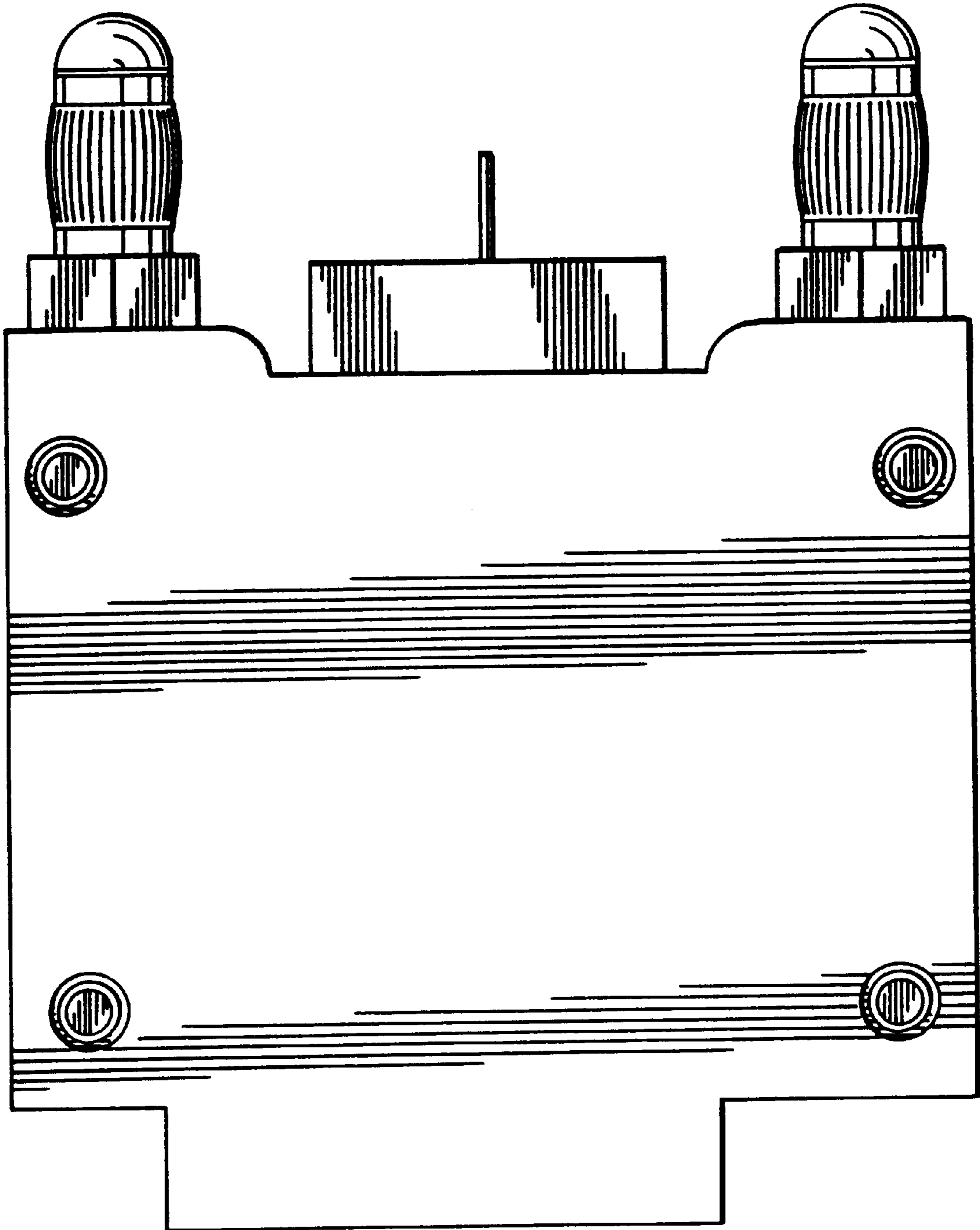

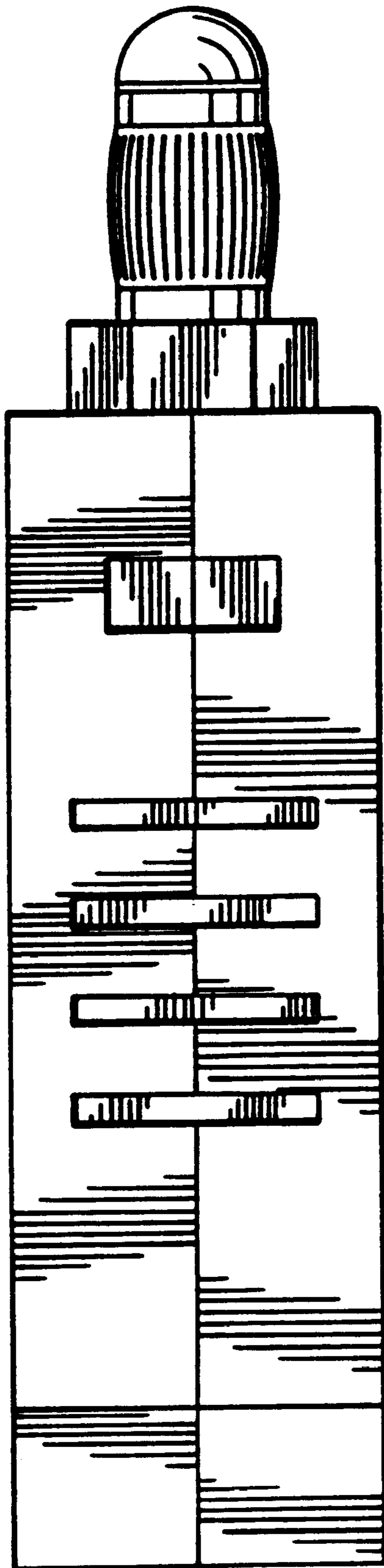

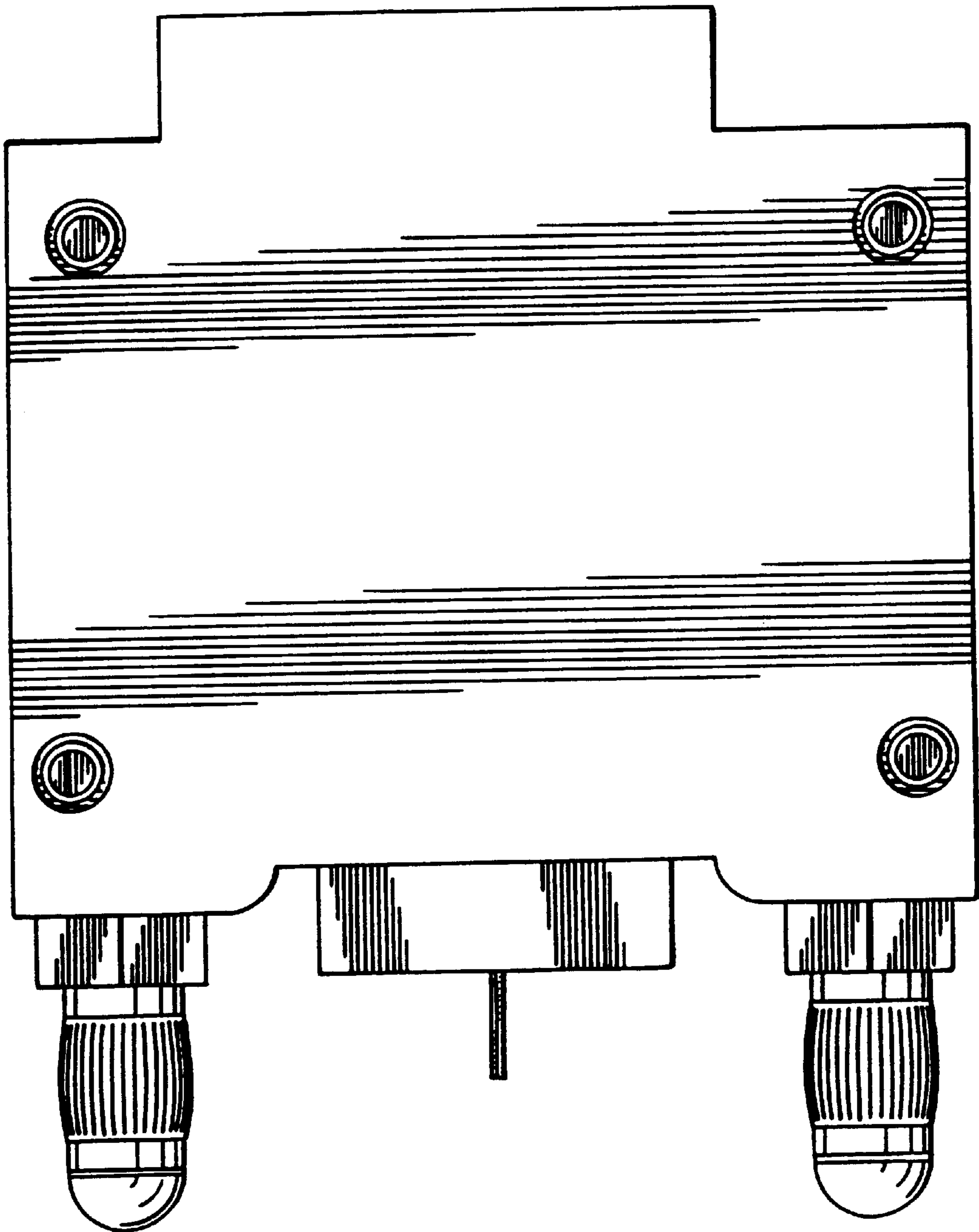

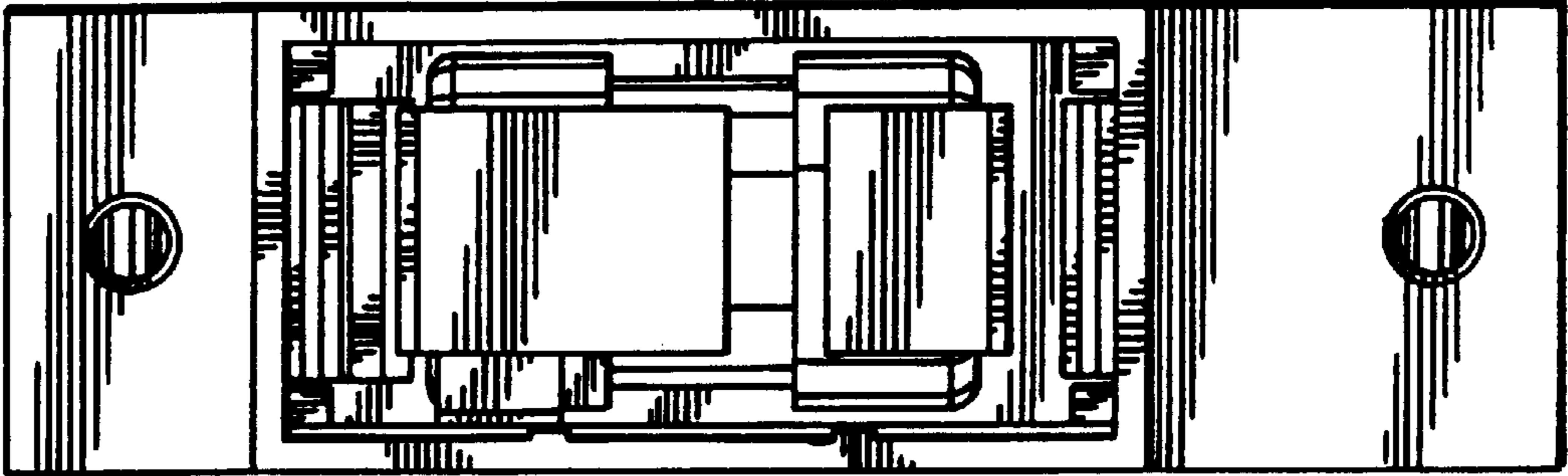
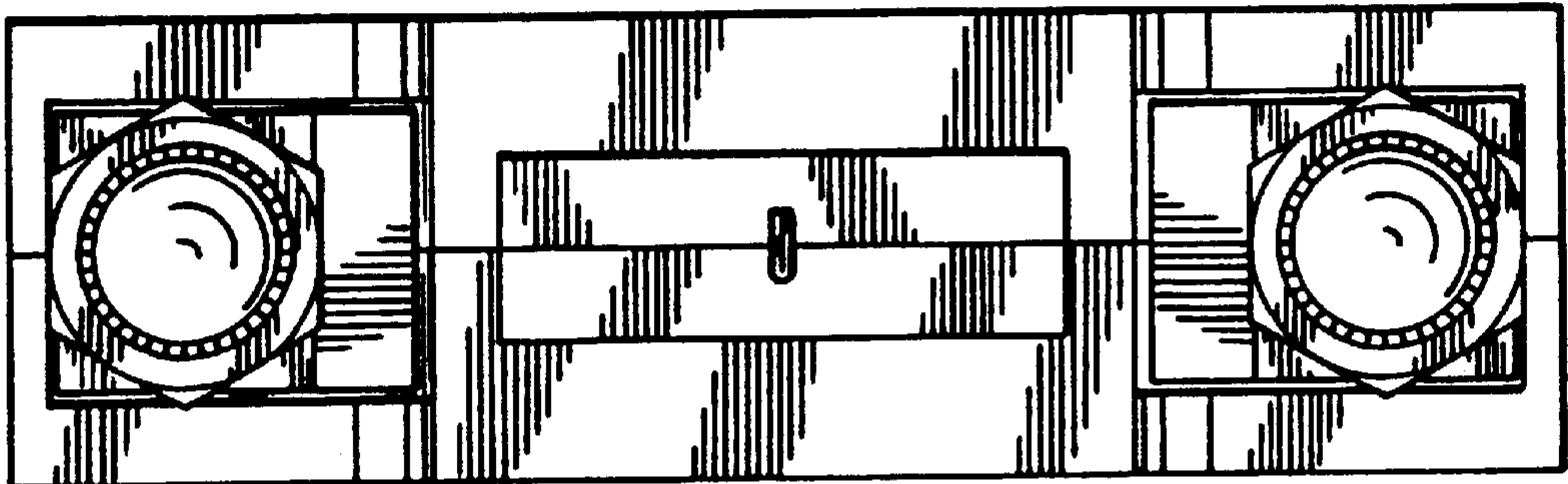

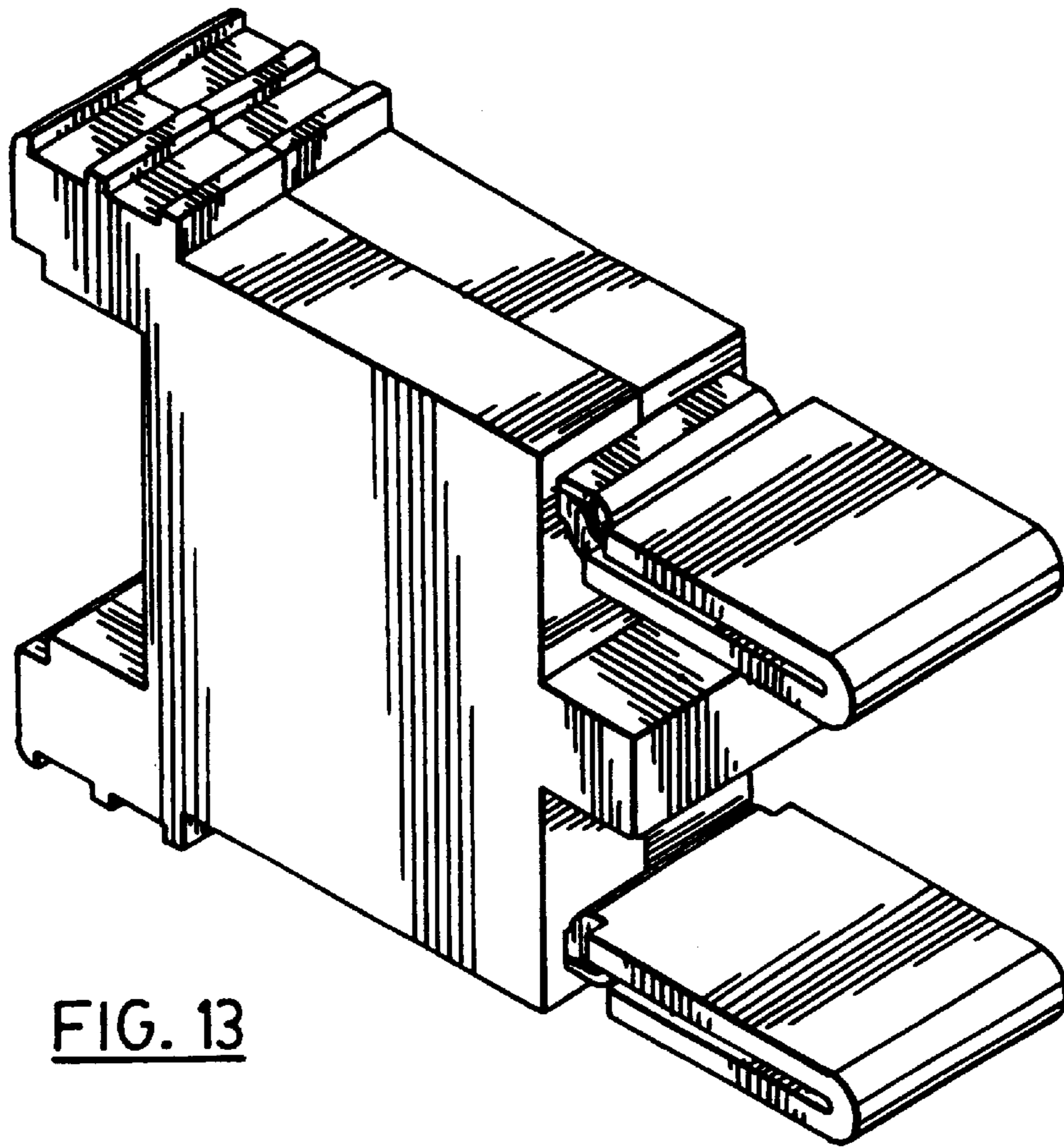

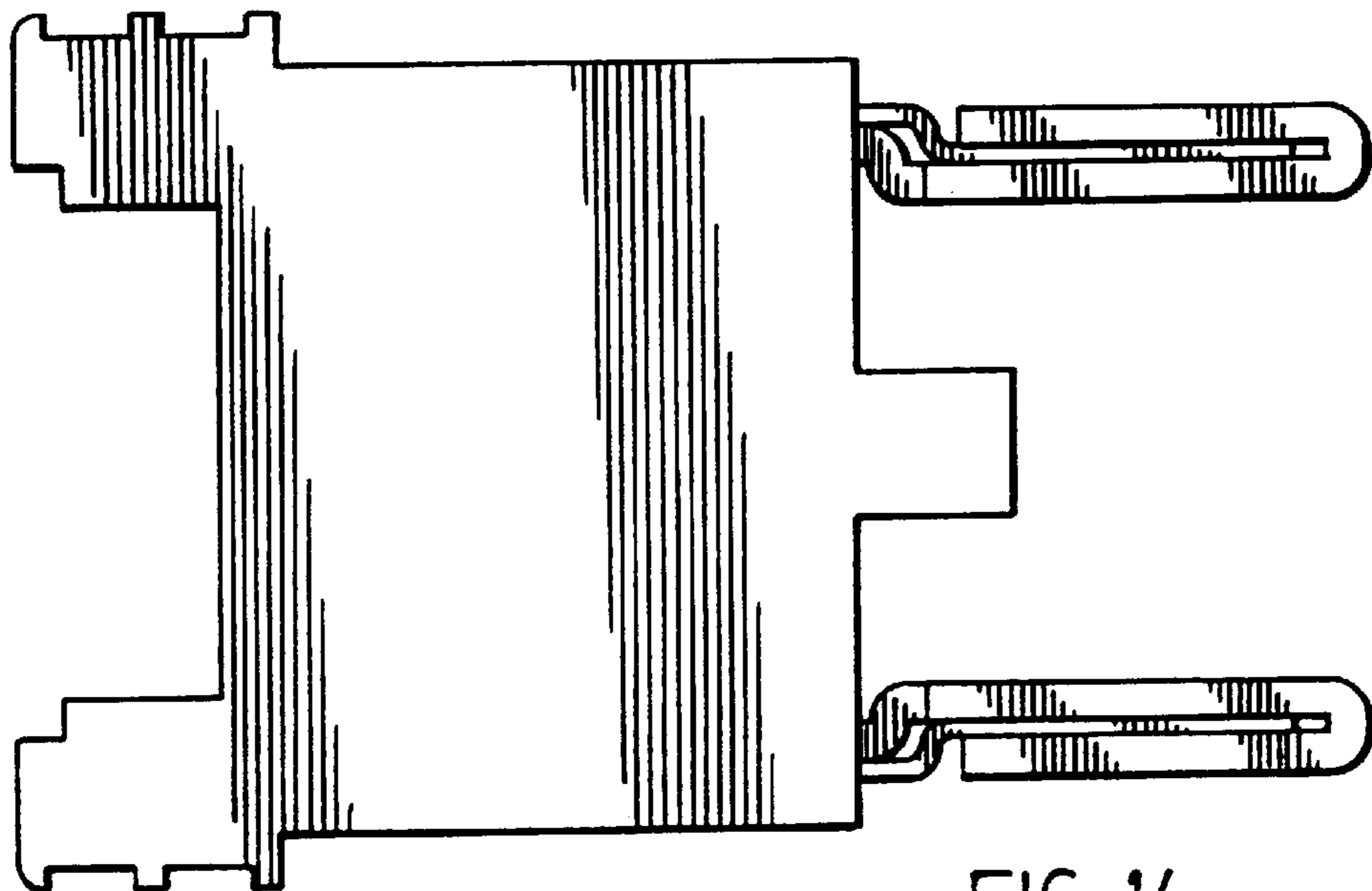

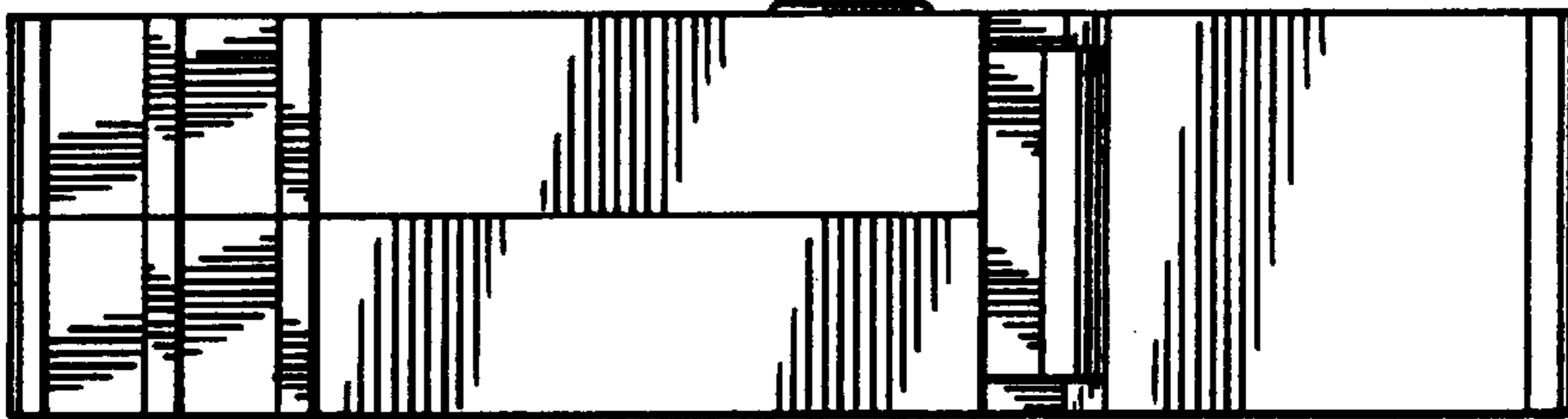

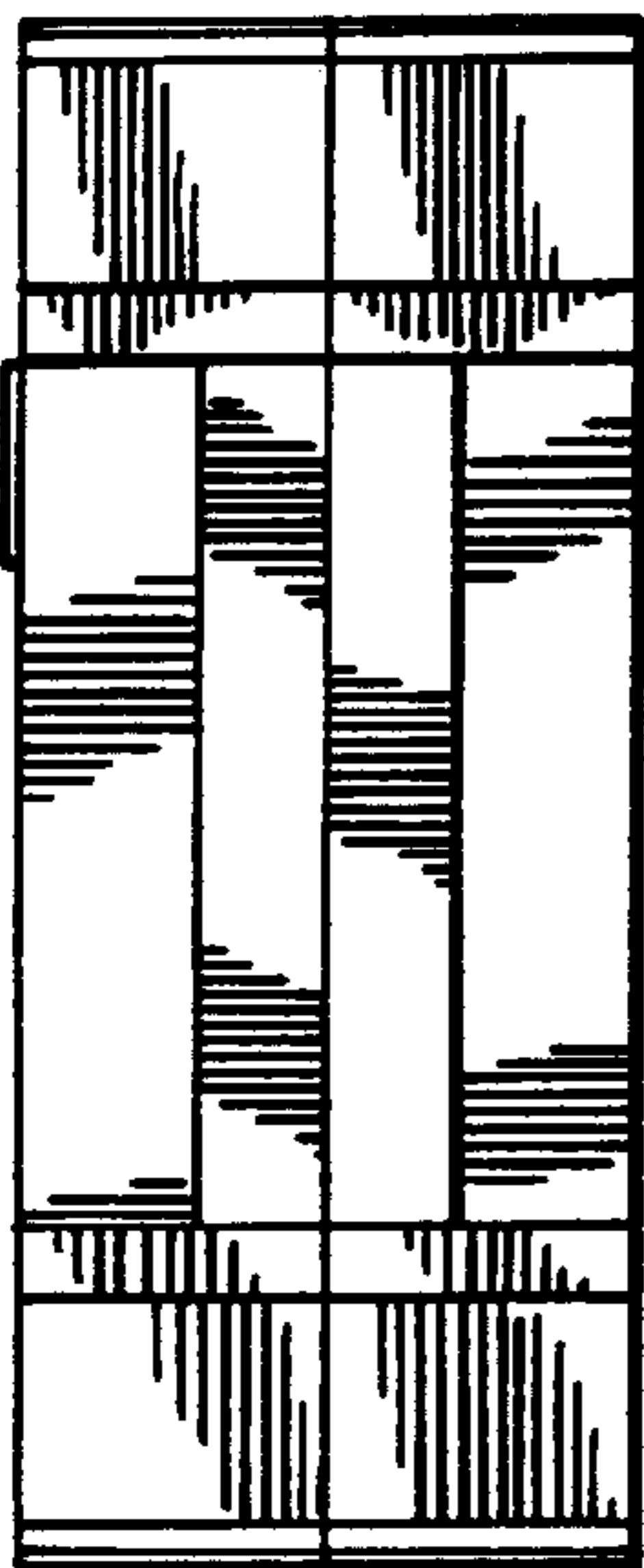

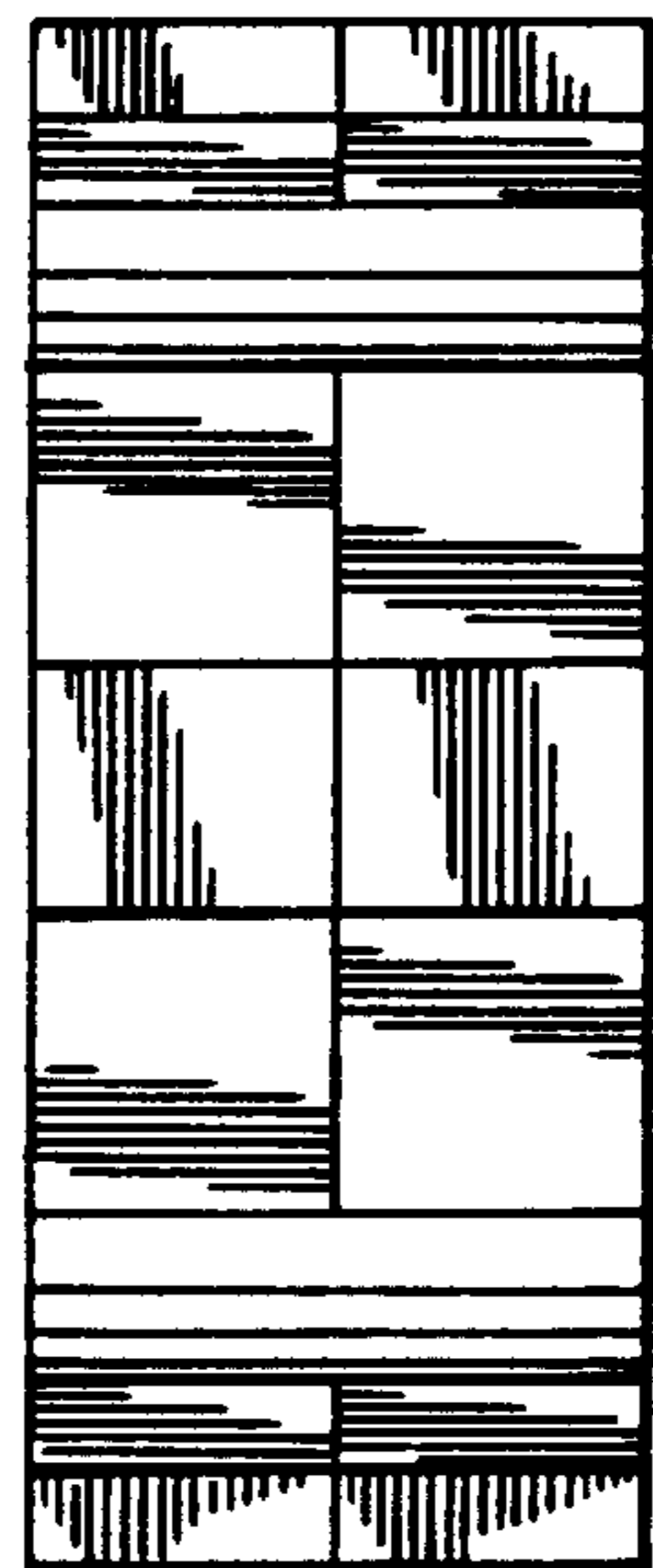

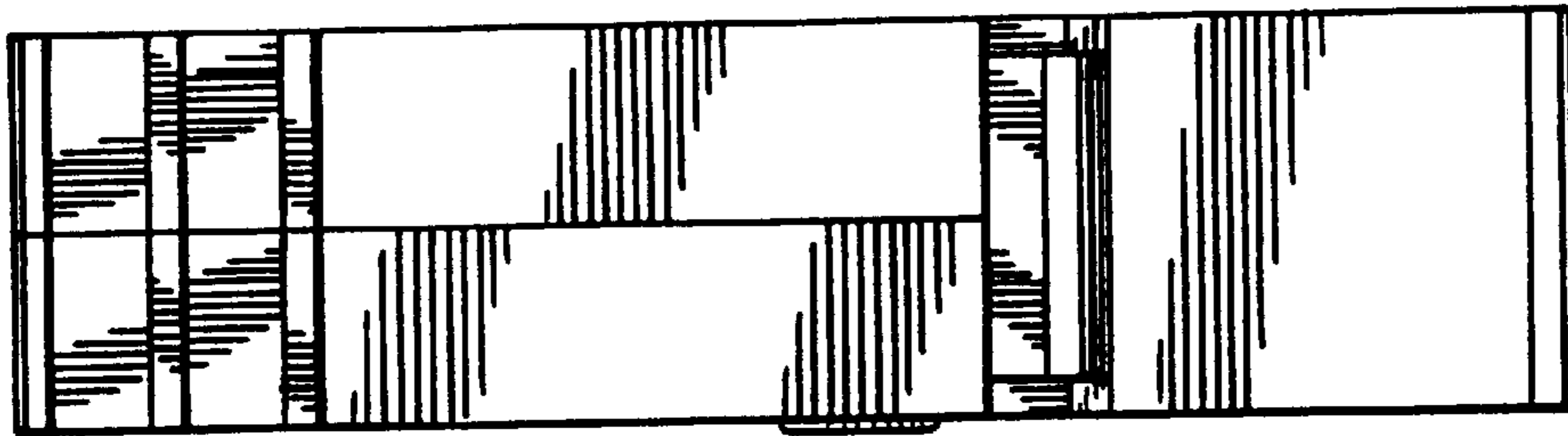

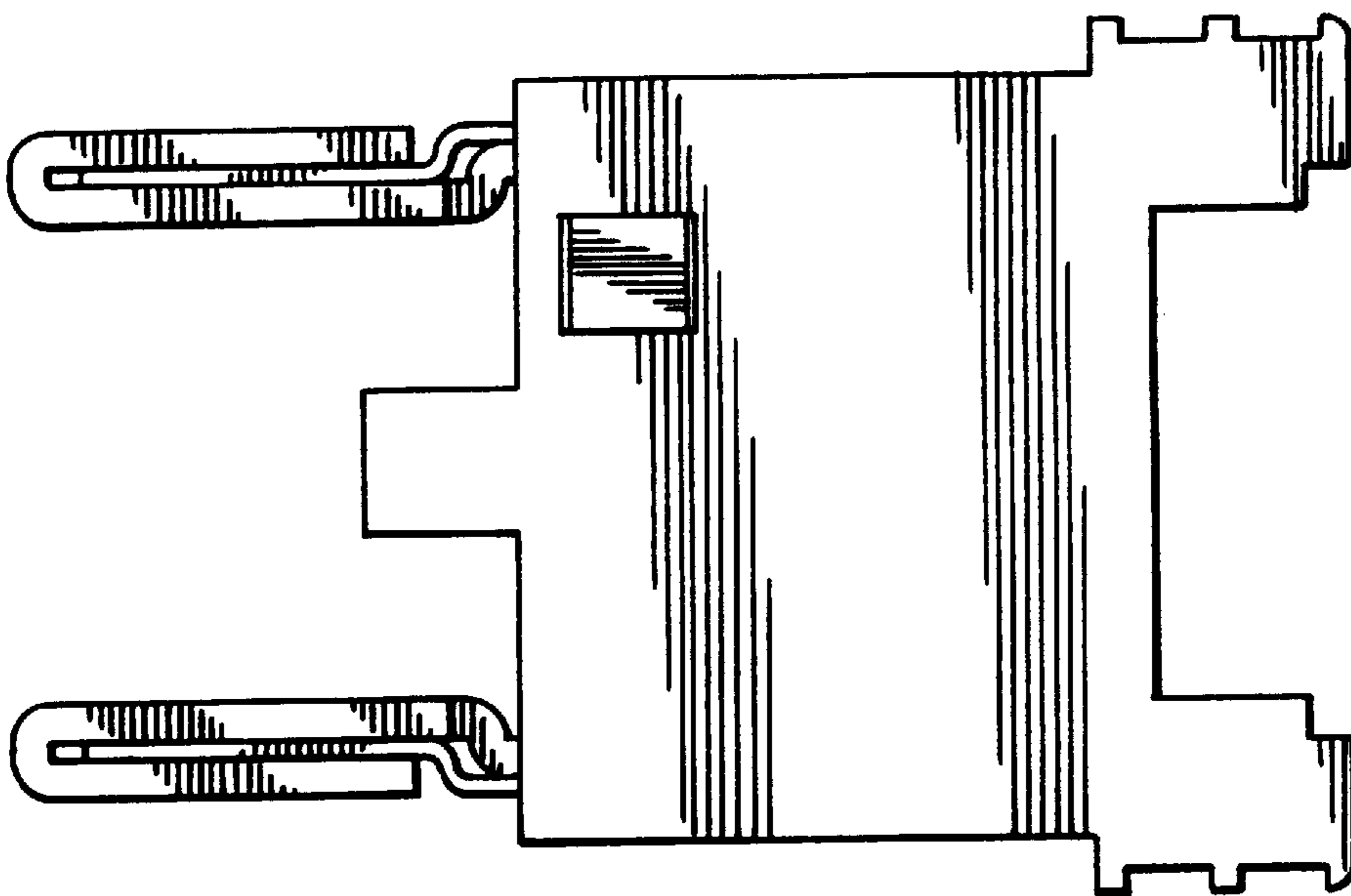

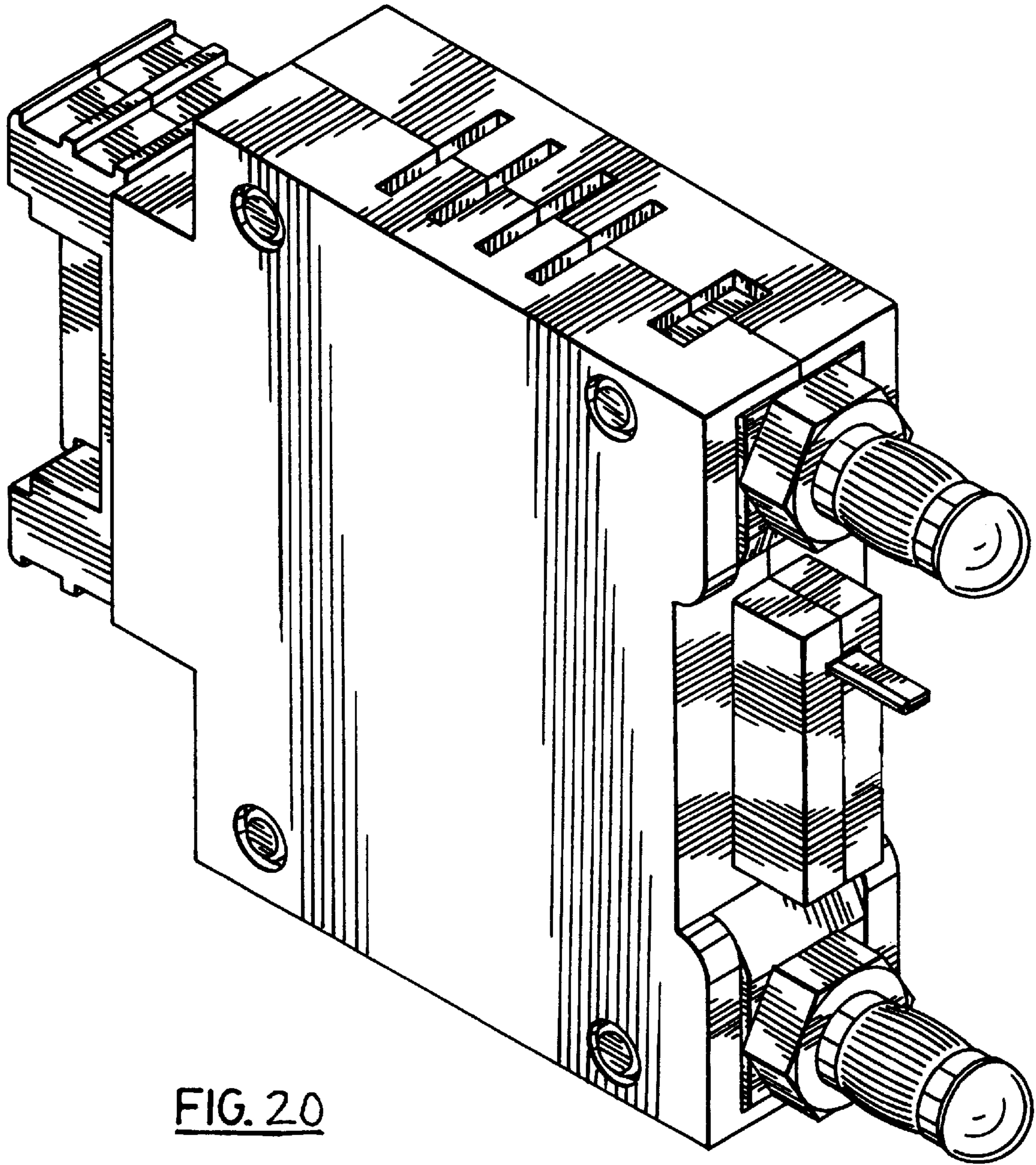
