FIG. 5 is a rear perspective view thereof;

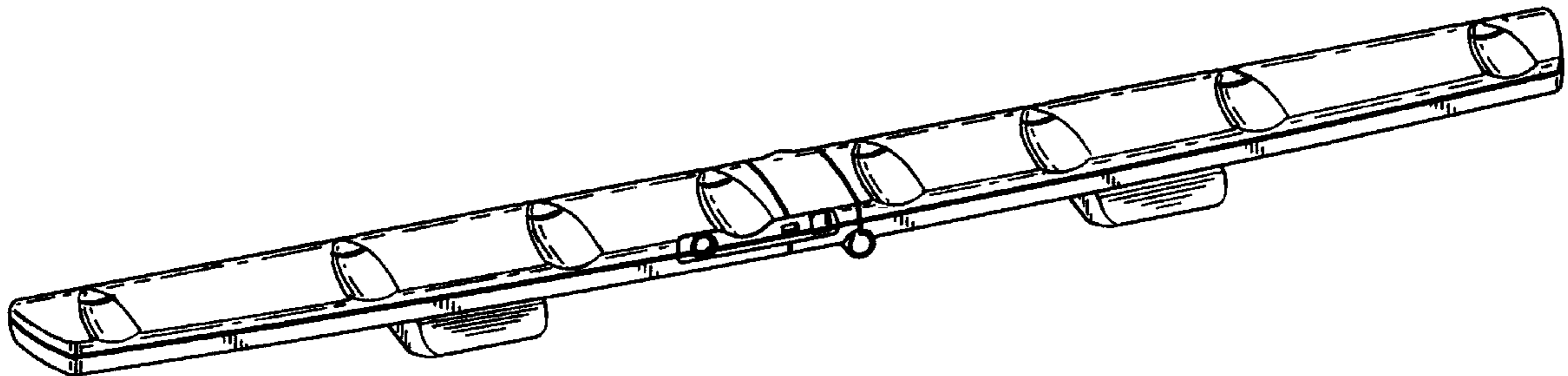
FIG. 6 is a side perspective view thereof.

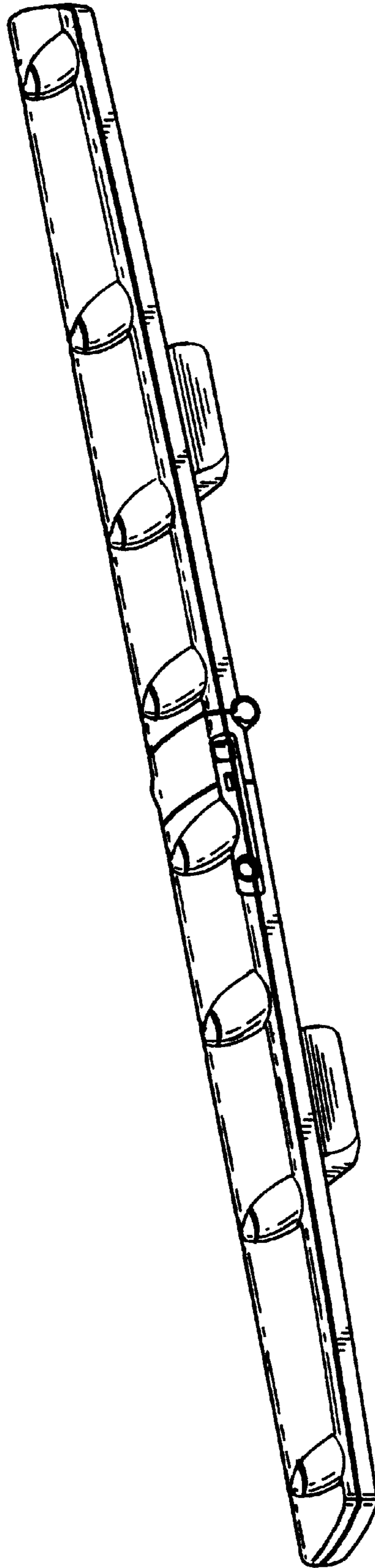

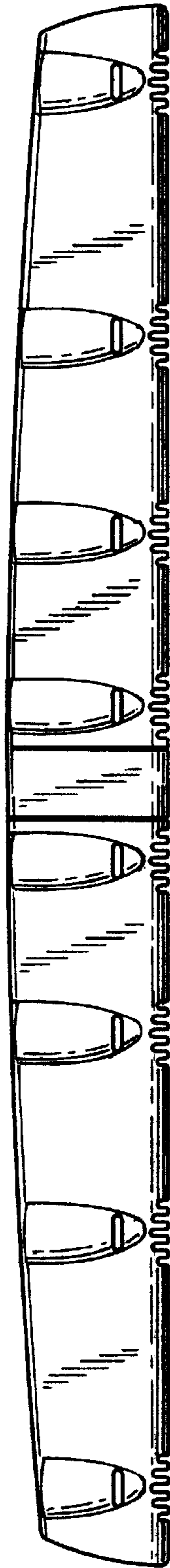

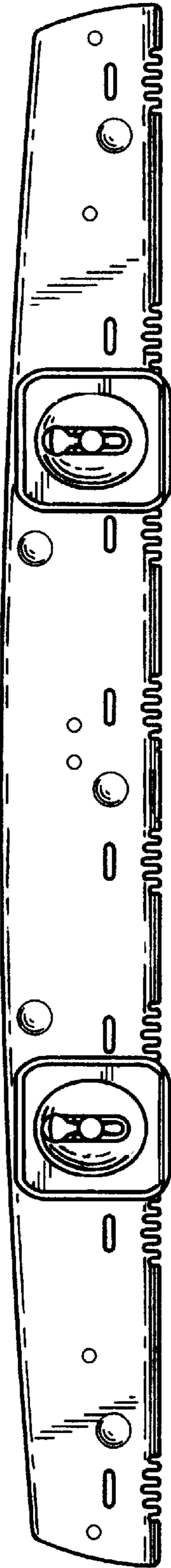

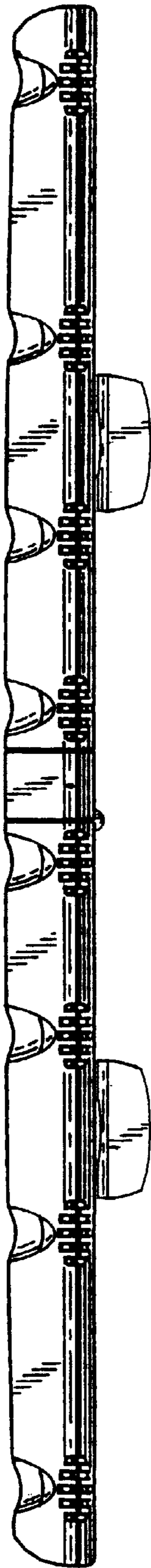

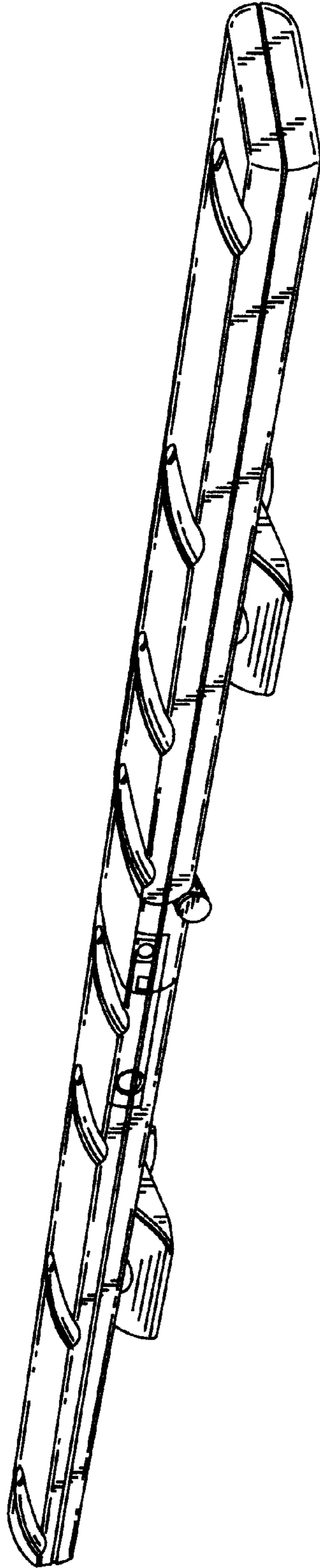
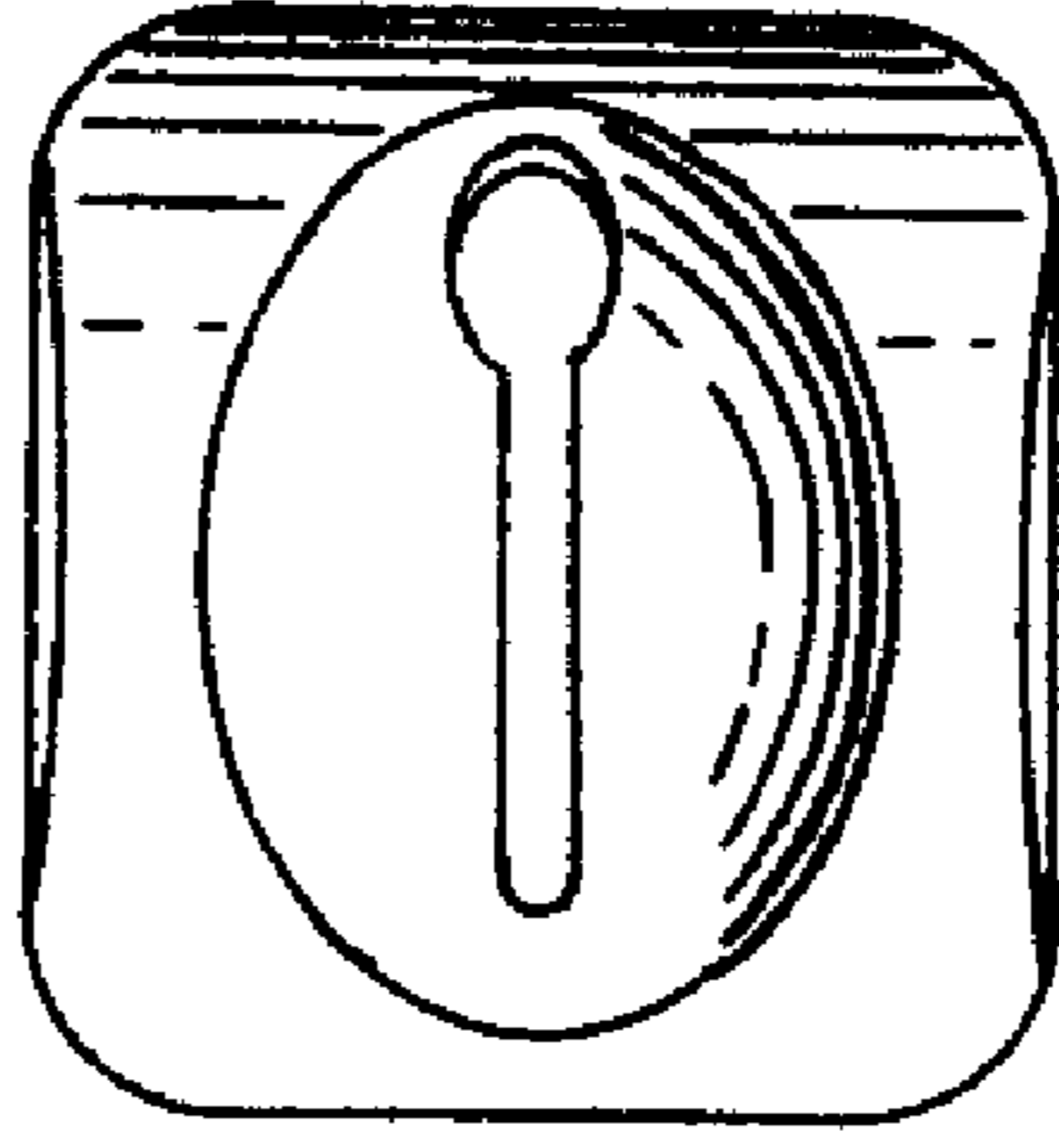
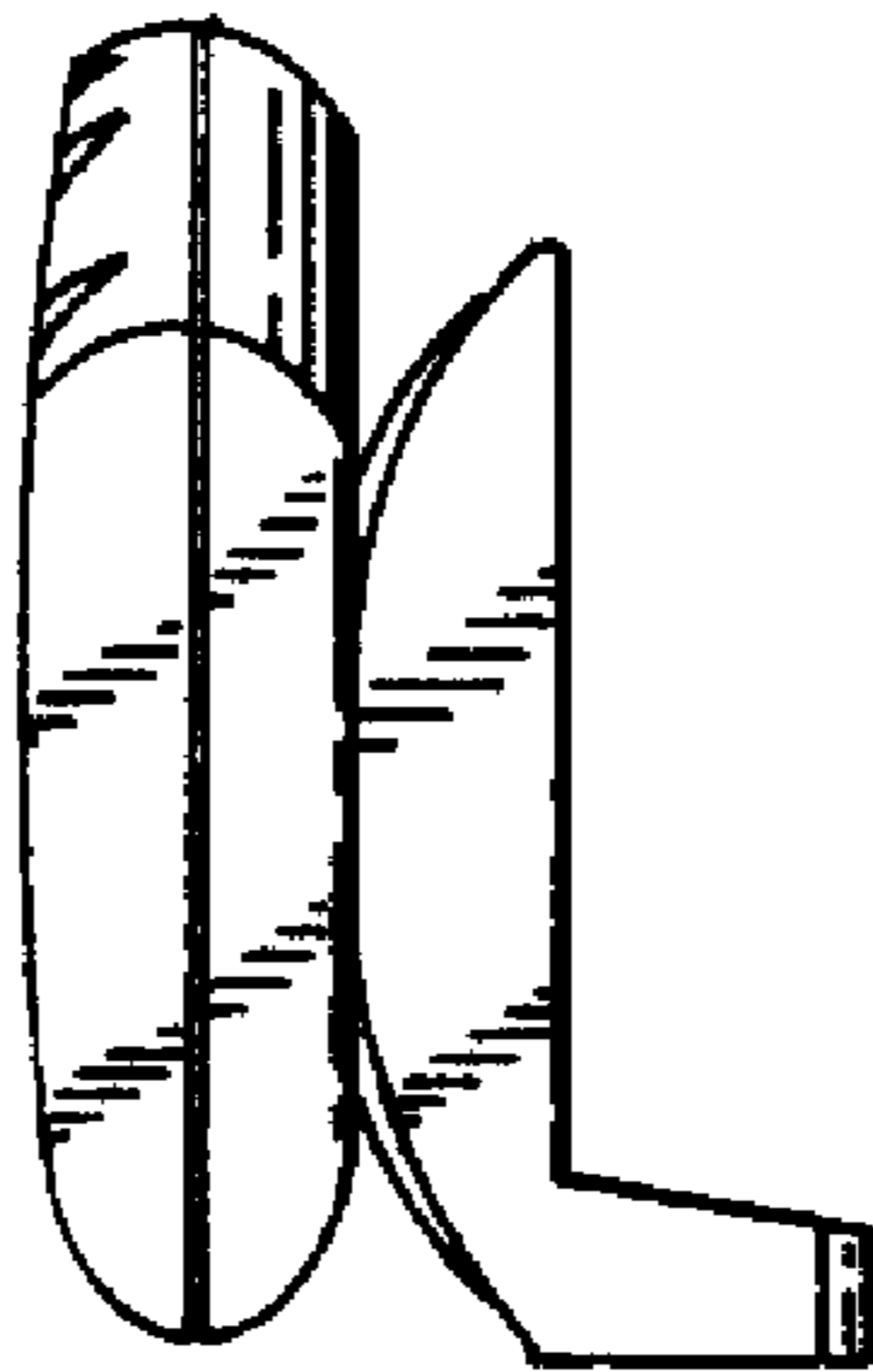


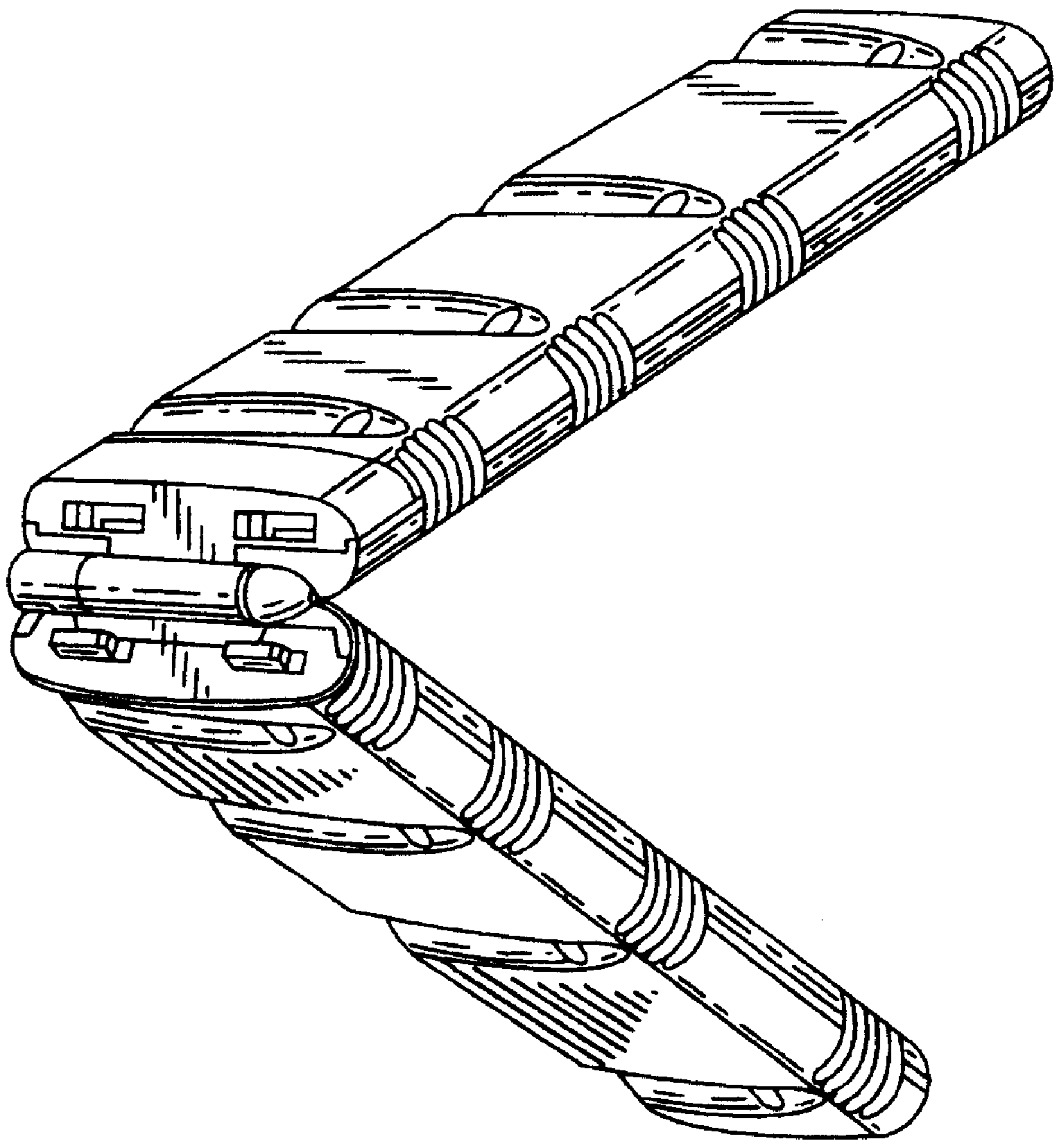

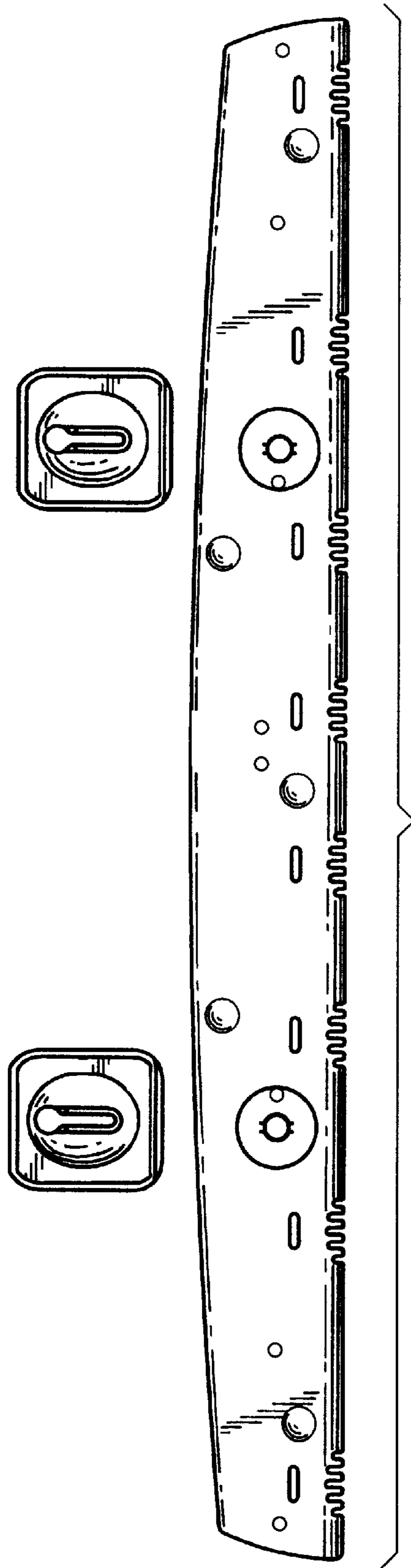
