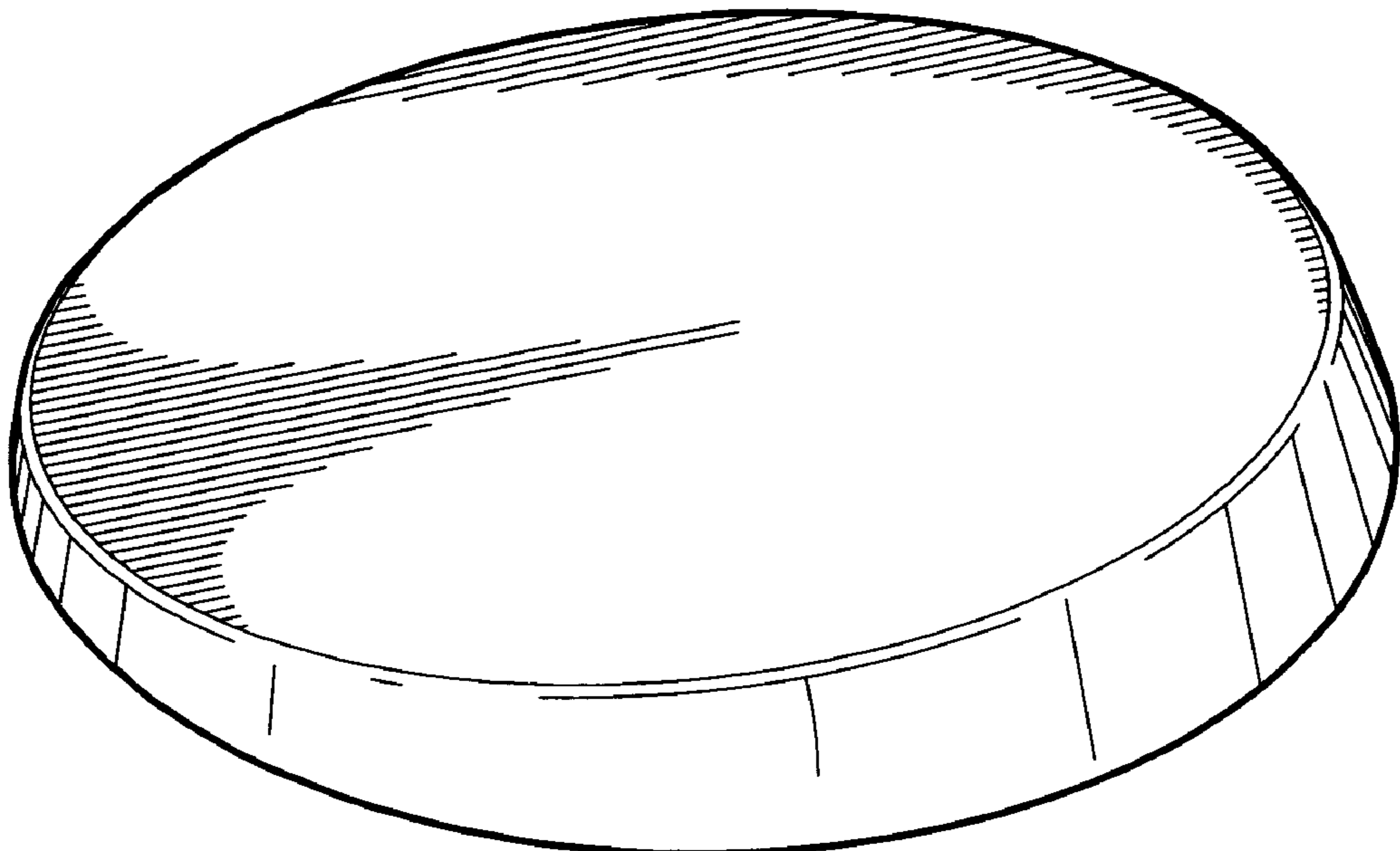
(57) **CLAIM**

The ornamental design for a computer mouse ramp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the computer mouse ramp showing my new design;
FIG. 2 is a side elevation view thereof, the opposite side being a mirror image thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

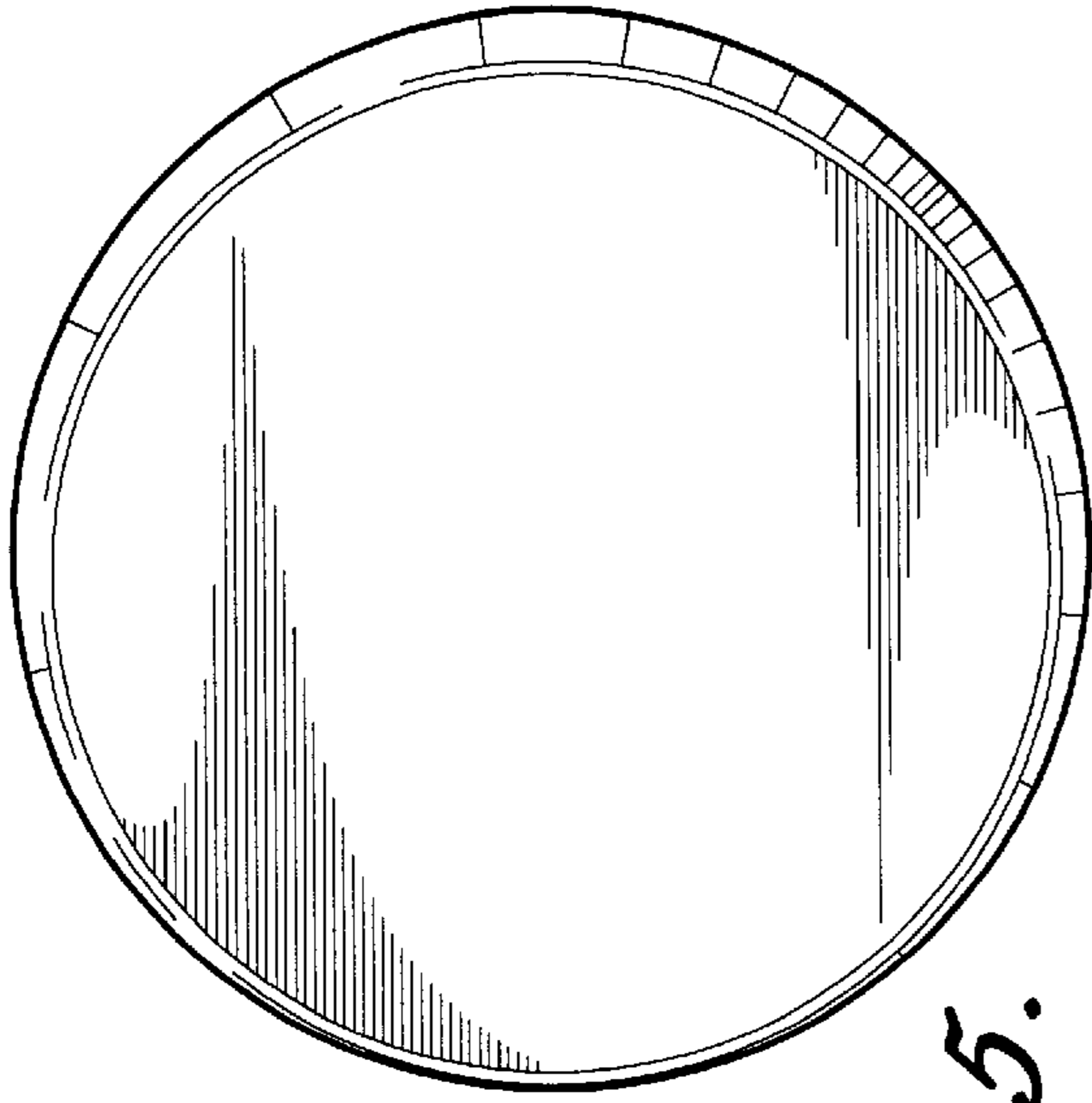

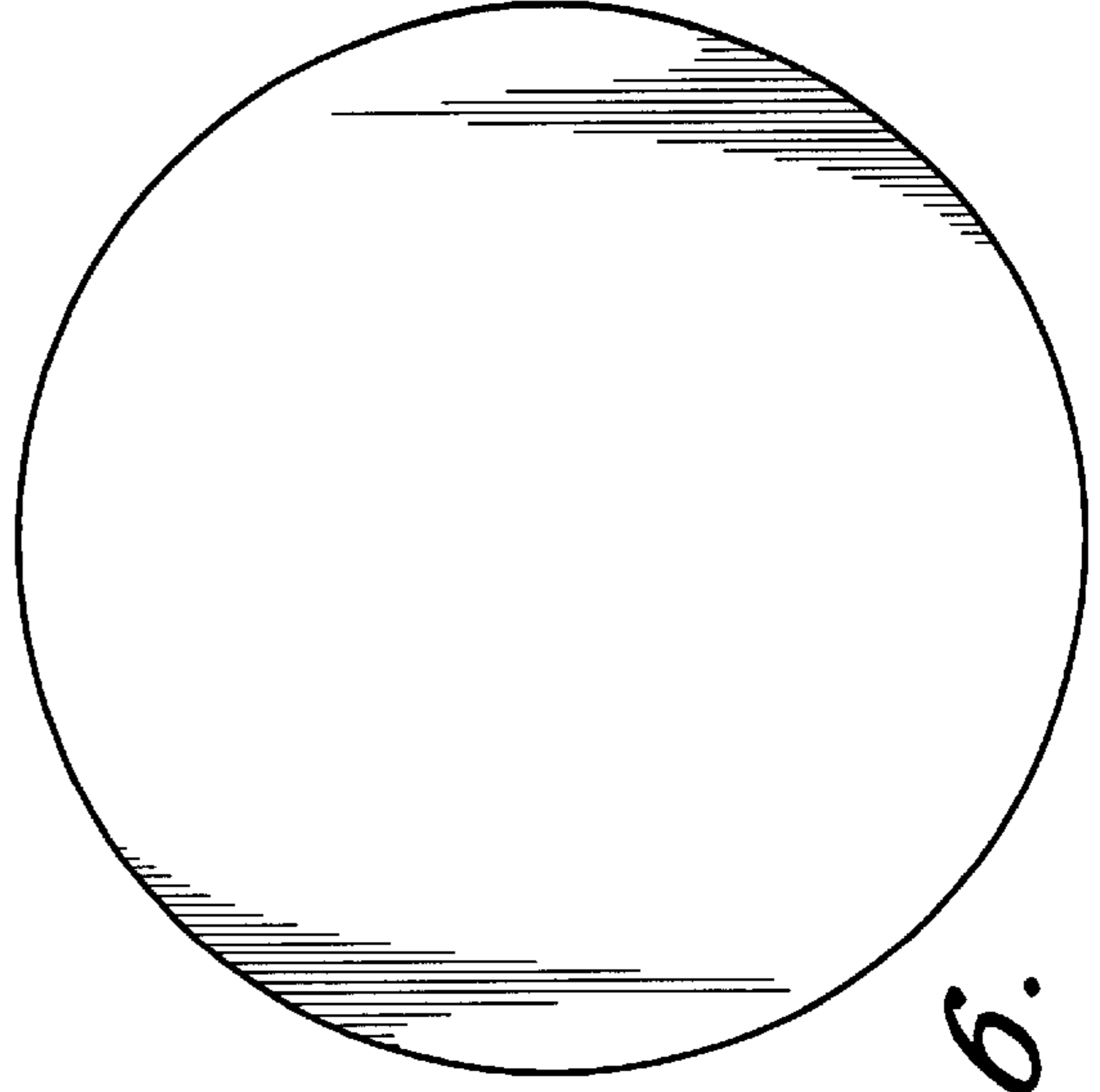

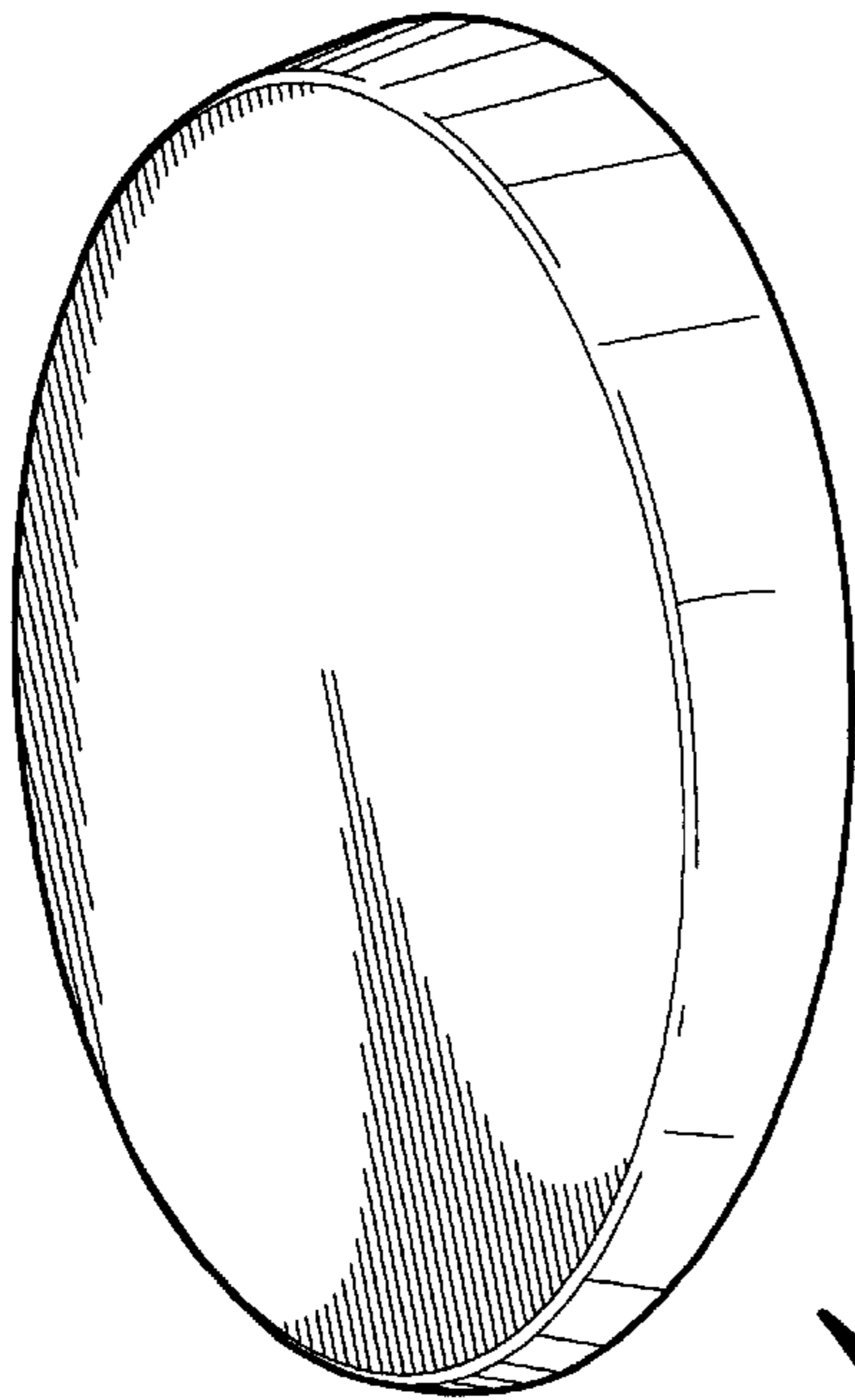

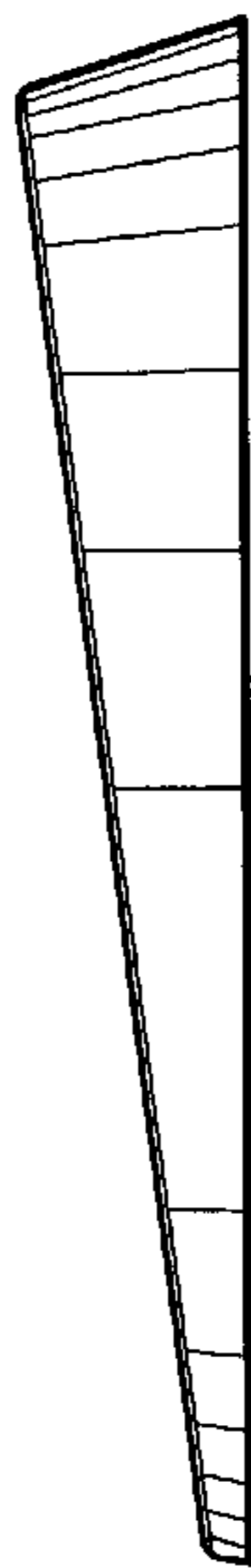

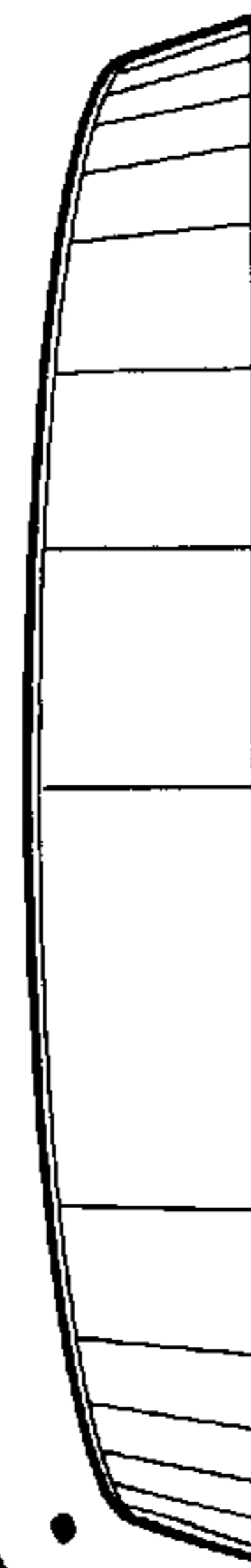

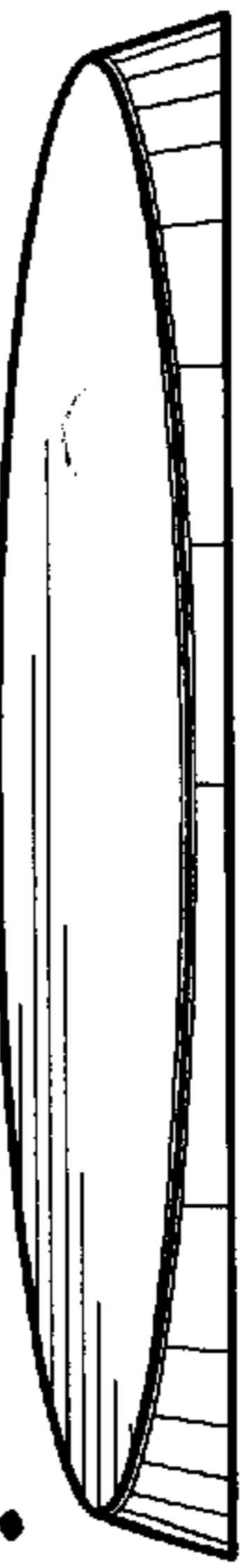
