FIG. 2 is a top plan view of a door for gaming machine shown in FIG. 1;

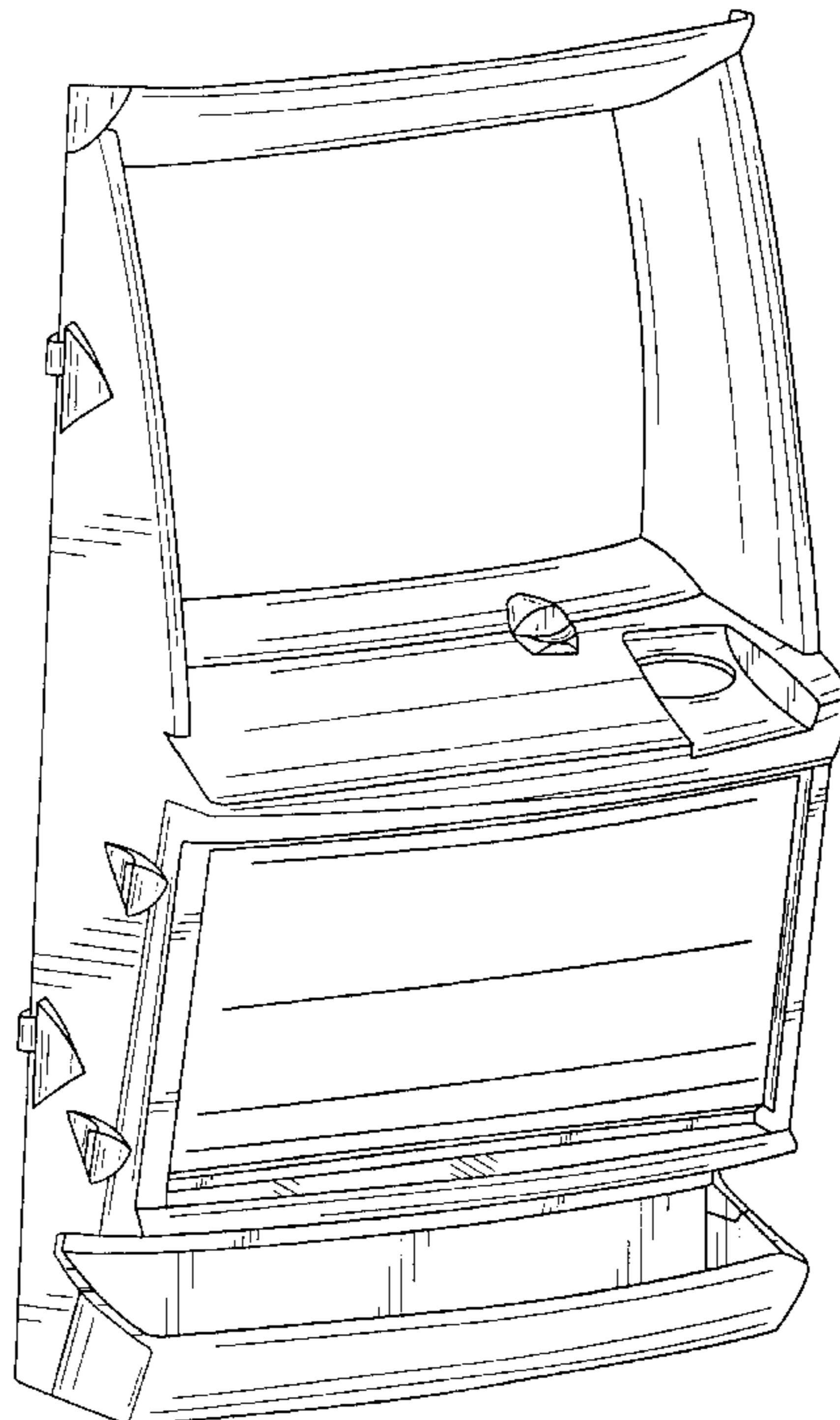
FIG. 3 is a front view of a door for gaming machine shown in FIG. 1;

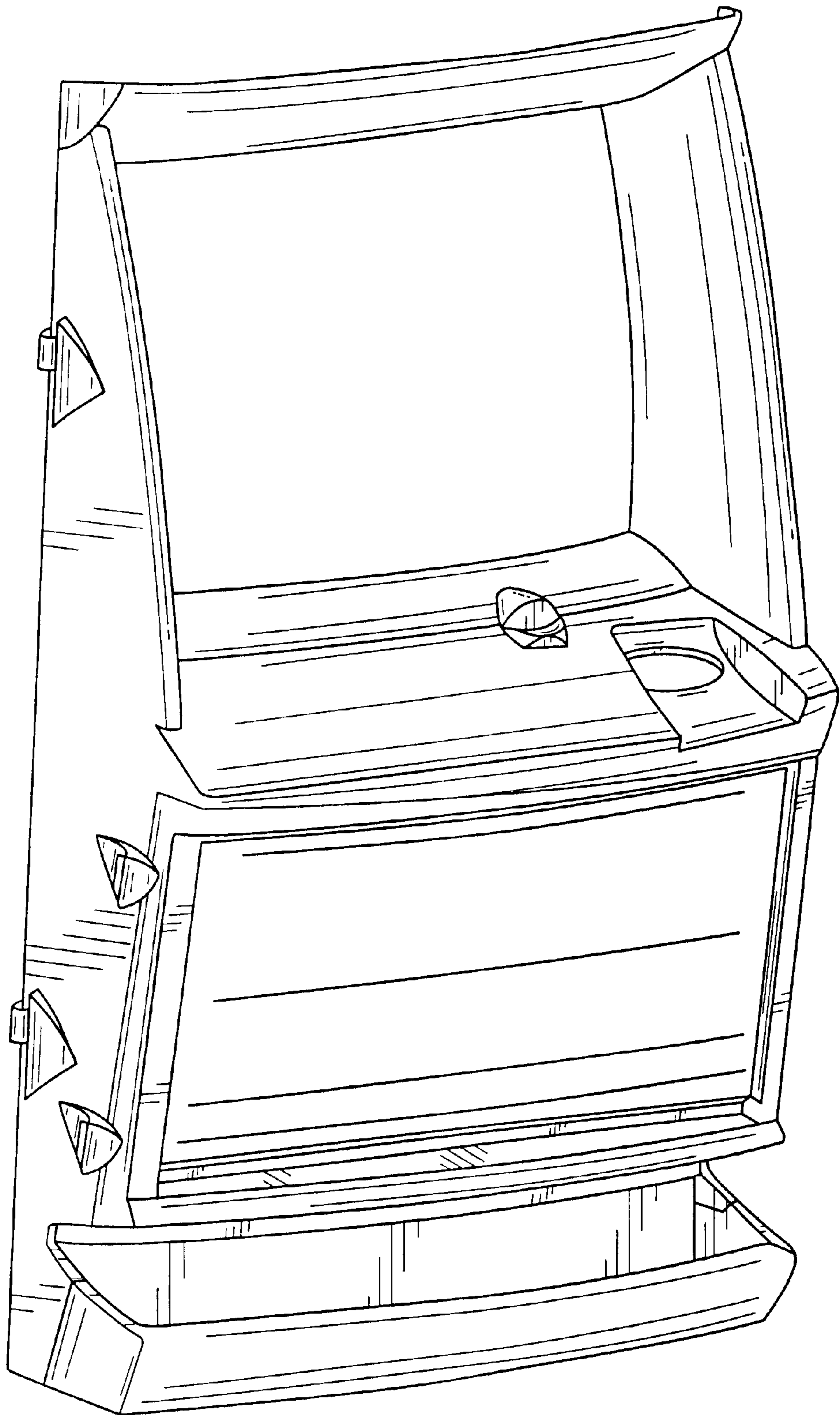

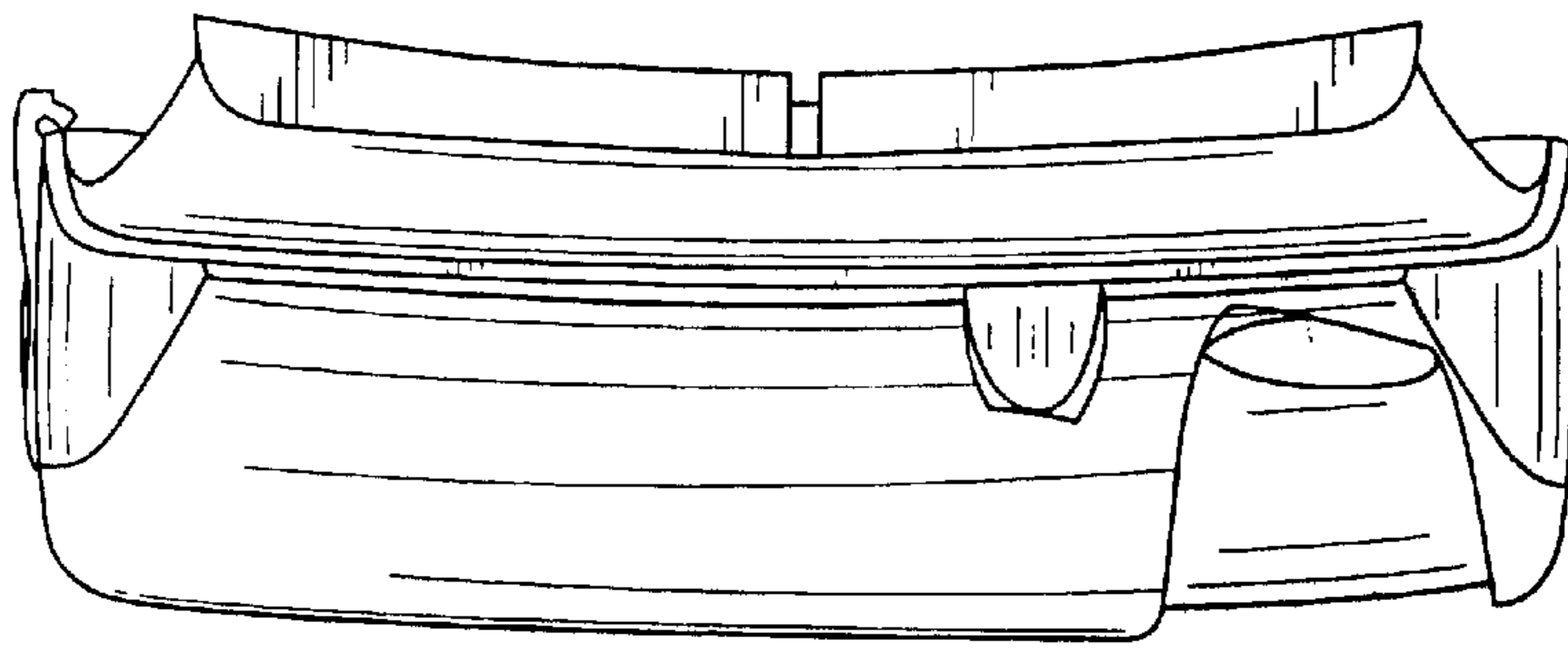

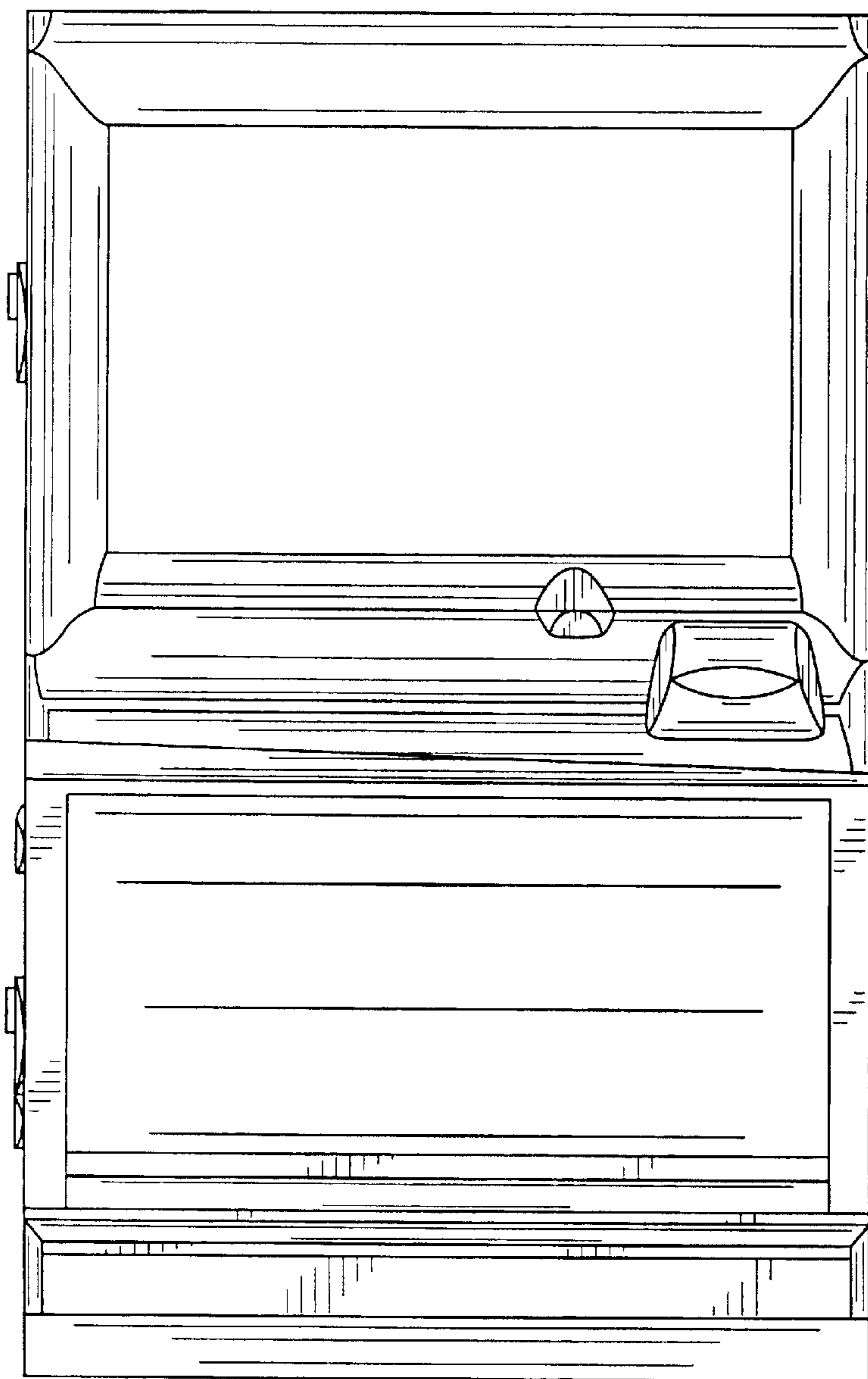

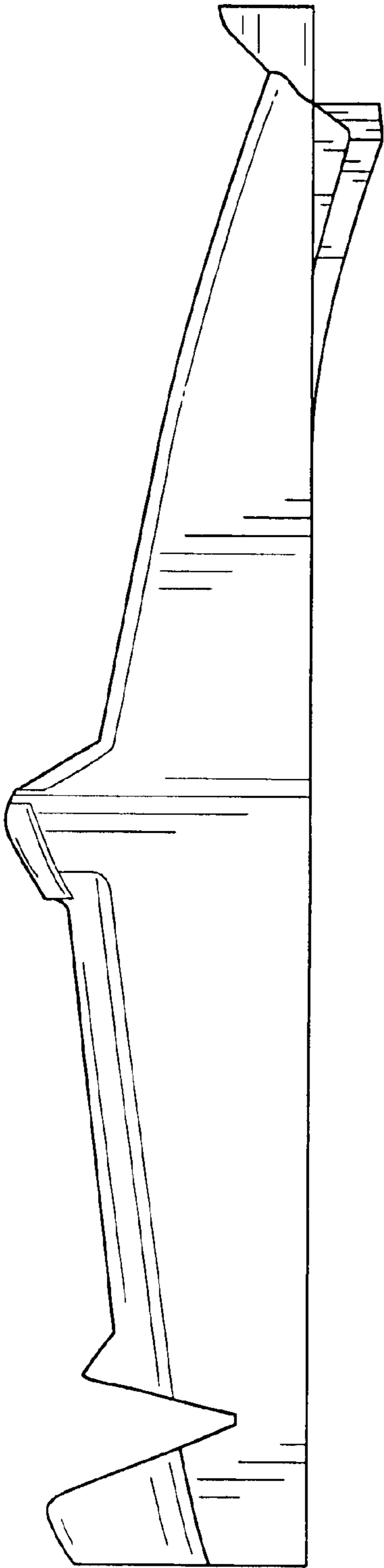

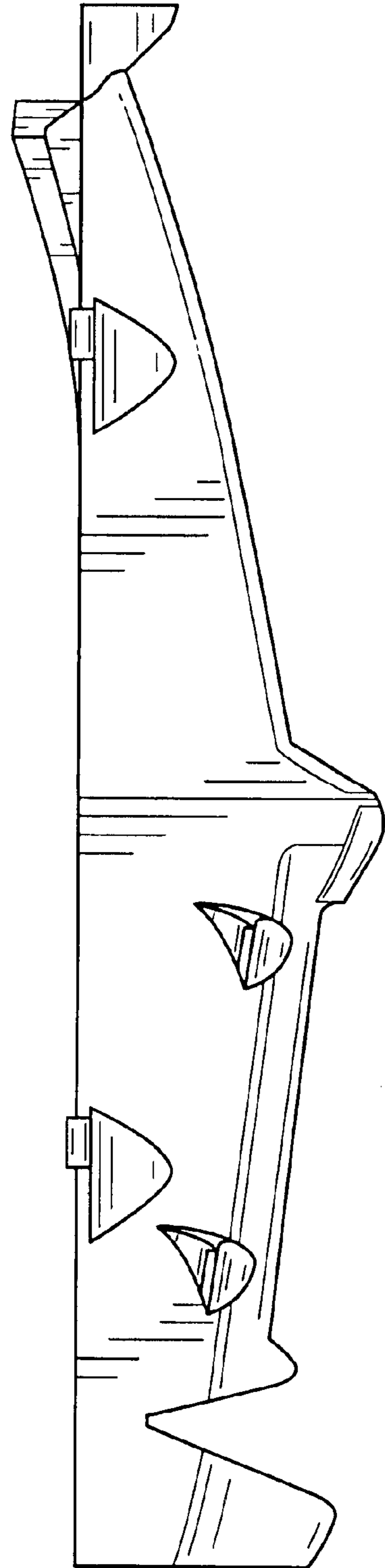
