FIG. 4 is a rear view thereof;

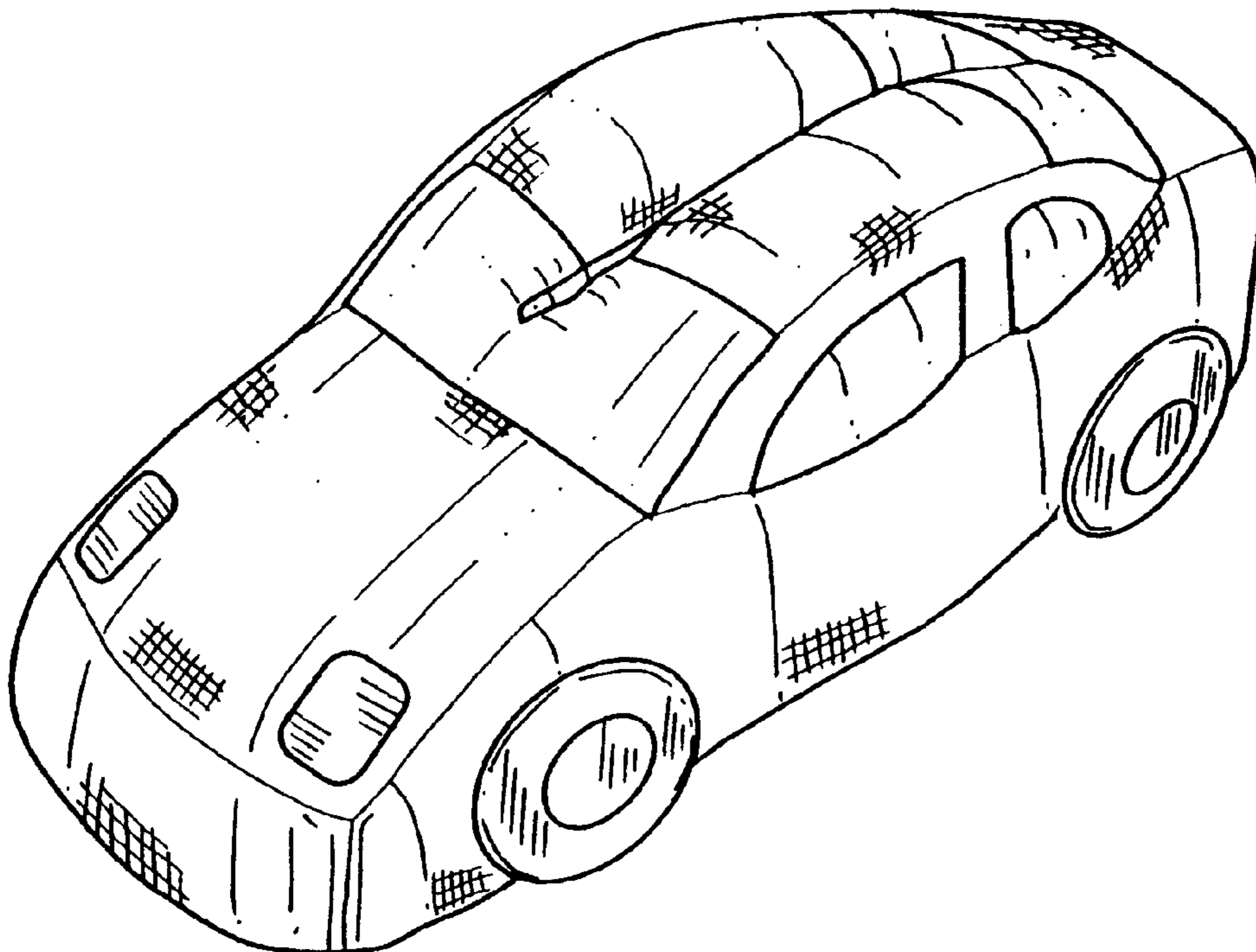
FIG. 5 is a side view thereof, the other side view being mirror image thereof;

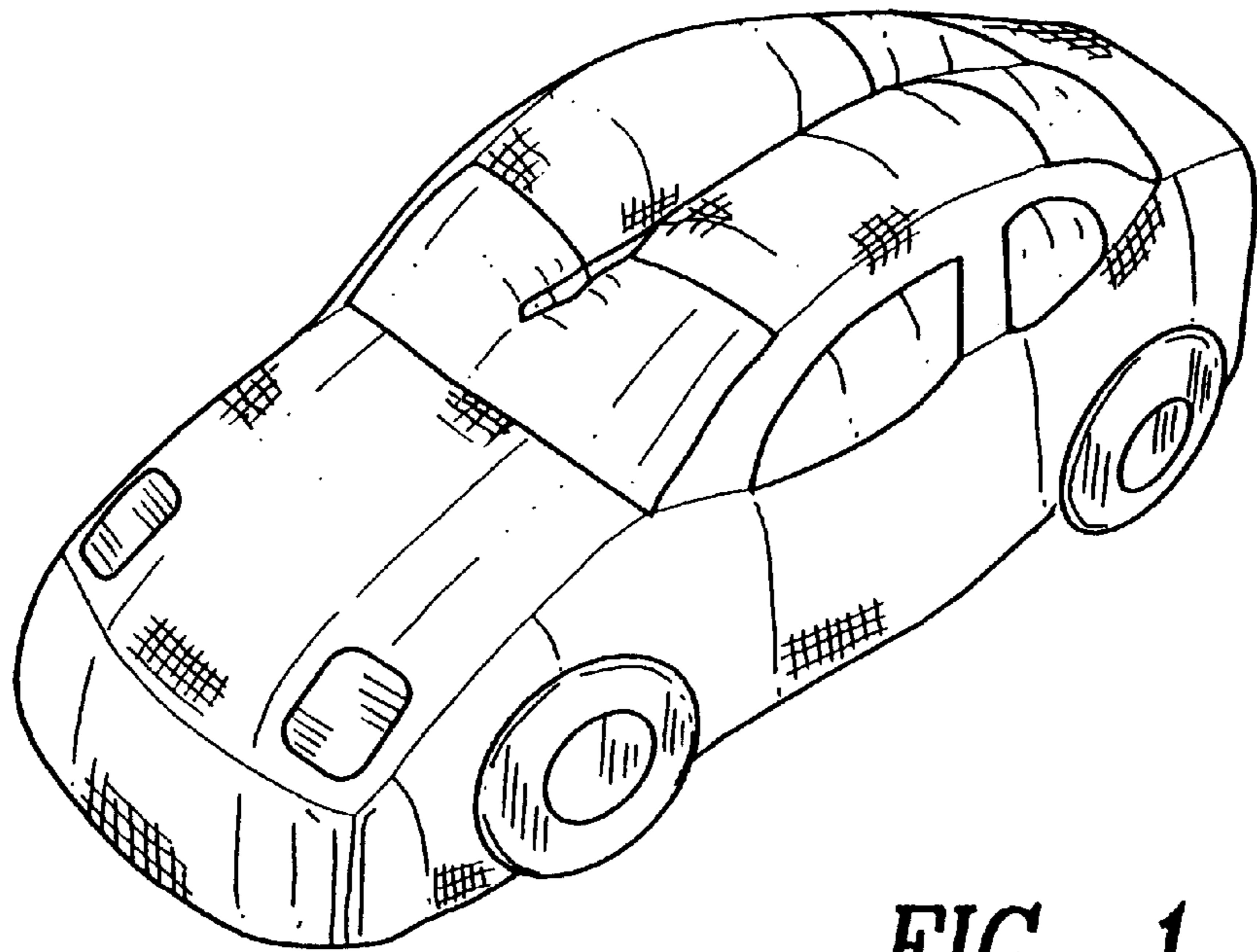

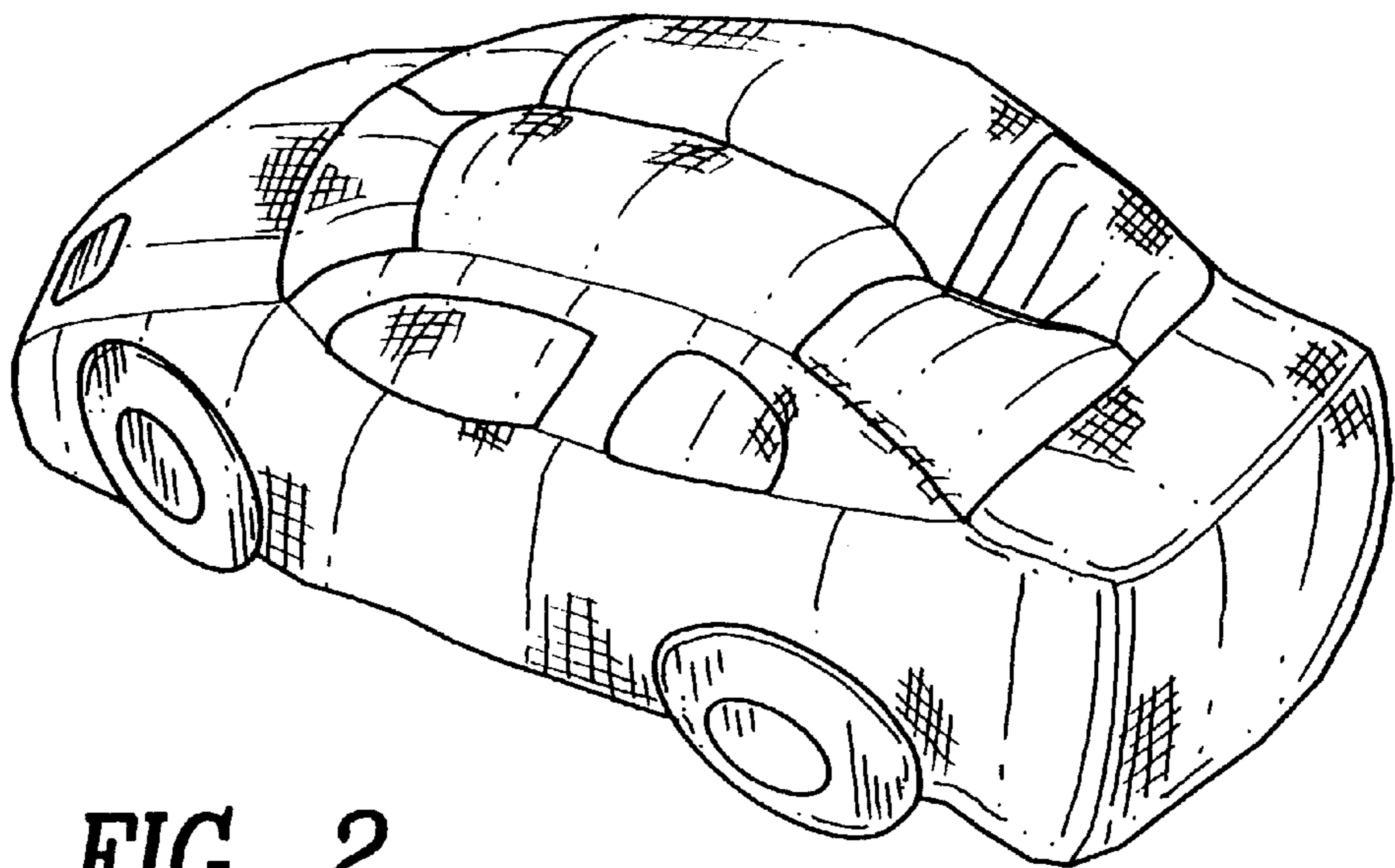

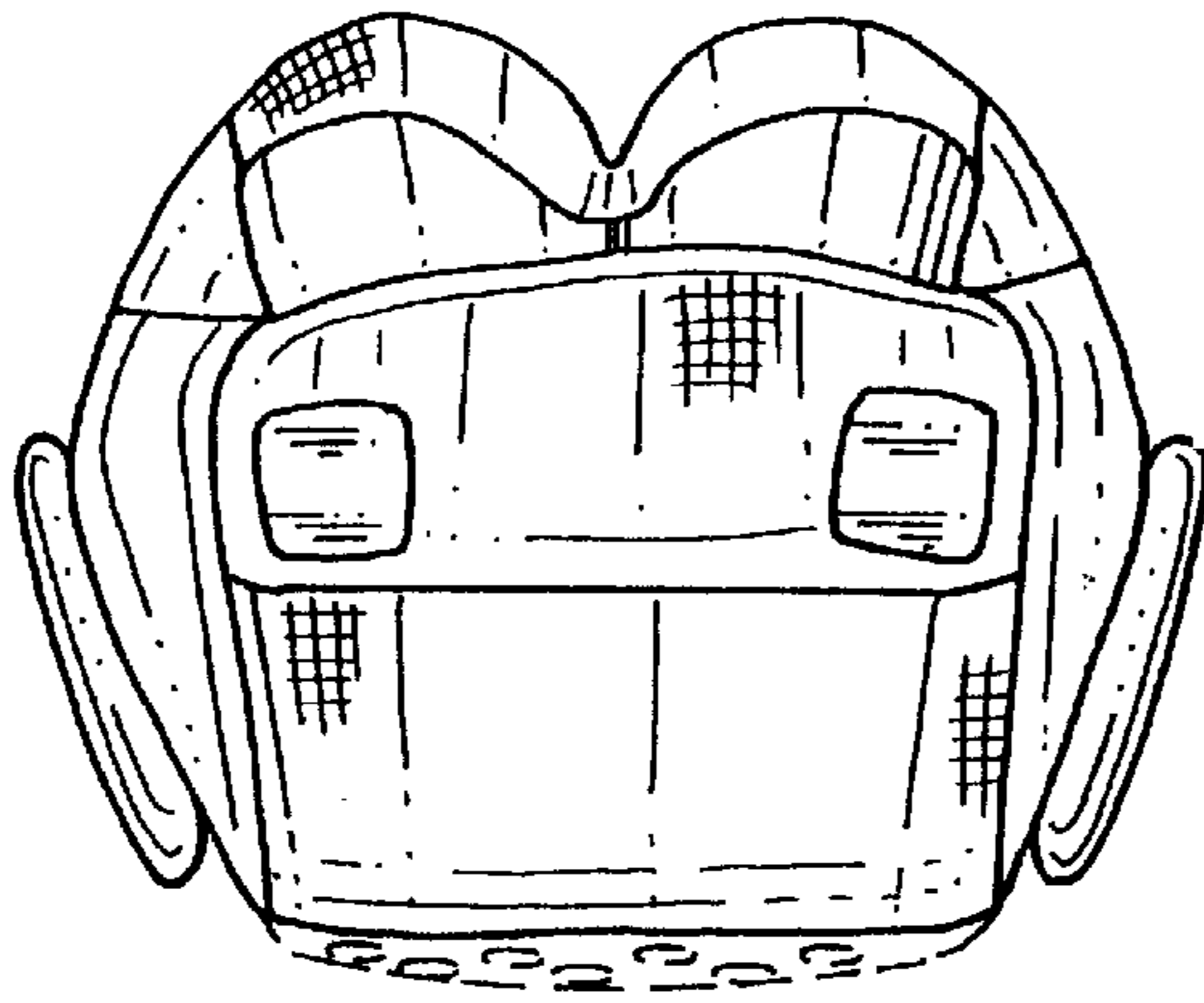

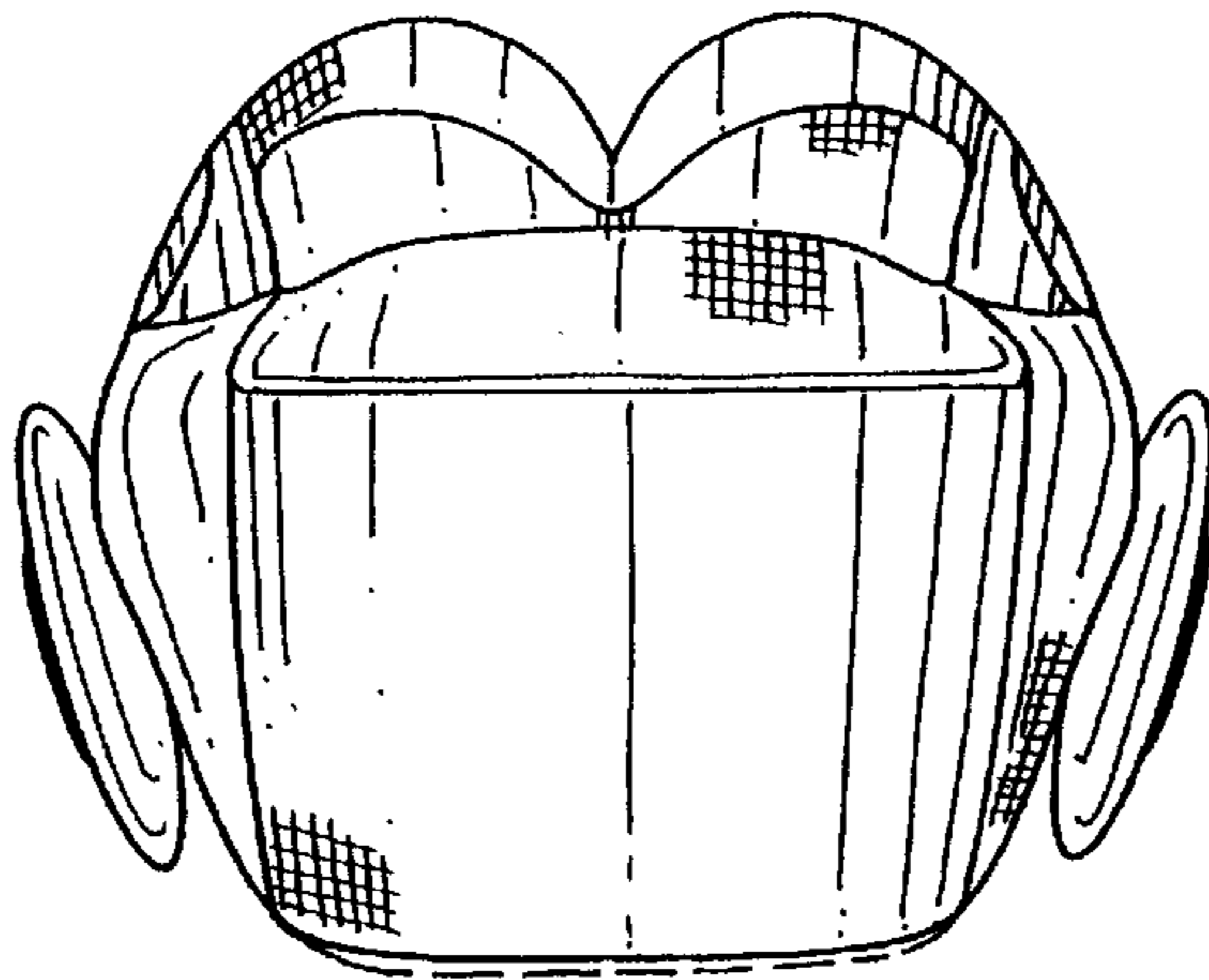

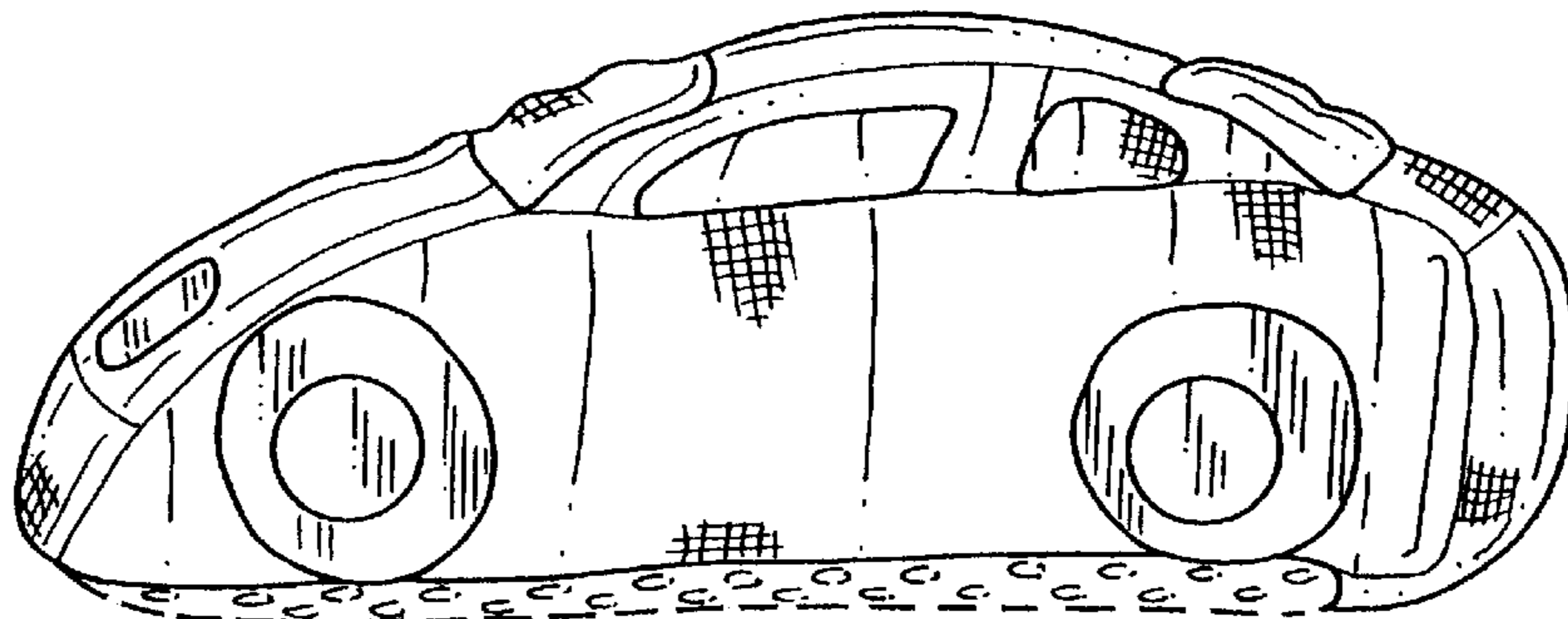

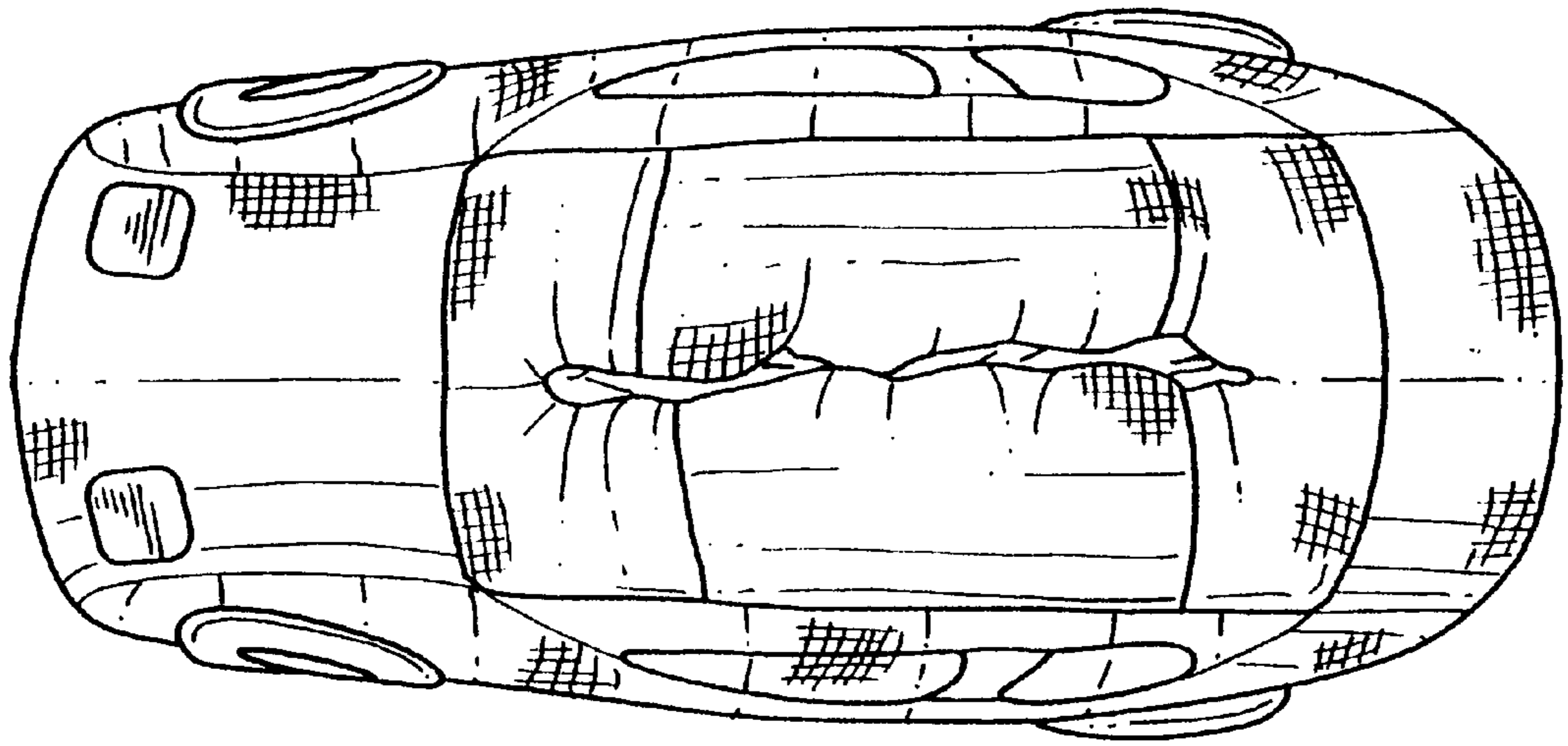

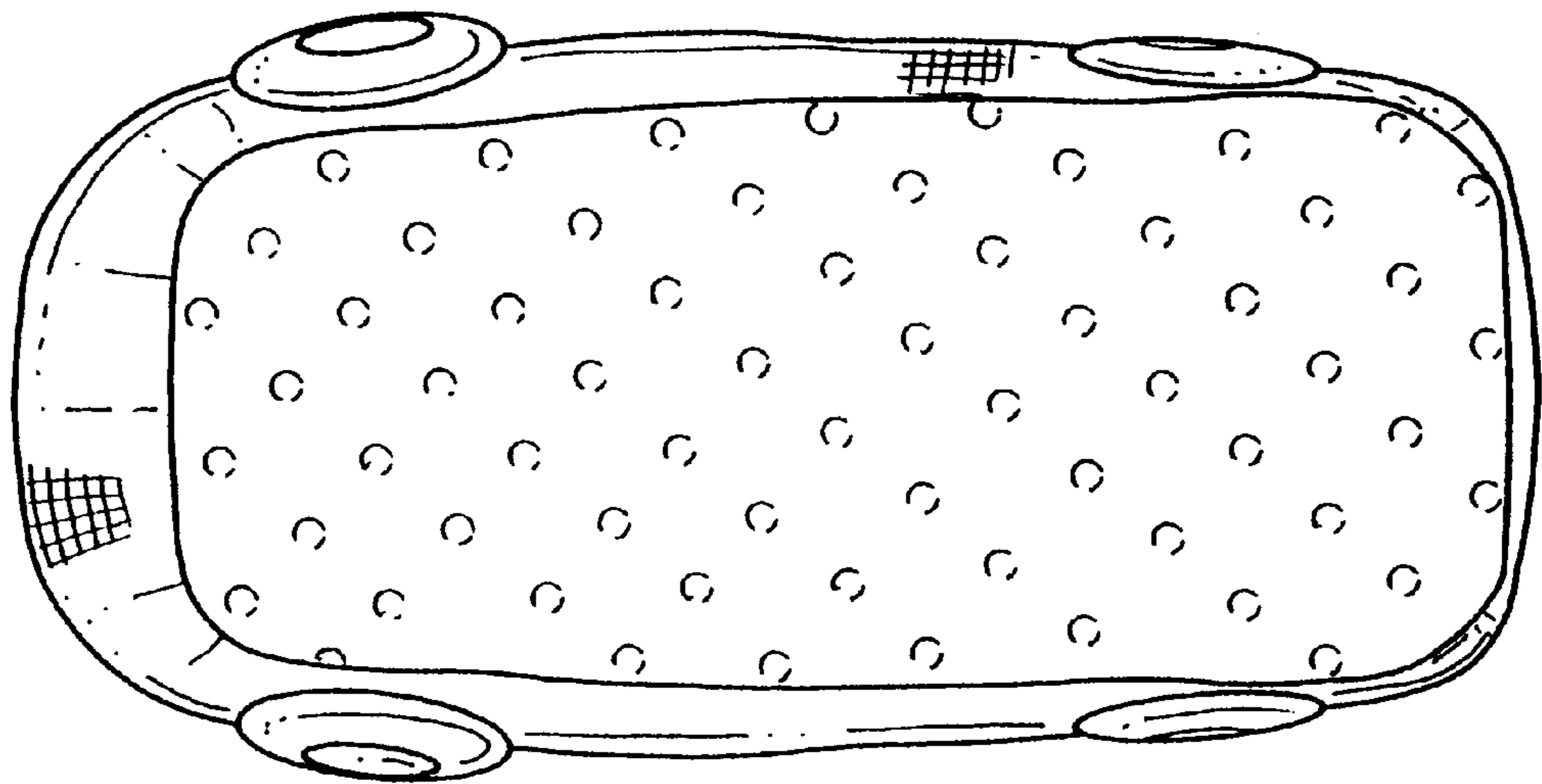
