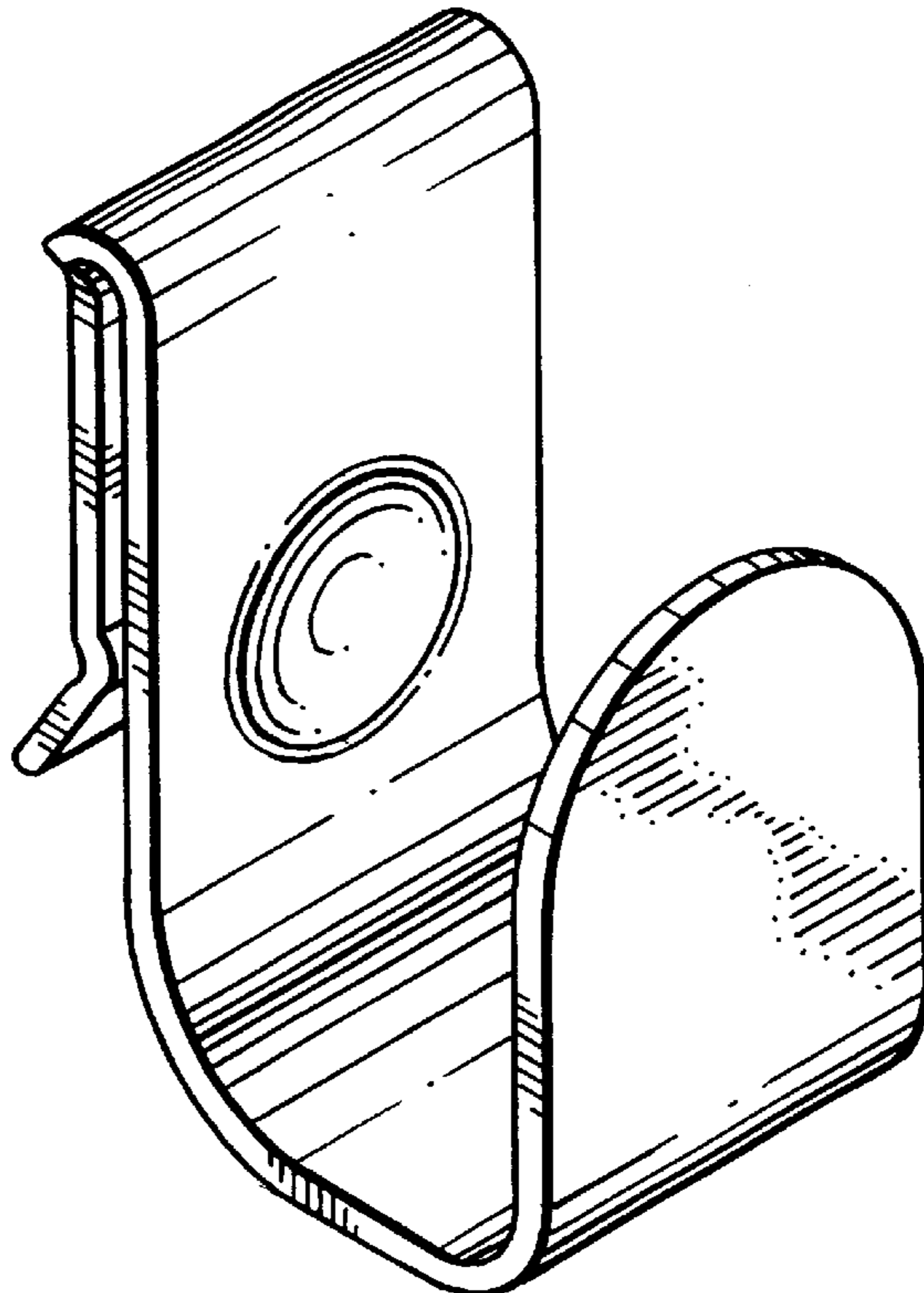

**DESCRIPTION**

FIG. 1 is a front isometric view of the applicant's clip-on golf ball holder illustrating the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a side elevational view thereof; FIG. 7 is a rear isometric view thereof; and, FIG. 8 is a front isometric view of a second embodiment of the design including a pair of golf tee holders and a ball marker holder.

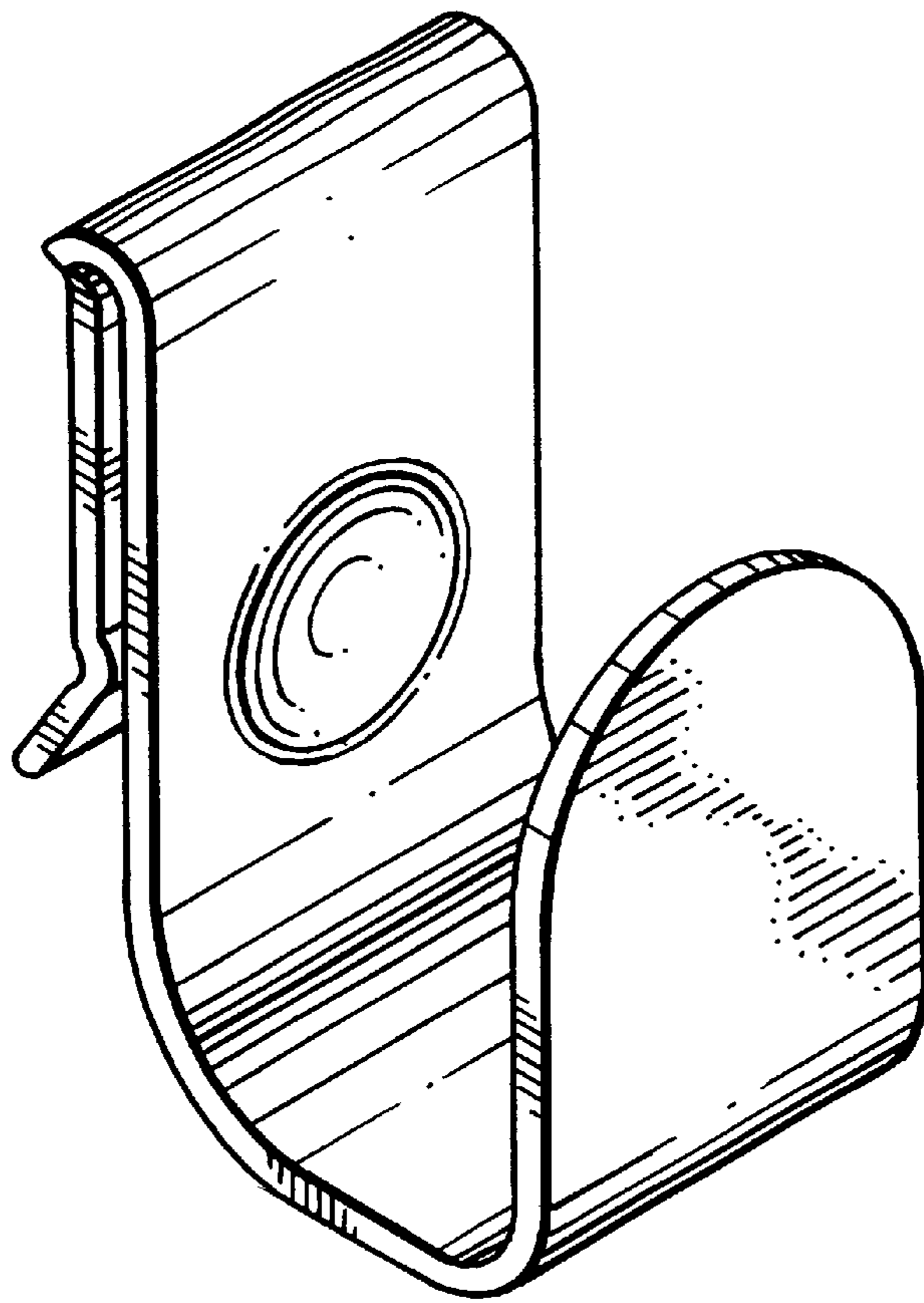

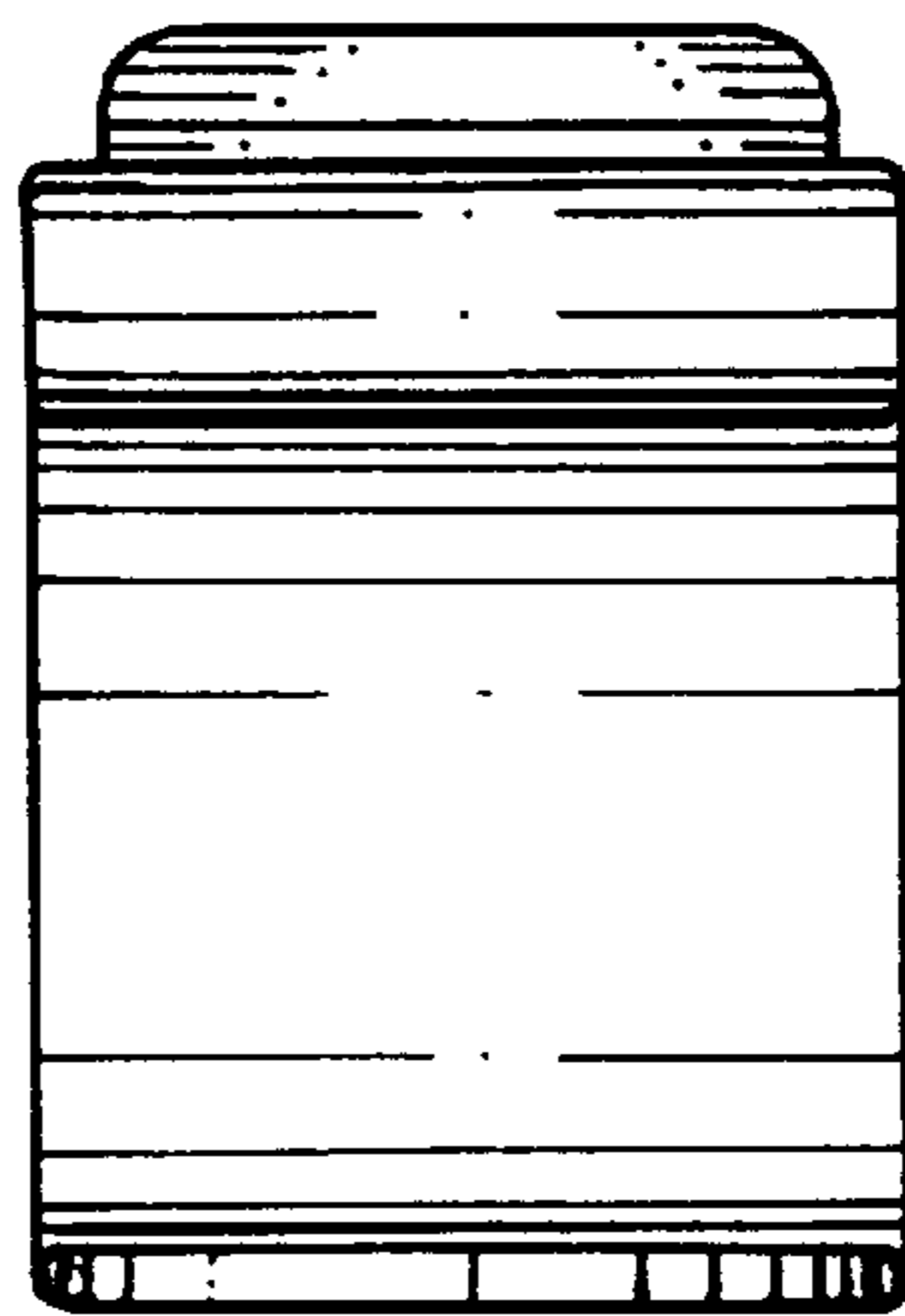

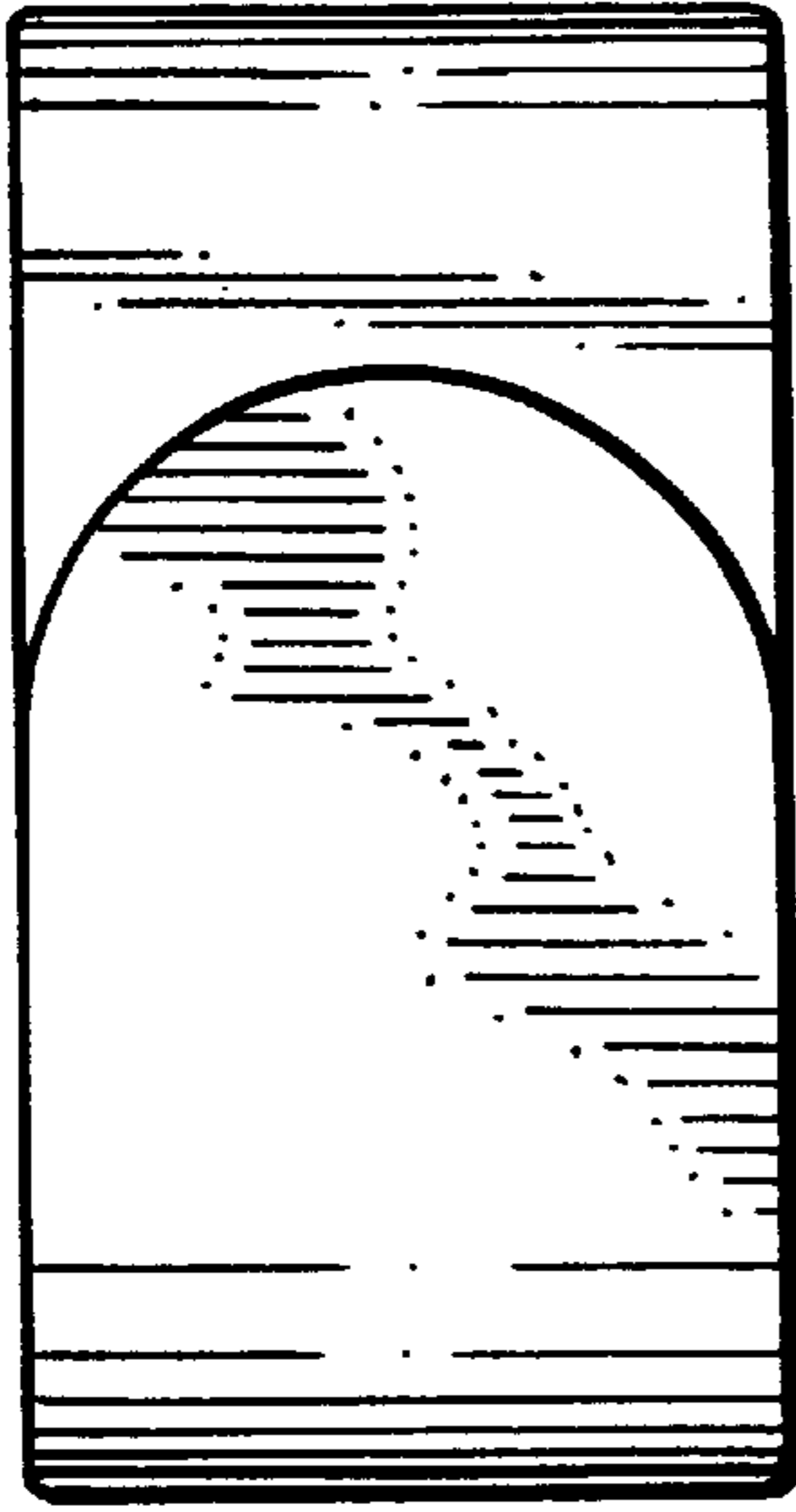

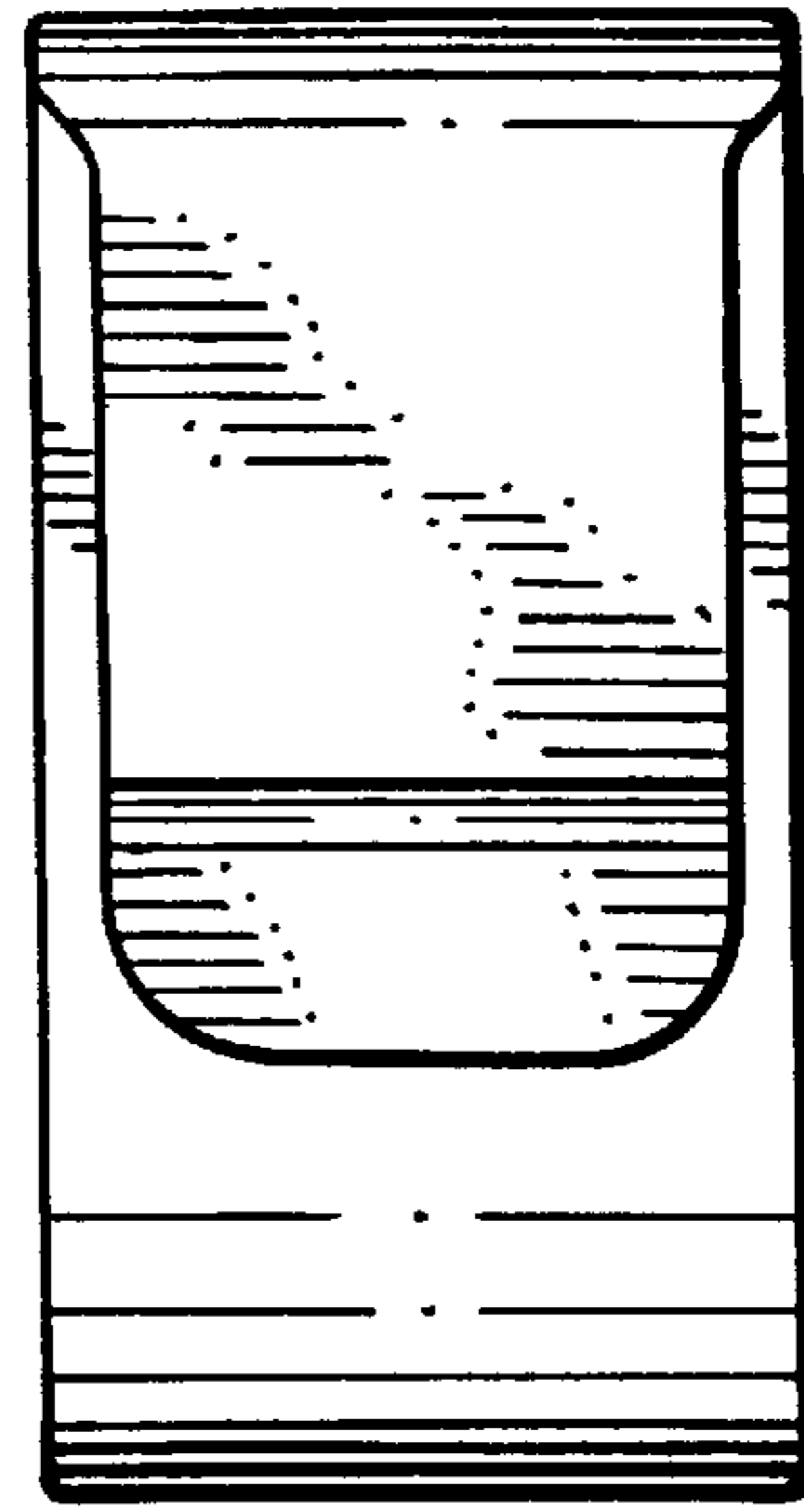

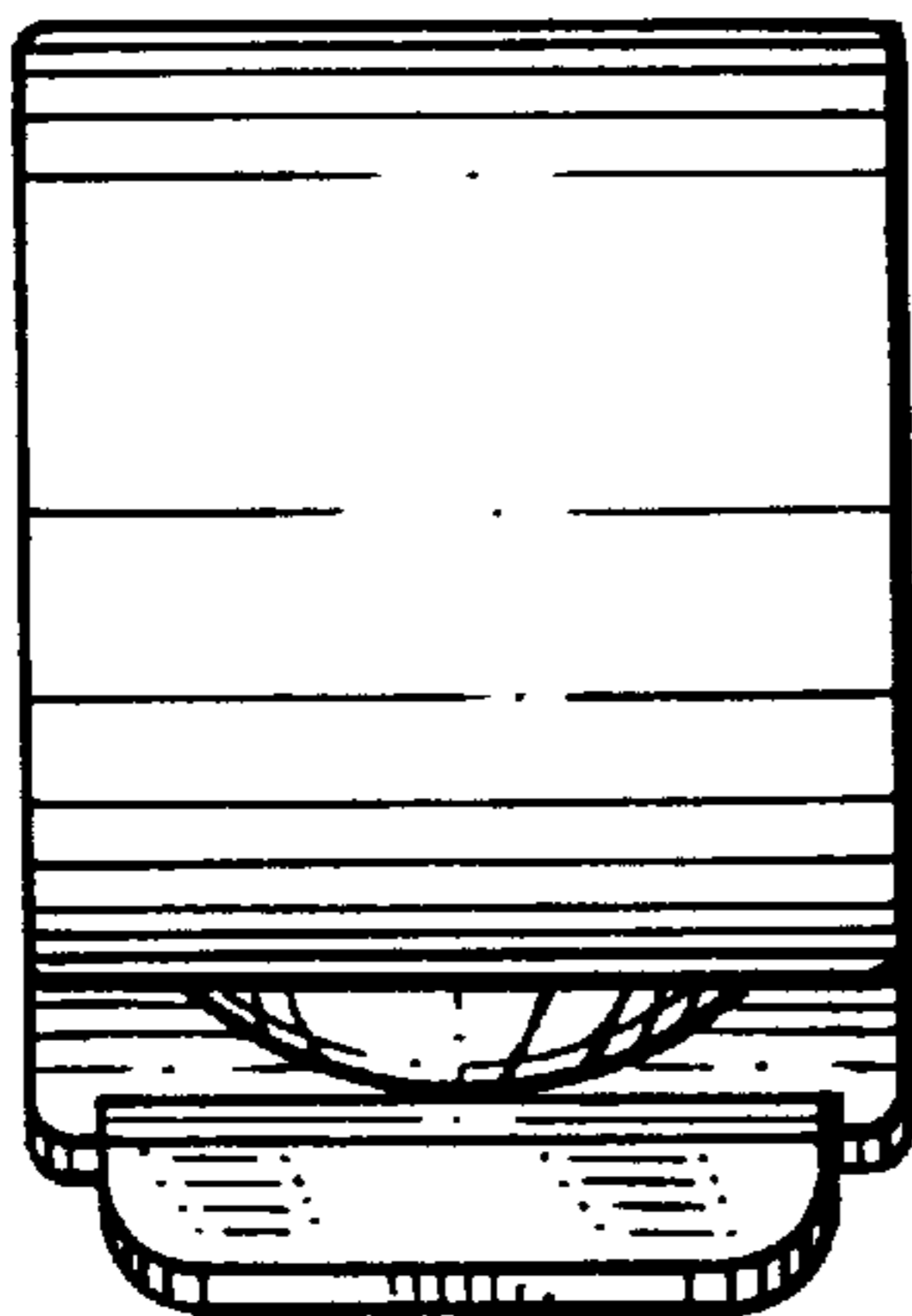

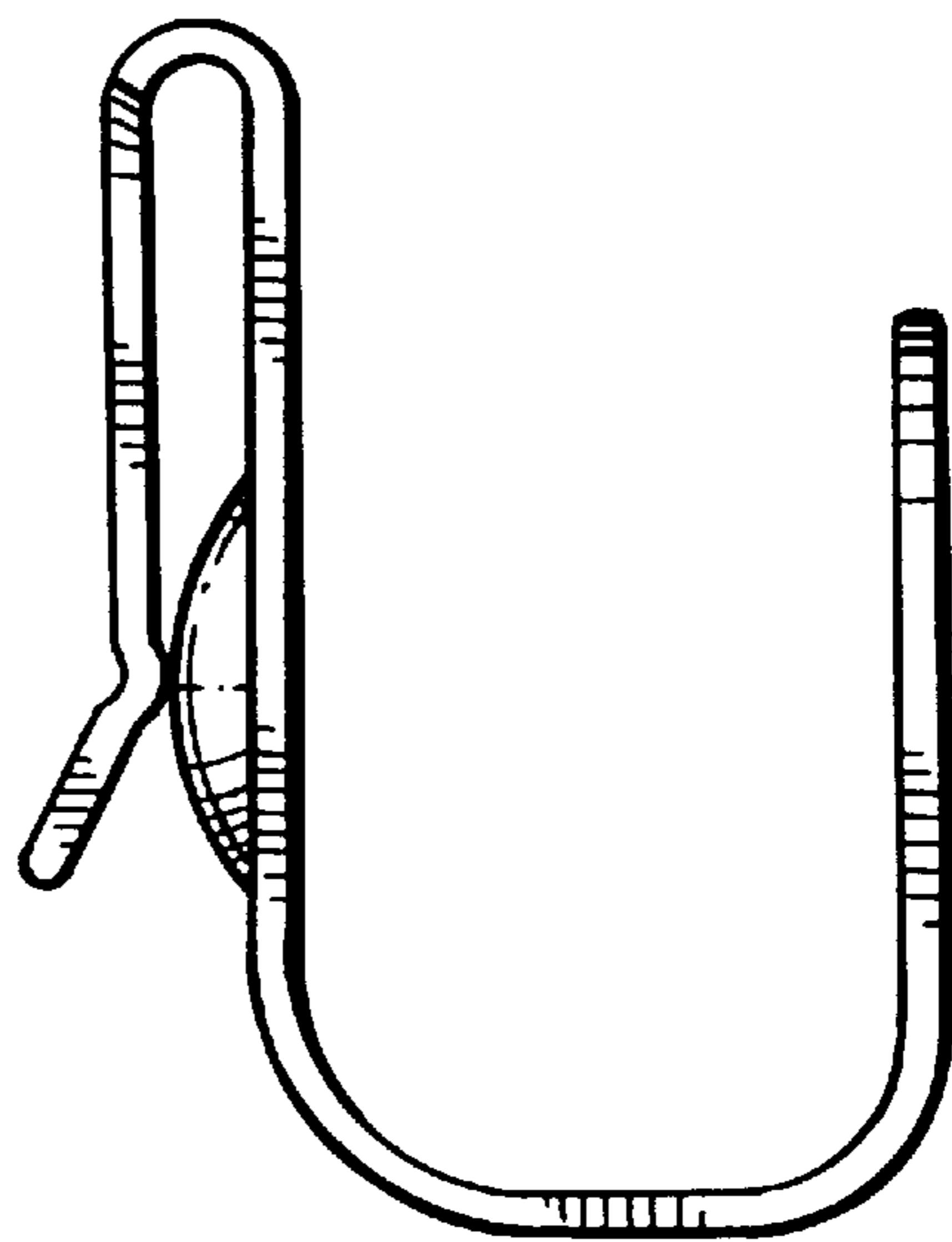

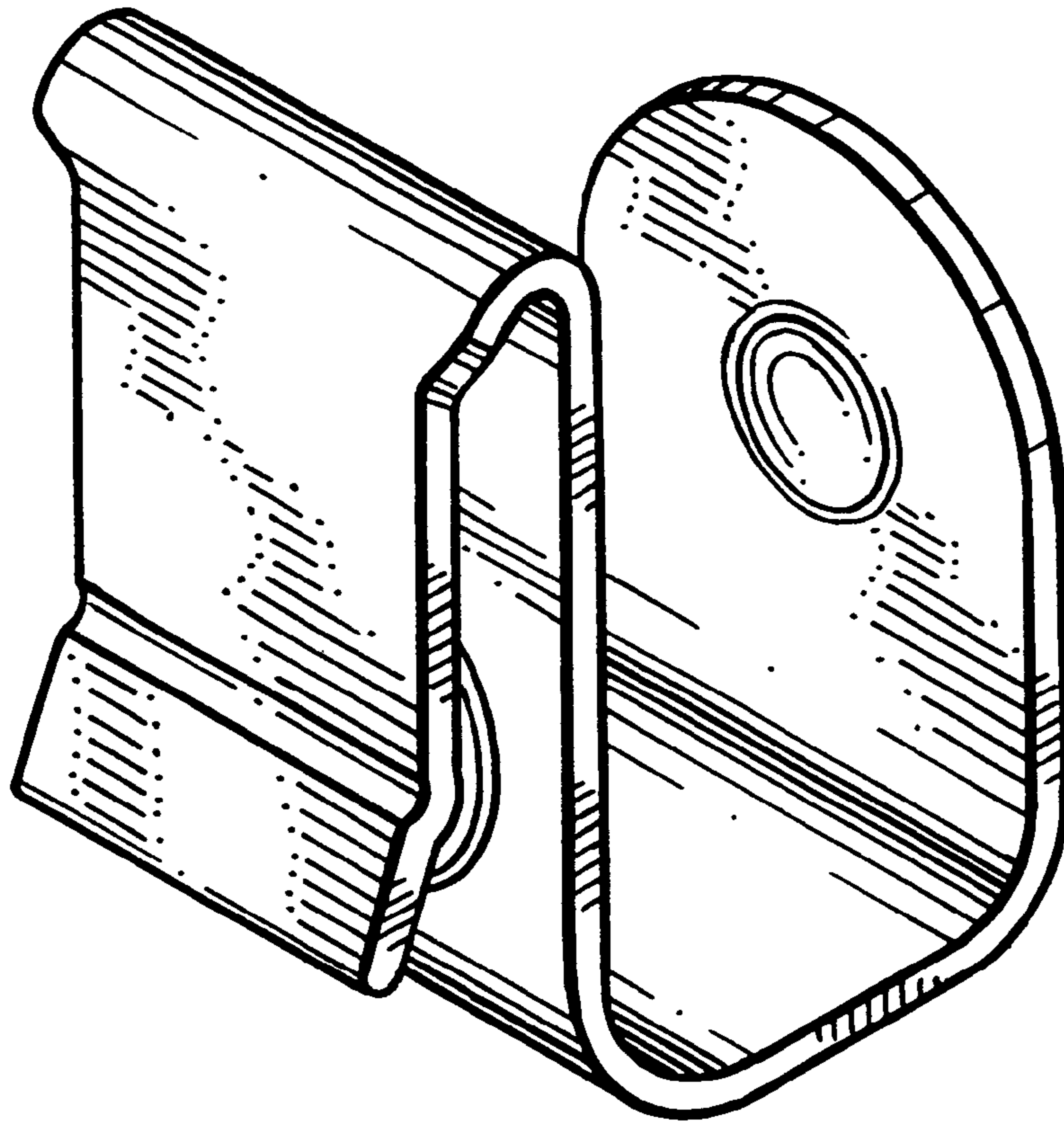

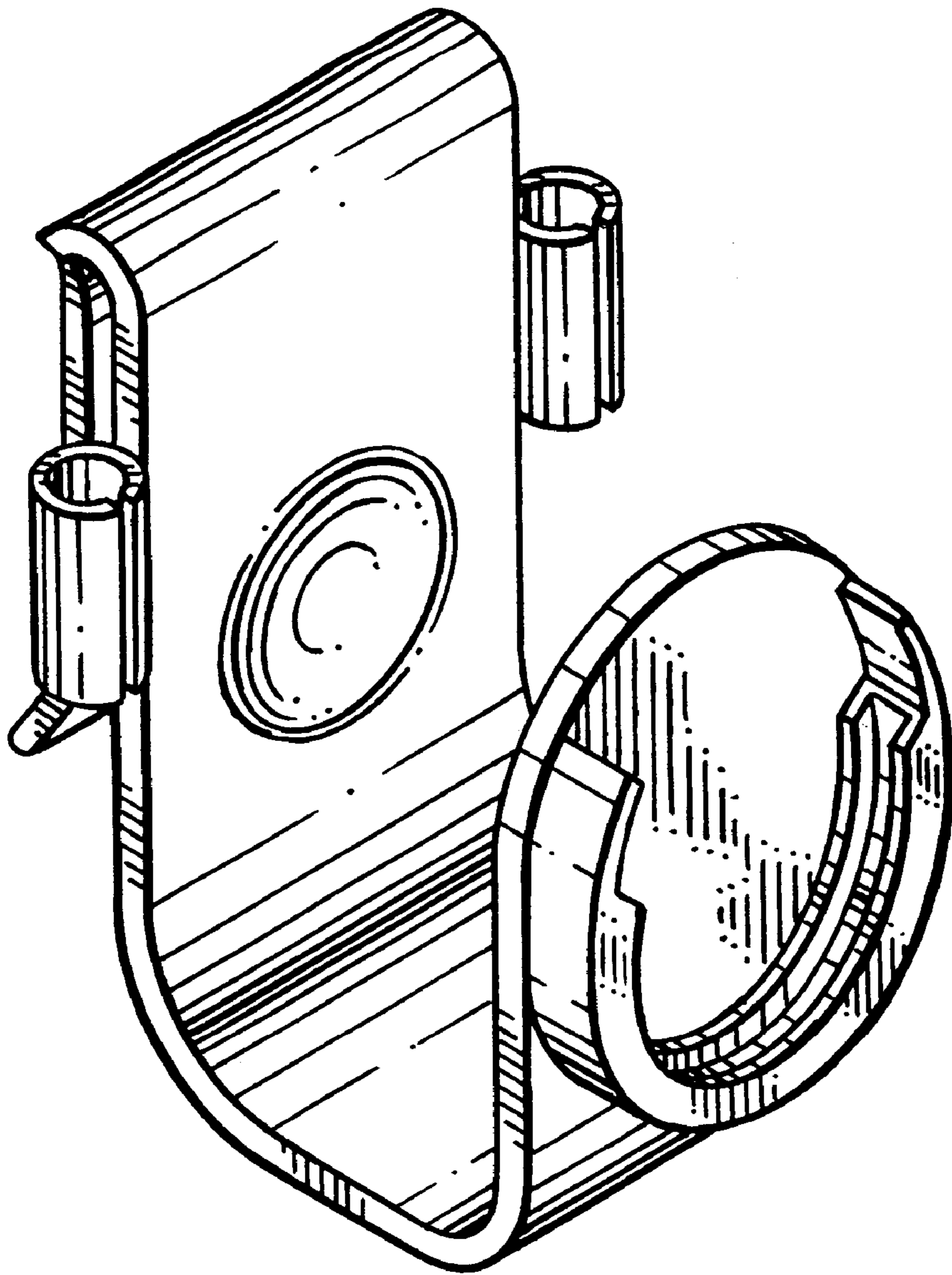
