(57) **CLAIM**

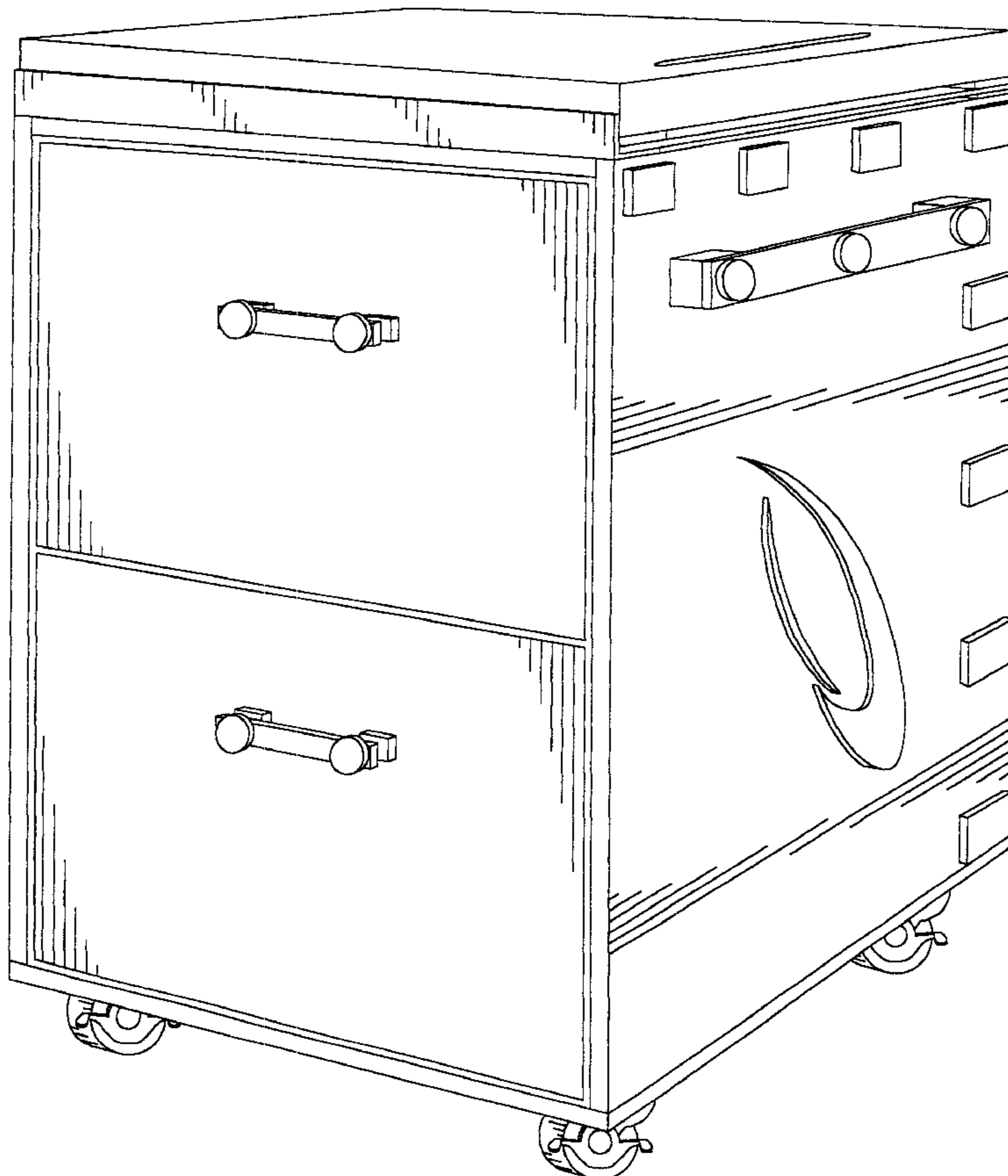
The ornamental design for a double butcher block storage island, as shown and described.

DESCRIPTION

FIG. 1 is a fully assembled perspective view of a double butcher block storage island showing the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is a exploded perspective view.

The broken line showing the bracket in FIG. 5 is for illustrative purposes and forms no part of the claimed design.

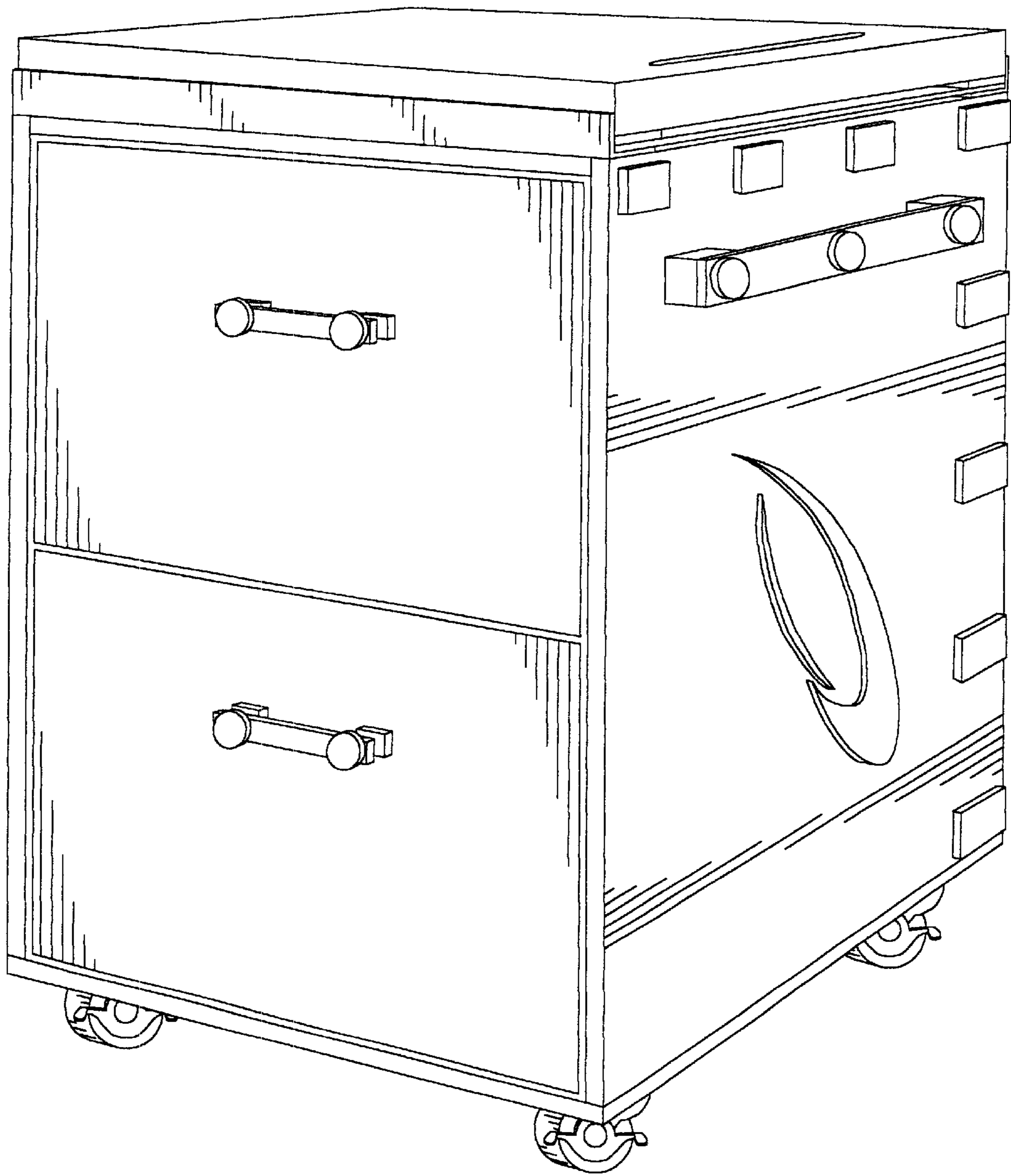

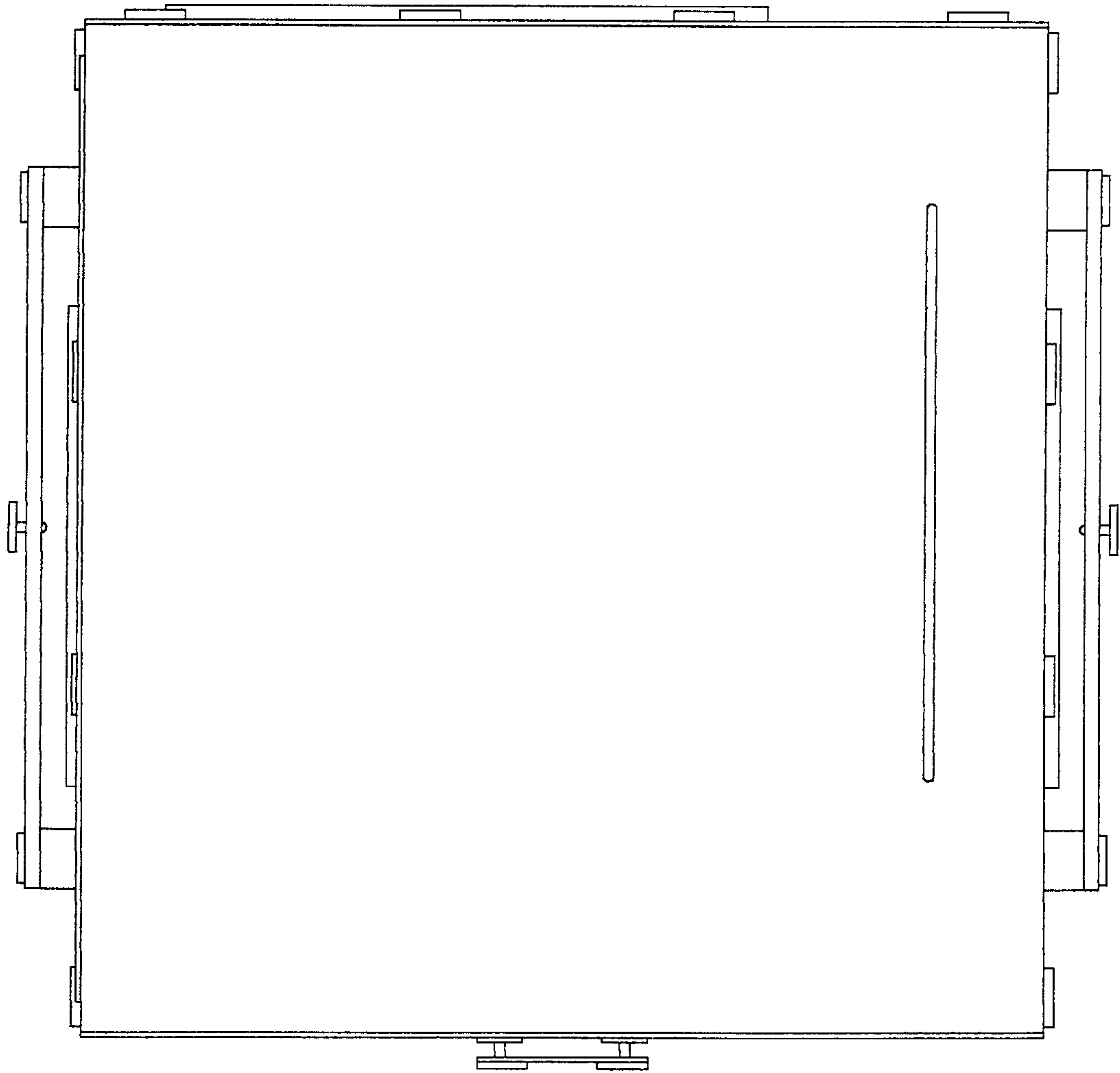

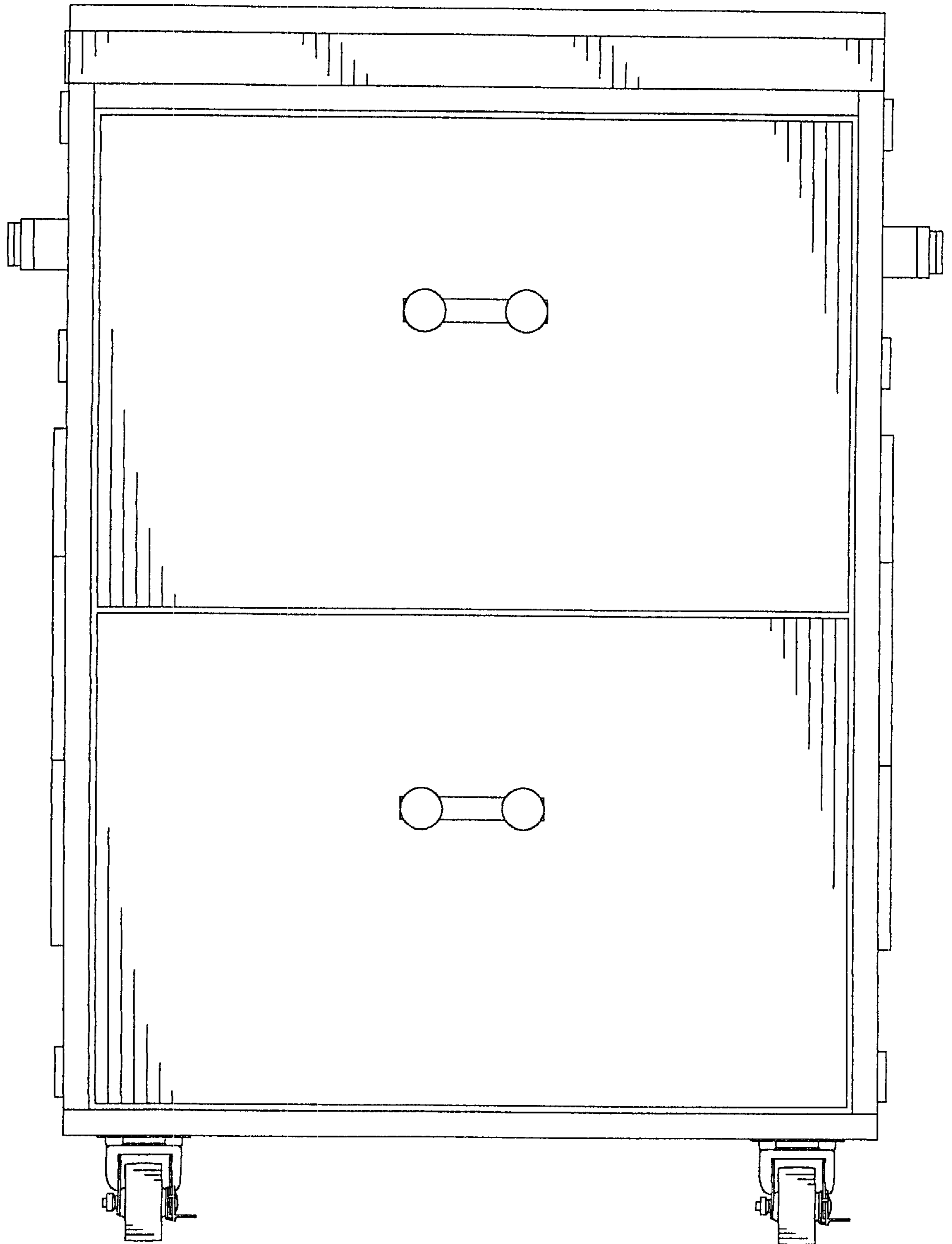

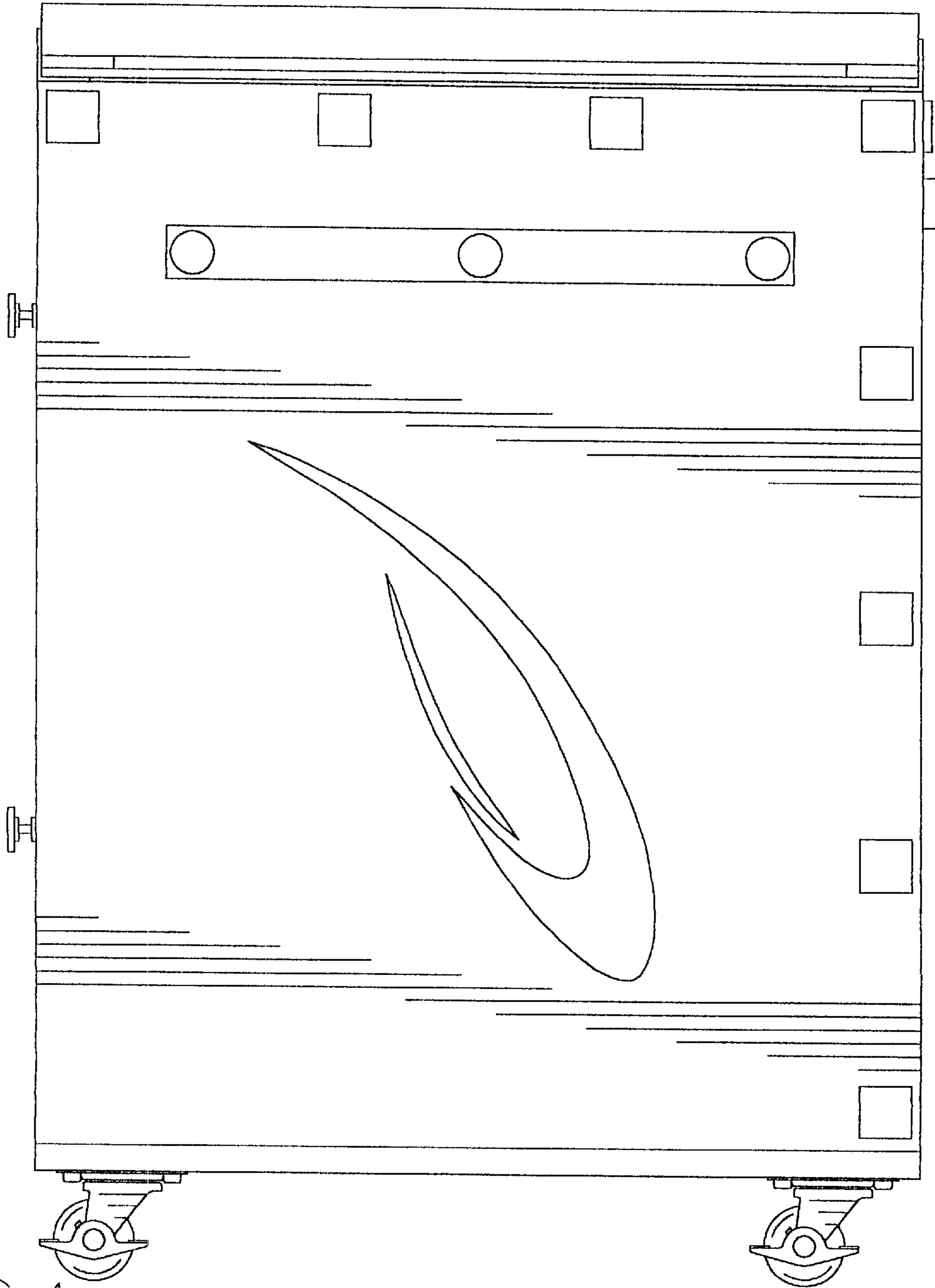

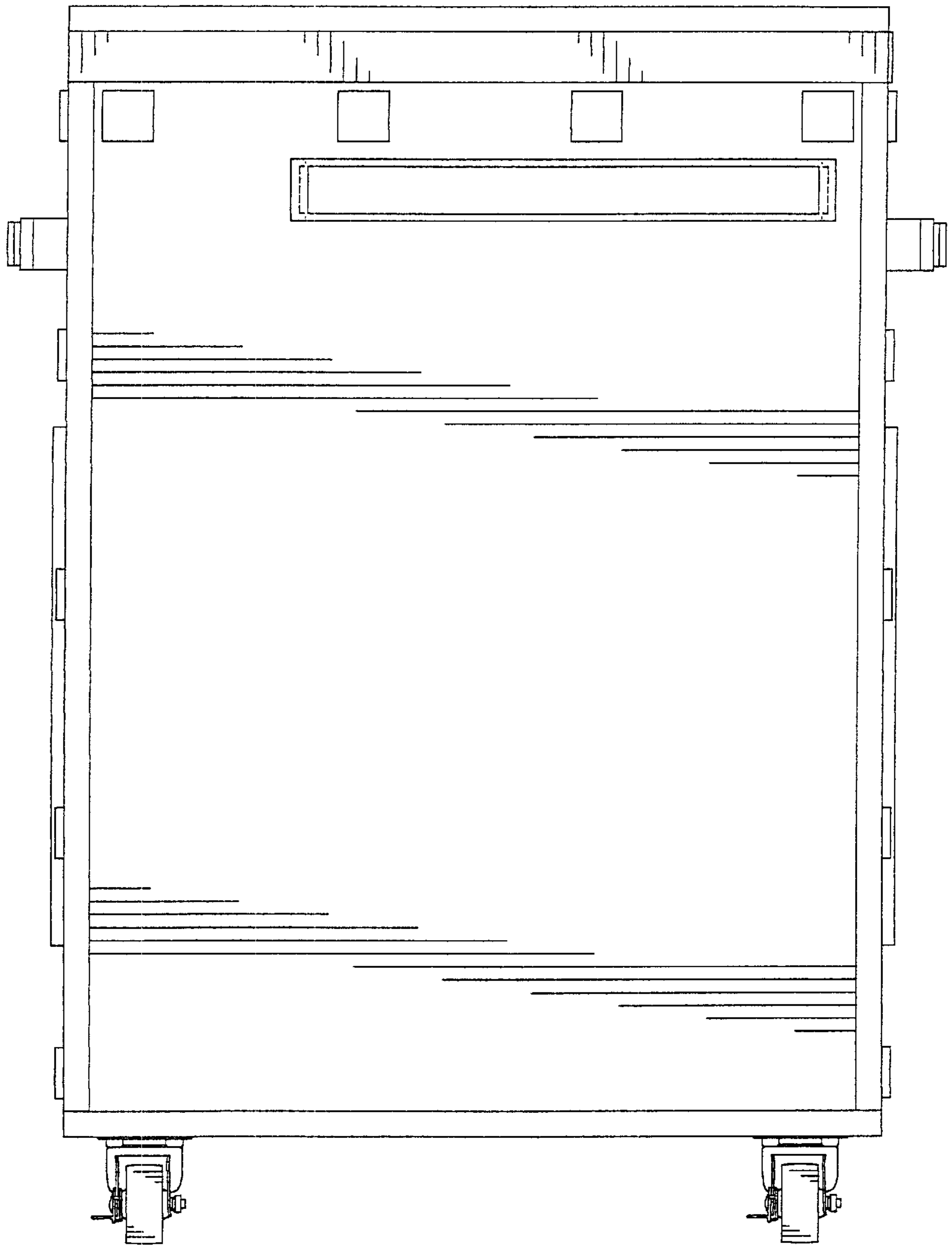

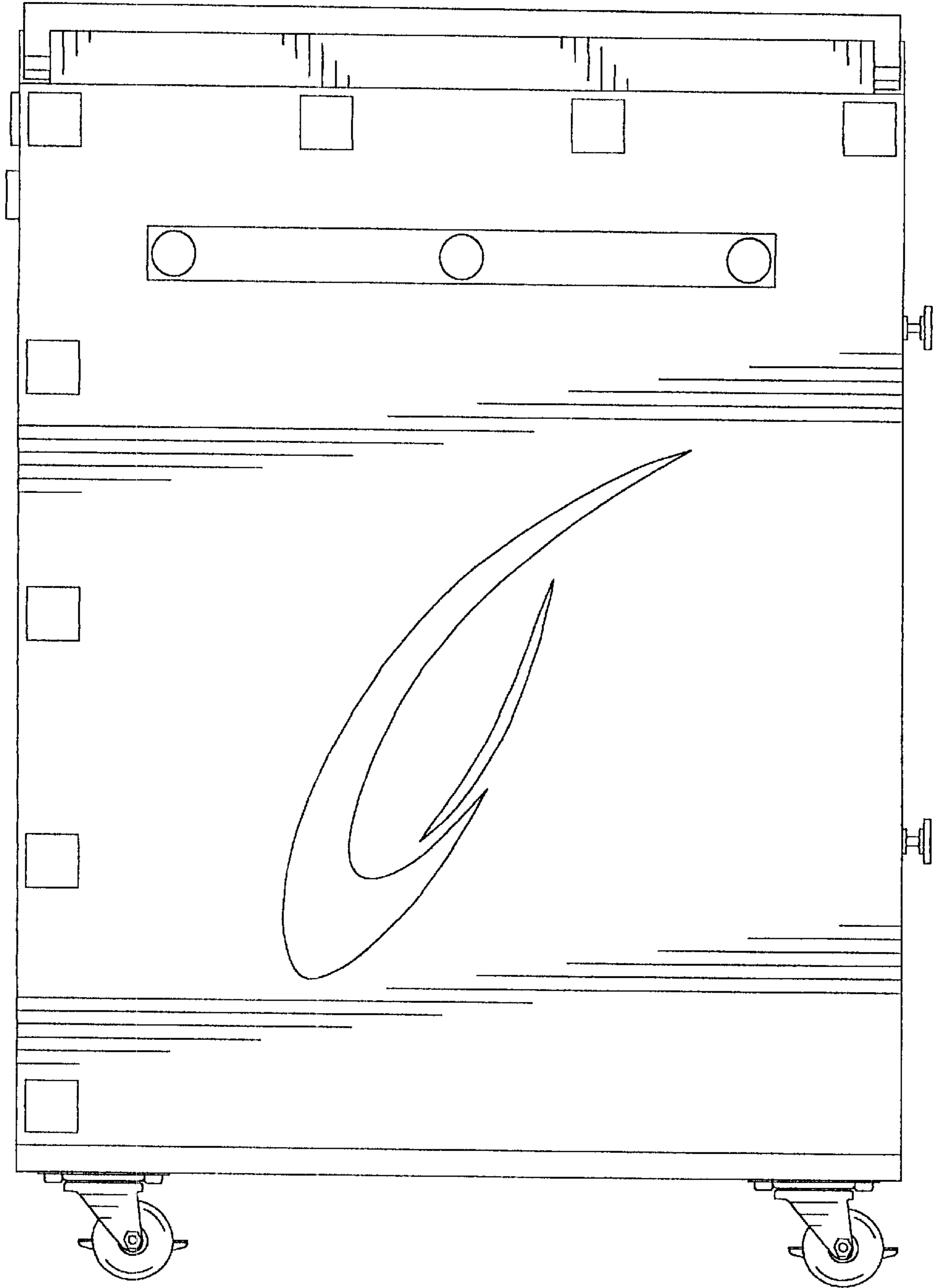

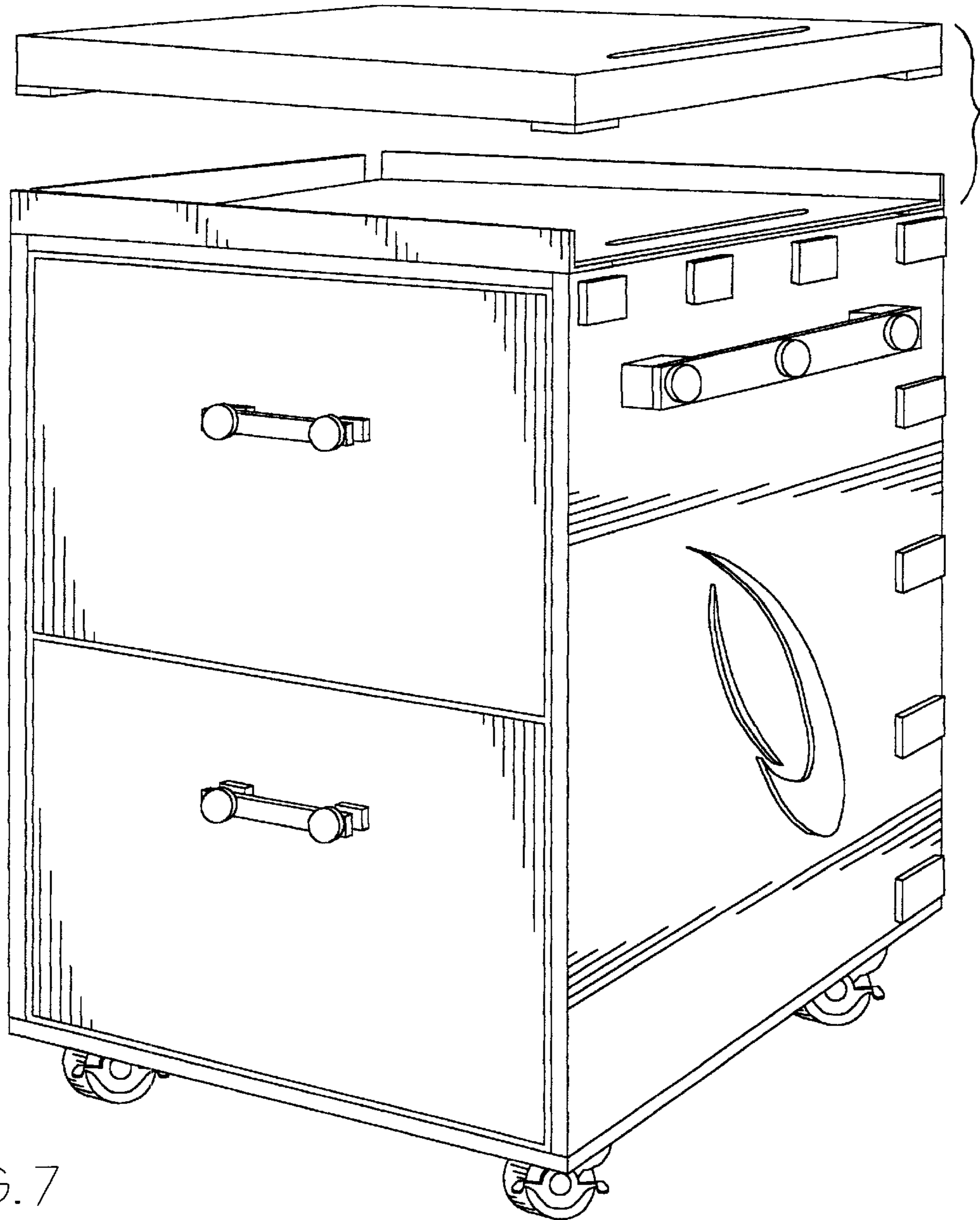
