in the closed, self-covering position;

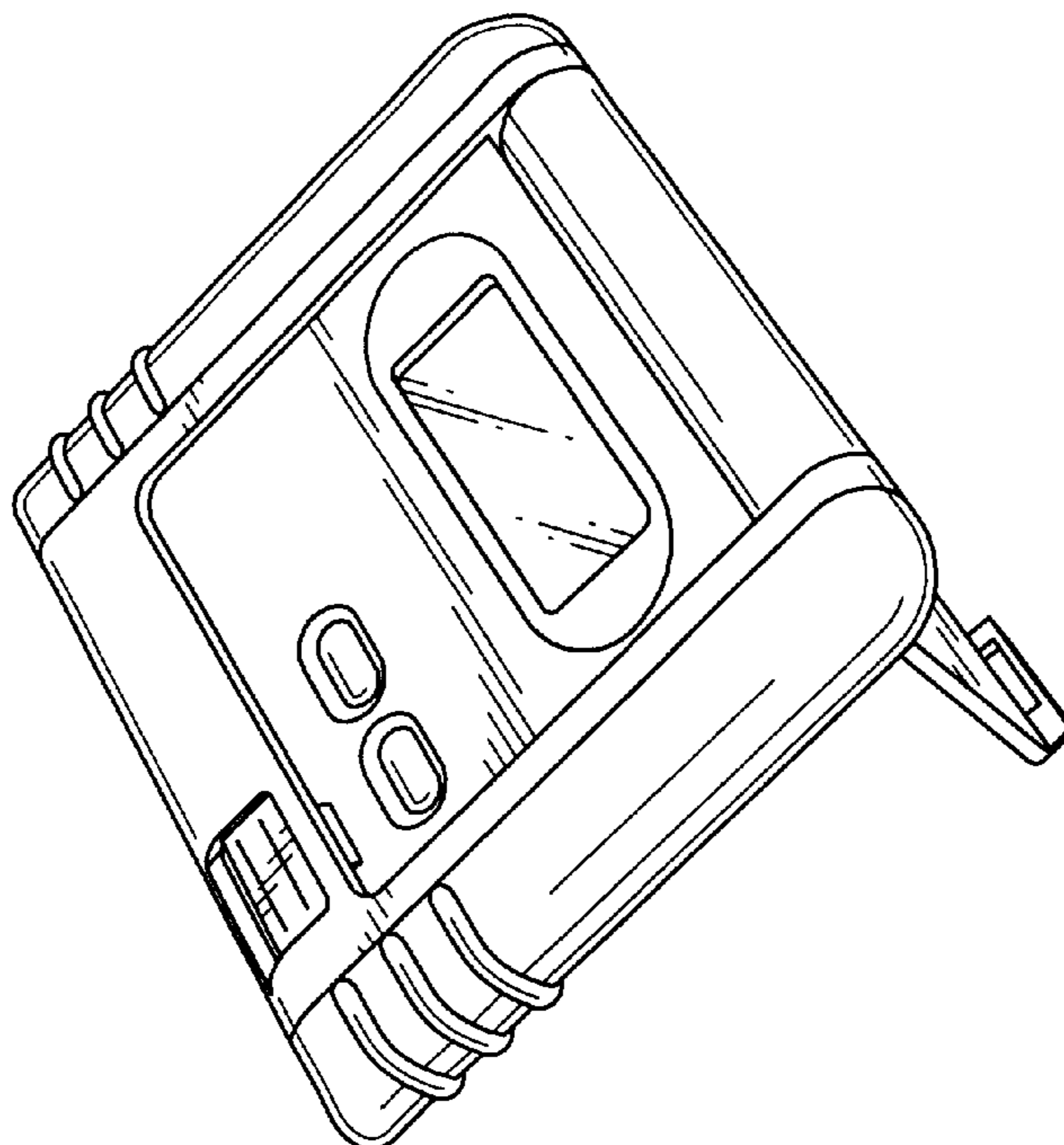
FIG. 9 is an elevational view from one side thereof with its

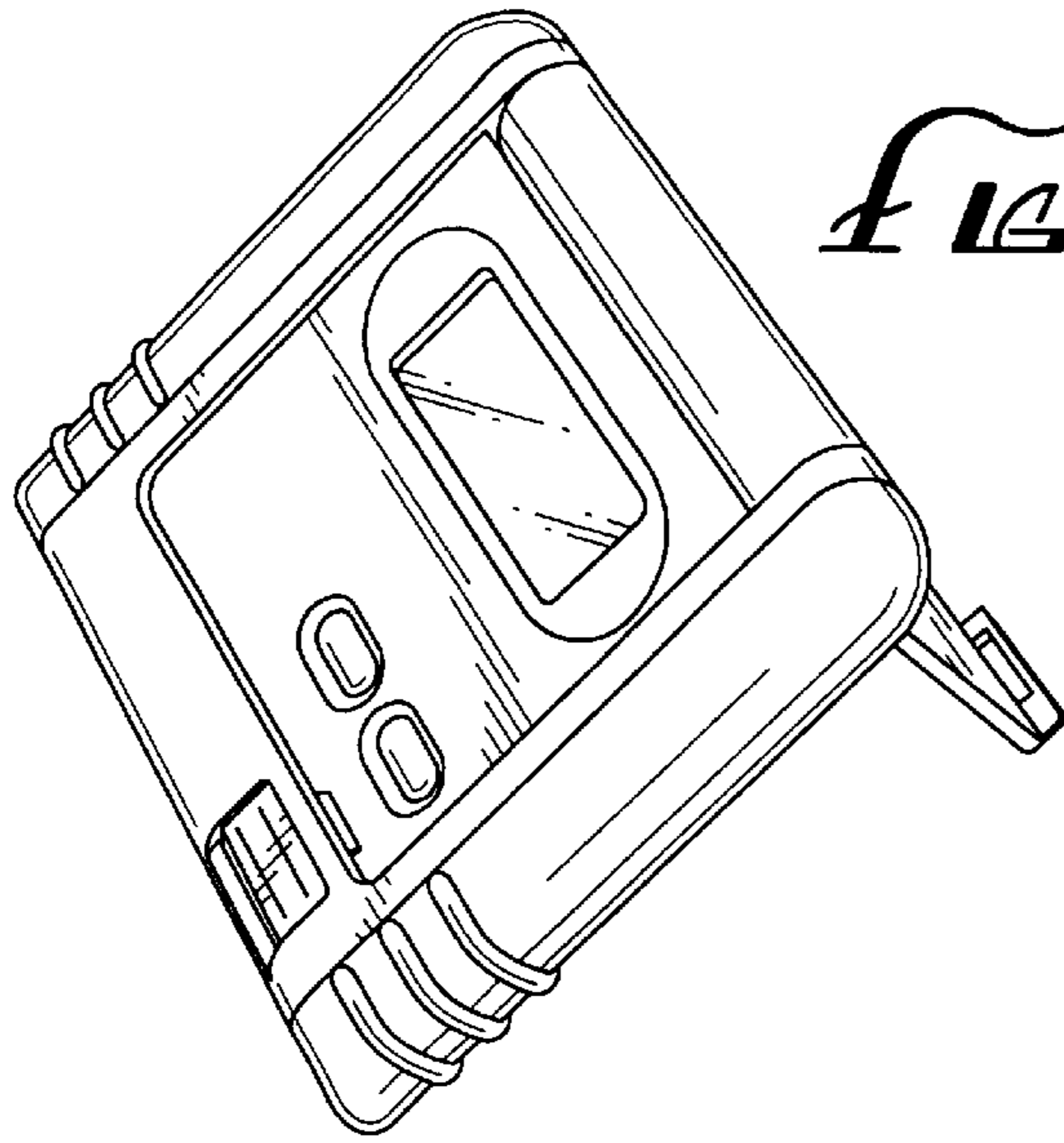

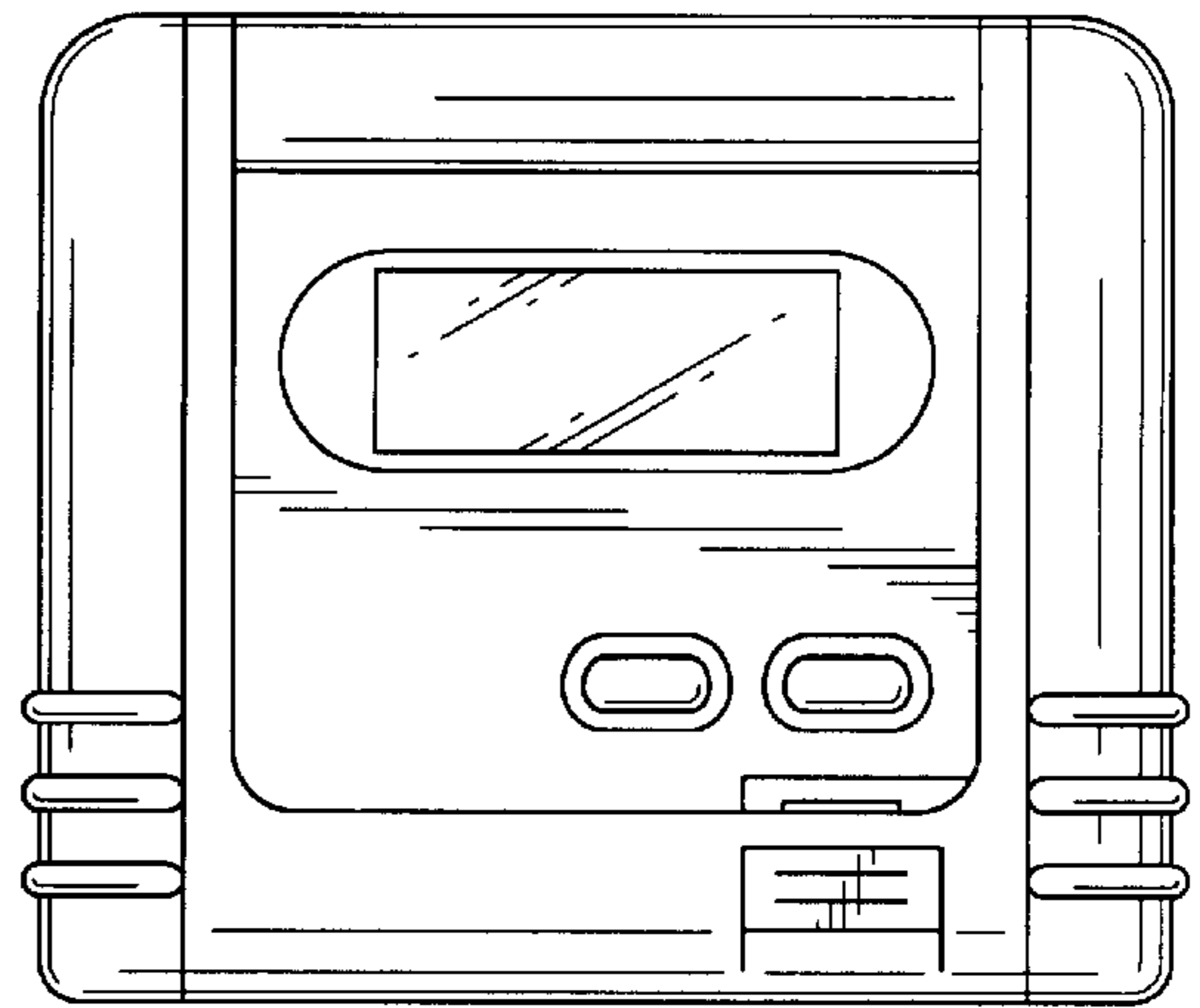

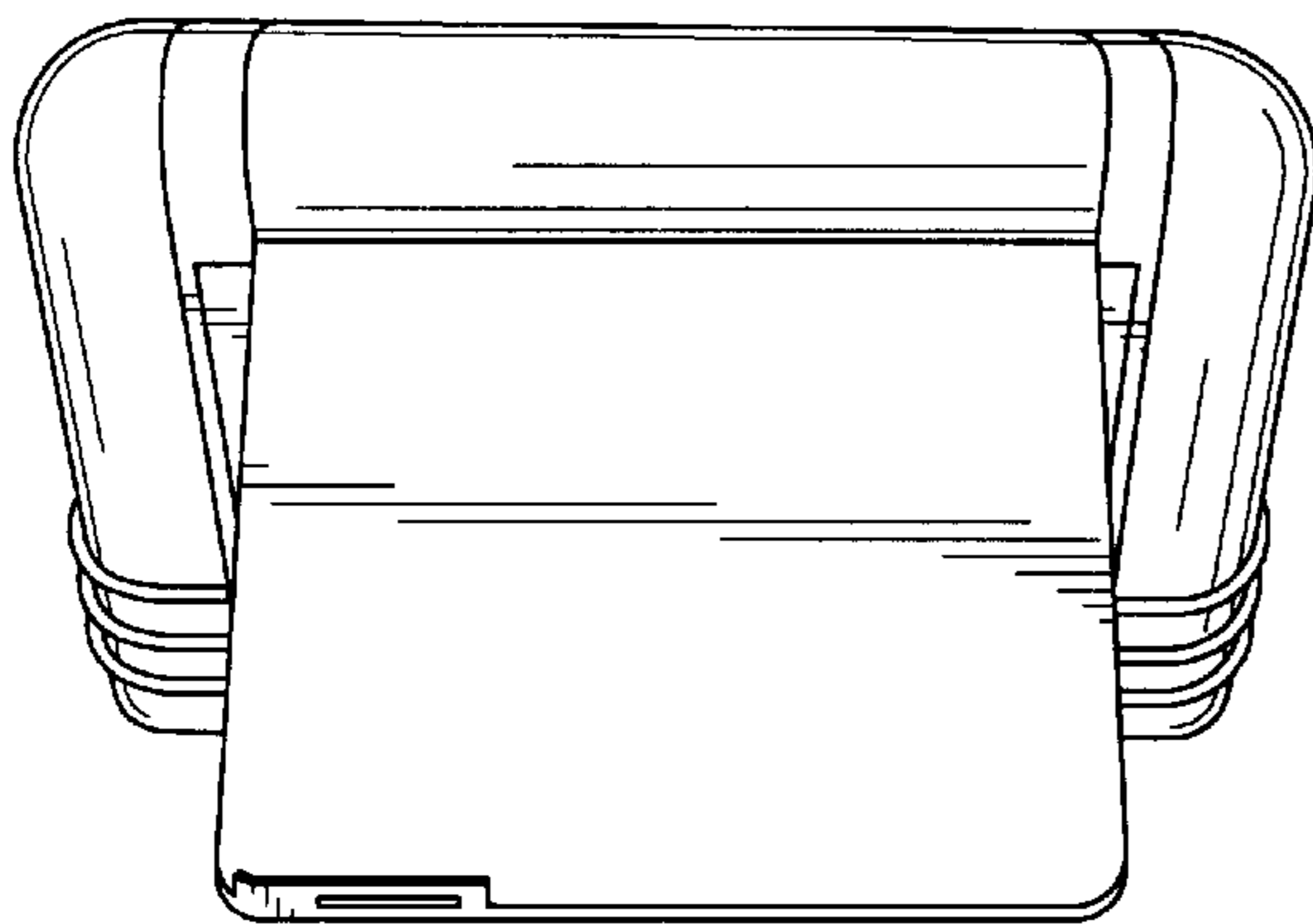

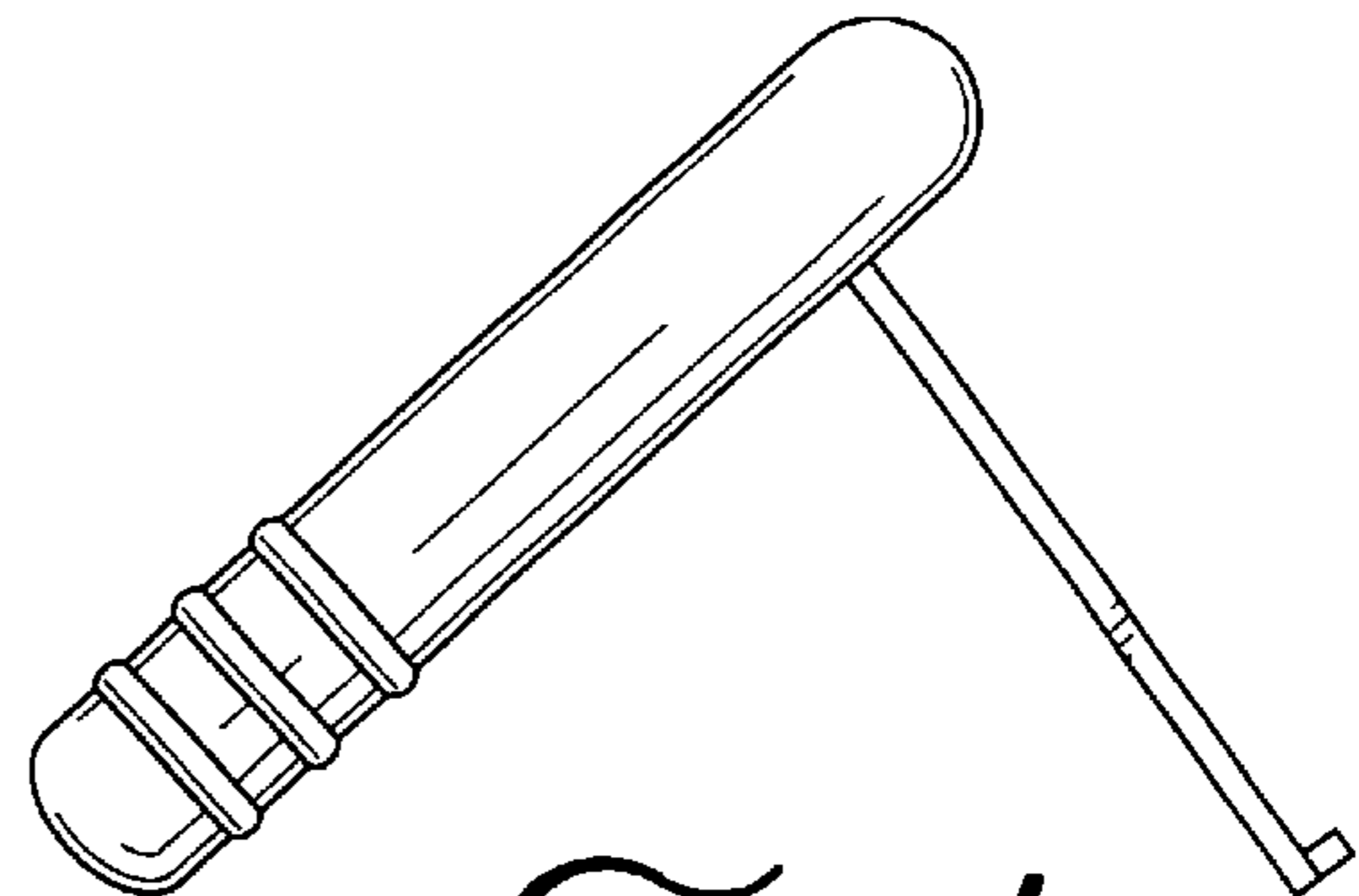

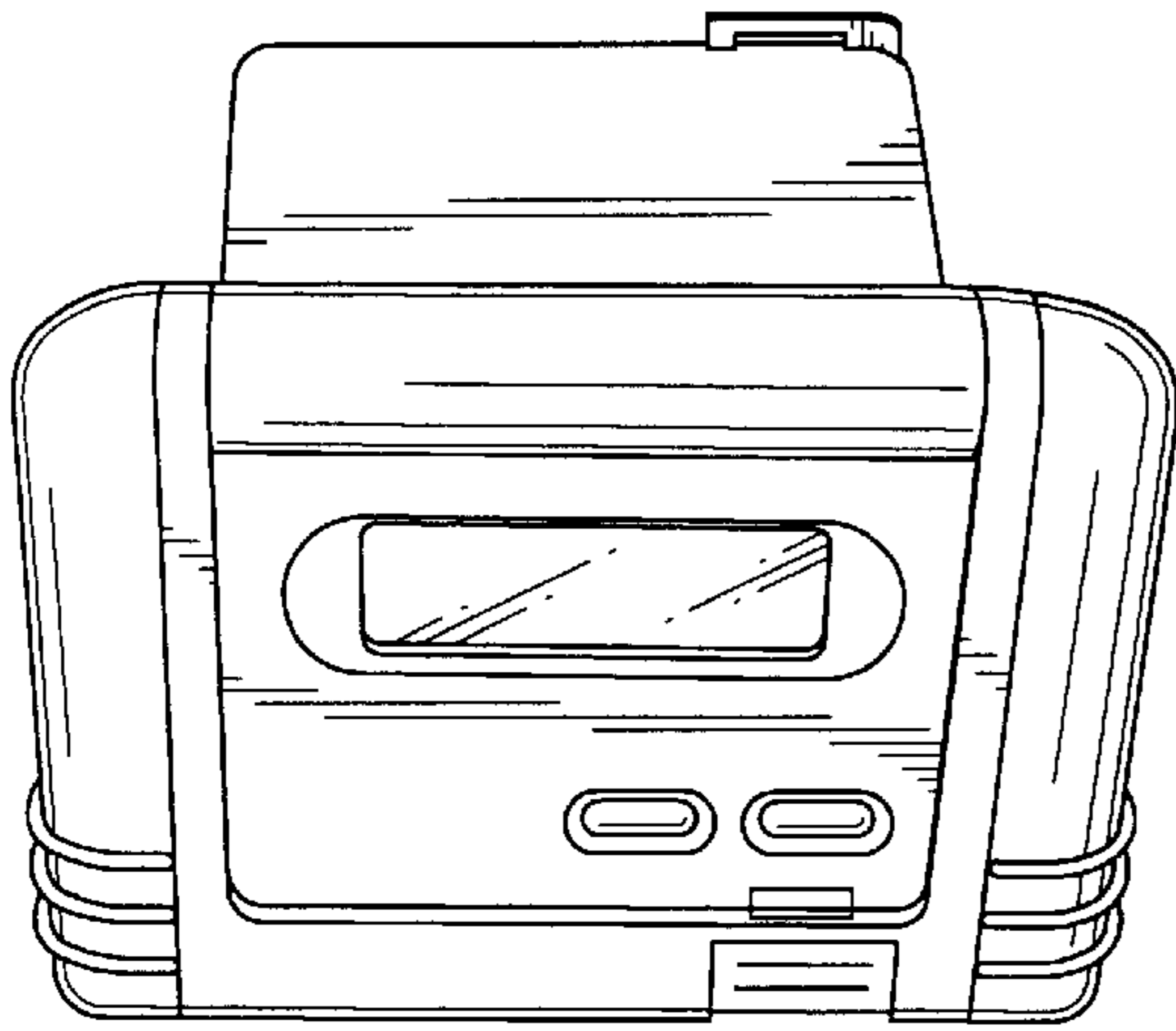

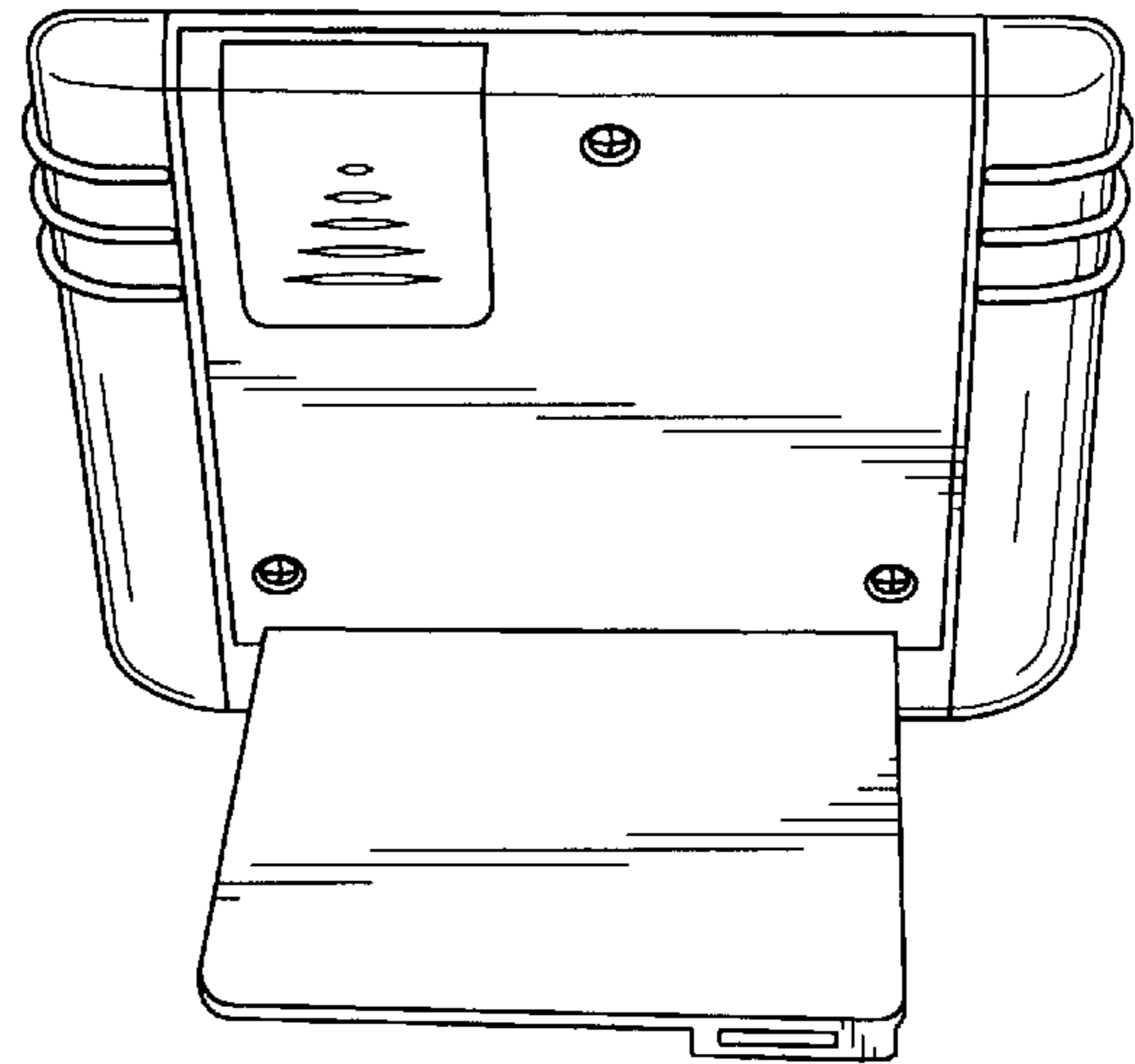

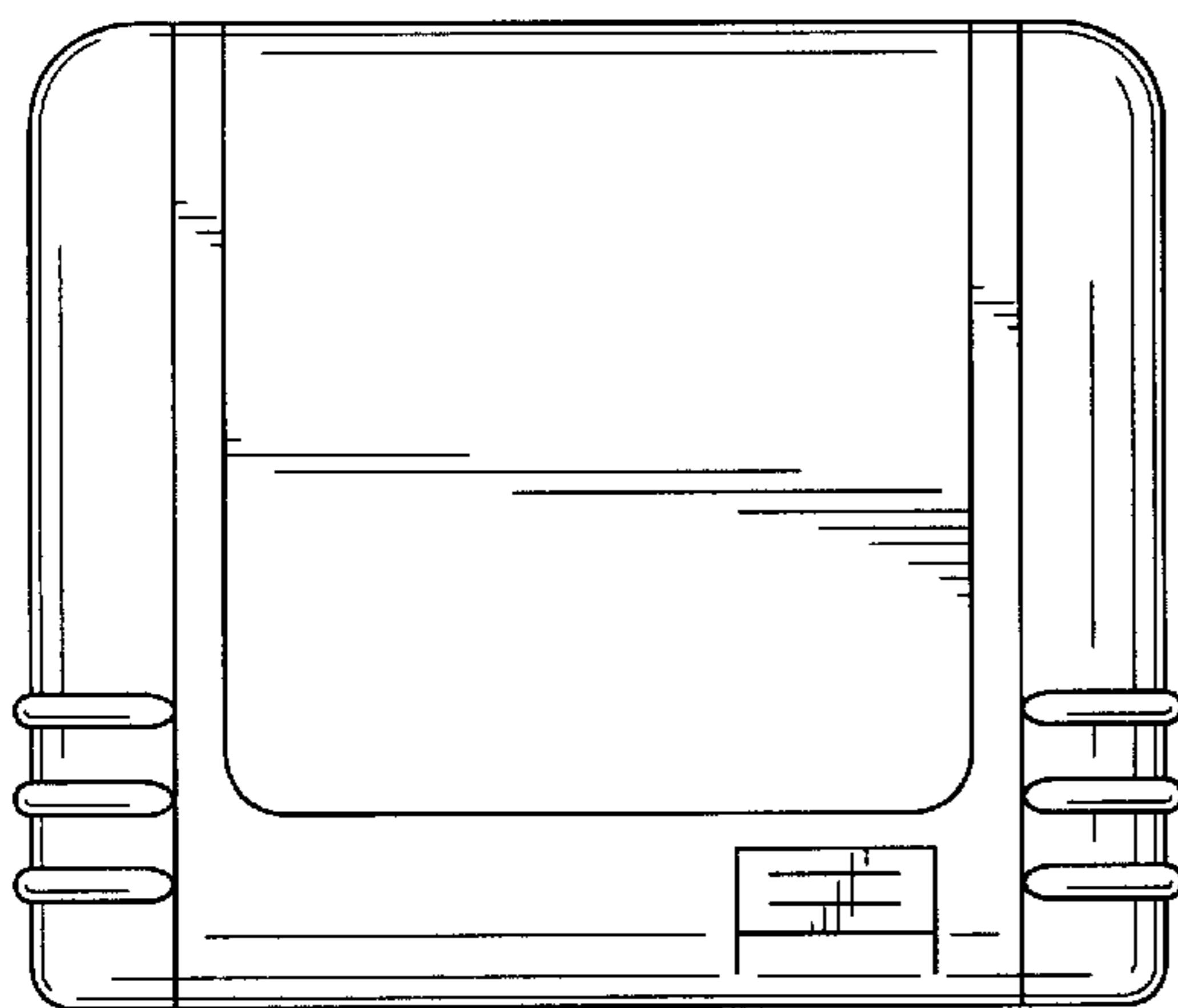

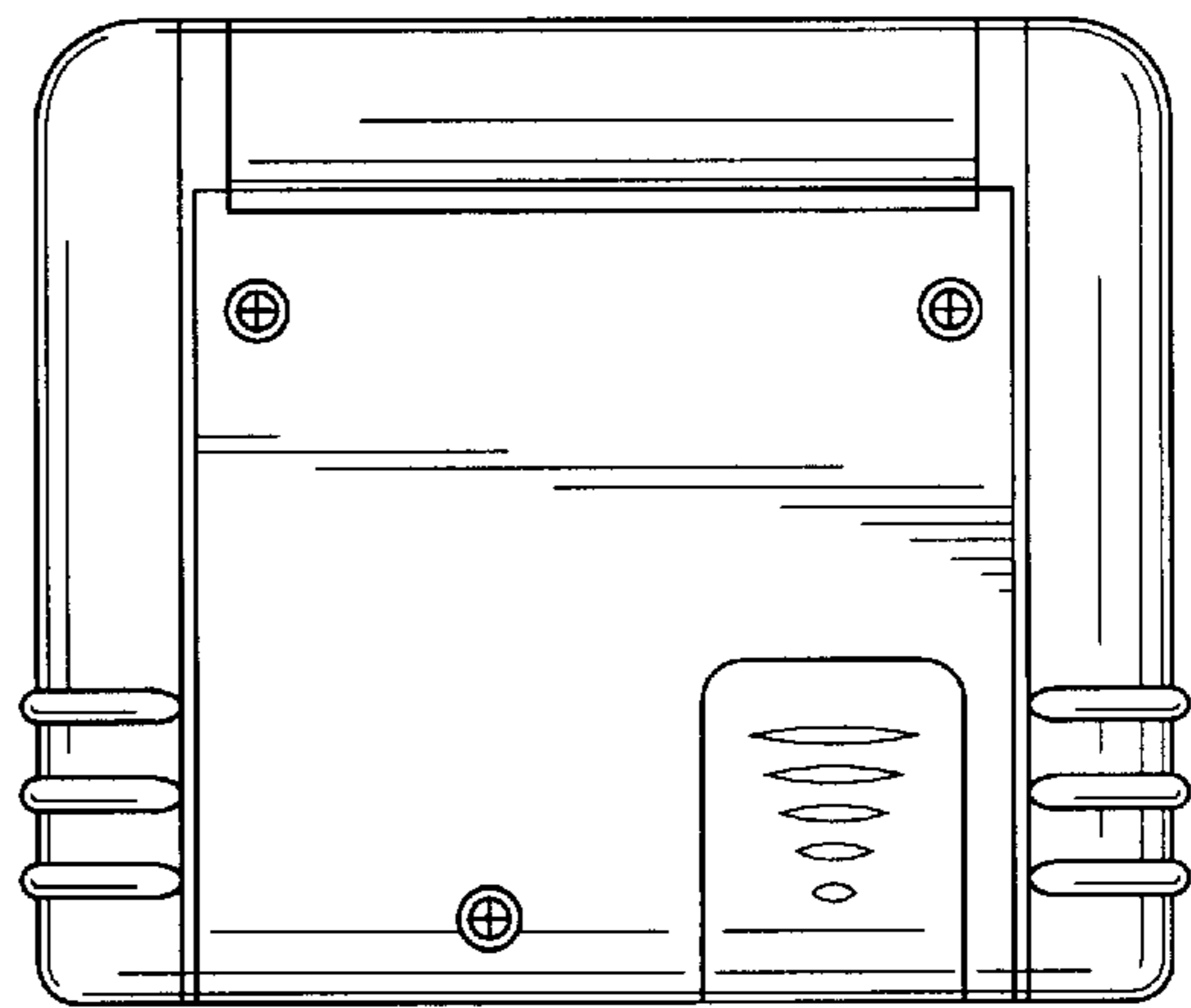

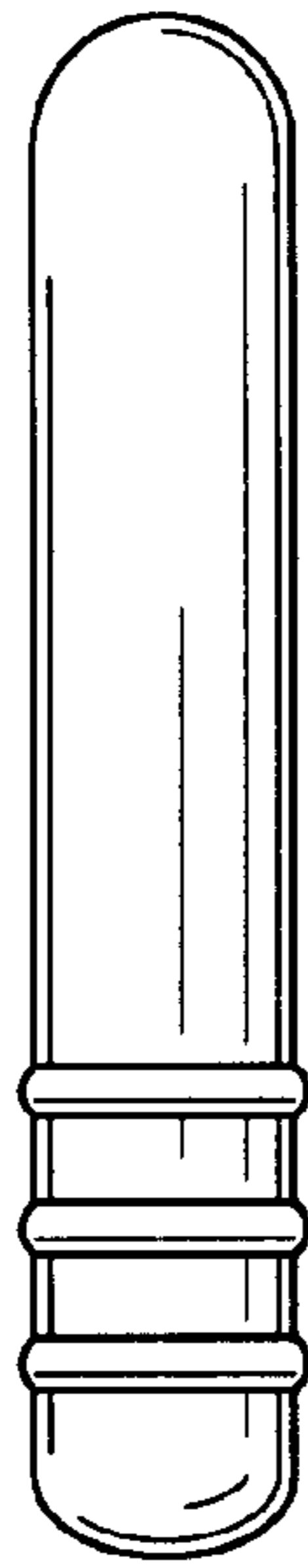

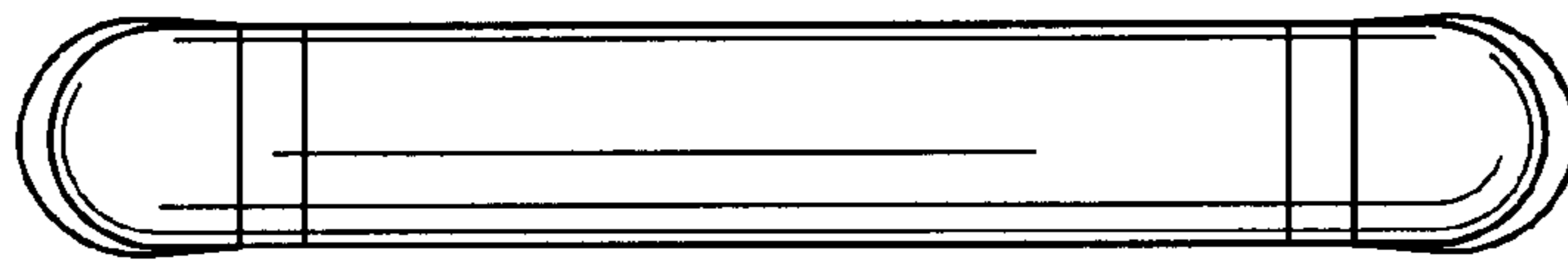

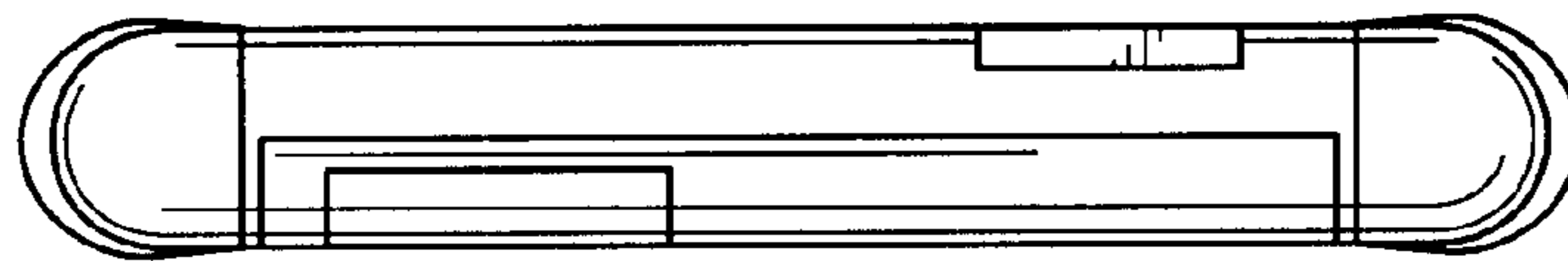
