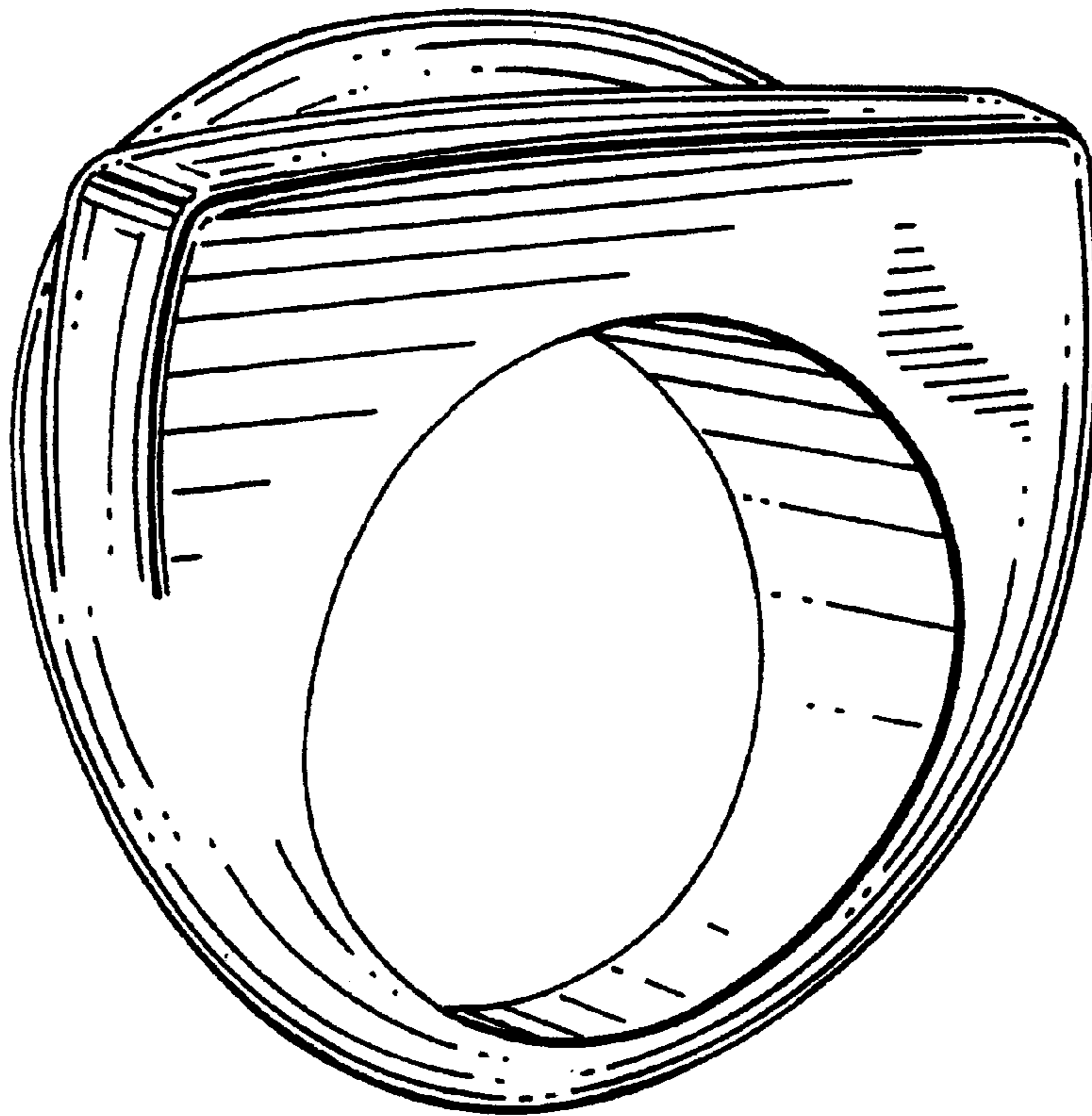
(57) **CLAIM**

The ornamental design for a finger ring, as shown.

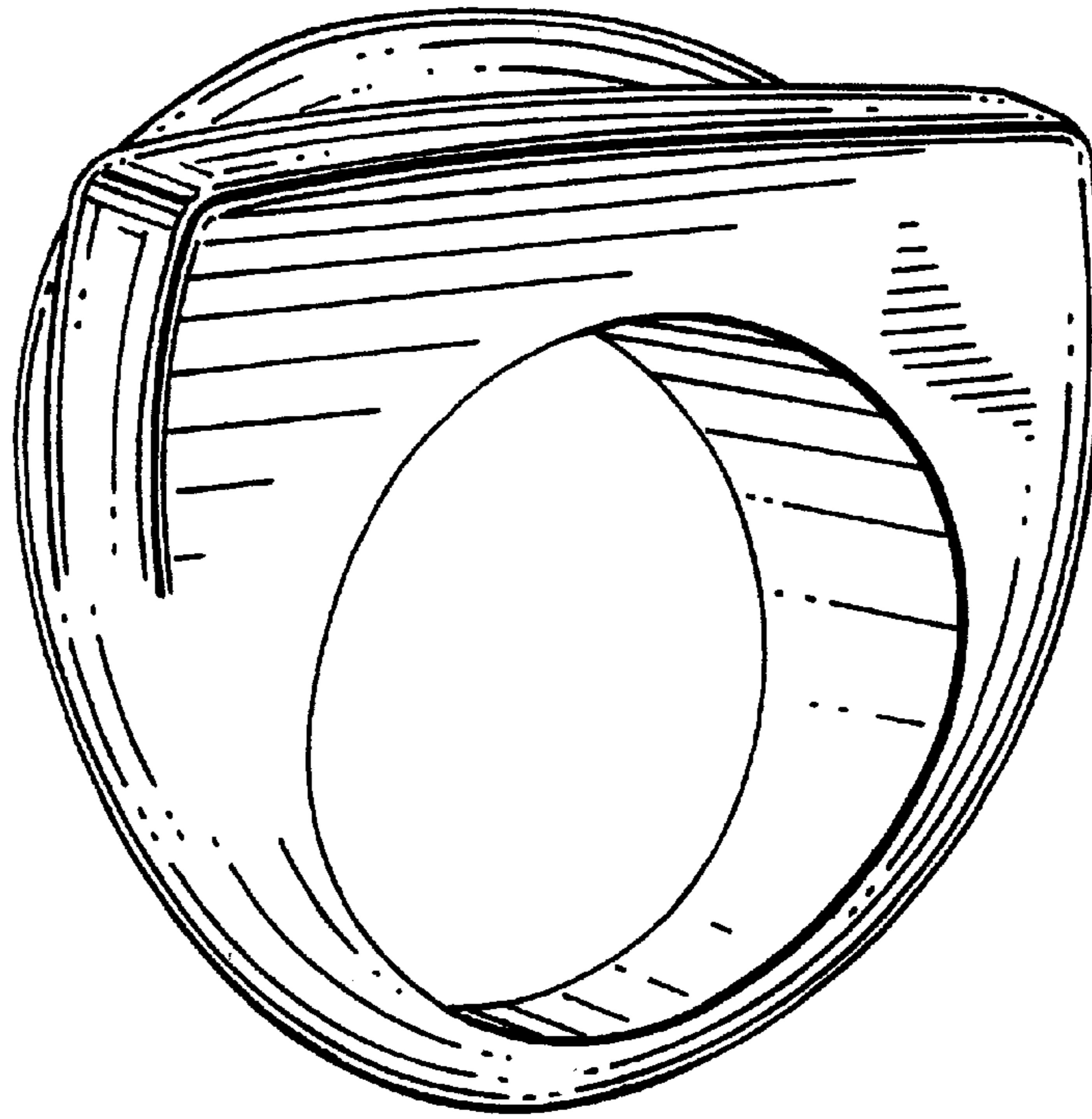
**DESCRIPTION**

 FIG. 7 is a bottom plan view thereof.

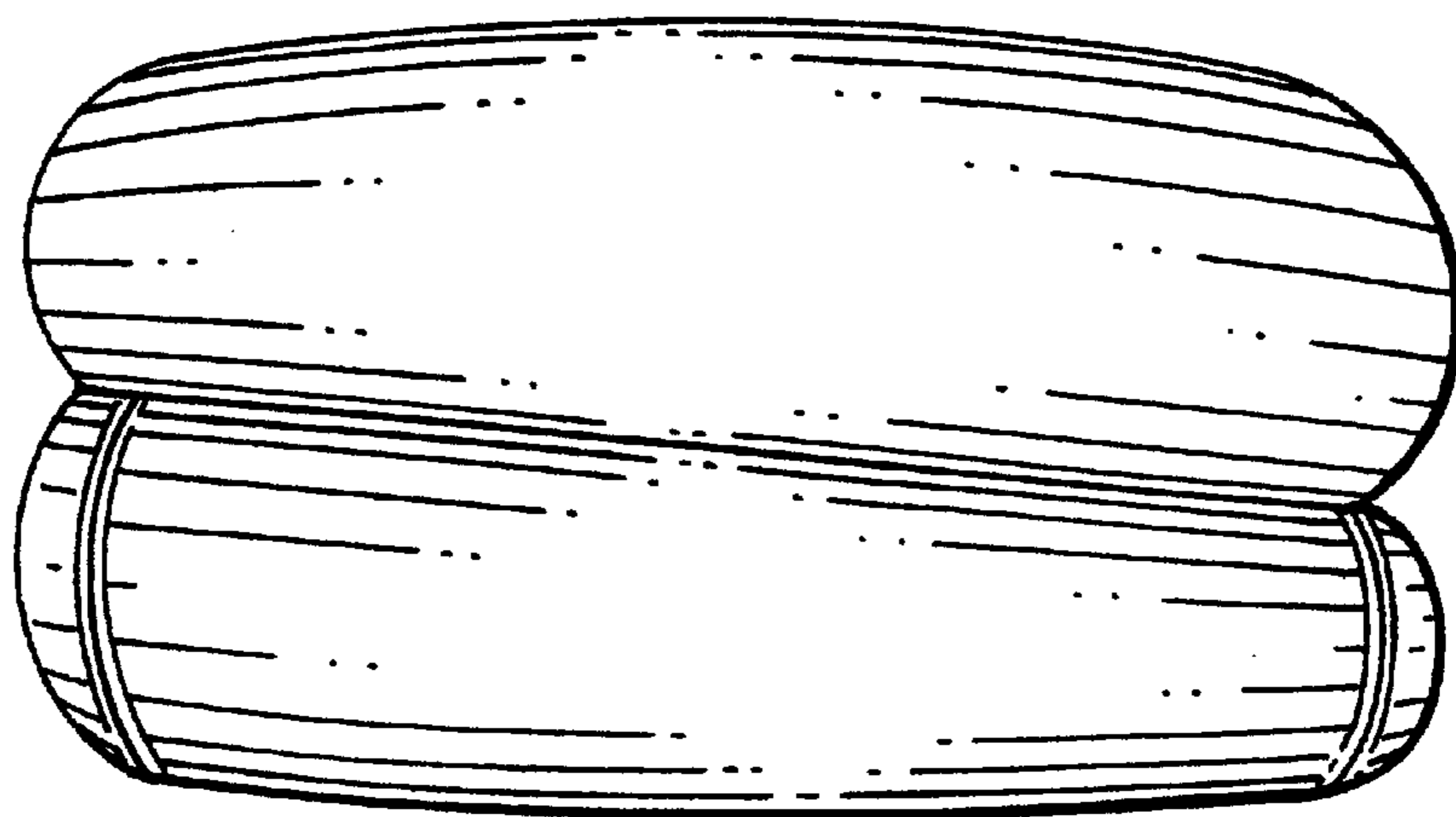

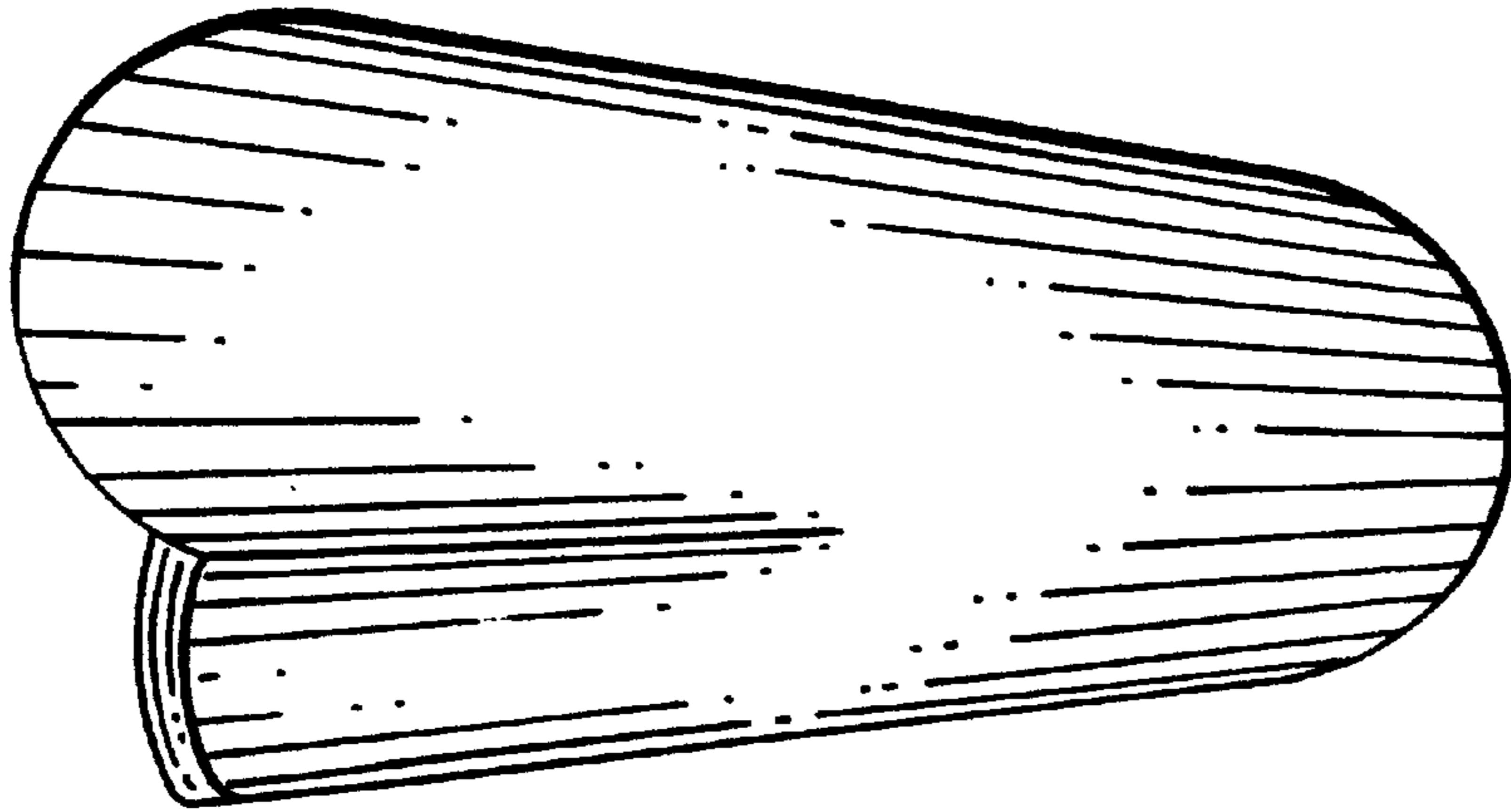

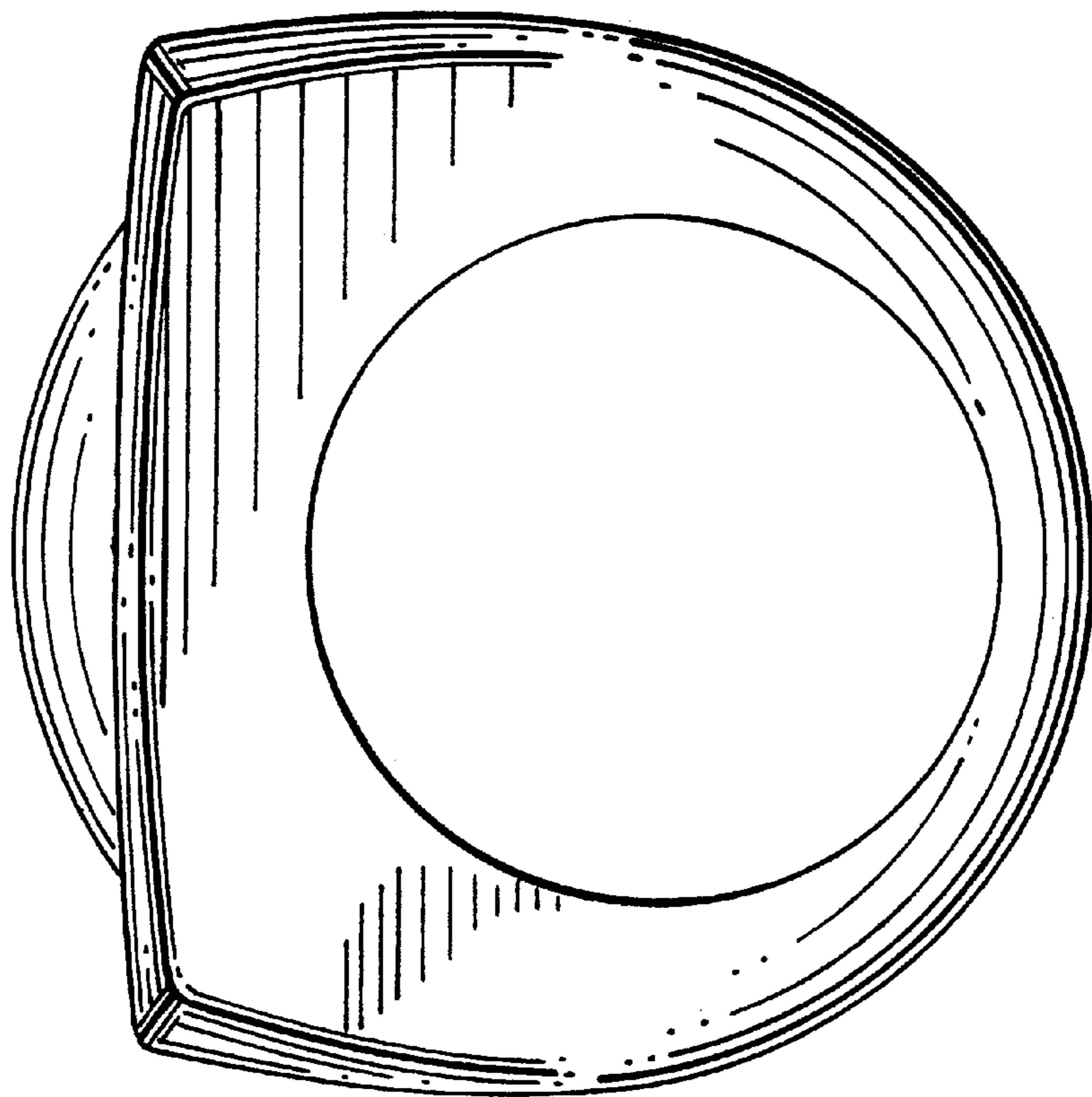

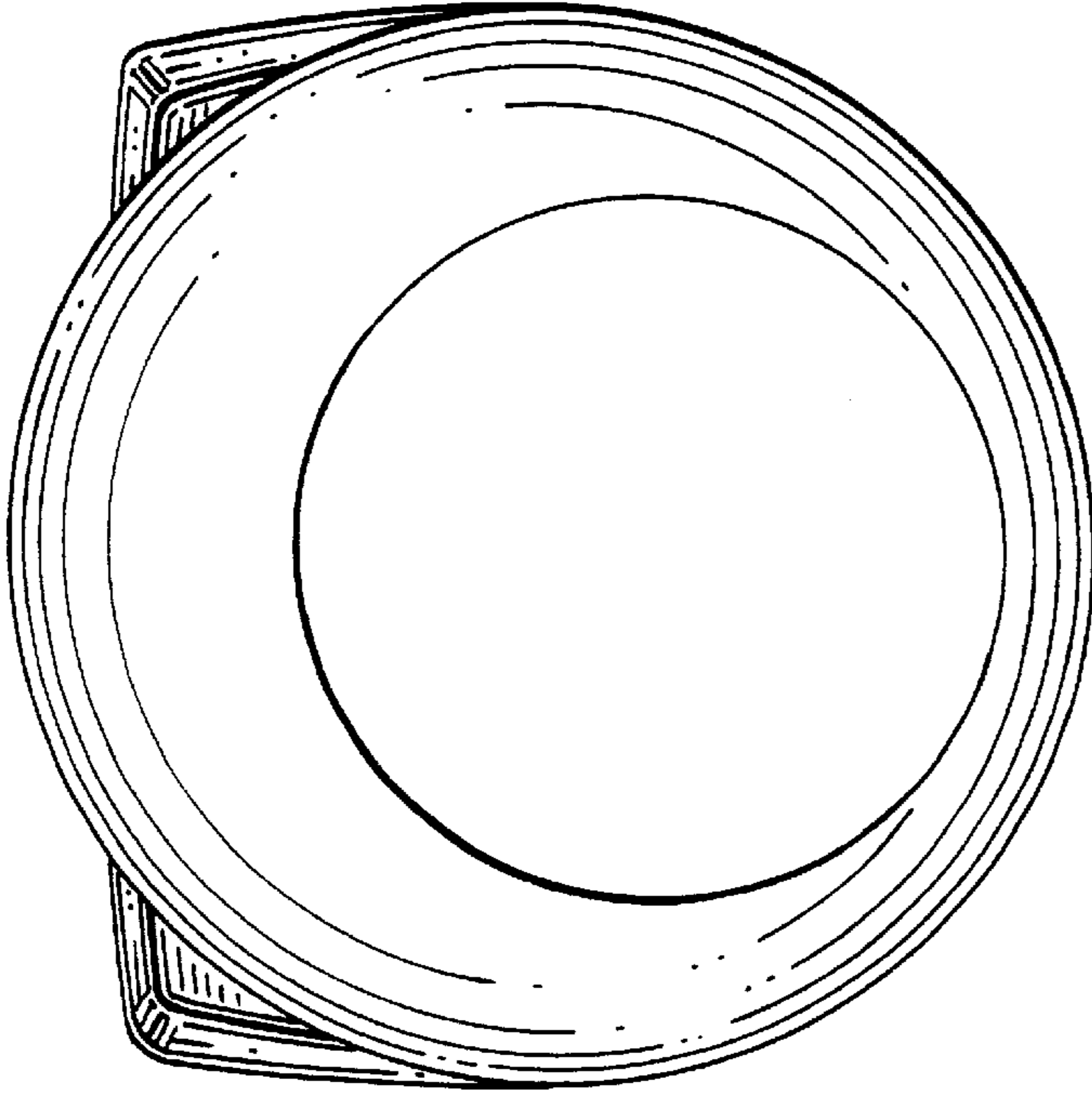

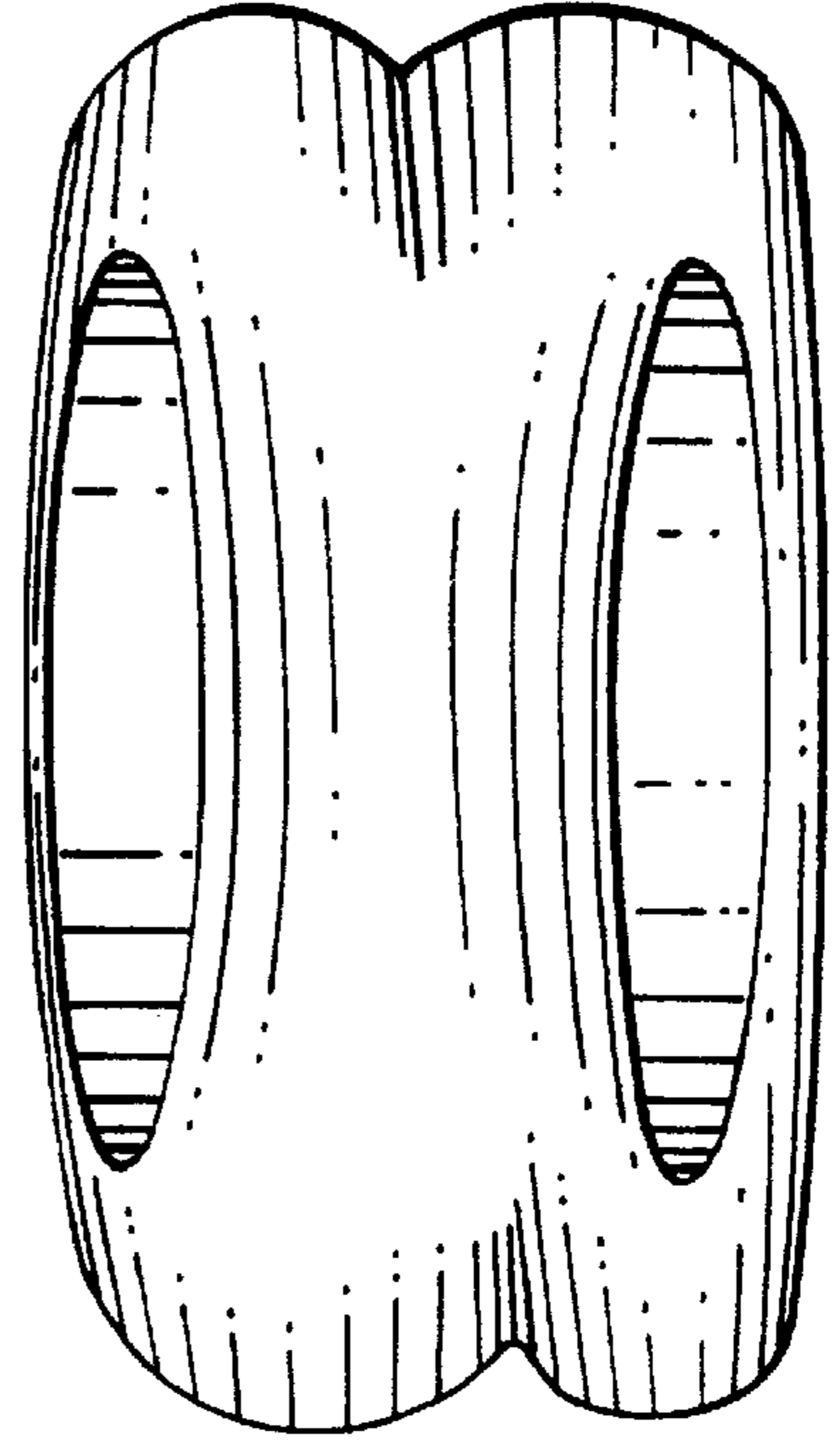

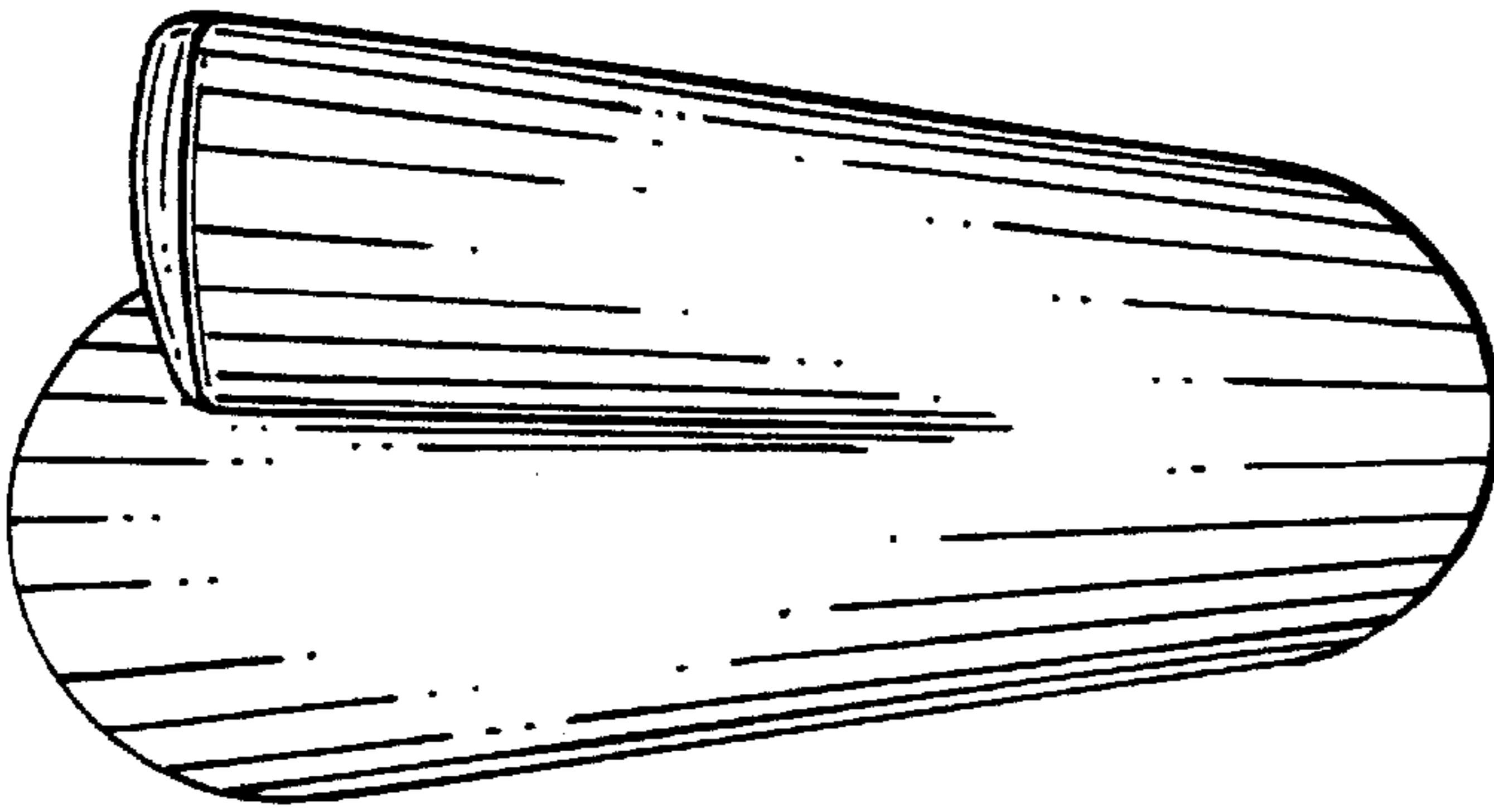
