**DESCRIPTION**

design;

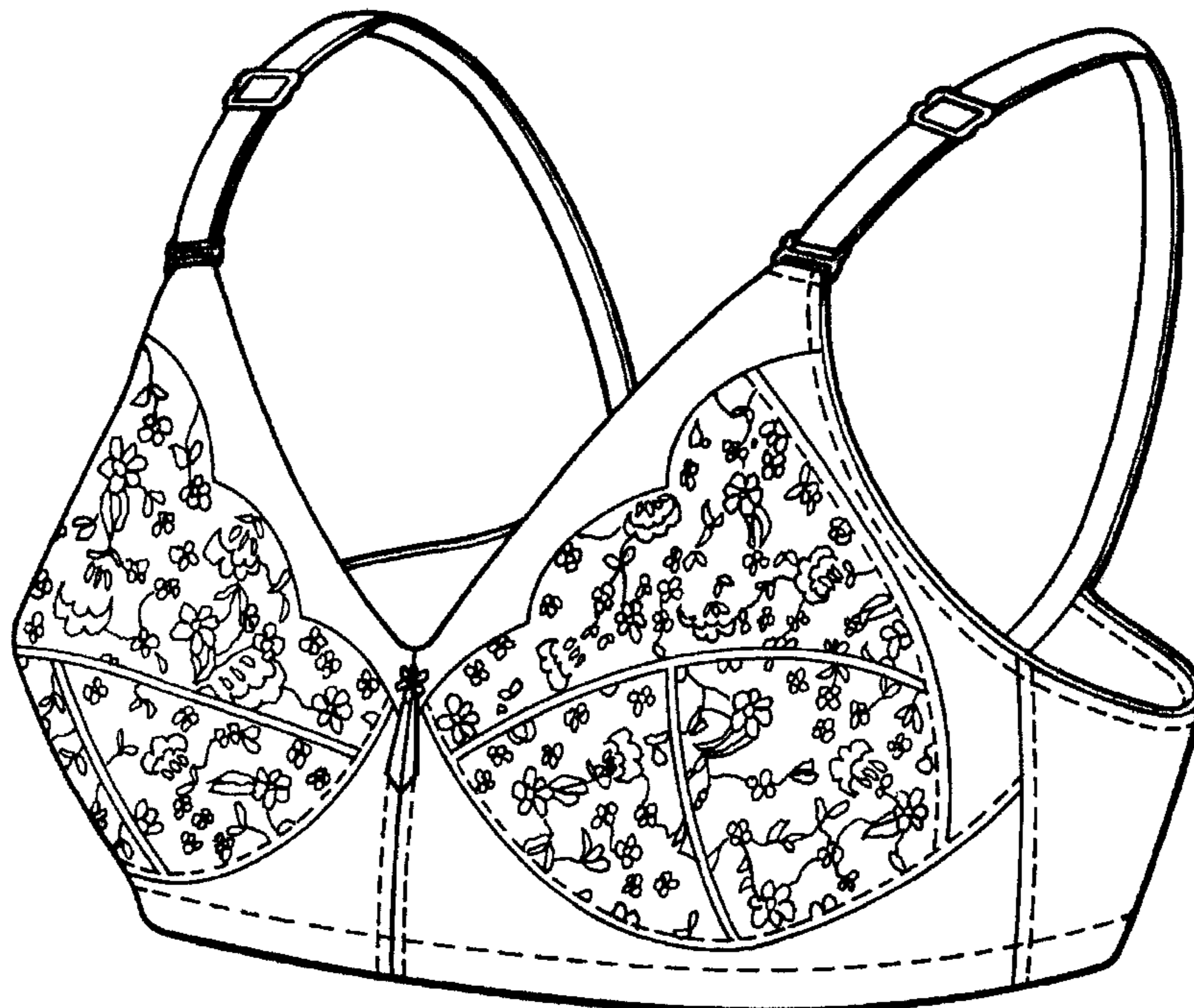

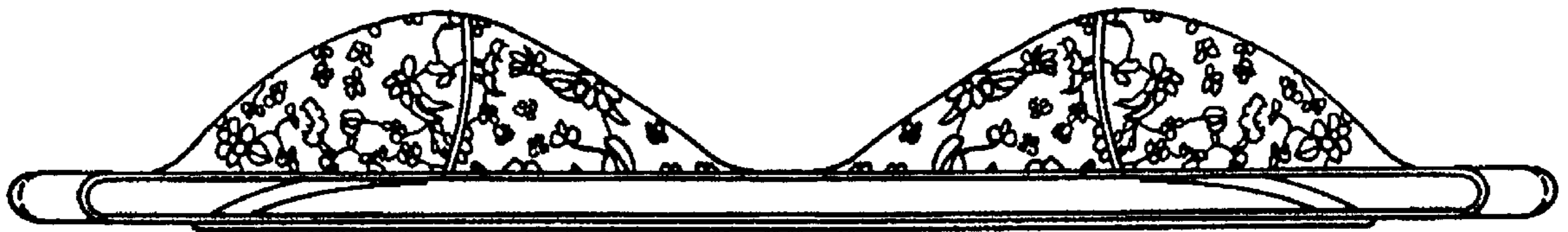

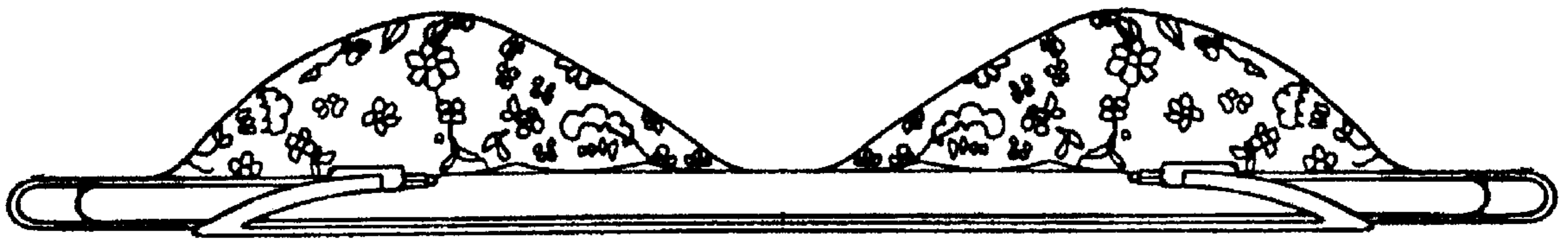

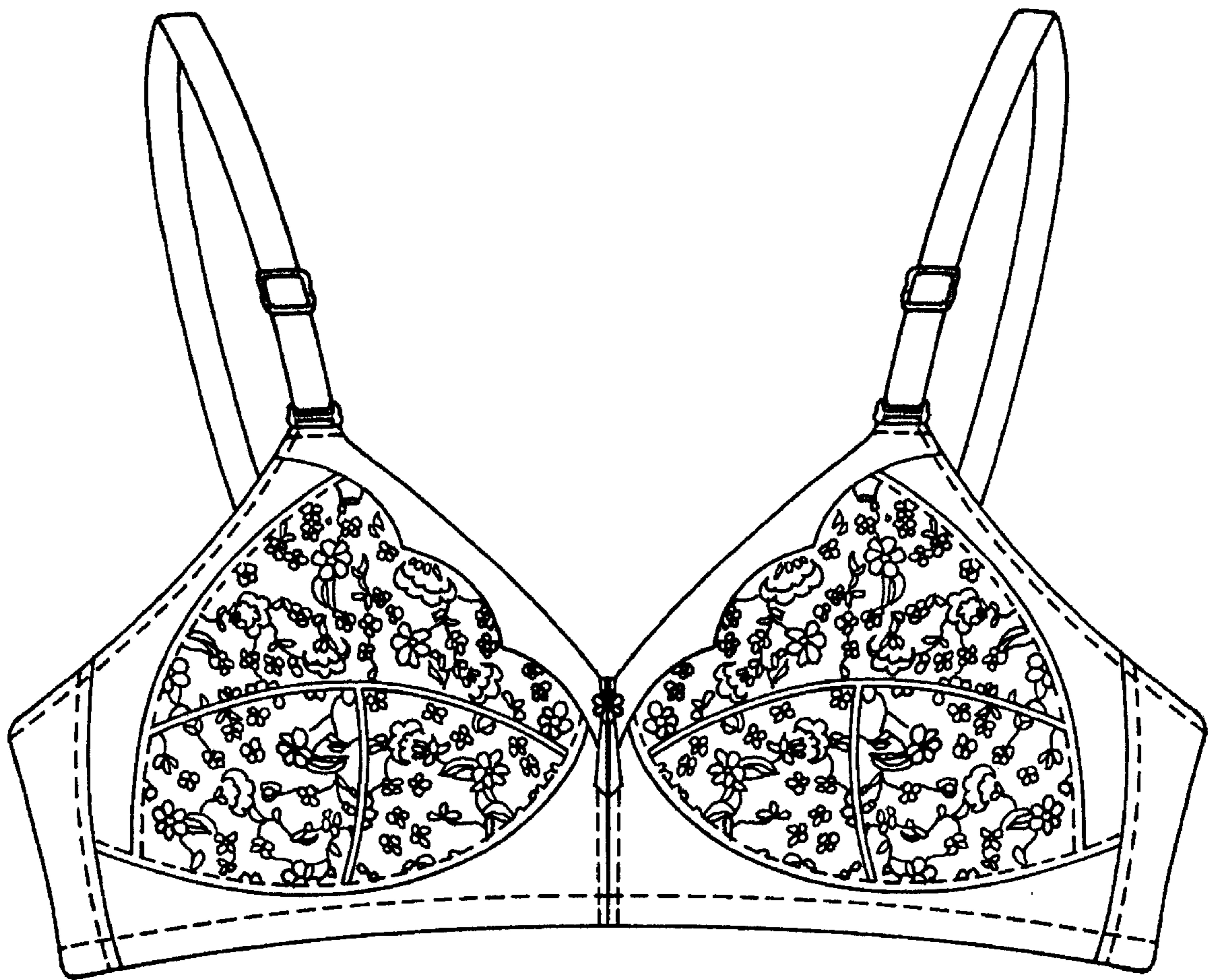

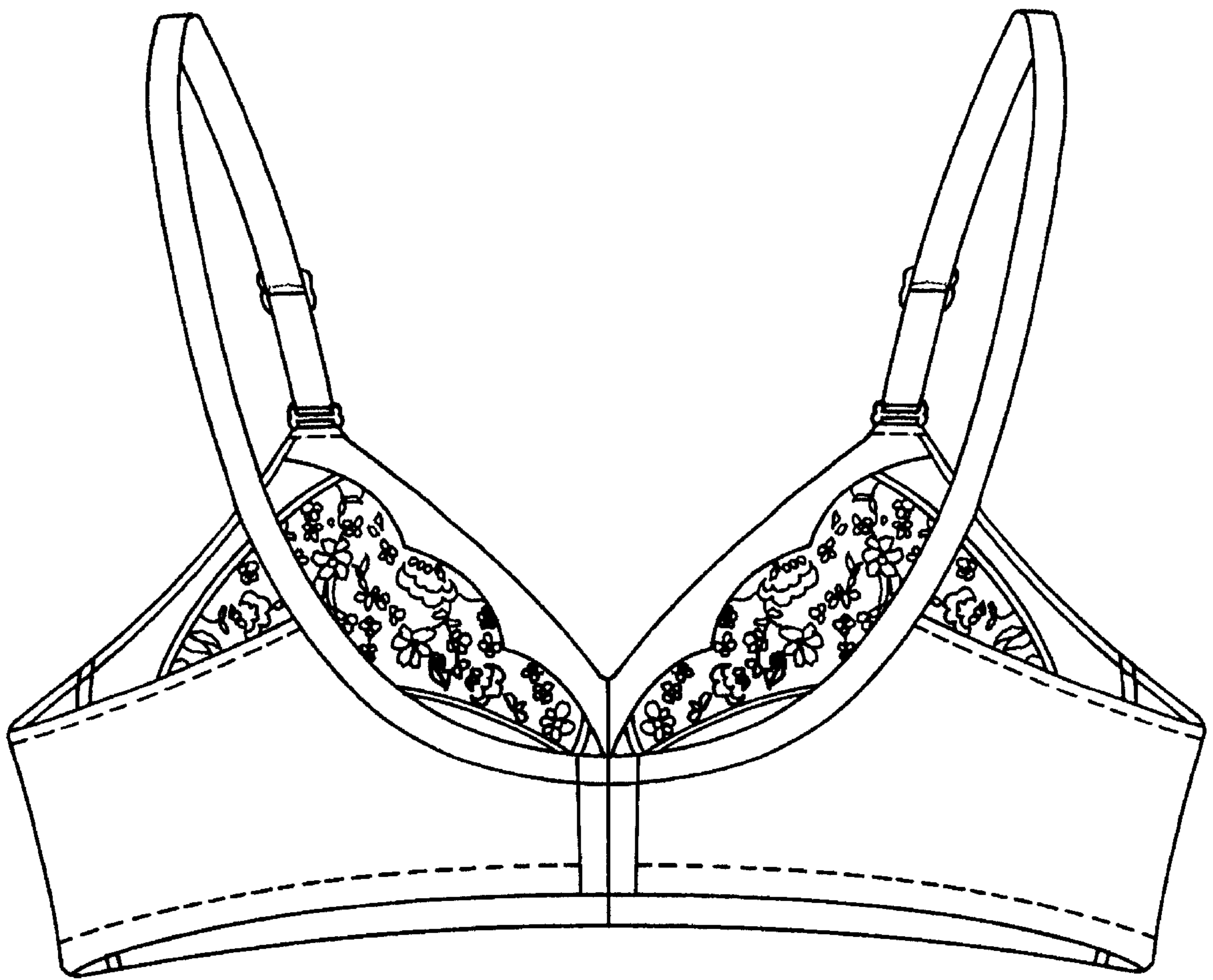

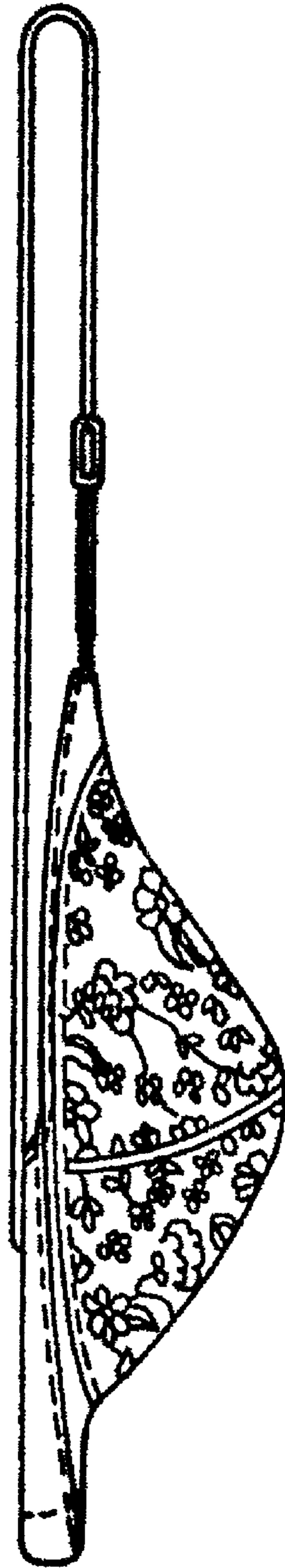
