(57) **CLAIM**

The ornamental design for a headwear with novel visor, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a headwear with novel visor showing my new design;
 FIG. 2 is a top plan view of the headwear with novel visor as shown in FIG. 1;
 FIG. 3 is a front elevational view of the headwear with novel visor as shown in FIG. 1;
 FIG. 4 is a right side elevational view of the headwear with novel visor as shown in FIG. 1; the same as a left side elevational view thereof;
 FIG. 5 is a rear elevational view of the headwear with novel visor as shown in FIG. 1; and,
 FIG. 6 is a bottom plan view of the headwear with novel visor as shown in FIG. 1.

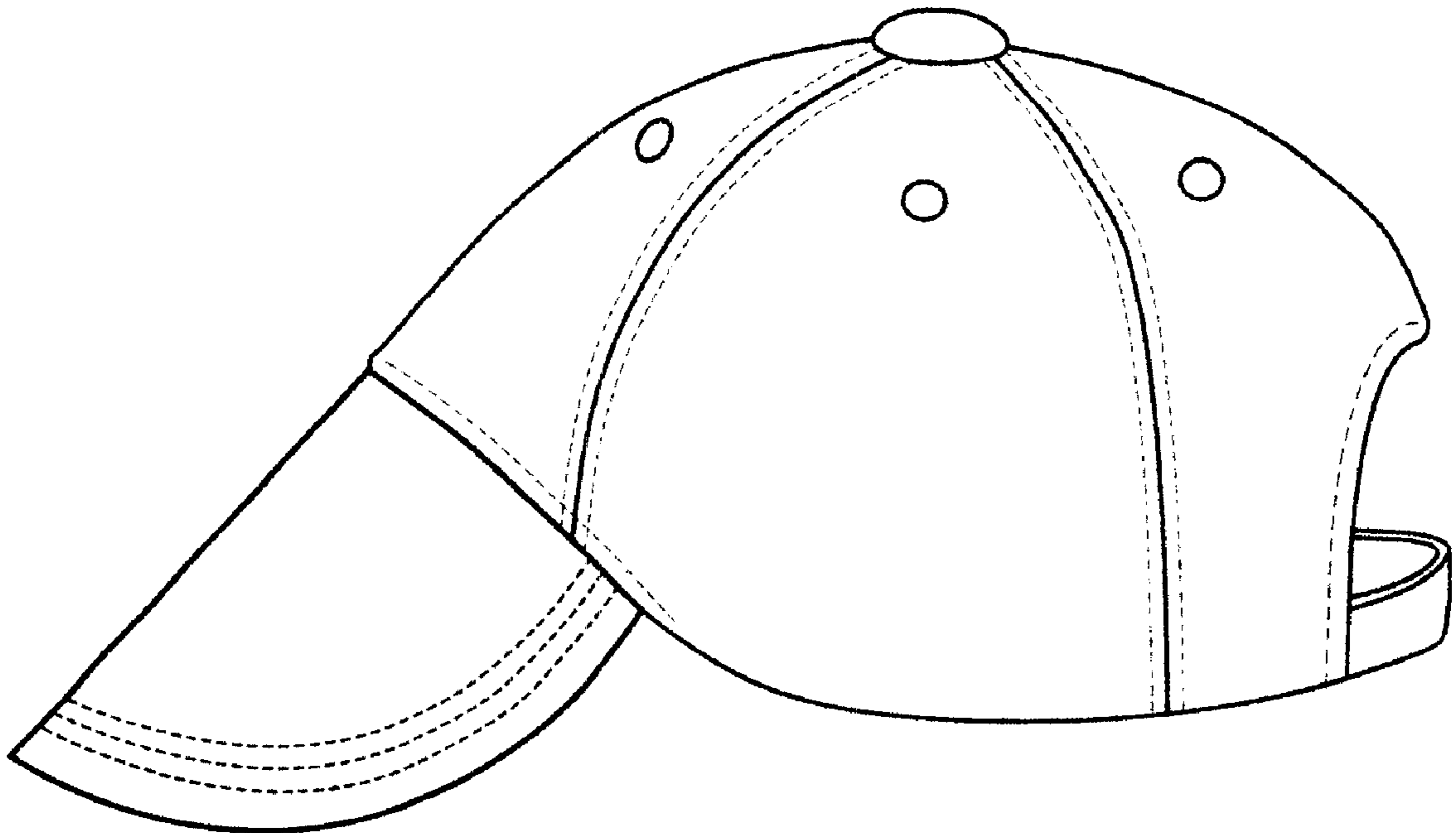

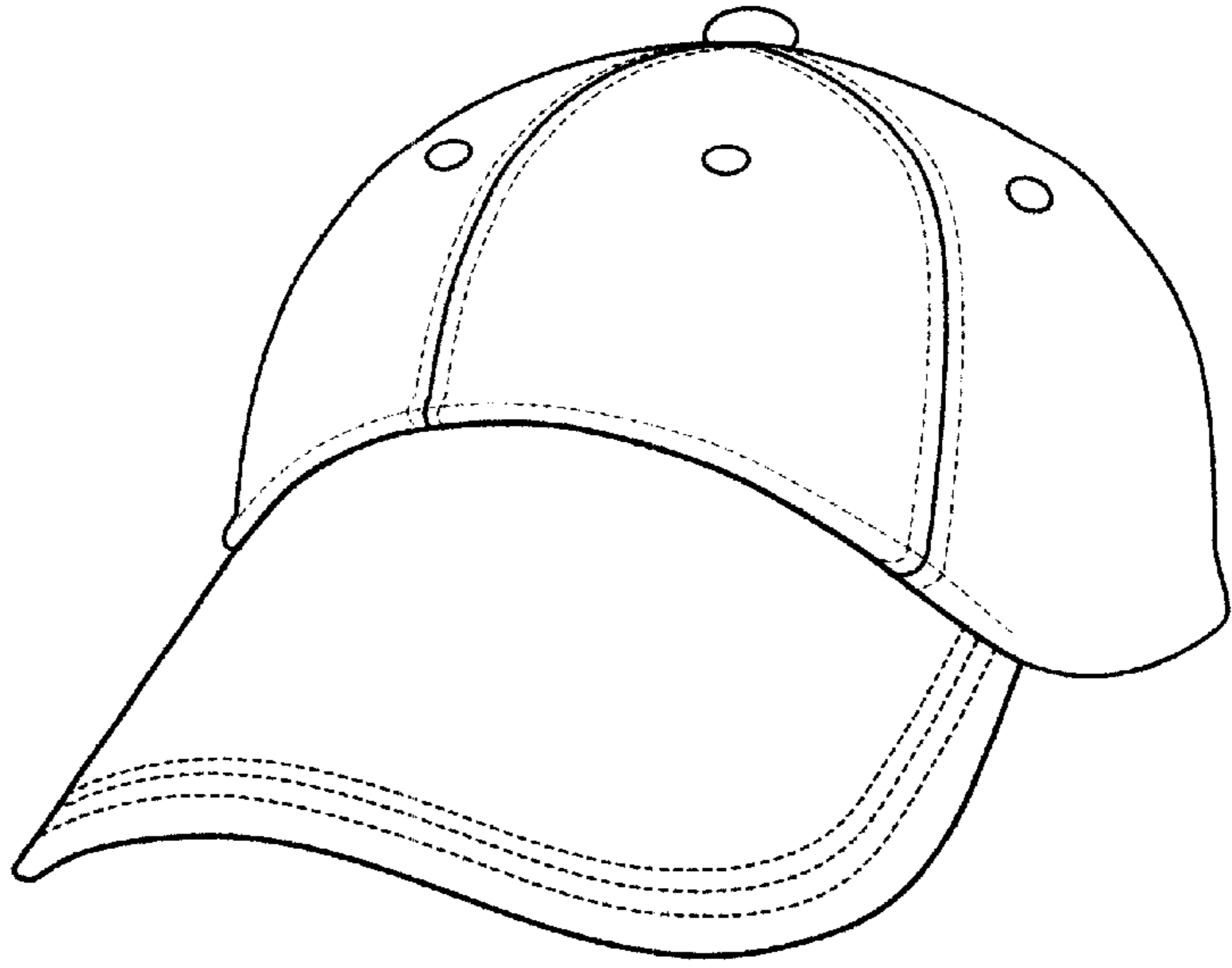

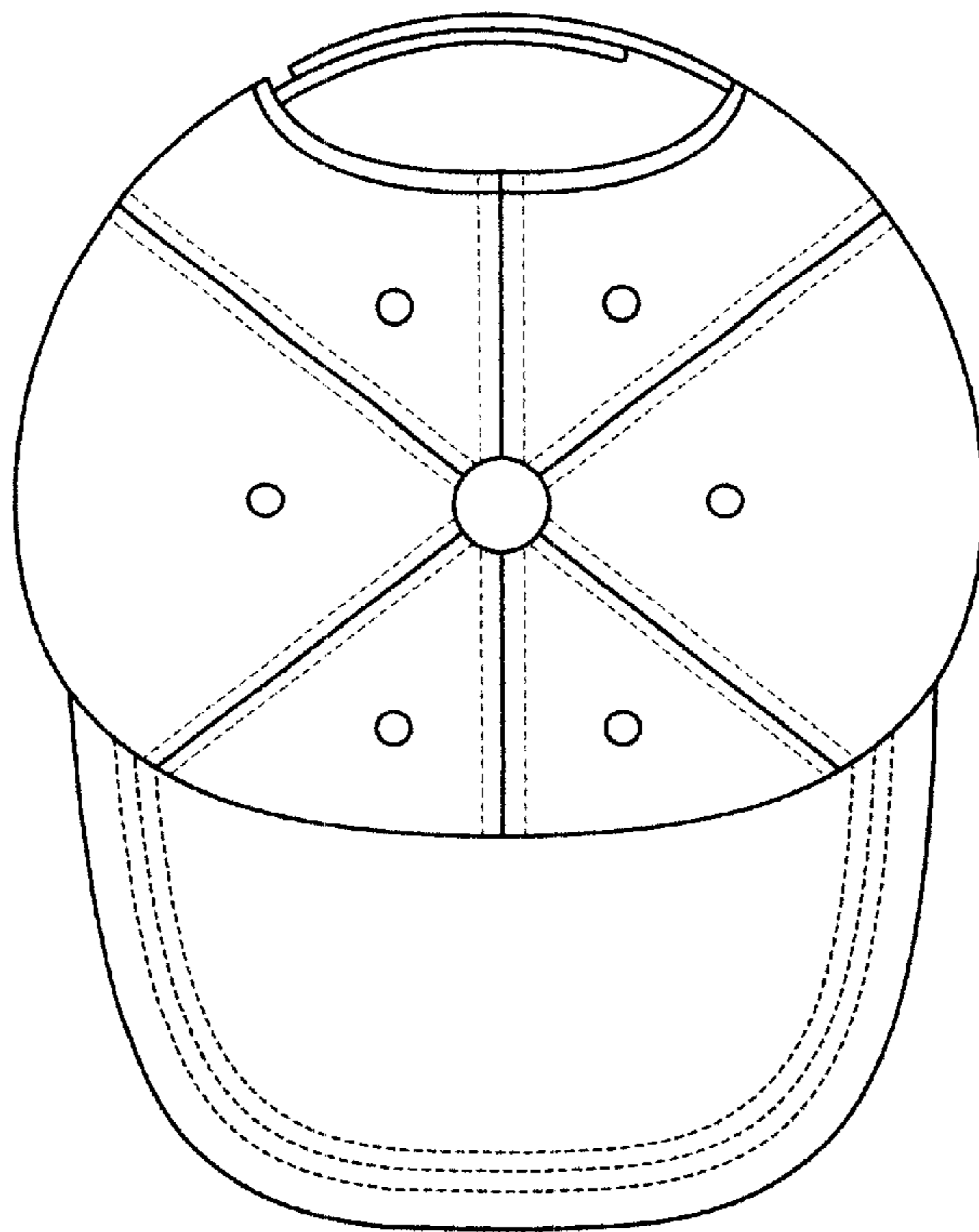

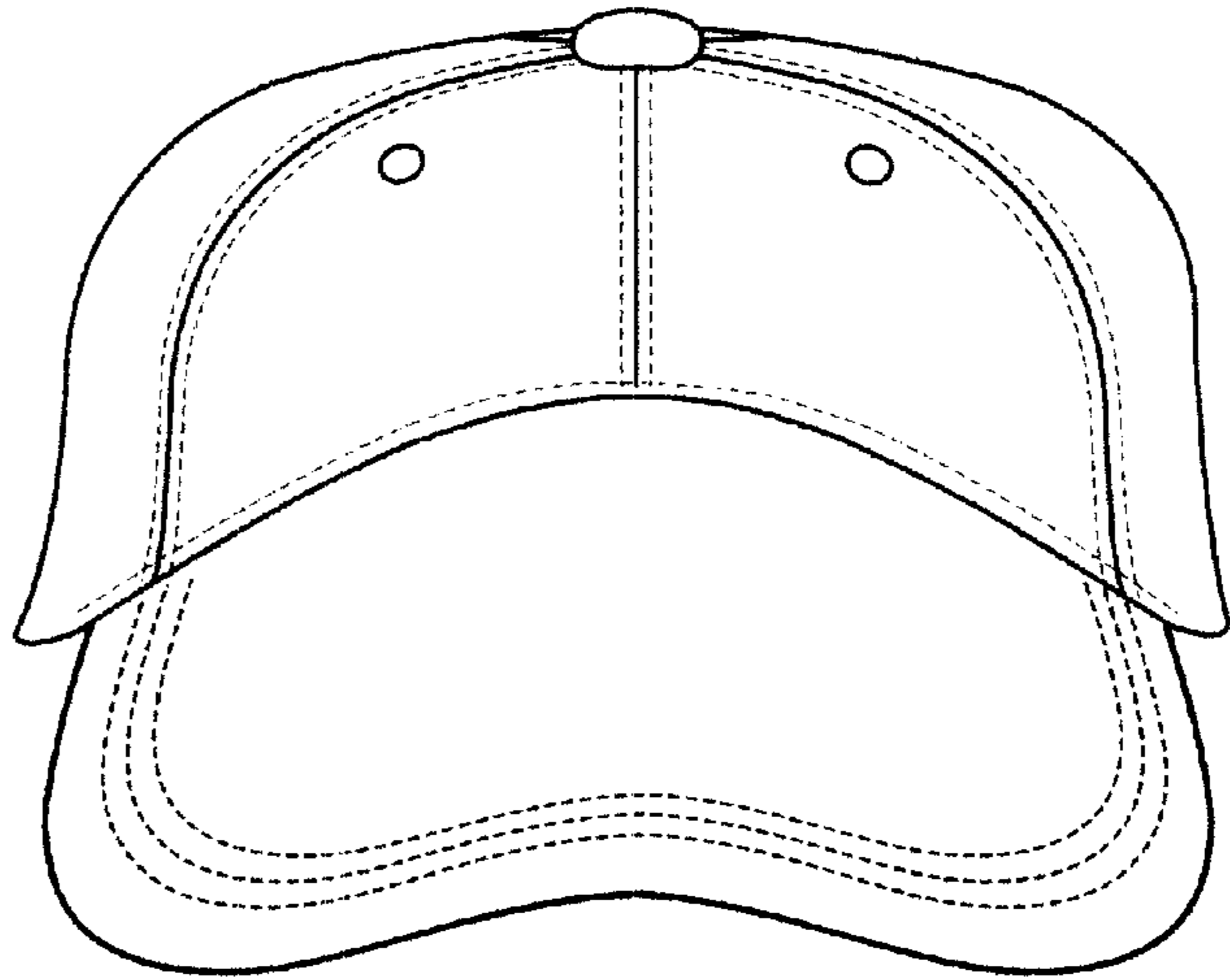

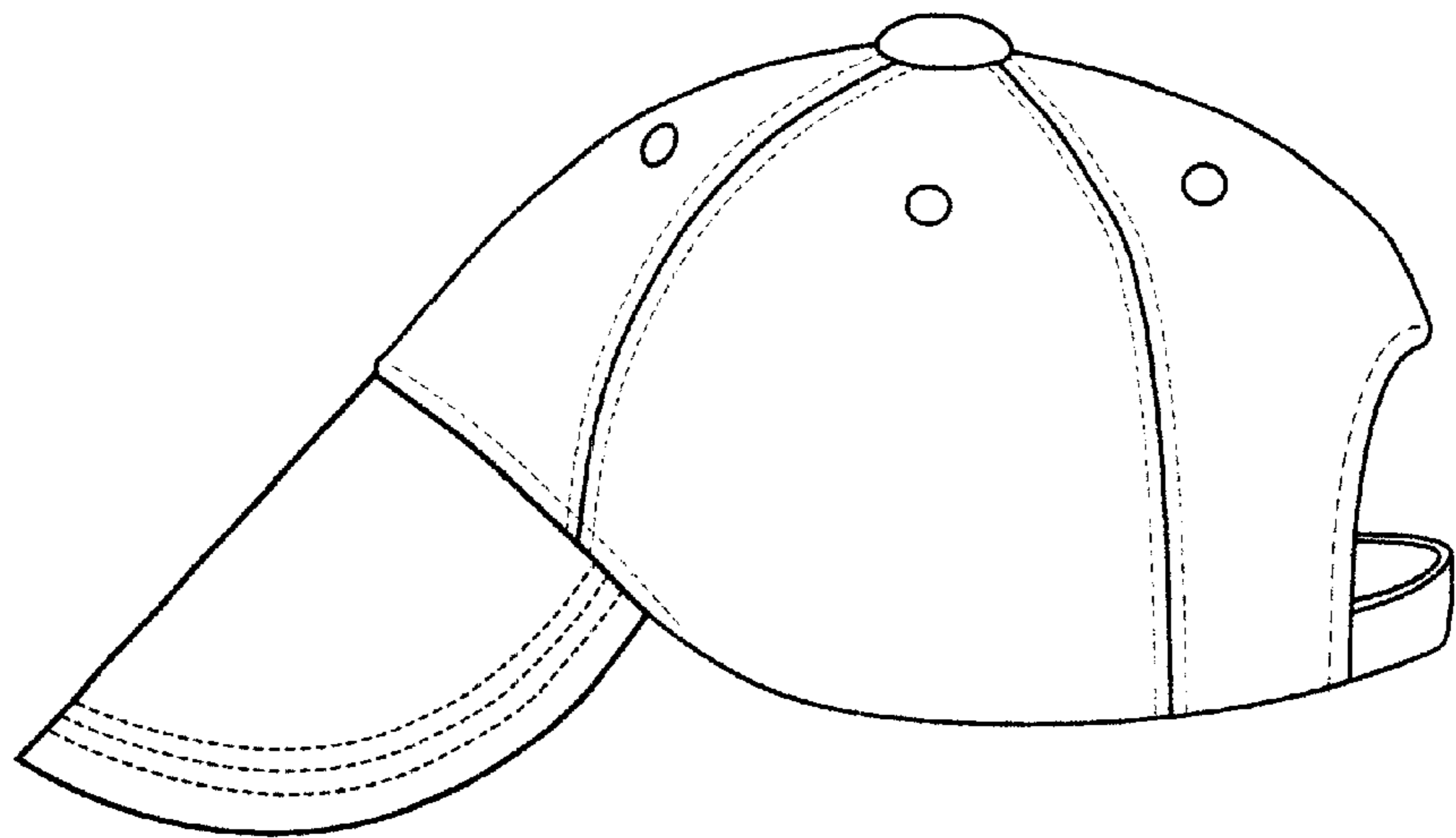

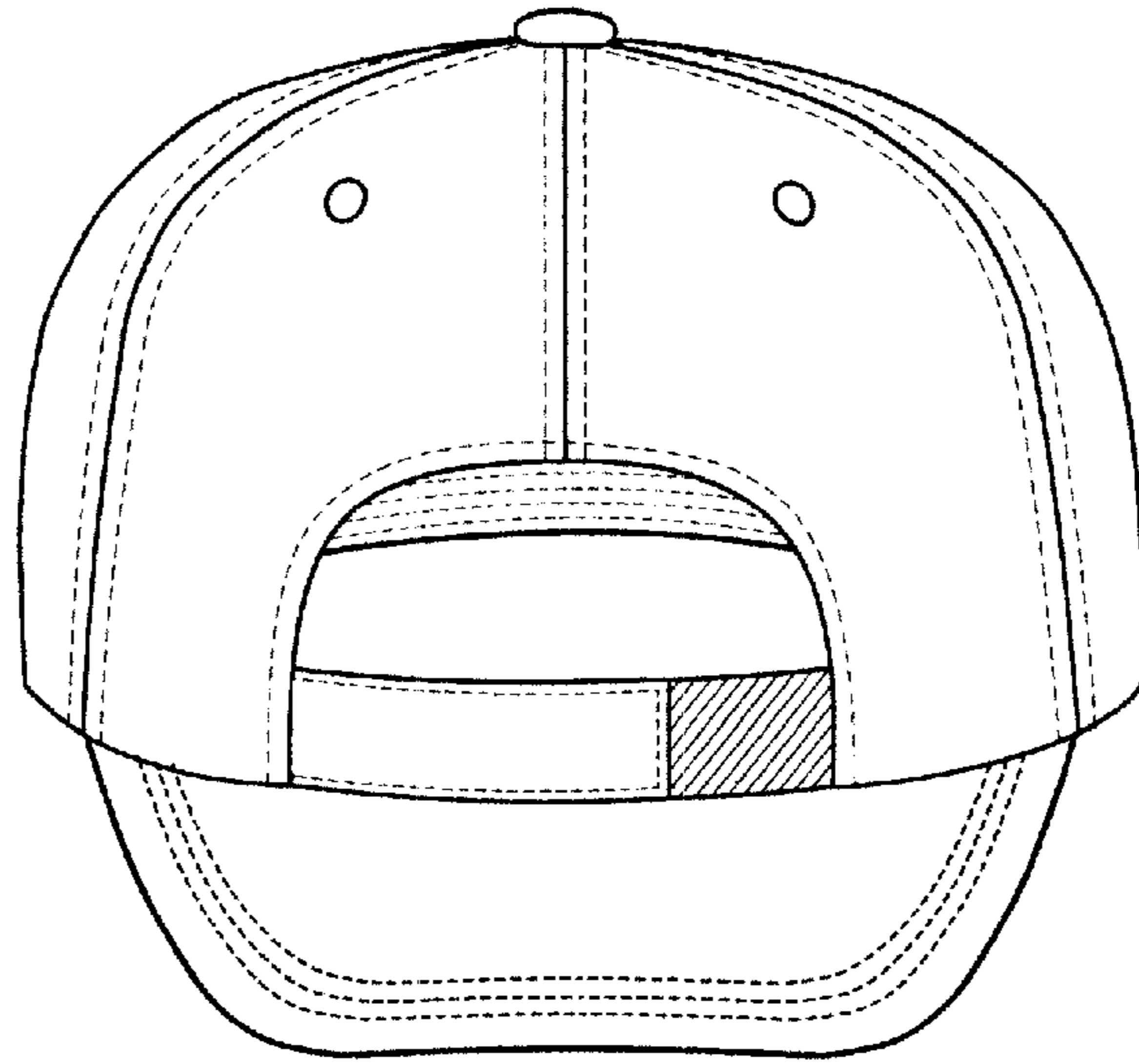
