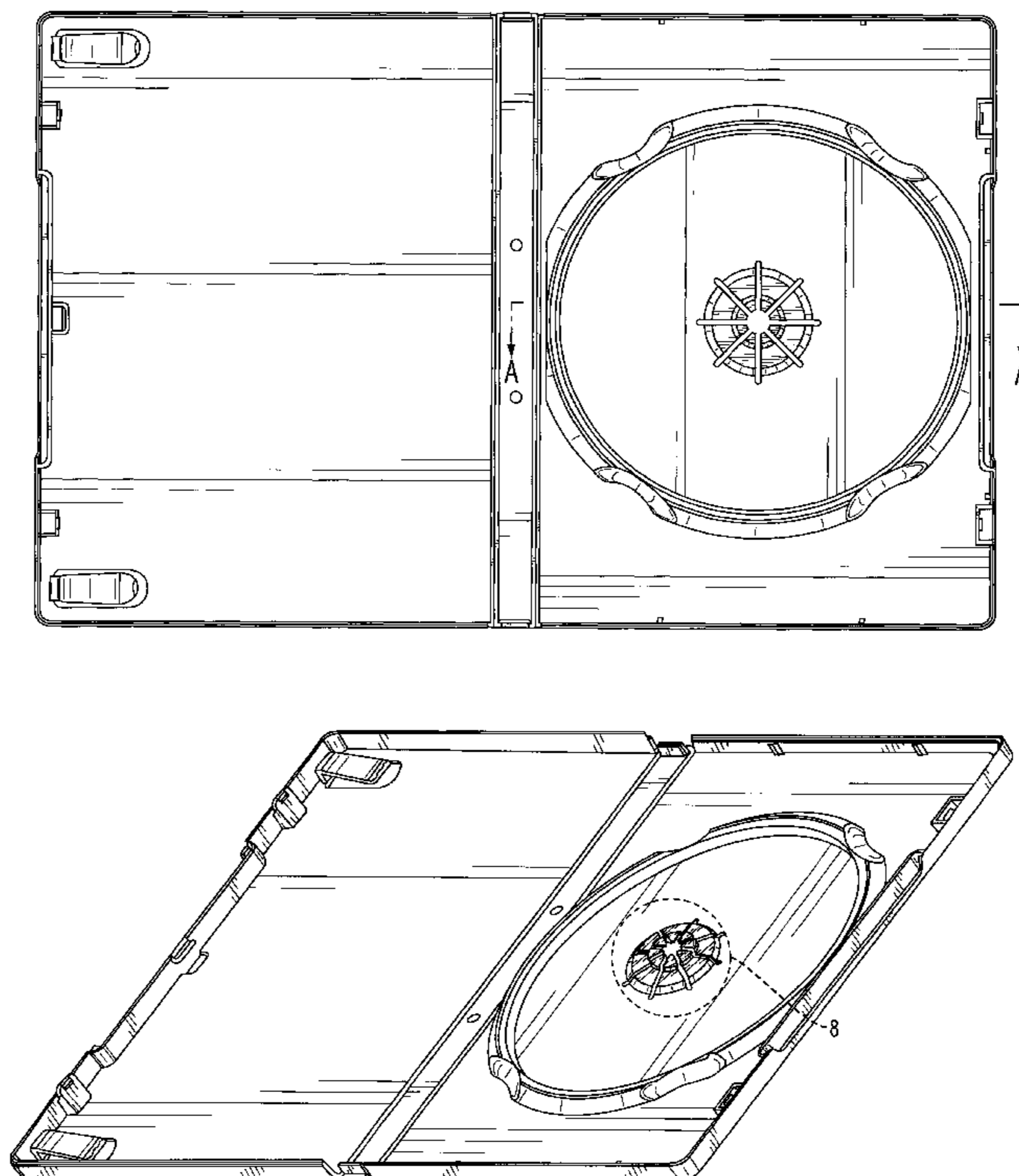
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a disk box showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a perspective view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a right side elevational view thereof; and,
FIG. 8 is an enlarged fragmentary view showing the central hub of FIG. 3.

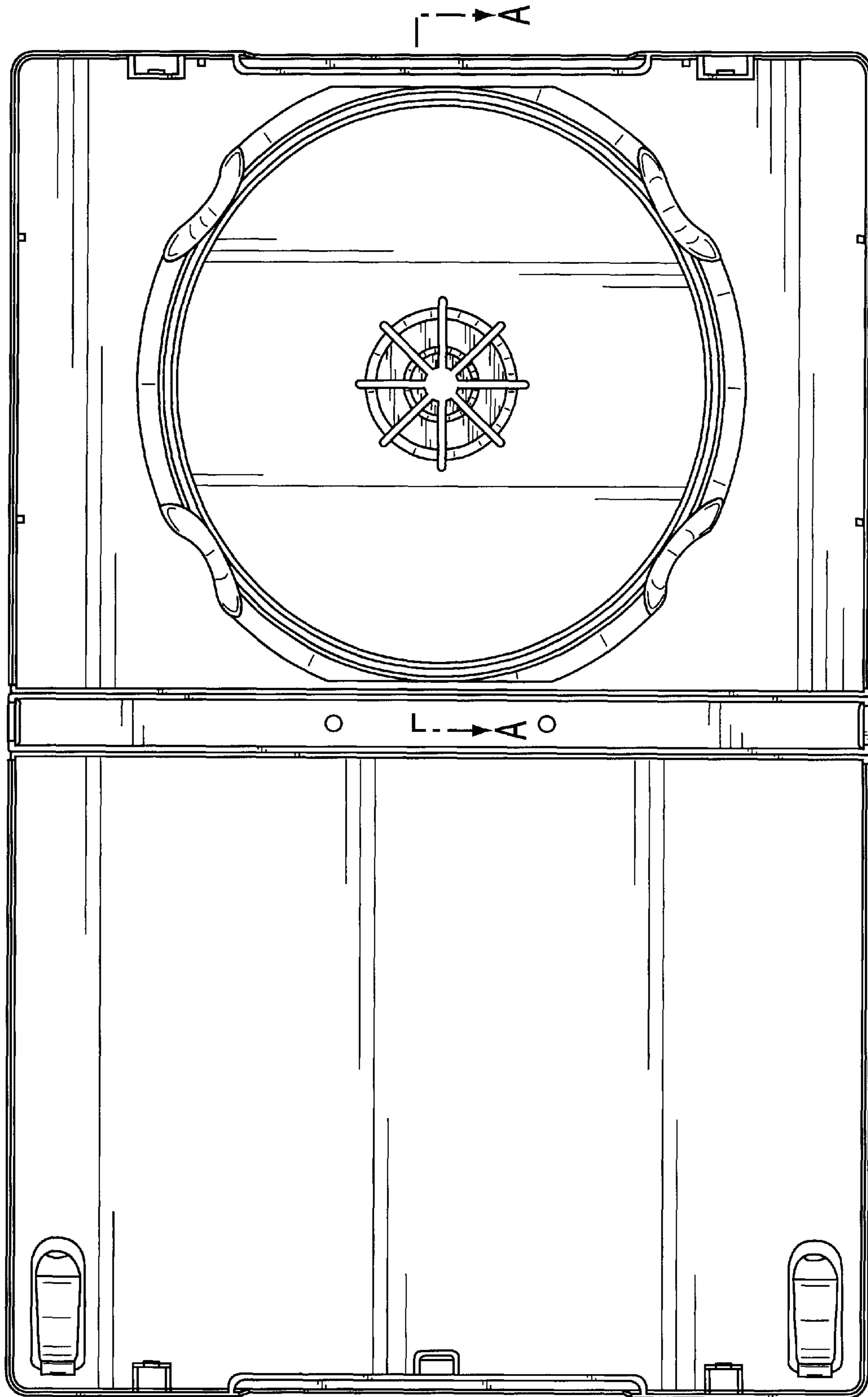

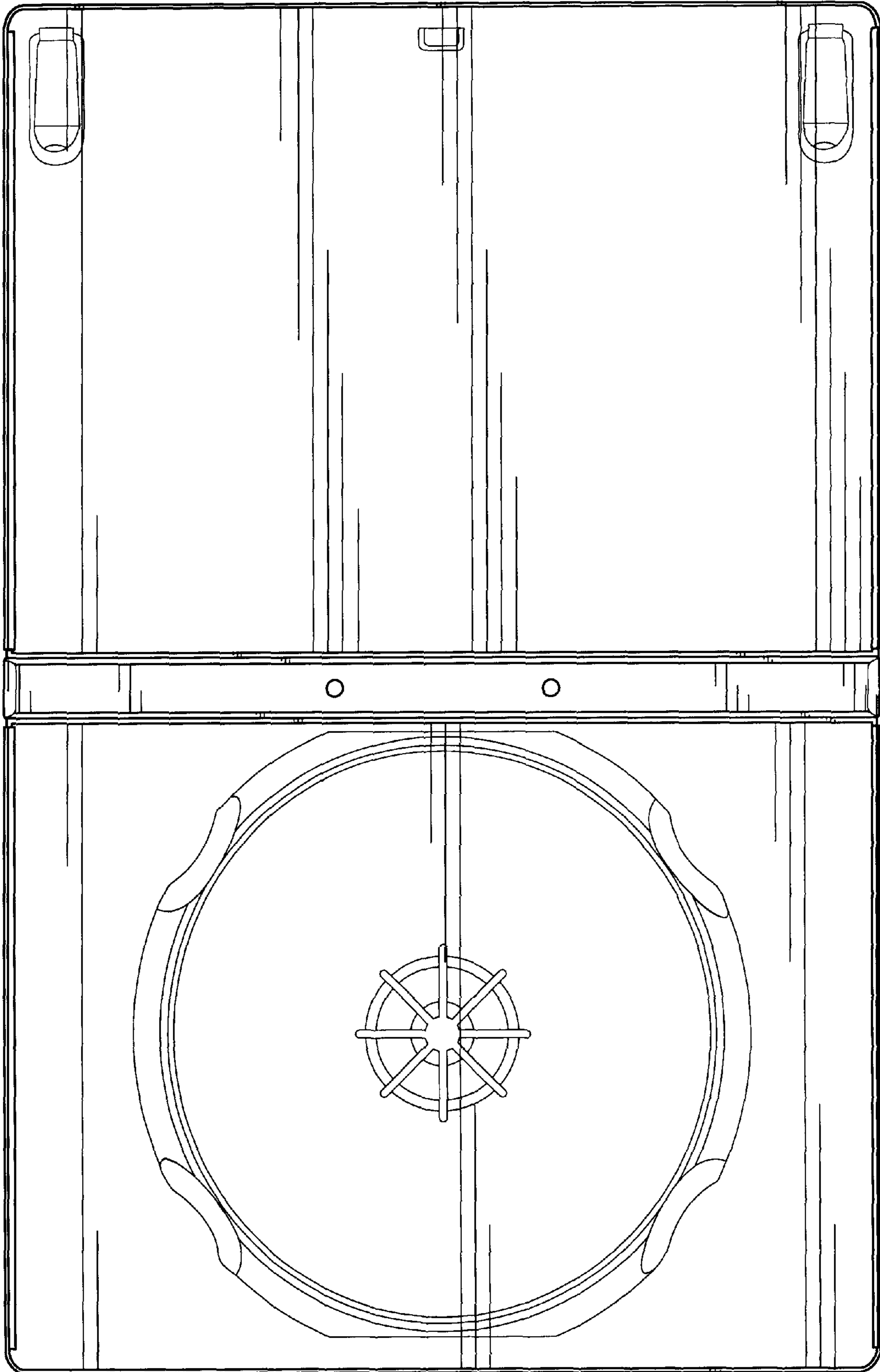

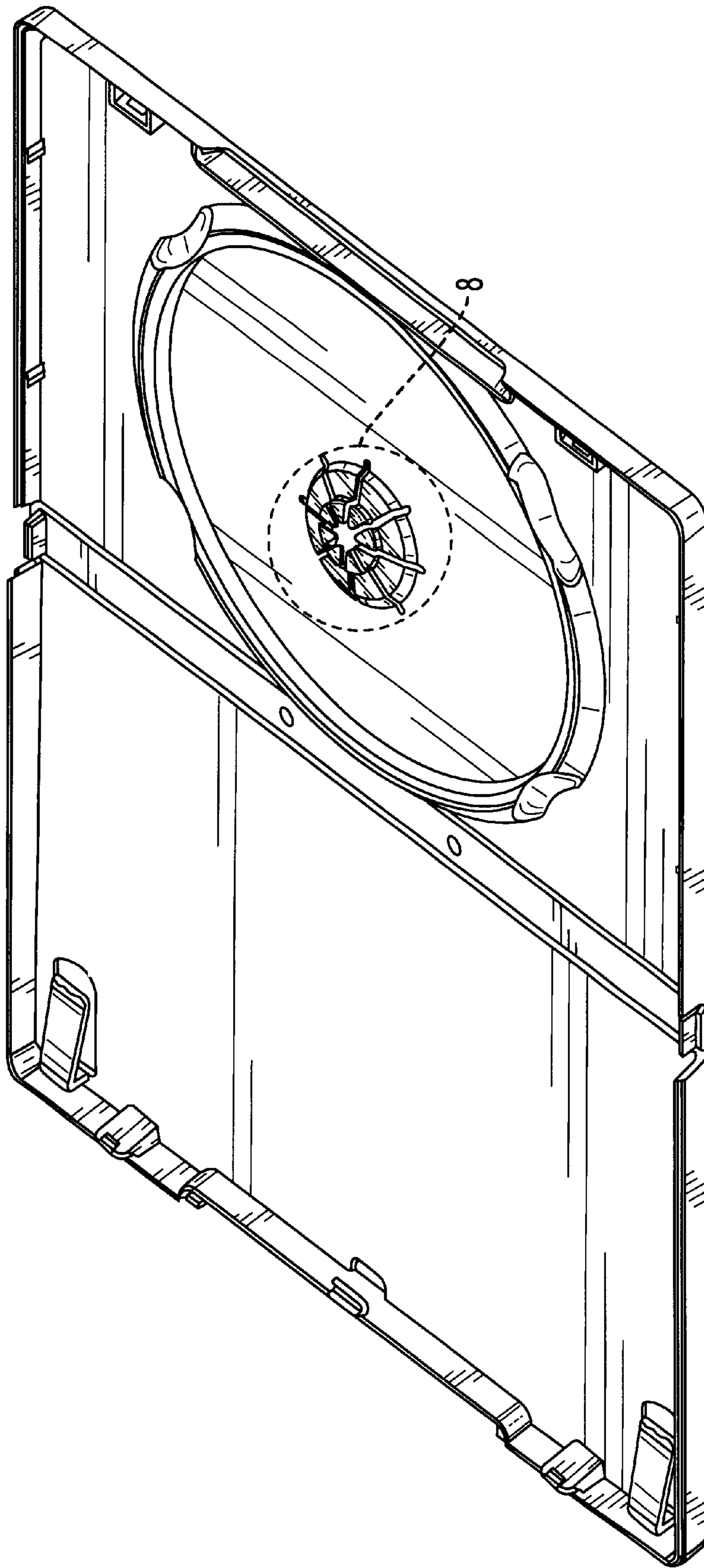

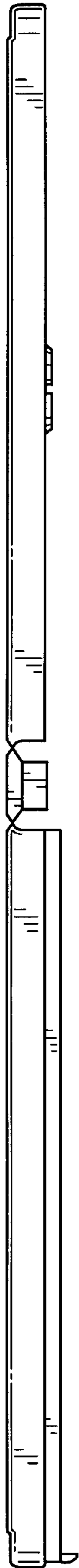

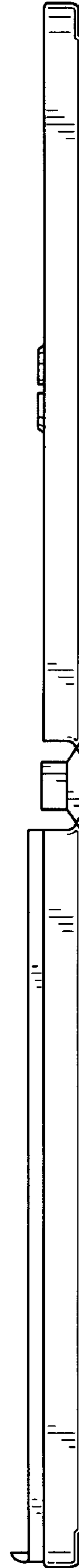

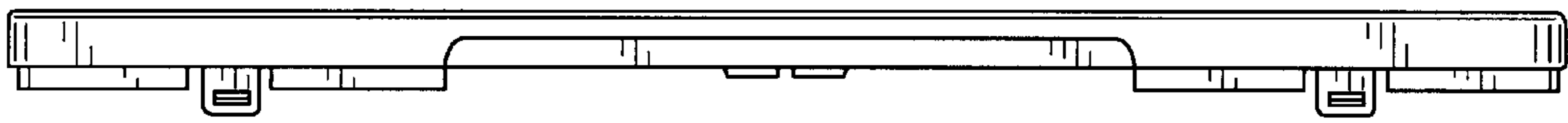

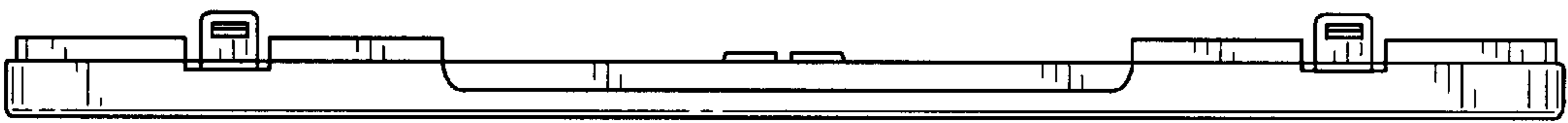

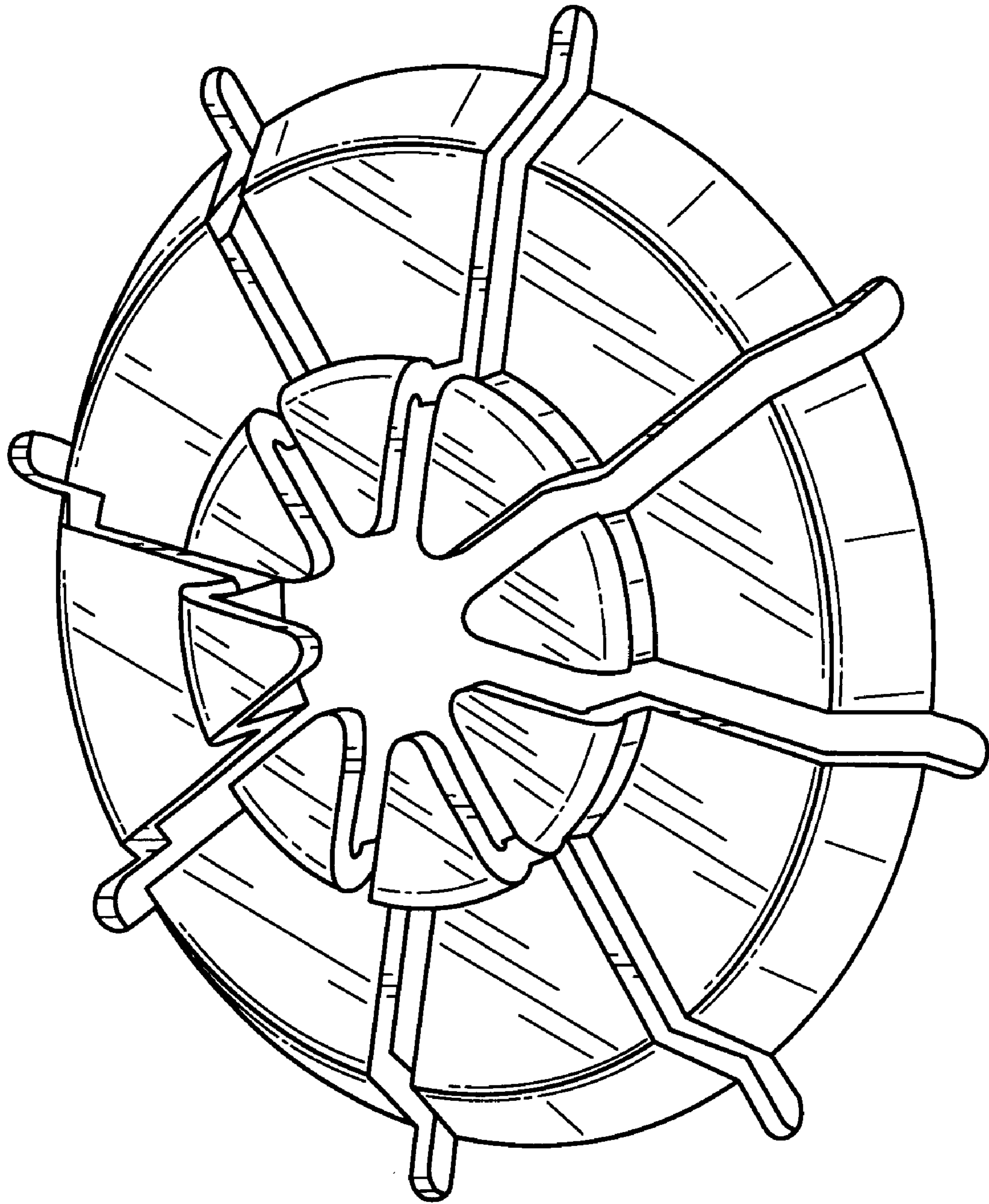
