FIG. 1 is a top perspective view of the snack packaging of the present invention;

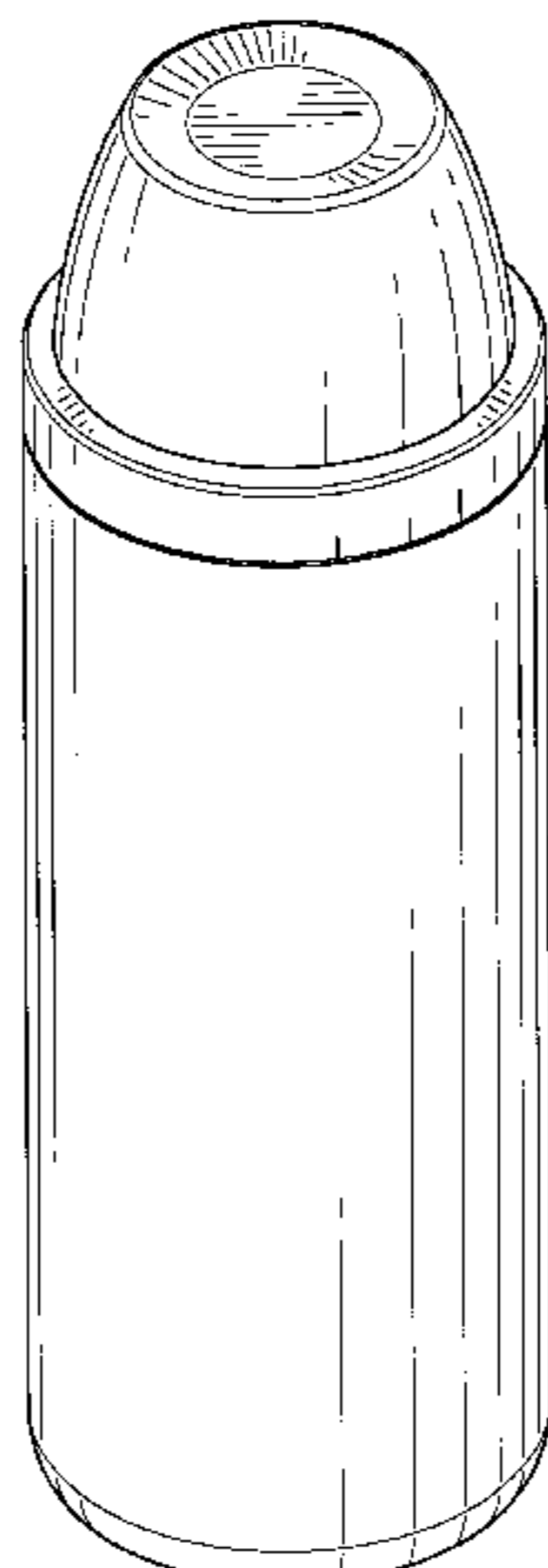
FIG. 2 is a side view of the snack packaging of the present invention;

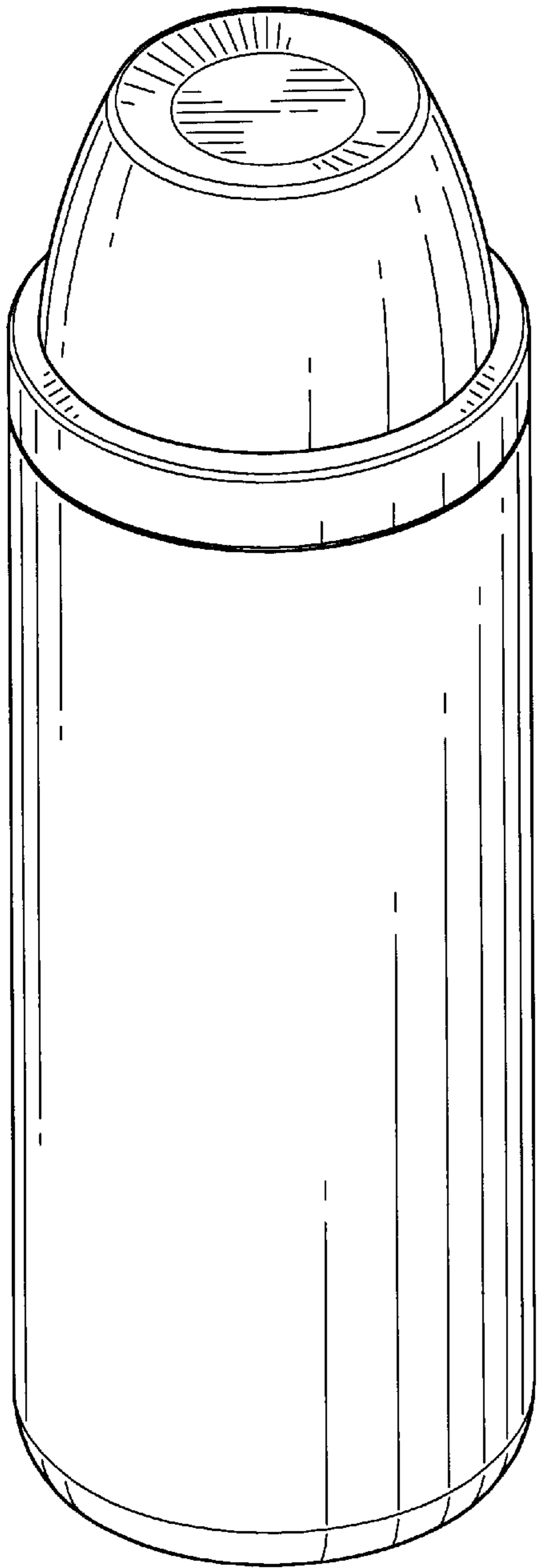

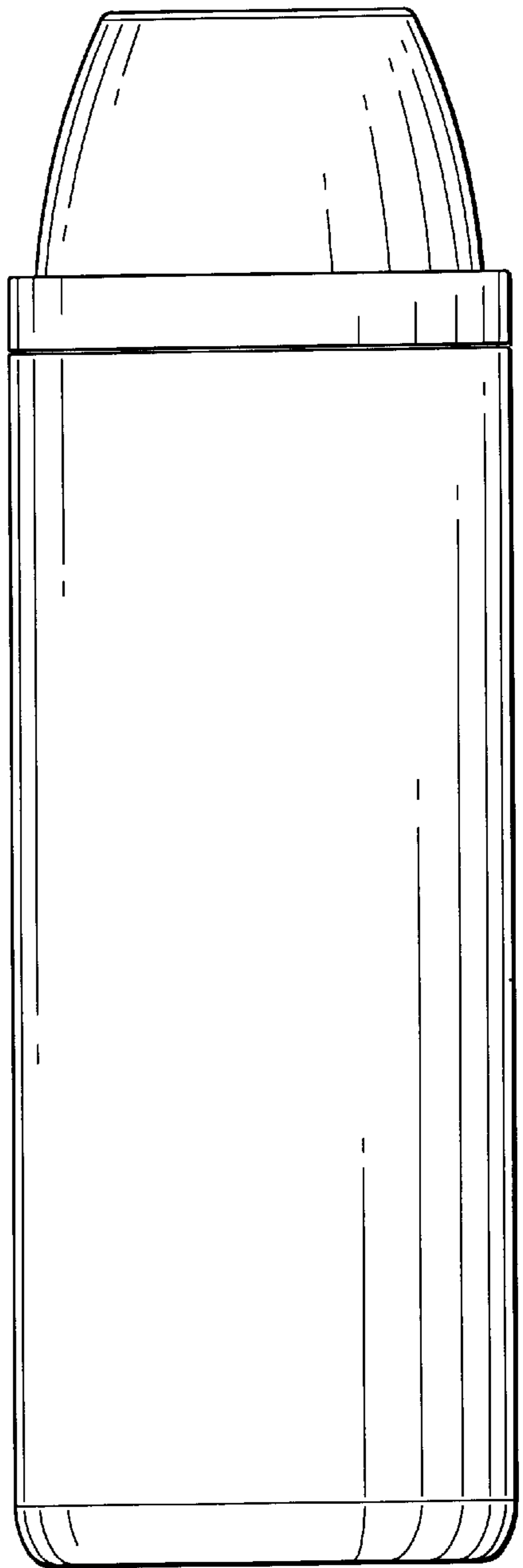

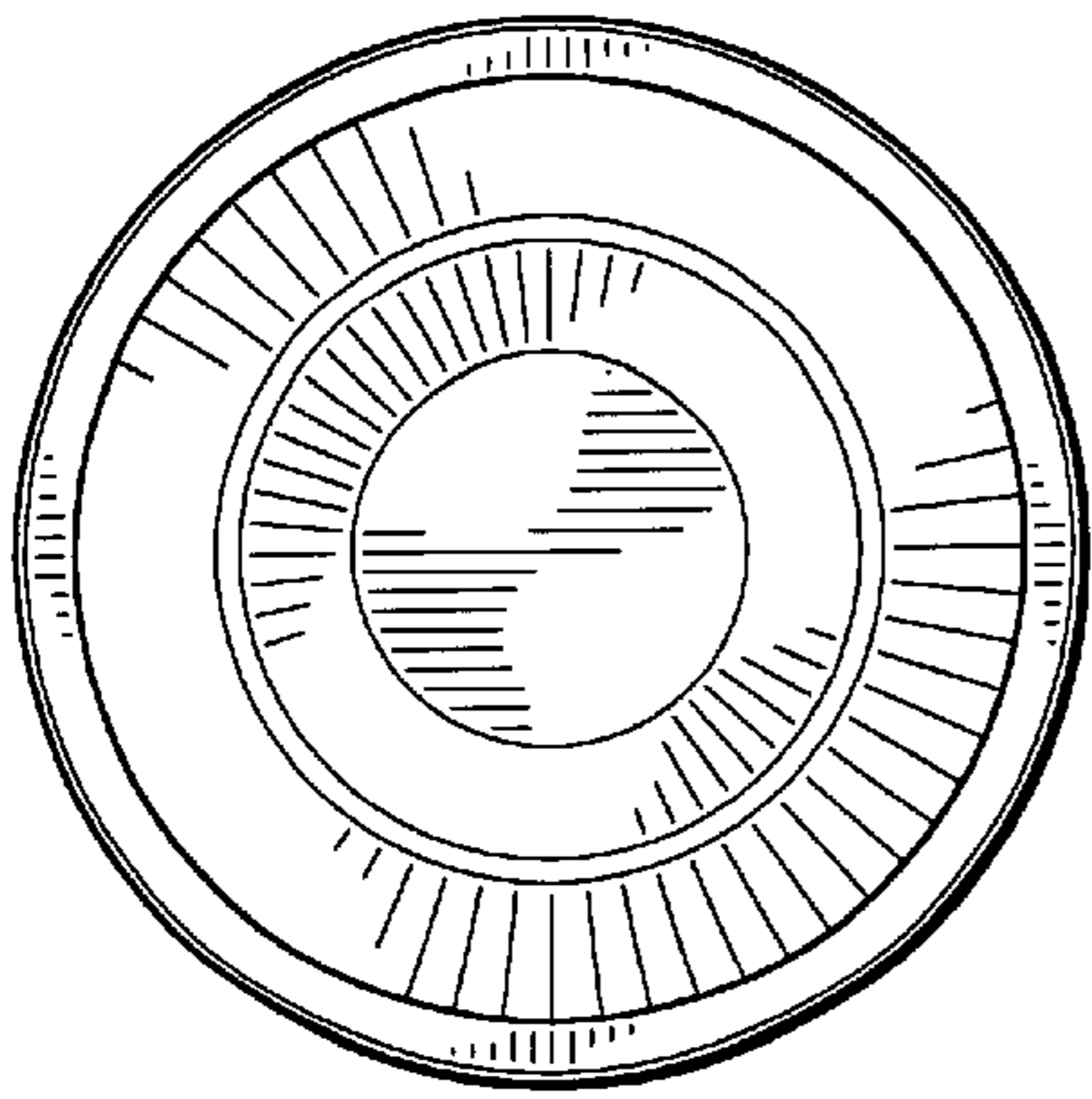

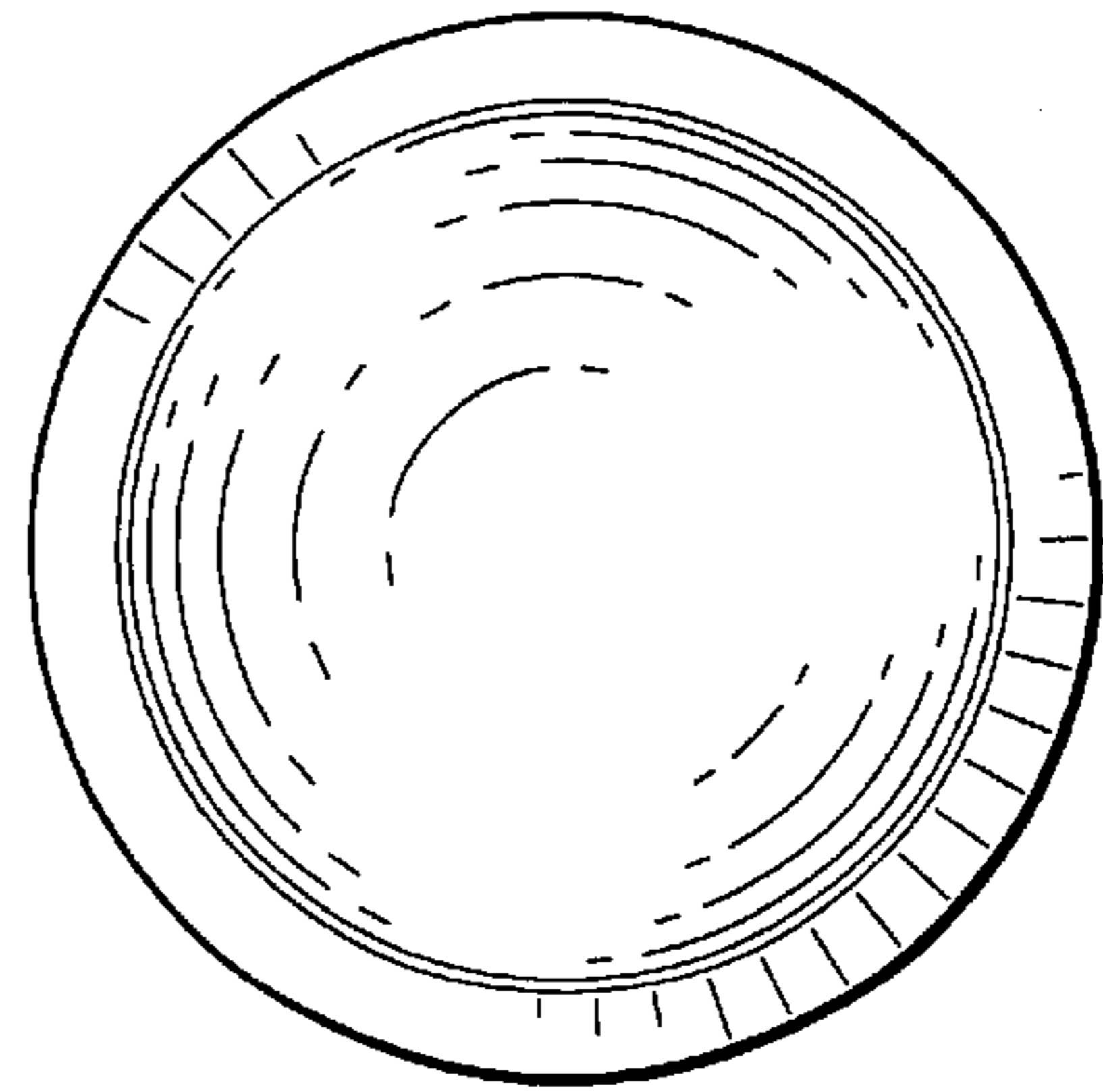

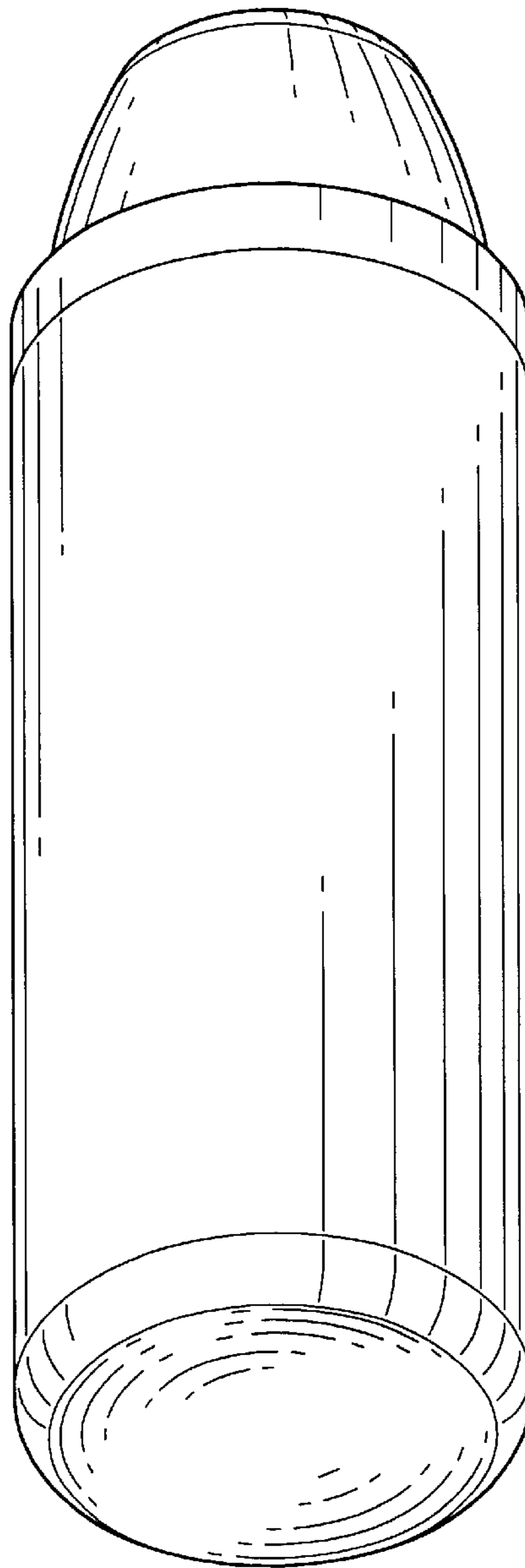
