FIG. 7 is a bottom plan view of the head lamp for automobile according to the present invention.

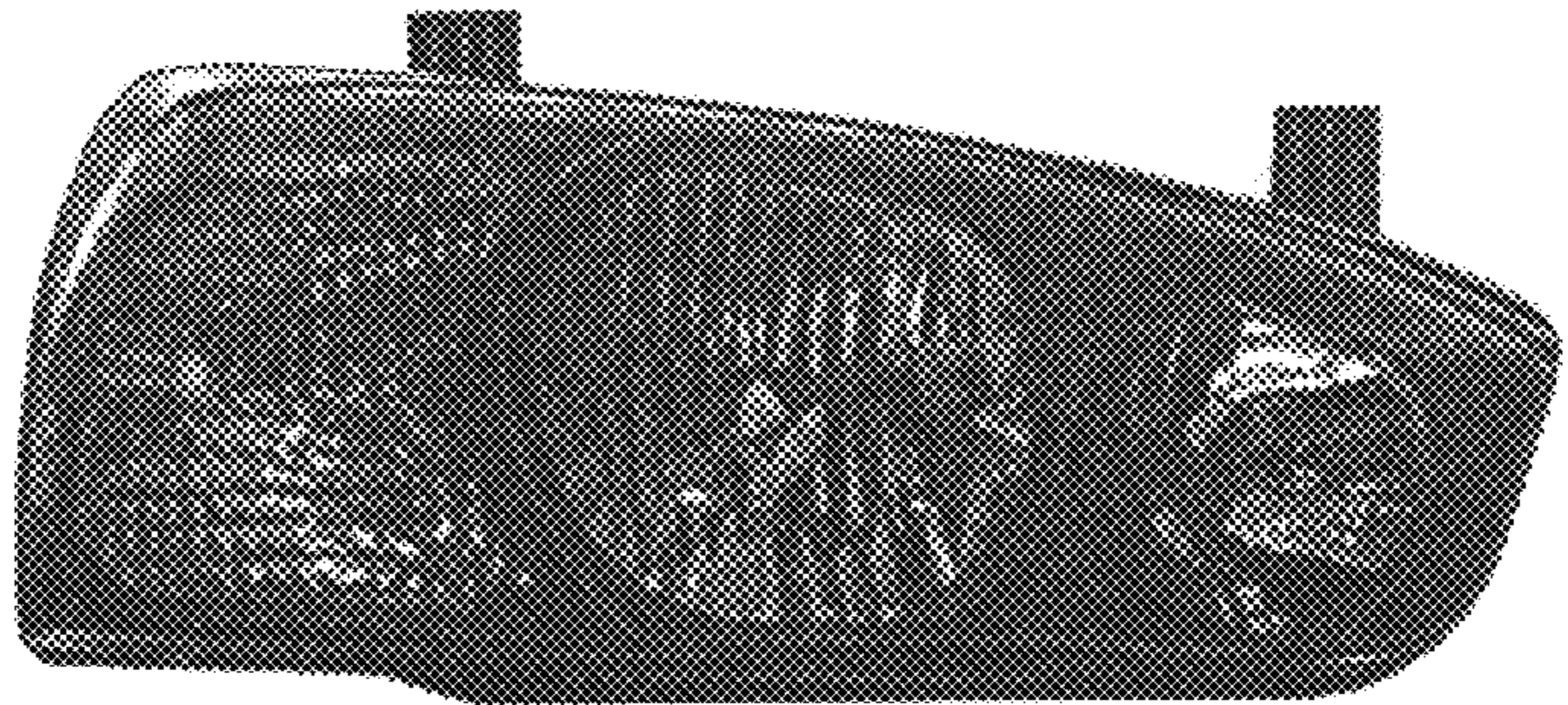
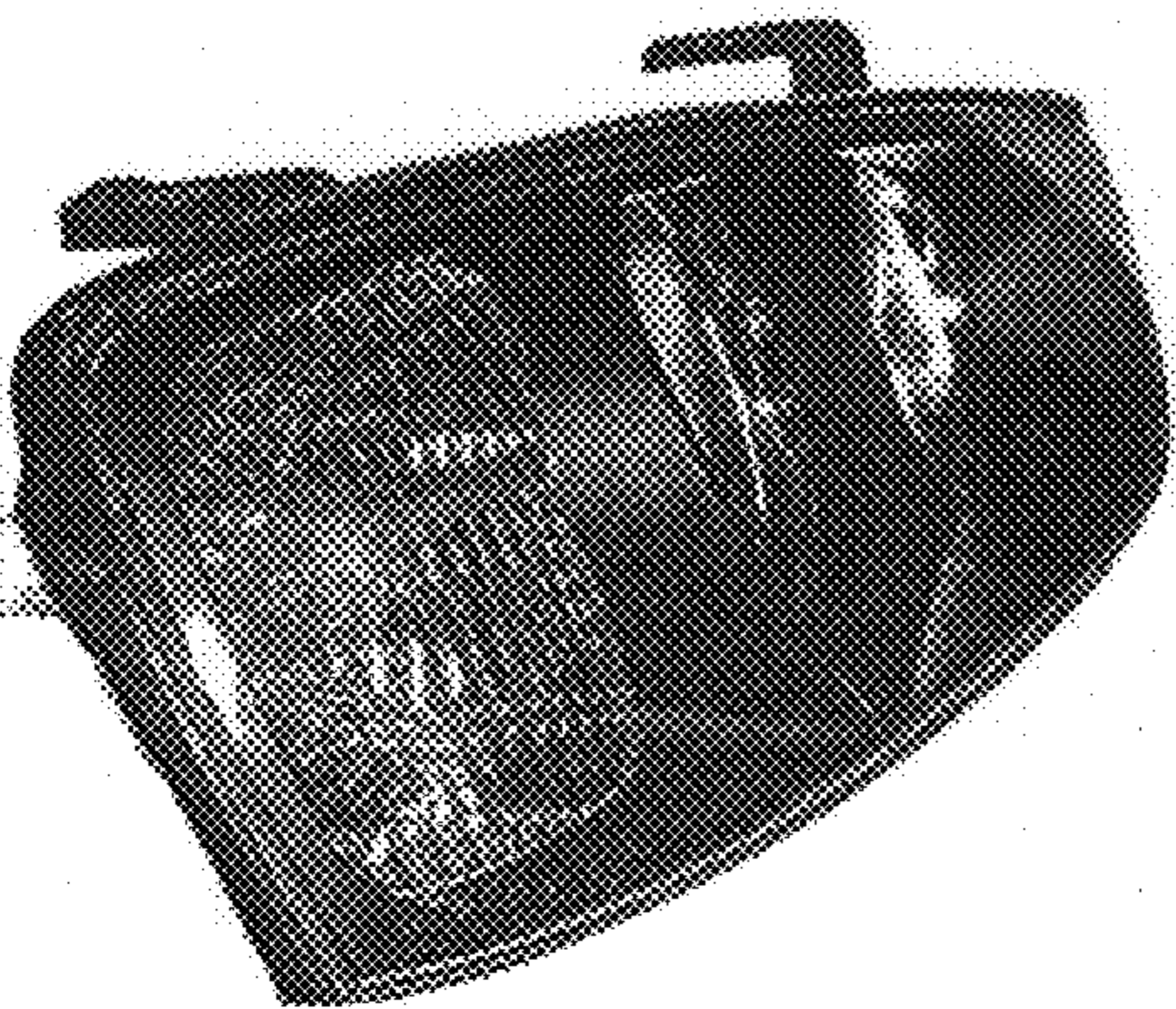

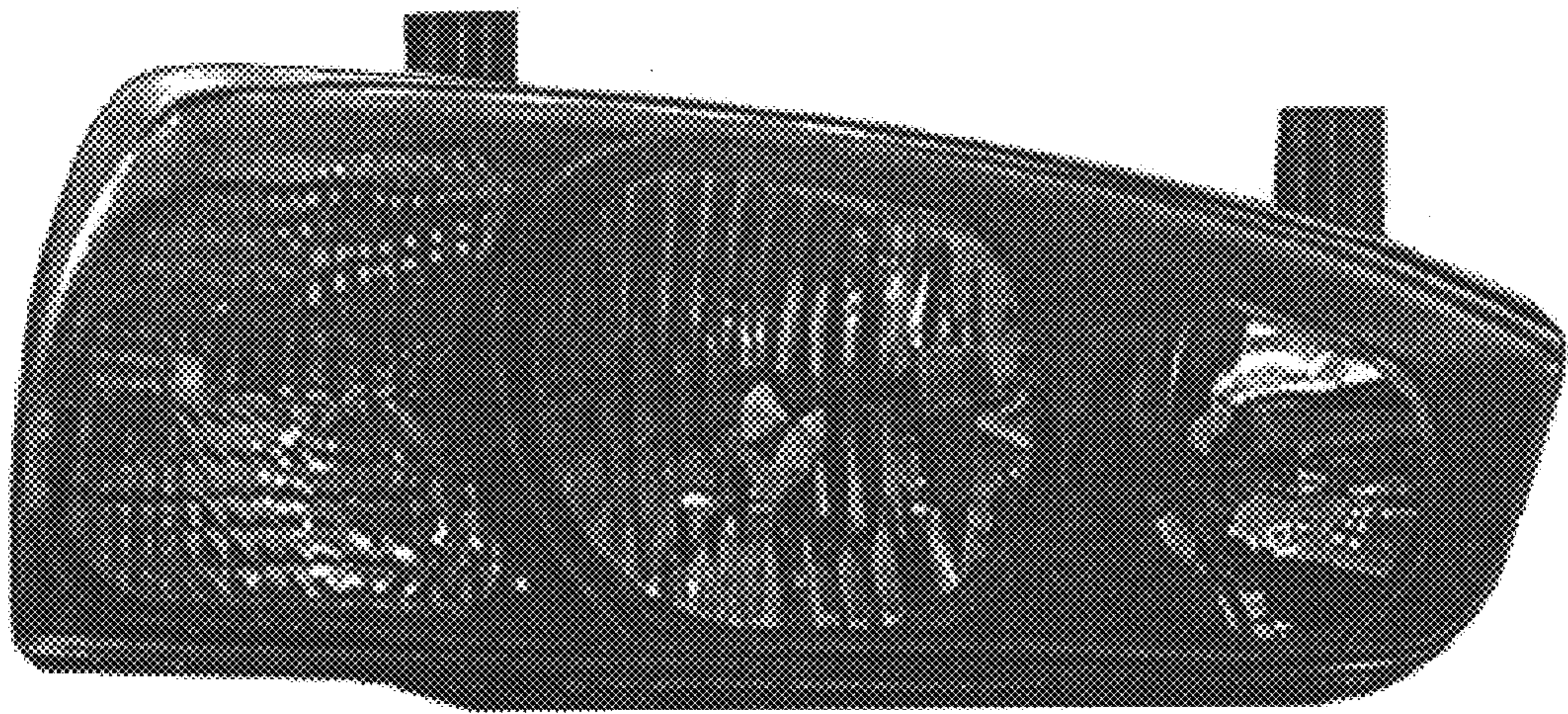

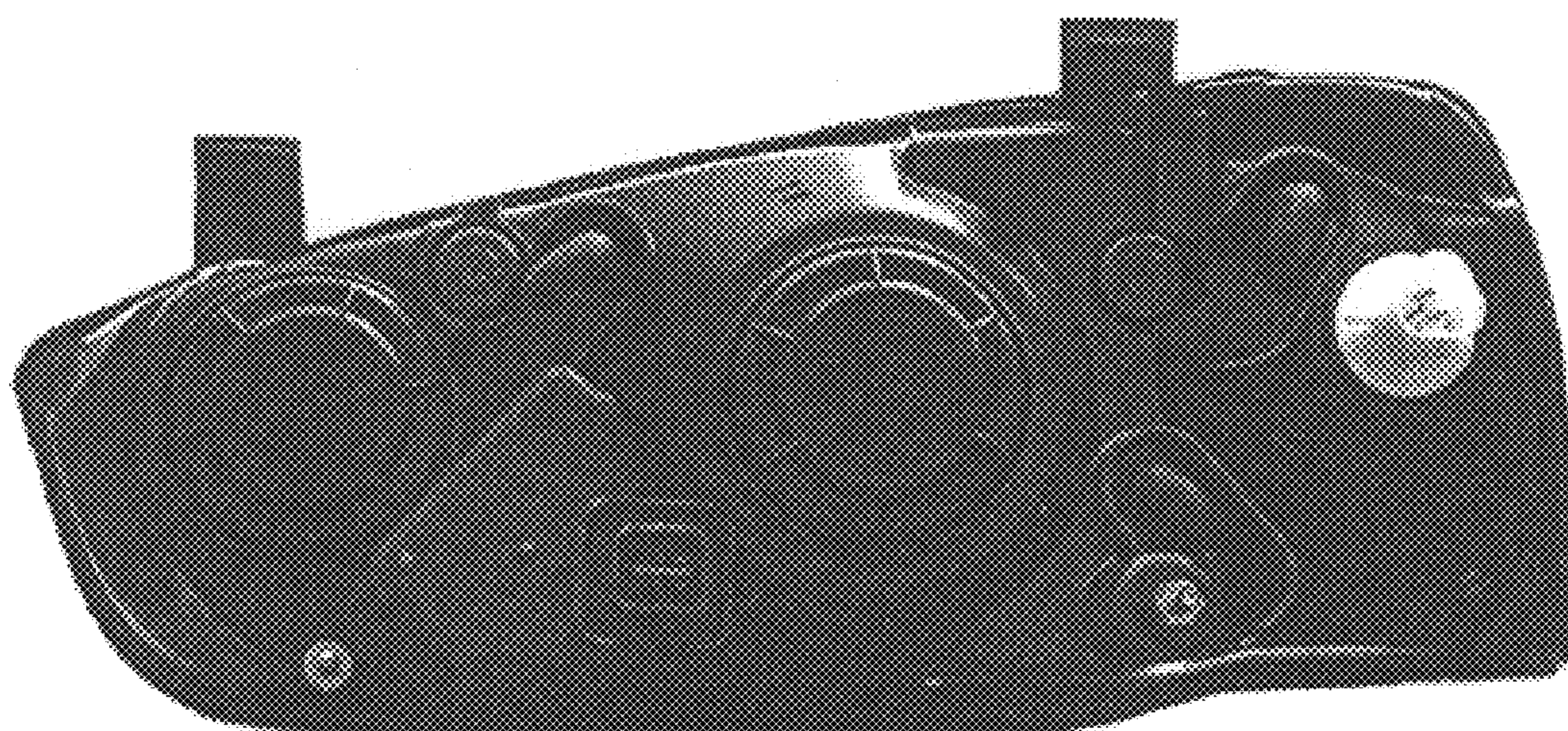




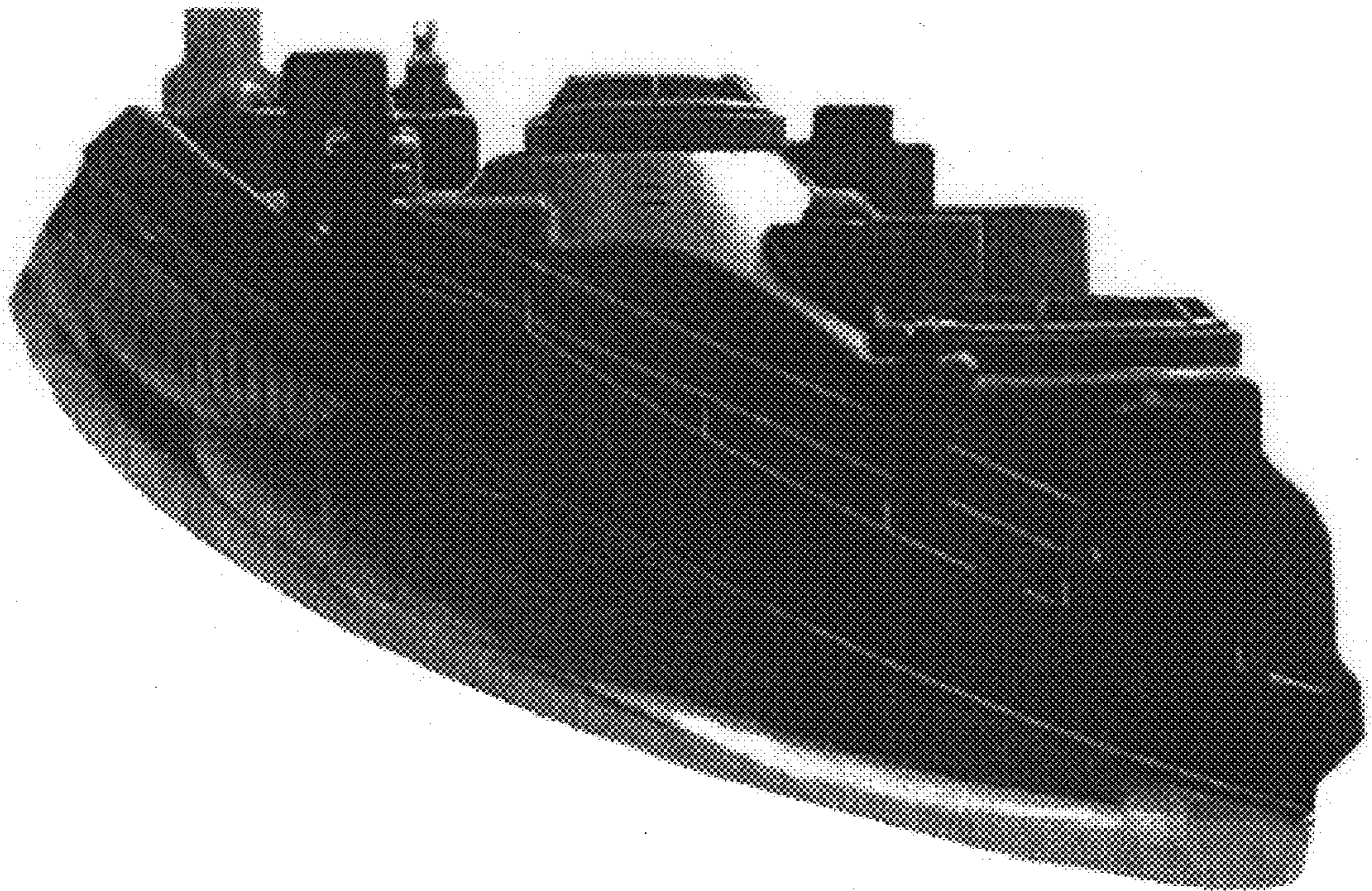

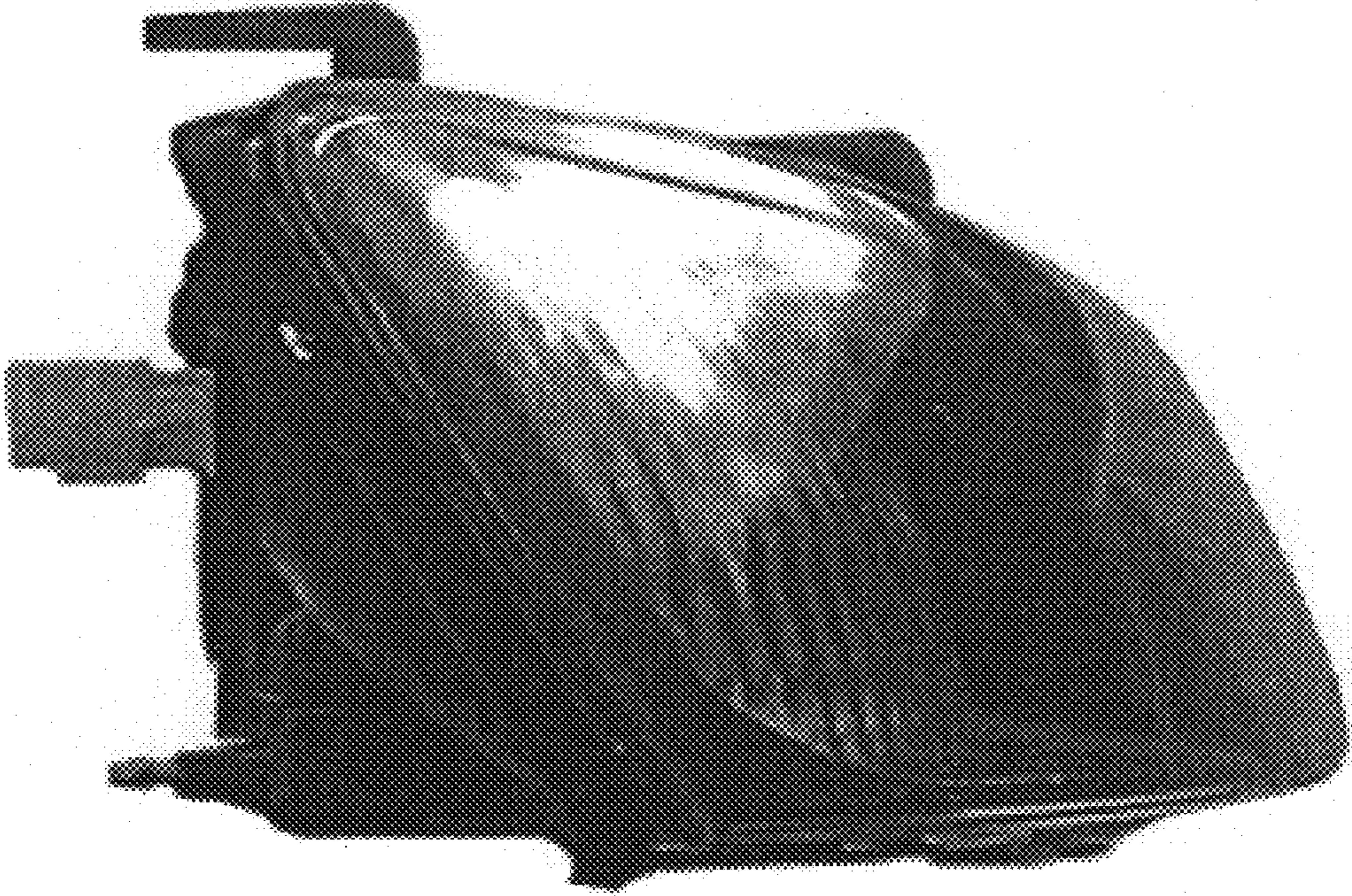

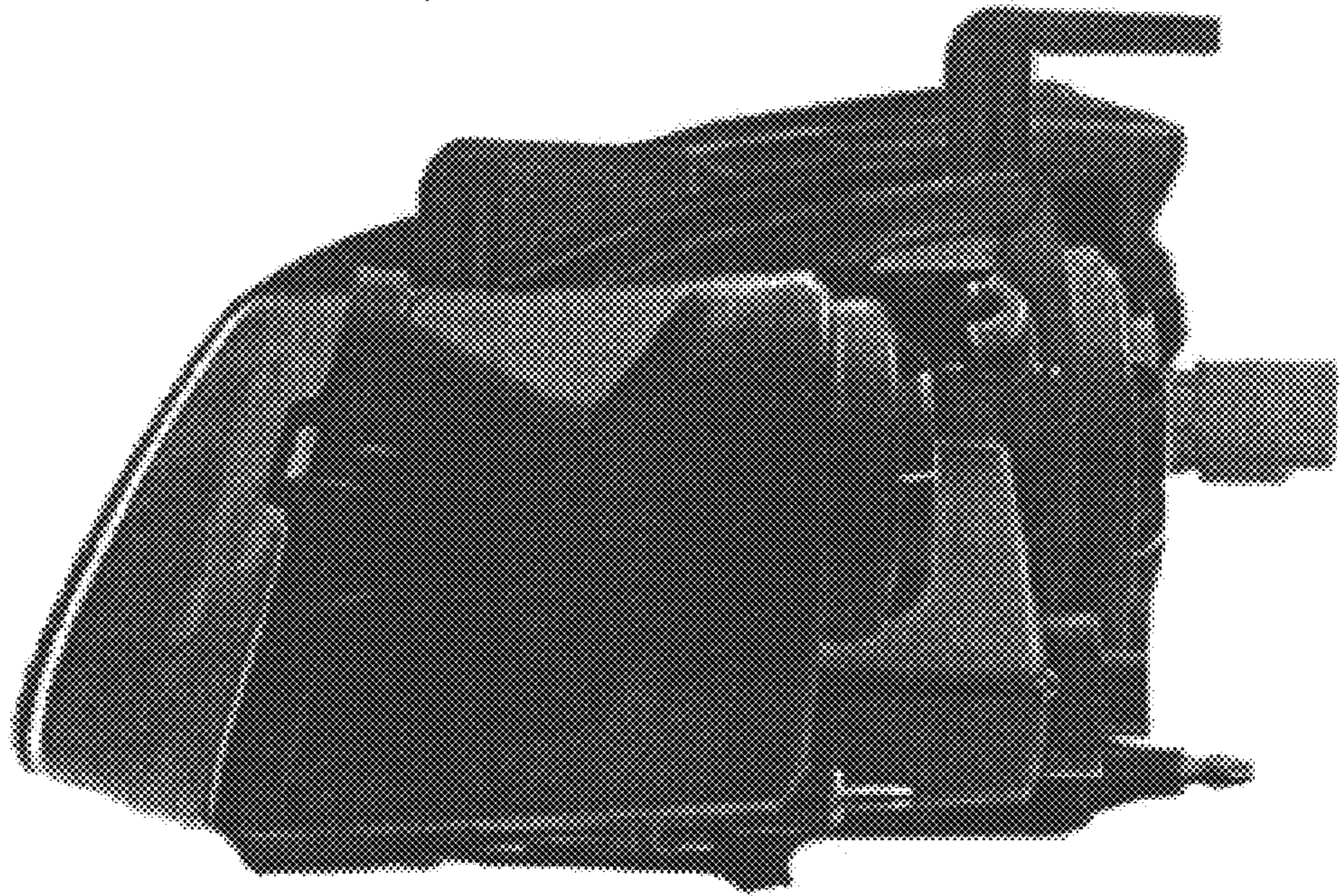

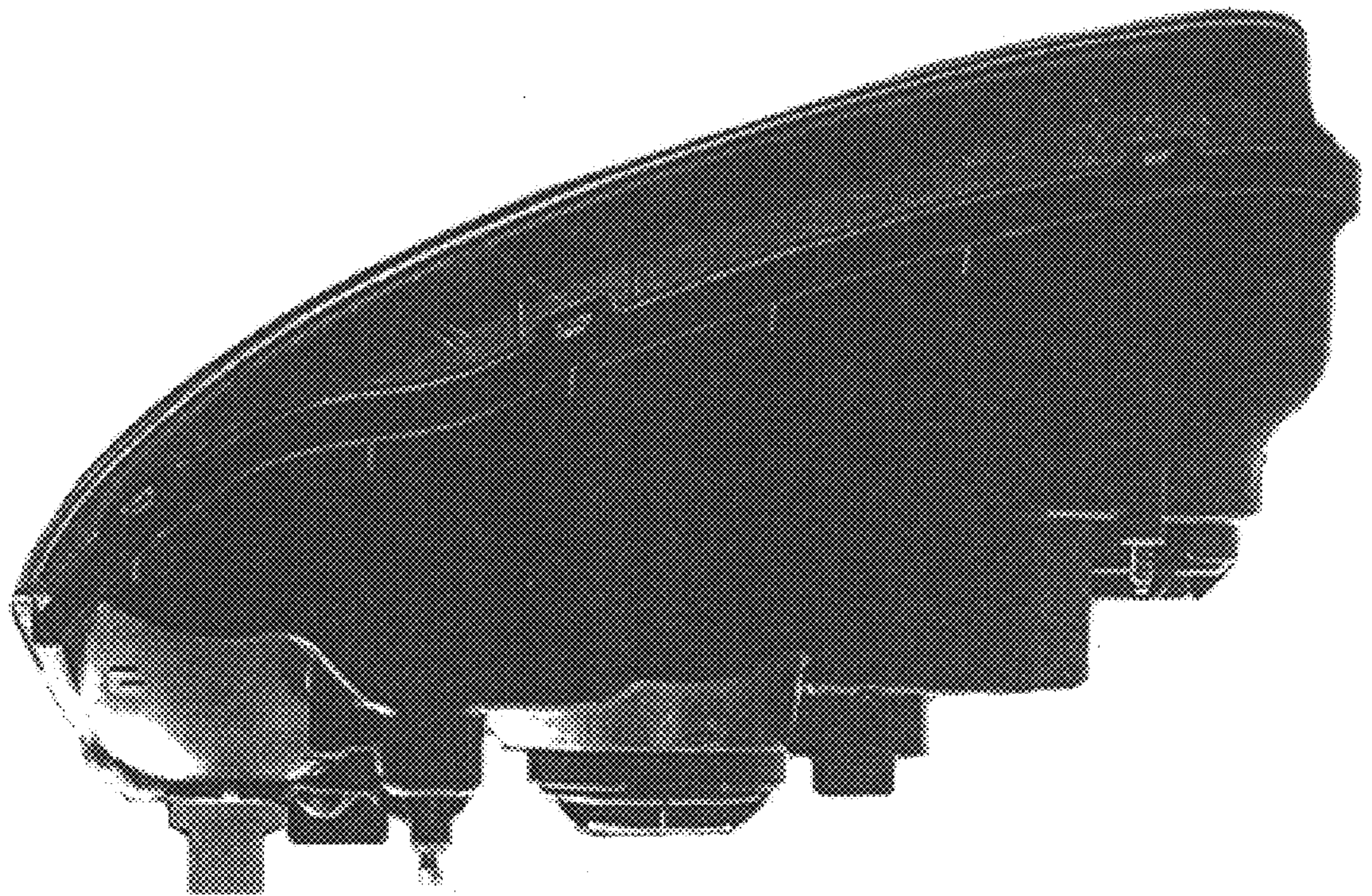
