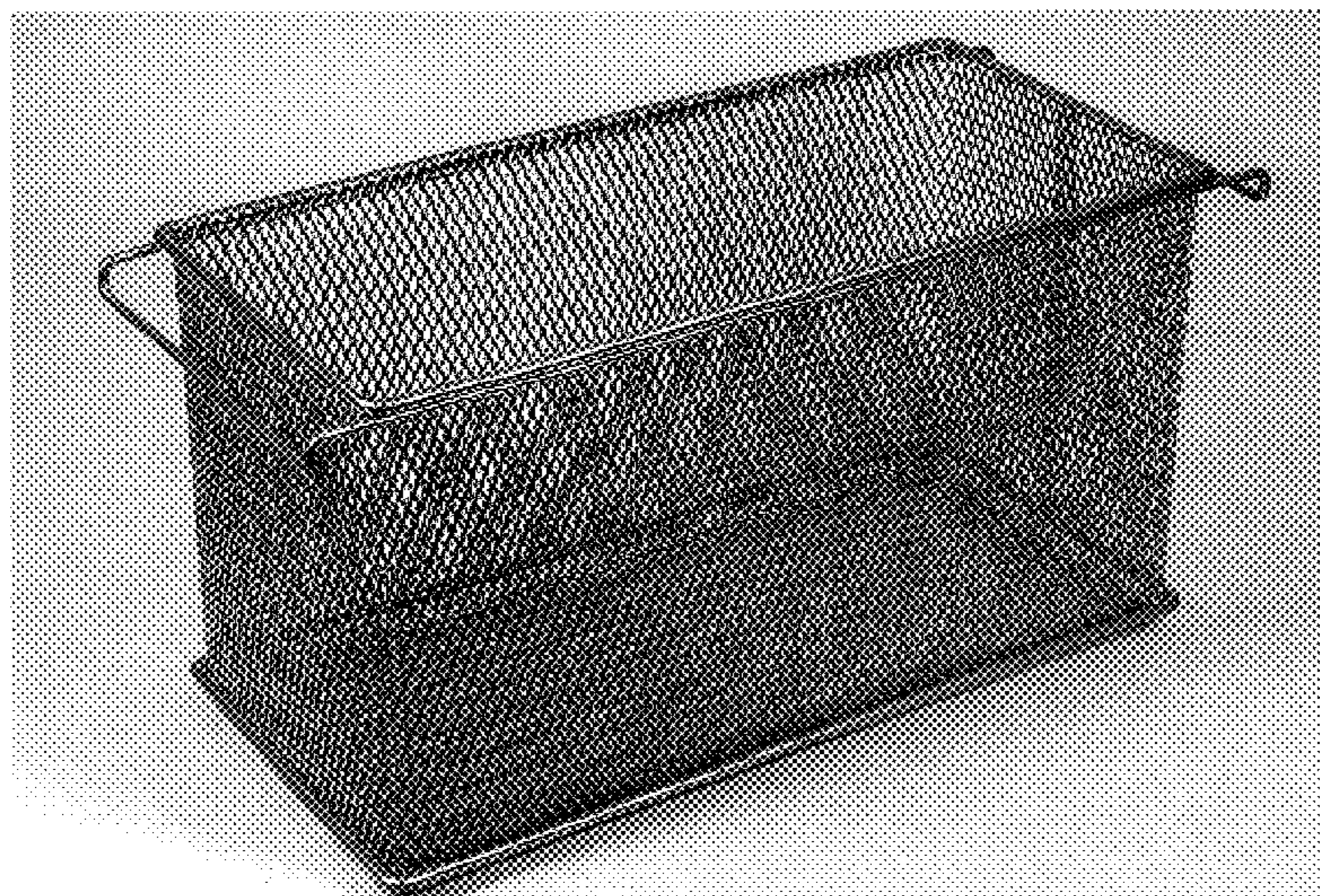
(57) **CLAIM**

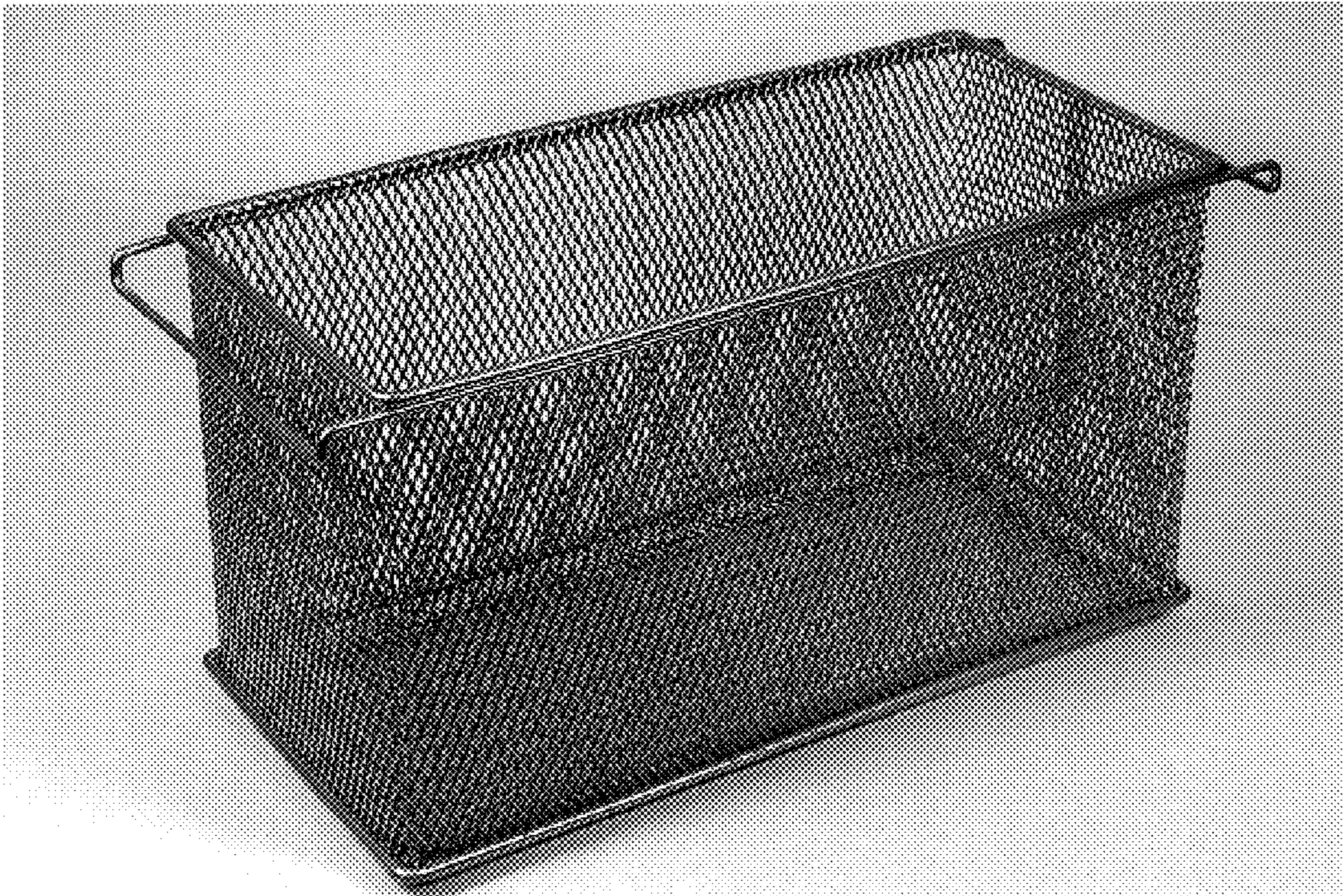
The ornamental design for a mesh file drawer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mesh file drawer showing my new design;

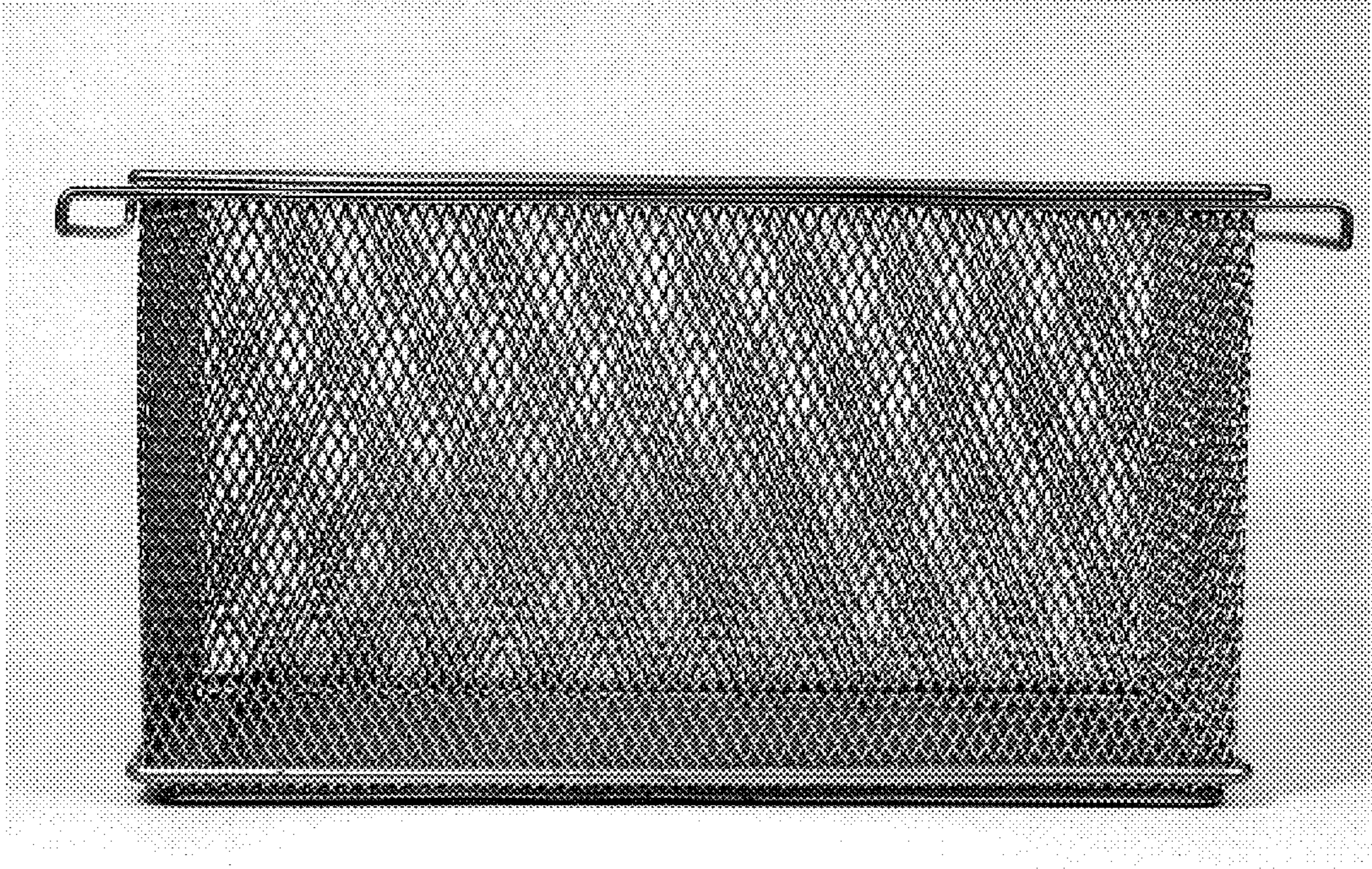

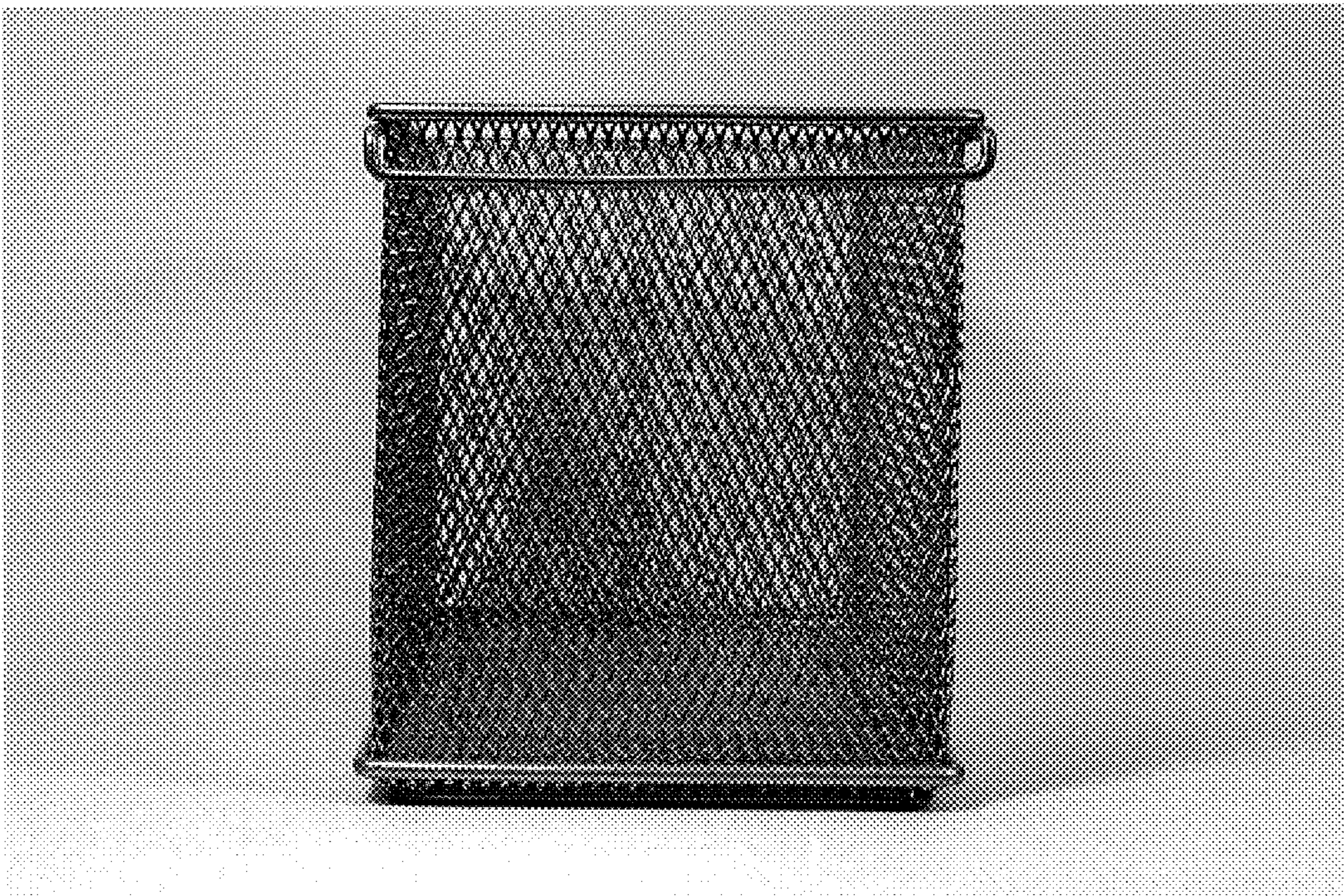
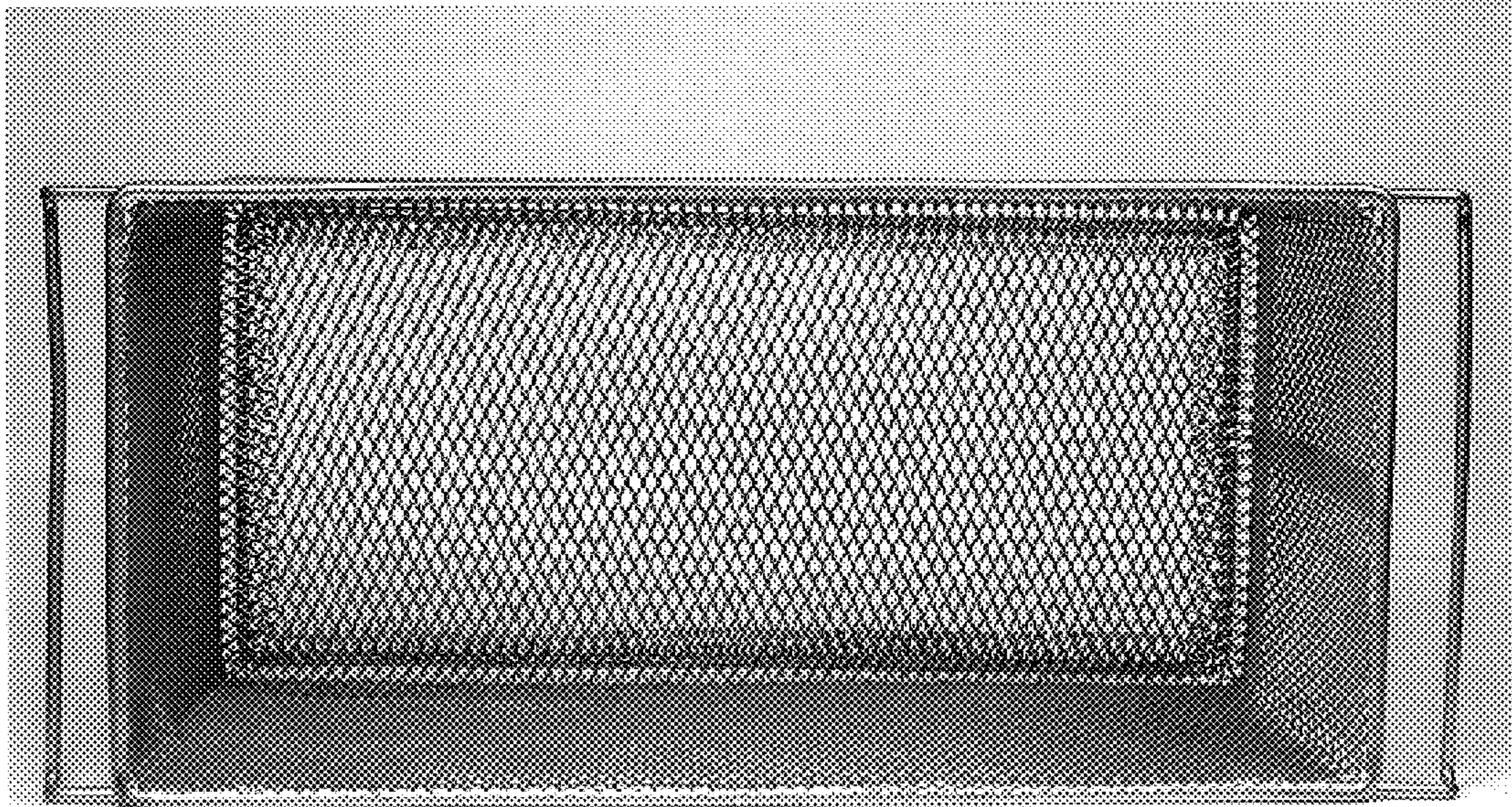
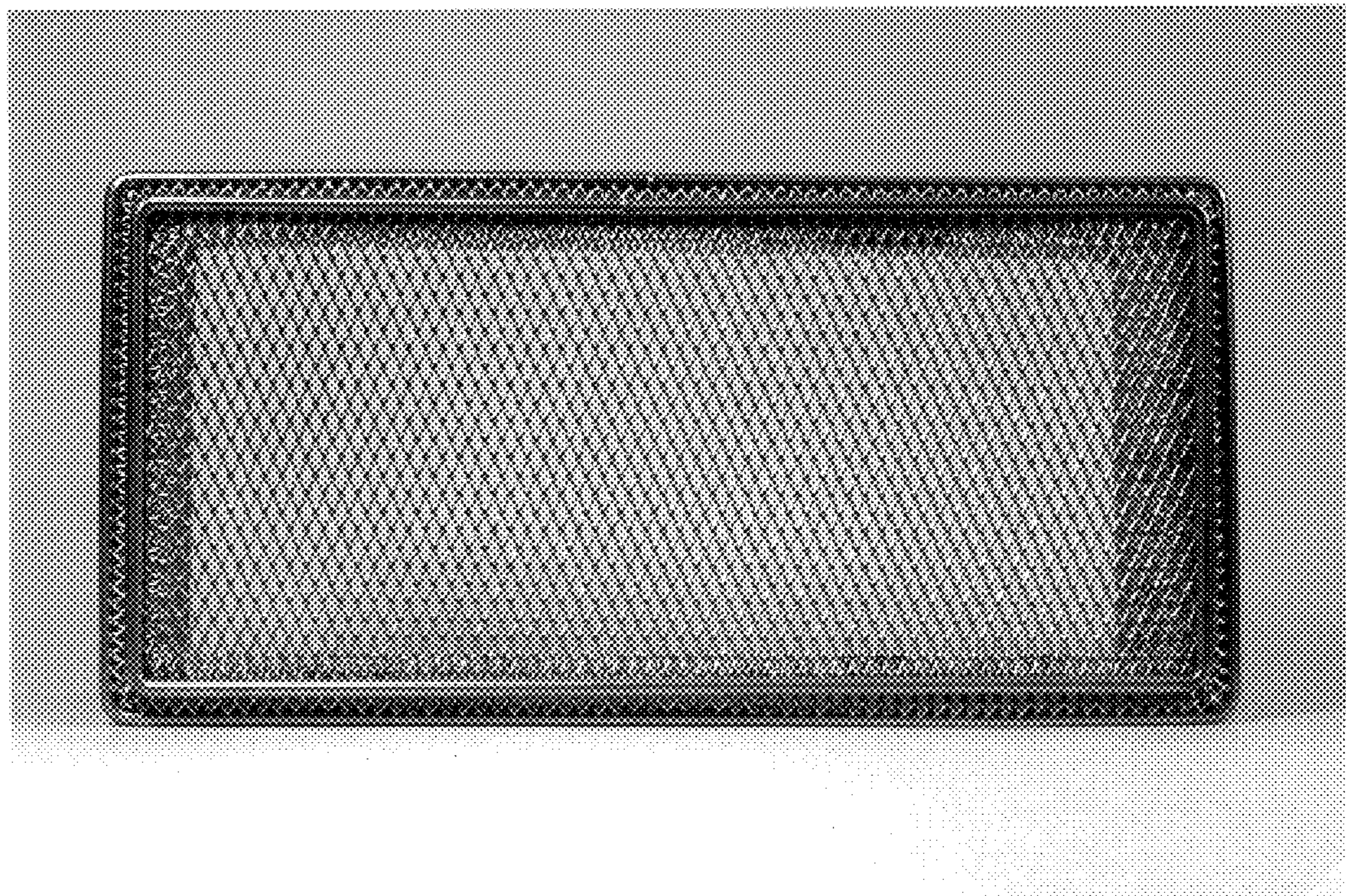
