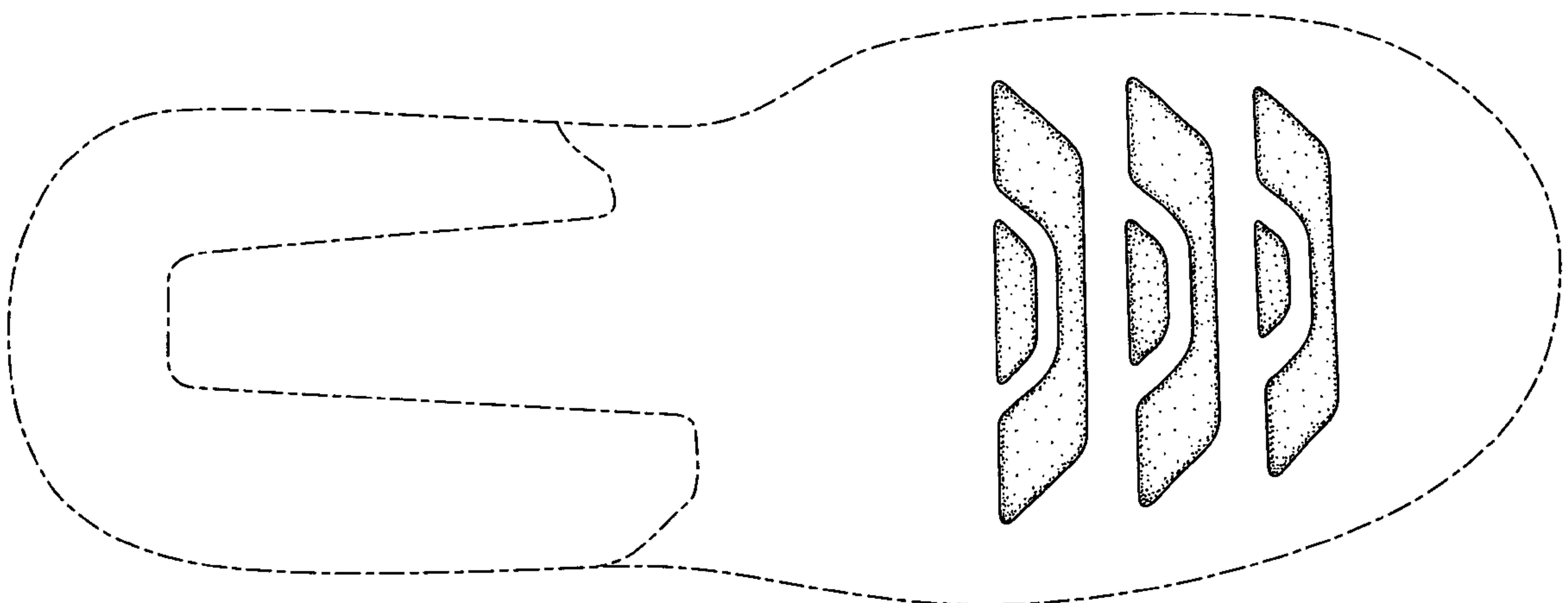
(57) **CLAIM**

The ornamental design for a portion of a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a portion of a shoe sole showing my new design;

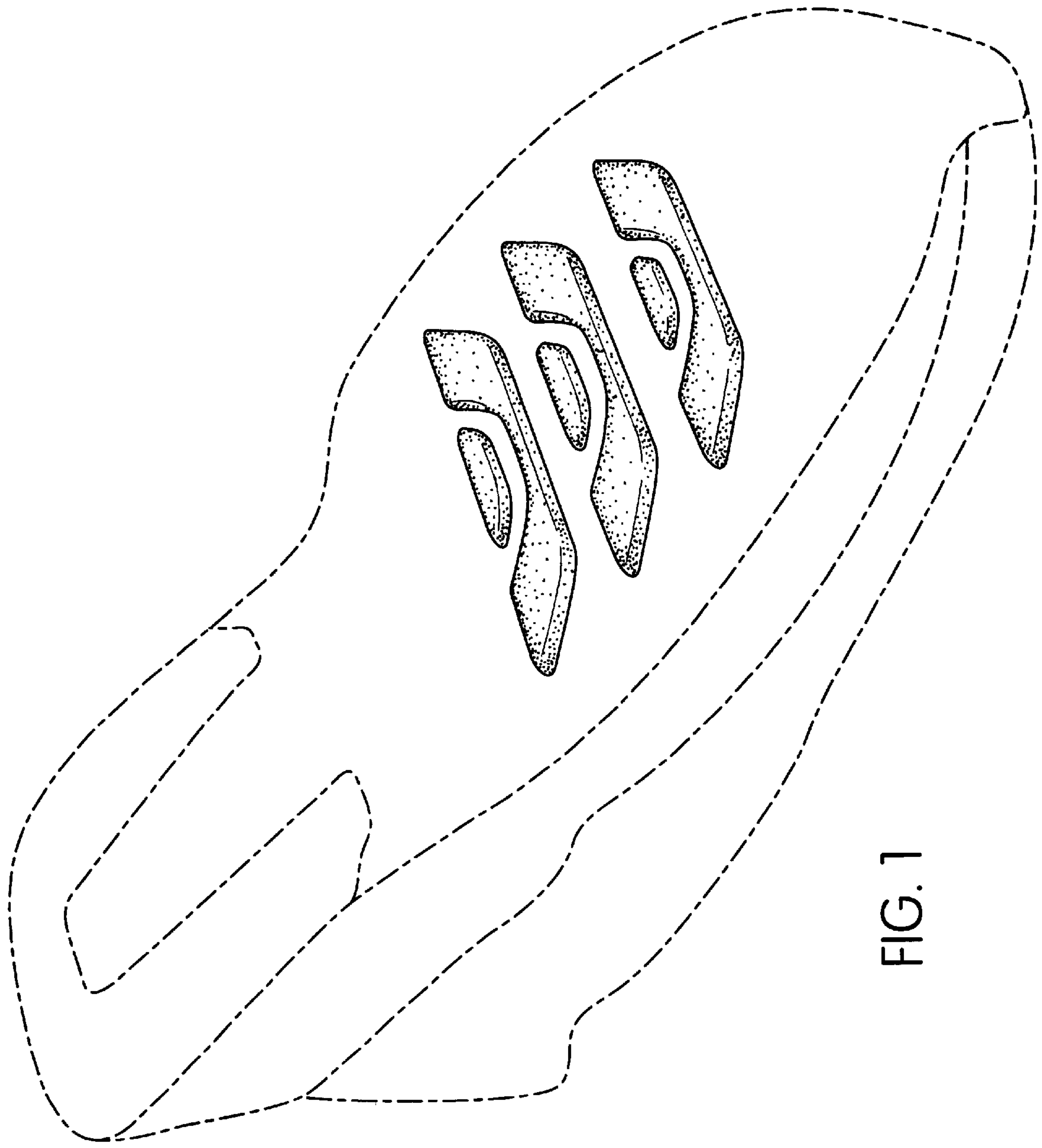

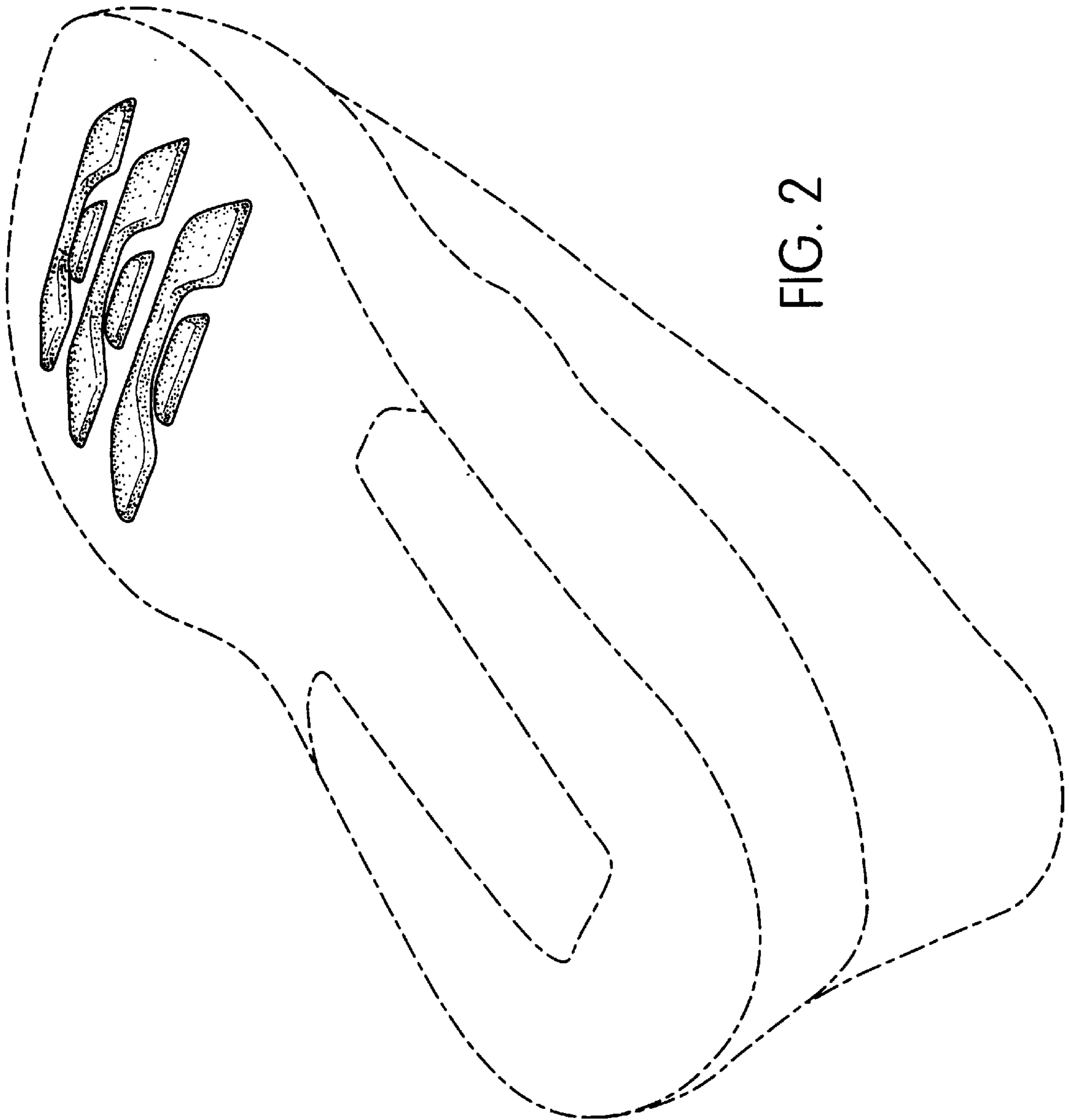

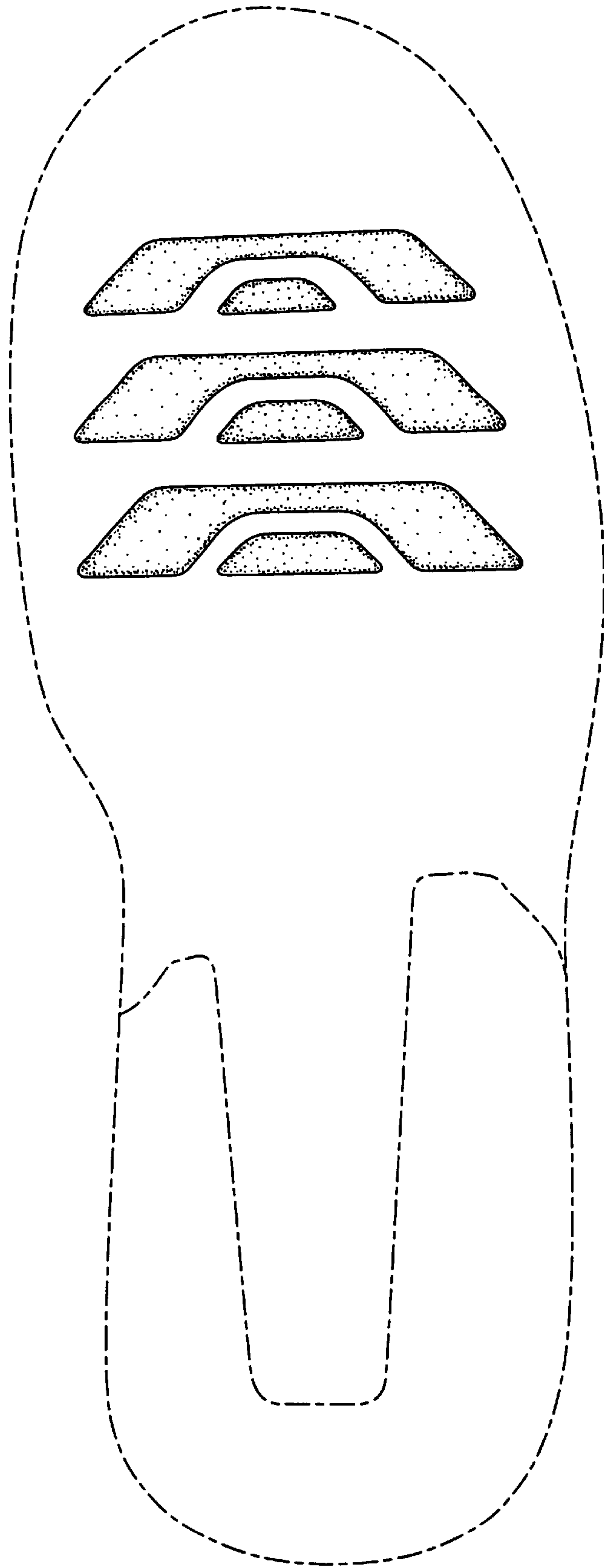
