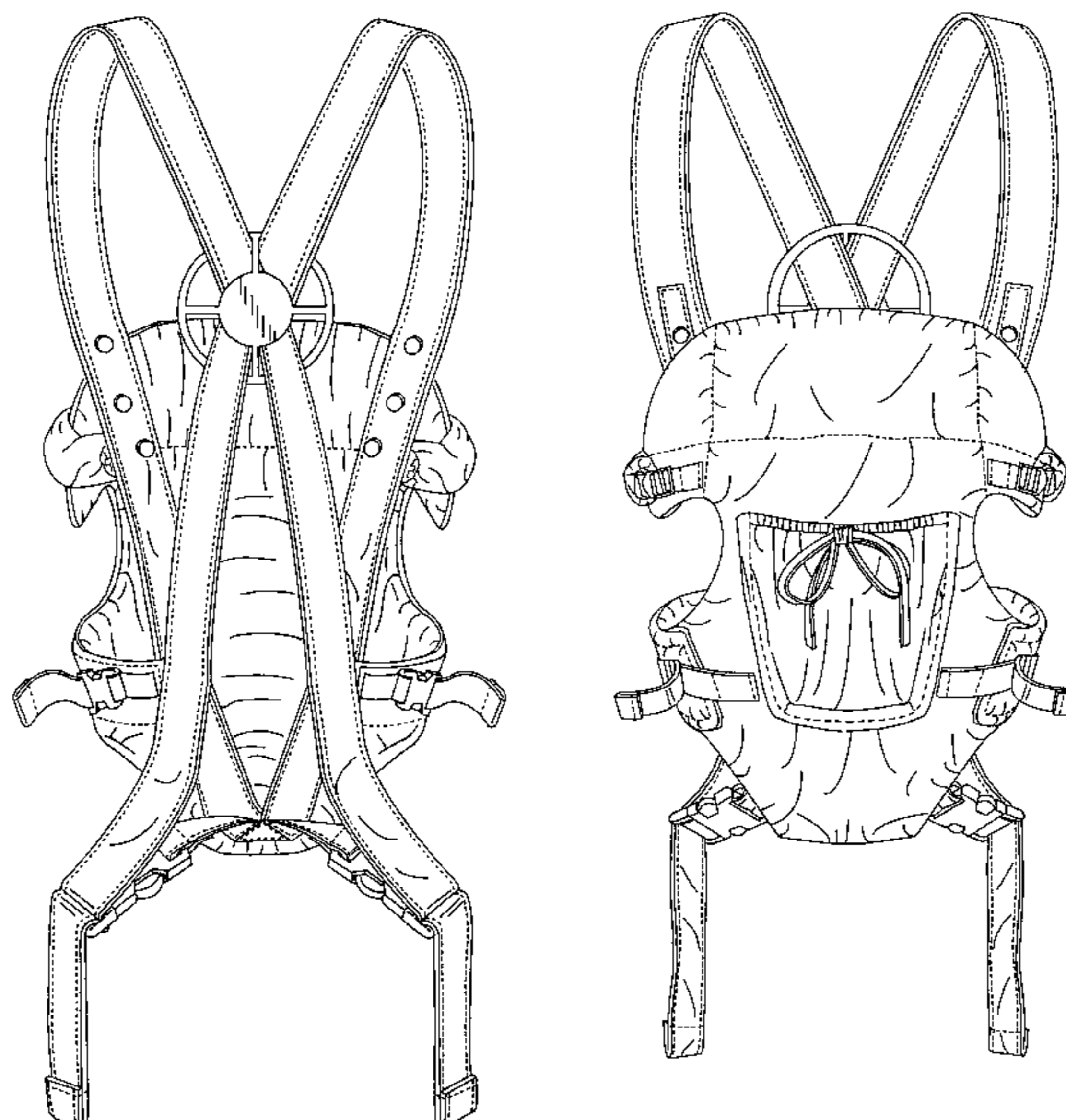
(57) **CLAIM**

The ornamental design for an infant carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the infant carrier of the present invention showing my new design;  
FIG. 2 is a back elevational view thereof;  
FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a top plan view thereof.  
The broken lines shown throughout the views are understood to represent stitching.

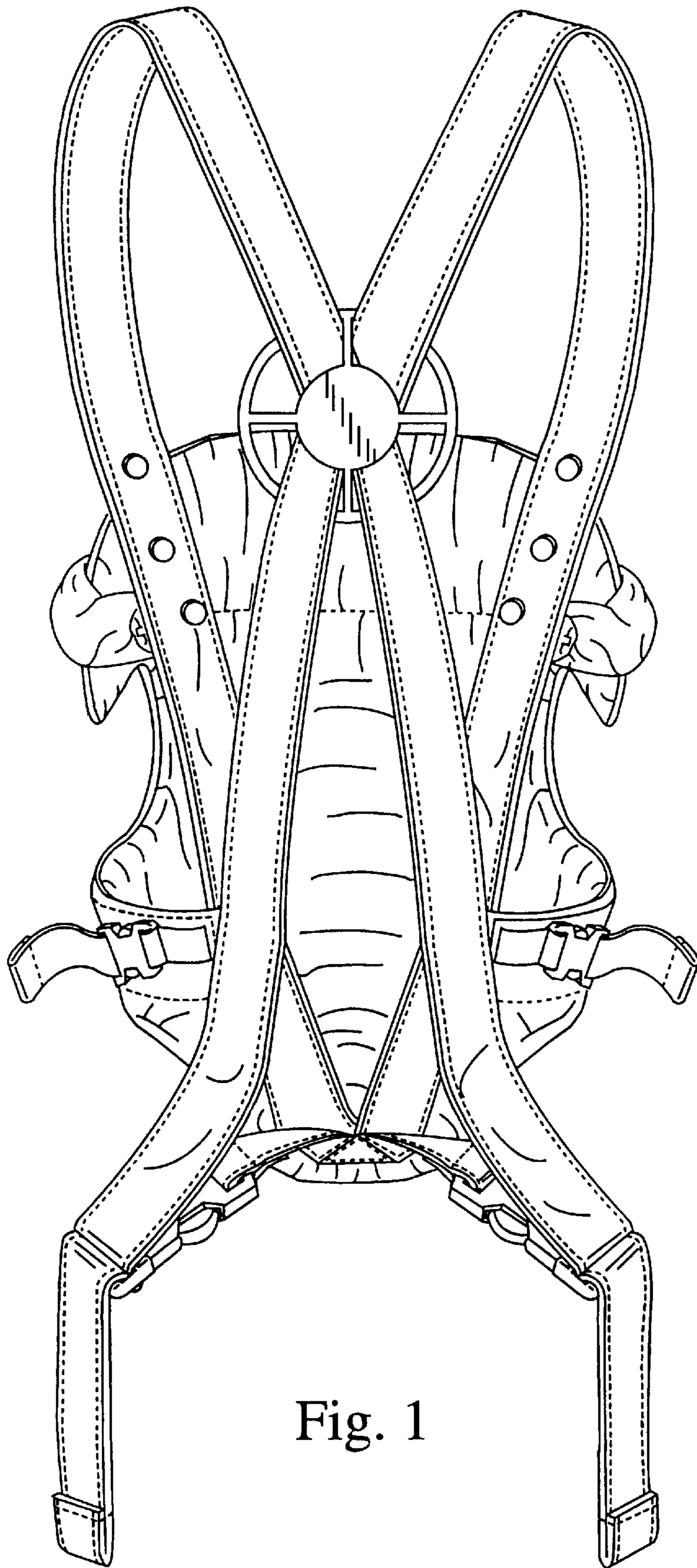

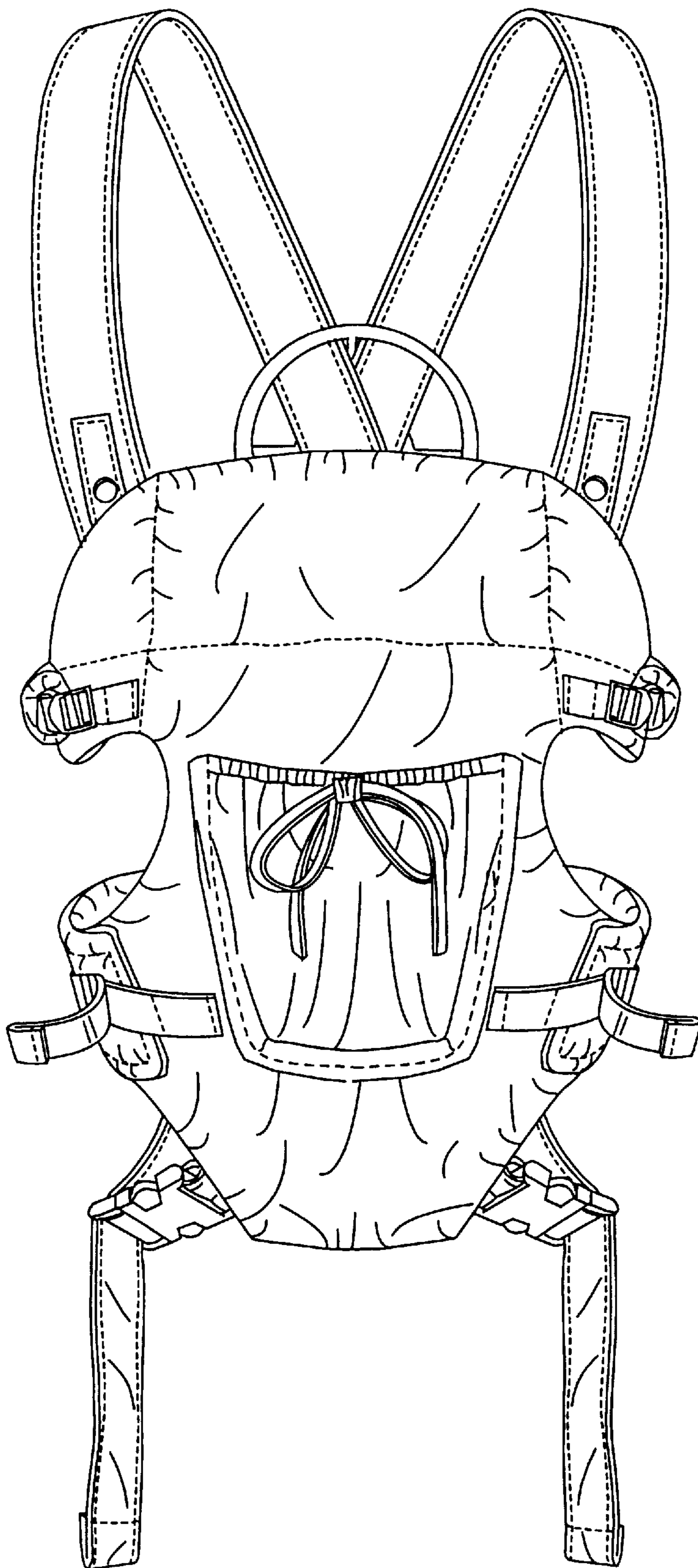

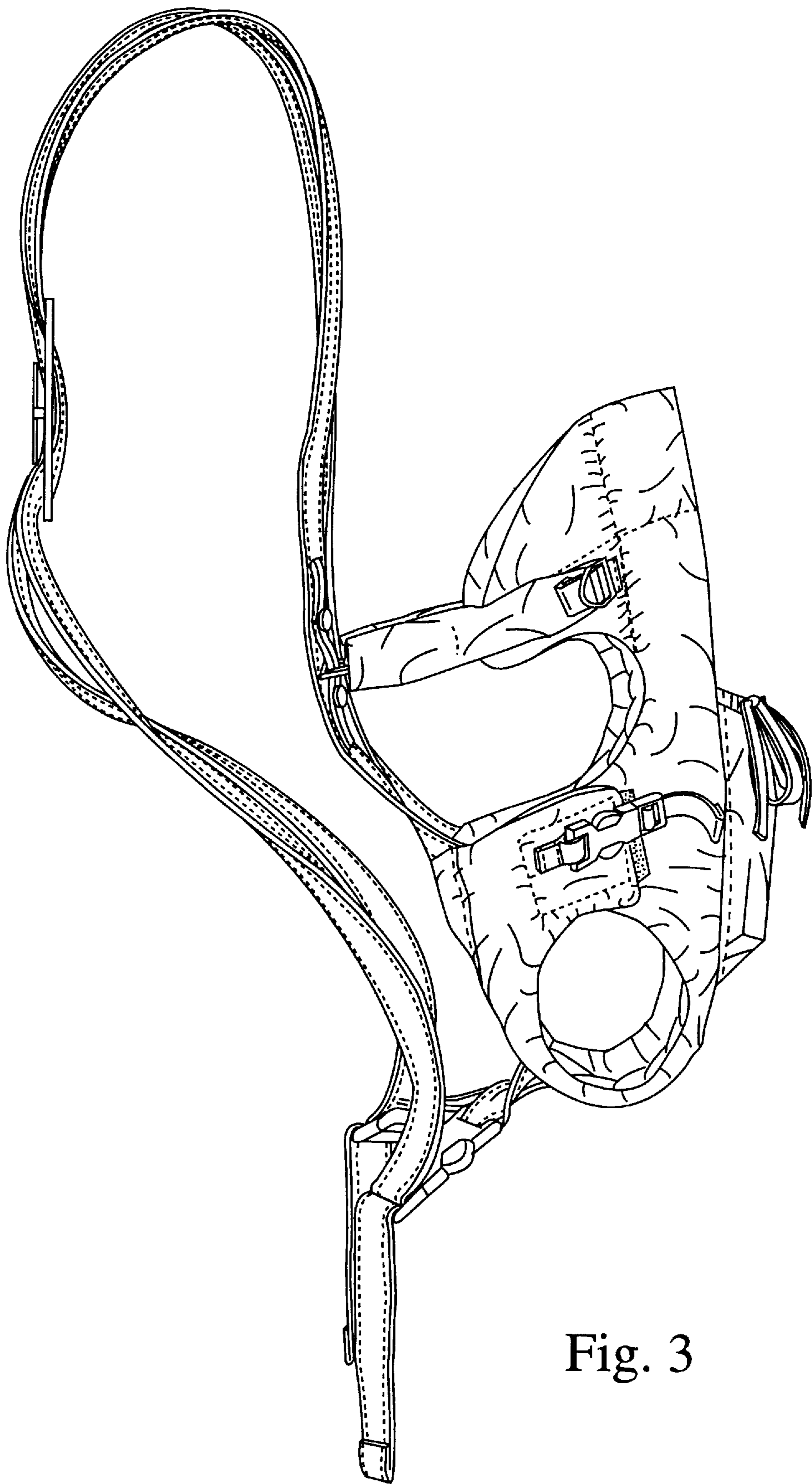

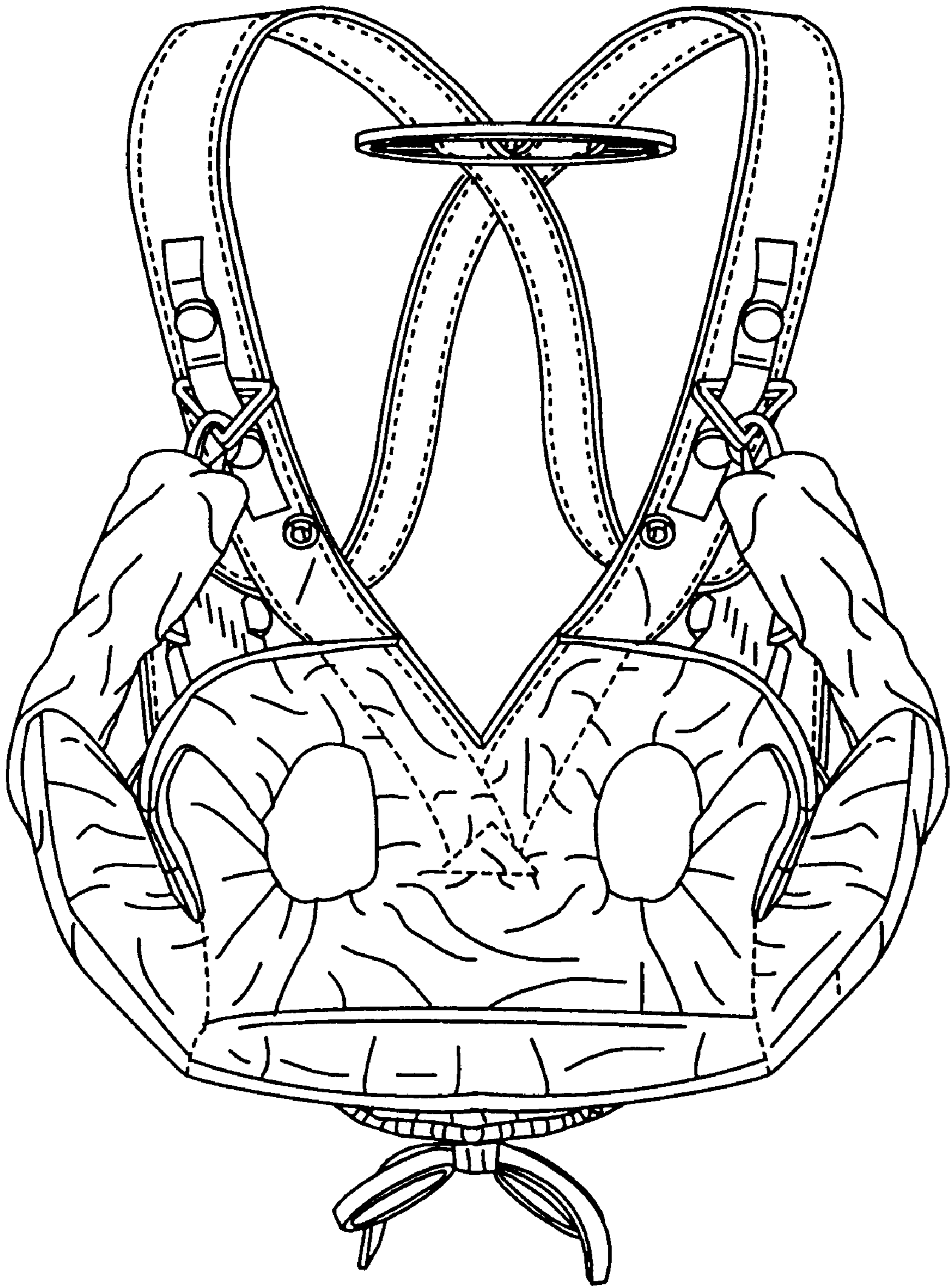

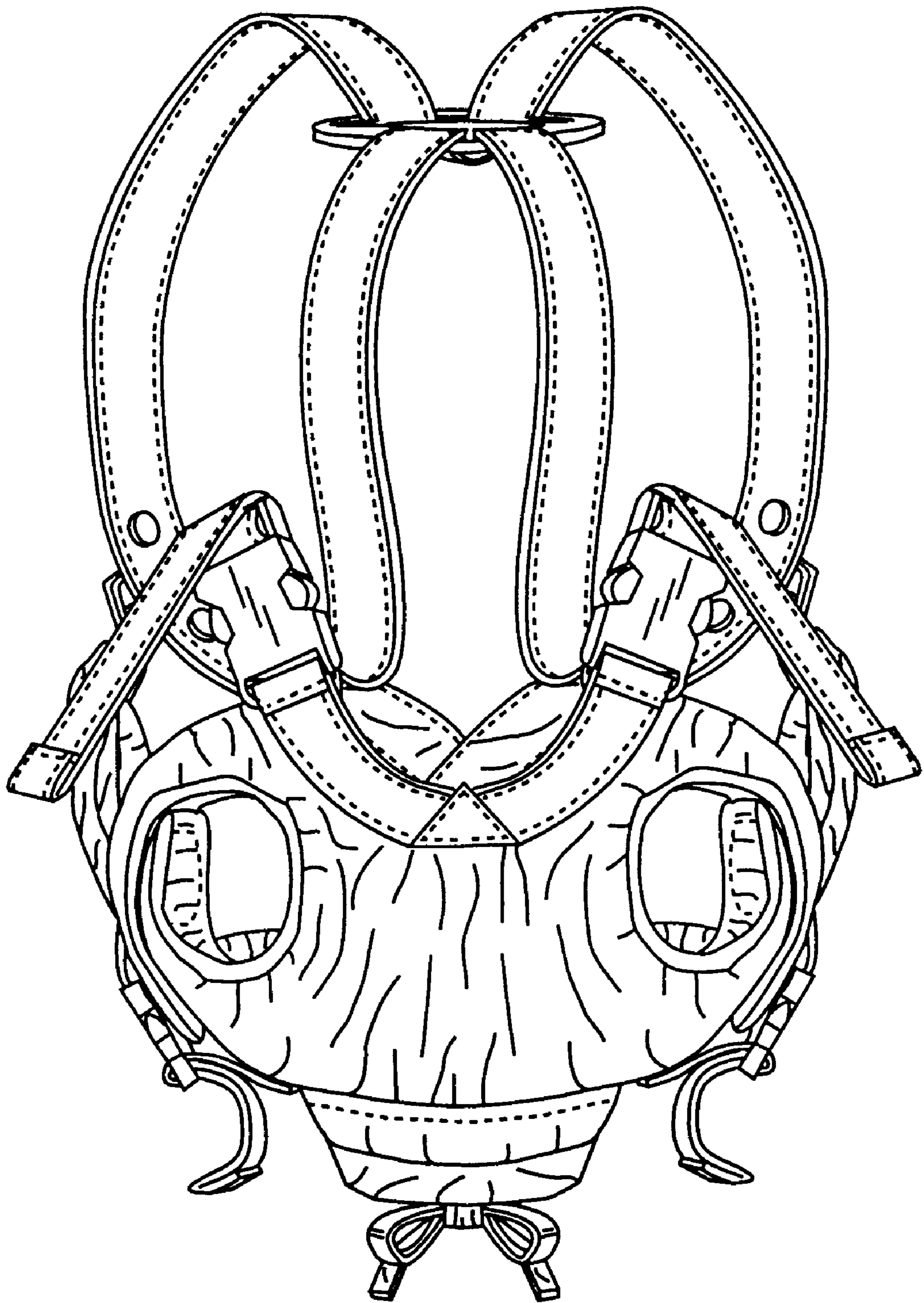
