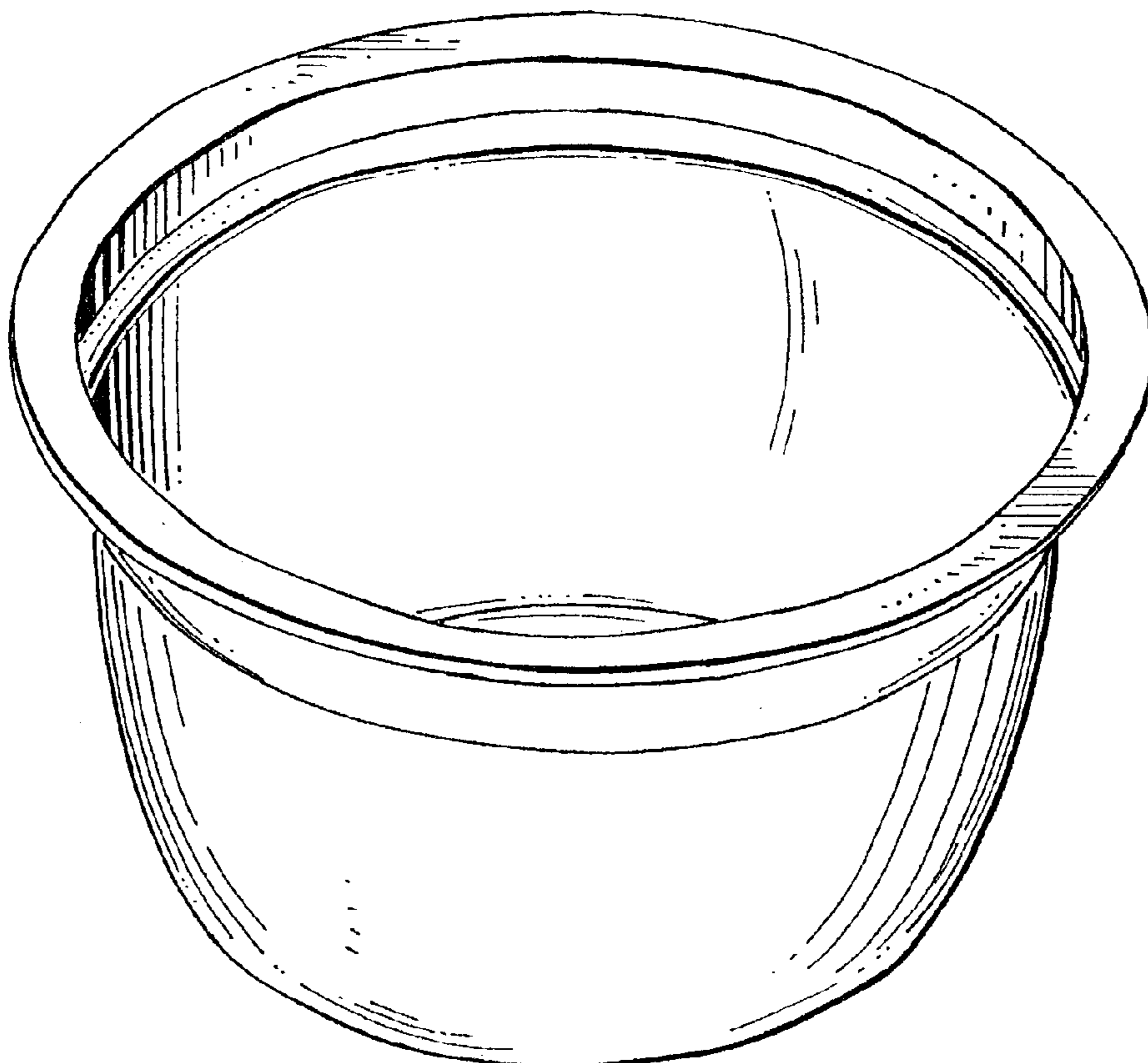

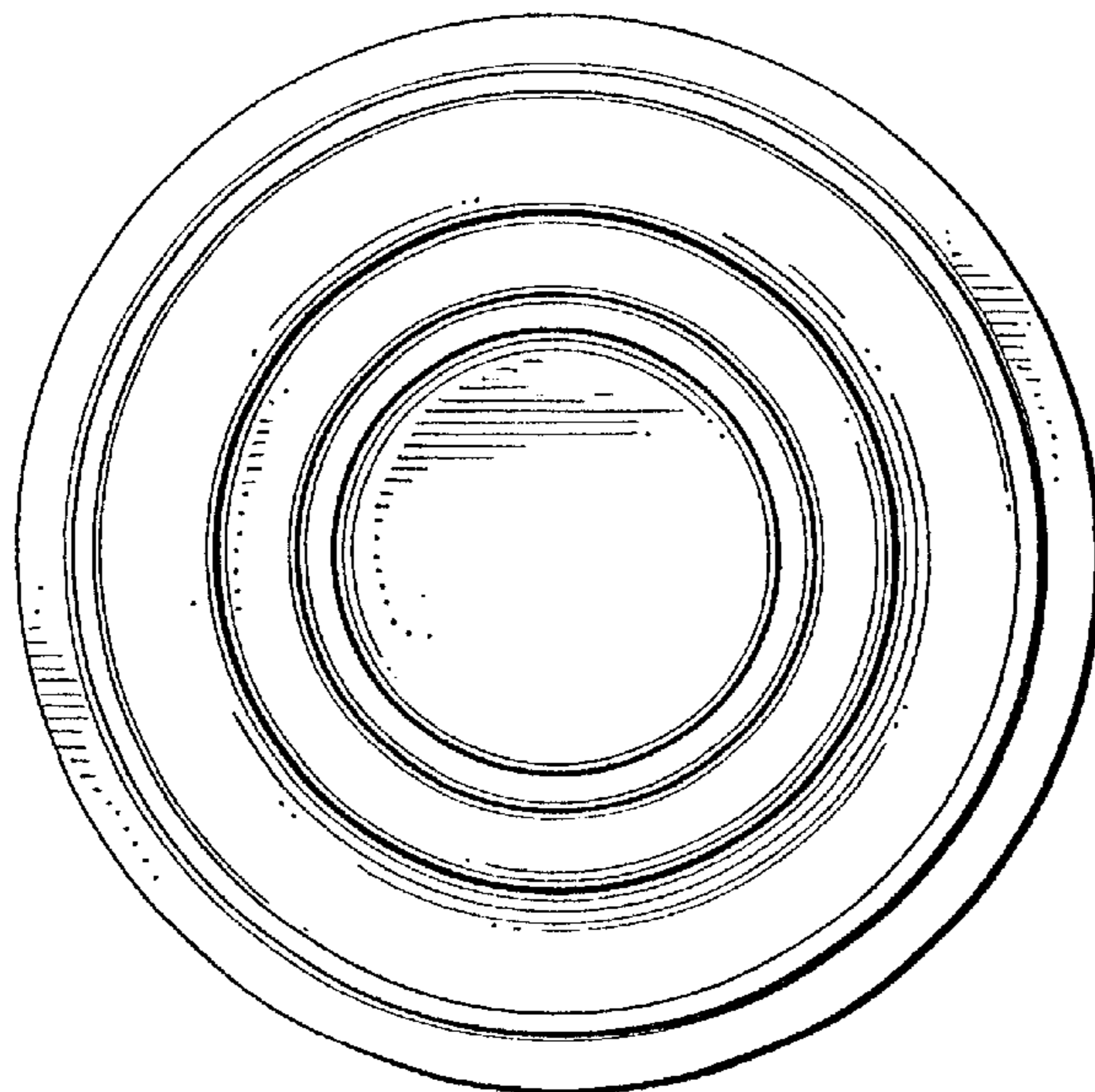
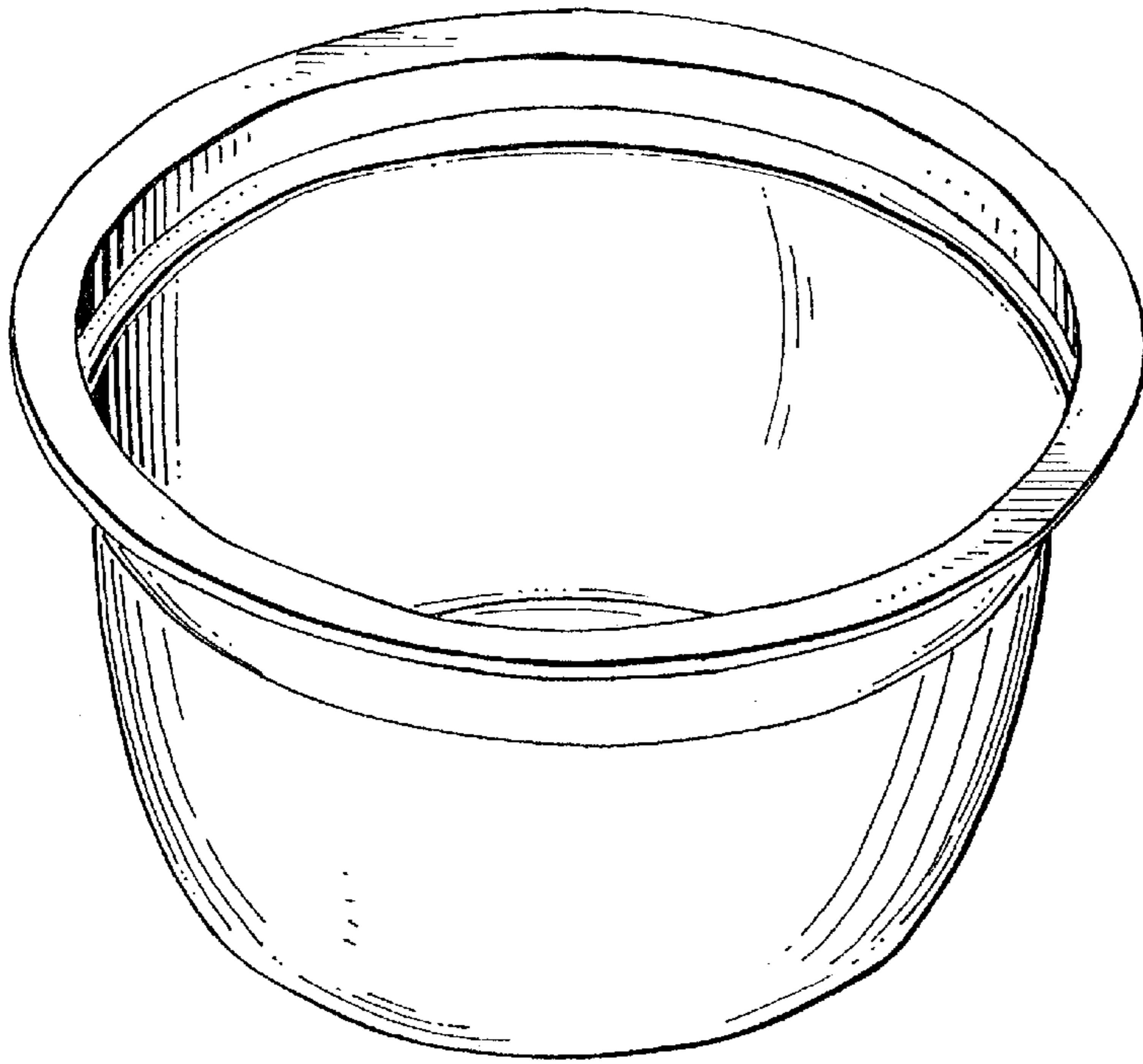
The ornamental design for a hot-fill container, as shown and described.

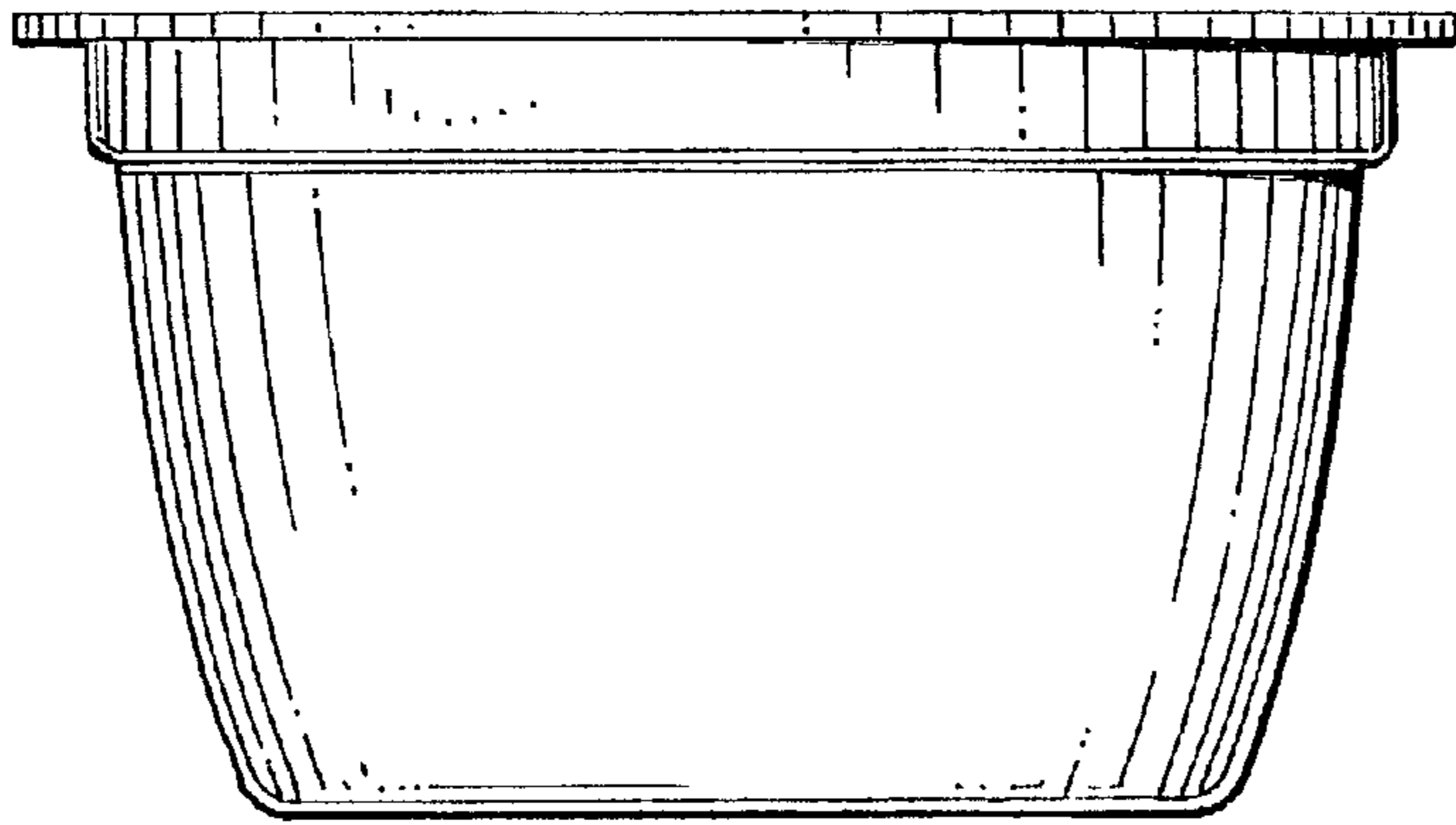

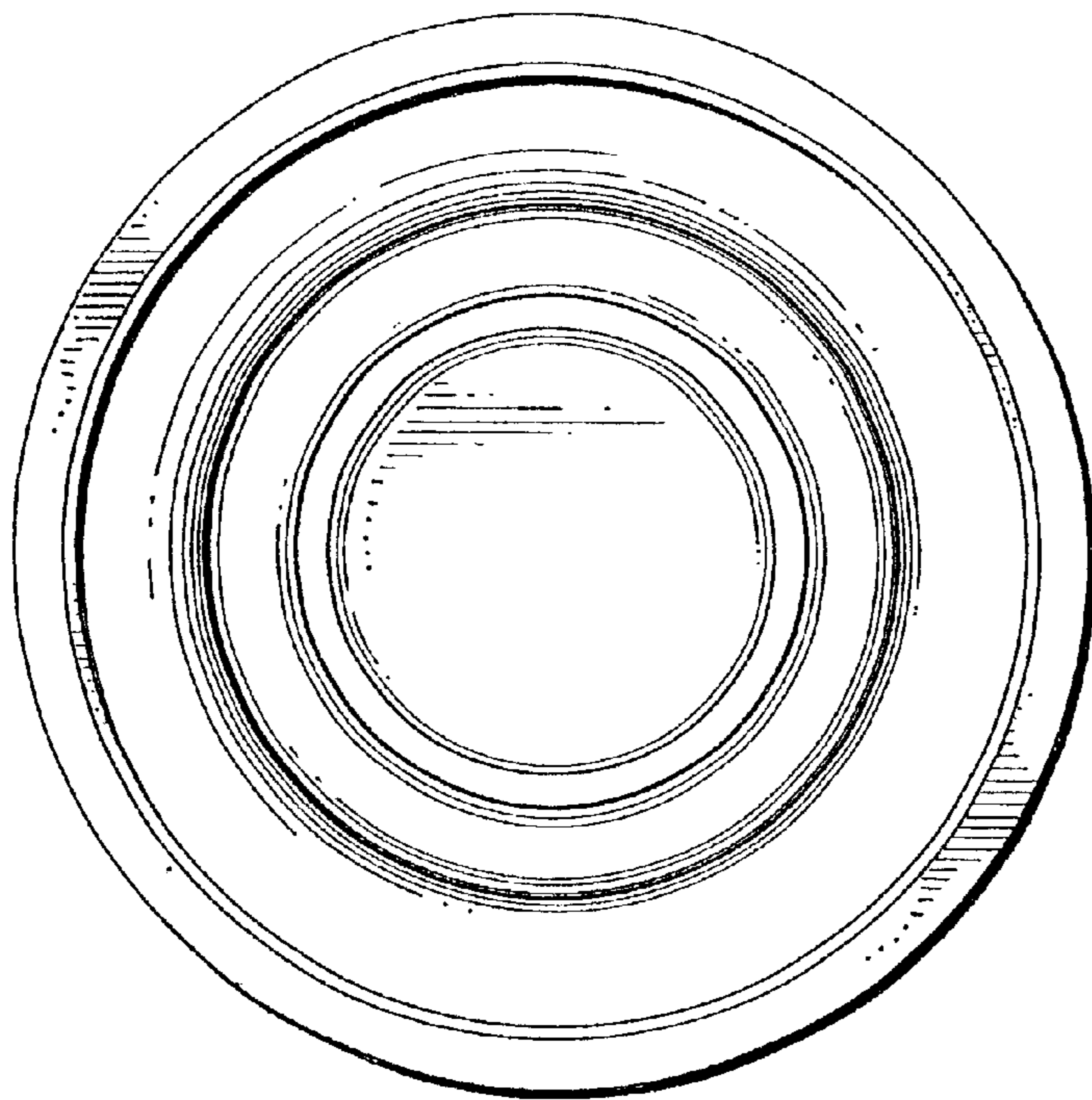
