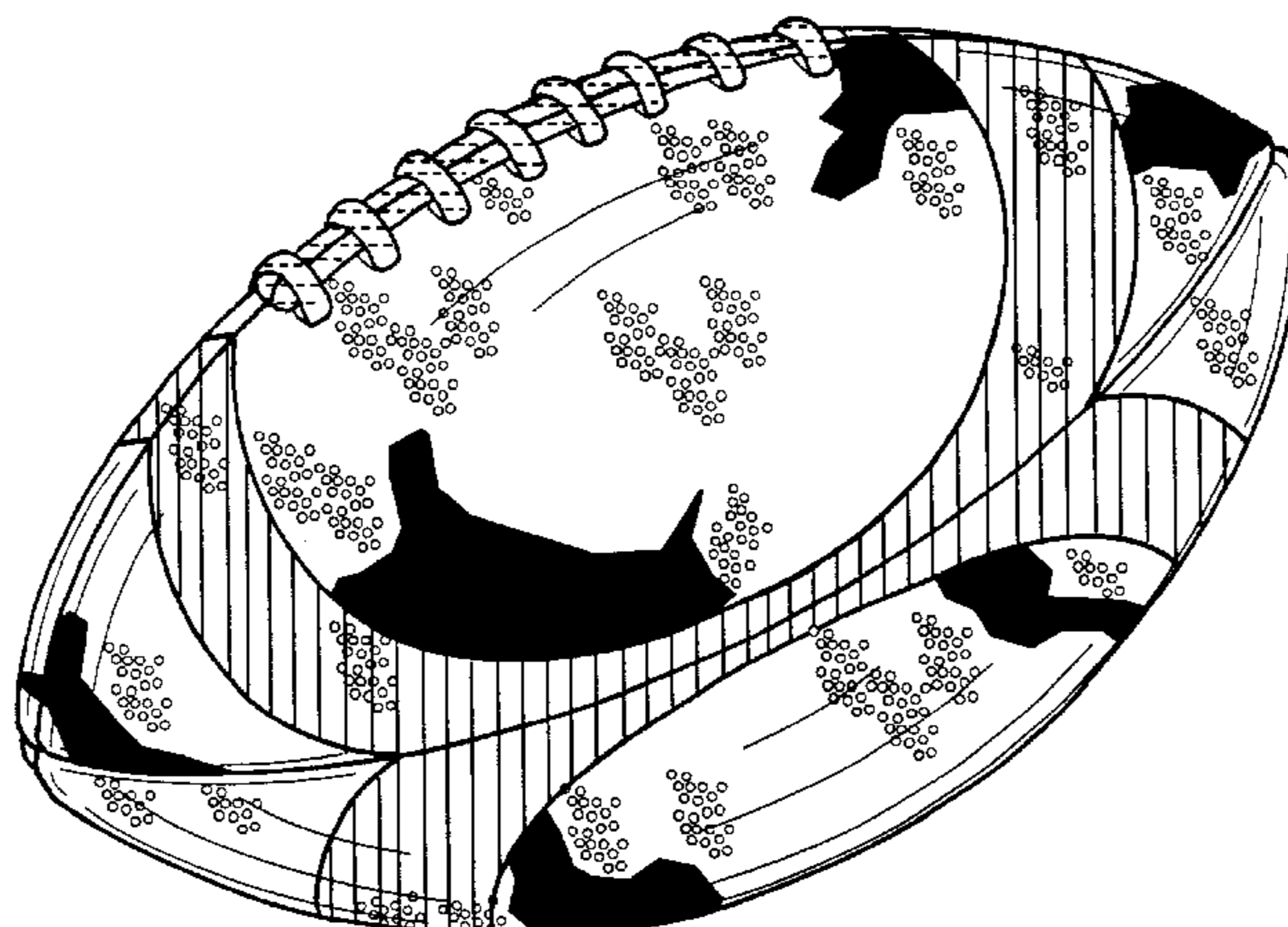
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side perspective view of a football of the present
invention. The drawing has been lined to depict color;
FIG. 2 is a right side view of the football of FIG. 1;
FIG. 3 is a left side view of the football of FIG. 1;
FIG. 4 is a top view of the football of FIG. 1;
FIG. 5 is a bottom view of the football of FIG. 1;
FIG. 6 is a front end view of the football of FIG. 1; and,

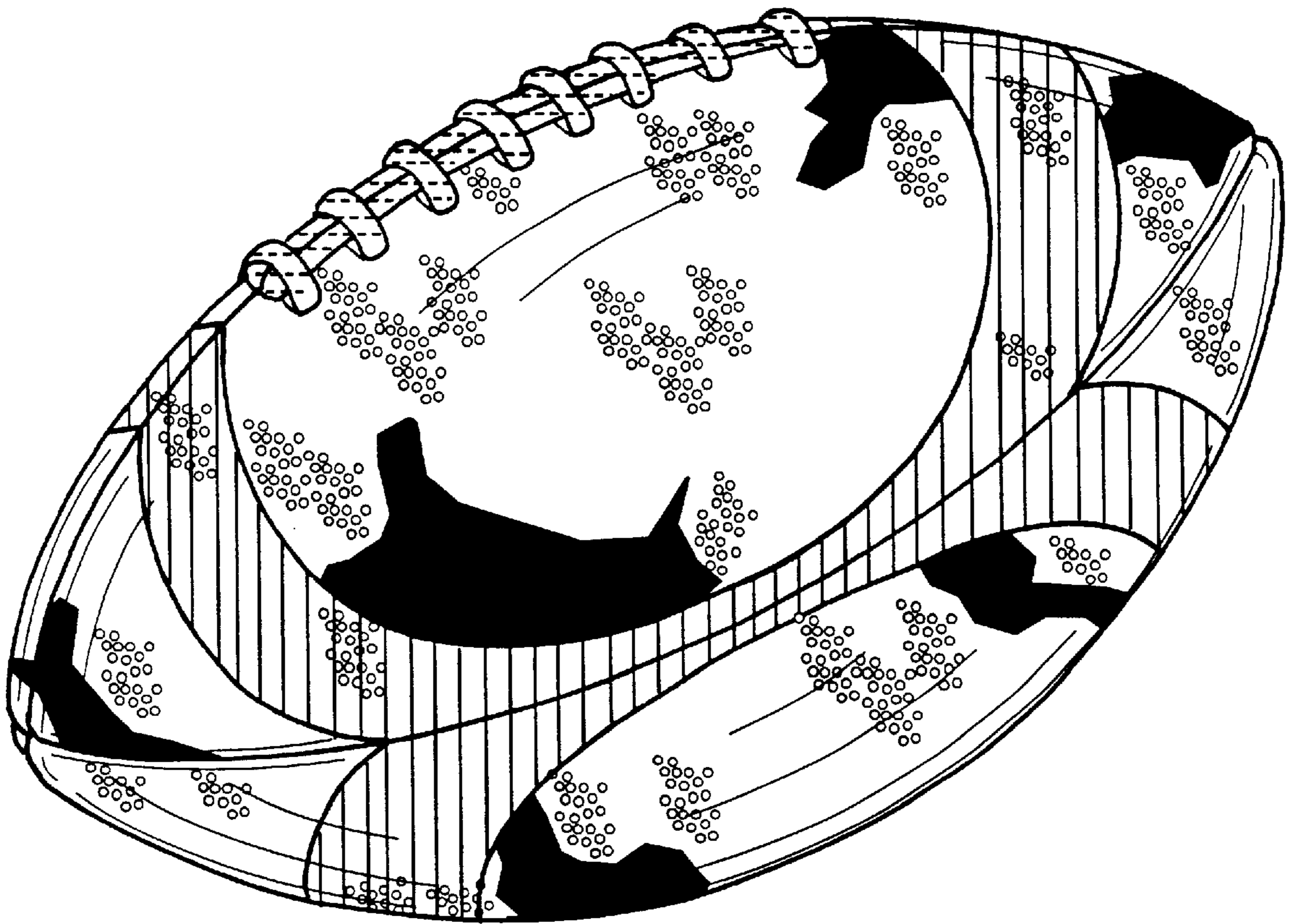

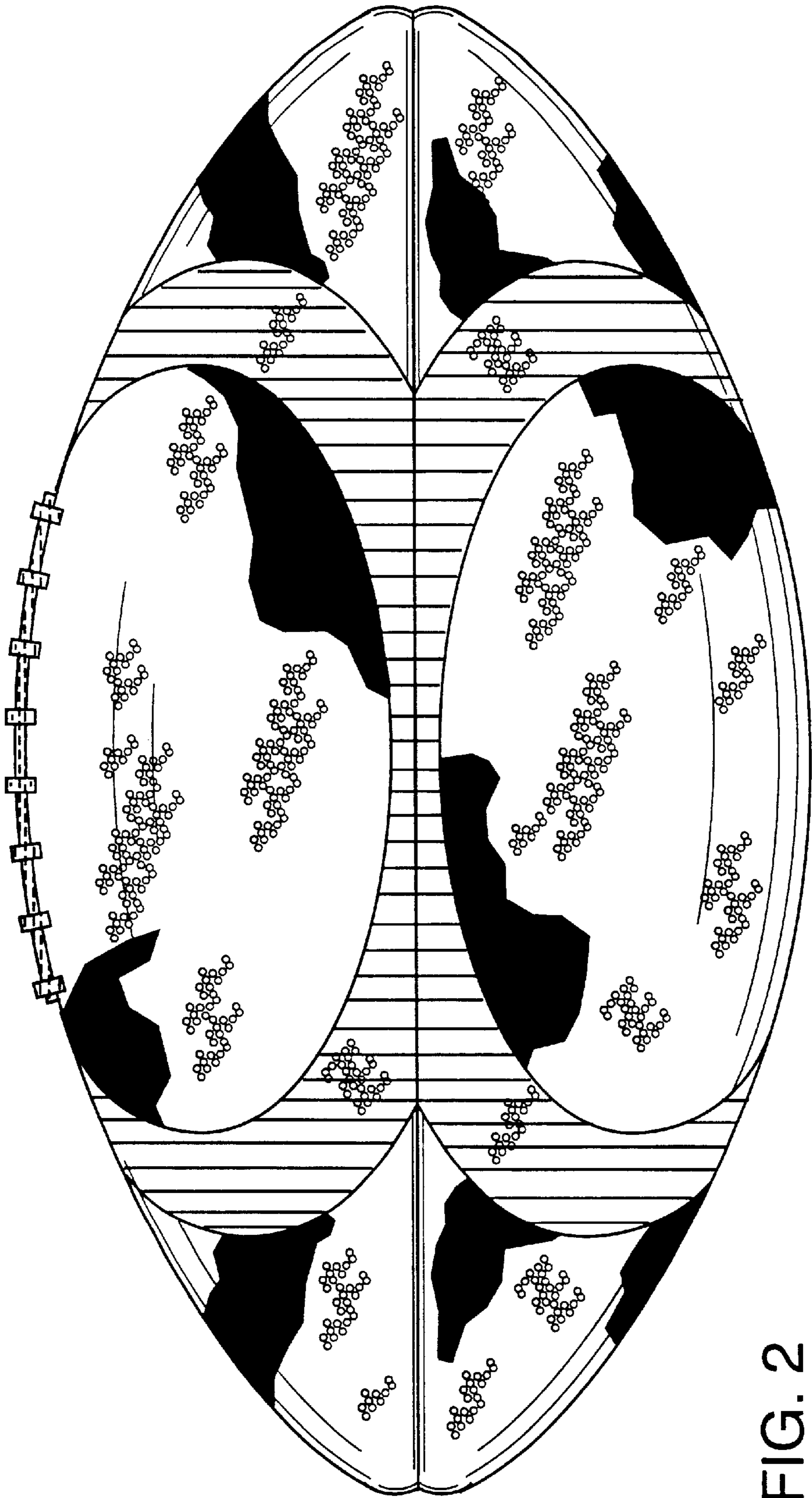

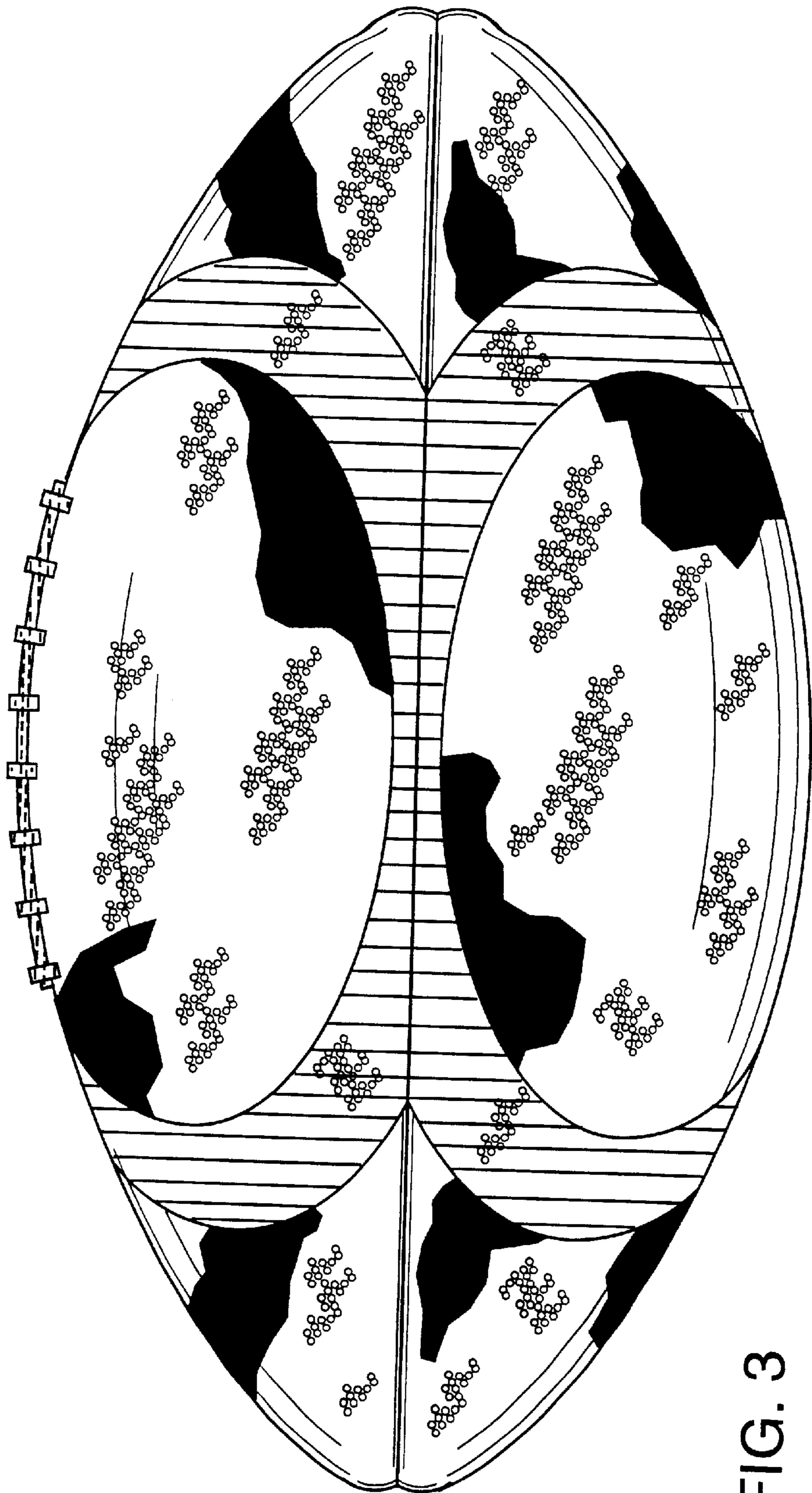

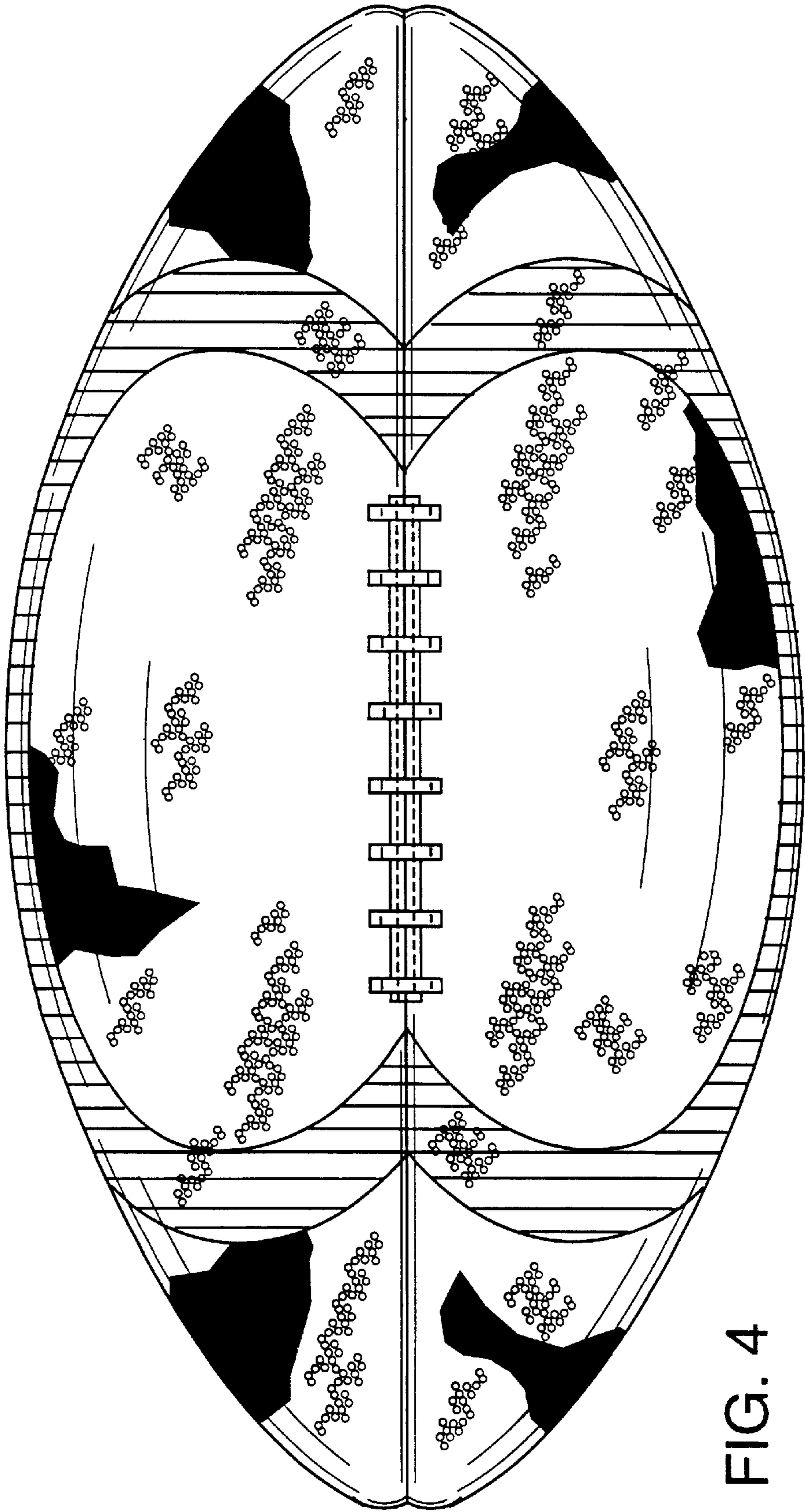

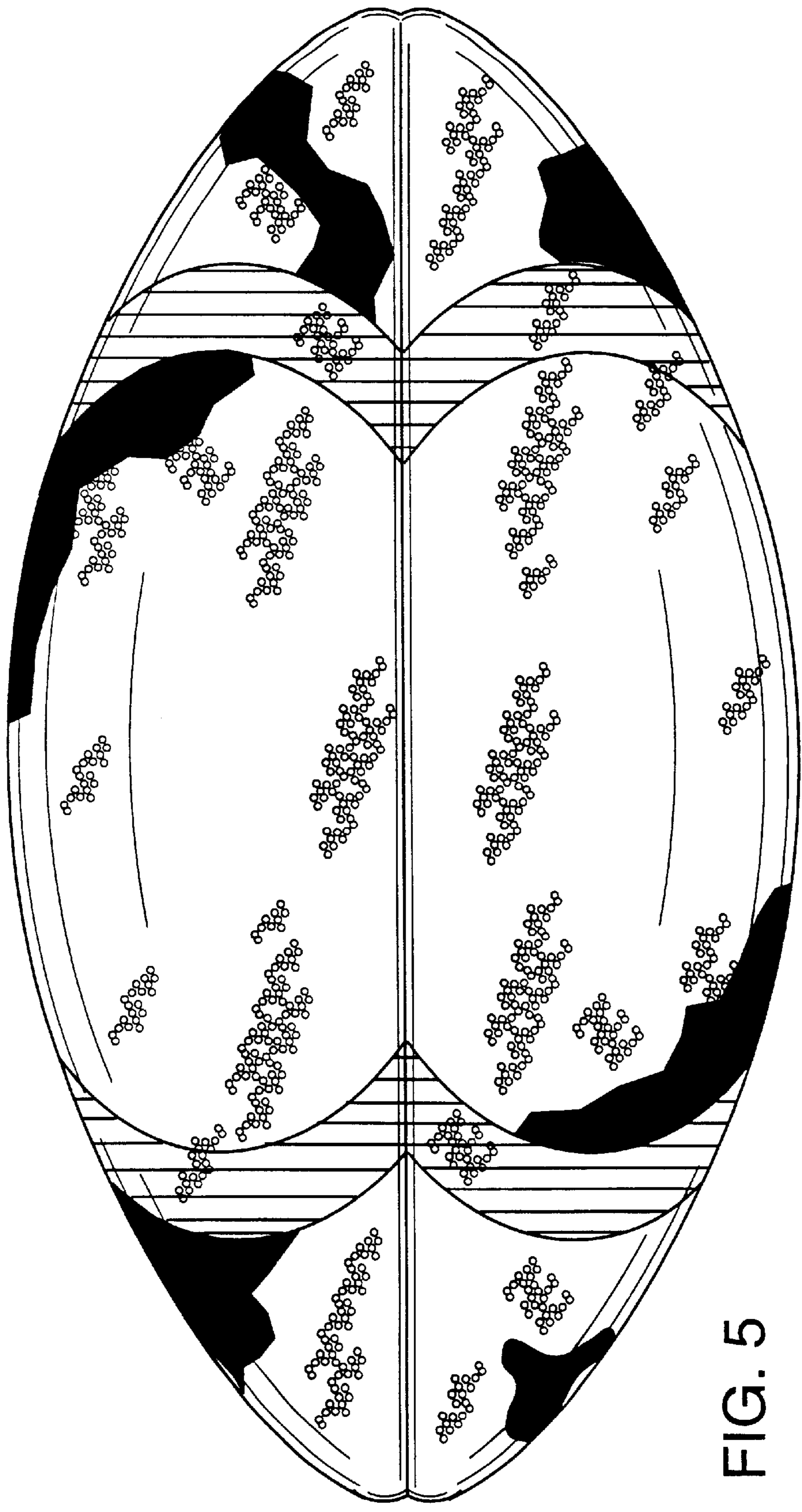

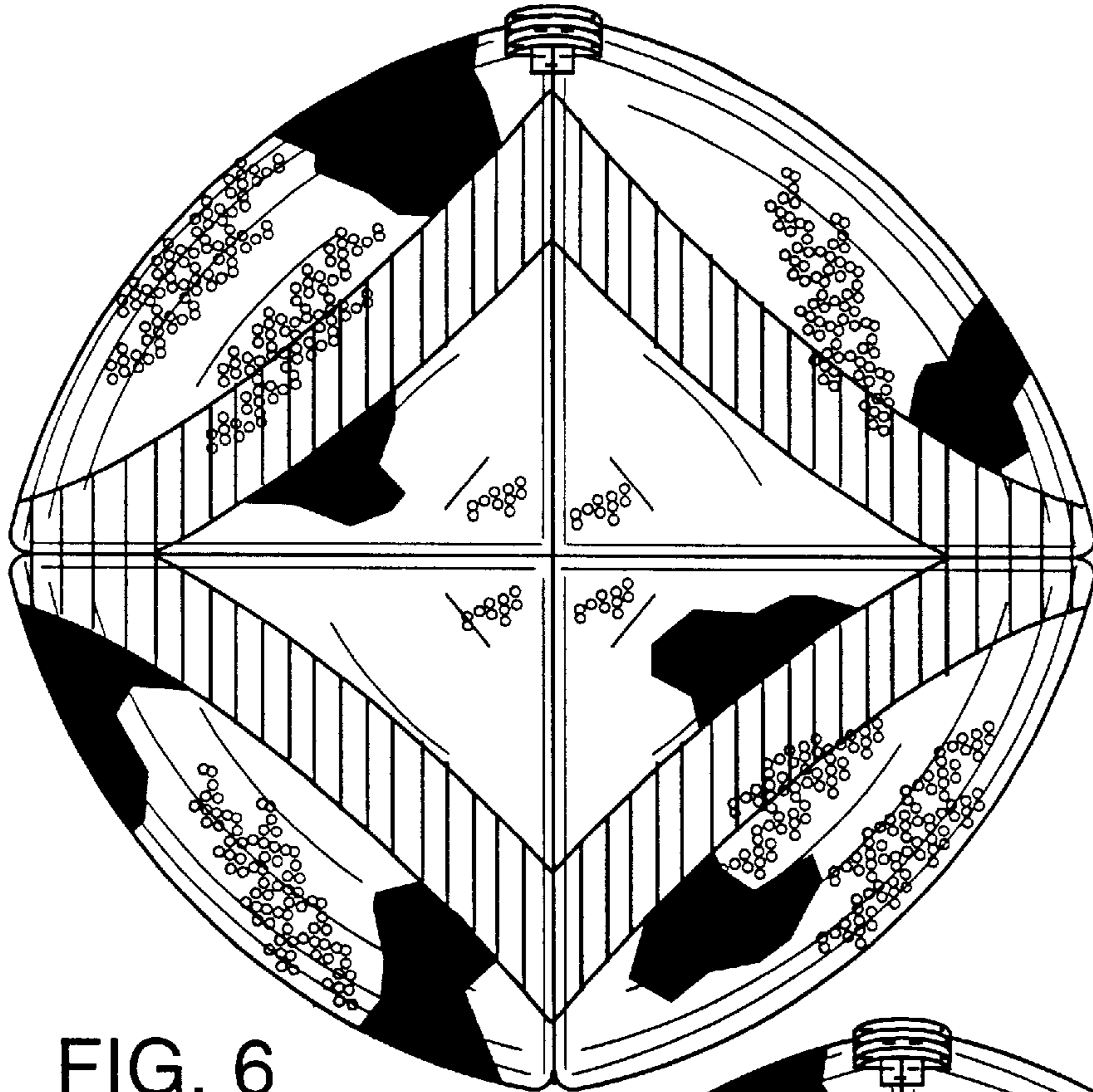

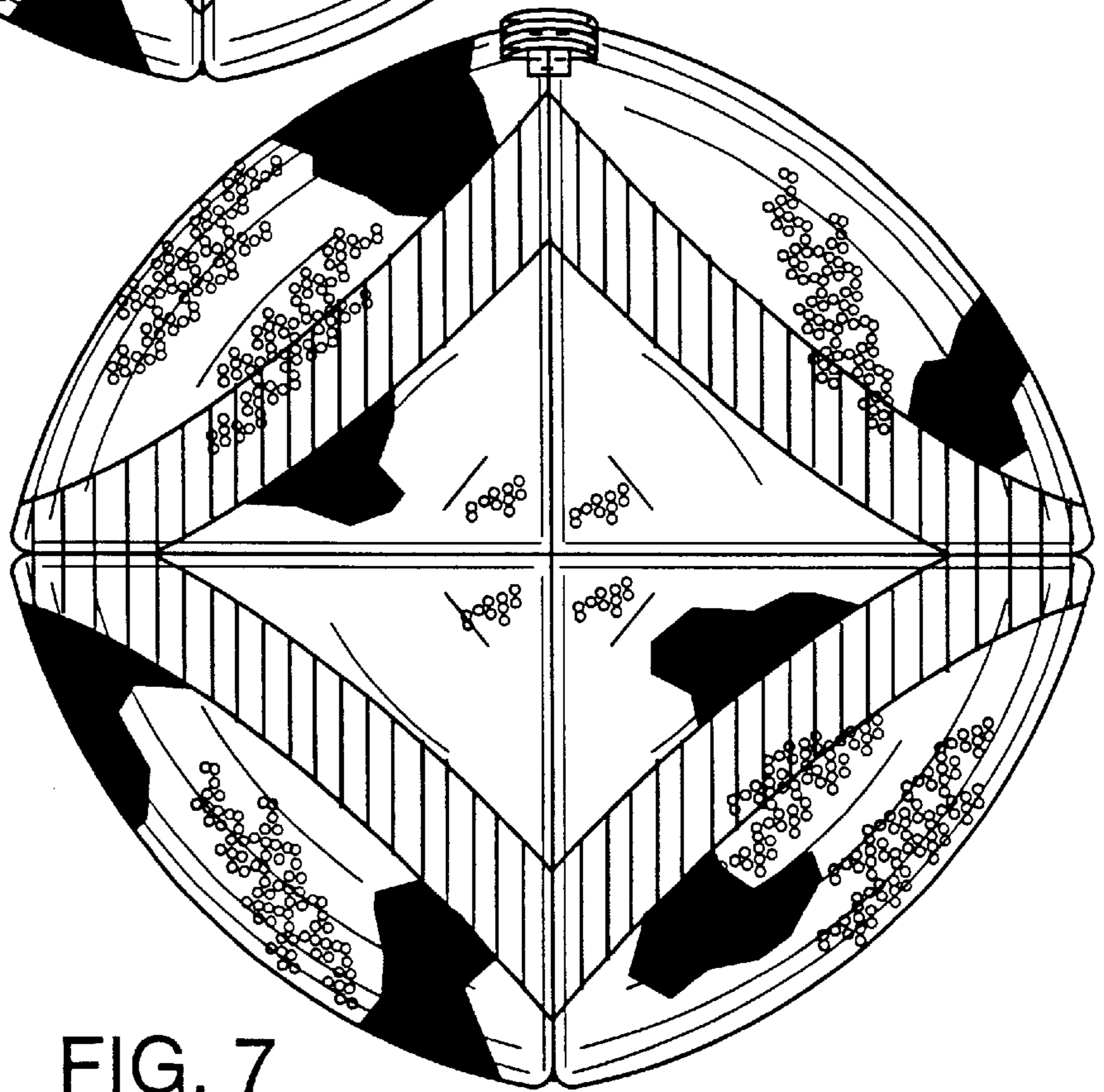
