(57) **CLAIM**

The ornamental design for a stem for an article of stemware, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a stem for an article of stemware according to the present design; the rear elevational view being the same;

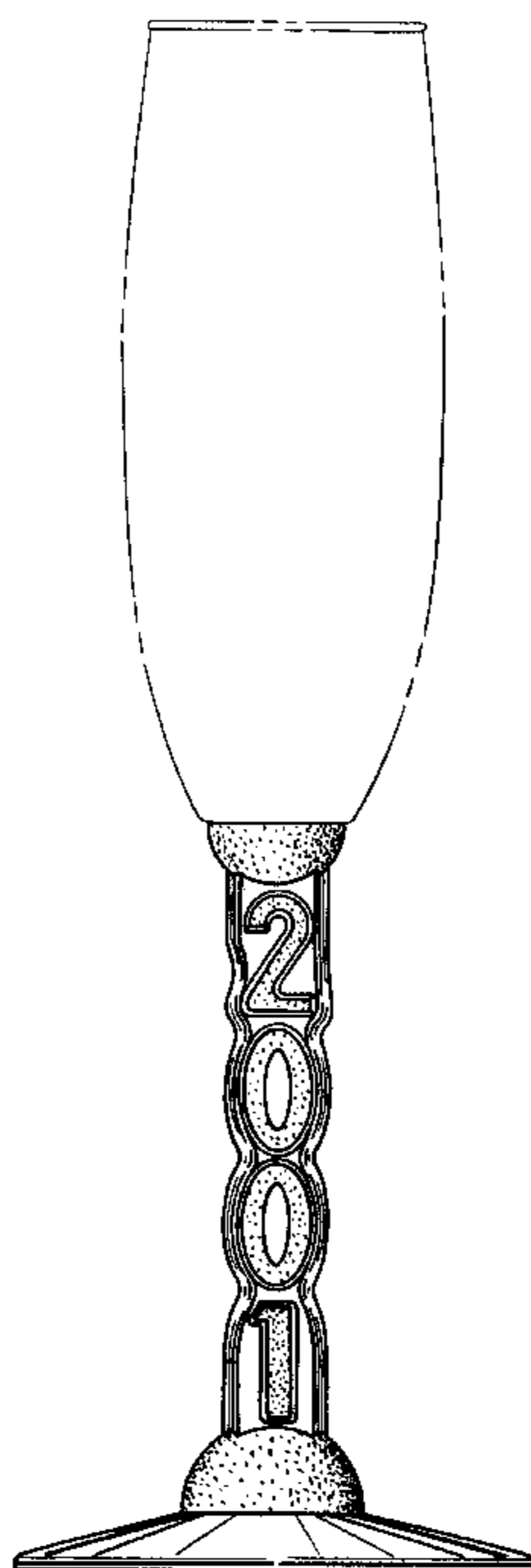
FIG. 2 is a right side elevational view thereof; the left side elevational view being the same;

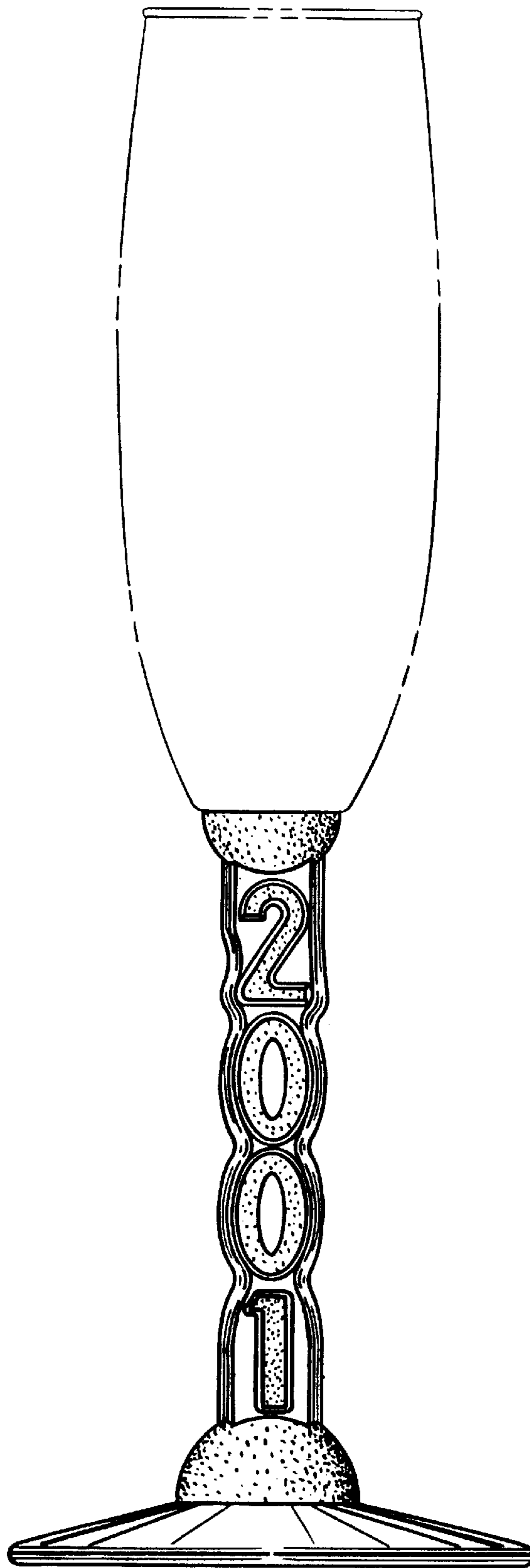

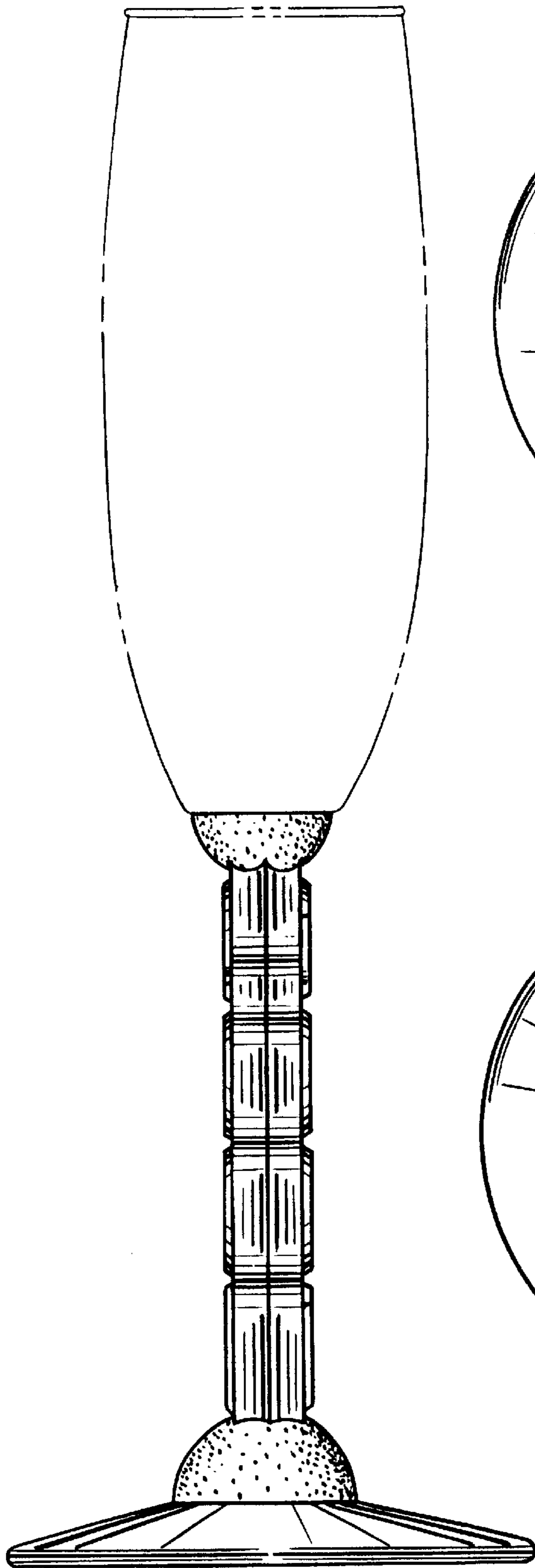

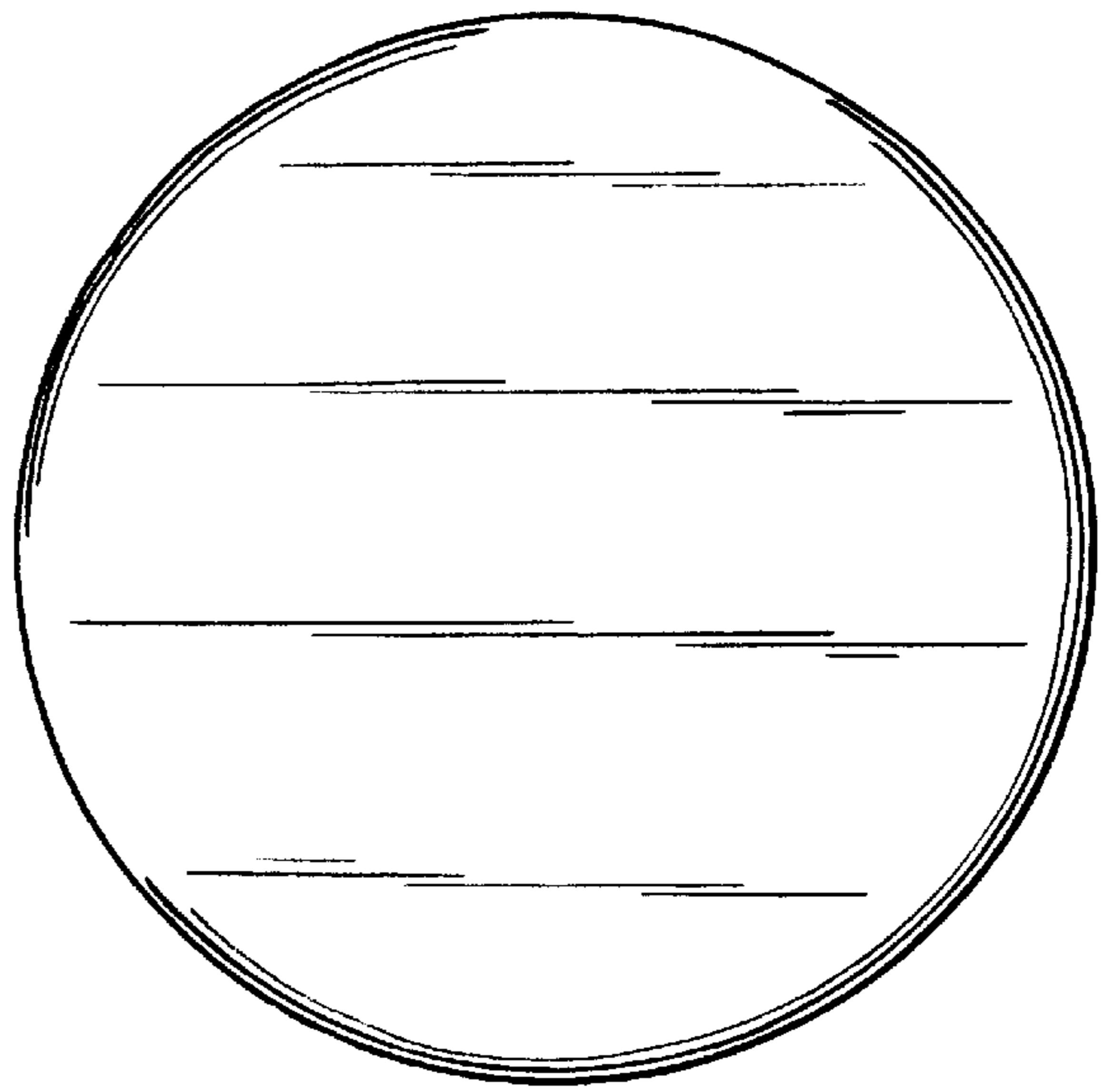

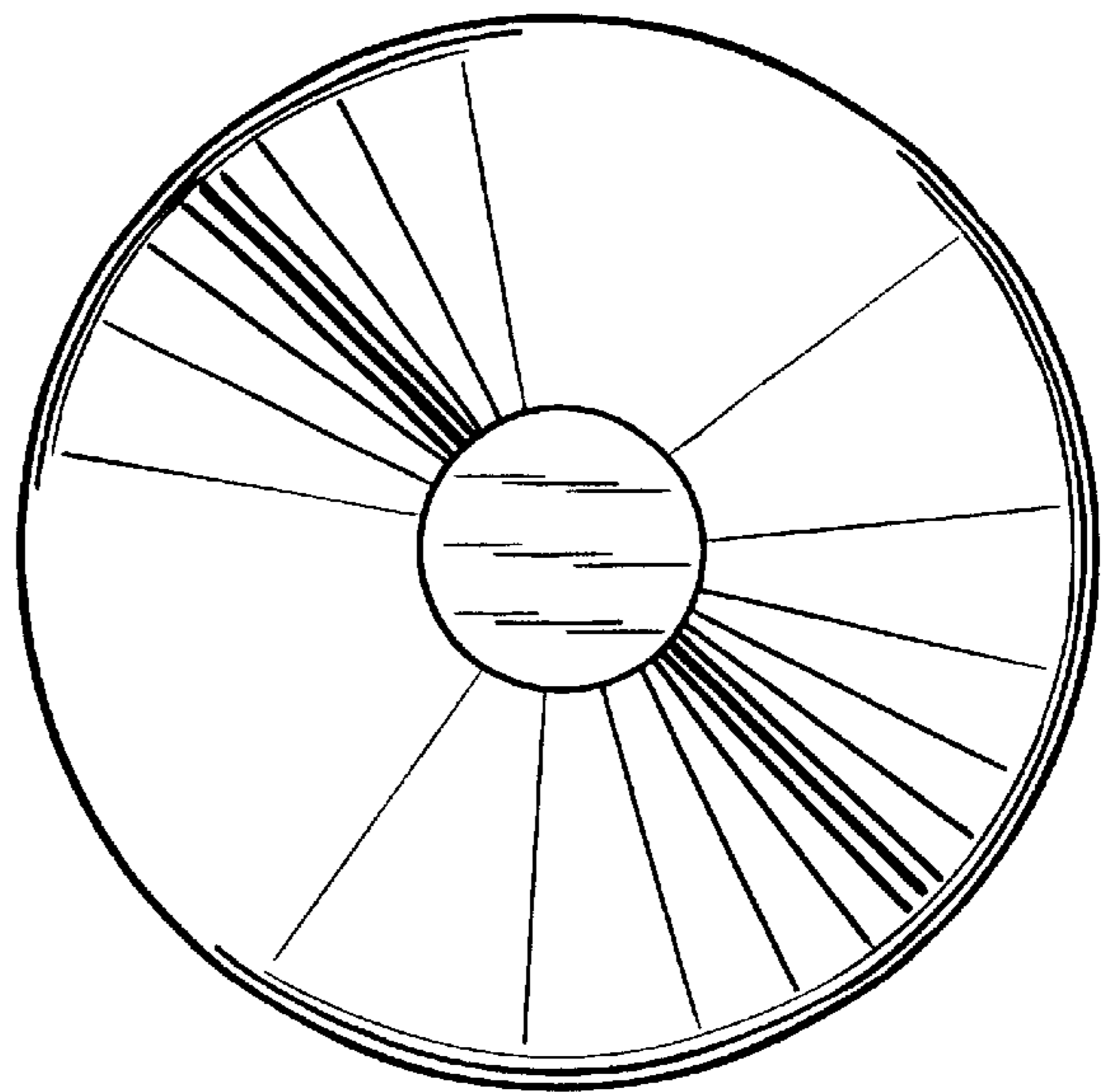
