The ornamental design for a photograph display frame, as shown and described.

DESCRIPTION

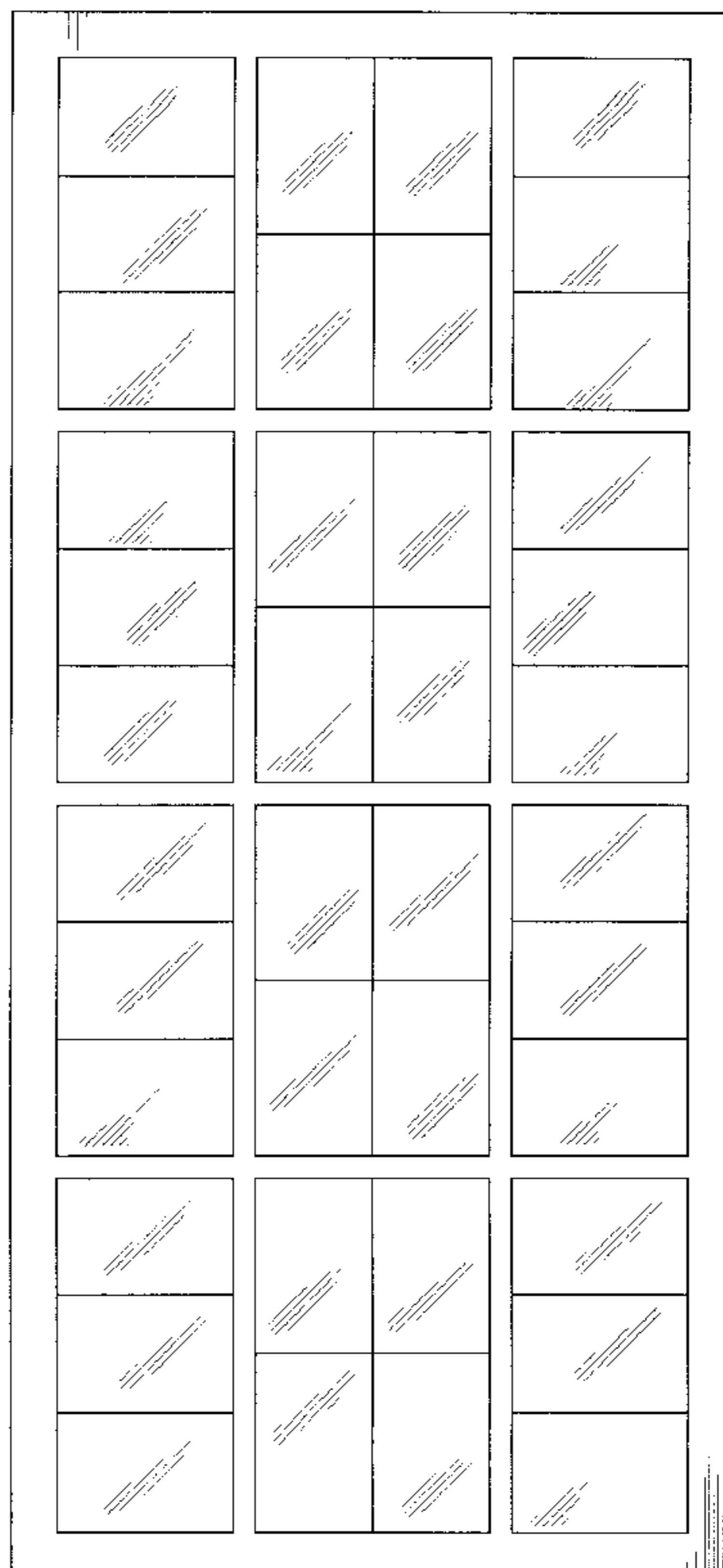
FIG. 1 is a front view of a first embodiment of my photograph display frame;

FIG. 2 is a rear view of the photograph display frame of FIG. 1; and,

FIG. 3 is a front view of a second embodiment of my photographic display frame having a top margin shown adjacent the photograph display frame portion.

The photo display is sheet-like, with no visual aspect thickness.

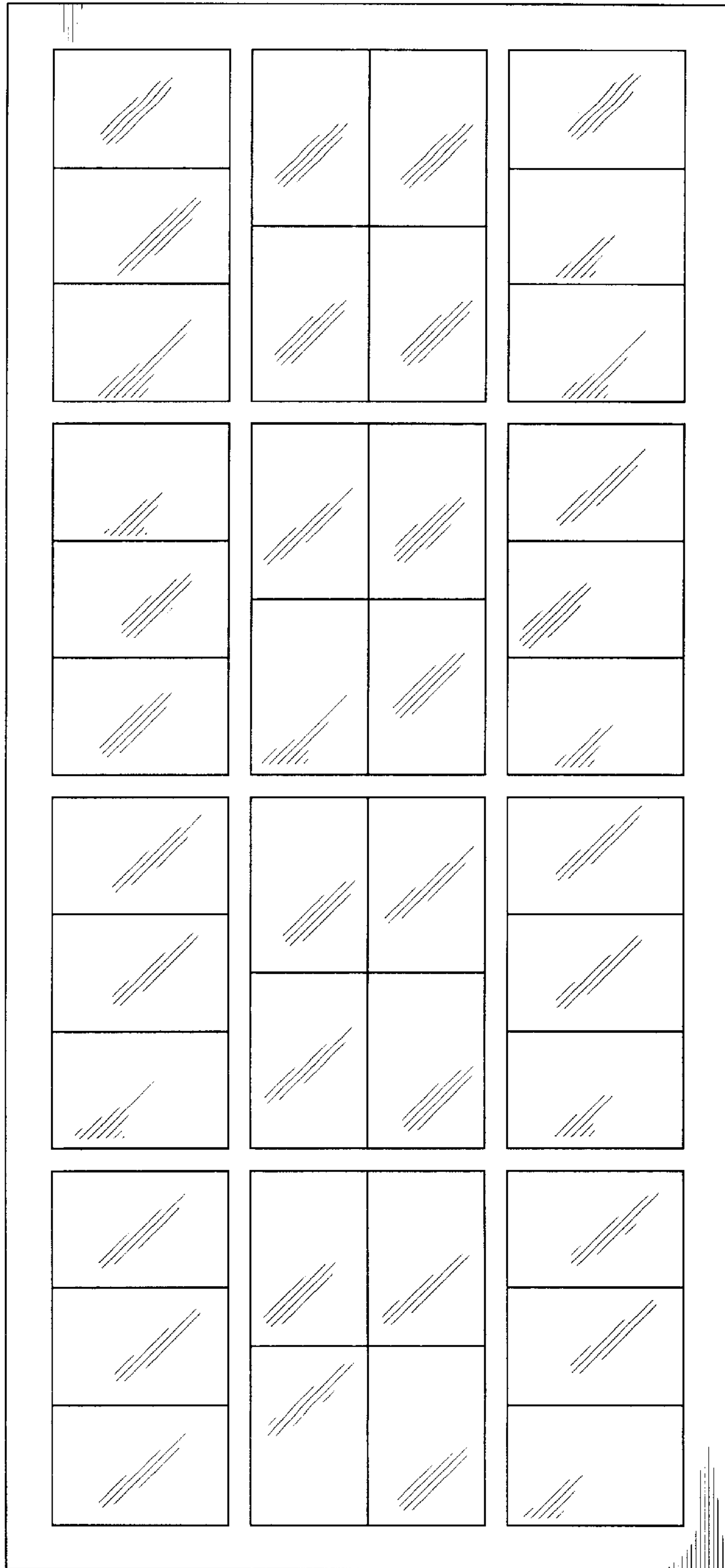

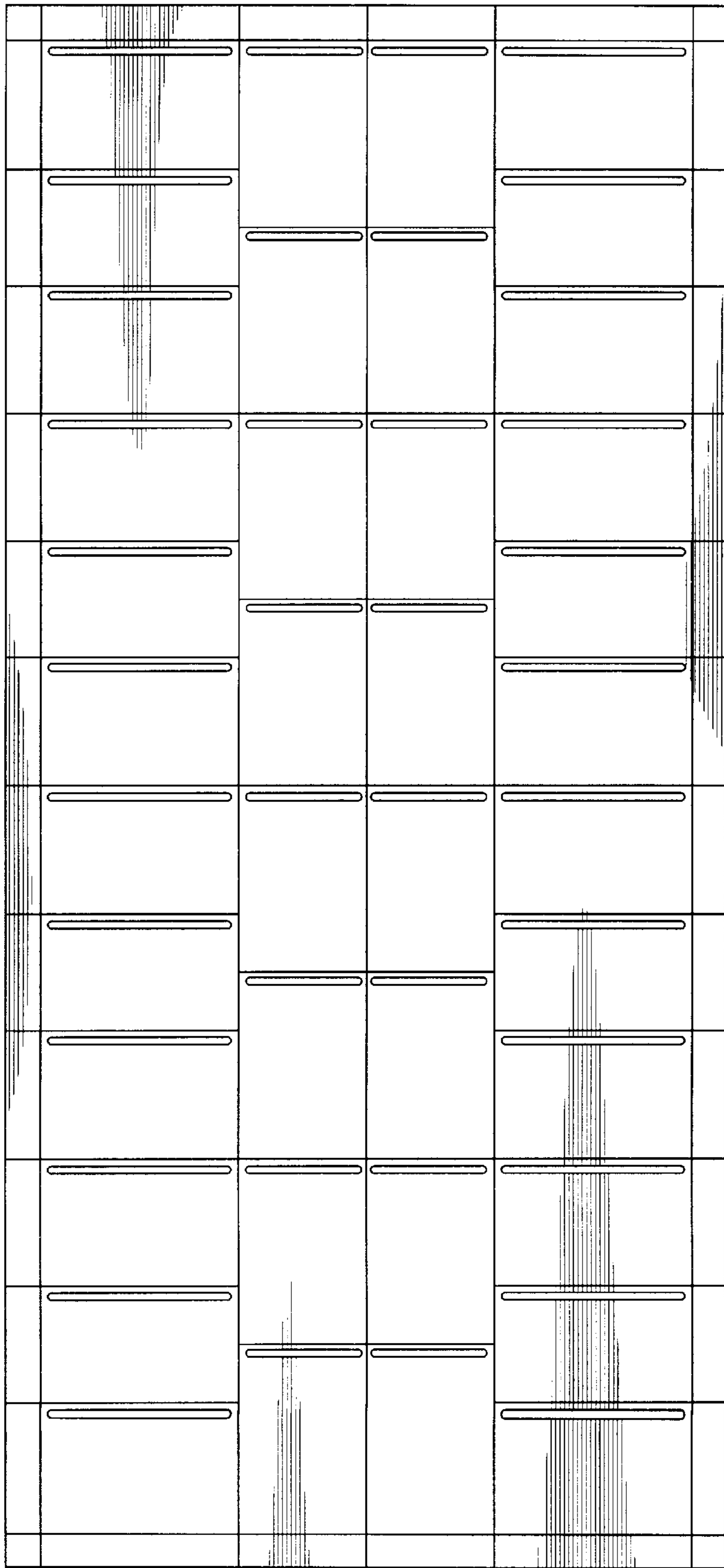

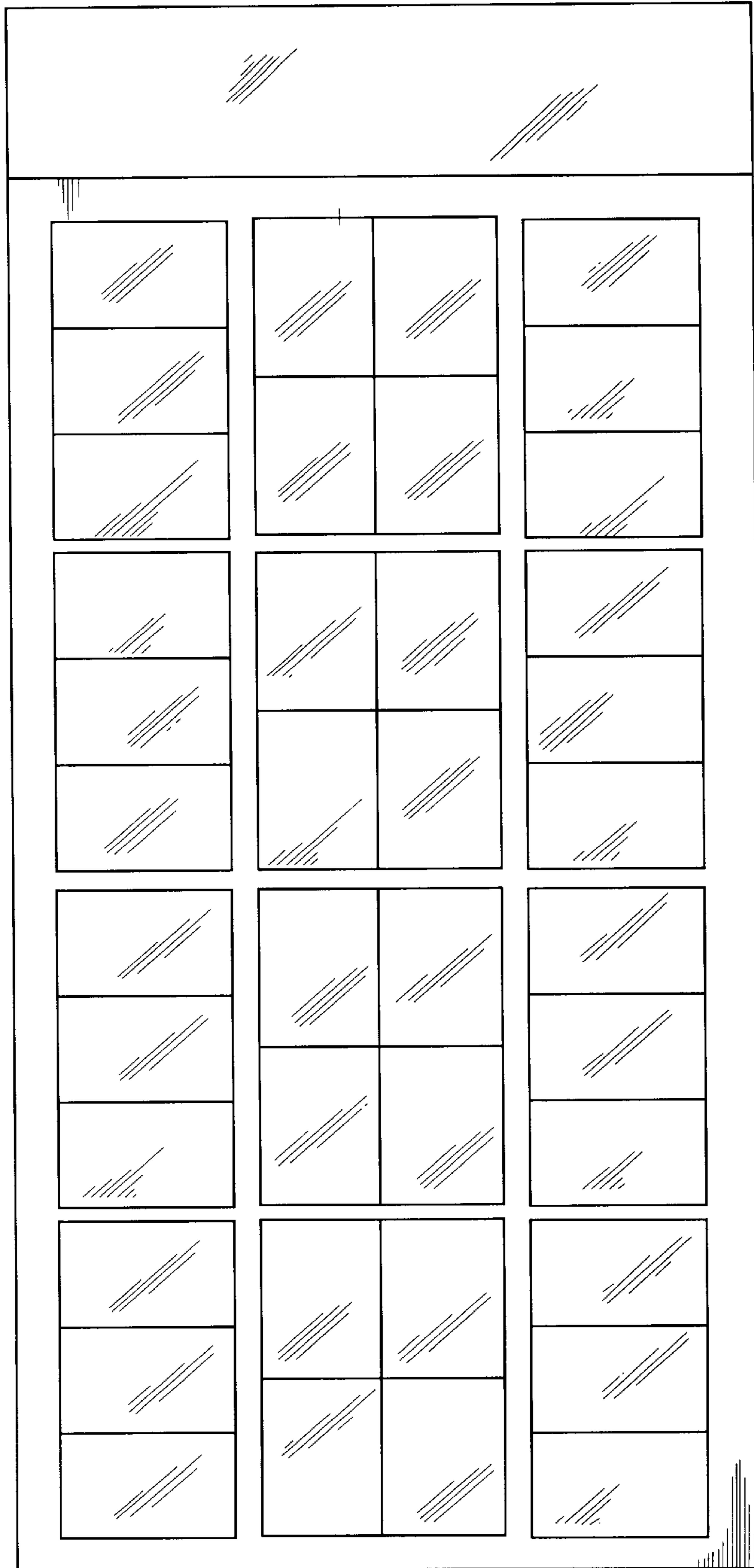
