(57) **CLAIM**

The ornamental design for a “CD holder”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a “CD holder” showing my new design;

FIG. 2 is a rear perspective view thereof;

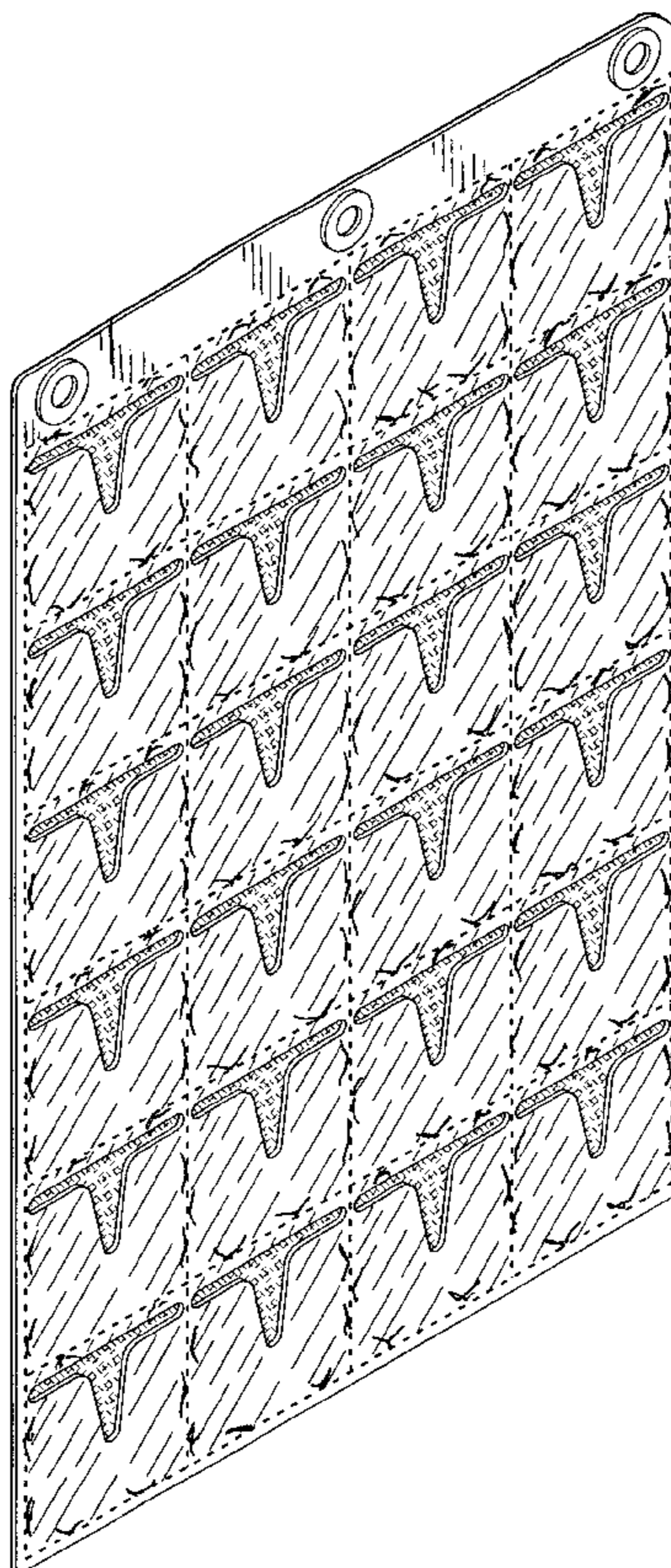
FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image thereof; and,

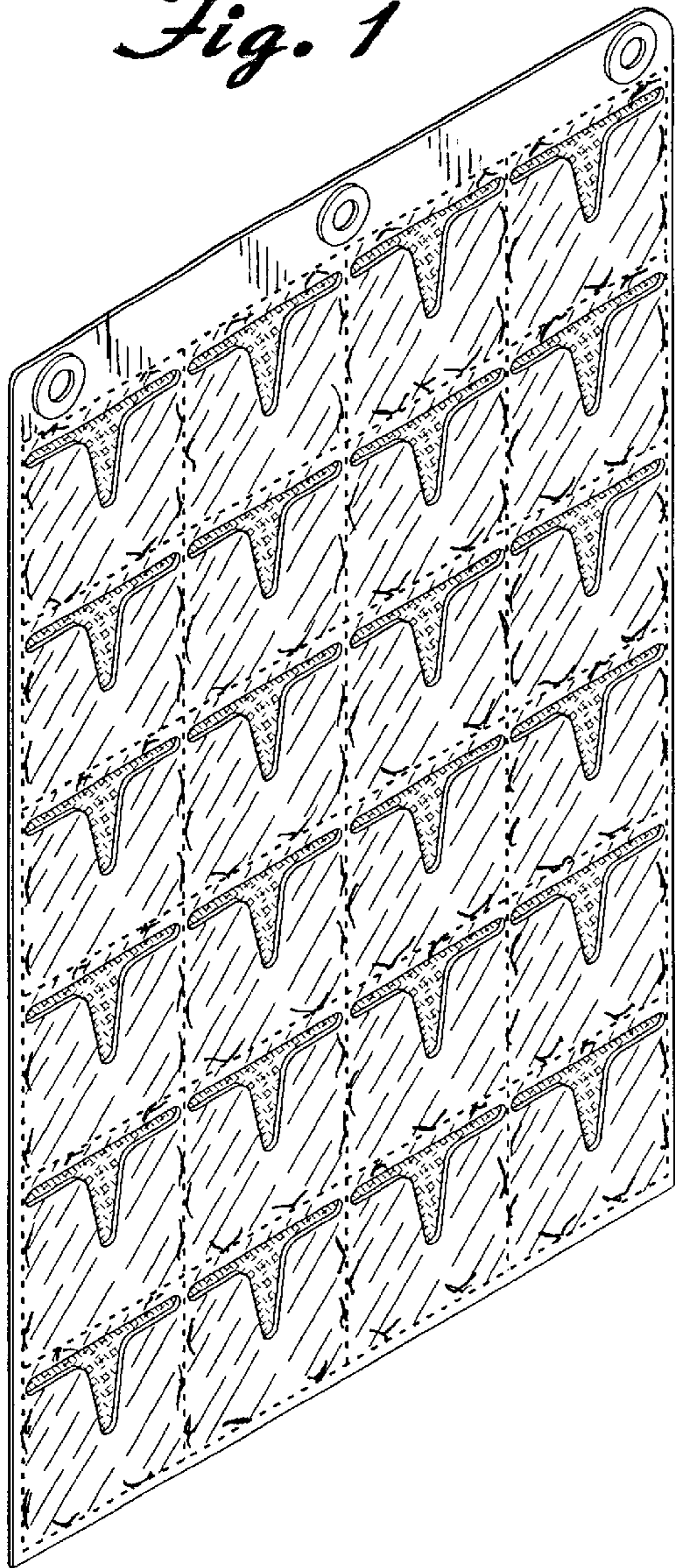
FIG. 5 is a front perspective view similar to FIG. 1 showing the “CD holder” in use.

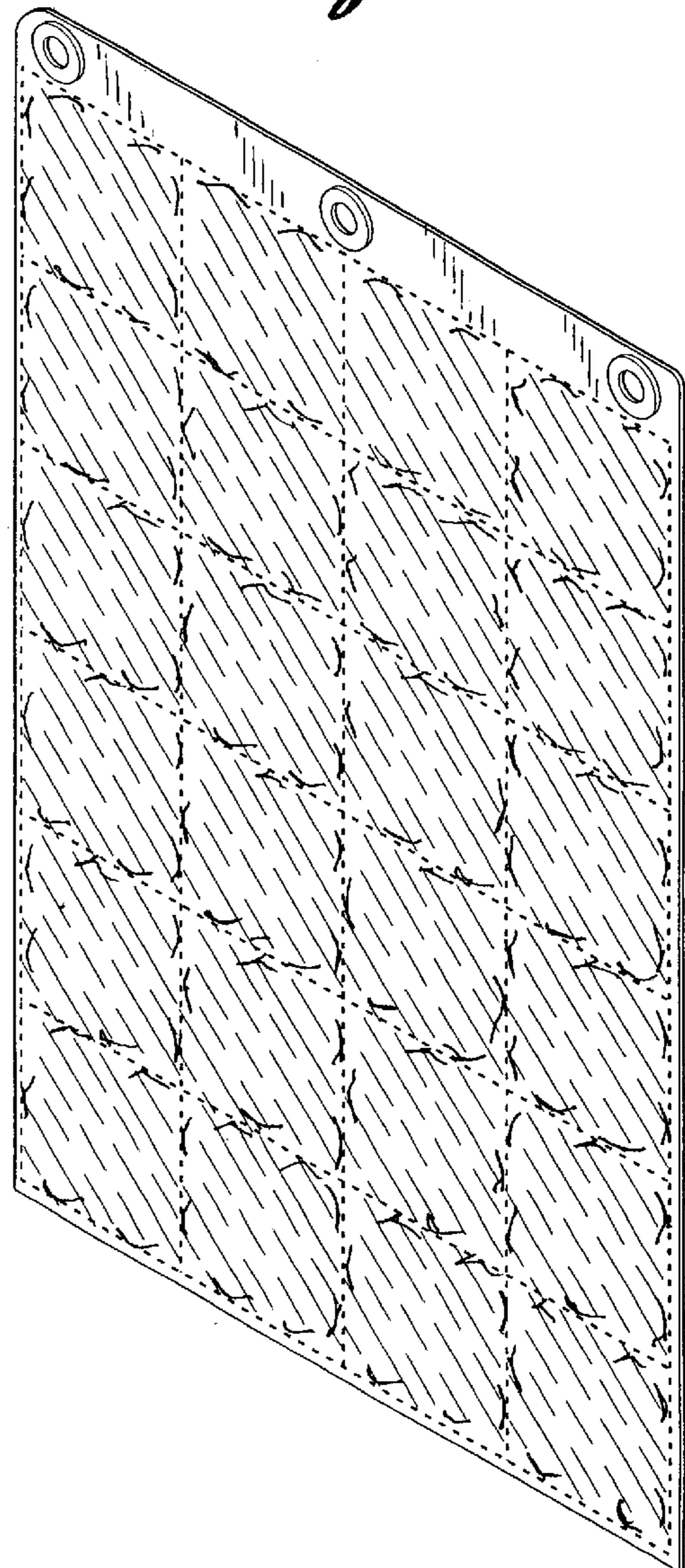

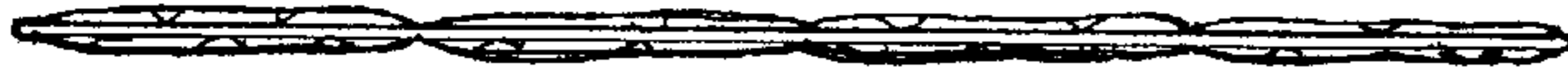
