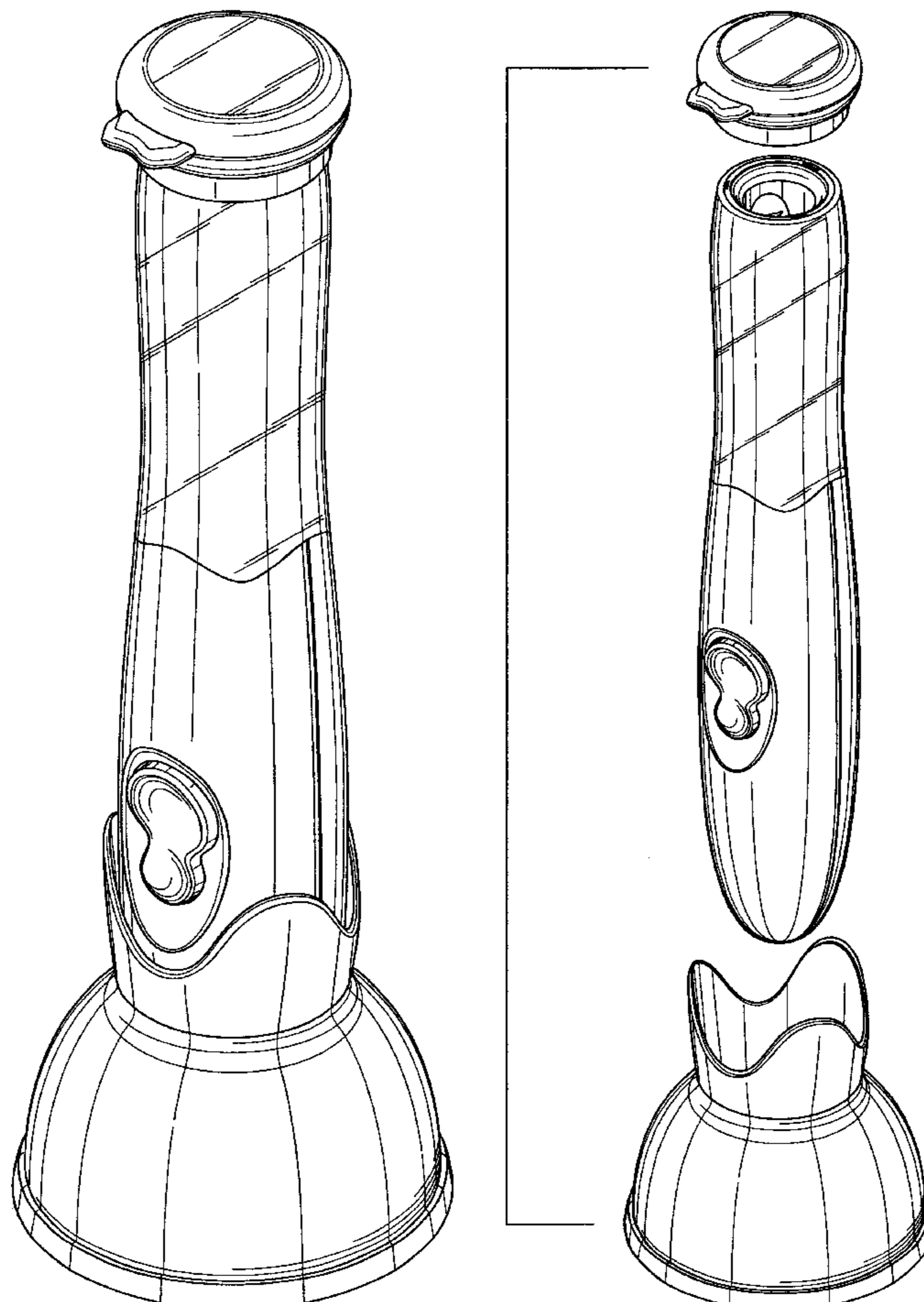
(57) **CLAIM**

The ornamental design for an electric wine opener, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of an electric wine opener showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top plan view thereof;

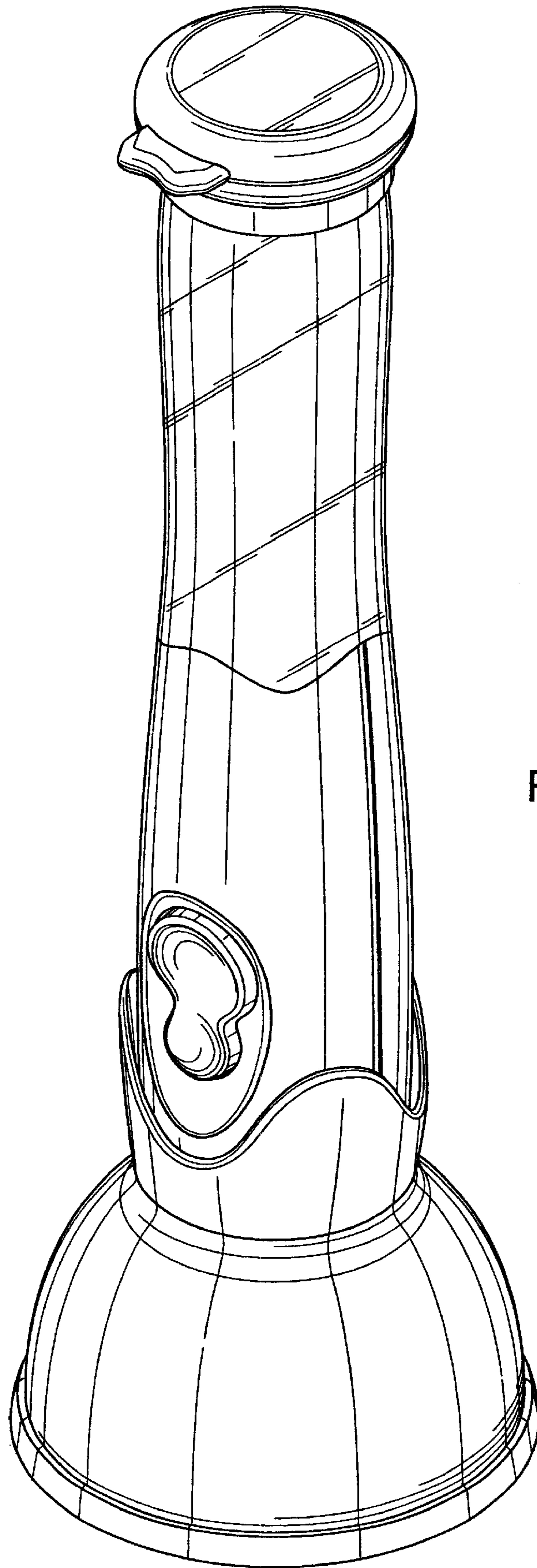

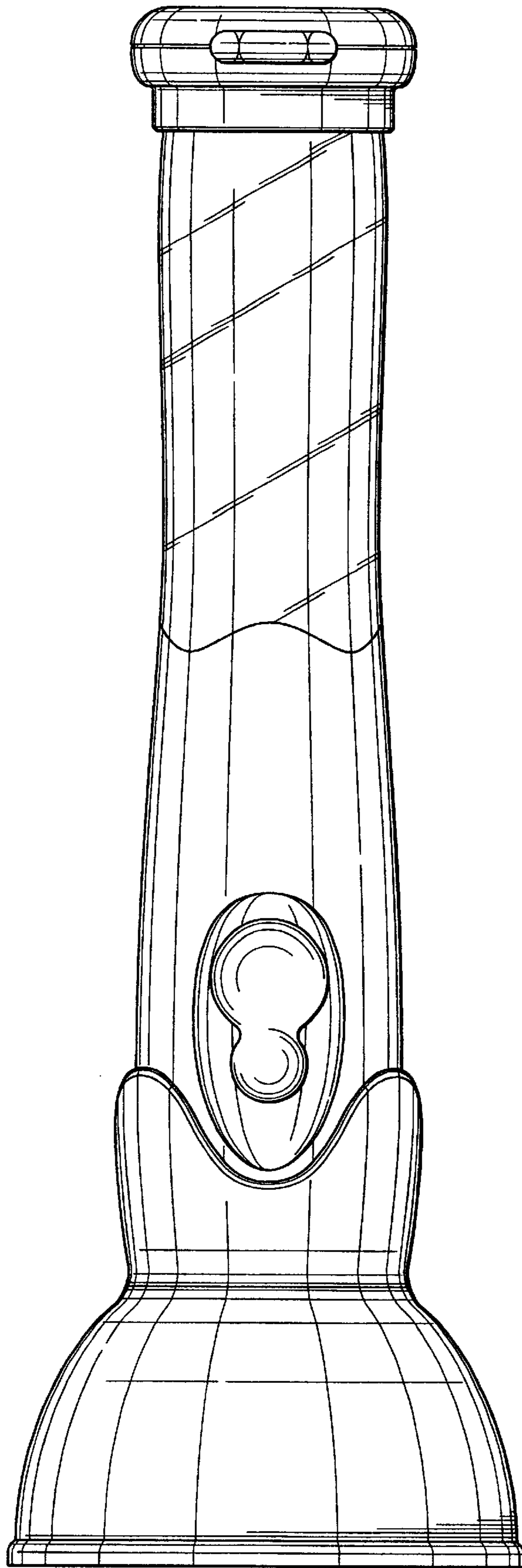

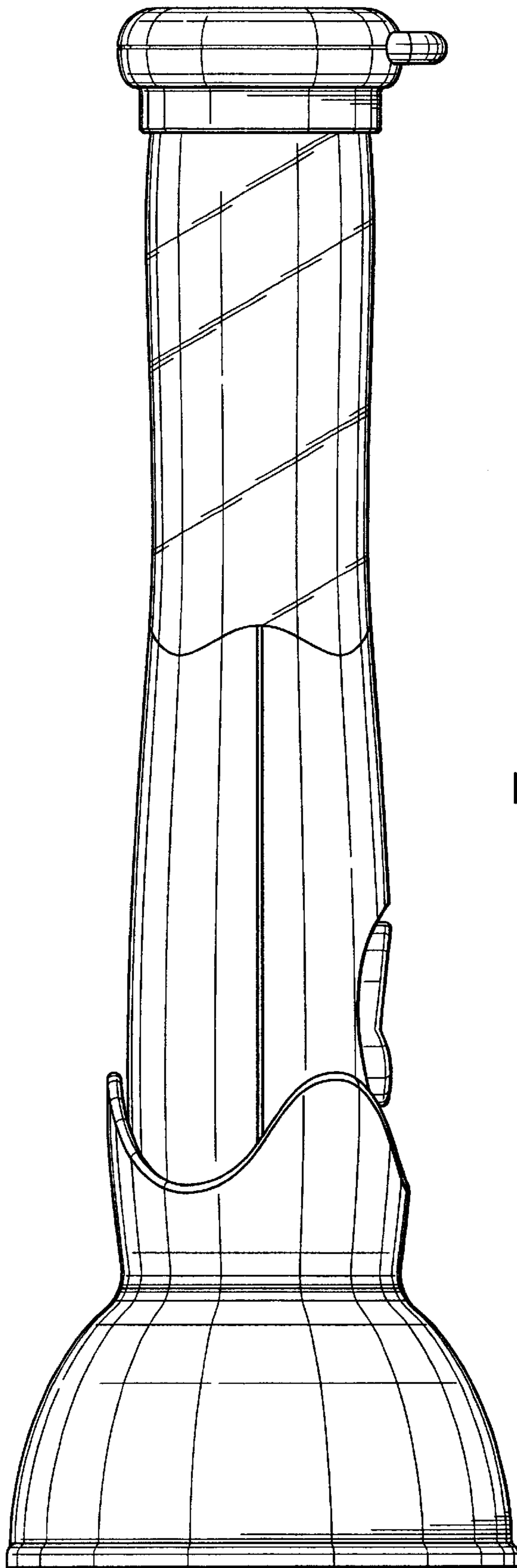

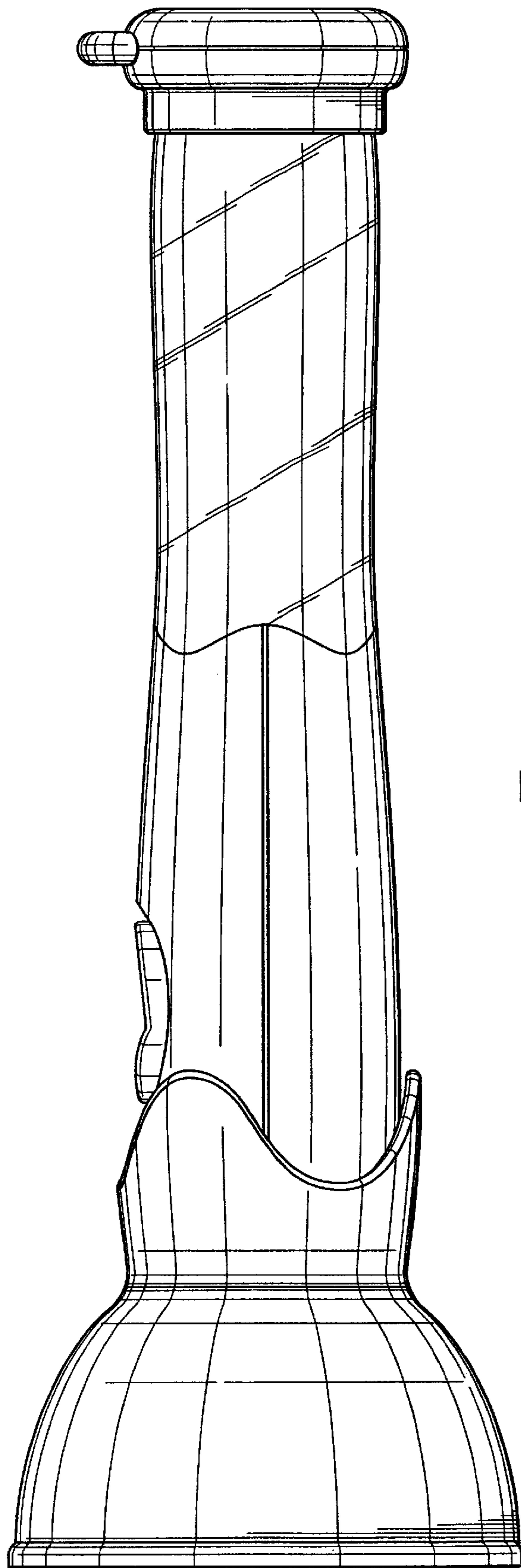

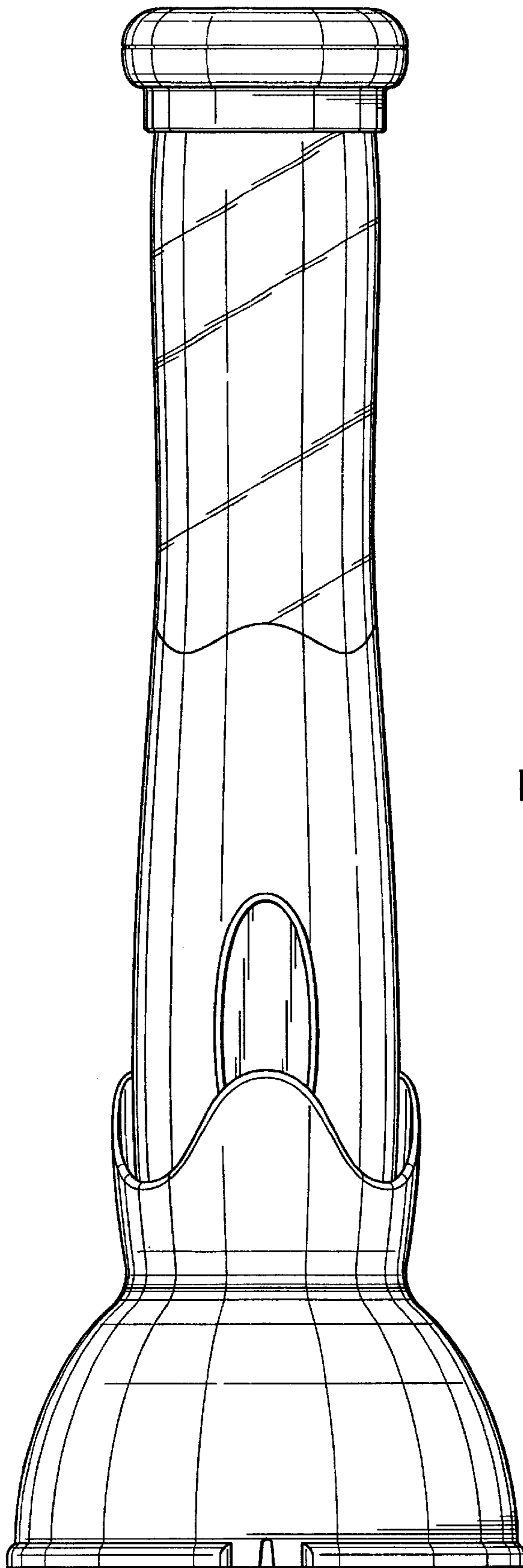

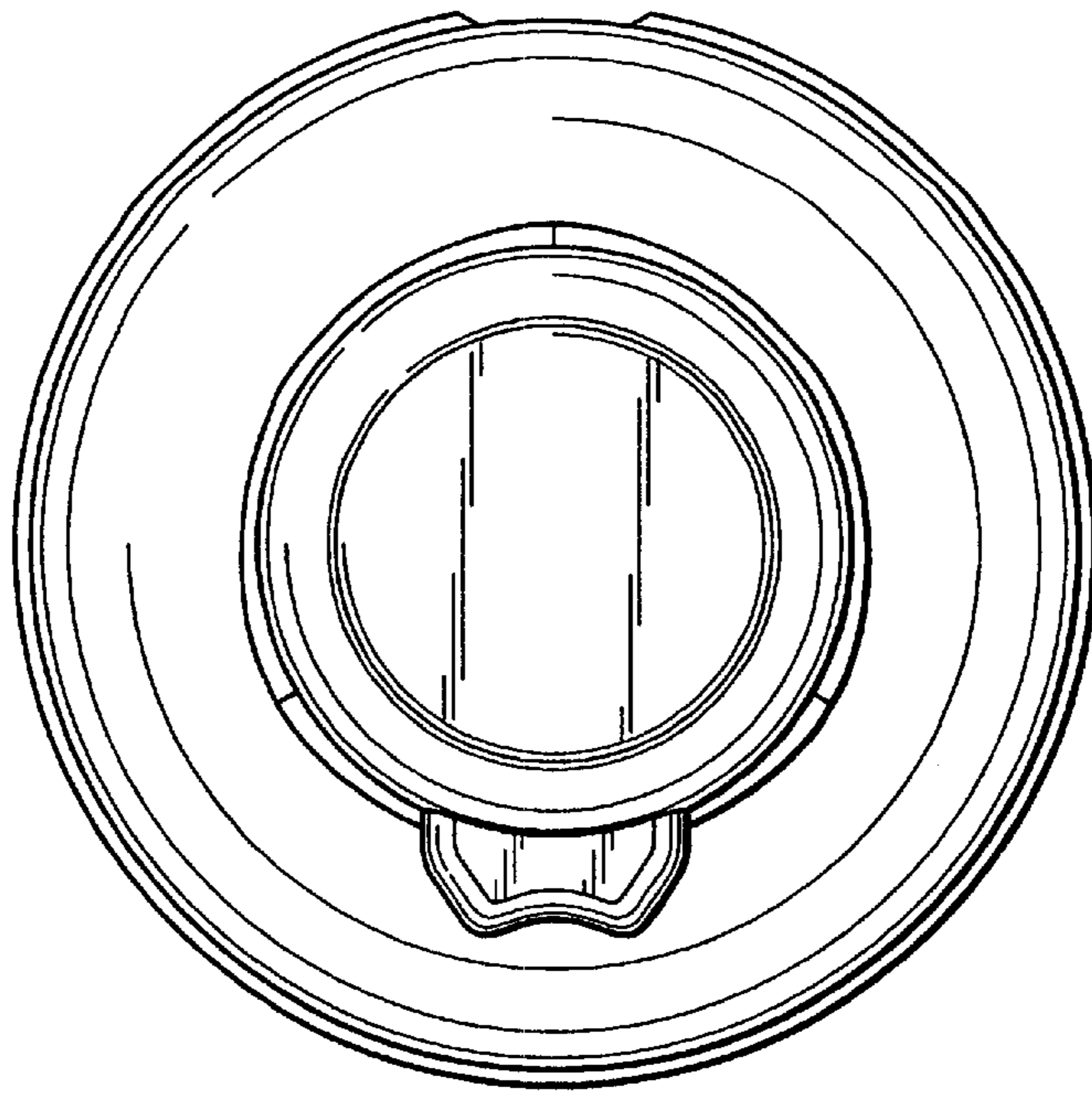

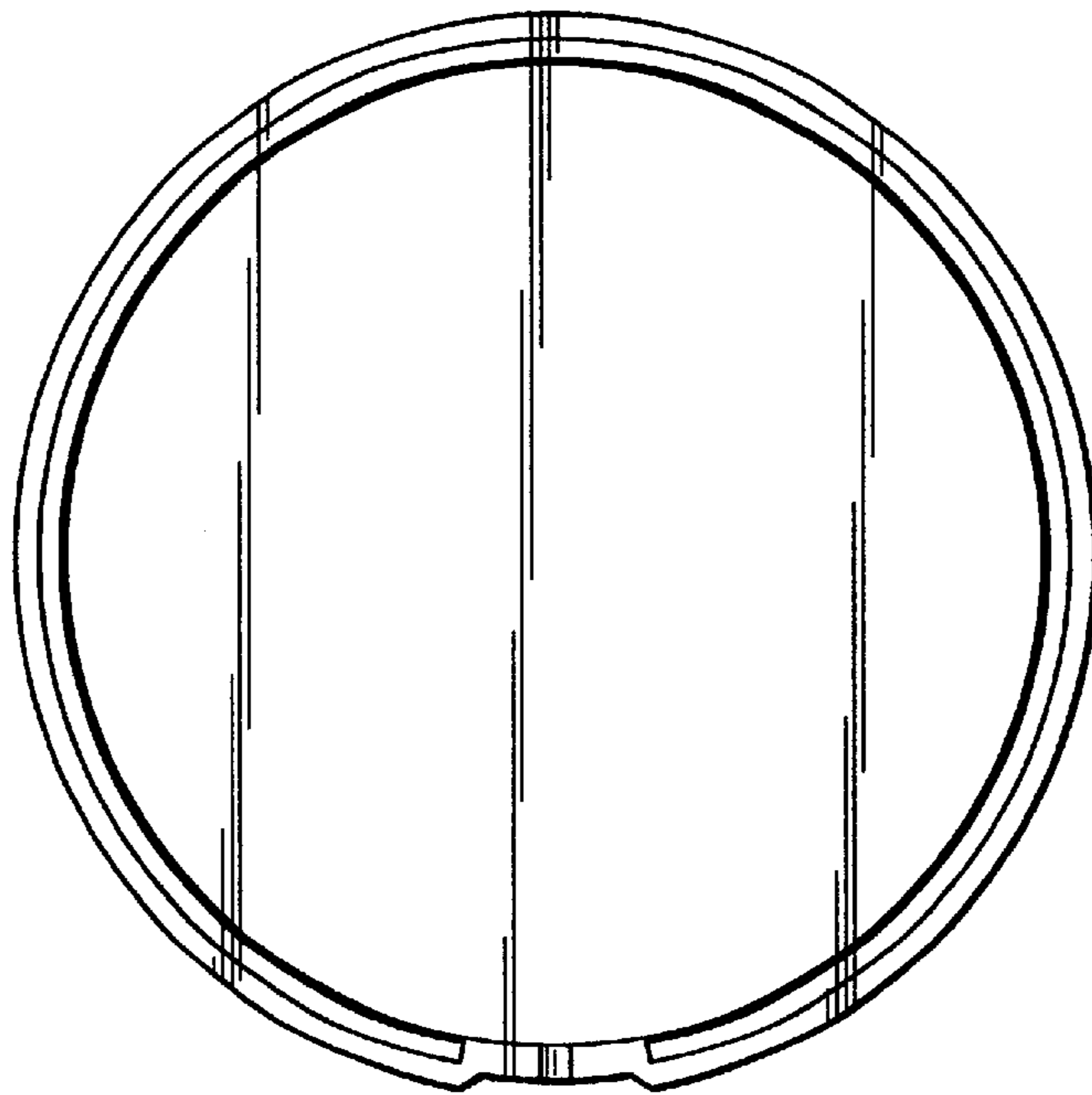

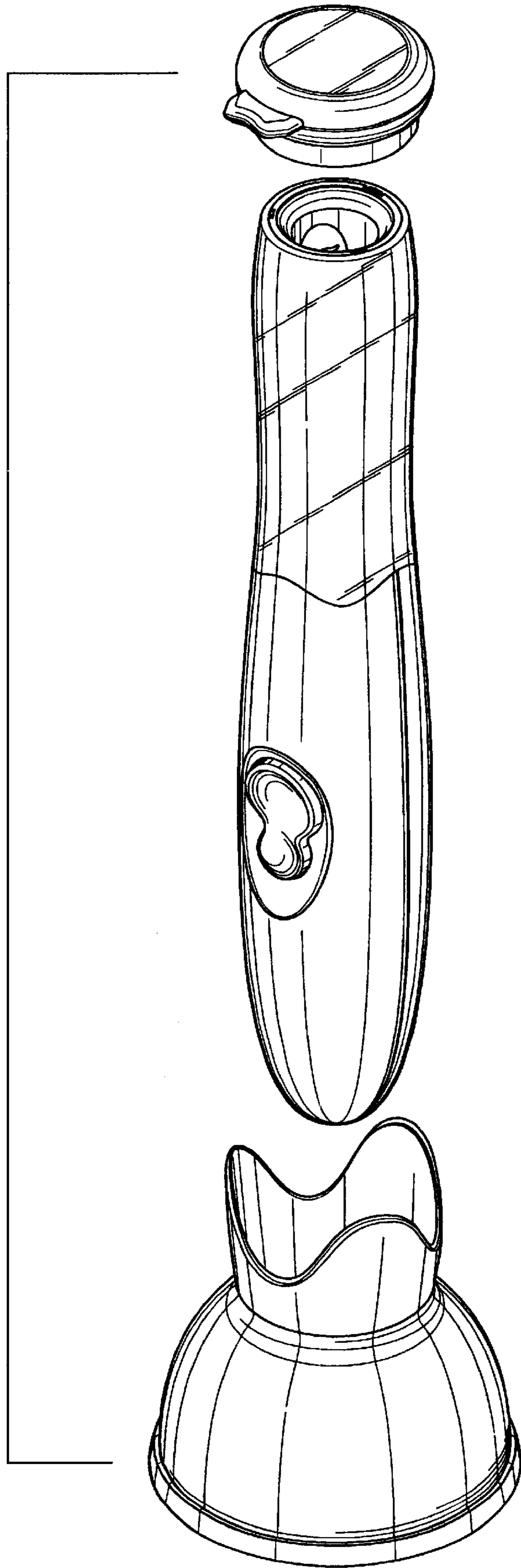

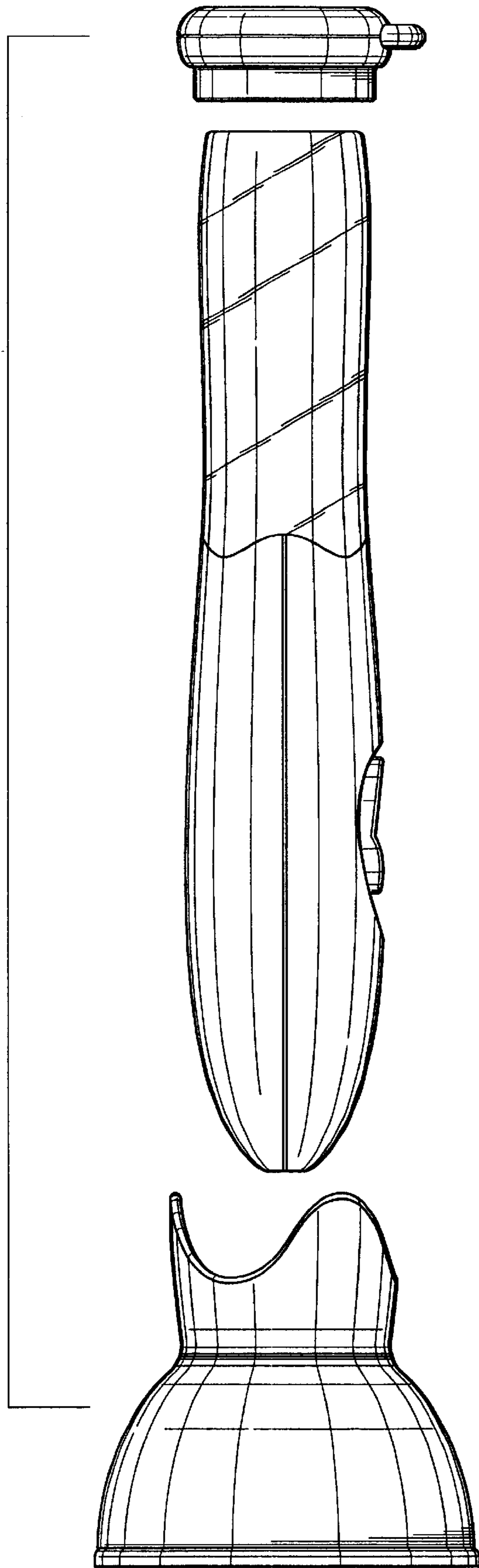
