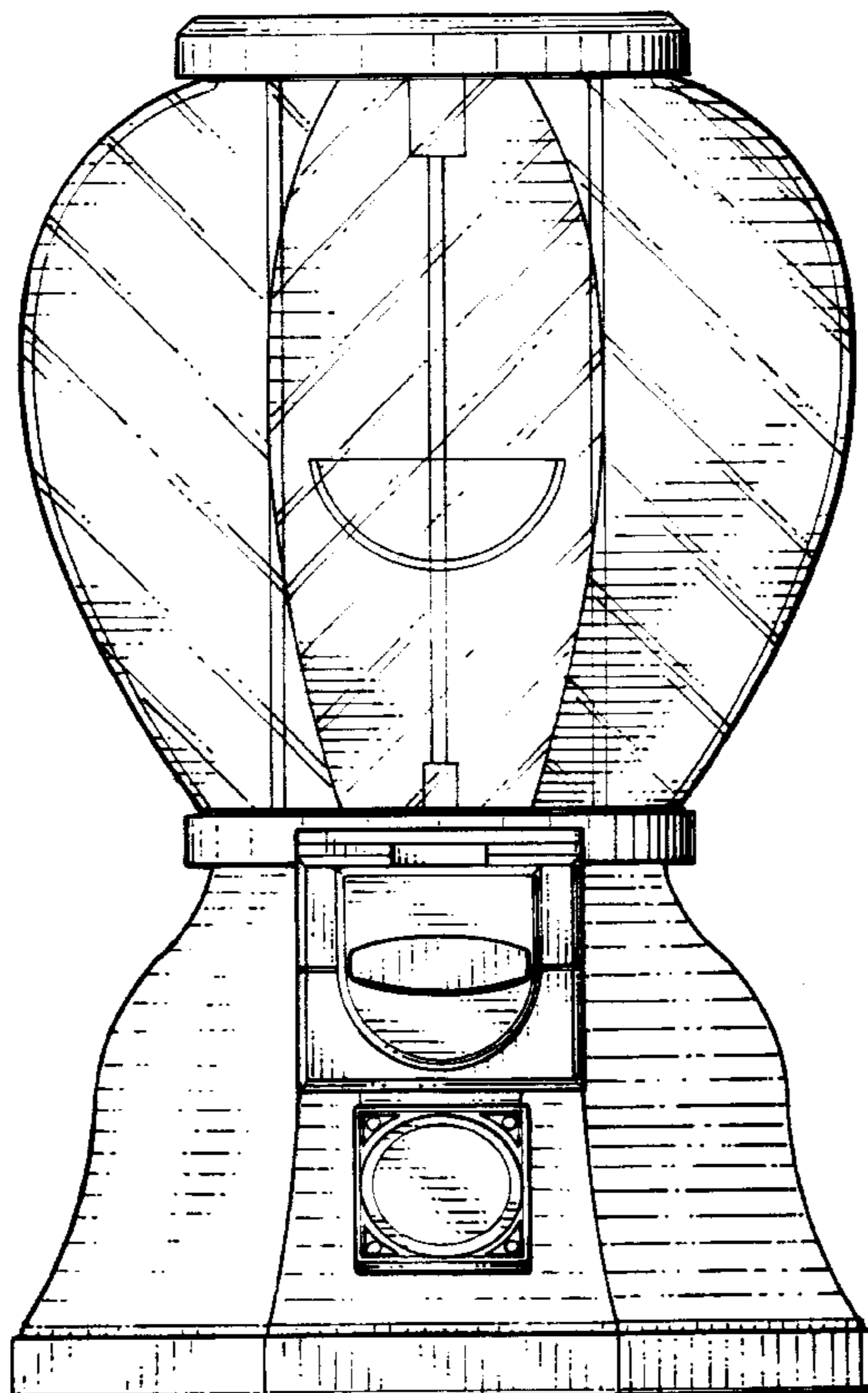
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation of a vending machine showing my new design;

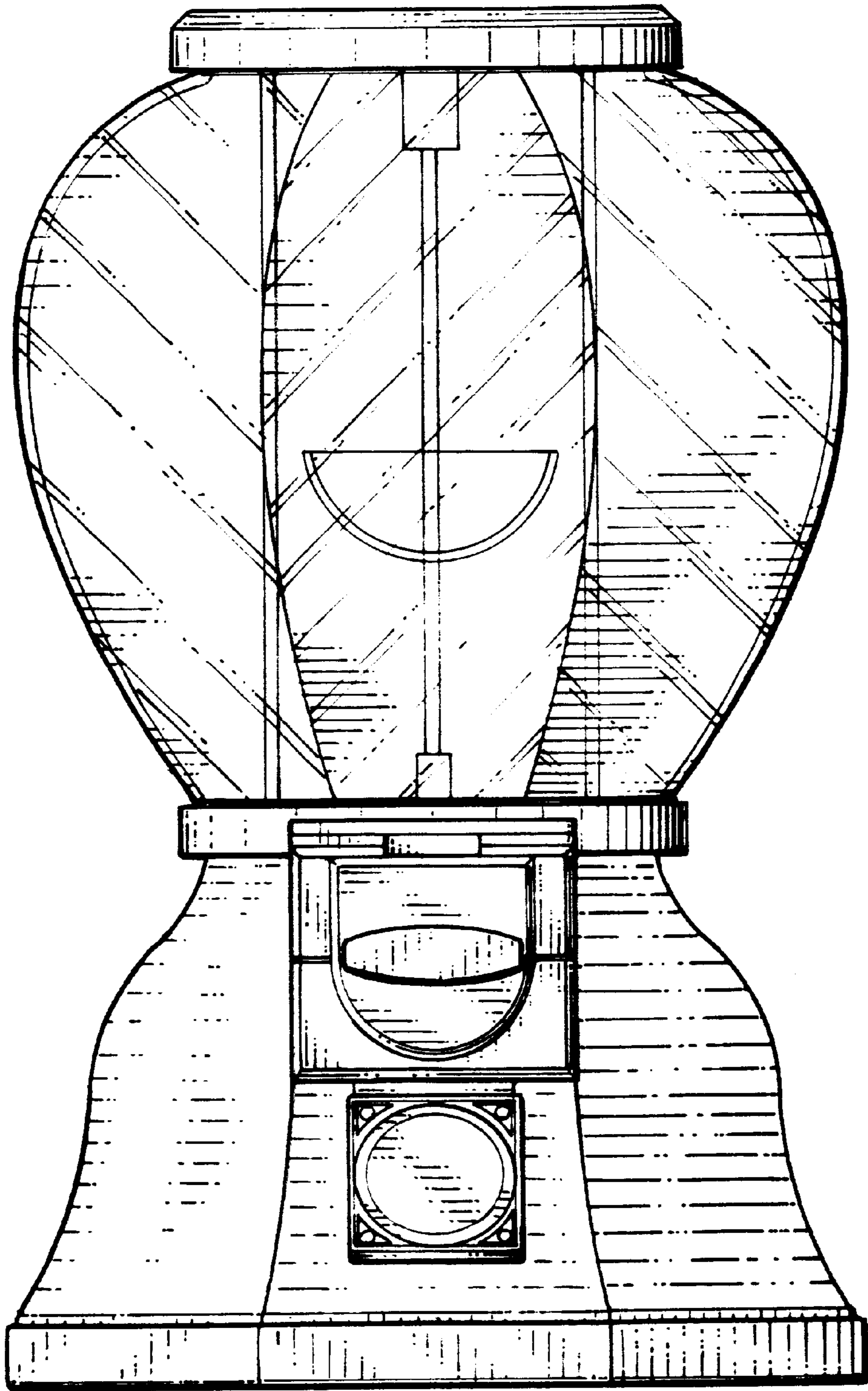

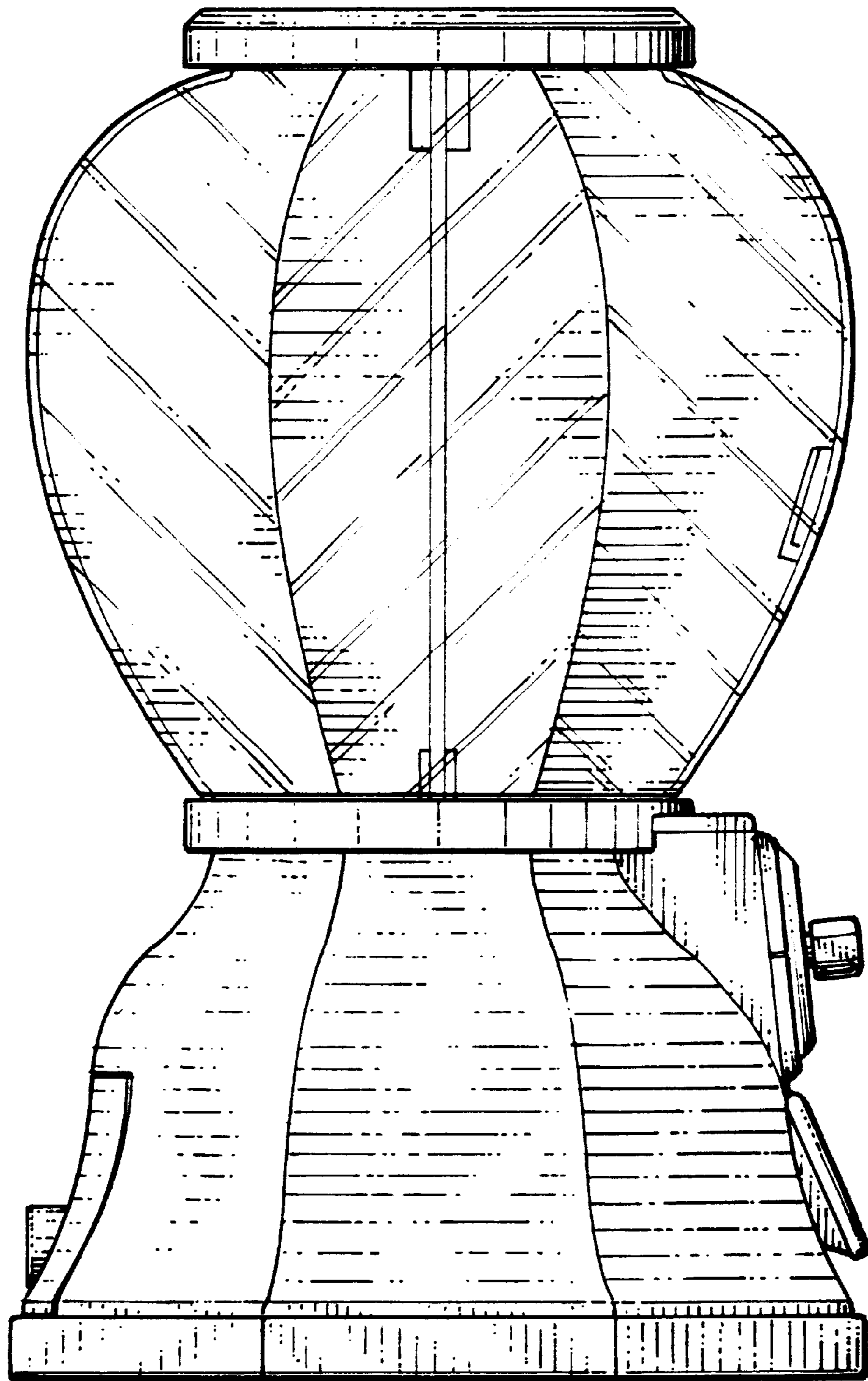

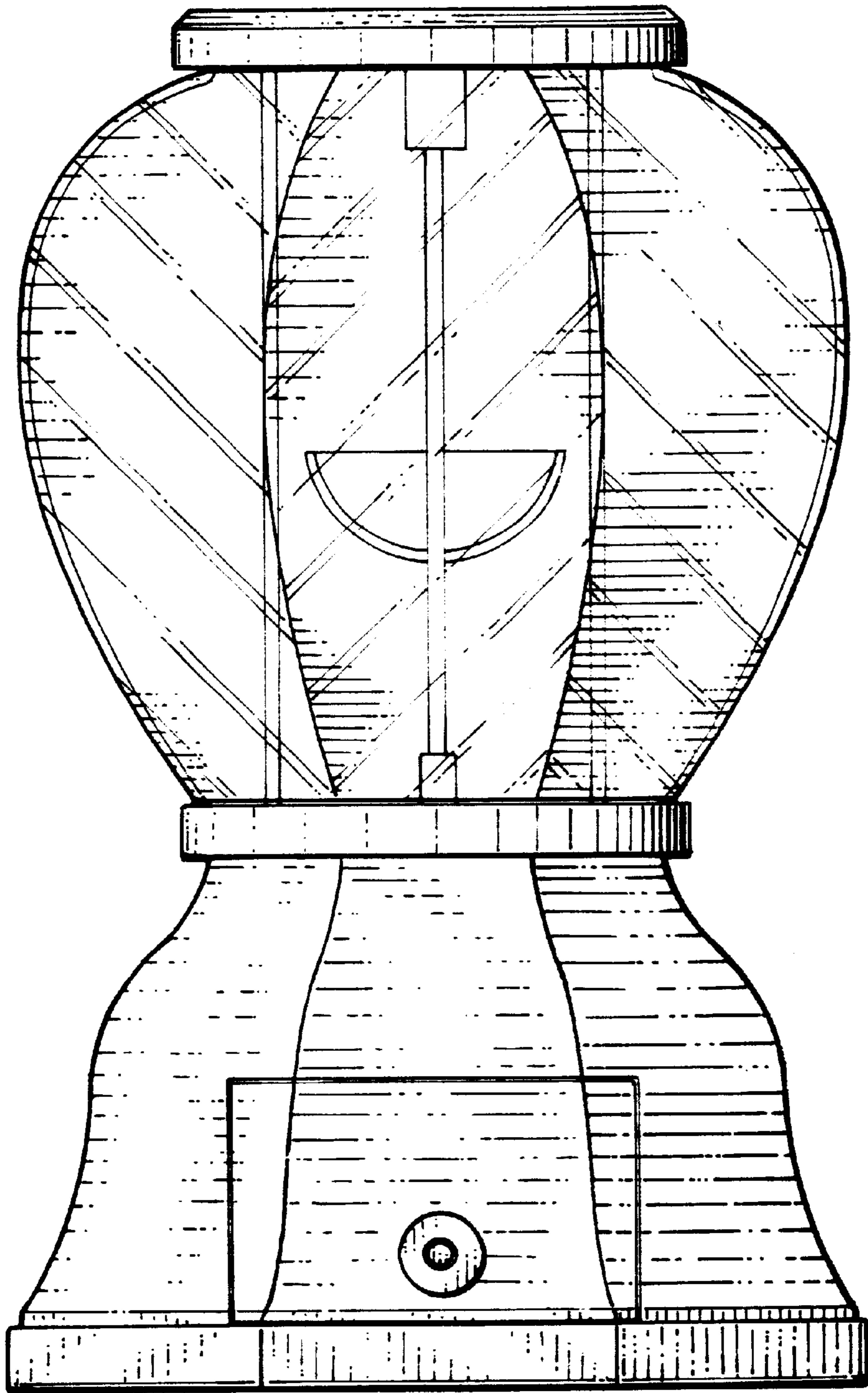

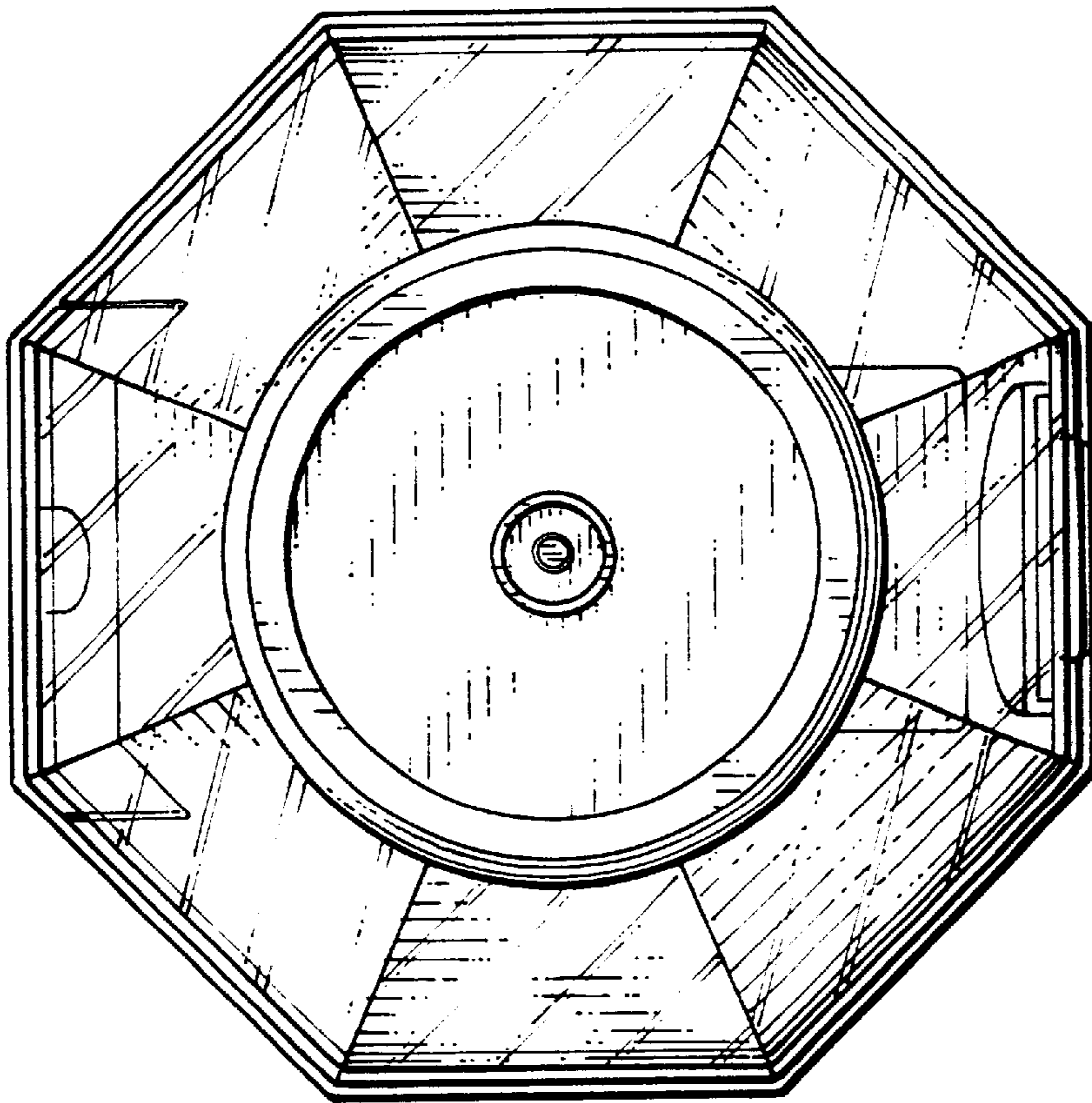

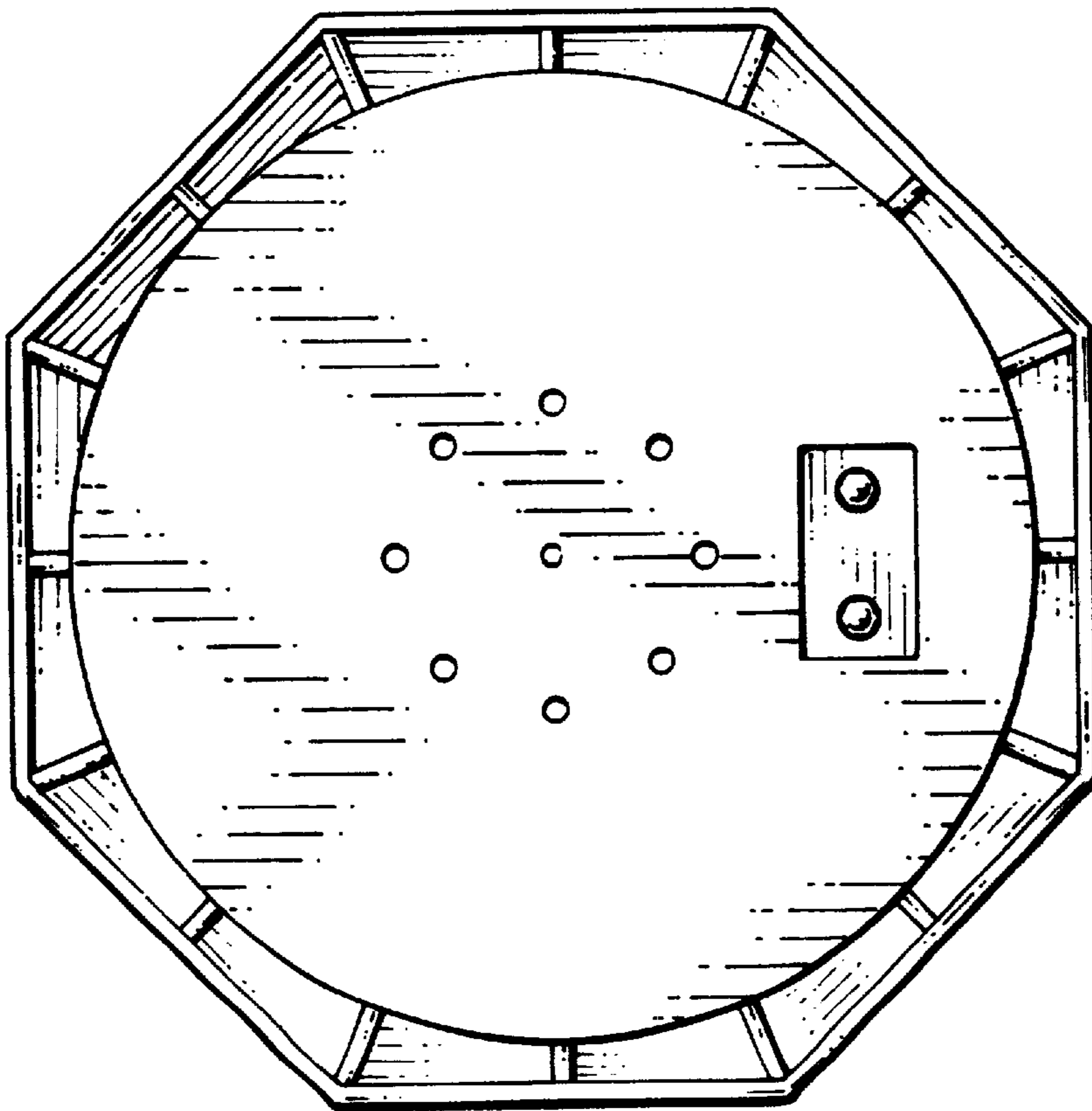
