(57) **CLAIM**

The ornamental design for a pantyhose article, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a pantyhose article according to my new design;

FIG. 2 is an enlarged fragmentary view of FIG. 1 showing the details of the woven crotch portion;

FIG. 3 is a view showing the crotch portion of FIG. 2 from a left side perspective;

FIG. 4 is a view showing the crotch portion of FIG. 2 from a bottom, front and left perspective;

FIG. 5 is an inverted front perspective view of the toe portion enlarged to show the ornamental woven connection line at the toe;

FIG. 6 is an enlarged fragmentary view showing the inner thigh portion of a second embodiment of my design;

FIG. 7 is an enlarged fragmentary view showing the toe portion of the first embodiment in a non-worn state;

FIG. 8 is a bottom view showing the first embodiment of the design in a non worn state, with the legs spread apart and sectioned to allow a more complete view of the crotch zone;

FIG. 9 is a front view showing the first embodiment in a non worn state a back view being a mirror image thereof;

FIG. 10 is a front view of the second embodiment of the design wherein the modification resides in the widened shape of the upper thigh portions and the woven details of the inner thighs as shown in FIGS. 6 and 15;

FIG. 11 is a sectional view along line XI—XI of FIG. 1;

FIG. 12 is a perspective view of the first embodiment shaped as it appears when worn; and

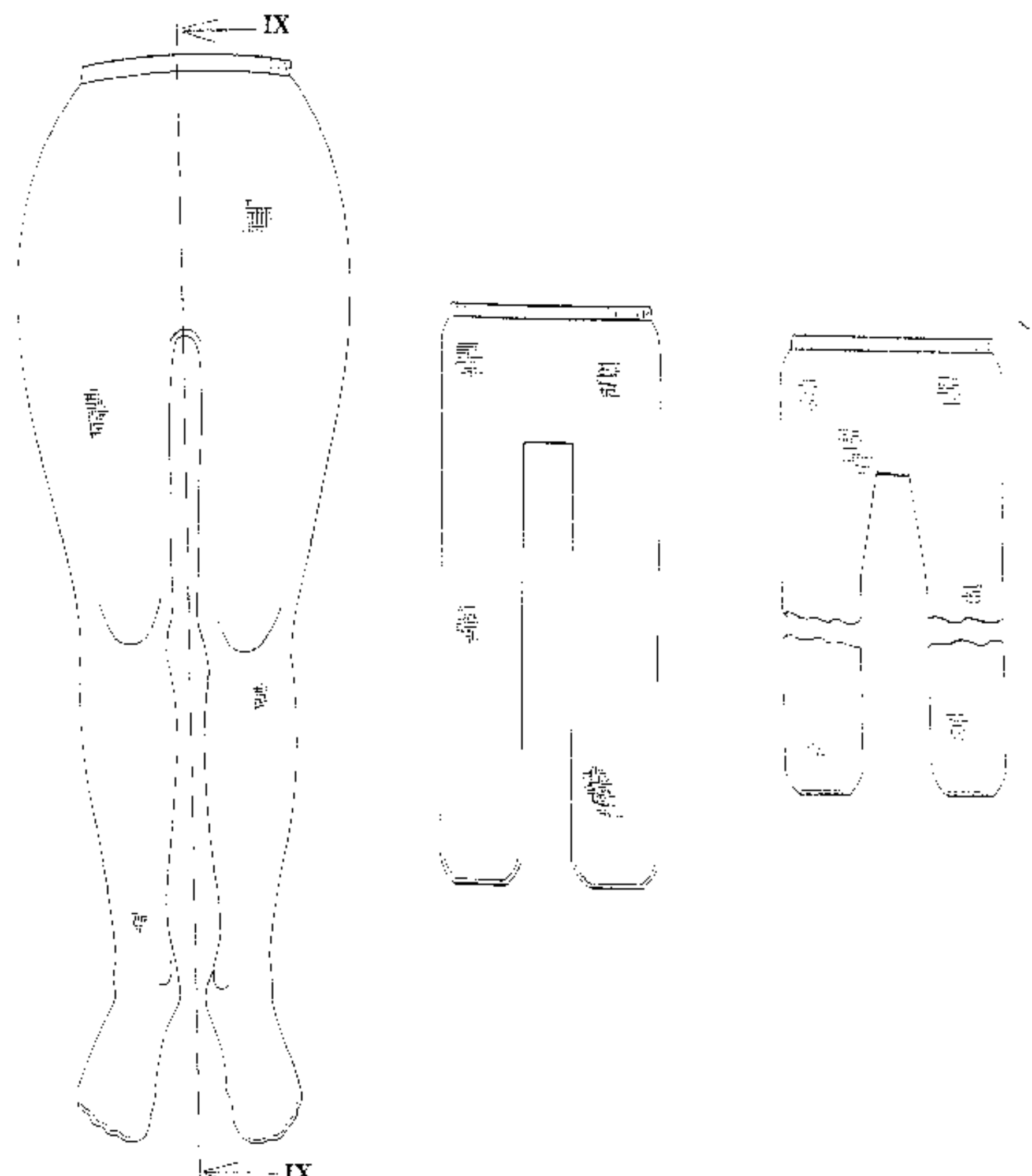
FIG. 13 is a perspective view of the first embodiment shown in another relaxed configuration;

FIG. 14 is a bottom view of the first embodiment of the design with the legs spread apart; and,

FIG. 15 is a bottom view of the second embodiment of the design with the legs spread apart.

The pantyhose article is shown partially broken away in FIGS. 10 and 13 for ease of illustration.

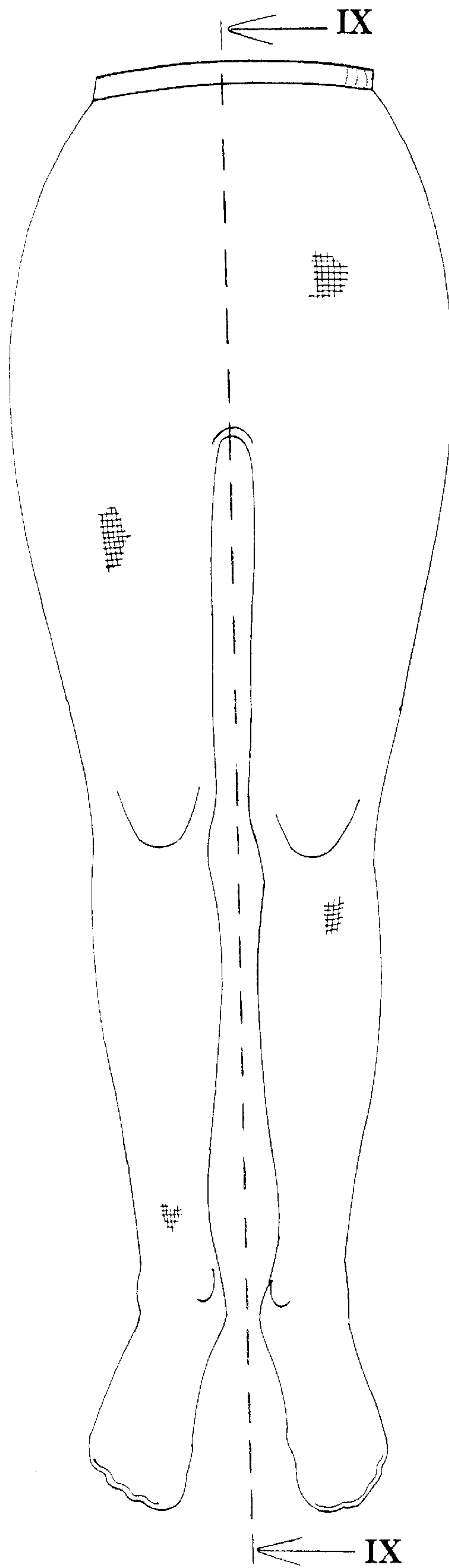

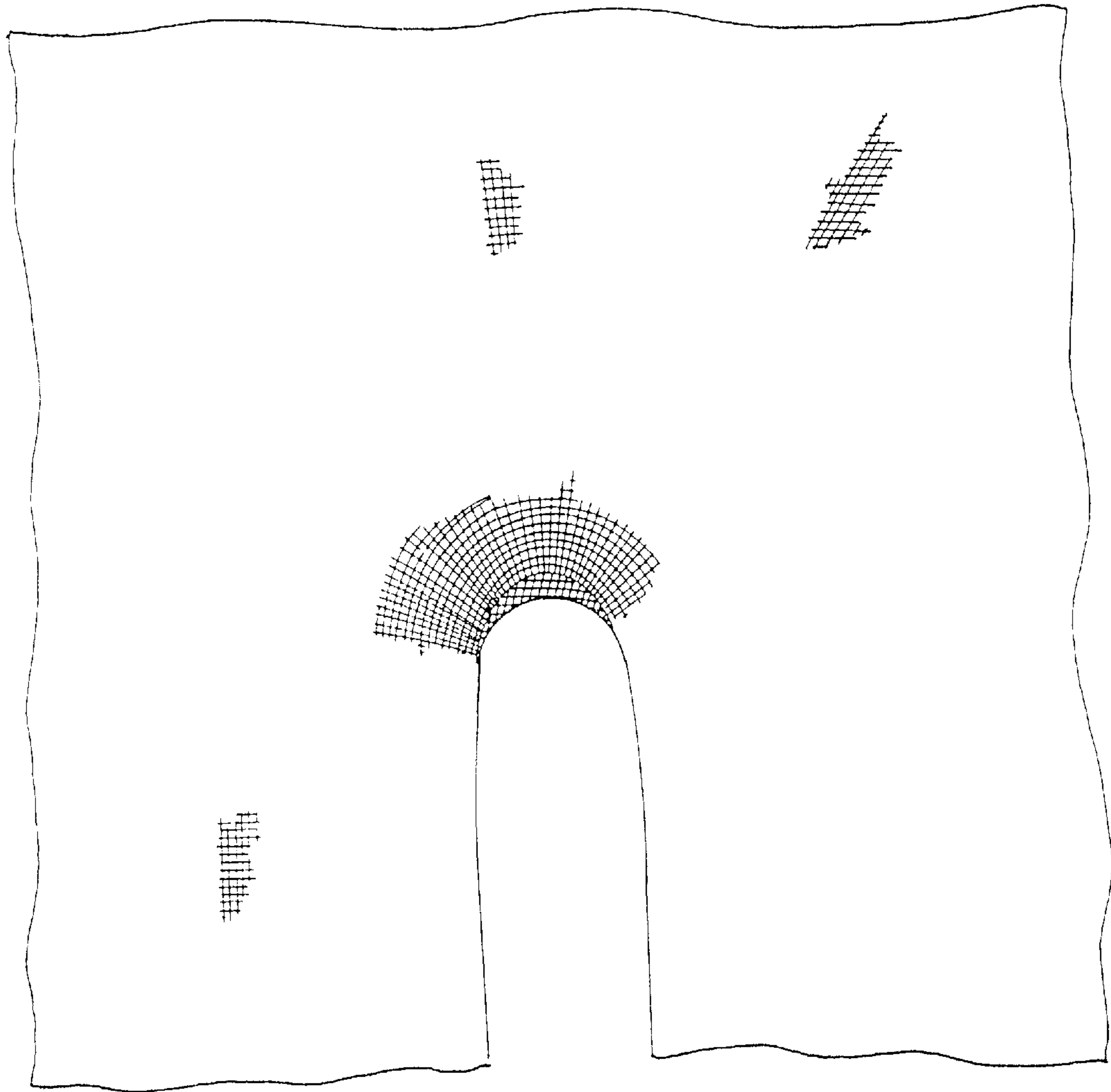

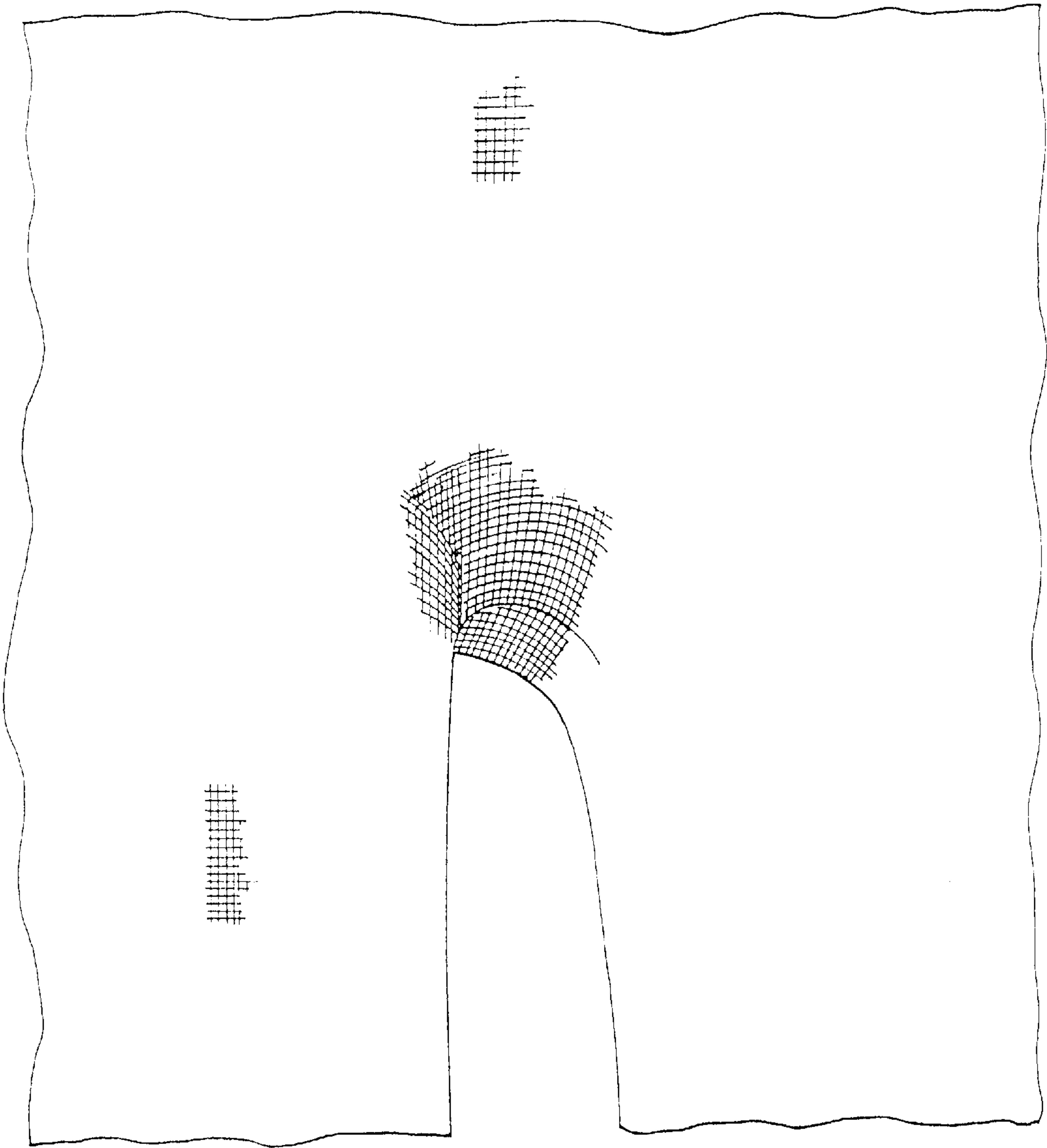

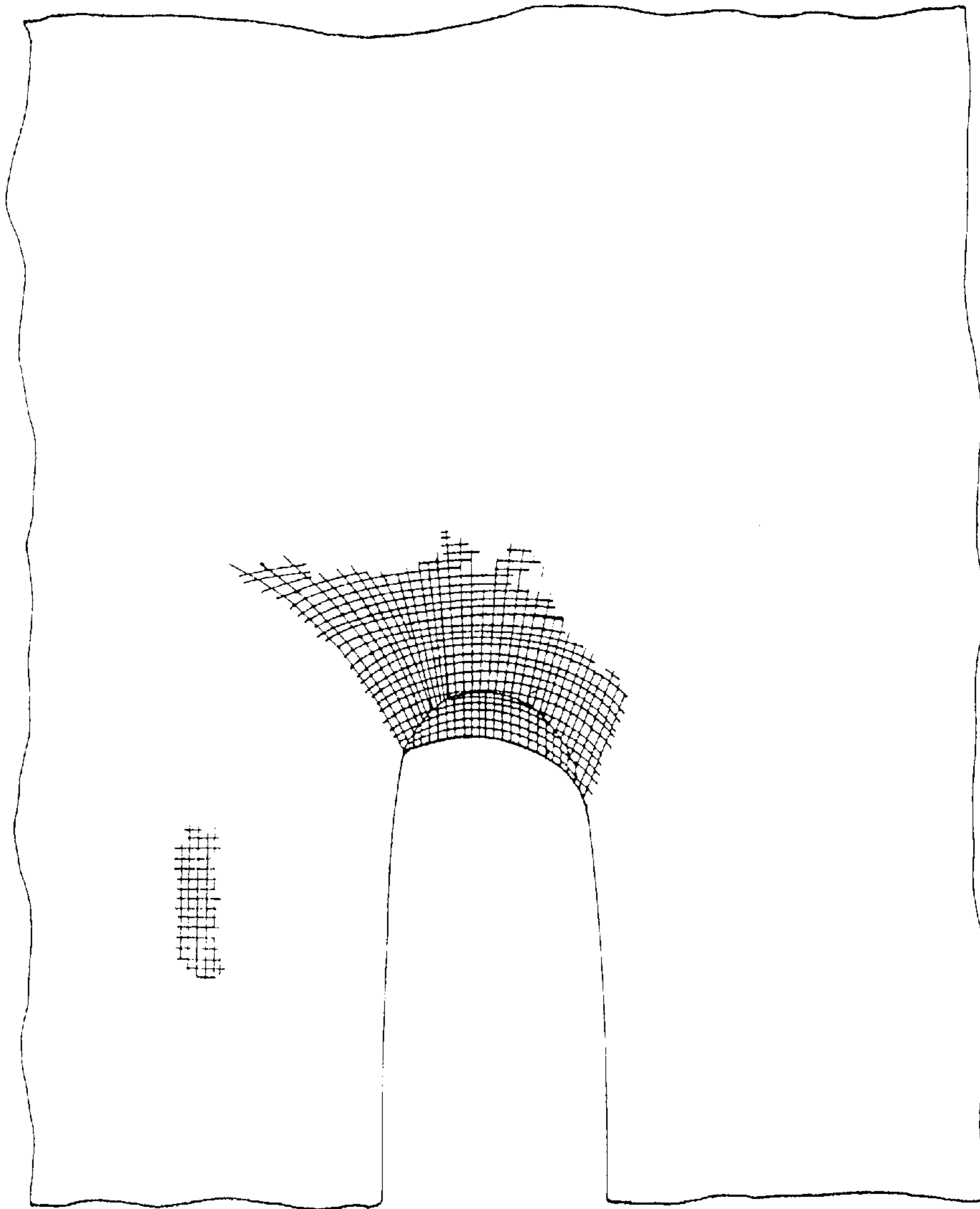

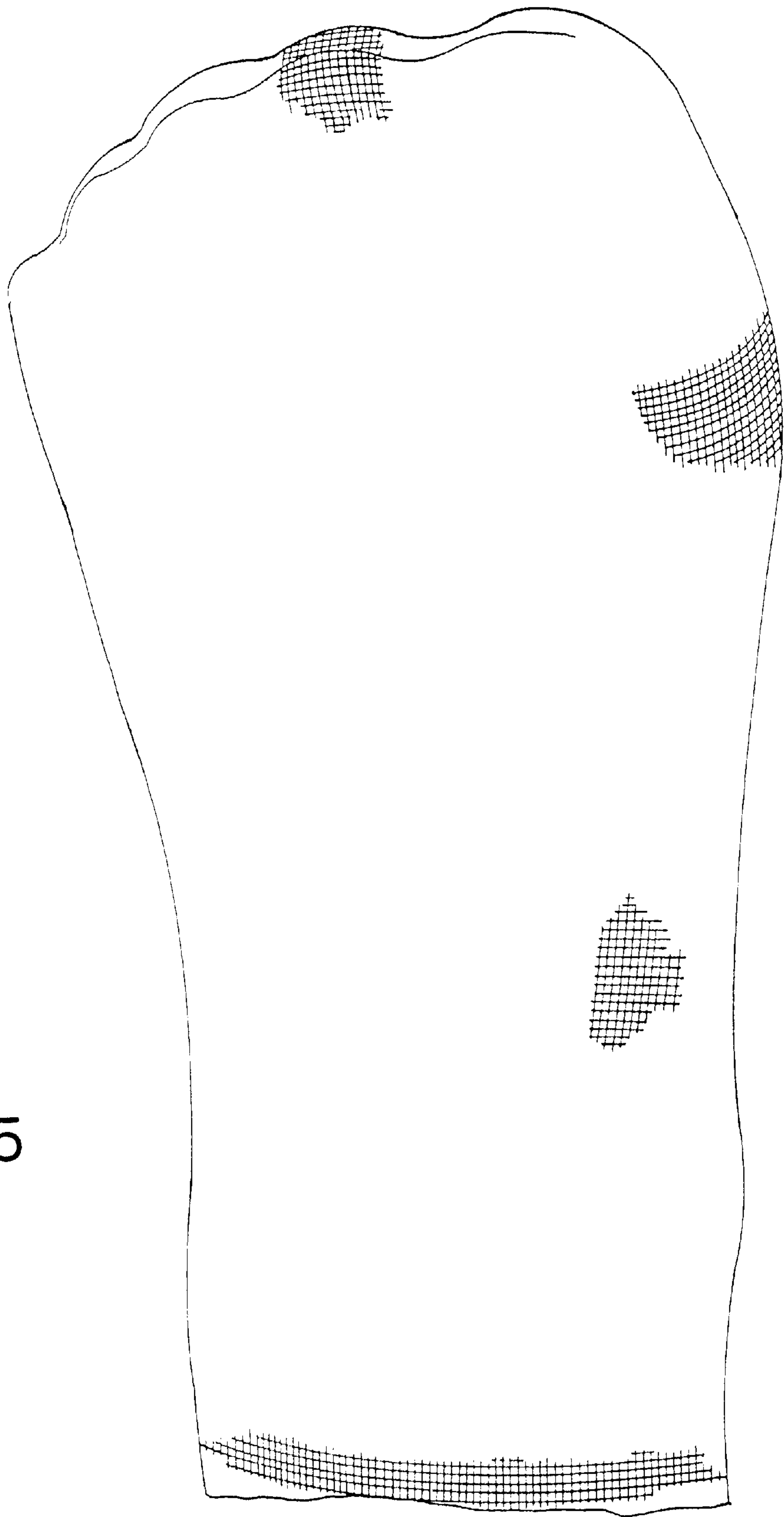

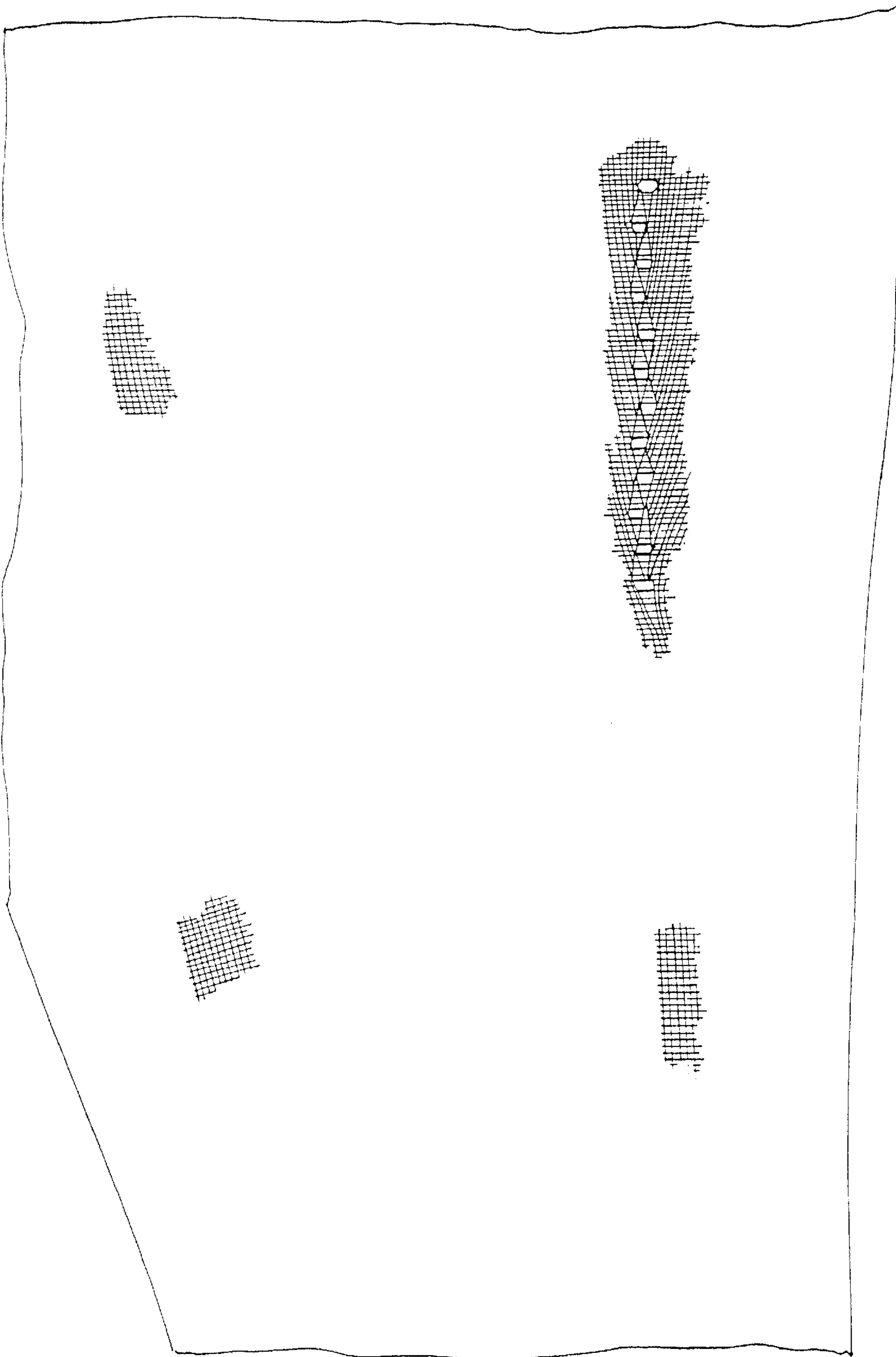

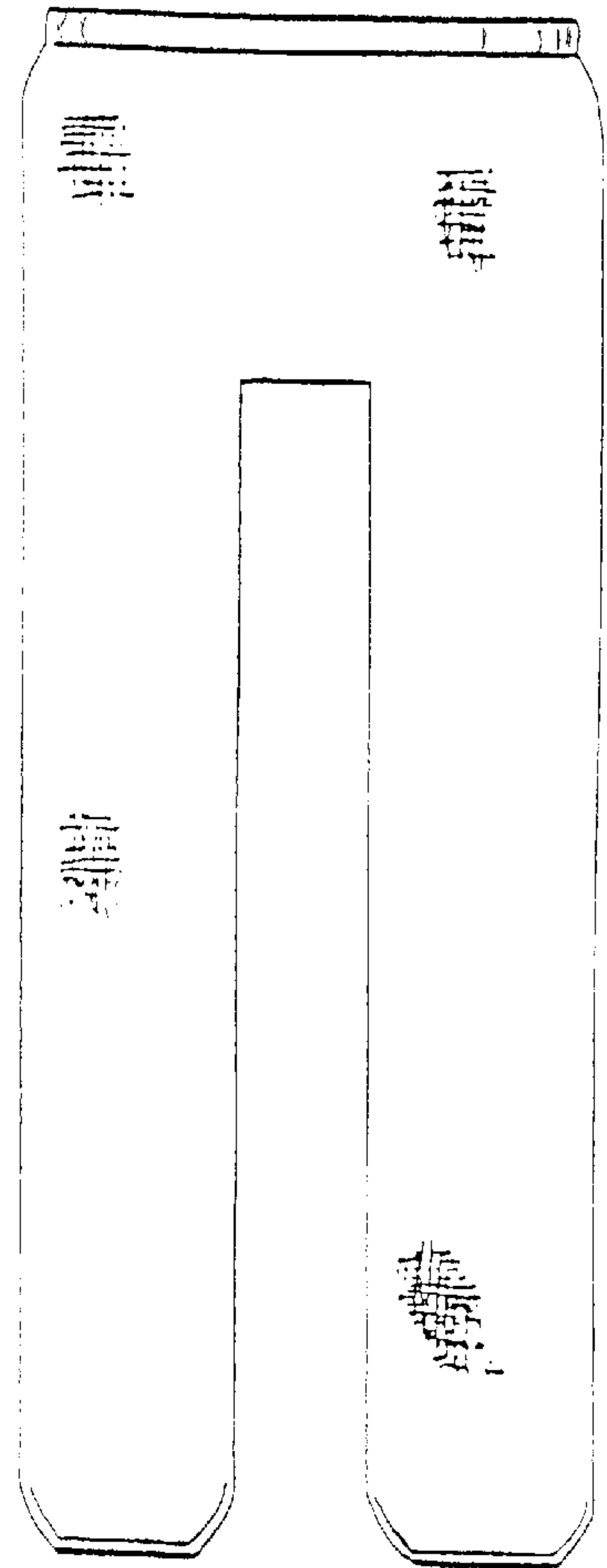

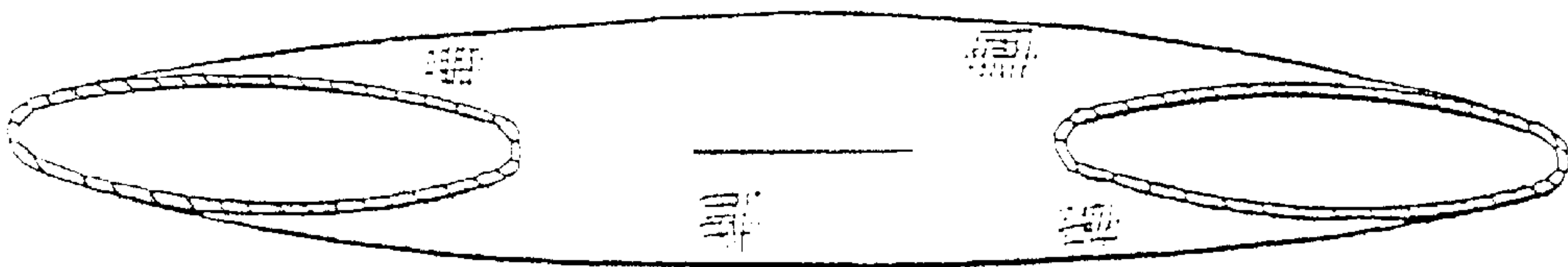

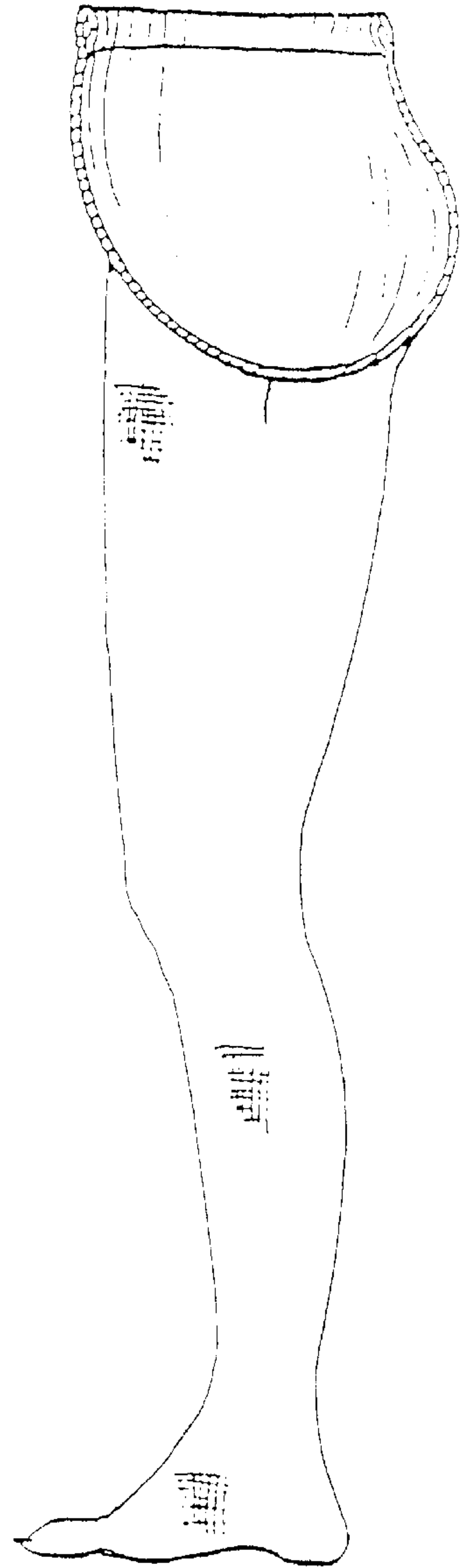

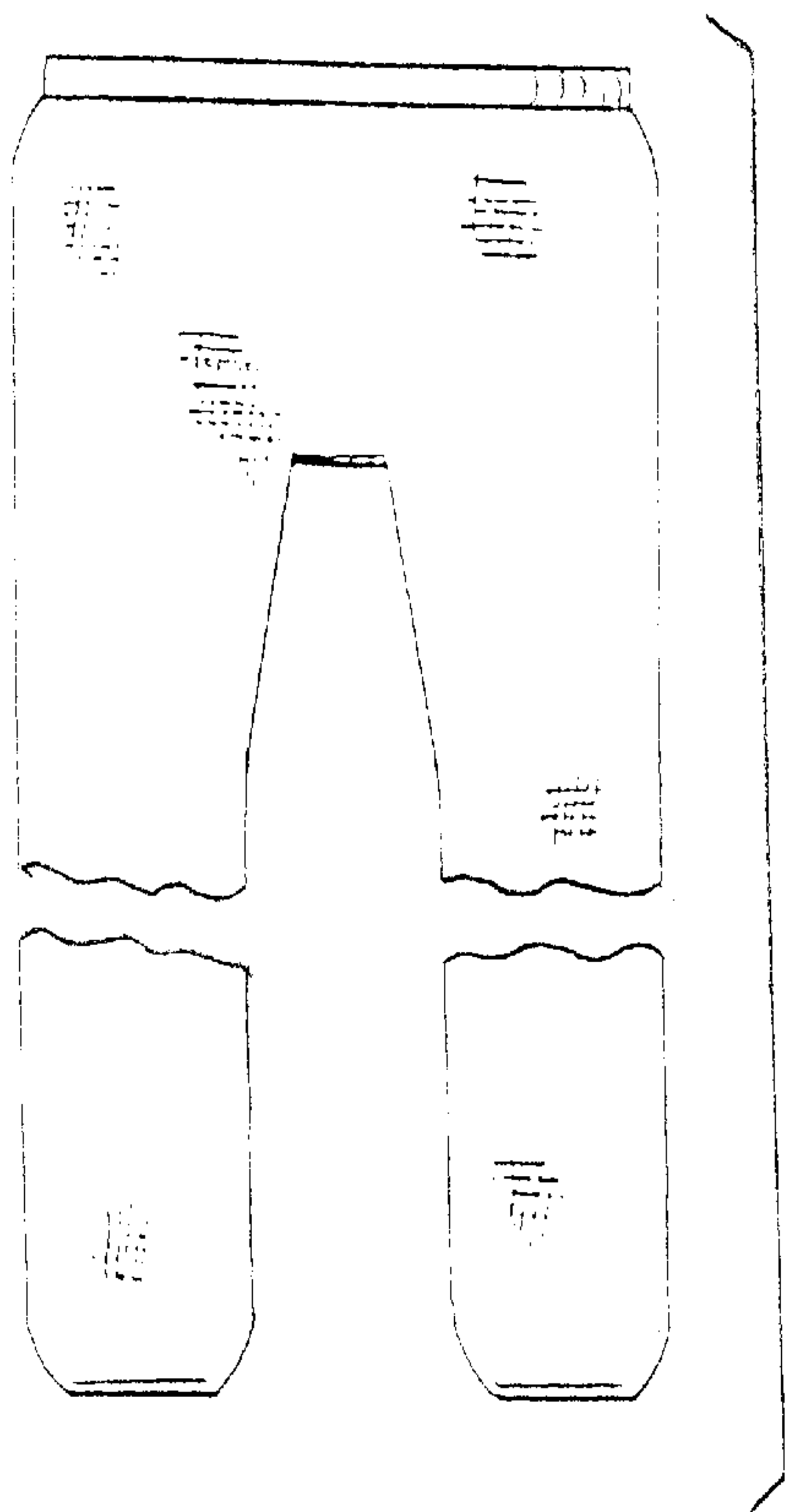

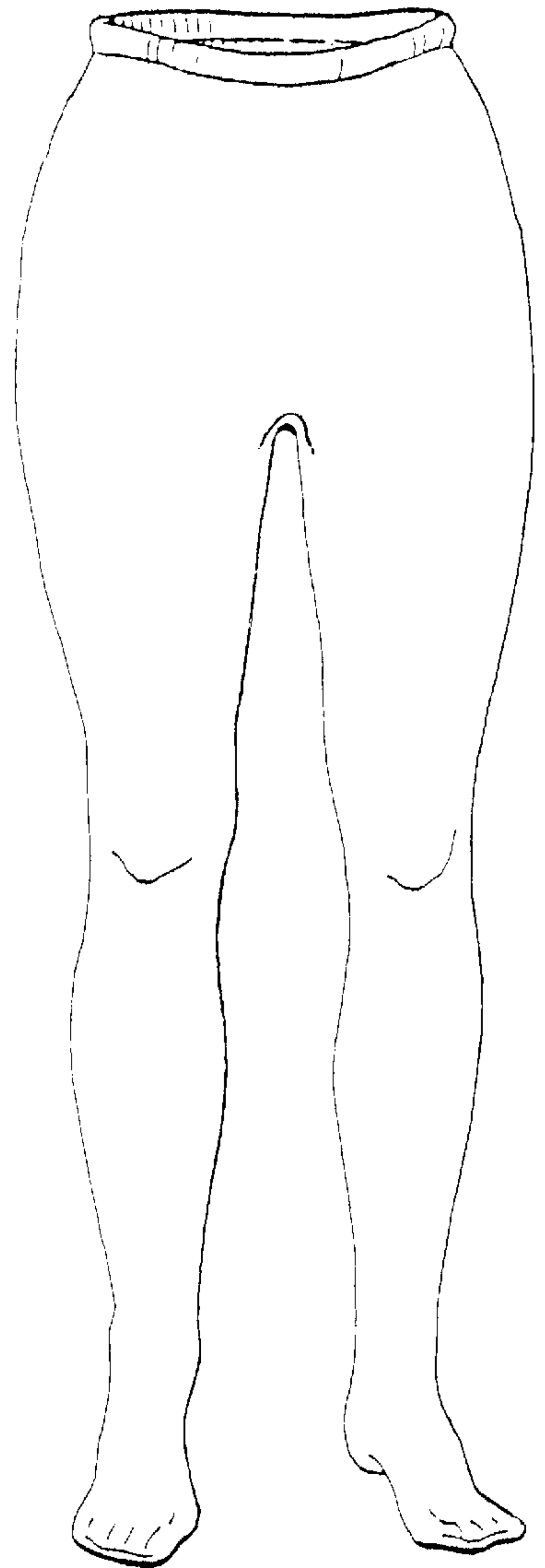
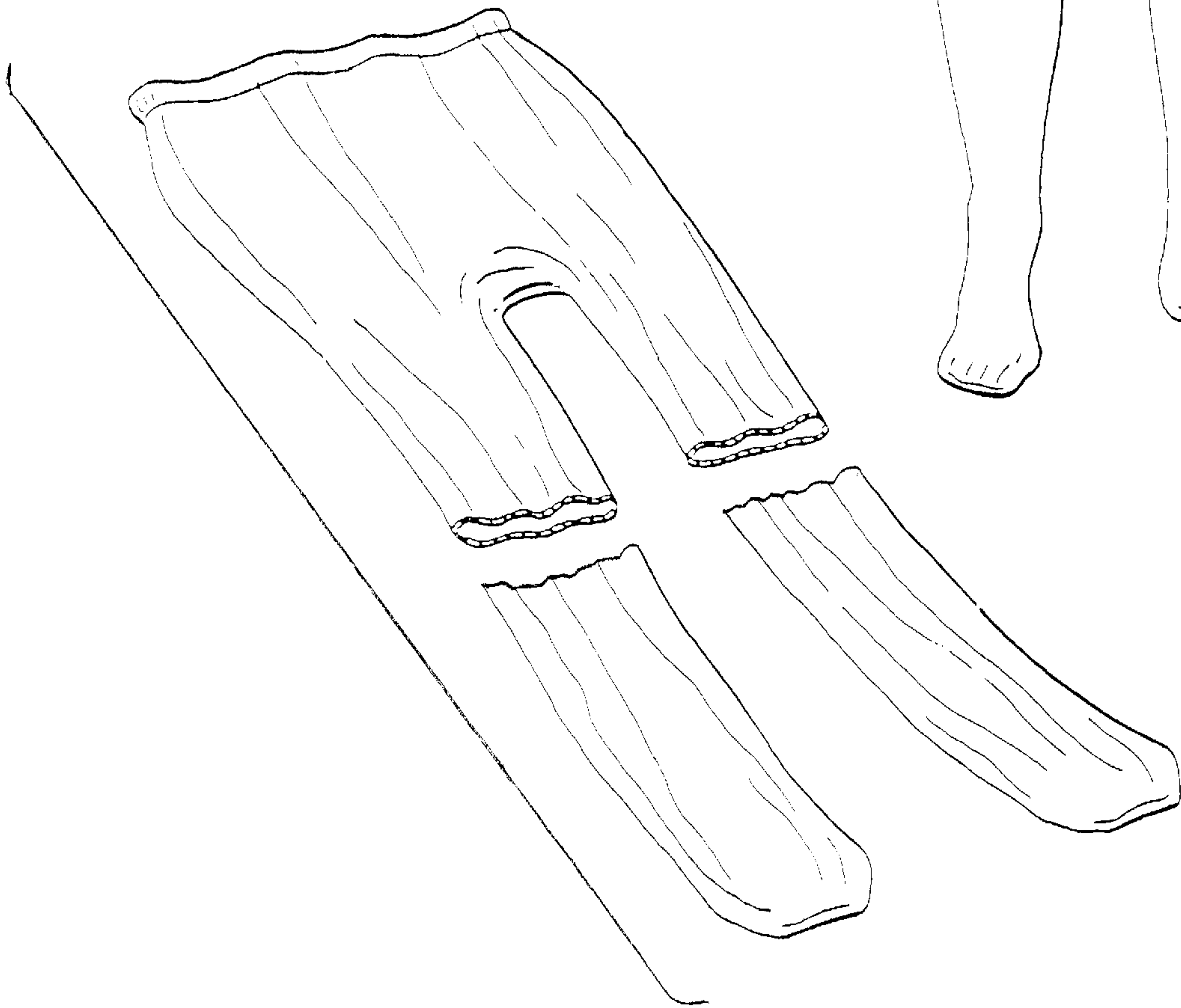

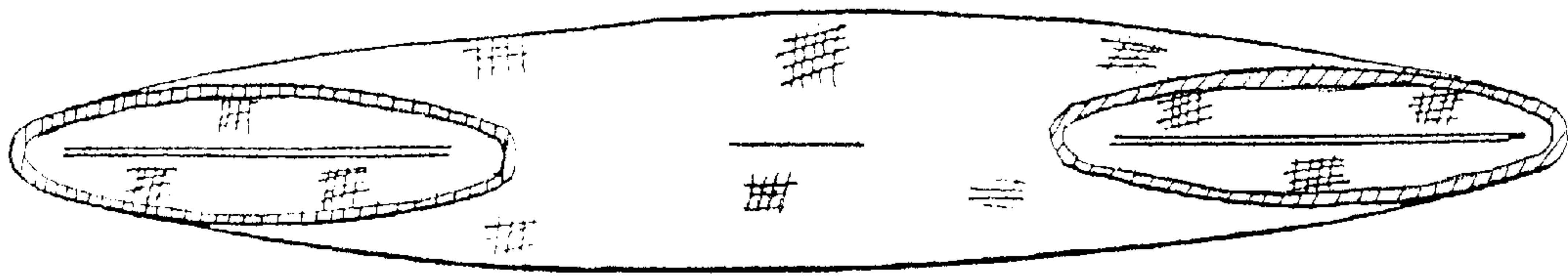

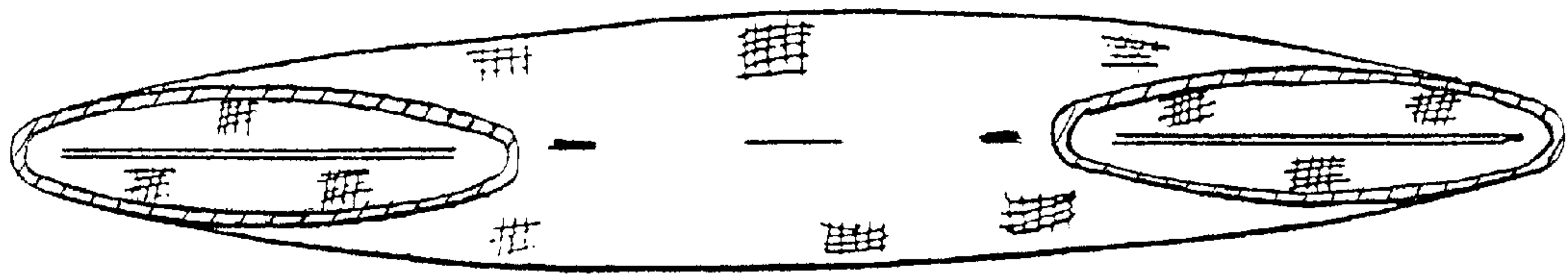
