DESCRIPTION

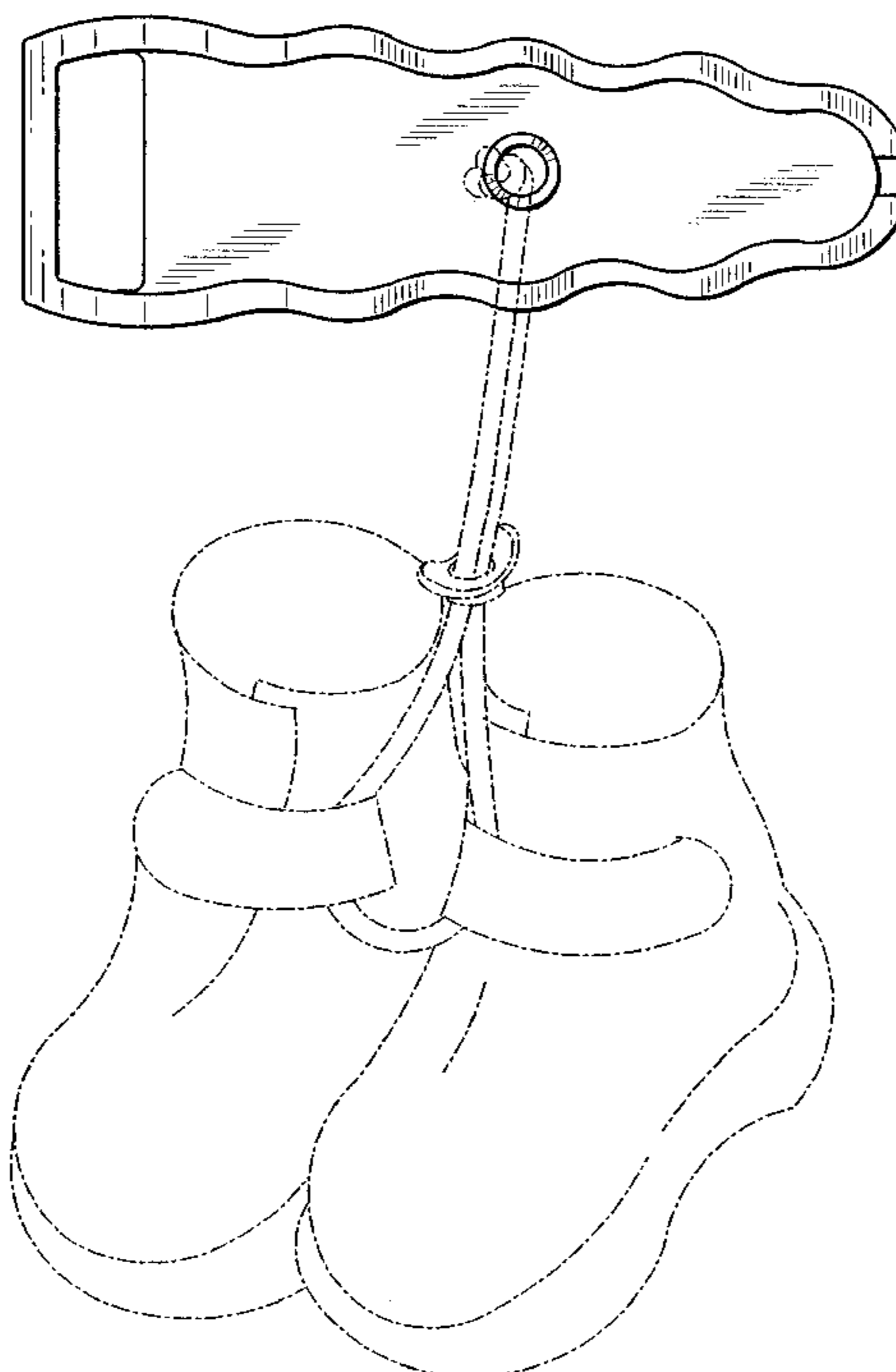
FIG. 1 is a side view of the boot carrier and latching tool showing my new design with boots and rope in phantom; FIG. 2 is a side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top view thereof, the bottom view being a mirror image thereof; FIG. 6 is an alternative embodiment shown in a side view, the other views being the same as FIGS. 3, 4 and 5 above; and FIG. 7 is another alternative embodiment shown in a side view, the top view being the same as FIG. 5 above; FIG. 8 is a front view of the embodiment of FIG. 7; and, FIG. 9 is a rear view thereof.
The broken line showing the boots and rope in FIG. 1 are for illustrative purposes only and form no part of the claimed design.

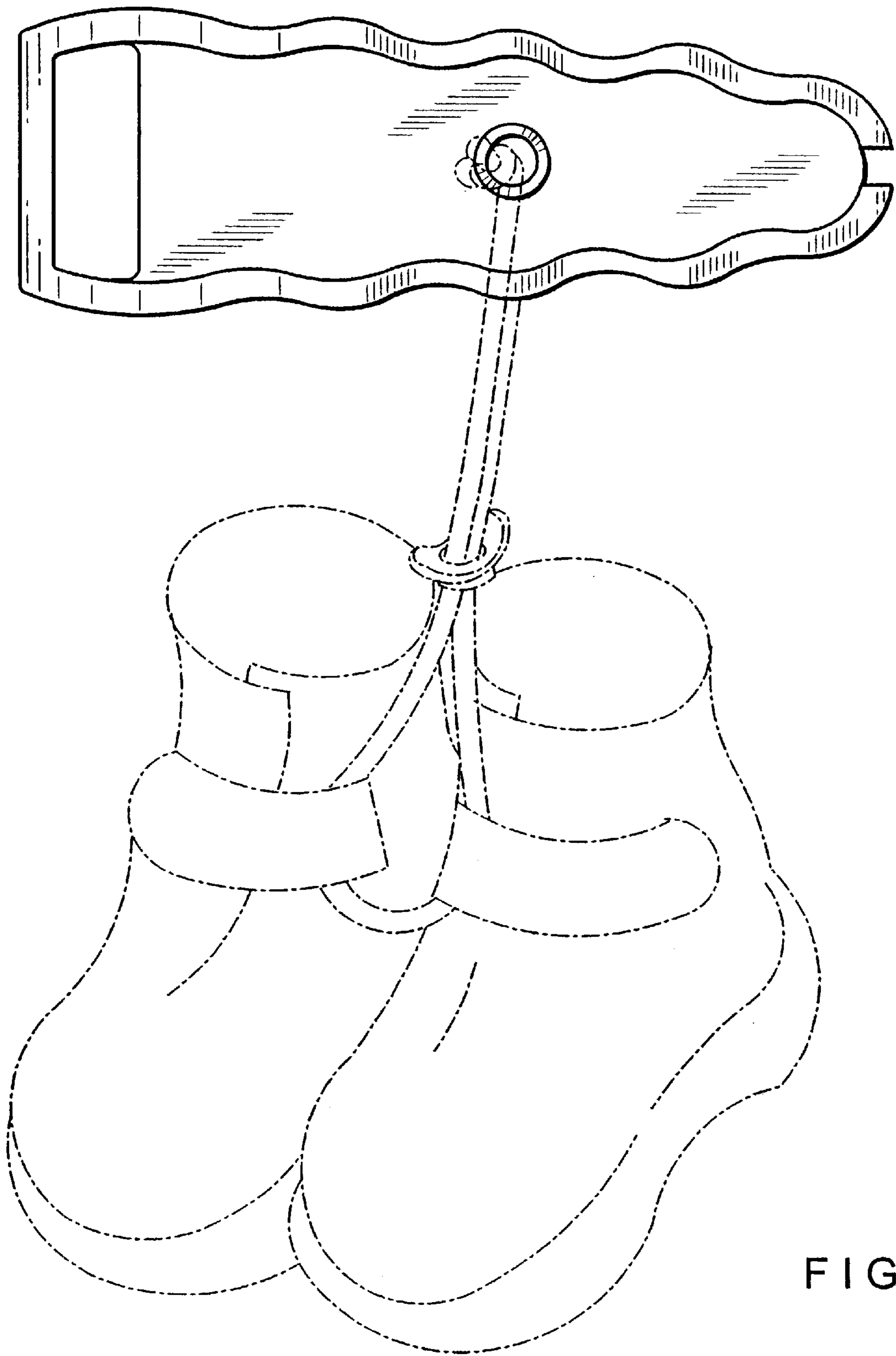

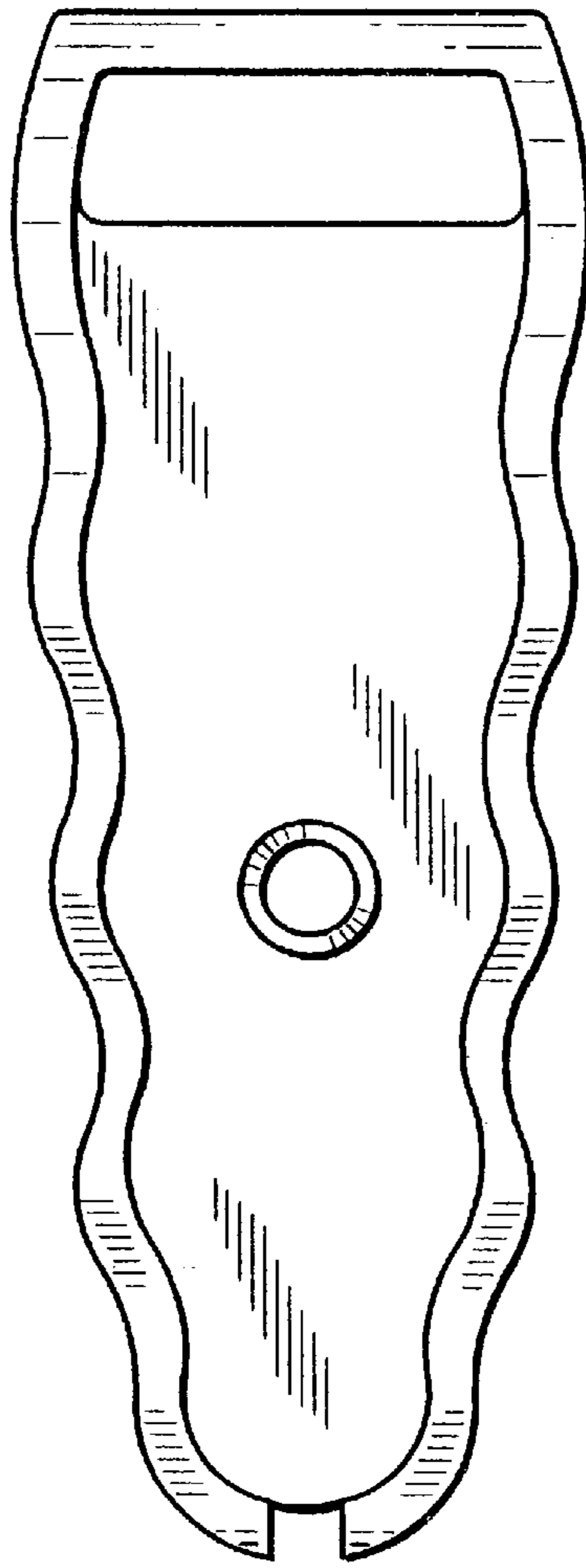

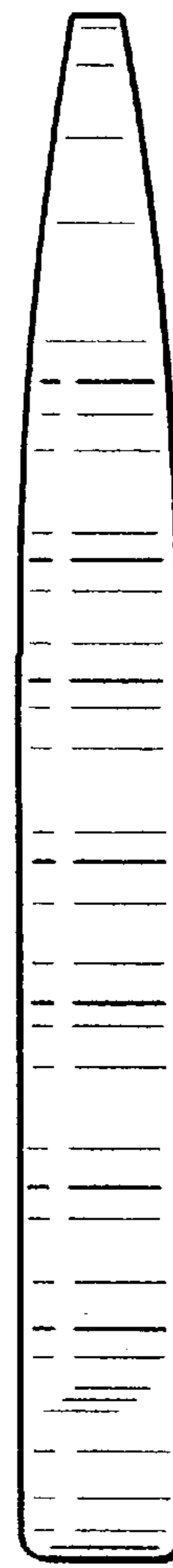

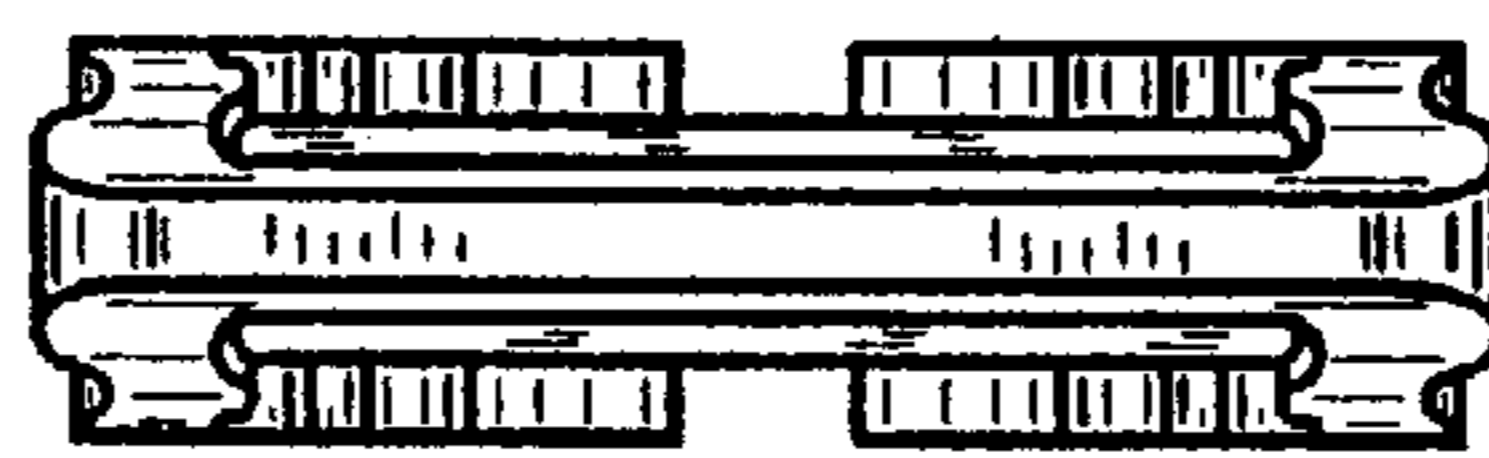

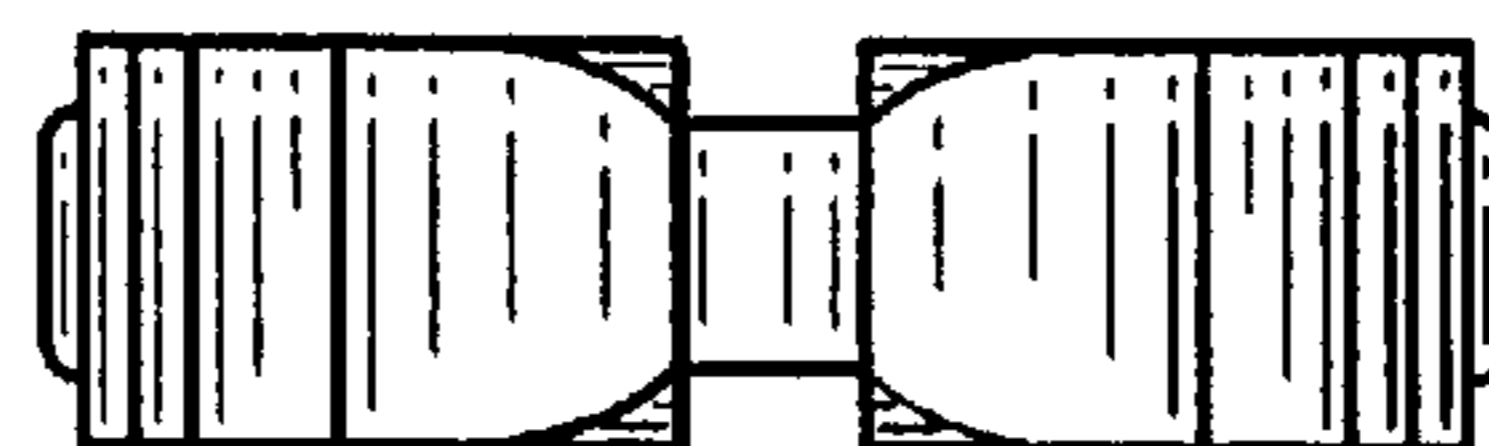

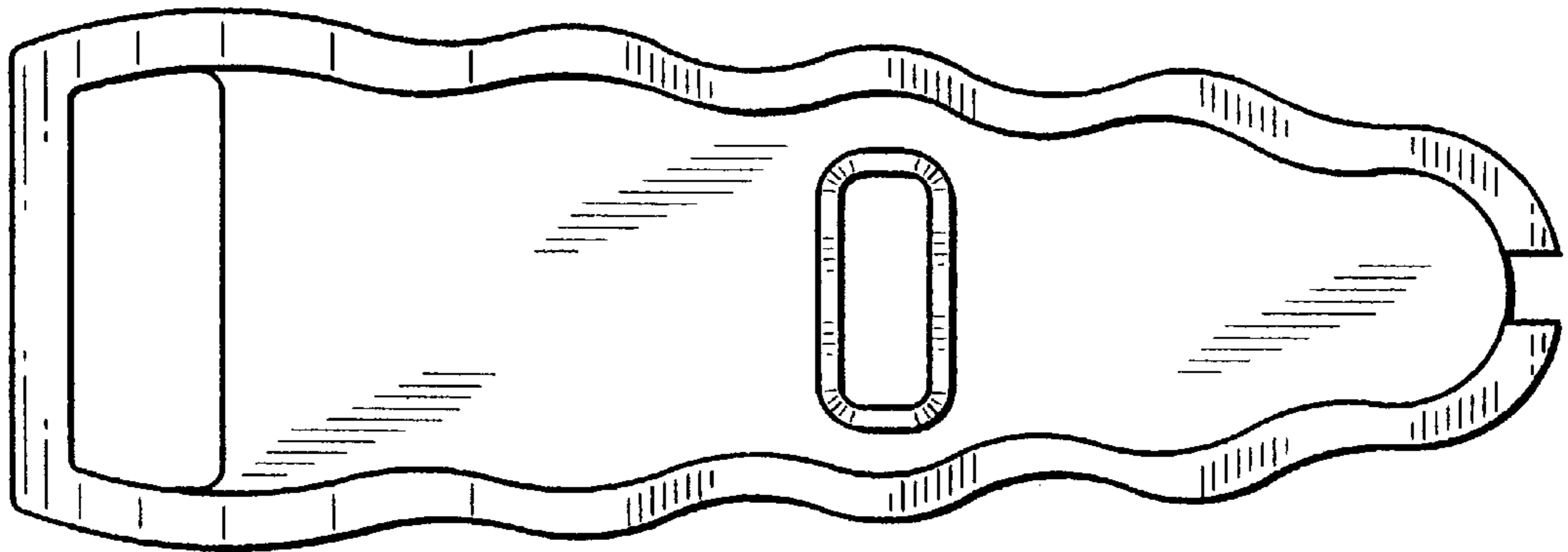

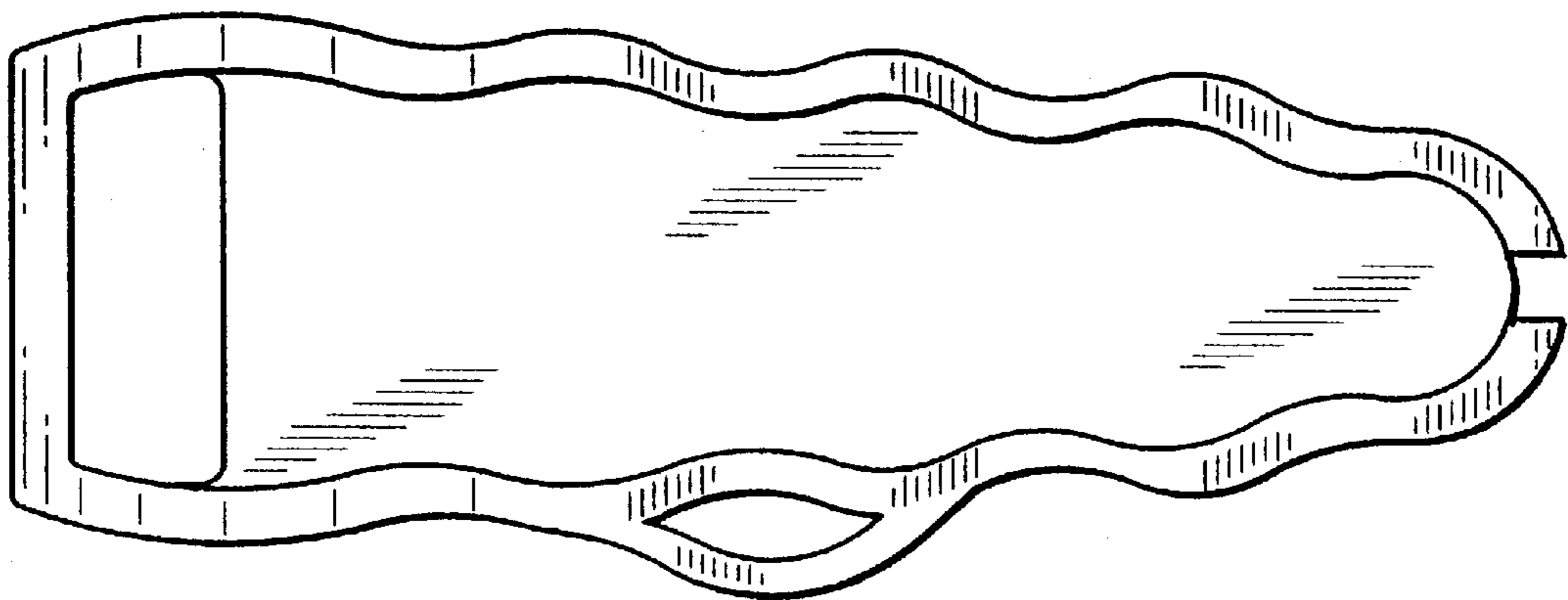

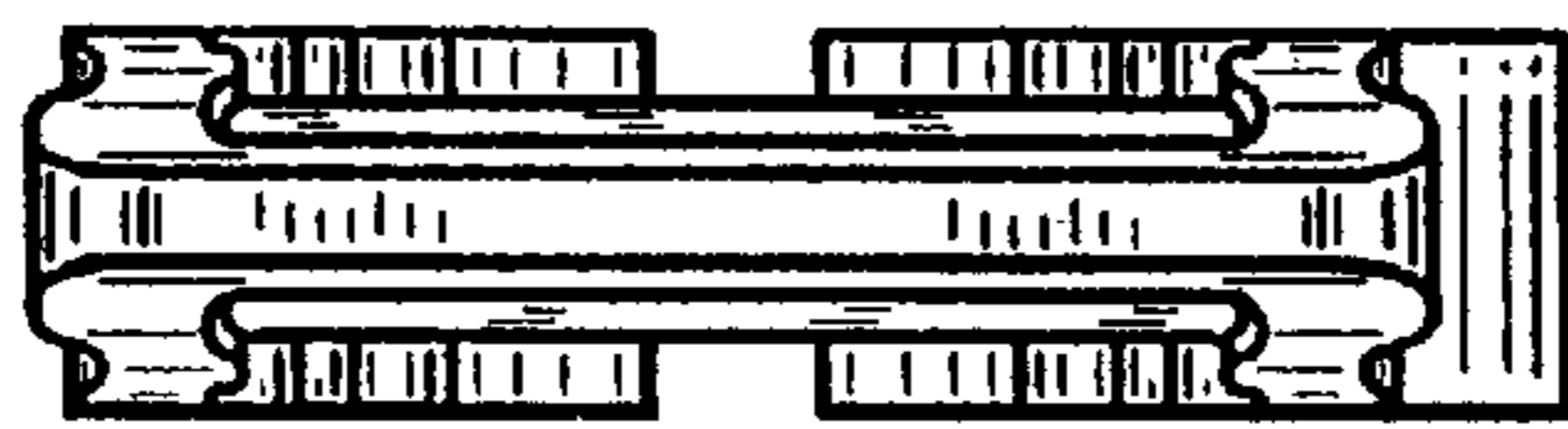

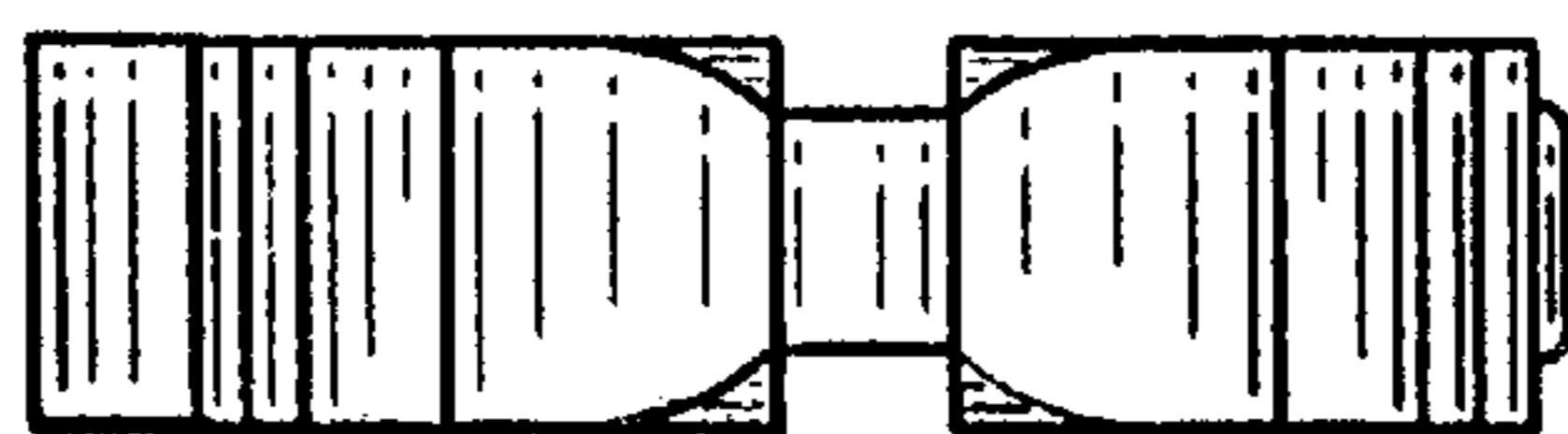
