FIG. 7 is a perspective view of the jewelry setting of FIG. 4 provided on a chain;

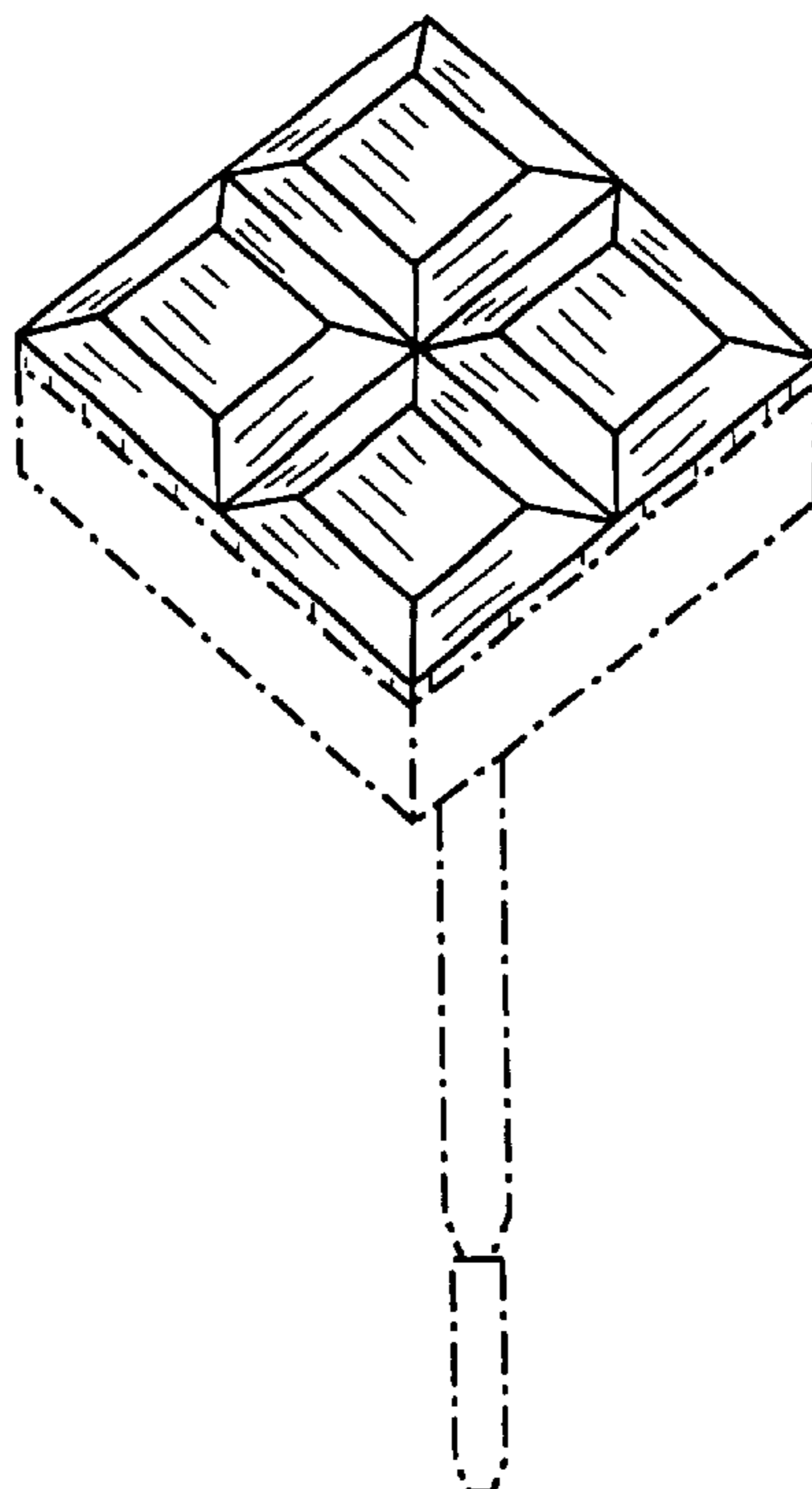
FIG. 8 is a top view of a third embodiment of the jewelry setting according to the present invention provided in a ring;

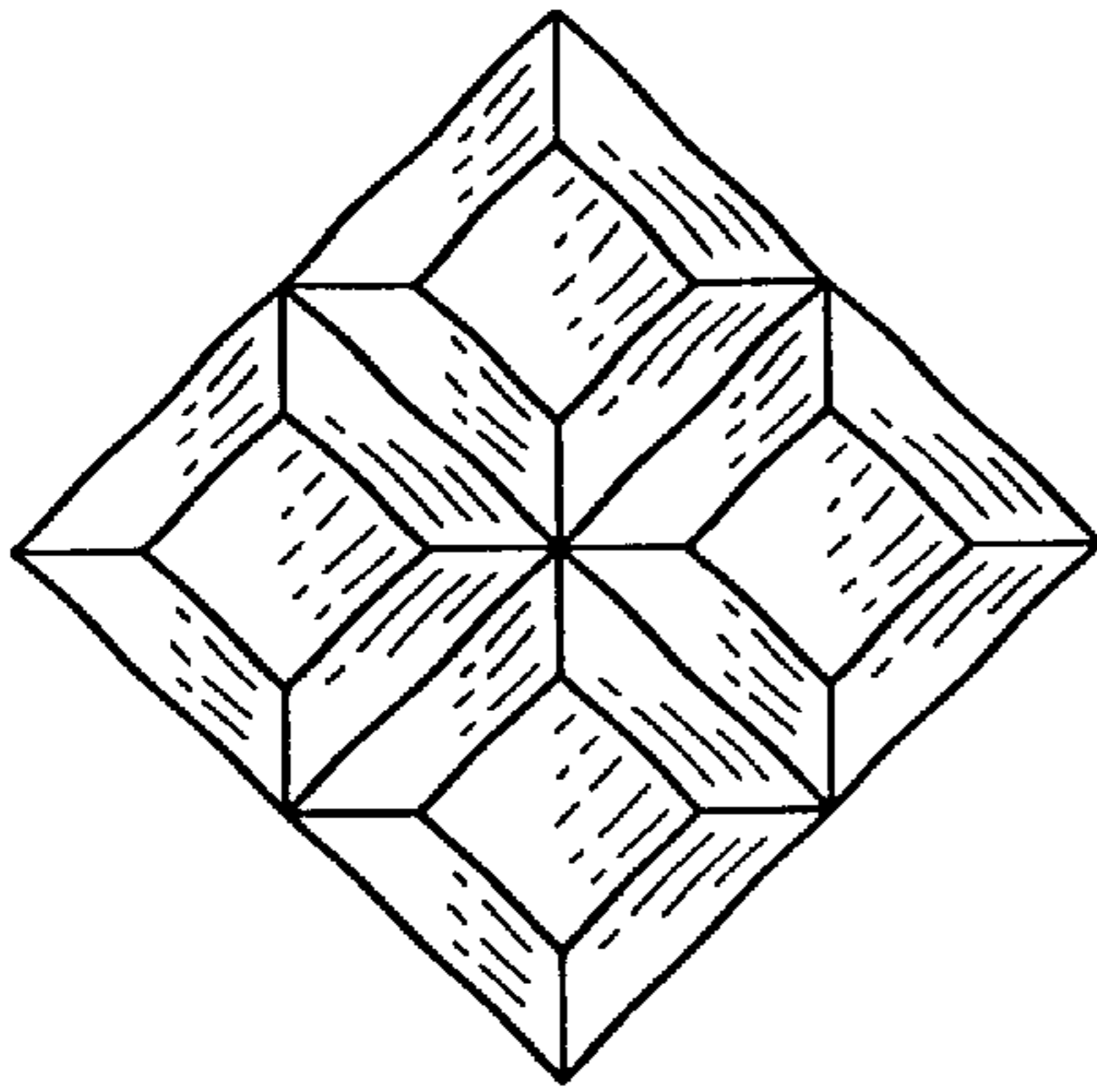

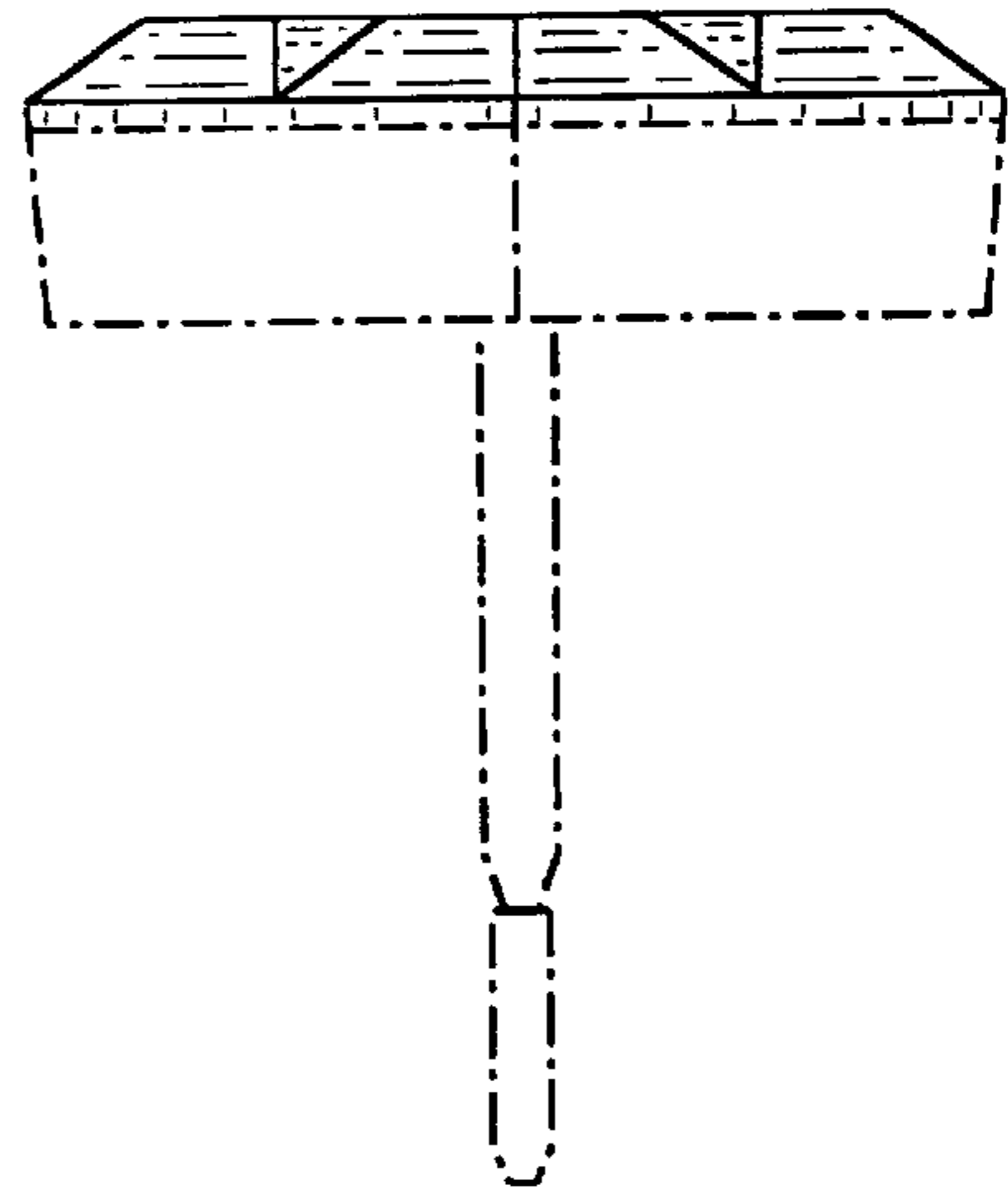

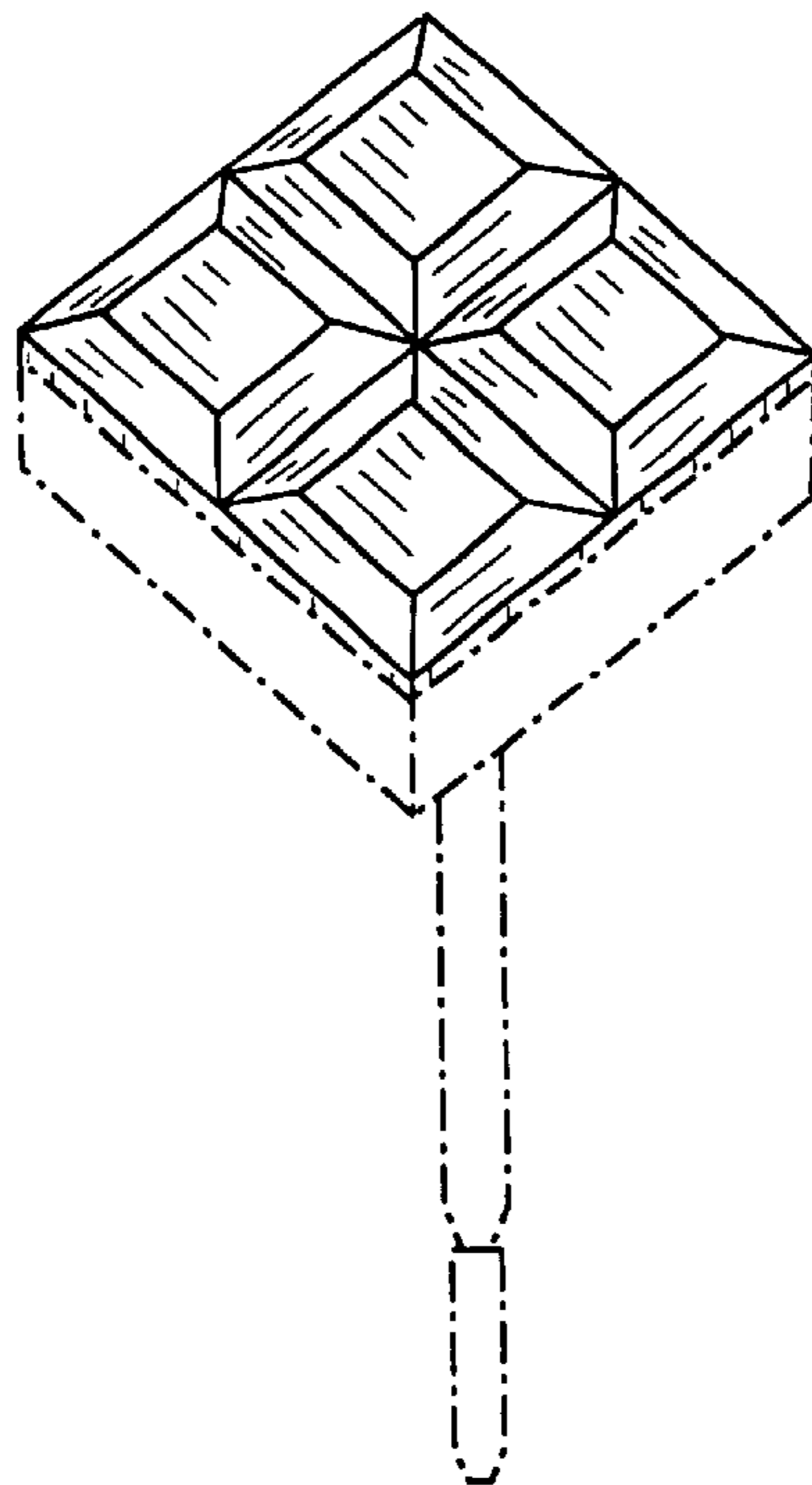

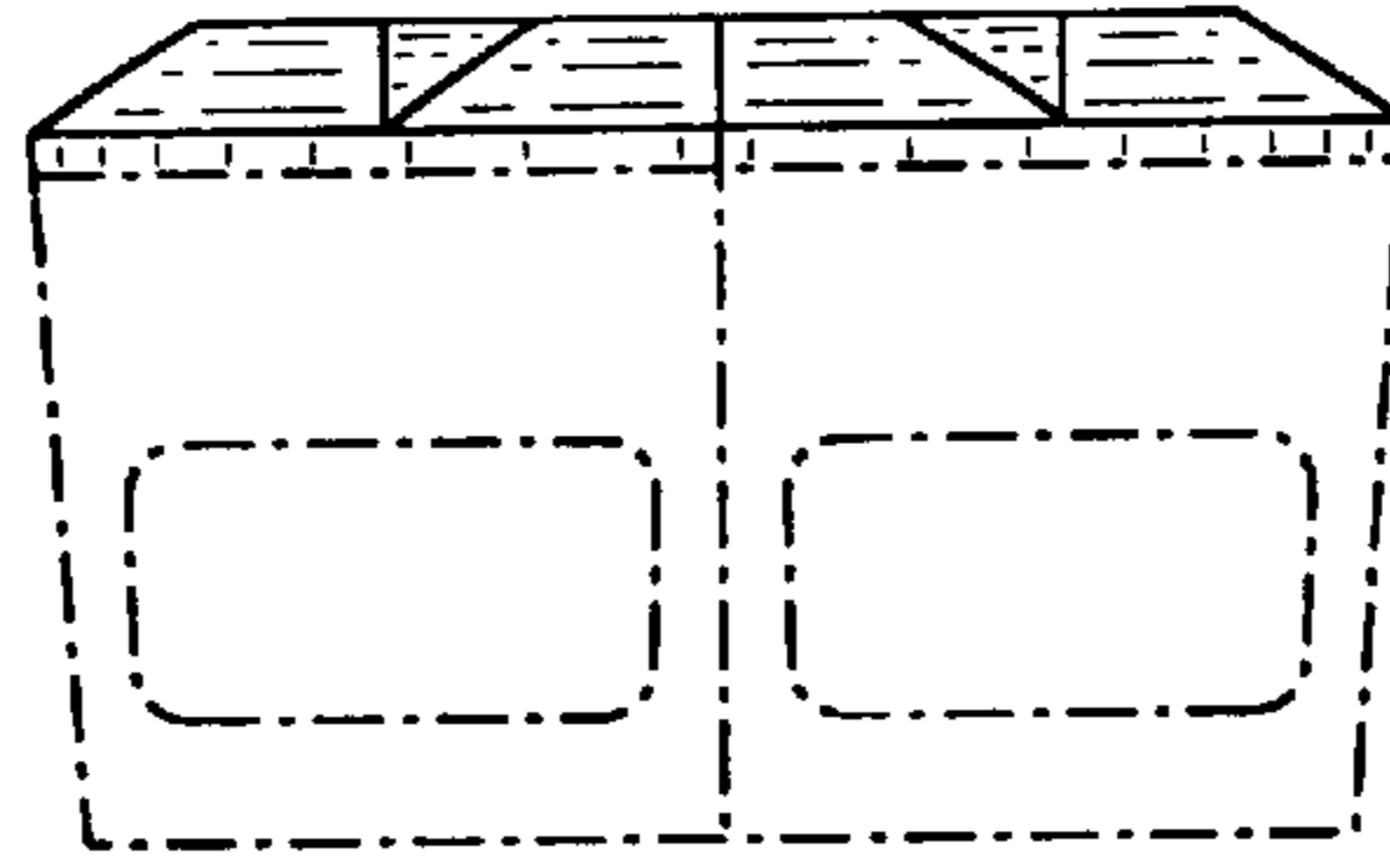

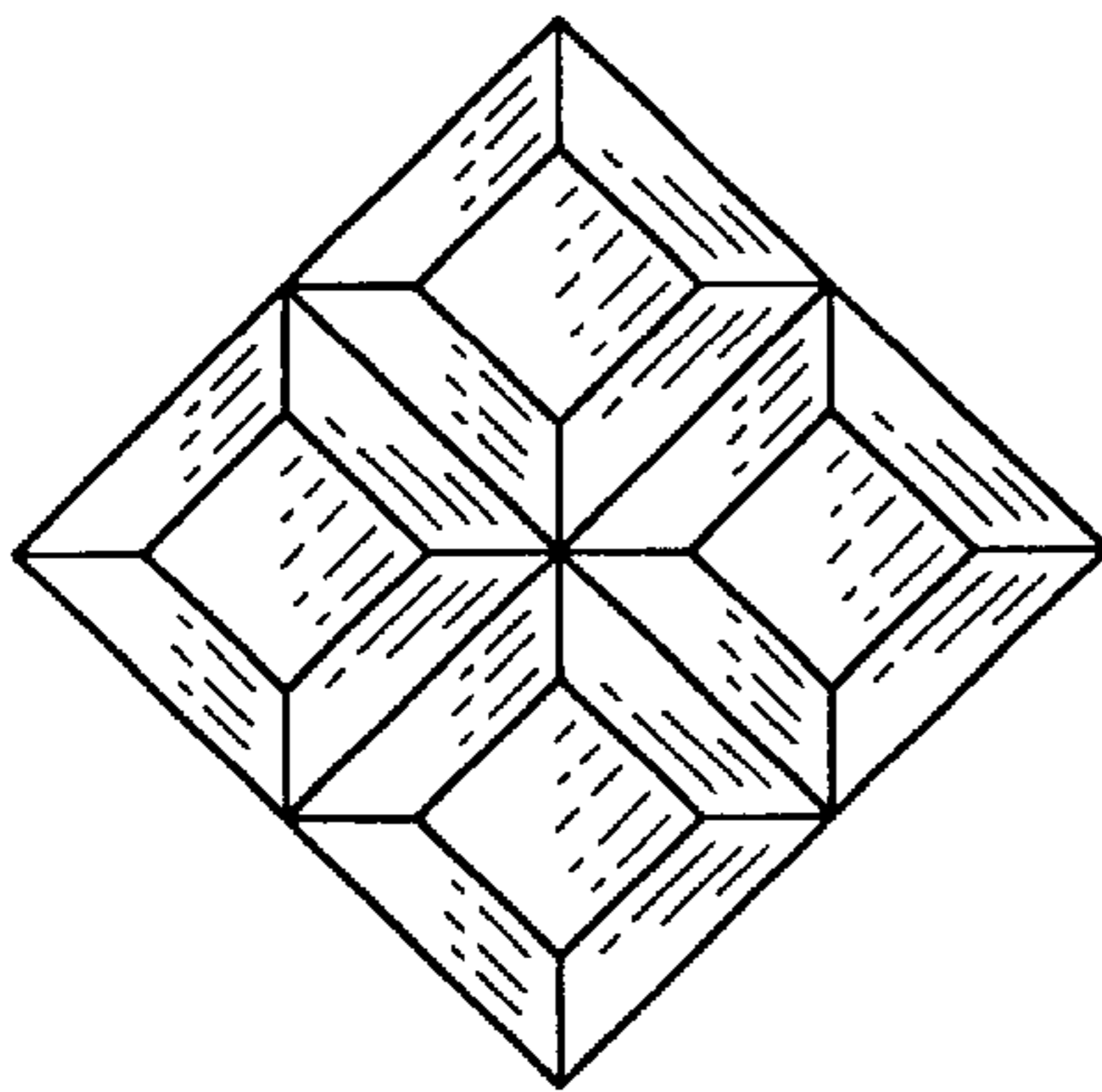

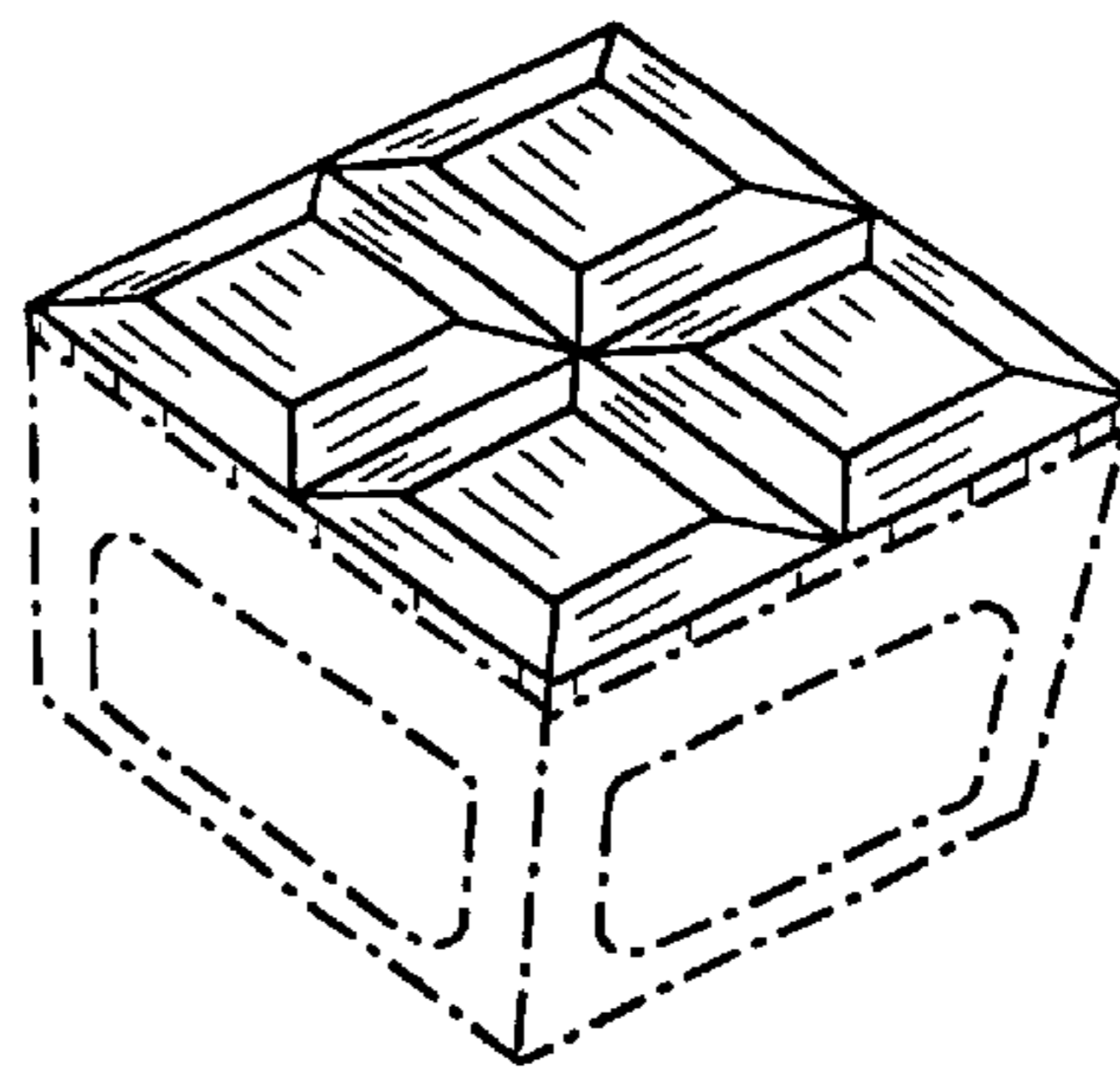

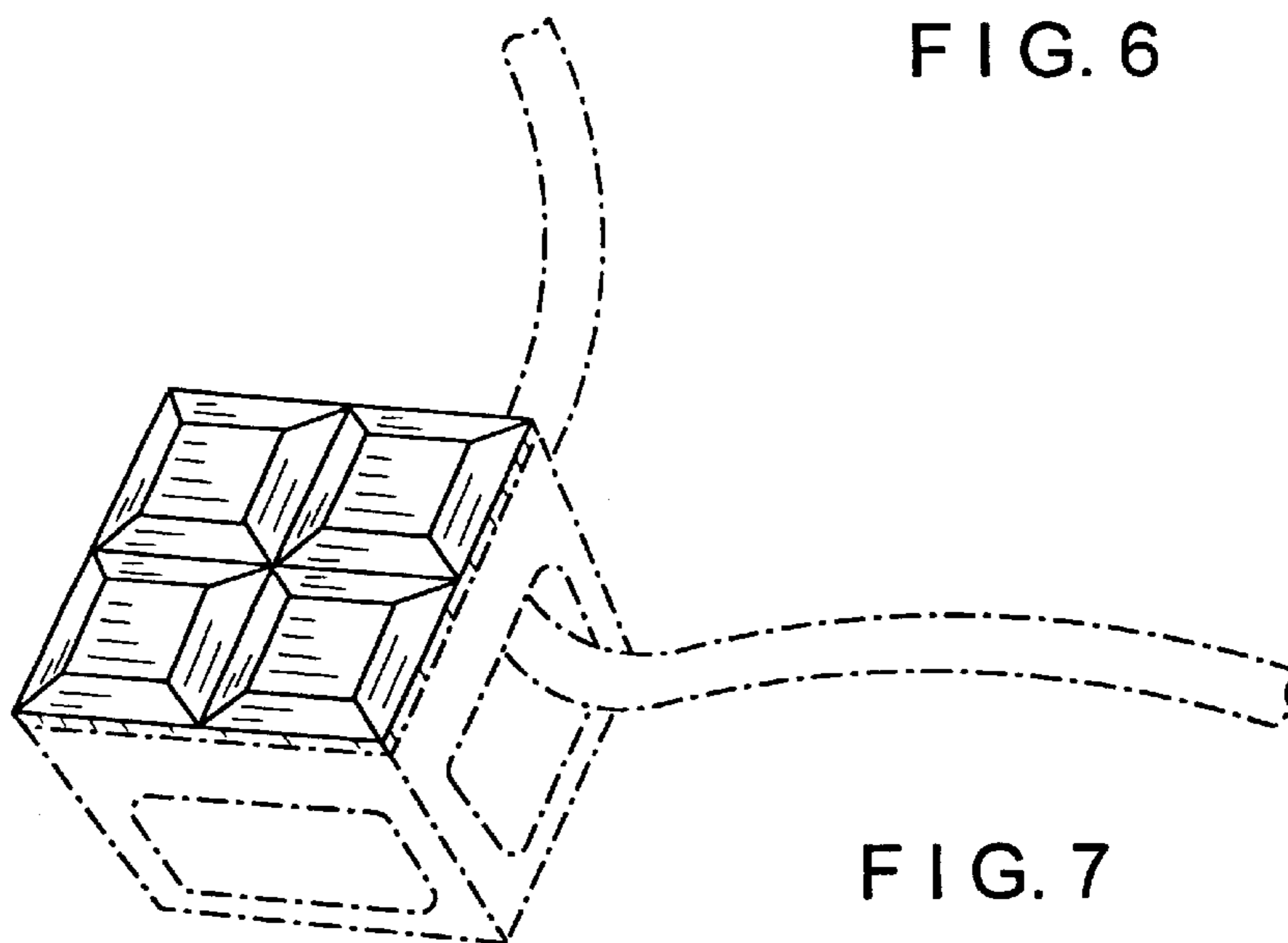

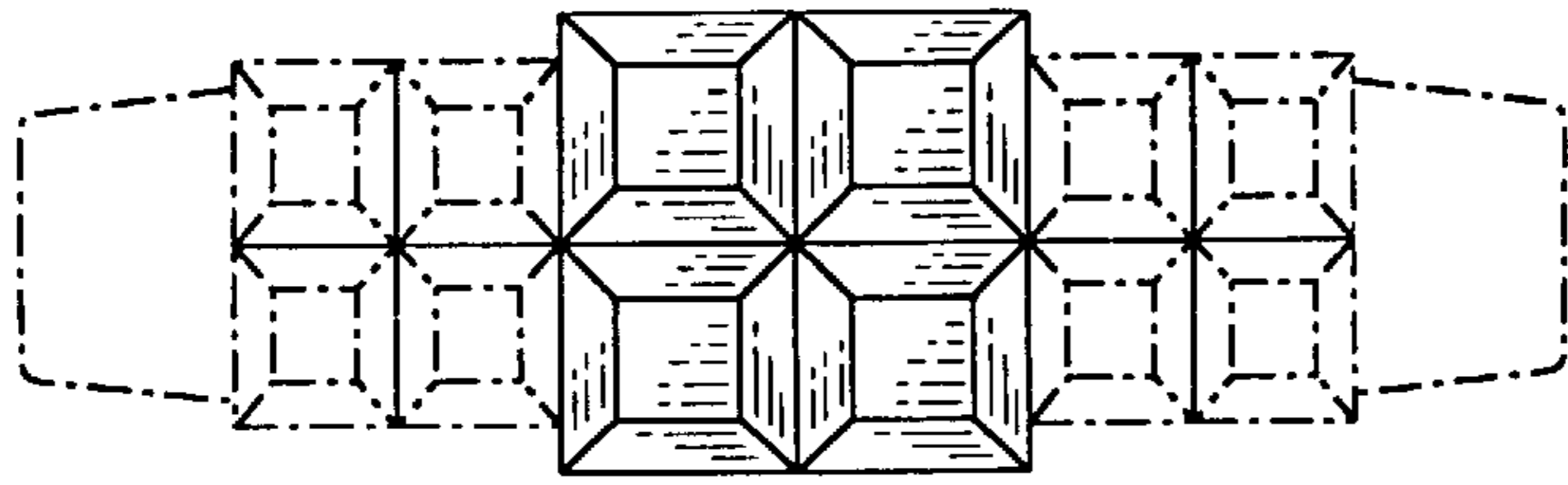

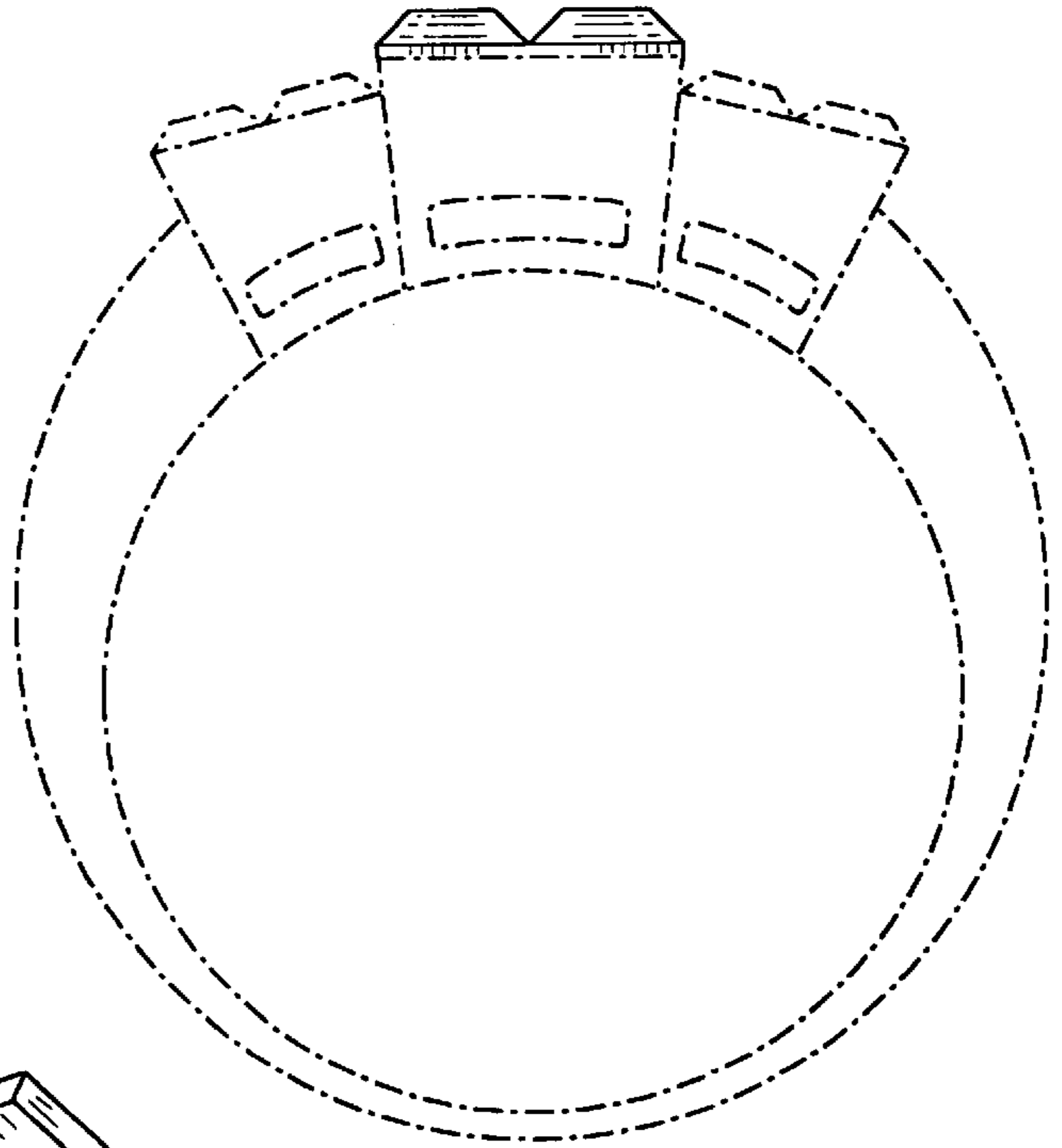

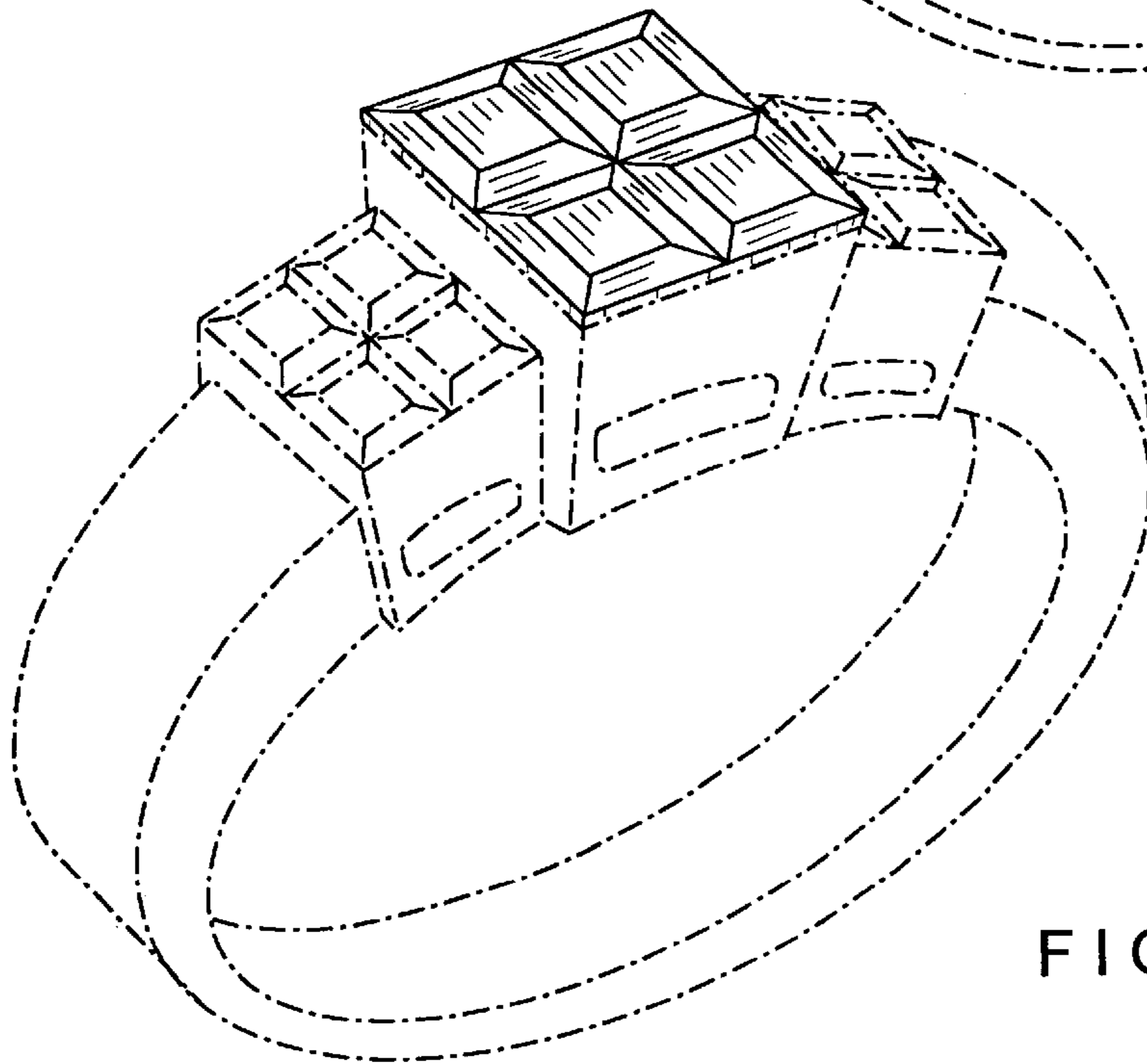
