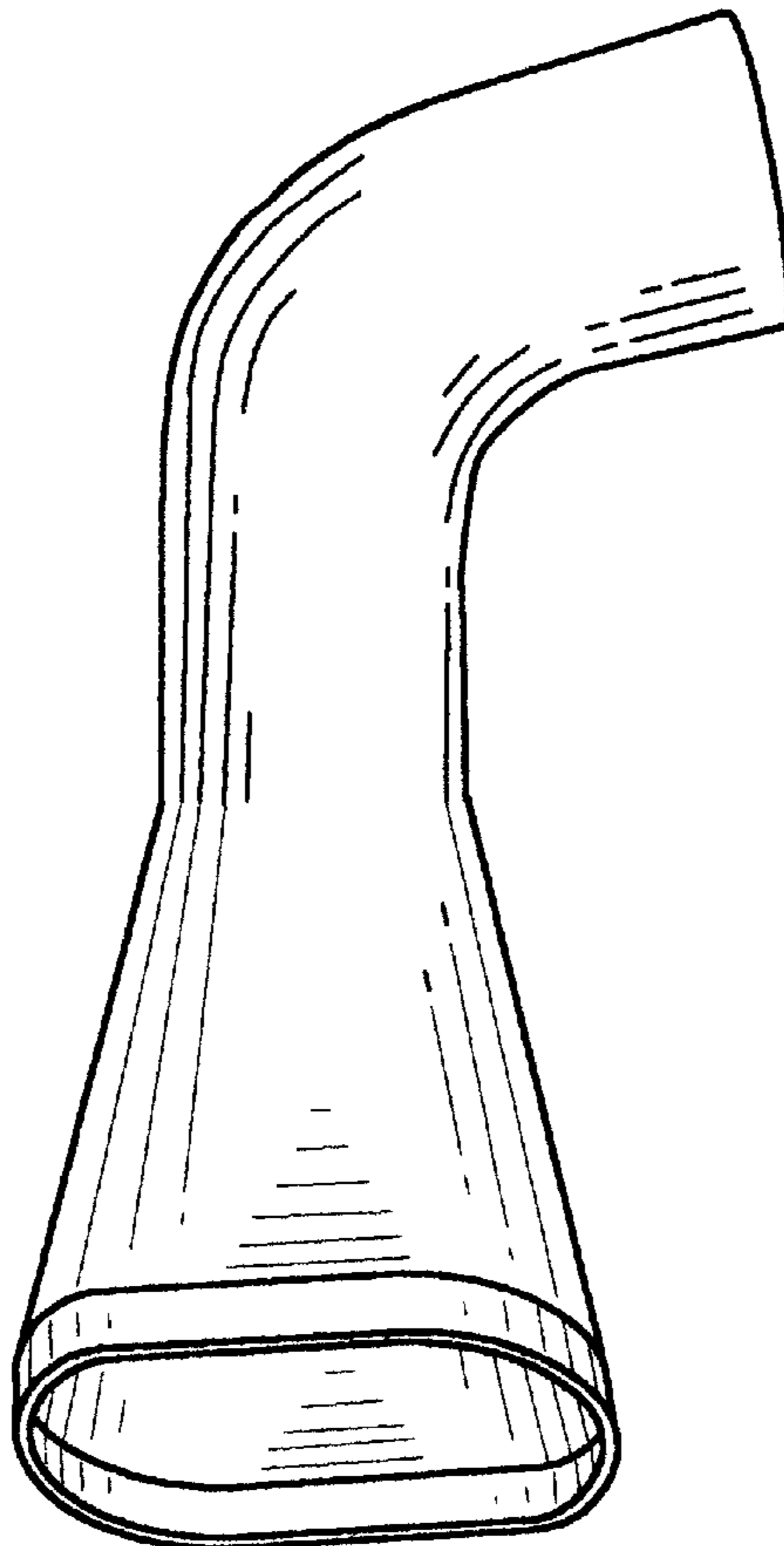
FIG. 1 is an underside perspective view of a supercharger discharge tube according to the present invention;

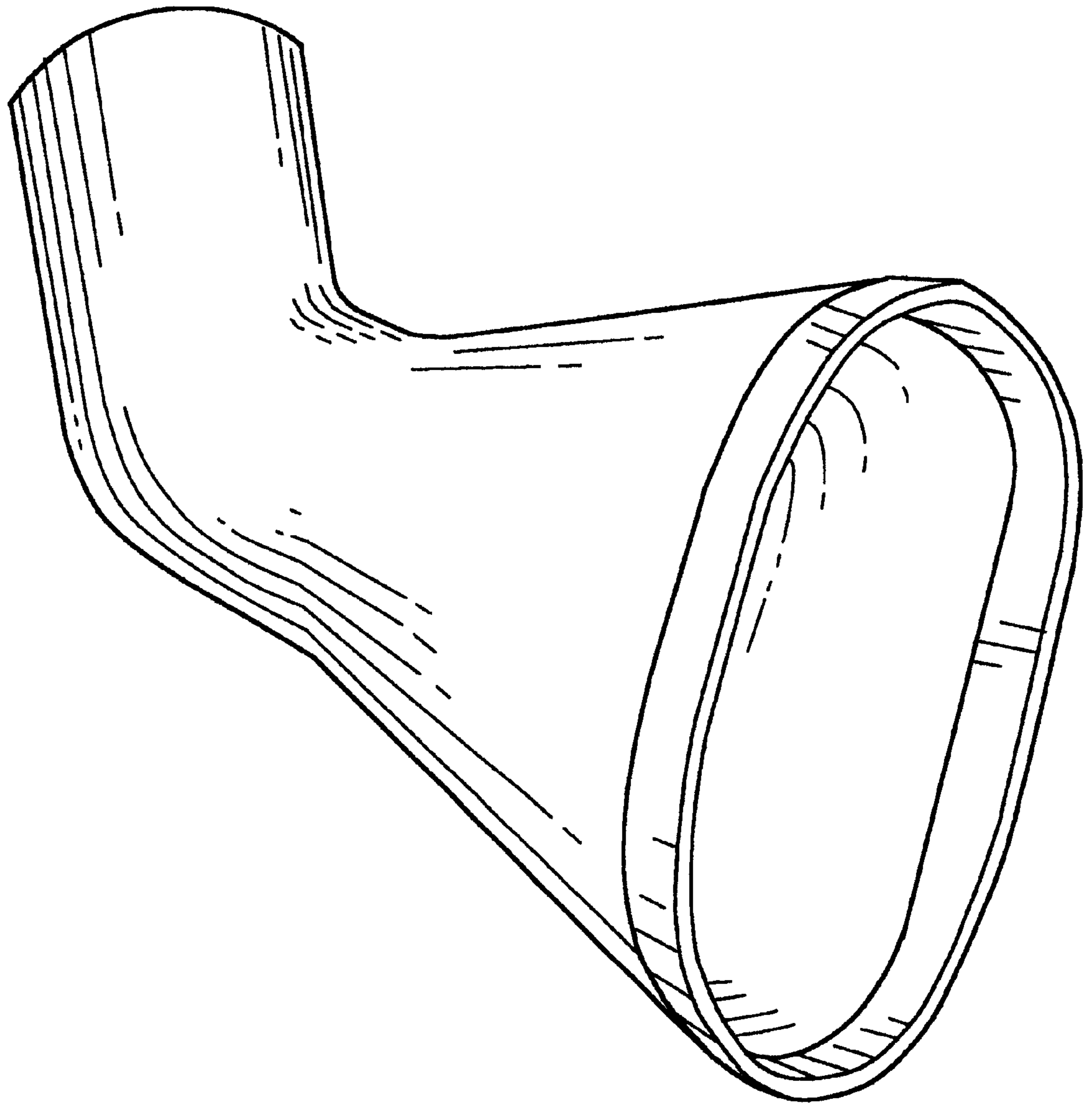

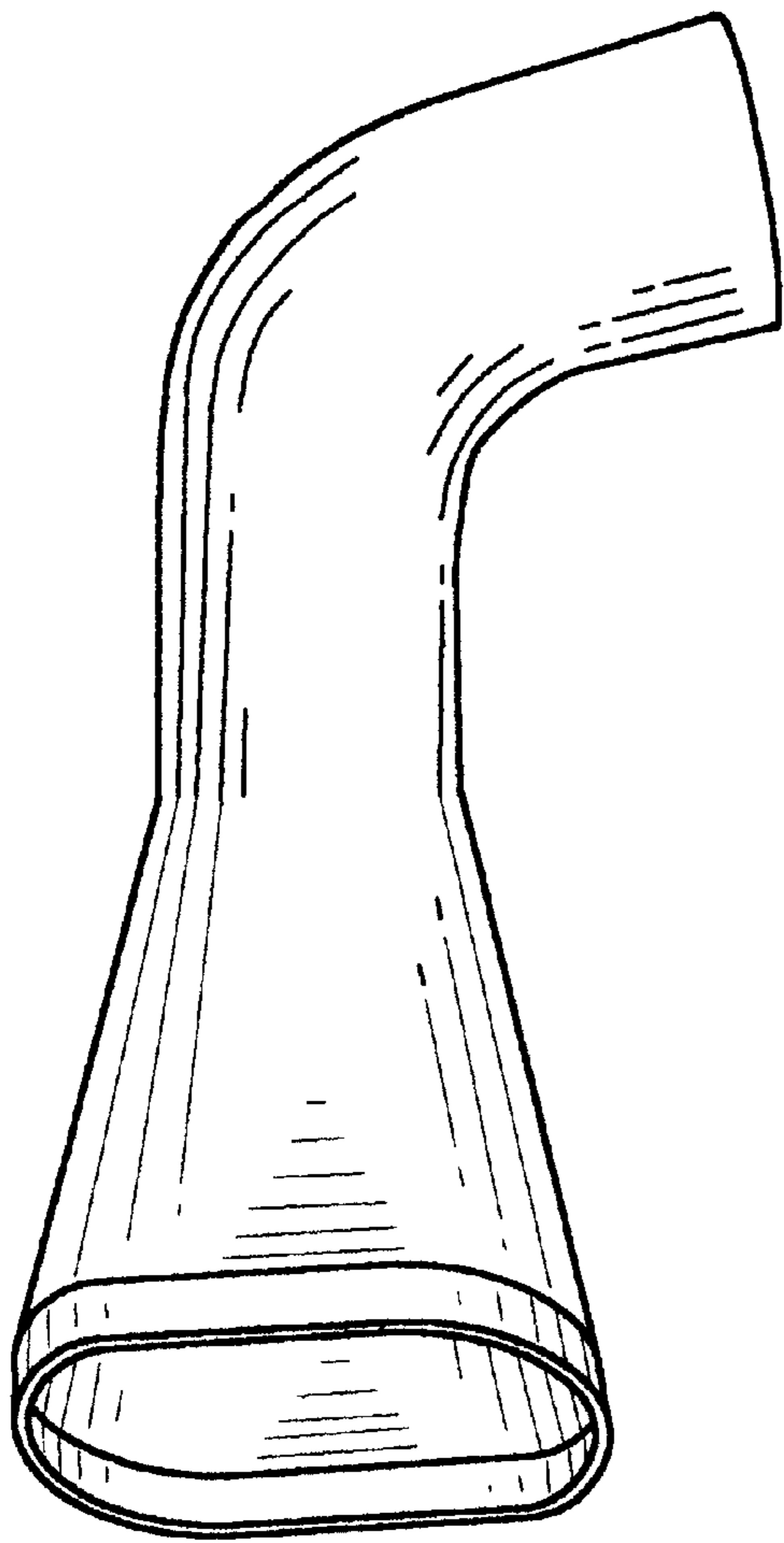

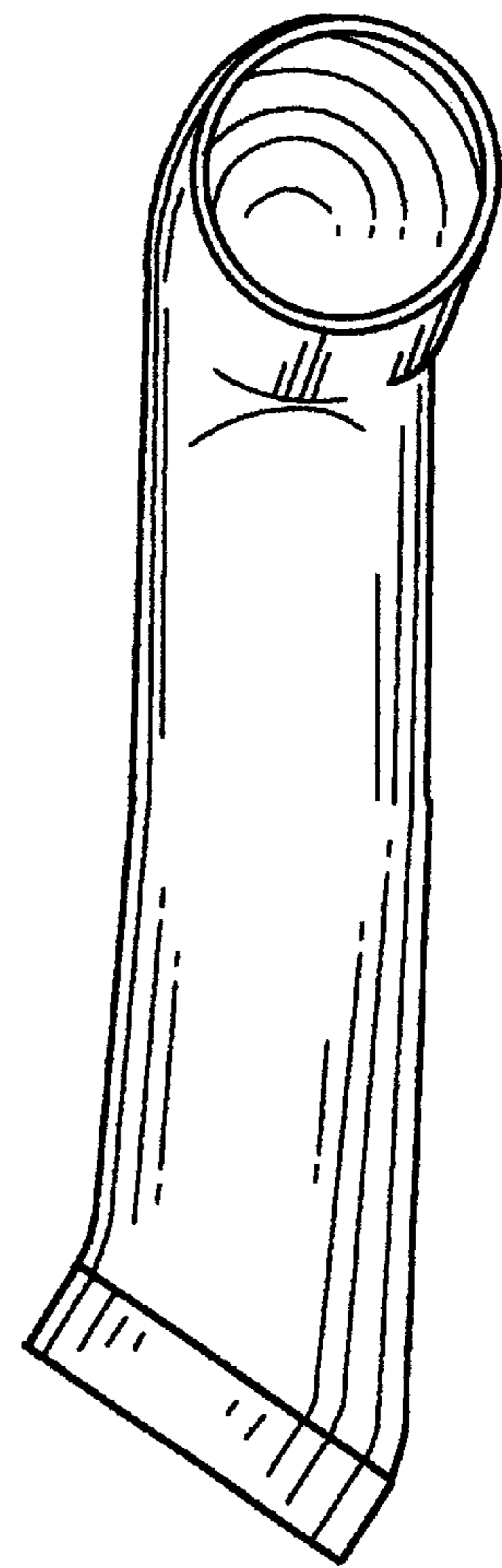

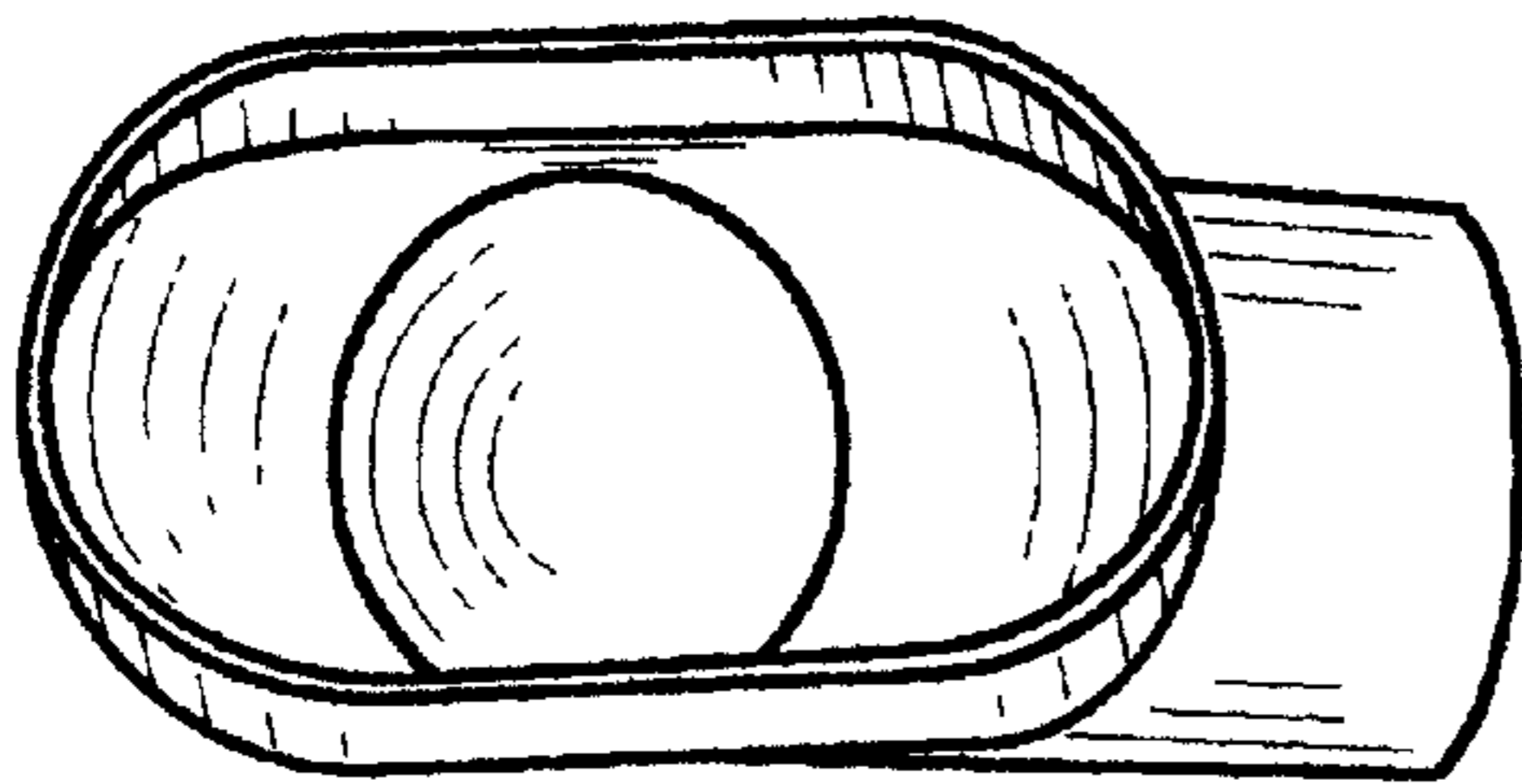

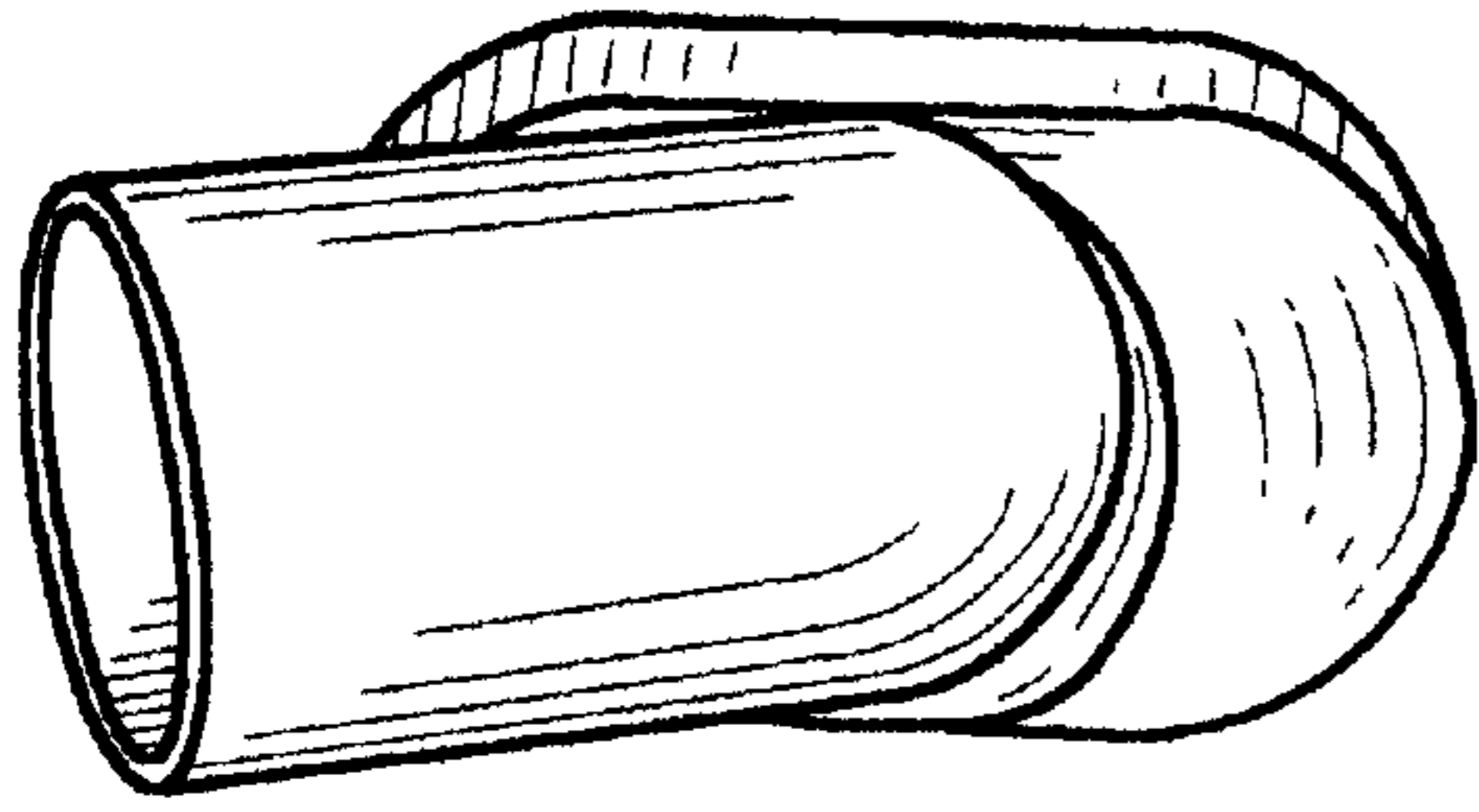

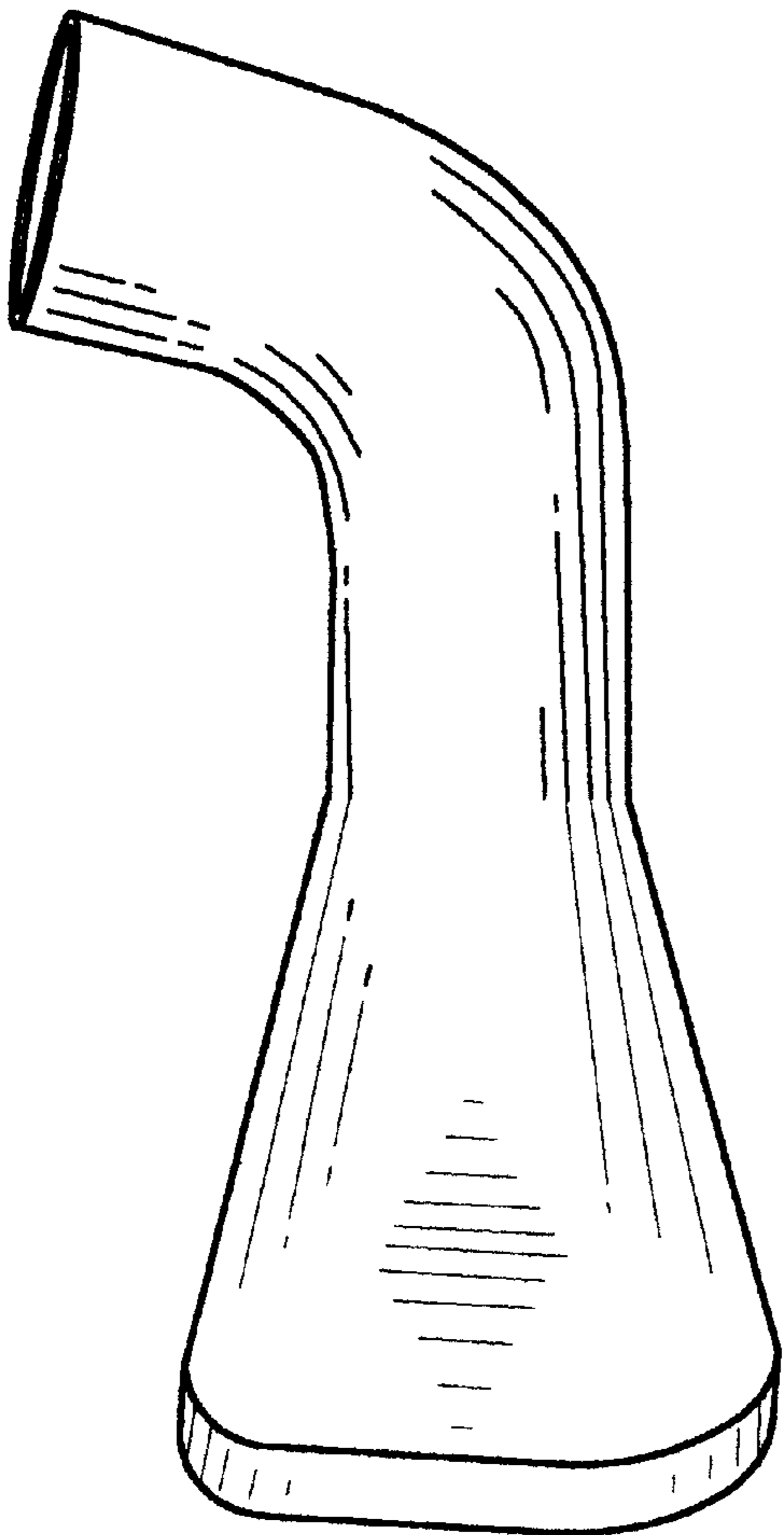

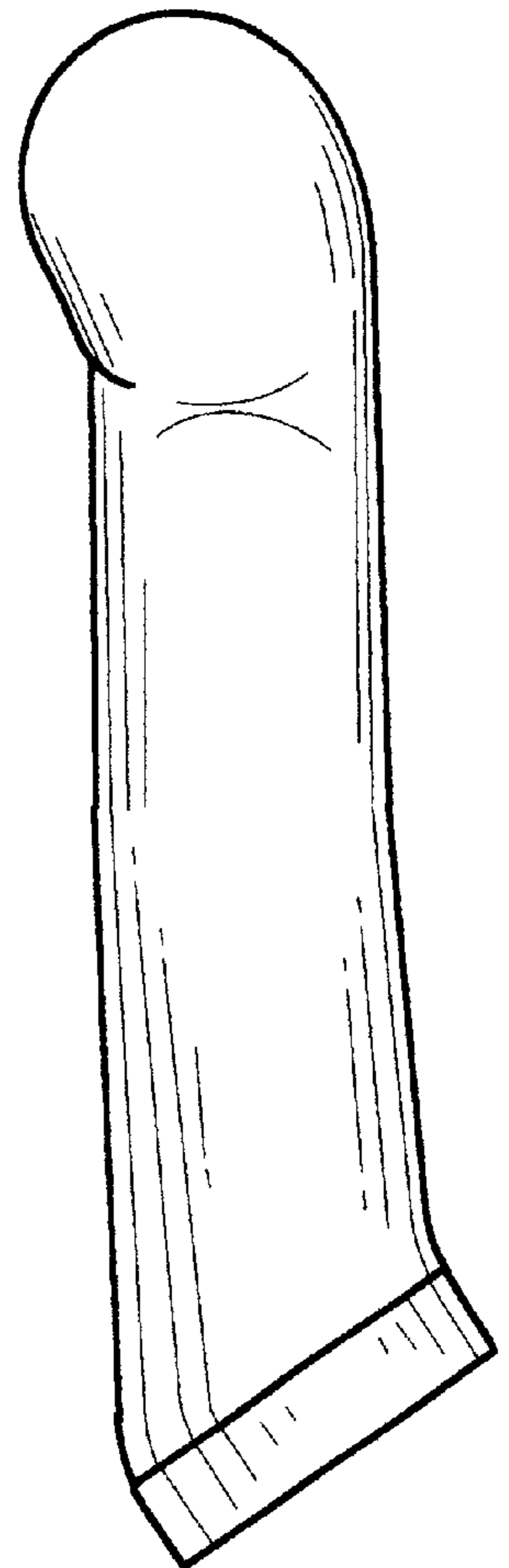
