FIG. 2 is a rear view thereof;

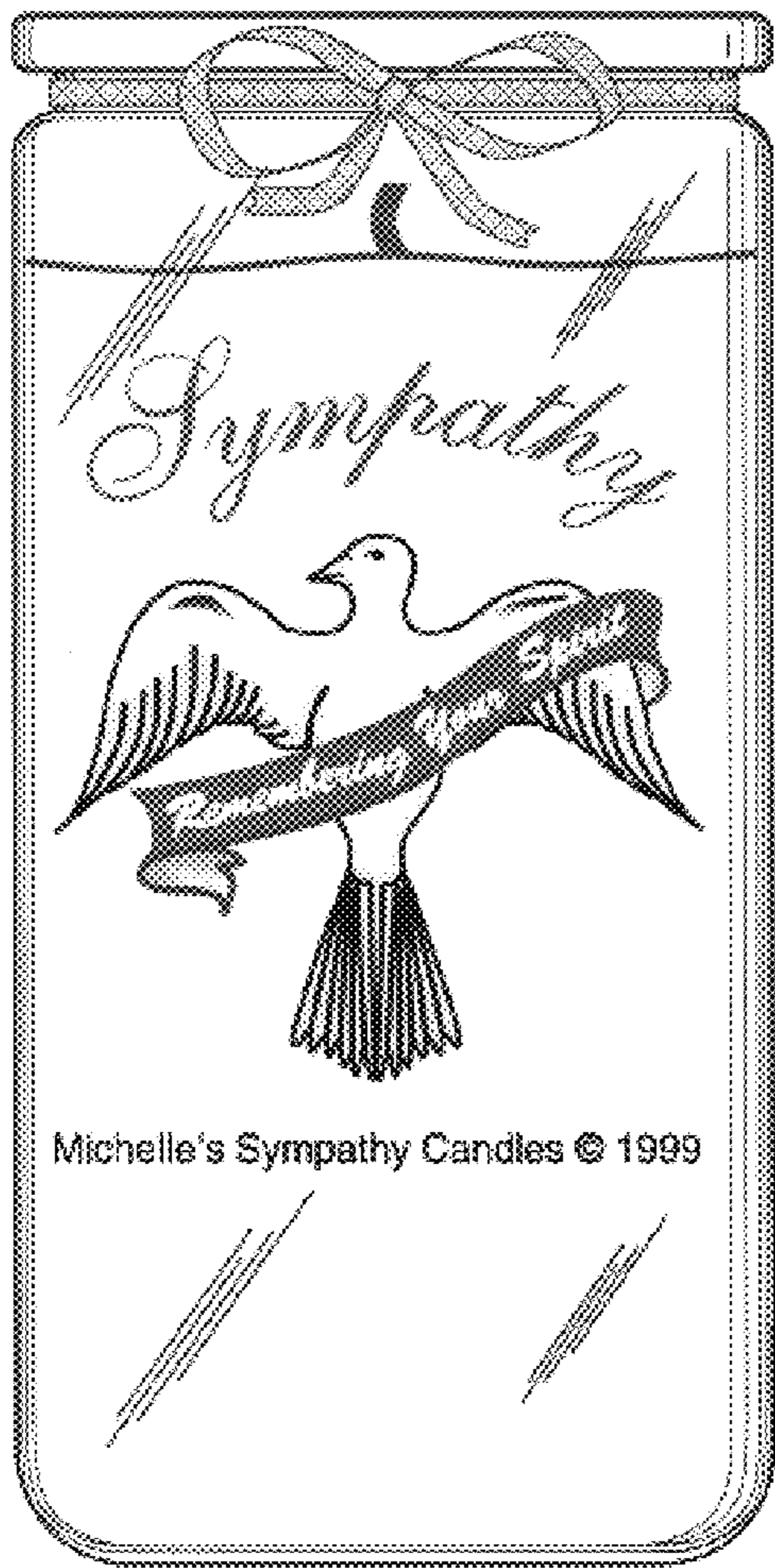
FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof; and,

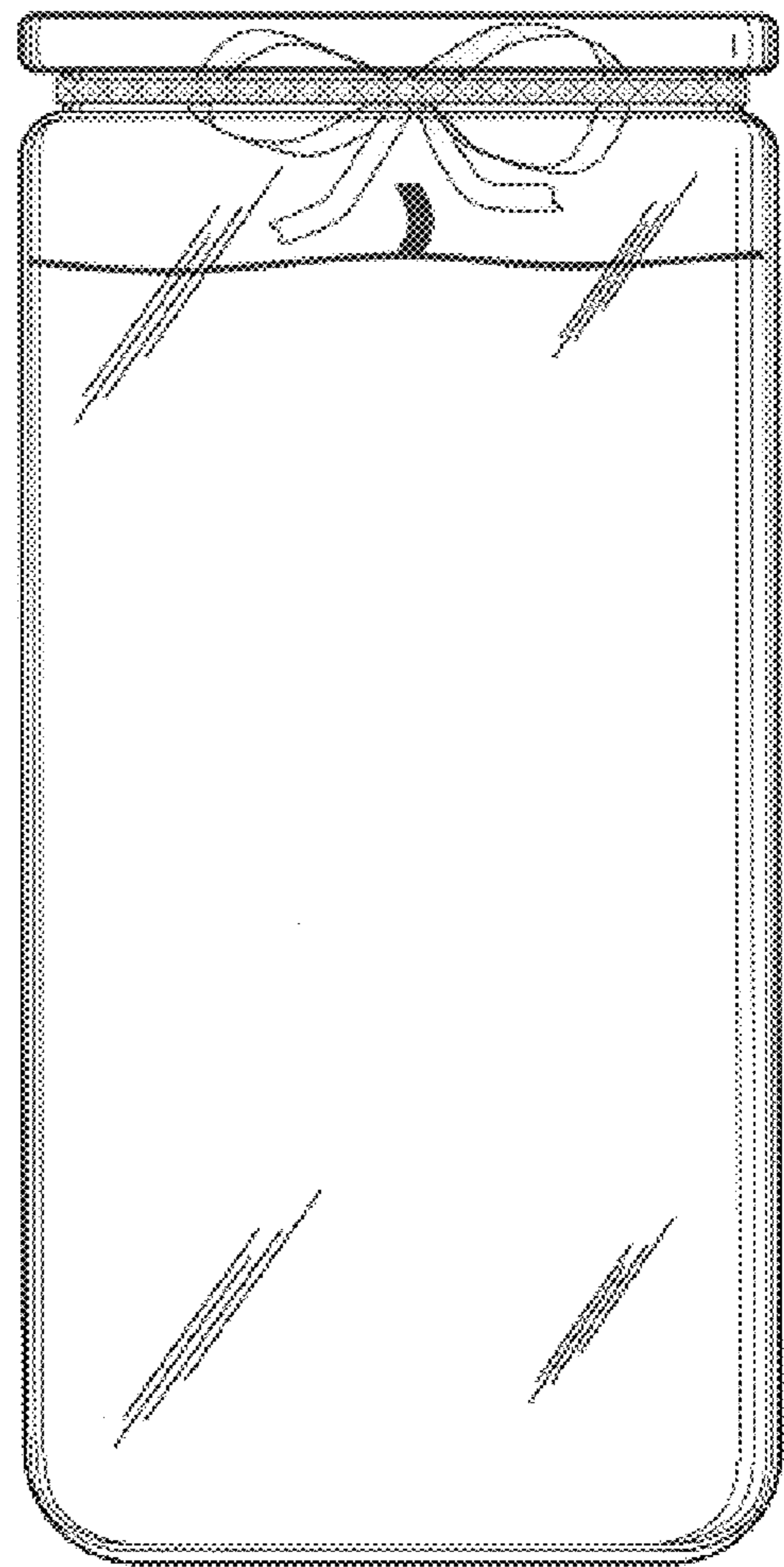
FIG. 5 is an enlarged view of the label of the claimed design for clarity of illustration. The color shown on the claimed design forms no part thereof.

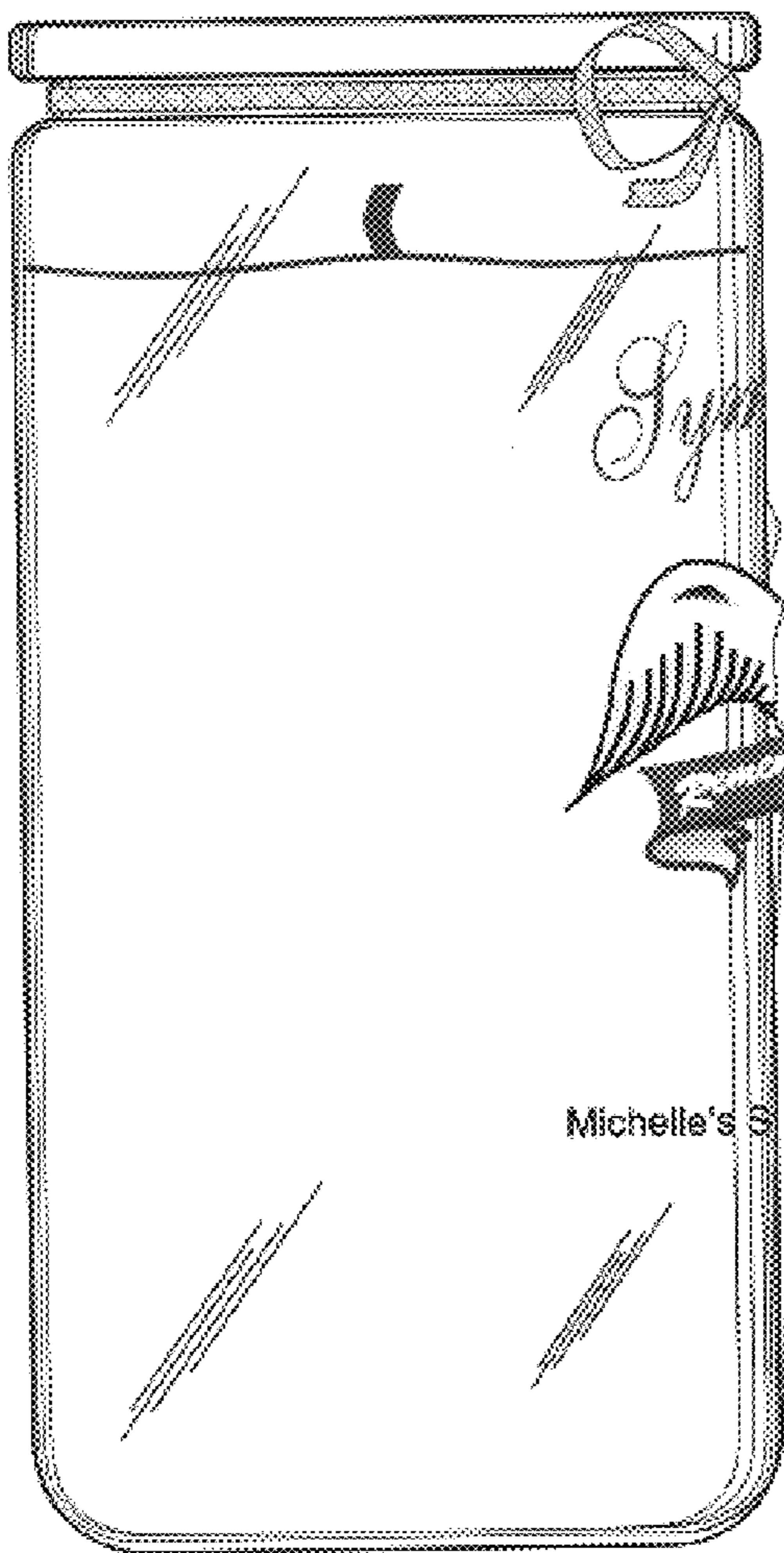

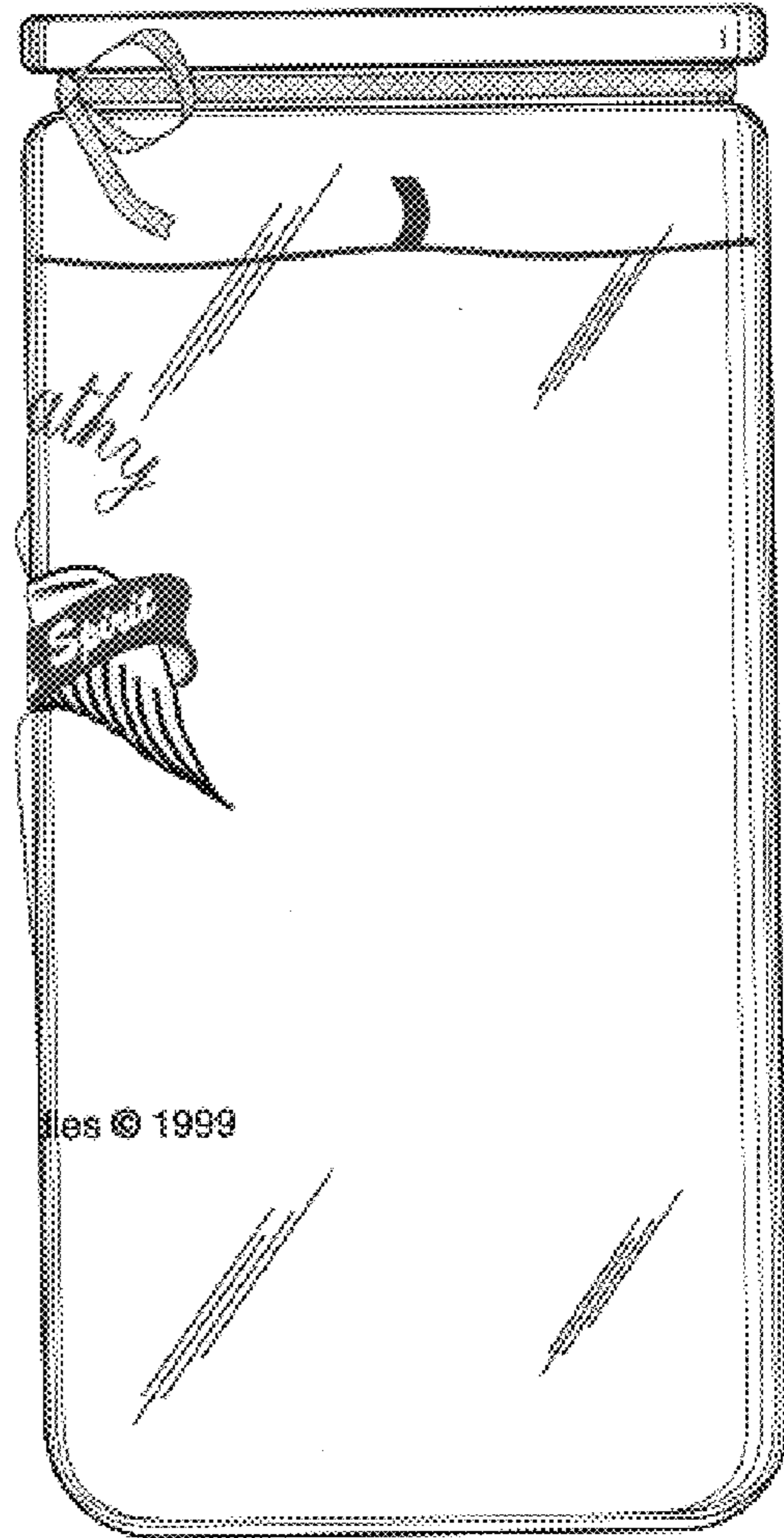
