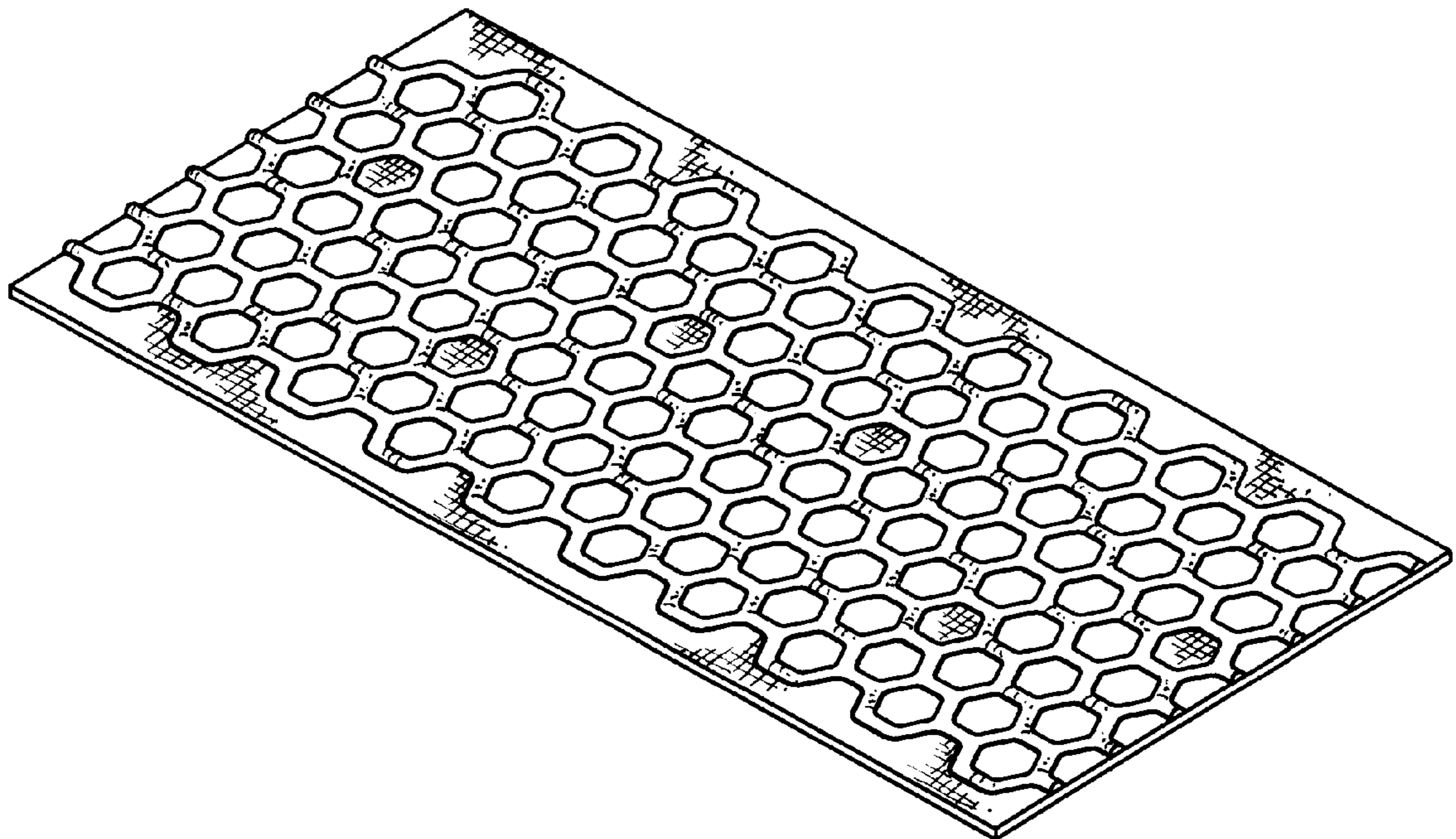
(57) **CLAIM**

The ornamental design for a ribbon-type textile with silicone coating, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a ribbon-type textile with silicone coating according to the inventive design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a left side elevational view thereof; and,

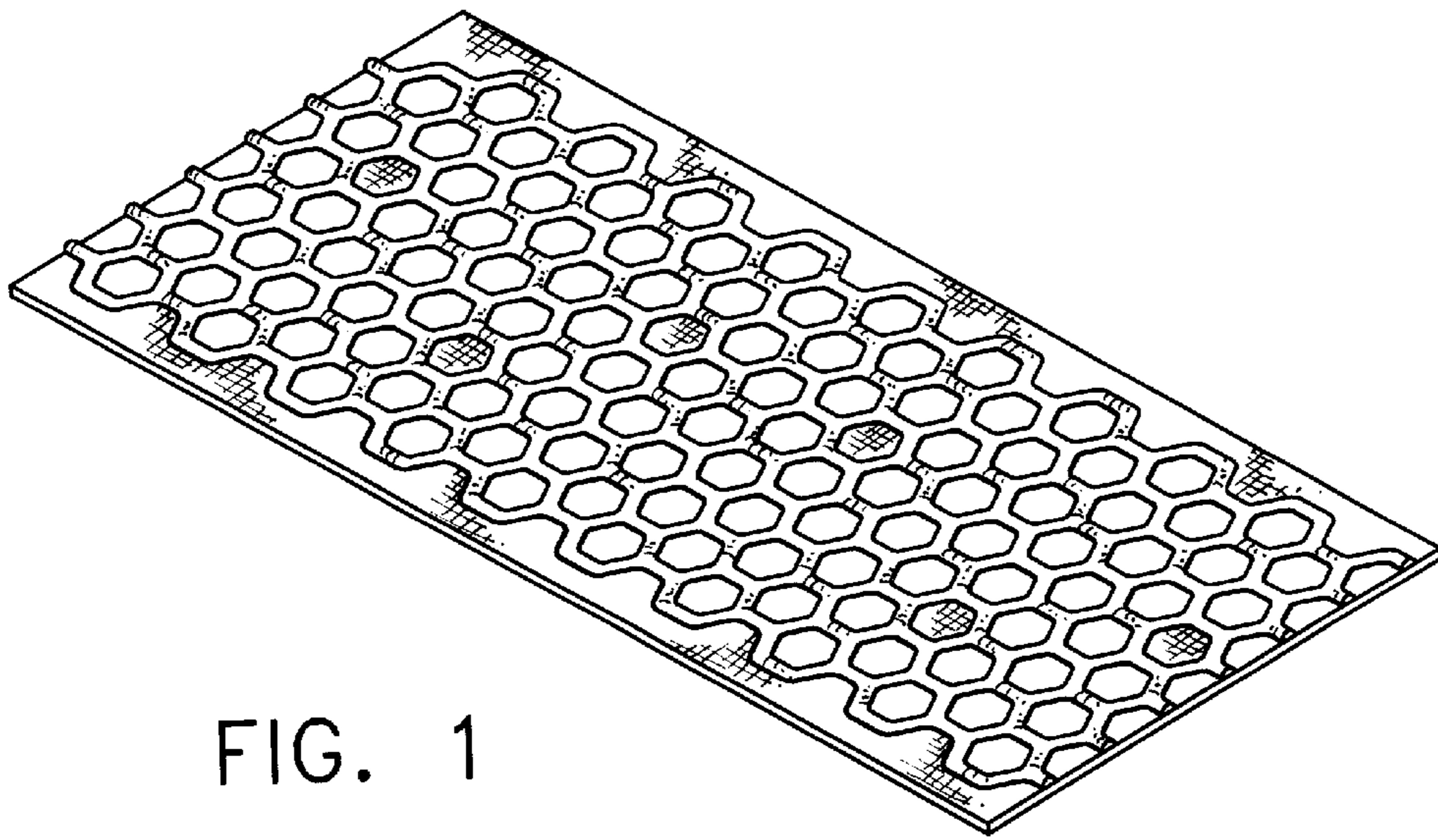

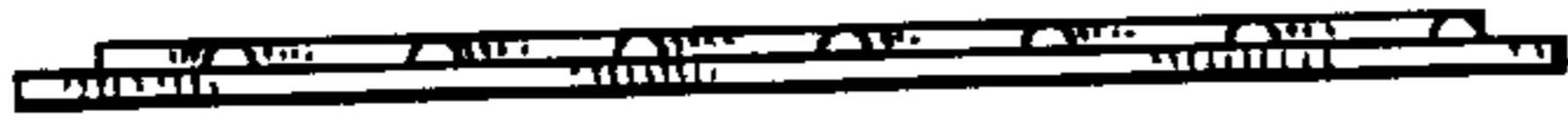

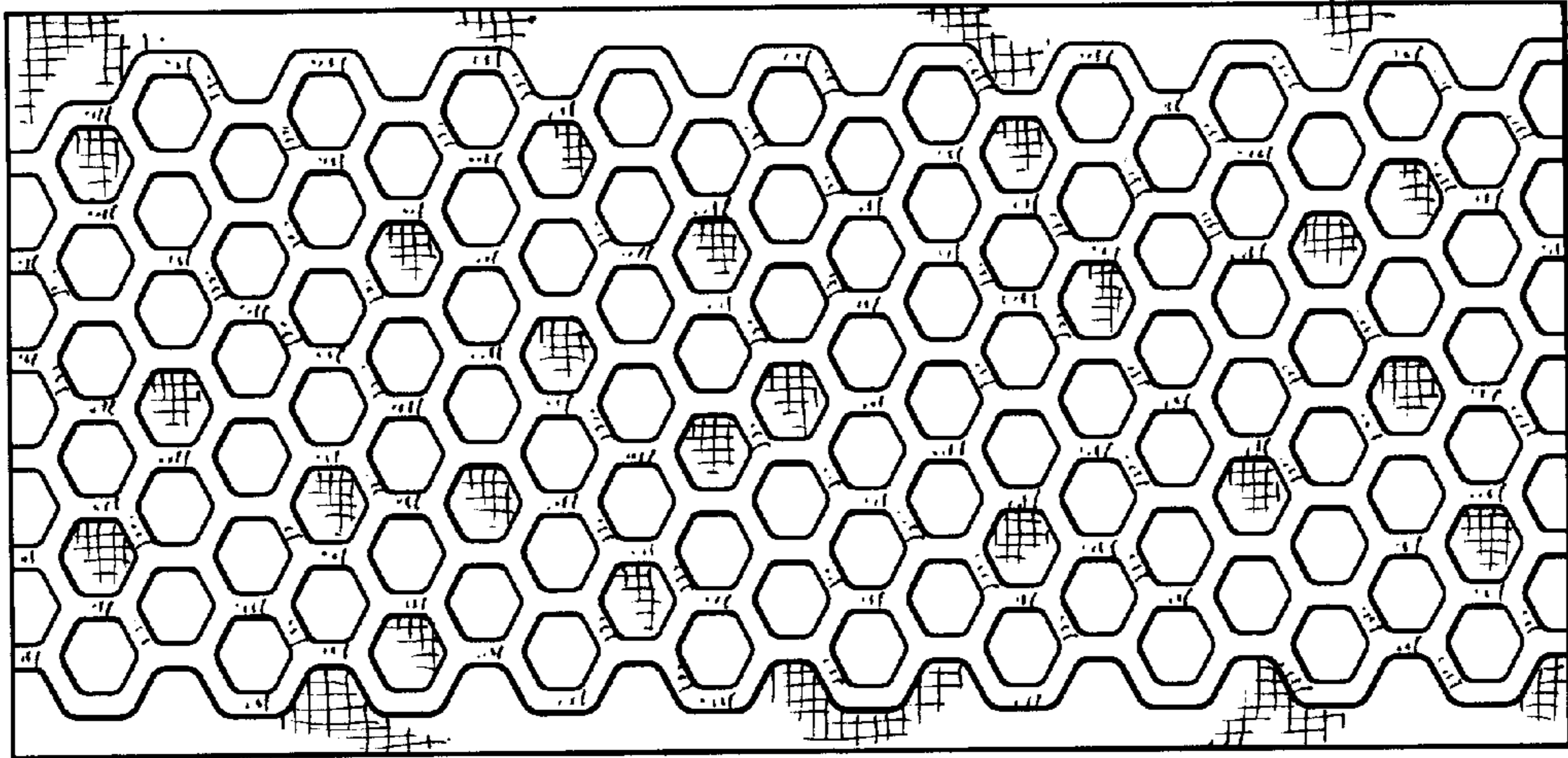

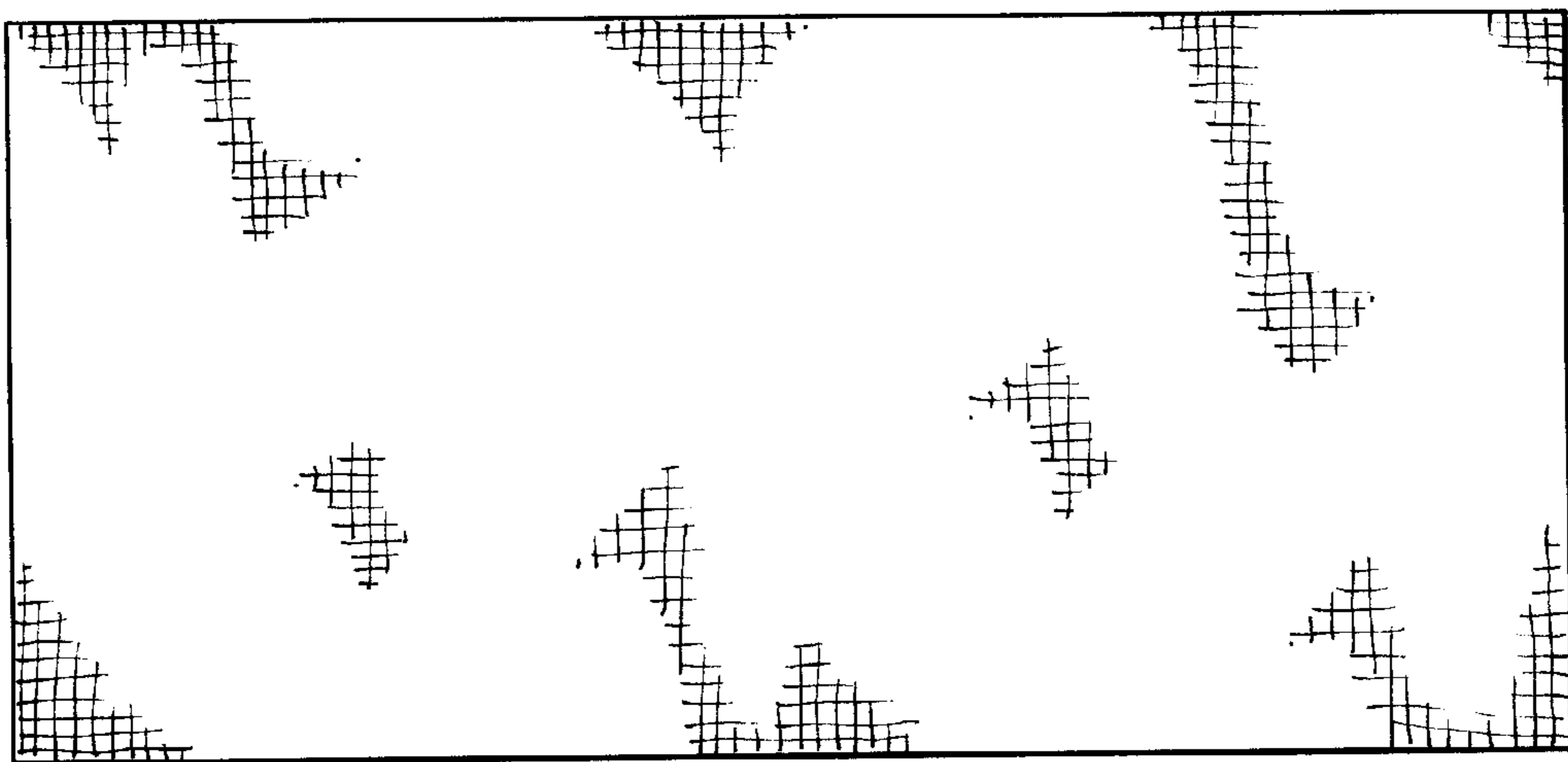
